Lawrence se hunde más con La Turba Linchadora

Los observadores del ayuntamiento sabemos que la Comisionada del Servicio de Inspecciones, Caroline Ganley, ha sido la blanco de algunos miembros del concilio de la ciudad. El martes pasado, 20 de septiembre, la ciudad se hundió más aún con la mentalidad que hace tanto tiempo estamos tratando de erradicar: compinches políticos.

Éste fue el peor caso de comportamiento mezquino por parte de los miembros del concilio. Algunos de ellos intentaron en vano guardar el decoro de sus puestos pero, en un final, el elemento despreciable prevaleció.

Es de conocimiento común dentro del ayuntamiento de Lawrence que Barbara González leía una copia preparada por otra persona. Editorial

Es hora de cambiar

Hay buenas noticias saliendo de Lawrence. Tenemos construcciones por doquier, el Boston Globe dice que nuestro departamento de bomberos está entre los mejores del estado, la guerra contra el fraude de los seguros de automóviles y todas las cosas buenas que el alcalde promueve cada vez que habla en público. Ahora, el nivel de desempleo en la ciudad se redujo por 8 puntos de 14.6% que era hace apenas dos años.

Lo único que tenemos haciendo daño a la ciudad es el concilio. Tenemos a unos cuantos ahí que trabajan en detrimento de los residentes, jugando a la política y usando su influencia para lograr venganzas personales.

La semana pasada querían destrozar a la Comisionada de Servicios de Inspección, Carolina Ganley y durante las audiencias para el presupuesto fue abusada verbalmente y abochornada en público. Algunos concejales piensan que ella no está operando su departamento debidamente pero tienen memoria selectiva.

Cuando el Departamento del Agua tuvo su escándalo por mentir acerca de las químicas en el agua y por falsificar documentos en sus informes al estado, ellos se encogieron de hombros. Es más, en la actualidad estamos bajo una orden del gobierno federal y la EPA nos está vigilando.

Cuando la torre de agua de Tower Hill se rompió hace un par de años en temperaturas muy bajas debido a negligencia, las reparaciones costaron \$50,000. Despues que estuvo fuera de comisión por varios meses poniendo en riesgo a la población, no vimos ningún movimiento para reprocharle al director de DPW.

Lo que necesitamos es cambiar a ciertos miembros del concilio que se prestan para este tipo de comportamiento. Si pudieramos elegir a gente decente al concilio!

Time for a change

There is good news coming out of Lawrence. There is a building boom, the Boston Globe said that our fire department is among the best in the state, the war against auto insurance fraud and all the good things the mayor promotes at each speaking engagement. Now, the unemployment rate in the city went down 8 points from 14.6% in two short years.

The only thing really hurting the city right now is the City Council. We have a bunch there working in detriment of the residents, playing politics and using their influence to accomplish personal vendettas.

Last week they wanted to tear apart the Commissioner of Inspectional Services, Caroline Ganley and during the budget hearings she was verbally abused and embarrassed in public. Some council members think that she is not managing her department adequately but they have selected memory.

When the Water Department had their scandal for lying about the chemicals in the water and falsifying documents in their reports to the state, they didn't make a big deal out of it. In fact, we are now under a consent order from the federal government and the EPA is monitoring us.

When the water tower in Tower Hill broke a couple of years ago in a cold spell at a cost of \$50,000 due to negligence, it was out of commission for many months. You did not see a movement to reprimand the DPW director.

What we need is changing the council members who avail themselves to this type of behavior. If we could only elect decent people in the City Council!

Lawrence sinks to a new low with The Lynching Mob

City Hall observers are aware that Caroline Ganley, Commissioner of Inspectional Services has been the target of some members of the City Council. Last Tuesday, September 20, the city sank even further into the mentality that we try so hard to eradicate: political cronyism.

This was the worst case of sleazy behavior at the Council Chambers. Some of them tried in vain to keep the decorum of the office but, overall, the despicable element prevailed.

It is common knowledge within Lawrence City Hall that Barbara González was reading a copy prepared by someone else. Let's hope that had she written the material, she would have included the response she received in a four-page memo from Caroline Ganley that same morning of the council meeting. In it, Ms. Ganley responded to each of the complaints with lengthy descriptions of the situations, the people involved and the reasons why the decisions were made.

Ms. Ganley also states that no one asked anything of her, not even the City Attorney, Charles Boddy, has been communicating with her as he should prior issuing memos or information to the press. "In the future, I would appreciate if you would contact me first, before releasing such a memorandum, so that you may make an informed opinion as to matters at hand," she wrote in a memo to Mr. Boddy.

Appointed Councilor Barbara Gonzalez read a long list of gossip and innuendos against the Commissioner but those employees had not made use of the normal channels to alleviate any criticism they may have of their supervisor.

The Personnel Director, Frank Bonet, said that he has not handled any of those accusations. In fact, Barbara said several times that she had placed

calls to Mr. Bonet that went unanswered. Mr. Bonet said in a telephone interview that she has never called or left a message in his office in search of any information. "Only once she asked for an organizational chart and I told her that we didn't have one; that I could give her a list of employees, which she accepted, instead," said Mr. Bonet.

That was the only time she has contacted the personnel office.

The City Council is aware that they have no firing rights but by giving a "No Confidence Vote" perhaps they will stain sufficiently the reputation of this department head that she would want to leave her employment with the city. We all know that there was a need to clean up the Inspectional Services Department and that sanitization has not gone far enough.

While we can expect such behavior and manipulation from Barbara, it is really pathetic that other councilors would go along with her lies. This issue is now scheduled to go before the Personnel Committee and it is safe to assume that people would have to testify – people like the Personnel Director who will attest to the fact that Barbara never came looking for information from his office or left any messages that went unanswered.

People of Lawrence, this is the reason that it is so important the caliber of candidates we elect to represent us!





I am writing to respectfully request your immediate attention to the most fundamental issue of citizen rights and voting privileges. As you are aware, the city has continually disrespected the voters by misinforming and misidentifying the polling sites and precinct lines of various precincts in the city. This intolerable situation has existed for months. I have pointed it out numerous times in public statements and yet you have taken no action. Various members of my staff have also noted the deficiency to city personnel. The city continues to display incorrect and outdated information on its Web site regarding polling locations. I even took the step of posting the correct information on my own Web site. This is a ludicrous situation.

I have learned that your administration will not undertake the necessary tasks and expend the funds needed to inform citizens in Districts C and D of changes in precinct lines and voting locations. This is unacceptable. I demand your immediate attention to cure this.

I have also had numerous complaints from citizens that some who have attempted to exercise their right to vote on an absentee voting basis, as allowed by law, have been intimidated by the process and had their ability, even their right to do so, blocked within the walls of our City Hall.

I have decided to seek counsel from the United States Justice Department and the Massachusetts Secretary of State. This has been done today. Thank you for your letter outlining your concerns about the alleged lack of information pertaining to election sites. You also express concern about funding the election division to inform citizens in Districts C and D about precinct changes and that citizens are being "blocked within the walls of city hall" from obtaining absentee ballots. Although you lodge many complaints in the letter I will do my best to assist you with an answer. I believe that voting is a sacred right in which our forefathers fought hard to secure. The answer to these questions actually according to the law lies with you. If you refer to our city charter and turn to section 3.6 paragraph A which reads "The City Council shall elect a city clerk.. City Councilors may remove said official(s) by a 2/3 majority vote of the full council." Paragraph B reads "The city clerk shall...have powers and duties with respect to the regulation and supervision of elections..." Instead of outsourcing your responsibility to Boston or Washington I would respectfully suggest that you get together with your colleagues and own up to your responsibility. I will help in any way I can. It is my belief that the Council made a wise choice in appointing Mr. Maloney the city clerk. He is a man of integrity and a duly sworn member of the bar. I know that city clerk Maloney would never knowingly violate anyone's right to vote..

As to your point about my administration spending the necessary funds to inform citizens of changes in the precinct lines I offer my following thoughts. After you voted to change these precinct lines you then voted against the city clerk's and election division's budget. As a matter of fact you voted *no* to fund the police department, fire department, inspectional services, elderly services and education this fiscal year. Councilor, you have been on many ballots over the past decade without ever uttering a complaint about the integrity of our elections. Real leadership isn't just making "public statements" about a problem; it's about working together to solve them. Hundreds of Volunteers to Clean Up Lawrence's Spicket River

LAWRENCE, MA—Groundwork Lawrence will hold their 4th Annual Spicket River Cleanup on Saturday, September 24 from 9:00 am to 12:30 pm. Lesly Melendez, Groundwork's Environmental Outreach Coordinator, says the group is expecting more than 300 volunteers for this year's cleanup, including students from Lawrence High School, Central Catholic High School, Philips Andover Academy, and Merrimack College, as well as corporate teams from New Balance and Enel/ Essex Company. The cleanup is being organized in partnership with the City of Lawrence, Urban Ecology Institute, Arlington Community Trabajando, and Lawrence CommunityWorks, with support and donations from local businesses including Jackson Lumber, the Lawrence Athletic and Civic Club, Sal's Just Pizza, and G & Z Pizza. The event is also supported through a grant from the Jesse B. Cox Charitable Trust.

This year, the cleanup will target five sites along the river that have been subject to persistent dumping over the years. These sites were identified as a top priority by Groundwork Lawrence and members of the Spicket River Task Force, a broad-based coalition of river enthusiasts, during a river-

wide survey last spring. The five sites include dumping "hot spots" under bridges and in out-of-the-way locations that have been difficult to reach during previous cleanups. According to Melendez, "In the past, we've focused on the riverbanks that were easiest to gain access to. This year, we'll be working to clean up those areas that we haven't been able to reach in the past." She added, "It's really encouraging that the places we've already cleaned up have remained clean—and we're not seeing a lot of new dumping. That is a great sign that people are beginning to respect the river and look at it in a different way."

The annual Spicket River Cleanup is part of a much larger effort to transform this long-neglected a river into a community treasure. Ecological assessments conducted by the Urban Ecology Institute and Lawrence High School students have already documented a remarkable amount of biodiversity along the river, from the majestic Great Blue Herons that make the river their home to more than fifteen types of native plants. This fall, members of the Groundwork Green Team, an after school program for city youth, will be working on a detailed survey of the riverbanks to map

out the locations of native and invasive plants in preparation for riverbank restoration work this spring.

From Stevens Pond at Malden Mills to its confluence with the North Canal and Merrimack Rivers, the Spicket meanders through some of the City's most densely settled neighborhoods—and those with the least amount of green space. According to Groundwork Lawrence Executive Director Maggie Super Church, the statistics point strongly to the need for new green space and recreational opportunities in this part of the city. "In most of North Lawrence, there is less than 140 square feet of green space per capita—that's about the size of your average living room. At the same time, we have the greatest density of children and elderly residents living along the river, but they have virtually no access to the water." Church also points out that "The Spicket River presents a rare opportunity to improve quality of life for literally thousands of city residents. There are twelve schools located within a half-mile of the river, and those students could be participating in outdoor learning activities.... there is the potential to create 15-plus acres of new parkland along the Spicket River, on land that is

currently vacant or contaminated. Riverfront parks can also be connected with walking and cycling trails. That kind of change can help transform a neighborhood."

The Greenway concept is already moving from the visioning stage into reality. Current projects include the construction of a new 2.7-acre park on a former brownfield site behind Brook Street, slated to be in construction this spring, as well as the cleanup and redevelopment of the former Oxford Paper site, which will create a new 2-acre park as part of the Gateway Project. Plans have also been completed for new parkland in a FEMA-designated flood zone in the Arlington neighborhood, as well as schoolyard renovations and a new skate park at the Leonard School, which lies immediately adjacent to the Spicket River. In total, more than \$2.5 million of capital projects are in the pipeline as part of the Spicket River Greenway.

The 4th Annual Spicket River Cleanup will take place, rain or shine, on Saturday, September 24, from 9:30 to 12:30. Registration starts at 9 am at the Central Catholic Gym, where volunteers will be directed to sites along the river. Long pants and long sleeves are recommended. A celebratory lunch and raffle for all volunteers will conclude the cleanup at Central Catholic High School.

Notes from your Librarian



Hi Rumbo readers. We have had some great news here at the library. After a few months of delays, it looks like we will soon be ready to get started on the renovations to the building that I mentioned in the spring.

All three floors of the library will be re-carpeted, including the auditorium. Our chairs have been re-upholstered to complement the new carpets and we will be opening up our new history room on the third floor.

We are grateful to the city and the mayor for including the library in the city's capital improvement. We are also grateful to the trustees of the White Fund who are sponsoring the purchase of furniture and a microfilm reader for the History Room. We have a great building here, and these improvements will make it something of which the whole city can be proud.

Our children's librarian, Terry Farish, and I attended a meeting of the Pathways to Family Success group this week. Pathways is sponsored by the Massachusetts Department of Education and the Greater Lawrence Community Action Council and is a collaborative of city agencies working towards goals of literacy, education and healthy family life in our community. The library really needs to be part of this collaborative and we look forward to working with them further.

We will partner with them to sponsor the annual literacy day in Lawrence on November 5th. We expect that literacy day will be both fun and educational for all of our patrons and staff. I'll let you know more about this as things progress.

Early in 2006 we will also partner with them on the *Mother Goose Asks Why*

program which focuses on reading, mathematics and science skills. Terry is a great believer in forming reading habits in children who are still quite young. The *Mother Goose* program will give her the opportunity to train people in the community to, themselves, train families in the early reading habit.

I was presented with another interesting partnership prospect last week too. The *Weed and Seed* program, that has made such progress in District C of our city, is moving into areas of districts A and B. Council-at-large candidate Nilka Alvarez and husband Richard Rodriguez hosted an introductory session for residents and stakeholders of these neighborhoods. *Weed and Seed* seeks to improve quality of life in neighborhoods by reducing crime through early intervention with at-risk youth.

The library is in the area covered by the *Weed and Seed* program and it is something we need to support and be a part of. We want the area around our building to continue to be safe for all our patrons. We want to keep unacceptable elements away from our young people. A library should be a sanctuary and we intend to keep it that way—a place for all of our citizens to enjoy in peace and safety.

Just a reminder too folks: Lawrence Cultural Council grant applications are now available in our reference department. I chair the council so I can answer any of your questions. The applications are due October 17th. See you at the library.




