



El dilema del seguro de salud en MA

El Gobernador Mitt Romney ha firmado la ley aprobada por la Cámara de Representantes y el Senado que requiere que cada ciudadano compre seguro de salud, haciendo de este estado el primero en la nación que provee cobertura de salud a la mayoría de sus ciudadanos.

Se requerirá que la industria privada provea seguro de salud a sus empleados y aquellos que no lo hagan, los Demócratas y los proveedores de cuidado de salud quieren imponerle una penalidad de \$295 anuales por trabajador, pagaderos al estado. El Republicano Romney vetó este requisito, creando la primera fricción de la legislación.

Todos sabemos que esto va a ser muy costoso. Entre tanto, se han creado provisiones para los pobres que no puedan pagar

Esta fue una movida audaz de parte de los legisladores y el gobernador, va que no se ha hecho en ninguna otra parte del país y el Gobernador Romney ha advertido que hasta que el sistema esté en funcionamiento después del 1ro. de julio, 2007, las cosas no van a ser fáciles.

Tengamos confianza que para cuando todos los detalles estén finalizados, la ley provea una cobertura asequible para todos.

The health insurance dilemma in MA

Governor Mitt Romney has signed into law a bill approved by the House of Representatives and the Senate requiring every resident to buy health insurance, making this state the first in the nation to provide health coverage to the majority of its citizens.

Private industries will be required to provide health insurance to their employees and to those that don't, Democrats and health care providers want to penalize them with a fee of \$295 per worker each year, payable to the state. Romney, a Republican, vetoed the requirement, creating the first friction of the legislation.

We all know that this could be very costly. Meanwhile, provisions have been made for the very poor who may not afford this coverage.

It was a bold move by our legislators and the governor since it has not been done anywhere else in the country and Governor Romney has warned that things may get rocky for a while as the system gets in place after July 1, 2007.

Let's remain confident that by the time all details are finalized, the law will provide everyone with affordable coverage.

Desde el 1999 mi esposo Alberto Surís y yo hemos venido luchando con el tema que Lawrence debe tener un canal de acceso público como el resto de las ciudades y pueblos que pagan por el servicio

La política han desempeñado un papel grande en todas las decisiones tomadas y cuando finalmente pensamos que la lucha ha terminado (incluso si no es a nuestra satisfacción), encontramos que no hemos terminado.

El problema es que no hay comunicación entre los departamentos de la ciudad. Por ejemplo, nadie le ha dicho al Presidente del concilio de la ciudad que él ya no tiene autoridad sobre el equipo o la estación. El Presidente Patrick Blanchette del concilio admitió en una conversación telefónica conmigo que él no tenía idea que el antiguo sistema había cambiado. El continúa al cargo de la programación del canal 22, el Canal Gubernamental, aún después de haber formado una organización no lucrativa "con el fin de operar, mantener y administrar las instalaciones de televisión del canal de Acceso Público y el canal Gubernamental en la Ciudad Lawrence, Massachusetts." Eso explica muchos de los malentendidos y por qué las cosas están en tan malas condiciones. ¡Nadie está hablando!

En octubre del 2004, Lawrence Community Access Television, Inc. (LCAT) fue creado con el fin de administrar la Estación de Acceso Público (el canal 8) y la estación de Acceso del Gobierno (el canal 22). Este ha sido un camino difícil y las cosas no se han desarrollado como debía ser, principalmente que terminamos con un estudio que apenas se puede utilizar debido a su tamaño.

Lantigua alaba nueva ley del cuidado de la salud

Comenzando una nueva era de cuidado de la salud en Massachusetts, la legislatura ha aprobado efusivamente una medida que dará cobertura a casi todos los residentes del estado que hoy no cuentan con seguro médico en el término de tres años.

Basado en el principio de la responsabilidad que comparten los individuos, las empresas donde trabajen y el gobierno esta decisión jugará un papel muy importante en asegurar acceso casi universal al cuidado médico y preservar cientos de millones de dólares en fondos federales.

"Me alegra reportar que la Legislatura

está haciendo la reforma del cuidado médico una realidad en Massachusetts," dijo Lantigua. "Mis colegas y yo somos parte de un momento histórico para reparar un sistema deficiente y proveer una cobertura de buena calidad a buen precio." Unos 500,000 residentes serán beneficiados como resultado de esto.

Entre las provisiones de la ley están:

MANDATO INDIVIDUAL:

Obedeciendo a la tradición de primicias en Massachusetts, esta ley crea un el primer mandato en la nación que requiere que todos los residentes que puedan pagarlo compren seguro de salud.

RESPONSABILIDAD DEL PATRONO:

La legislación crea un nuevo sistema de Contribución Justa requiriendo que todos los negocios contribuyan hacia el costo del seguro de salud de sus empleados.

NUEVO SUBSIDIO DEL ESTADO:

La nueva ley establece un subsidio para las personas con una entrada menor del 300 por ciento del Nivel Federal de Pobreza. Los adultos con entradas de hasta el 100 por ciento del Nivel Federal de Pobreza (\$9,700) serán elegibles para obtener cobertura sin tener que pagar primas.

EXPANSIÓN DE MASSHEALTH:

La legislación expande el programa de MassHealth a incluir a niños de familias hasta el 300 por ciento del Nivel Federal de Pobreza (\$48,000 para una familia de tres). Además, restaura todos los beneficios que fueron eliminados previamente, incluyendo servicios dentales y de visión, quiroprácticos y prótesis, y también crea un programa piloto para dejar de fumar para los miembros de MassHealth.

TASA DE REEMBOLSO JUSTO:

La ley aumenta el reembolso que los hospitales, médicos y centro comunitarios de salud reciben por tratar a los pacientes del estado. Estos aumentos están atados a la calidad y otras medidas.

"La Cámara de Representantes estima que todos debemos ser parte de la solución," dijo Lantigua. "Dejamos claro que apoyamos el compartir la responsabilidad para asegurarnos que el gobierno, los residentes y los comercios están trabajando hacia la misma meta de reducir significativamente el número de personas sin seguro en Massachusetts y colaborar con el costo por igual. Me alegra saber que la versión final contiene estas partes esenciales."

Una vez que sea implementado, este plan será el modelo nacional. "Massachusetts una vez más es el líder en la nación con un plan innovador que logrará la tan ansiada meta de expandir el cuidado médico para todos," dijo el Senador Edgard M. Kennedy (D-Massachusetts). "No hubiésemos podido lograr este histórico acuerdo sin el fuerte liderazgo del Presidente del Senado Travaglini y el Presidente de la Cámara de Representantes DiMasi. Sus destrezas creando esta legislación y su dedicación de verlo hecho realidad han sido extraordinarias."

"No es ninguna exageración decir que esta es una ley histórica," dijo el Representante Lantigua. "Estoy orgulloso del haber sido el ejemplo para el resto del país y me siento honrado de haber podido contribuir a este esfuerzo."

"Pedimos a las autoridades que hagan los cambios necesarios para tratar a estos millones de trabajadores con justicia. Ellos están aquí para engrandecer y colaborar con esta gran nación", dijo el Reverendo Blanco.

"We are America" (Nosotros somos América), dijo Brian De Peña, cambiando el tono de la vigilia. "Hoy protestamos - mañana votamos", dijo De Peña motivando a la multitud. De Peña le dio

The forum was followed by a discussion of ways for banks and credit unions to assist the immigrant community in obtaining education, training and reasonable financing rates as well as alternative ways to decrease the high foreclosure rates in the city.

Meehan to Host Town Meeting on College Affordability

Congressman Marty Meehan (D-MA) will host a Town Meeting about college affordability at Northern Essex Community College on April 15, 2006. Meehan has invited all residents from Haverhill, Andover, Lawrence, and Methuen to join him and a panel of college admissions and financial aid experts for this important discussion on the rising cost of college tuition and how to improve the availability of higher education.

"For America to remain the most competitive and innovative nation, we must continue to lead the world in human talent and creativity. Investing in our education system is the key to achieving this goal," said Meehan. "Sadly, a college education is now out of the reach for many Massachusetts students. Now, more than ever, it is important that families understand federal, state and private financial aid opportunities, as well as the college admissions process."

Meehan released a report last week that analyzes the dramatic increase of college tuition in Massachusetts over the last decade. The report finds that tuition and fees at public colleges in Massachusetts increased by more than 70% in the last ten years, and nearly 60% at private colleges in the same time period, putting a college education out of reach for an increasing number of high school graduates in Massachusetts.

Meehan's report finds that the total cost of an education at a public college in Massachusetts, including tuition, mandatory fees and room and board, has nearly doubled in the last ten years, from \$3,646 in 1996-97 to \$6,215 in 2005-06. The average tuition and fees of the private schools sampled in 1996-97 was \$16.952 and in 2005-06 that figure was \$26,723.

Most startling is the fact that inflation does not account for the cost increases over the last decade. Total costs have risen more than twice as fast as inflation at both public and private institutions. At private schools, total cost rose by 53% and at public schools total cost rose by 65%, while inflation only accounted for a growth of 25%.

exercising undue power over what is broadcasted on Channel 22, the Government Channel after a non-profit organization was established for "the purpose of operating, maintaining, and managing the Public, and Government Cable Television access facilities in the City of Lawrence, Massachusetts." That explains lots of misunderstandings and why things are so mess up. Nobody's talking!

In October of 2004, Lawrence Community Access Television, Inc. (LCAT) was created for the purpose of managing the Public Access Station (Channel 8) and the Government Access Station (Channel 22). It has been a difficult road and things have not developed as they should have, namely that we ended up with a studio that can hardly be used for anything due to its size.

While you are reading, keep also in mind that this organization operates with 100% of cable subscribers' money. A percentage of what we pay for cable service at home comes back to the city to run these stations.

Volunteers continued working with the new administration hoping that things would settle down someday and everything is taking its course by now at Channel 8. New cameras and other equipment have been purchased by LCAT for the City Council Chamber to transmit all the meetings held there by members of the Council as well as Boards and Commissions.

Although Ginny Alexander, LCAT's station manager has been cooperative offering assistance to anyone looking for help, we have disagreements as to what belongs on Channel 8. We argue over the fact that the mayor's show "Lawrence on the Move" is being shown on Channel 8 but it belongs on the Government Channel (22).

Another point of contention is that the

We must wonder who is really in charge and why these things happen. Supposedly, the control has been given to the non-profit created to operate both stations. Who at LCAT is responsible for what happens? While Ms. Alexander is the station manager, they are run by a board of directors and it has been close to a year since the last time they held a meeting. You should be advised that these meetings were illegally held in secret. Being a public agency, supported by the public's money, every person interested in the future of the Public Access Channel should be allowed to participate – after all, it's our money!

In the end, no one's watching the hen house. Demand change.







Enmendar su declaración de impuestos

¡Uy! Usted descubrió un error después de presentar su declaración de impuestos. ¿Qué puede hacer? Podría necesitar enmendar su planilla.

"El Servicio de Impuestos Internos (IRS) generalmente, corrige errores matemáticos o le solicita las formas omitidas – como W-2s o anexos. En estos casos, no necesita enmendar su declaración", dice Sara Eguren, vocera de la agencia federal.

Sin embargo, debe enmendar su declaración si cualquiera de los siguientes datos apareció incorrectamente:

- Su estado civil para fines de la declaración
- El total de sus ingresos
- Sus deducciones o créditos

Utilice la Forma 1040X, Amended U.S. Individual Income Tax Return (Declaración Enmendada de Impuestos sobre el Ingreso Individual), para corregir la Forma 1040, 1040A, 1040EZ o la declaración electrónica presentada previamente. Esté seguro de anotar el año de la declaración que usted está enmendando en parte superior de la Forma 1040X. Si usted está enmendando más de una declaración de impuestos, utilice una Forma 1040X separada para cada año y envíe cada una en un sobre separado al centro de procesamiento del IRS para el área en la que usted vive. Las instrucciones de la 1040X incluyen las direcciones para los centros.

La Forma 1040X tiene tres columnas. La Columna A se utiliza para mostrar las figuras originales o ajustadas de la declaración original. La Columna C se utiliza para mostrar las figuras corregidas. La diferencia entre las columnas A y C es demostrada en la columna B. Hay un área en la parte posterior de la forma donde usted explica los cambios específicos

Si usted está declarando para reclamar un reembolso adicional, espere hasta haber recibido su reembolso original antes de presentar la Forma 1040X.

hechos en la declaración y la razón de cada cambio.

Si los cambios implican otro anexo o forma, adjúntelo a la 1040X. Por ejemplo, si usted está presentando una 1040X porque tiene un niño calificado y ahora desea reclamar el Crédito Tributario por Ingreso del Trabajo, usted debe adjuntar un Anexo EIC de la forma 1040 para indicar el nombre de la persona calificada, año de nacimiento y número de Seguro Social.

Si usted debe impuestos adicionales del 2005, debe presentar la Forma 1040X y pagar el impuesto para la fecha límite de abril para evitar cualquier penalidad e interés. Si usted está declarando para reclamar un reembolso adicional, espere hasta haber recibido su reembolso original antes de presentar la Forma 1040X. "Puede cobrar ese cheque mientras espera cualquier reembolso adicional", sugirió Eguren.

Generalmente, para reclamar un reembolso, usted debe presentar la forma 1040X en un plazo de tres años a partir de la fecha usted presentó su declaración original o dentro del plazo de dos años a partir de la fecha en que usted pagó el impuesto, cualquiera sea más tarde.

NECC Opens Sleep Lab

Northern Essex Community College recently opened its new Sleep Lab which is located on the college's Lawrence Campus, 45 Franklin St., and will be used by faculty and students in the college's Polysomnography Program.

The lab features two beds with infrared video cameras that will monitor individuals while they sleep. It will be used as a teaching tool by faculty in the two-semester certificate program which was launched in the fall of 2004 and is designed to train sleep technologists to work in area sleep labs.

Valued at \$60,000, the equipment was donated by Dr. Howard Zolot, a North Andover periodontist and member of the college's Dental Assistant Program Advisory Board. After reading that the college had started a Polysomnography Program, Dr. Zolot contacted the college, offering to donate the equipment which had been left in one of the office properties he owns. "Some doors close and others open," said Dr. Zolot. "It was my pleasure to be able to donate this equipment."

Jackie Long Goding, dean of health professions at NECC, welcomed guests to the opening of the Sleep Lab and explained how the program was started. Chris Rowse, coordinator of NECC's Respiratory Care Program, and Andrew DesRosiers, director of Holy Family Hospital's Sleep Lab, met at a conference and began discussing the need for more formal training of sleep technicians. The two are now co-directors of the program.

DesRosiers credits the growing awareness of sleep apnea-a condition where individuals stop breathing repeatedly during their sleep-and its link to hypertension and high blood pressure with creating the growing need for sleep labs.

In addition to the equipment donation, the college also received a sleep software license donation with accompanying software from Medcare Inc. of Iceland, valued at \$50,000.

REP. FINEGOLD PROPOSES MAKING ATTACKS ON **HOMELESS A HATE** CRIME

Citing a recent crime in which a homeless man was assaulted while sleeping on a park bench in Boston's North End, Representative Barry R. Finegold (D-Andover) has proposed legislation that will extend protection under Massachusetts' Hate Crime Statute to include homeless individuals.

Currently, the Massachusetts Hate Crime Statute makes it a crime to assault and cause injury to an individual with the intent to intimidate the person based on the person's race, color, religion, national original, sexual orientation, or disability. Such crimes are punishable by five years in state prison and up to a ten thousand dollar fine. The proposed legislation will bring a person's housing status under the Hate Crime Statute.

Representative Finegold believes that prior to this legislation, homeless people were not afforded the same protection and recourse as other citizens, primarily due to their housing

"If an individual is assaulted in their home, among the many charges available to authorities are trespass, breaking and entering, or perhaps unlawful entry; all of these charges ratchet up the penalty for the assault. These are not available to authorities when a homeless person is assaulted and as a result, the punishment for the suspect may not be as severe," commented Representative Finegold.

"According to the Department of Veterans Affairs, nearly 200,000 veterans go homeless on any given night. Many homeless people suffer from mental illness or simply have not been given a fair chance in our communities. These individuals deserve to be protected by our legal system and by making it a hate crime to assault a homeless person, we will hopefully deter future attacks on homeless people," commented Representative Finegold.

"This important legislation will go a long way in protecting individuals whose only crime is not having a place to call home," commented Robyn Frost, Executive Director of The Massachusetts Coalition for the Homeless.

Representative Finegold filed the legislation on Thursday of last week.

Amending your tax return

Oops! You've discovered an error after your tax return has been filed. What should you do? You may need to amend your return.

"The IRS usually corrects math errors or requests missing forms — such as W-2s or schedules. In these instances, do not amend your return," said the federal agency's spokeswoman Sara Eguren.

However, do file an amended return if any of the following were reported incorrectly:

- Your filing status
- Your total income
- Your deductions or credits

Use Form 1040X, Amended U.S. Individual Income Tax Return, to correct a previously filed Form 1040, 1040A, 1040EZ or electronically-filed return. Be sure to enter the year of the return you are amending at the top of Form 1040X. If you are amending more than one tax return, use a separate 1040X for each one and mail each return in a separate envelope to the IRS processing center for the area in which you live. The 1040X instructions list the addresses for the centers.

The Form 1040X has three columns. Column A is used to show original or adjusted figures from the original return. Column C is used to show the corrected figures. The difference between the figures in Columns A and C is shown in Column B. There is an area on the back of the form where you explain the specific changes being made on the return and the reason for each change.

If the changes involve another schedule or form, attach it to the 1040X. For example, if you are filing a 1040X because you have a qualifying child and now want to claim the Earned Income Credit, you must attach a Form 1040 Schedule EIC to show the qualifying person's name, year of birth and Social Security number

If you owe additional tax for 2005, you should file Form 1040X and pay the tax by the April due date to avoid any penalty and interest. If you are filing to claim an additional refund, wait until you have received your original refund before filing Form 1040X. "You may cash that check while waiting for any additional refund," suggested Eguren.

Generally, to claim a refund, you must file Form 1040X within three years from the date you filed your original return or within two years from the date you paid the tax, whichever is later.

Form 1040X and instructions are available at IRS.gov or by calling 1-800-TAX-FORM (1-800-829-3676).

Lantigua heralds approval of Health Care Reform Bill

Embarking on a new era of health care reform in Massachusetts, the state's Legislature has overwhelmingly approved comprehensive legislation that would cover virtually all of the state's uninsured residents within three years, Rep. William Lantigua (D-Lawrence) has announced. The measure was then signed into law by Governor Mitt Romney.

Based on the principle of shared responsibility, individuals, employers, and government will play an active role in ensuring near-universal access to health care and preserving hundreds of millions of dollars in federal funding.

"I am happy to report that the Legislature is making real health care reform a reality here in Massachusetts," Lantigua said. "My colleagues and I have seized this historic opportunity to overhaul a broken system and deliver affordable, quality coverage." Lantigua noted that the legislation would extend health benefits to more than 500,000 state residents currently without coverage.

Major provisions of the legislation include:

· Individual Mandate: Holding true to a long tradition of Massachusetts "firsts," the bill creates a first-in-the-nation individual mandate to require all residents who can afford it to purchase health insurance.

• Employer Responsibility: The legislation creates a new Fair Share Contribution by requiring all businesses to contribute toward employee health insurance costs.

• New State Subsidies: The bill establishes new state subsidies for individuals with incomes of less than 300 percent of the Federal Poverty Level (FPL). Adults with incomes up to 100 percent of the FPL (\$9,700) will be eligible for coverage without premiums.

• MassHealth Expansion: The legislation expands the Commonwealth's MassHealth

program to include children from families up to 300 percent of FPL (\$48,000 for a family of three). In addition, it restores all previously cut benefits, including dental and vision services, chiropractic and prosthetics, and creates a smoking cessation pilot program for MassHealth enrollees.

Fair Reimbursement Rates: The bill calls for long overdue increases in reimbursement rates to hospitals, physicians, and community health centers for treating the Commonwealth's MassHealth patients. These increases are tied to quality and other performance measures.

"The House feels very strongly that everyone should to be part of this solution," Lantigua said. "We went on record in support of shared responsibility to ensure that government, individuals and businesses are all working towards the same goal of significantly reducing the number of uninsured in Massachusetts and reining in costs for everyone. I am pleased that the final version contains these essential parts."

Once implemented, the consensus plan will be a national model. "Massachusetts once again leads the nation with an innovative plan that will achieve our longstanding goal of expanding health care for all," said United States Senator Edward M. Kennedy (D-Massachusetts). "We could not have achieved this landmark agreement without the strong leadership of Senate President Travaglini and House Speaker DiMasi. Their skill in crafting this legislation, and their dedication to seeing it through, have been extraordinary."

"It is not overstatement to call today a landmark in state history," Lantigua said. "I'm proud of the example we've set for the rest of the country, and honored to have been able to contribute to this effort."

Mayor Names Parking Facility Task Force

Mayor James J. Fiorentini today announced the creation of the "Downtown Parking Facility Task Force". The task force will review the Preliminary Engineering work being done on proposed sites for an Intermodal Transit Parking Facility. They will make recommendations as to the final location of a new parking facility to be built in the downtown Haverhill area.

Through the efforts of Congressman Marty Meehan, the city received last summer a \$7.6 million dollar appropriation for an Intermodal Transit Facility. The grant can cover only 80% of the total project costs. The remaining 20% of the project costs must be paid for with non-federal funds. The City will partner with the Merrimack Valley Regional Transit Authority to develop this facility. One of the City's main goals in this partnership is to get the structure built without using taxpayer funds for construction.

Fiorentini stated that he wanted a broad-based inclusive committee to determine the location of the facility:

"Our committee reflects a broad cross-

section of the community. I was looking for residents and business people. I was looking for people who were in the downtown every day and understood its needs and especially its parking needs. The committee includes both technical and nontechnical people. This will be a challenging task and I appreciate the willingness of these volunteers to serve."

Named to the committee are architect Martha Briggs, businessman Peter Carbone, former City Councilor Robert Des Marais, downtown restaurant owner John Fahimian, medical secretary Cate O'Hara, City Engineer John Pettis, Economic Development Director Bill Pillsbury, Haverhill PD Captain Alan Ratte, and

City Councilor Robert Scatamacchia.

Mayor Fiorentini said, "I want a facility that meets the Federal funding requirements and helps relieve our downtown parking needs. The City will do everything it can to speed this process along. I look forward to working with our state and federal official to make this project a success."

Candlelight rally for illegal immigrants

Last Monday, April 10th, Lawrence produced the second demonstration in favor of the illegal immigrants, this time in a form of a peaceful vigil. Several hundreds of demonstrators stood at the intersection of Essex and Broadway for about an hour, some with candle lights.

Contrary to the previous demonstration, neither of the main organizers of last week's demonstration, Martina and José Cruz participated this time. Instead, a Catholic Priest, St. Mary of the Assumption Parish Vicar, Reverend Jorge Reyes, OSA, and Reverend Pastor Rafael Blanco joined the demonstrators and prayed for a just and peaceful solution to the illegal immigrants' problems.

"We ask the authorities to make the necessary changes to treat these millions of workers with justice. They are here to make this county bigger and to collaborate with this great nation", said Reverend

"We are America", chanted Brian De Pena, changing the tune of the vigil. "Today, we protest – tomorrow we will vote", said De Pena, motivating the crowd. De Pena gave credit to former Councilor Marcos Devers for being the one who got the permit from the police to demonstrate. "We should keep the order, though, don't get down from the sidewalk", said De Pena to a very well behave crowd.

"We are not here leaned to anybody. The United States is ours", said former Councilor at-Large Marcos Devers, who said that even President Bush admitted that

"This country will be stronger if we respect everybody's rights – ¡Que vivan los inmigrantes!" (Long live the immigrants), said Meyers in Spanish, to the delight of the crowd.

Meyers strongly recommended the movie 'A day without Mexicans. "It's a funny comedy, but it tells what the U.S. would be without Mexicans," said Meyers, whose family is Mexican on his wife's side.

Five GLTS Students Win Medals at SkillsUSA District Competition

Senior John Provencal of Lawrence made school history at the recent SkillsUSA North District competition, becoming the first Greater Lawrence Technical School student to earn a gold medal in cabinetmaking.

John was one of five GLTS students to earn medals at the event. The others were juniors Stephen Lebel of Methuen (silver, Electronics Applications), Astrid Parra of Lawrence (bronze, First Aid/CPR), Kristin Maglio of Lawrence (bronze, Nurse Assisting), and Rafael Sanquintin of Lawrence (bronze, Office Computer Applications).

"In October, I started working for a cabinetmaking shop," John said. "Between that, and my teachers here at the school, I was well-prepared for the competition."

John is a member of Greater Lawrence Tech's Cooperative Education Program. Co-op students alternate weeks at the school with weeks working for an employer in their field. During his co-op weeks, John works for Acorn Wood Products in North Lawrence.

The district contest consisted of two written tests: one assessing knowledge in a student's career major, and the other assessing SkillsUSA organizational knowledge. John, for instance, answered questions on cabinetmaking terminology, and "how to" questions on different cuts and hinges.

About 500 students compete at four SkillsUSA district events across the Commonwealth. The top three winners in each category go on to the Massachusetts SkillsUSA State Leadership and Skills Conference April 27-29, where they compete in hands-on activities in their major, as well as in a variety of leadership categories.

In addition to its five medal winners, Greater Lawrence will send approximately 17 other students to the state conference to compete in leadership events and other skills events that begin at the state level. Those events include Community Service, Tech Prep, Entrepreneurship, and Customer Service.

state conference are among the top students in their career areas," Greater Lawrence SkillsUSA advisor Linda Cote said. "They demonstrate high level skills that will benefit them as they move into the workforce, or postsecondary education."

Kristin Maglio credited Ms. Cote with helping her claim a bronze medal in Nurse Assisting at the District competition.

"Ms. Cote gave me practice problems to help me prepare," she said. "I had to answer questions about basic nursing skills, like how to take care of an elderly patient, how to make sure they're safe, proper hygiene, how to apply a dressing, and nursing terminology."

In addition to Ms. Cote, Ilene Karnow serves as a Greater Lawrence Technical School SkillsUSA advisor.

Greater Lawrence is a "total participation" school, involving all its students in the SkillsUSA process. The SkillsUSA Professional Development Program used at GLTS teaches students skills that ensure a smooth transition from school to the work world. Among other topics, students are taught goal setting, communication skills, and career awareness.

More than 300 elite athletes ages 14-18 vied at this competition for Junior National Titles in the solo, duet, trio and team events. Also up for grabs were 10 spots on the 2006 U.S. Junior National Team which were named at the conclusion of the meet. The Junior National Team will go on to compete in the X FINA Junior Synchronized Swimming World Championships October 26-29 in Guangzhou, China.

For the ANA Synchers, outstanding performances were delivered by trio swimmers Stephanie Garcia-Restrepo, 16, of Billerica, Rita Gillan, 18, and Ashley Cohen, 16, of Andover, earning them a 14th place finish. Gillan and Garcia-Restrepo finished 23rd for their duet, and 23rd and 24th, respectively, for their solo routines, qualifying them for the U.S. Nationals at the end of April.

The ANA Synchers is the synchronized swimming team sponsored by



the Andover/North Andover branch of the Merrimack Valley YMCA. The team has grown from 15 swimmers ten years ago to close to 60 swimmers today. In addition to its growth in numbers, over time the ANA Synchers have risen rapidly through the ranks to qualify for an increasingly elite level of competition. In addition to the U.S. National Championships, the Synchers expect to send 35 athletes competing in 12 events to the Age Group Championships in Seattle, WA in June, and 18 athletes competing in all 5 events to the international U.S. Open Championship in Orlando, Florida in July.

Meehan to Host **Town Meeting on** College **Affordability**

Congressman Marty Meehan (D-MA) will host a Town Meeting about college affordability at Northern Essex Community College on April 15, 2006. Meehan has invited all residents from Haverhill, Andover, Lawrence, and Methuen to join him and a panel of college admissions and financial aid experts for this important discussion on the rising cost of college tuition and how to improve the availability of higher education.


"For America to remain the most competitive and innovative nation, we must continue to lead the world in human talent and creativity. Investing in our education system is the key to achieving this goal," said Meehan. "Sadly, a college education is now out of the reach for many Massachusetts students. Now, more than ever, it is important that families understand federal, state and private financial aid opportunities, as well as the college admissions process."

Meehan released a report last week that analyzes the dramatic increase of college tuition in Massachusetts over the last decade. The report finds that tuition and fees at public colleges in Massachusetts increased by more than 70% in the last ten years, and nearly 60% at private colleges in the same time period, putting a college education out of reach for an increasing number of high school graduates in Massachusetts.

Meehan's report finds that the total cost of an education at a public college in Massachusetts, including tuition, mandatory fees and room and board, has nearly doubled in the last ten years, from \$3.646 in 1996-97 to \$6.215 in 2005-06. The average tuition and fees of the private schools sampled in 1996-97 was \$16,952 and in 2005-06 that figure was \$26,723.

Most startling is the fact that inflation does not account for the cost increases over the last decade. Total costs have risen more than twice as fast as inflation at both public and private institutions. At private schools, total cost rose by 53% and at public schools total cost rose by 65%, while inflation only accounted for a growth of 25%.
