

El recuento de votos de las elecciones finales celebradas el 6 del pasado mes de noviembre, que fuera solicitado por las candidatas Ruth Rojas y Bárbara González por los Distritos B y C, se llevaron a cabo el lunes, 26 de noviembre, 2007. Rojas estaba postulada contra la incumbente Grisel Silva y Bárbara lo estaba en contra del incumbente Jorge González.

Los totales oficiales del Distrito B daban a Silva 492 votos y 466 a Rojas. Después del recuento, Silva subió a 497 y Rojas a 467. La diferencia de 26 votos del conteo original subió a 30 con 110 boletas dejadas en blanco.

En el Distrito C, no hubo mucha diferencia tampoco. Bárbara González estaba postulada en contra del concejal incumbente del Distrito C Jorge A. González. El total oficial de la elección daba a Jorge 421 y a Bárbara 391. Después del recuento, Jorge terminó con 417 y Bárbara con 388. La diferencia original de 30 votos, quedó rebajada a 29 después del recuento, con 96 boletas dejadas en blanco.

El recuento se llevó a cabo bajo la supervisión de la Comisión de Elecciones y su Presidente Robert Hutton, con la ayuda de Ronald Martin, y Emilio García. También Rafael Tejeda, coordinador de elecciones y el Escribano de la Ciudad, Bill Maloney, participaron.

Los votos del Distrito B fueron contados a mano en dos mesas por Annia Lembert, Ana Levy, Mike Rivera y Jonas Stunza teniendo como observadores a Bill Collins, Richard Rodríguez, Annette Webster y Domingo Meléndez.

Eleanor Fulgione, Julio Tejada, German Lembert y Angel Marmol contaron a mano los votos del Distrito C, mientras que Robert Beals, Anna Lembert, José Figueiro y Sara Saldaña actuaron como observadores. Ruth Rojas, Jorge A.

González y Bárbara González actuaron como sus propios representantes durante el conteo, mientras que Olga Silva, suegra de Grisel Silva representó a ésta última.

“Recuentos como estos suelen costar a la ciudad entre \$2,000.00 y \$3,000.00”, dijo el Escribano de la Ciudad Bill Maloney. Debido a que este fue efectuado durante horas de trabajo, Maloney estima que costará entre \$900.00 y \$1,000. “Por suerte no tuvimos que utilizar al abogado de elecciones”, añadió Maloney.

“Estoy muy satisfecho con los resultados (del recuento)”, expresó Maloney. “Esto prueba cuán seguro es el sistema y a la vez invalida cualquier argumento que alguien pueda hacer de que se han añadido boletas”. Maloney hizo estas declaraciones por teléfono y enfatizó el hecho de que el recuento mostró la misma cantidad de votos que la cuenta original.

EDITORIAL

Elecciones de Lawrence necesitan cambios

Hubo una época durante las elecciones en la Ciudad de Lawrence cuando los candidatos latinos culpaban el control de los anglos en el Departamento de Elecciones como la razón por no ser electos. Ahora, las cosas han cambiado y la mayoría de los trabajadores en los colegios electorales son de habla española y algunas personas continúan quejándose. La razón esta vez es porque amigos y familiares de candidatos están controlando el proceso.

Esas fueron algunas de las alegaciones para hacer el reciente recuento en dos distritos en Lawrence. Nosotros pensamos que eso fue señal de desperdicio y un gasto innecesario cuando consideramos que la diferencia fue 26 y 30 votos en cada distrito. Si tomamos en consideración que el Concejal Joseph Parolisi perdió por apenas 40 votos en una elección por toda la ciudad, él tenía más justificación para pedir un recuento de votos que aquellos por distritos. Su probabilidad de hacer un cambio significativo era remota dado a la tecnología de hoy y la certeza de los equipos modernos.

Sí, hay quienes se quejan y esta vez los candidatos de habla inglesa lo hacen en silencio porque ellos también piensan que no pueden confiar en un sistema del cual los latinos se están apoderando. No es cuál grupo está controlando el proceso electoral sino la integridad de las personas que lo operan. El sistema necesita arreglos y hubo muchas inconsistencias durante las elecciones que esperamos serán corregidas – empezando con la eliminación de los votantes inactivos en esa lista.

La Junta Electoral siempre permite los recuentos porque no quieren privar a nadie de ese derecho; pero debemos considerar una ordenanza que requiera un número exacto de votos o un porcentaje del total de votos como medida por medio del cual se pueda considerar un recuento y evitar este trabajo adicional y gasto a la ciudad.

Lawrence elections need changes

There was a time during election time in the City of Lawrence when Latino candidates blamed the Anglo control in the Elections Department as the reason for not being elected. Now, things have changed and most of the workers in the polling stations are Spanish-speakers and some people continue complaining. The reason this time is because friends and relatives of candidates are controlling the process.

Those were some of the allegations for a recent recount on two districts in Lawrence. We believe that it was a sign of waste and unnecessary expenditure when considering that the difference was 26 and 30 votes in each district. If we take into consideration that Councilor Joseph Parolisi lost his seat for merely 40 votes in a city-wide contest, he was more justified in asking for a recount than those at the district level. Their probability of making a significant change was remote given today's technology and the accuracy of modern equipment.

Yes, people still complain and this time the English-speaking candidates do it quietly because they also feel they cannot trust the system that is being taken over by Latinos. It's not what language group is managing the electoral process but the integrity of the people behind it. The system needs fixing and there were many inaccuracies during the last elections that hopefully will be taken care of – namely the elimination of the inactive voters on that list.

The Board of Registrars always allows recounts to take place because they don't want to deprive anyone from that right; but meanwhile, we must consider an ordinance that would require a set number of votes or percentage of the total votes as the benchmark by which a recount should be considered and avoid this extra work and expense to the city.

Radhames recuerda que los amigos de infancia que no fueron al club ahora están muertos, en la cárcel, o son una carga para la sociedad. El acreditó a los Boys & Girls Clubs por ser, "La Mejor Organización de Jóvenes en América, punto" y la razón por su éxito. El sabe que el club todavía está abierto por el apoyo de la comunidad y quiere que otros continúen con sus responsabilidades. Radhames estaba orgulloso de sus logros, pero él está más orgulloso de su hermana, Raquel A. Nova, quien también fue honrada esa noche.

Raquel A. Nova es una mujer de muchos primeros; una de las primeras muchachas que se asignó al Girls Club cuando abrió sus puertas en 1996, la primera alumna que obtuvo su maestría de Clark University y la primera mujer en el Salón de Fama del Boys & Girls Club de Lawrence. Pero muchos de estos primeros nunca se hubieran realizado si no fuera por las relaciones que ella hizo en el club. Raquel, como su hermano, vino de la República Dominicana cuando tenía diez años y se esforzó para aprender inglés. El club siempre estaba ahí en cualquier situación especialmente con los asuntos que cada niña tiene que afrontar.



Raquel recuerda siendo un miembro de Project Advance- un programa para la prevención de embarazos de la juventud. En ese programa ella recibió una camiseta que decía, "Yo voy a esperar" y desde ese momento ella tomó esas palabras seriamente y pudo participar en muchas de las oportunidades que el club le ofreció. Ella sabe cuánto el club ha hecho por ella y por eso es que está ayudando al club en la

mayor forma posible; ella es la Directora de Educación.

Raquel supervisa todos los programas educacionales y guía a los jóvenes a altos niveles de educación. Raquel se rió al saber que no fue escogida para ser Joven del Año cuando ella era más pequeña, pero reconoce que estar en la Sala de la Fama es mucho más honor. Ella le dio las gracias a todos, especialmente a su hijo Noah de diez

y ocho meses, quien estuvo corriendo durante su discurso.

El estado ampliará laboratorio en Lawrence

El viernes, 16 de noviembre, 2007, en una fría y ventosa mañana, oficiales de la ciudad y el estado se reunieron bajo una carpeta en el 37 de la Calle Shattuck, en Lawrence, para anunciar la expansión, renovación por valor de \$22 millones, de la planta Senator William X. Wall Experiment Station in Lawrence, operada por MassDEP.

Las mejoras en la planta incluirán el uso de foto-cédulas para atrapar la energía solar, un súper eficiente sistema HVAC que ahorrará hasta el 40% del gasto de calefacción y aire acondicionado, jardines de lluvia, para el mejor uso del agua de las tormentas así como su reciclaje para usos de irrigación y ventanas grandes para aprovechar la luz y el calor solar, instalación de un "techo verde" y espacio en el parqueo para conectar vehículos híbridos.

La administración del Gobernador Deval Patrick dio inicio a la primera fase del proyecto de ampliación, renovación planeada para dos años, la cual transformará el laboratorio medioambiental operado por el Departamento de Protección Ambiental de Massachusetts en un edificio "verde" con todos los adelantos modernos. El proyecto añadirá 13,000 pies cuadrados al histórico edificio de 22,000 pies cuadrados.

"La Estación Experimental Wall tiene una larga y excelente historia como laboratorio ambiental y en su nueva reencarnación será un edificio modelo", dijo

Ian Bowles, Secretario de Energía y Asuntos Ambientales. "Yo aplaudo a MassDEP por seguir el llamado del Gobernador Patrick de predicar con el ejemplo con este edificio, que demostrará lo que puede hacerse con energía eficiente y manejo del agua"

La Estación Experimental Wall es el laboratorio principal de agua potable de Massachusetts y anualmente lleva a cabo 10,000 análisis de contaminantes en el agua, aguas negras, aire, terreno, desechos peligrosos, peces, y otras muestras. La planta también certifica a más de 150 laboratorios comerciales y municipales para asegurar de que cumplen con los análisis de agua potable y no potable.

"Estoy excitado de que este edificio de Lawrence haya sido certificado como 'verde'", dijo el Alcalde de Lawrence Michael J. Sullivan. "Tanto trabajo ambiental que se realiza en esta planta, es lógico de que este edificio se transforme eficiente en energía".

La primera fase del proyecto envuelve la ampliación de la planta a un costo de \$16 millones, utilizando fondos aprobados por la Legislatura de Massachusetts. Fondos también son proveídos por la Agencia de Protección Ambiental a través del Fondo de Agua Potable. La segunda fase que envuelve \$6 millones, que utilizará fondos del Environmental Bond Bill, serán utilizados para renovar el edificio existente.

En 1993, el laboratorio fue nombrado Senador William X. Wall a raíz de su súbito fallecimiento. El Senador Wall representó a Lawrence en la Legislatura por 40 años, y fue el que introdujo la ley que creó el laboratorio el cual fue ocupado en 1954. Miembros de su familia asistieron a la ceremonia.

La Estación Experimental fue fundada en 1887 como uno de los primeros laboratorios en el mundo dedicados al estudio del medio ambiente. El trabajo que allí se llevó a cabo creó los cimientos de tratamientos modernos de purificación de agua usados a través del mundo. En 1975, la sociedad Americana de Ingenieros Civiles designó el edificio como "Atracción Nacional Histórica de Ingeniería Civil".



Hoy, muchos estudiantes en Lawrence High School ignoran la regla del uniforme. Usan las camisas por fuera, los tenis están gastados, y la camisa del uniforme está cubierta por abrigos y sudaderas.

Los estudiantes en todas las escuelas nunca han tenido una reunión para explicarles las reglas. Ellos no tienen tan siquiera copias del manual de estudiantes o una copia del código de disciplina. Ellos son inocentes porque nadie les ha dicho cuáles son las reglas. ¿Cómo pueden romper reglas que no conocen?

El Superintendente Laboy ahora quiere imponer disciplina comenzando con los uniformes. Por favor, busque el mensaje que envió a todos los maestros de LHS, el cual reproducimos en la página 27, aunque solo en inglés.

Los maestros están pasando más tiempo en su día de trabajo vigilando lo que los estudiantes están usando que en enseñar. Cada día hay más presión en los profesores haciéndolos responsables de si los estudiantes lo están cumpliendo o no. Los integrantes del comité de ayuda para los damnificados de la Tormenta Noel de la República Dominicana que preside Ernesto Bautista, presentaron un informe general del proceso de recaudación desarrollado por dicho comité a raíz del paso del fenómeno atmosférico por la nación dominicana.

Bautista agradeció el apoyo y las muestras de solidaridad mostradas por la comunidad en general ante la tragedia que afectó a la República Dominicana.

Destacó además el papel que los medios de comunicación han jugado en la campaña de recaudación para los hermanos dominicanos.

En el informe que fue presentado a los medios de comunicación durante una rueda de prensa realizada en los salones de Casa Dominicana, 160 Garden St. la mañana de este jueves, 29 de noviembre, se establece que hasta el momento fueron embarcados tres contenedores, enviados vía New Jersey hasta la República Dominicana.

El último contenedor contenía 362 cajas con alimentos enlatados, 4,290 libras de arroz, seis sillas de ruedas, 28 pares de muletas, 343 cajas de ropa, 25 andadores y 8 bastones. Asimismo, 19 maletas llenas de ropa, 7 cajas de zapatos, 29 galones y 8 garrafones de agua respectivamente, dos cajas de medicinas, 40 galones de aceite y 10 paquetes de agua de 24 botellas cada uno.

Mientras que los artículos nos cuantificados son: cloro, detergente, cepillos dentales, toallas y papel sanitario, pañales desechables, frazadas, jugos y sábanas, entre otros.

Solo en Lawrence, Massachusetts, se ven las cosas que se ven durante el proceso electoral. Nuestras elecciones son únicas y el que no lo crea o no lo quiera creer solo está queriendo tapar el sol con su dedo.

A pesar que esta pequeña ciudad está en territorio americano, dentro de lo que el resto del mundo considera una de las más grandes potencias, las elecciones que se llevan a cabo aquí año tras año están llenas de trampas, vicios electorales y fraudes por sacar al aire libre.

Segundo, tiene que tener el conocimiento absoluto de la lista de votantes registrados. Y tercero, tiene que contar con muchos, muchos, muchos y muchos más amigos y conocidos dispuestos a darle una manita.

Si todavía no entiende cómo esto sucede para ganar unas elecciones, tome la ayuda del departamento de elecciones, donde a usted se le permite saber qué trabajador electoral le va a tocar trabajar en un precinto de su favor. Más todavía, si sus relaciones son extremadamente buenas, usted puede hasta cierto punto hacer su pedido de trabajadores electorales para algún precinto. Y si quiere más, hasta los mismos familiares de los empleados del departamento de elecciones, como por ejemplo la mamá de uno de los empleados y la esposa y el hijo del coordinador de las elecciones son empleados como trabajadores electorales pagados.

Con esa ayuda que usted acaba de leer,

ahora añádale el conocimiento de la lista de votantes. Donde si usted sabe que una persona registrada para votar ya no vive aquí y nunca se ha registrado en ningún otro lugar, usted puede enviar a uno de esos amigos o amigas suyas para que ocupe el lugar del que ya no vive aquí y vaya a ejercer el derecho del voto. Solo tiene que memorizarse el nombre completo, la dirección y la fecha de nacimiento por si se la preguntan. Todo eso lo provee la misma lista.

Y si le sobran amigos, lo único que tiene que hacer es enviarlos al departamento de elecciones uno o dos días antes de las elecciones y los pone a votar en ausencia. Es lo más fácil que un candidato puede hacer para conseguir votos. Sus amigos no tendrán nada de que preocuparse, por que los que trabajan allí no le van a preguntar a su amigo si estará indisponible o enfermo el día de las elecciones, o si estará fuera de la ciudad dicho día. Ambas razones necesarias para permitírselo botar en ausencia.

Todo, todo esto se hace aquí en Lawrence, elección tras elección. Pero si usted quiere mejores elecciones, va a tener que tomar el consejo que el di al principio de esta columna: Múdese a un país tercero mundista. Así mismo como lo está leyendo.

Aunque usted no lo crea, esos mismos países donde su gente casi no trabaja por la escasez de trabajos, donde la educación es casi inexistente, donde los derechos civiles a los cuales nosotros estamos acostumbrados se quebrantan a cada hora, estos países hacen algo que en la Ciudad de Lawrence, Massachusetts, no se hace- tener elecciones limpias y transparentes.

En Nicaragua las elecciones se hacen los domingos. Pero mejor todavía, ningún nicaragüense puede votar si tiene otra ciudadanía extranjera. Y tiene que haber rescindido de la misma por lo menos cuatro años antes de las elecciones en las que va a participar. Y si eso no es suficiente, ningún pariente dentro del cuarto grado de consanguinidad o segundo de cualquier candidato, militar, policíaco o ligados con vínculos conyugales o de parentesco puede trabajar en ningún centro de votación. Y si trabaja no puede ejercer el derecho al voto.

Si todavía no entiende cómo esto sucede para ganar unas elecciones, tome la ayuda del departamento de elecciones, donde a usted se le permite saber qué trabajador electoral le va a tocar trabajar en un precinto de su favor. Más todavía, si sus relaciones son extremadamente buenas, usted puede hasta cierto punto hacer su pedido de trabajadores electorales para algún precinto. Y si quiere más, hasta los mismos familiares de los empleados del departamento de elecciones, como por ejemplo la mamá de uno de los empleados y la esposa y el hijo del coordinador de las elecciones son empleados como trabajadores electorales pagados.

En Costa Rica la estabilidad política del país es sostenida a partir de fines de la década de los cuarenta cuando dio origen a uno de los organismos electorales más exitosos a nivel mundial utilizando maneras honradas al momento de hacer elecciones.

En México el votante no tiene que desplazarse mucho para votar, los centros de votaciones se establecen a no más de 200 metros de la residencia del votante.

En estos países si usted se registra a votar es mandatario ejercer el derecho al voto: Argentina, Australia, Austria, Bélgica, Bolivia, Brasil, Chile, Costa Rica, Cipre, Ecuador, Egipto, Fiji, Francia (para el senado solamente), Gabón, Grecia, Guatemala, Honduras, Italia, Liechtenstein, Luxemburgo, México, Nauru, Netherlands, Paraguay, Perú, Filipinas, Singapur, Suiza (en el pueblo de Schaffhausen), Tailandia, Turquía y Uruguay.

Para sorprendernos mejor, todavía en la mayoría de estos países los votos se cuentan a mano. No porque no puedan costear los altos costos de la nueva tecnología disponible, es simplemente un proceso más controlado y mejor garantizado por sus oficiales.

Lo que todavía aquí en Lawrence, Massachusetts, no se ve ni se palpa, en estos países tercero mundistas los criterios

que se utilizan para que sus elecciones sean limpias y transparentes son: la Igualdad, donde hay un sólo voto por cada ciudadano inscripto. Donde hay una condición para hacer efectivo este criterio. El poder identificar adecuadamente al ciudadano que ejerce el voto. El segundo criterio es la Accesibilidad, donde todos los ciudadanos deben tener la posibilidad de votar teniendo accesible el lugar de votar, no utilizando establecimientos privados, ni a mucha distancia de sus residencias.


En Kenya los ciudadanos tienen que votar por un candidato por puesto, no puede dejar la papeleta en blanco en ninguna de las áreas.

En Jamaica la inscripción del votante va conjunto a una foto, tomada por el gobierno federal, no por el local.

En estos países se usan tintas para marcar a sus votantes después de ejercer su derecho al voto: Albania, Arabia Saudita, Benín, Burkina Faso, Camboya, Timor Oriental, Etiopía, Gambia, Ghana, Guinea-Bissau, Guyana, Haití, Irak, Jordan, Lesoto, Liberia, Micronesia, Montenegro, Nicaragua, Ruanda, San Vicente y las Granadinas, Uganda y Yemen.

CIUDAD DE LAWRENCE DEPARTAMENTO DE POLICÍA AVISO A LOS CONDUCTORES DE VEHÍCULOS

Sec.19-72 Prohibición de estacionamiento durante algunos meses, entre las 12:01 a.m. y 6:00 a.m. en lados y días alternos de la vía pública, en algunas calles.

Durante el período de diciembre 15 a marzo 15 anualmente, entre las horas de 12:01 AM. y 6:00 A.M. diariamente, los vehículos deberán estacionarse alternativamente a un mismo lado de la calle, a menos que esté prohibido por la ley.

En los días pares del calendario, los vehículos deberán estacionarse a lo largo de los números pares de las calles. Los días nones del calendario, los vehículos deberán estacionarse a lo largo de los números nones de las calles.

De acuerdo con esta sección, el estacionamiento de vehículos será permitido solamente en las calles donde el ancho del camino entre las aceras o a lo largo de las mismas, mida no menos de 30 pies de ancho de acuerdo con los datos en poder del ingeniero de la ciudad, y no será permitido en ningún otro lugar prohibido con anterioridad.

Los vehículos estacionados en violación de esta disposición serán removidos bajo la dirección de las autoridades encargadas de remover la nieve; estos vehículos también pueden ser removidos por el Jefe del Departamento de Policía, sargentos u otros oficiales de alto rango en el departamento, designados de vez en cuando, por el Jefe de Policía

Cualquiera que pare o estacione su vehículo en cualquier lugar bajo el

control de la ciudad de manera que impida en cualquier forma la limpieza y recogida de la nieve o hielo, o en violación de cualquier ordenanza que prohíba el parar o estacionar vehículos en los caminos durante el mencionado tiempo y como se dijo, cualquiera que viole estas ordenanzas será responsable de los gastos de remolque y almacenaje de su vehículo así como a multas, en caso de ser sometido a tal castigo.

El costo por remolcar un vehículo removido por violación de esta sección y seguidamente el gasto de su almacenaje será de acuerdo con las tarifas establecidas por DPW de Massachusetts.

Enron V: la crisis de la vivienda



Enforcing the Uniform Policy at LHS

Now that the dedication is over and LHS is back to fend for itself... here are few tidbits:

The BMF School is the Business Management and Finance School and unfortunately, it's run like a business that is going under. The teachers are furious over the lack of support from the Sharkey, Julie and Miller administration. At the same time the building administration is overwhelmed by the mandates of Dr. Sharkey, Dr. Miller and wannabe Dr. Eric Julie. Sharkey and Julie spend the day figuring ways to complicate the lives of the small school principals. Miller is only at LHS on In-Service and pay days. Sharkey is seldom seen in the building.

The BMF school is run by a couple of most times likeable administrators. Former Haverhill High School Principal Joseph McMilleon runs the school and his assistant is Ed Reynoso. They try so hard do their best but their school is out of control.

Yes, the BMF School out of control but so is the PFA (Performing Fine Arts). The very worst is the International. The school is run by a tyrant. Rules are not enforced. Students act inappropriately. They are late for class and out of uniform. Students who are late don't have to sign in to the office. They don't have to sign in because nobody is in the office.

A couple of weeks ago, BMF Assistant Principal Reynoso was in Orlando, Florida with Dr. Laboy at the ALAS junket. Sal Petralia was with him along with Dr. Hector Torres of UMass and Special Assistant/Urban Affairs Liaison/Bodyguard Mark Rivera. They are touting the new LHS and the uniform policy.

Today, many students at LHS ignore the uniform policy. Shirts hang out, sneakers



Just an Observation

The epitome of arrogance is in front of the new high school building. Hanging over the main entrance to the new Lawrence High School is a sign that reads "A Legacy of Learning, Dr. Wilfredo T. Laboy, Superintendent of Schools." The Dr. Wilfredo T. Laboy, Superintendent of Schools logo can be found all over the city on trucks, literature, buses, schools, signs, and classified ads. It's as common as an EXIT sign. This shameless self promotion has been tolerated for years. Now Lawrence High School has become a monument to himself.

Alumni and students are baffled why the sign over the main door doesn't say Lawrence High School. Does the "Legacy of Learning" sign convey a deeper message? If that is true, does the fact that the sign is hung crooked convey another message?

are worn, sweat shirts and coats cover the uniform shirts.

Students in all schools never had an assembly to explain the rules. They don't have student handbooks or a copy of the discipline policy. They are innocent because nobody told them the rules. How can you break the rules if you don't know them?

Superintendent Laboy now wants to enforce discipline beginning with the uniforms. Please take a look at a message he sent to all LHS teachers which we reprinted on page 27.

Teachers are spending more and more of their day focusing on what the students are wearing than actual teaching! There is more and more pressure on the teachers to be responsible for whether or not the students are in compliance. It's gotten so bad that the principal, vice principal and safety officer often walk into the classrooms - in the middle of class - and pull kids out who are not in full compliance to give them detentions. It is such an interruption

and then it takes the kids another 10-15 minutes to get back on task again. On top of it, when students do something REALLY bad (like swear at a teacher or fight) they don't get detentions. The discipline is very inconsistent.

The other issue is that some schools (PFA most notably) don't seem to enforce the uniform rule or the "no electronics" rule at all, so the students at school where the rules are more heavily imposed feel "picked on".

I understand the benefits of the uniforms and I'm all for them, but when teachers lose 20 minutes per class dealing with uniforms issues, it's gone too far or it needs to be addressed in a different way.

Imagine! We have a sign that hangs over the main entrance of Lawrence High School that includes Dr. Laboy's name and

Mayor Manzi & Superintendent Whitten Announce Scholarship

Mayor William M. Manzi, III, and Superintendent of Schools Dr. Jeanne Whitten are pleased to announce the creation of the Charles J. Amshy and Sally A. Amshy Scholarship Fund. Sally Amshy and her late husband Charles J. Amshy, designated that their legacy aid students who have graduated from Methuen High School.

Sally Ann (Vaitkunas) Amshy was born in Lawrence on December 20, 1911 to William and Madeline Vaitkunas, who were immigrants from Lithuania. Sally attended school in Lawrence and Methuen. She graduated from Searles High School in 1930 and married Charles Amshy in 1933. She worked in local mills and later as a secretary at Raytheon Company in Andover prior to her retirement. A member of the Methuen Senior Center, she enjoyed taking trips with the seniors and gardening. Sally Amshy's desire was that the family's funds be used as scholarships to deserving students of Methuen High School.

These funds have been turned over to the City of Methuen and are to be maintained and invested for the purpose of annually awarding scholarships to graduates of Methuen High School who shall be attending a college or university to further their education. The Charles J. Amshy and Sally A. Amshy Scholarship Fund Committee will award \$5,000 each to four deserving seniors at this year's graduation commencement. The trustees would utilize the funds for college tuition and/or room and board, books and related expenses for needy and deserving students.

As part of the criteria for receiving these funds, it is clearly stated in her last will and testament that a scholarship committee be established known as the Charles J. Amshy and Sally A. Amshy Scholarship Fund Committee. The Scholarship Fund Committee is comprised of Mayor William M. Manzi and/or his designee Colleen McCarthy, Superintendent of Schools Jeanne Whitten and/or her designee Ann Marie Krusell, the Principal of Methuen High School, Arthur Nicholson, and the City Auditor, Thomas J. Kelly.

Applications are available in the Methuen High Guidance office. The applicant must be a Methuen High School Senior beginning his/her plan of study in an educational program above the high school level within six (6) months of high school graduation. The awards and amounts will be based on the following criteria: financial need, academic performance, character, involvement in extracurricular and community activities during their high school years, a personal essay, and letters of recommendation. Semi-finalists will be invited to an interview.

On Thursday, November 15, 2007, it was a rainy and windy day, but there was something to be happy about in the City of Lawrence. The Boys & Girls Club of Lawrence was hosting its 21st Hall of Fame Induction Ceremony honoring four amazing alumni, their achievements and their continuing contributions to making the club a better place for kids. This was the first ceremony since the new club building was inaugurated and everything from the pumpkin centerpieces to the desserts was a great accent to the celebrations of the night.

The night started off with the Pledge of Allegiance by the 2007 Youth of the Year, Amanda Diaz. Arthur Richter, President of the Board of Directors and a past Hall of Fame honoree as well, introduced the first honoree Brian Mitchell, who is always proud to say that he is from Lawrence. Brian is the President and CEO of Polychromix, which is a company that develops and manufactures advance chemical sensing and analysis systems, used in the material science industries.

Looking back at the club's importance he states, "I learned about the cultural diversity of an immigrant city like Lawrence and believe to this day it provided me a much broader education than I could have ever received in any classroom." He emphasized that night that he wanted to thank the kids of the club for the new club; he knows that so many are supporting the club's mission because of the dedication of those kids.

Next to be honored was Radhames Nova, who was born in the Dominican Republic and moved to Lawrence when he was thirteen with his mother, Esperanza Manukian. Within the club, Radhames was very active in basketball and the Keystone Club. After attending Central Catholic High School and earning a Bachelor of Science in French and Italian from Middlebury College, he then became the club's first Director of Development where he supervised efforts to raise \$8.5 million dollars towards the new building. He now works with Fidelity Investments Charitable Services as a Planned Giving Associate.

Radhames recalled that the friends he grew up with that steered away from the club ended up either killed, in jail or a burden to society. He credits the Boys & Girls Clubs as being "The Best Youth Organization in America, period," and the reason why he is successful. He knows that the club is still open because of the support of the community and he wants to encourage others to continue with that commitment. Not only was Radhames proud of his successes, but he was also proud of his sister's, Raquel A. Nova, who was also an honoree that night.

Raquel A. Nova is a woman of many

firsts: one of the first girls who signed up for the girls club, the first alumni to get a master's degree from Clark University and the first woman to be inducted into the Hall of Fame. However, many of these firsts could not have been accomplished if not for the relationships she built in the club. Raquel, like her brother, came from the Dominican Republic when she was ten and struggled with learning English. The club was always there to help in any situation especially with issues that young girls deal with in Lawrence.

Raquel remembers being a member of Project Advance-Teen Pregnancy Prevention program. There she received a shirt that said, "I'm going to wait" and ever since that moment she took those words to heart and listened to the club's message. She was able to enjoy her childhood and took advantage of the many opportunities the club had to offer. She knows how much the club has done for her and that is why she is giving back to the club in the biggest way – she is the Director of Education.

Raquel oversees all educational programs and is able to guide the youth to higher education. Raquel laughed about not being chosen Youth of the Year when she was younger, but recognizes that being inducted into the Hall of Fame is much more of an honor. She thanked everyone especially her eighteen month-old son, Noah, who was running around during his mom's speech.

The last honoree of the night, Robert

Sheehan, was introduced by Steve Kelley who said, "Bobby was the slow white guy on the basketball court!" Robert remembers Kelley telling him that everything he did was "wrong"! But since then he has done many right things. He has become the owner of Sheehan's Towing and Service Center in Methuen and South Lawrence since his father passed away four and one-half years ago. It was an emotional night for him because he was not able to share his excitement with his father but he thanked his family for all their support. Robert attributes Steve Kelley as being "the most influential role model" in his life next to his family and he is happy that the new club building is named after Steve.

Robert still gives back to the club by volunteering and serves as a Director for the YMCA, Boating Club, Central Catholic High School, and the Nevins Nursing Home.

Closing the ceremony that night was the Rededication of the Hall of Fame Wall where all 56 past honorees' names were read and included the four new honorees of 2007: Brian Mitchell, Radhames Nova, Raquel A. Nova, and Robert Sheehan.

There was one quote on the wall that serves as inspiration for all, especially the kids of the club. It read, "If you can DREAM it, you can DO it." The four honorees represented this message clearly; they are now living out their dreams and giving back to a club that gave them so much.

Lawrence Housing Partnership Announces Third Free Mortgage Check-Up Clinic for Local Homeowners

A free Mortgage Check-Up Clinic sponsored by the City of Lawrence's Housing Partnership, with support from the state's Massachusetts Housing Partnership will be held on Sunday, December 2nd from 1:00-3:00 pm at the Community Development Department at 147 Haverhill Street. Lawrence homeowners are urged to RSVP to 978-620-3510 for an individual appointment.

This is the Lawrence Housing Partnership's third Mortgage Check-Up Clinic. Mortgage lending experts and housing specialists from across the region will help local homeowners better understand their mortgage options and provide free and trustworthy advice on how to keep their mortgages healthy to avoid common financial pitfalls that can lead to foreclosure.

According to Andrea Ryan, Housing Manager in the City of Lawrence Community Development Department, more than 50 homeowners have received individualized mortgage advice at the past two clinics. "We see people at all stages. Some have already received notices and we must work very fast to help them. Most of the people who attended our August clinic came to ensure that they were fixing any problems before they were in trouble." Ryan explained that unfortunately, as the number of foreclosures rises, companies

claiming to offer simple and easy solutions for homeowners in crisis come out of the woodwork as well. And they often charge high fees and causing homeowners more trouble than they already had. Ryan says "People need to be careful and informed. It is very important for anyone who has a question or concern about their mortgage--no matter what stage they are in--to come to the Mortgage Clinic for free, trusted, expert advice."

The Partnership's efforts respond to the large and pressing need to educate homeowners. A growing problem in Lawrence, according to data collected by the Warren Group, in Lawrence there have been 327 petitions to foreclose and 234 foreclosure auctions since the beginning of 2007. Organizations across the state as well as the Governor's administration are urging homeowners to learn more about their mortgages and seek counseling to determine what they can do if they, too, may be in danger of losing their homes. Local non-profits Lawrence CommunityWorks, Arlington Community Trabajando, Neighborhood Legal Services, and Housing Options for Mass Elders all have expertise in helping homeowners with their mortgages and foreclosure prevention. Counselors from each agency will be at the clinic to speak with homeowners.

Local lenders involved in the clinic

also underscore the importance of local homeowners taking preventative action. Val Divito of Metro Credit Union has found that "homeowners are not aware that they may have a high risk adjustable rate mortgage with increase in the payments in the near future." These sharp payment increases, particularly for folks who are already struggling to pay their mortgages, can put homeowners in immediate jeopardy. Many owners of multi-family homes find themselves in particularly tough situations when units are vacant or tenants don't pay.

Lawrence homeowners in this situation or who have mortgages with high or adjustable interest rates should make a special effort to attend. People should bring whatever mortgage documents they have to ensure that they get the most effective advice possible.

The Mortgage Clinic is a City and Partnership sponsored public education event only. Homeowners will receive a free credit report. Lenders will not be marketing loan products or banking services. Participants will not do any refinancing or apply for any loan products during this event.

The event is free and fully bilingual. Those interested in attending are urged to RSVP with the Community Development Department by calling 978-620-3510.

The Lawrence Housing Partnership was formed in the spring of 2007 in response to the variety of pressing housing needs in the city. The Partnership's mission is to promote and protect quality, affordable housing and homeownership by developing collaborations that foster a stronger community. Currently facilitated by the City of Lawrence Community Development Office, members include local non-profit organizations from across the city and representatives from private industry, particularly banks and credit unions.

The speakers highlighted Mrs. Karl's career accomplishments and thanked her for her dedication to the children of Lawrence.

Patricia Foley Karl, a Lawrence native and long-time public school educator in Andover and Lawrence, recently completed seventeen years as Executive Director of the Lawrence Youth Commission/Lawrence Family Development & Education Fund.

Inc. and founded the Lawrence Family Development Charter School on West and Haverhill Streets in 1995. Mrs. Karl, members of the board and a group of Latino parents welcomed the 1993 Education Reform Act as an opportunity for strong parent involvement and leadership in a community-led school.

Mrs. Karl has had many successes in her career, but the one she is most proud of is Lawrence Family Development Charter School. Now in its thirteenth year of operation, the school was recently noted by the Commissioner's Office of the Massachusetts Department of Education as having posted one of the strongest gains in the state in the 2007 MCAS with a 33% point gain in grade 6 English Language Arts and a 14% point gain school wide in Mathematics.

Lawrence Family Development Charter School educates approximately 600 students from early kindergarten to grade 8, enrolling 99% Hispanic students with 87% below the poverty level according to the DOE profile. As news reports continue to emphasize the gap in academic achievement for Hispanic students both in the state and nationwide, LFDCS is a school committed to beating those statistics. Compared to

Hispanic students across the state, LFDCS outperformed at every grade level, with remarkable differences at the middle school level, showing an eighth grade Composite Performance Index (CPI) of 88.8 (LFDCS) to 75.2 (Massachusetts) in English Language Arts and 79.6 (LFDCS) to 49.0 (Massachusetts) in Math. The exceptional achievement of middle school students, well prepared for transition to high school, is seen in the high admissions rate of LFDCS graduates to excellent area secondary schools both private and parochial. More than 60% of the class of 2006 and 100% of the class of 2007 were accepted at one or more schools including: Phillips Academy Andover, Governor's Academy, Pingree School, Brooks School, Central Catholic High School, St. John's Preparatory School, Presentation of Mary and Notre Dame High School.

To ensure that the hard work of teachers and students culminates in exceptional opportunities LFDCS has inaugurated an endowment fund to provide scholarships for graduates. "The fund was named for Patricia Foley Karl, who" said Ralph Carrero, a co-founder and new Director/Superintendent, "worked tirelessly, inspiring students, believing always that education is the road to breaking the barriers and the cycle of poverty." Patricia will help to guide the fund over the next ten years, setting sights on a million dollar mark, or \$100,000 annually for ten years. The four-year-old students, currently in the school's K-1 program, will be eighth grade graduates in ten years—a statistic that makes real the urgency to provide the scholarships that will not only support the road to their futures but also for generations to come.

The school has always encouraged its students to high academic achievement and to "reach for the stars." The Patricia Foley Karl Scholarship Endowment Fund will ensure their reach is realized.

Laboy attempts to impose discipline

(Superintendent of Schools Wilfredo T. Laboy sent this message Wednesday morning, November 28, 2007.)

The issue of non-compliance with the LPS Uniform Policy has been brought to my attention by a number of staff, students and parents. It is my obligation and responsibility to address it. I don't want to name any name or point fingers at who is responsible for this situation that seems to be getting out of control very rapidly. Each adult member of the school community must do his/her part in order to keep students on track—administrators at the door, teachers in the classrooms—everyone means everyone, consistently and unconditionally, every period of the day, every day of the week. Students can not be allowed to be indifferent to the disciplinary actions that you must apply when they violate the LPS Uniform Policy. I have been told that students wear shirts either too big or too small and out of their pants, which are huge hanging down near the knees; sneakers in all colors; all types of boots, jackets and sweaters on top of the school shirt so nobody can identify them easily. If students are allowed this kind of defiance, they are in essence laughing in our faces by this repeated, incorrigible behavior.

I strongly believe that humans are creatures of habit. Everything we do is a result of patterns either copied or learned systematically. We must implement our Uniform Policy consistently, daily, and over a long period of time so that it becomes an inherent part of our school life and becomes institutionalized. We must adhere to a vision that in the near future no one will remember a time or place when students did not wear

uniforms. These students depend on each one of us to teach them the customs and habits that will ensure they become positive and productive individuals for today's society.

We will not allow anything less than the official uniform to be worn in school. That means THERE WILL BE NO STUDENTS WITH COATS, JACKETS, SWEATERS (UNLESS IT HAS THE LPS LOGO), NO COLOR SNEAKERS, (ONLY BLACK SNEAKERS), HOODIES, etc. STUDENTS MUST PUT THE EXTRA CLOTHING IN THEIR LOCKERS. THERE ARE NO EXCUSES NOW!!!! The only clothing allowable is the official uniform of each school... NO EXCEPTIONS, WITHOUT ANY EXCUSES. I will be visiting the school and I hold the adults responsible for enforcing the LPS Uniform Policy - we have an ethical and moral responsibility to do so.

Please contact me if any piece of this is unclear. Thank you for your cooperation and leadership.

Seems that nobody has made the Lawrence Public Schools aware that it is against the law to impose the use of uniforms in public schools. According to Massachusetts General Laws, Part I. Administration of The Government, Title XII. Education, Chapter 71. Public Schools, Schoolhouses, you will find the following:

Chapter 71: Section 83. Dress and appearance of students protected
Section 83. School officials shall not abridge the rights of students as to personal dress and appearance except if such officials determine that such personal dress and appearance violate reasonable standards of health, safety and cleanliness.

State to expand lab in Lawrence

On Friday, November 16, 2007, in a cold, windy morning, state and city officials gathered under a tent placed at 37 Shattuck Street, in Lawrence, to announce the \$22 million expansion, renovation of MassDEP's Senator William X. Wall Experiment Station in Lawrence. The green upgrades will include use of photo-voltaic cells as a solar energy source, a super-efficient HVAC system to save up to 40 percent on heating and cooling costs, rain gardens for better management of storm water, rain water recycling for non-potable uses and irrigation, large windows that will allow the sun to provide light and heat, installation of a "green roof," and a set-aside for plug-in hybrid vehicle parking spaces.

The Governor Deval Patrick Administration broke ground on the first phase of a planned two-year, expansion and renovation project which will transform the state environmental laboratory operated by the Massachusetts Department of Environmental Protection into a state-of-the-art, "green" building. The project will expand the historic 22,000-square-foot facility, by an additional 13,000 square feet.

"The Wall Experiment Station has a long history of excellence and innovation as an environmental laboratory, and in its new incarnation it will be a model building," said Secretary of Energy and Environmental Affairs Ian Bowles. "I applaud MassDEP for taking up Governor Patrick's call to lead by example with this state-of-the-art facility, which will demonstrate what can be done with energy efficiency, renewable energy, and water management."

MassDEP's Wall Experiment Station is Massachusetts' principal drinking water laboratory, and the facility annually performs 10,000 lab analyses of contaminants in water, wastewater, air, soil, hazardous wastes, fish, and other samples. The facility also certifies more than 150 commercial and municipal labs for compliance analysis of both potable and non-potable water.

"I'm thrilled that this Lawrence facility has been certified as a LEED green building," said Lawrence Mayor Michael J. Sullivan. "So much environmental work is done at the William X. Wall Experimental Station, and it is only fitting that this building has become so energy efficient."

The first phase of the project involves a \$16 million facility expansion, utilizing funds approved by the Massachusetts Legislature. Funding is also being provided by the U.S. Environmental Protection Agency through the State Drinking Water Revolving Fund. The second phase - to be funded through the Environmental Bond Bill - will involve a \$6 million renovation of the existing lab.

In 1993, following his sudden death, the laboratory was named in honor of former Senator William X. Wall, who represented Lawrence in the Legislature for 40 years. He had filed the bill that resulted in the current Station being built and occupied in 1954. Members of Sen. Wall's family attended the groundbreaking ceremony.

The Lawrence Experiment Station was founded in 1887 as one of the first laboratories in the world dedicated to environmental research. The work conducted there laid the foundation for modern methods of wastewater treatment and drinking water purification used throughout the world. In 1975, the American Society of Civil Engineers designated the facility as a "National Historic Civil Engineering Landmark."
