

# Los veteranos protestan en contra de Stokes

El Reverendo James F. Stokes estaba supuesto a asistir a la primera reunión del año del Comité Escolar de Lawrence, el jueves 10 de enero, 2008, de acuerdo con su promesa.

Temprano ese día, volantes comenzaron a circular por la ciudad llamando a los líderes de la ciudad y a los veteranos a venir a la reunión a hablar en contra de Stokes, el cual había sido arrestado por la Policía de Lawrence y miembros del FBI y encausado de cargos en la Corte Federal de Boston, por falsificar documentos y mentir acerca de haber servido en el servicio militar.

Los veteranos estaban terriblemente ofendidos por las mentiras de Stokes de haber servido en el servicio militar por 20 años. De acuerdo con los volantes, Stokes decía que había servido como Capitán en los US Marine Corps. También mintió cuando dijo que era un veterano de Viet-Nam y el de haber ganado medallas de servicio distinguido y hasta había recibido una medalla de Corazón Púrpura. El volante también decía de que un CORI (récord de antecedentes penales) que le había sido aplicado, revelaba que el Sr. Stokes tiene un extenso record criminal y hasta ha estado en la cárcel en Carolina del Norte.

El volante estaba pidiendo la renuncia de Stokes y si él no renunciaba, los veteranos iban a pedir a las autoridades de la ciudad que lo descalificara como miembro del comité. Los veteranos también estaban

Stokes no se presentó a la reunión. De acuerdo con la miembro del Comité Escolar Martina Cruz, él la llamó y le dijo que no vendría. Después de la reunión, el Alcalde de Lawrence, Michael J. Sullivan sugirió ante varias cadenas de televisión de Boston que Stokes debía renunciar. A la mañana siguiente, el Escribano de la Ciudad de Lawrence recibió, vía fax, la renuncia de Stokes. Un abogado de la ciudad y un oficial de policía de Lawrence le visitaron en su casa para certificar el documento.

Mientras nos preparamos para ir a la imprenta, el Escribano de la Ciudad William Maloney está esperando por una opinión legal del departamento legal de la ciudad sobre la situación con Greg Morris, si se le debe devolver su cargo, o si en efecto se necesita una nueva elección para decidir quien reemplazará a Stokes.

## Veterans protest against Stokes

Rev. James F. Stokes was supposed to attend the first meeting of the year of the Lawrence School Committee which was held on Thursday, January 10, 2008, as he previously pledged.

Early that day, flyers were circulating around the city calling on veterans and city leaders to come to the meeting and speak out against Stokes, who the day before was arrested by Lawrence Police and FBI Agents, arraigned and charged in federal court in Boston, with falsifying US documents and lying about serving in the military.

Veterans were deeply offended by Stokes fabricating documents about serving in the US Military for twenty years. According to the flyer, Stokes claimed to have served as a Captain in the US Marine Corp. He also lied about being a Vietnam War veteran and having medals of distinguished service and a Purple Heart. The flyer also said that a CORI background check revealed the Mr. Stokes has an

extensive criminal background and has even been in prison in North Carolina.

The flyer was asking for Stokes' resignation and if he didn't resign, veterans were going to ask city election officials to disqualify him as a member of the Committee. Veterans were also asking that Mr. Greg Morris, a legitimate veteran, who ran as incumbent against Stokes to be reinstated on the Lawrence School Committee.

Stokes did not show at the meeting. According to Committeewoman Martina Cruz, he called telling her that he wasn't coming. After the meeting, Lawrence Mayor Michael J. Sullivan suggested to Boston television that Stokes should resign. The next morning, Lawrence City Clerk received via fax, Stokes' resignation. It took a city lawyer and a Lawrence Police officer, to get his resignation notarized.

At press time, City Clerk William Maloney is waiting for a legal opinion from the city attorneys regarding the situation with Greg Morris, if he can be reinstated in his position or if in fact, we need a special election to decide who will replace Stokes.

### Dr. King, nosotros tenemos un sueño también

Fue en el año 1968, cuando el Rev. Dr. Martin Luther King Jr. fue asesinado. El impacto que ese hombre creó en el movimiento de los derechos civiles fue tan significativo que nadie pudo imaginarse que en el 2008 la Ciudad de Lawrence necesitaría un líder de su estatura pero si el Dr. King está mirando, debe estar muy desilusionado que sus enseñanzas no dieron resultado aquí.

Casi 39 años después de su muerte, el pueblo de Lawrence es víctima de brutalidad policíaca bien documentada. Seguimos eligiendo a personas que son una vergüenza para la nación poniendo sus intereses personales por delante de los del pueblo que están supuestos a representar. Hay carencia de responsabilidad en el ayuntamiento ya que nadie responde preguntas con respecto a los \$15 millones que se han perdido de la cuenta de "free cash".

Ahora Lawrence ha comenzado el nuevo año en una nota muy negativa, adquiriendo el tipo de publicidad que se encuentra en países del tercer mundo. Cuando no están de acuerdo con el resultado de las elecciones, deciden cancelarlas e imponer el deseo de alguien. En Lawrence, sugirieron eso la semana pasada. ¡Qué atrocidad!

La primera reunión del Comité Escolar fue caótica casi volviéndose un circo con cámaras de televisión de varias estaciones de Boston. Los reporteros se fueron con el sabor amargo que Lawrence tiene lo que merece pero nosotros sabemos más que eso.

Es hora de que hubiésemos alcanzado un poco del progreso del cual el Dr. King soñó en las últimas cuatro décadas. Necesitamos líderes que nos representen, no políticos en tiempo de elecciones solamente. Lawrence necesita ayuda porque nosotros tenemos sueños por completar.

### Dr. King, we have a dream, too

It was 1968, the year when Rev. Dr. Martin Luther King Jr. was assassinated. The impact that man created in the civil rights movement was so meaningful that no one could imagine that in 2008 the City of Lawrence would need a leader of such stature but if Dr. King is looking down, he must be quite disappointed that his teachings did not take hold here.

Almost 39 years after his death, people in Lawrence are victims of well-documented police brutality. We keep electing individuals who are a discredit to the country putting their personal interests ahead of the people they are supposed to represent. There is lack of accountability at City Hall by not answering questions regarding the \$15 million missing in the "free cash" account.

Now, Lawrence has started the new year on a very negative note, gaining the type of publicity found in third world countries. When they don't agree with elections results, they choose to cancel the outcome and impose someone's will. In Lawrence, it was suggested last week. What a travesty!

The first meeting of the School Committee was chaotic almost turning into a circus with television cameras from several Boston stations. The reporters left with the sour feeling that Lawrence has what it deserves but we know better.

We should have caught up to the progress Dr. King dreamt about in the last four decades. We need leaders to represent us, not politicians at election time only. Lawrence needs help because we have unfulfilled dreams.







Los miembros de Cosecha Borincana, Sara Iris Saldaña, Roberto Rivera y Domingo Meléndez se reunieron con el Alcalde de Lawrence, Michael J. Sullivan el jueves, 10 de enero, 2008, para informarle acerca de la próxima exhibición de autos planeada para el verano.

Domingo Meléndez, presidente de Cosecha Borincana, quiso mantener informado al alcalde acerca de los problemas relacionados a la exhibición de autos, los cuales retornaron a Lawrence después de 9 años de ausencia.

A propósito del costo de la protección policíaca, Meléndez dijo que eso no sería un problema para ellos, ya que la exhibición genera suficiente dinero para pagarla. “Este año estamos trabajando con una compañía empresarial que está dispuesta a compartir sus ganancias”, dijo Meléndez. Y hablando de quien pagaría por la protección policíaca de los festivales, el Alcalde Sullivan aseguró al grupo que si el Concilio aprueba el incremento de la tasa de impuestos, tal y

como fueron presentadas a ellos, la ciudad podrá pagar por ellos. “Yo no quiero herir la economía de la ciudad, pero si no son aprobadas y tenemos que cesantear a bomberos y policías, desde luego que vamos a cortar ese gasto y ahorrar más de \$100,000.00”, dijo el Alcalde.

La manera en que los organizadores del evento recaudan dinero es cobrando una tarifa por participar y un cargo adicional por cada categoría en la que quieran participar. “Las tarifas son, \$20 a \$25 a cada auto solo por participar y \$10 por cada categoría en la que quieran entrar, tales como pintura, sonido, etc.”, dijo Rivera.

El año pasado, la exhibición se llevó a cabo en el Pemberton Park, bajo negras nubes amenazadoras de lluvia, con 198 participantes apurados por terminar. Considerando que hay una gran cantidad invertida en los autos, con algunos dueños invirtiendo hasta \$25,000 en su conversión, este año, los organizadores de la exhibición de autos quieren llevar a cabo la exposición bajo techo y quieren utilizar el centro de Transportación Buckley para ese propósito.

El Alcalde Sullivan no ve un problema con usar el garaje localizado en la esquina de las calles Common y Amesbury, ya que, de acuerdo con los organizadores, el evento se llevará a cabo un sábado. “Podemos cerrar cualquiera de los pisos que ustedes necesiten y negociar cualquier arreglo con

los inquilinos”, dijo Sullivan agregando, “y pueden contar con un trofeo de 3 pies de alto - el Trofeo del Alcalde para el ganador”.

Este año será el 10mo aniversario de la exhibición de carros y los organizadores están contando con muchos más carros y consecuentemente, con una mayor audiencia que vendrá de sitios como Connecticut, New York, y de tan lejos como California. “Esta gente está planeando quedarse aquí por 2 ó 3 días, gastando dinero comiendo en nuestros restaurantes y permaneciendo en los hoteles de los alrededores”, dijo Meléndez.

El Alcalde Sullivan aprovechó la oportunidad para promover el Hotel Holiday Inn, localizado en la Ruta 114 en la intersección con la I 495 en Lawrence. “Ellos están ofreciendo una tarifa especial para grupos y festivales. Sólo tienen que llamar a Jessica, la administradora de ventas y decirle que yo te mando”.

Esta semana, los organizadores del evento darán una gira por el garaje Buckley con el objeto de encontrar el mejor sitio en el edificio y especialmente si hay suficiente claridad en el edificio para llevar a cabo el evento.

Durante el servicio religioso de ese día ofrecido en inglés y en español fue dramatizada la historia de los Tres Reyes

Magos.

Terminada la misa la Obispo participó de un almuerzo en el auditorio de la iglesia donde compartió con los presentes y les habló sobre la labor que viene realizando la Iglesia Episcopal y su trayectoria alrededor del mundo.

La Obispo estuvo contestando preguntas de los fieles relacionadas con la iglesia que dirige.

Cabe destacar que en la Iglesia Anglicana o Iglesia Episcopal sus miembros son cristianos y creen que ésta es una verdadera rama de la Iglesia Católica de Cristo y están organizados jerárquicamente como la Iglesia Católica, con obispos, pero separados del Papa.

Otra característica de la Iglesia Anglicana es mantener que las Sagradas Escrituras son la única autoridad de la fe, en el sentido de que éstas contienen todo lo necesario para la salvación, y que nada que no esté contenido en ellas puede requerirse como artículo de fe.

Igualmente de la misma manera que la iglesia católica romana y la ortodoxa la episcopal cuenta con monjas y monjes, lo que las hace tan similares.

más relevante es que en esta iglesia la mujer juega un papel importante ya que ella tiene decisión y voto en la misma, pudiendo convertirse hasta en obispos.

“Somos más democráticos, creemos en

la igualdad de géneros y que todos tienen voz y voto”, destaca la religiosa.

Tampoco existe un Vaticano, regido por un Papa.

Los sacerdotes tienen la libertad de contraer matrimonio.

Ella actualmente está divorciada, lo que representa una gran tristeza, pero dice no estar cerrada a una nueva relación.

Aunque no tiene hijos biológicos se siente ser madre a través de sus hijastros: dos hembras y un varón, quienes la han convertido en abuela de dos niños.

Harris es la máxima representación de la iglesia episcopal de Massachusetts, donde actualmente funcionan 192 iglesias.

Para ella el ser obispo es de suma importancia no solo porque es un indicio de que Dios creó a la mujer con los mismos derechos, sino porque puede ser un modelo para las jóvenes que pueden verla como un ejemplo dentro de la sociedad, con poder y voz que las hace seres valiosos y extraordinarios.

“No por estar casada o tener un hombre a su lado la mujer tiene valor, sino que por el mismo hecho de ser mujer, lo tiene”, dijo la Obispo.

## Violento fuego en iglesia abandonada



## Violent fire in an abandoned church

**A** vacant church located at 42-44 Park Street, Lawrence, went on fire around 6:00PM Sunday, January 13, 2008. The fire is under investigation.

No utilities were connected to the abandoned building, and according to Fire Chief Peter Takvorian was not until 20 minutes into the fire that they were able to douse the fire. "When I saw the fire, I knew that we could not save the structure and the lack of water pressure didn't help."

Takvorian also explained that thanks to two fire apparatus, one from Salem, NH and another from North Andover, were they able to bring water from as far as 800 to 1,000 feet away from the fire. Besides those two, apparatus from Andover, Haverhill, Lowell and Methuen came to help our firefighters.

"Flying embers ignited two roof tops in the surrounding buildings which we were able to suffocate. Fortunately there were not loss of life although one of our men received a knee injury, not life threatening, which is being checked as we speak", said Takvorian.

**U**na iglesia vacante localizada en el 42-44 de la Calle Park en Lawrence, se incendió alrededor de las 6:00PM del domingo, 13 de enero, 2008. El fuego está siendo investigado.

El edificio no estaba conectado a ningún servicio, tal como gas, electricidad o teléfono y de acuerdo con el Chief Peter

Takvorian no fue sino hasta 20 minutos después de haber comenzado el fuego que pudieron rociarlo con agua. "Cuando yo vi el fuego comprendí que no podríamos salvar el edificio pero la falta de presión en el agua no nos ayudó".

Takvorian explicó que gracias a dos camiones bombas, una de Salem, NH y la otra de North Andover, ellos fueron capaces de traer agua de una distancia de 800 a 1,000 pies del incendio. Además de esos dos, aparatos de Andover, Haverhill,

Lowell, y Methuen vinieron en ayuda de nuestros bomberos.

"Ascuas que volaban prendieron pequeños fuegos en dos de los techos vecinos, que por suerte pudimos sofocar. Afortunadamente no hubo pérdida de vida aunque uno de nuestros hombres sufrió una lesión en una rodilla, sin peligro de muerte, el cual está en el hospital siendo examinado en estos momentos", dijo Takvorian.

# Complacencia en lo cercano

El poeta latino Publio Ovidio Nasón (43 a.C. - 17 d.C.) decía: "Veo lo mejor y lo apruebo, pero sigo lo peor". Es la manifestación de la debilidad humana. Una cosa es tener claro lo que hay que hacer y otra distinta aplicarnos seriamente en su realización. San Josemaría dice en Camino: "¿Quieres de verdad ser santo? -Cumple el pequeño deber de cada momento: haz lo que debes y está en lo que haces". (Camino n.815). La voluntad significa la capacidad para hacer, para trabajar en aquello que se ha elegido como bueno, porque sus resultados serán positivos.

Uno de los mayores obstáculos en el fortalecimiento de la voluntad es buscar el éxito o el placer inmediato. Entonces el hombre es zarandeado y tiranizado por el instante más cercano y que más le apetece. Por este camino la persona no llega a vencerse y con frecuencia llega a la frustración porque no consigue lo que le pide el momento inmediato. Si no aprende a decir NO al deseo inmediato terminará entrando por el camino más fácil: el de la complacencia de lo cercano.

Pero observamos que la publicidad puede hacer un gran daño en la educación

de la voluntad estimulando precisamente el deseo de lo inmediato y creando necesidades cercanas de cosas que no satisfacen el ansia de felicidad del hombre.

Otro factor negativo es que estamos en una época confusa respecto a temas importantes. Por ejemplo se confunde el amor con el sexo, cuando son dos realidades distintas. El sexo es una condición orgánica que distingue en una misma especie dos tipos de individuos, masculino y femenino, entre los cuales tiene lugar un cambio de material genético. El amor, además de la atracción física, designa la unión de intereses, pensamientos y actos en torno a la persona amada y las manifestaciones de afecto y estimación recíproca que constituyen la base fundamental de los sentimientos de amistad, fraternidad y solidaridad. El amor cuando es auténtico implica gozos y renunciaciones, alegrías y sacrificios por el bien de la persona amada.

Estos errores crean un tipo de hombre que, aunque disponga de éxito profesional, su vida privada está rota, descompuesta, sin ejes de sujeción firmes.

# Mi Punto de Vista

## La semilla sembrada por un hombre llamado Martín

El Dr. Montesino, totalmente responsable por este artículo, es el Editor de LatinoWorldOnline.com y conferenciante del Information Processing Management Department en Bentley College, Waltham, MA.

El cuatro de abril de 1968, casi cuarenta años atrás, el Dr. Martin Luther King fue asesinado. Este mes, en enero 15 del 1929 había nacido en Atlanta, Georgia, y la nación que fue testigo de su larga dedicación y ardua senda al martirio que se ha convertido en su huella en esta tierra se detiene por unas horas para encender una vela en la tercera semana del mes y recordarlo con respeto.

No creo que sea capaz o siquiera autorizado para escribir sobre la vida de este hombre y reflexionar sobre la dimensión verdadera de su vida. Pero eso está bien. Otros han hecho lo mismo con más prosa y sabor que yo, tal vez con más derecho también. Pero yo creo que puedo compartir un pensamiento o dos con mis lectores sobre una vida que se ha convertido en un faro de esperanza para la raza humana, una luz que fue extinguida por una mano criminal que representaba lo peor en todos nosotros, pero un faro que sigue brillando hoy día.

Es fácil reflexionar sobre su vida y perder el significado verdadero de lo que hizo. Uno recuerda las caras cansadas y enojadas de aquellos que marchaban con él y podemos llegar a la conclusión errónea de que lo que hacía era luchar por una causa negra solamente. No me entiendan mal, su objetivo inmediato fue mejorar las

condiciones de vida de sus raíces y su raza, pero ese tren no se suponía que parara en esa estación. Su objetivo fue liberarnos a todos nosotros. No me importa si nuestra piel es blanca o carmelita; si sufrimos una injusticia él murió por nosotros.

Este mes, mientras nos sentábamos y observábamos las controversias que rodean al proceso de nuestra primaria electoral contemplamos una nación, los Estados Unidos del siglo 21, que toma forma en frente de nosotros y no tenemos otro recurso que no sea maravillarnos de la visión que sostuvo al doctor King en su camino a la eternidad. Ahora sabemos que mantenía esa esperanza: "Yo tengo un sueño," dijo en Washington en agosto 28 de 1963, "que mis cuatro hijos pequeños algún día vivirán en una nación donde no serán juzgados por el color de su piel sino por el contenido de su carácter." Por primera vez en nuestra historia vemos a un afroamericano y a una mujer compitiendo por la posición más elevada de nuestra nación y creemos que es posible que puedan ganar.

Desde luego, todavía existen algunos que odian y se revuelcan en el lodo del prejuicio porque no tienen otra forma de expresar sus creencias débiles y confunden la tradición con la inacción. Pero esas arenas de ignorancia y falta de entendimiento están siendo eliminadas por un tsunami oceánico de fe en el futuro de los Estados Unidos. Y hay muchos otros que están ansiosos por alzar sus ojos y ver el tope de la montaña que se convirtió en la única revelación en aquel

momento para el Dr. King. No sabemos cuales son los detalles de la dirección en que esta nueva esperanza nos va a dirigir. No podemos definir el final del camino en términos de personalidades, en realidad es irrelevante, pero estamos absolutamente seguros de que este nuevo paradigma es la cosecha de una semilla plantada por un hombre llamado Martin que no temía morir por sus sueños. La muerte, después de todo, nos afecta a todos más tarde o más temprano; la inmortalidad solo a unos pocos.

Y ese es mi punto de vista hoy.

### Yasmín Escoto, la portavoz de Laboy



# IRS Recomienda E-File con Cambios a Leyes de Impuestos

Con los paquetes de impuestos empezando a llegar a en el correo esta semana, el Servicio de Impuestos Internos (IRS) recuerda fijarse en cambios tardíos a las leyes de impuestos que pudieran afectar sus declaraciones.

El IRS está enviando este mes 16.5 millones de paquetes 1040 a los contribuyentes que en el pasado declararon en papel. El número de estos paquetes ha declinado rápidamente en años recientes, siendo 34 millones menos en tan solo cuatro años. Los paquetes en papel son mucho menos comunes según surge la popularidad de la declaración electrónica.

“El año pasado, el 57 por ciento de todas las declaraciones de impuestos usaron ‘e-file’, el método mas rápido, seguro y preciso que está disponible para el proceso”,

dijo portavoz del IRS Sara Eguren. “Y este año, declarar electrónicamente será lo más sencillo y efectivo especialmente para aquellos afectados por los cambios de AMT”, añadió.

Este año, los paquetes 1040 enviados por correo a los contribuyentes no incluirán ciertas otras formas debido a los cambios tardíos a las leyes de impuestos relacionados con el “patch” del impuesto mínimo alternativo (AMT). Estas están disponibles en versión actualizada en IRS.gov. Los contribuyentes que utilizan e-file deben cerciorarse de poner al día su software de impuestos antes de declarar.

Los cambios al AMT también significan que hasta 13.5 millones de contribuyentes que usan cinco formas relacionadas con la legislación del Impuesto Mínimo

El IRS también ha aumentado las alertas emitidas acerca de estafas por e-mail, conocidas comúnmente como estafas de “phishing” por pescar información, que alegan de manera engañosa proceder del IRS. Como regla, el IRS no envía e-mails que no han sido solicitados.

Alternativo (AMT) tendrán que esperar para declarar hasta que el IRS complete la reprogramación de sus sistemas para la nueva ley hasta el 11 de febrero, pero el efecto de este retraso podrá ser minimizado pues en temporadas pasadas solamente entre 3 y 4 millones de contribuyentes presentaron declaraciones con las formas afectadas durante estas semanas tempranas en la temporada.

El retraso de febrero causado por el “patch” del AMT afectará a contribuyentes que usen estas cinco formas:

- Forma 8863, Créditos de Educación.
- Forma 5695, Créditos Residenciales de Energía.
- El Anexo 2 de la Forma 1040<sup>a</sup>, Gastos del Cuidado de Niños y Dependientes para quienes presentan la Forma 1040<sup>a</sup>.
- Forma 8396, Crédito del

Interés Hipotecario.

- Forma 8859, Crédito de Nuevo Dueño de Casa en el Distrito de Columbia.

El IRS ha trazado como meta potencial el 11 de febrero para que se empiecen a presentar las cinco formas, permitiendo tiempo para poner al día y probar sus sistemas sin interrumpir operaciones. Las declaraciones electrónicas relacionadas a esas cinco formas no serán aceptadas hasta entonces y quienes declaren en papel también deberían esperar. El resto de declaraciones electrónicas y aquellas en papel serán aceptadas a partir de enero.

El IRS urge a los contribuyentes afectados a que declaren electrónicamente usando “e-file” para reducir el tiempo de espera de sus reembolsos. El e-file con depósito directo otorga reembolsos en un plazo tan corto como 10 días, mientras que las declaraciones hechas en papel toman de cuatro a seis semanas. Los contribuyentes pueden declarar electrónicamente a través de un preparador, con software comercial comprado o a través del Free File del IRS, si tuvieron ingresos de \$54.000 o menos.

“La gran mayoría de contribuyentes no se verán afectados por los cambios en la ley, así que se recomienda empezar temprano y aprovechar todas las muchas ventajas tributarias a disponibles que tan a menudo se ignoran”, dijo Eguren. “El IRS por su parte está haciendo lo posible por hacer de esta temporada tan serena como sea posible para todos”, concluyó.

Los contribuyentes también deben de estar enterados de créditos tributarios importantes como el Crédito Tributario por Ingreso del Trabajo (EITC), el Crédito por Ahorros y el Crédito Tributario por Niños. Existen límites de ingresos para los tres, pero créditos como estos pueden reducir de manera significativa la deuda en impuestos o aumentar los reembolsos.

El sitio de Internet del IRS, www.irs.gov, es una fuente de información disponible las 24 horas. Los contribuyentes pueden dirigirse a 1040 Central en IRS.gov para encontrar las noticias de impuestos más recientes, información acerca de los cambios a las leyes tributarias, publicaciones e información actualizada acerca de créditos tributarios muy valiosos.



## Green Card Para Víctimas de Abuso Doméstico

¿Es usted víctima de abuso doméstico? En los Estados Unidos existen miles de víctimas de abuso domésticos cuales no buscan ayuda por miedo a ser deportados.

Abuso domésticos incluye abuso físico, mental, o emocional. Personas quien son víctimas de este tipo de abuso pueden solicitar independientemente por su permiso de trabajo y residencia permanente (Green Card). El esposo o esposa quien comete el abuso no tiene nada que ver con el proceso, no tiene que firmar ninguna solicitud ni documento, y no asiste a la entrevista en el Servicio de Inmigración.

Para calificar para la residencia permanente el solicitante tiene que estar casado con una persona quien lo esté abusando. El abusador no tiene que ser ciudadano americano. Aún siendo el abusador residente permanente, la víctima del abuso puede calificar para obtener la residencia permanente (Green Card). Se requiere que la persona esté casada y se haya casado válidamente. Además de estar casados, se requiere evidencia del abuso. En estos tipos de casos hay muchas maneras de poder establecer la existencia del abuso. Ejemplos típicos de evidencia que acepta el Servicio de Inmigración son: récords médicos o de hospital, récords de sicólogos, récords de albergues para víctimas de abuso, affidávit de familiares o vecinos, etc.

En algunos casos no existen moretones físicos pero el abuso mental o emocional es tan obvio que el USCIS le otorga la residencia permanente (Green Card) al inmigrante. Los casos de maltrato mental o emocional son un poco más difíciles de establecer ya que más evidencia es necesaria. Sin embargo, la ley de Inmigración reconoce este tipo de maltrato como abuso doméstico y otorga residencias permanentes a los solicitantes que califiquen.

En este país existen muchas leyes cuales protegen a personas del abuso doméstico e incluyen protección específicamente para inmigrantes. El estatus legal o la manera de entrada (por la frontera o con visa) a los EE.UU. no afectan el caso de la víctima. Tampoco afecta que el abusador no sea ciudadano americano. Si usted está en una situación donde es víctima de abuso o maltrato doméstico no espere a ser otra estadística y protéjase hoy.

## Analizando la dieta de los estadounidenses

Aunque los libros de dietas siguen siendo parte de la lista de los libros más vendidos, parecería que esto está cambiando. Un reporte nuevo descubrió que las dietas ficticias están decayendo, y que ahora el factor que motiva más a las personas a estar a dieta es el querer sentirse más saludable. El nuevo reporte conducido por el grupo NPD en conjunto con el Programa Educativo de Procesadores de Leche, analizó el quién, cuándo, cómo y por qué,

de las dietas en este país. ## The Stokes saga

Last Friday, on our show "CrossOver" Richard Aybar and I tried to distance ourselves from the Rev. James Stokes dilemma stating that we don't condone his action and I personally said how much I loath liars. We had a very lively discussion because callers thought we were defending him. Not at all; we were examining the case.

I remember that a few years ago Laboy told everyone at the school department that no one was authorized to speak to a member of the press. I guess she must be Laboy's spokesperson.

# Cosecha Borincana's up-coming Car Show

Members of Cosecha Borincana, Sara Iris Saldaña, Roberto Rivera and Domingo Meléndez met Thursday, January 10, 2008 with Lawrence Mayor Michael J. Sullivan to inform the mayor about the upcoming car show planned for the summer. Domingo Melendez, president of Cosecha Borincana, wanted to keep the mayor informed about the issues involved with the car show, which returned to Lawrence last summer, after 9 years of being absent from the city. As far of the cost for police protection, Meléndez said that it won't be an issue, since the Car Show generates enough money to pay for it. "This year we are working with a promotional company willing to share their profits," said Melendez.

As who is going to pay for the festivals' police protection, Mayor Sullivan assured the group that if the council approves the budget as it was presented to them, the city will be able to pay for them. "I don't want to hurt the city's economy, but if the budget is not approved, and we have to layoff police and firefighters, of course that we have to cut that expense and save over \$100,000," said the Mayor.

Car Show organizers make a profit by charging the vehicle owners a fee to participate, and extra money for the categories in which they want to compete. "The fee is \$20 to \$25 to each car just to participate, and \$10 for every category they want to enter – paint, sound, etc.," said Rivera. Last year, the show was held in the open, at Pemberton Park, under menacing rain clouds with 198 participants rushing to finish. Considering that there is a lot of money invested in those cars, with some owners spending as much as \$25,000 in their conversion, this year, Car Show organizers want to hold the show under a roof and want to use the Buckley Transportation Center for that purpose.

Mayor Sullivan doesn't see a problem in using the garage located at the corners of Common and Amesbury, since according to the organizers, the show will happen on a Saturday. "We can close any of the floors you need and work any arrangements with the tenants," said Sullivan. "And you can count with a 3 foot tall trophy – The Mayor's Trophy for the winner," said Sullivan.

This year will be the 10th anniversary of the Car Show and organizers are hoping

for a larger amount of cars and consequently, a larger audience coming from places like Connecticut, New York and as far as California. "These people are planning to stay around for 2 or 3 days, expending money eating in our restaurants and staying in the surrounding hotels," said Melendez.

Mayor Sullivan took the opportunity to make a plug for the Hotel Holiday Inn located at Rt. 114 in the intersection with

I 495 in Lawrence. "They are offering special rates for groups and festivals. Just call Jessica, the Sales Manager, and tell her I sent you."

This week, car show organizers will be walking through the Buckley looking for the best location within the building and specially if there is enough light in the building to hold a show.

### The Hancock's softballers 70s

The fast pitch teams of the late sixties and early seventies had some excellent teams and made the City League very competitive. All games were played at the Hay den Schofield on Lawrence St. Some match ups would bring 1500 to 2500 fans. The Chez When/Sargent Club and Hermann Hall teams when playing each other brought great crowds and the playoffs guaranteed big crowd.

The Chez When had George Simonian a player manager, Joe D'Agata who would have been a superstar in any era. Dickie Lynch was a former Methuen great in baseball and continued in fast pitch softball. Eddie Aziz a third baseman was a slugger and a fine fielder; he works for Charlie Daher these days.

Don McLeod and Butch McFeeters were the pitchers. Mc Leod later becomes the women's hockey coach at Northeastern University. Butch came from and still resides in Wilmington.

The Hermann Hall team had Ernie Wilson and Dave Downey as hurlers. Ernie from Lowell has passed on and had a softball field in his hometown of Lowell named in his honor. Dave Miller, Willie Cartier, Irv Wermers and the great Billy Timmons had this team of aged and experienced stars ready to meet any team in the league.

Every team had their sights set on beating The Hancock's a team sponsored by the then Alderman Ray Hancock. This team and the aforementioned had been rivals for years and each game became a donnybrook, the contests created breaks in friendships and brought out the best of the players in each game. The fans loved the competition and plenty of betting went on in the stands.

The Hancock's featured the great Dick Krauss a former MHS 3 spot star and probably the league's most versatile player who could play anywhere including pitcher. Imagine have Krauss as your pitcher as DiResta catching. Dickie McCarron was at that time considered the top shortstop in the area. Dick could hit with power, run with great speed, had a cannon of an arm and was especially ready in big games.

Larry Klimas now a legend and a former LHS player on the Ed Buckley great and State Championship teams was

the second baseman. He sometimes played the outfield. Billy Bateman a CCHS Hall of Famer now would almost certainly be named to a softball hall of fame if there was one. He was one of many outstanding players of the hot corner in the league. Bobby Delduca was the baby of the team (meaning the youngest) he was an outfielder with good range and a fine arm. In all my years I've never seen anyone take to hitting a softball as hard and consistently as Bob. He became the cleanup hitter on a veteran laden team and didn't flinch at all. He was also a fine tennis player. His son "Bo" had a great career at MHS.

Frankie Ruediger was a young pitcher who has just retired from the Tribune and he had a great future in the league until his manager used him too sparingly. John Lenihan hit in every league he ever played in and this league was not an exception. A real quiet guy he came to play every game and no matter how many arguments over balls and strikes or safe or outs, John would be far away from the fray. He had that sweet picture book swing that many lefthander hitters owned.

Carmen Iannacilli was a speedster outfielder and is now in real estate in Salisbury where he now resides. He was a standout track man at CCHS and is a hall of famer at that school. He was once the principal of the now gone Kane School and an Athletic Director at LHS. John Buco was an outfielder and was a speedster and still lives in Methuen and he and Delduca was what we sometimes call "Goom Bas".

Bud Ohlin was a pitcher that was brought to me by a fan who said he "Could throw a ball through a cement wall." When I took Tommy DiResta to meet Bud and to have him pitch to tryout. He possessed a slow ball that was reminiscent to the days of "kitten ball". Tom and I kept waiting for him to become the flame thrower we heard of but it never happened, he did however have a good drop and great control. He also had a great sense of humor and won some big games for us. A trip to the mound to talk to Ohlin was an adventure for this manager, I'd be real serious and he'd have about 5 jokes to tell me. No matter the score how many men on base. He's dead now after overseeing the huge job of building the

Tribune building on route 114.

A guy that mingled with everyone and was a fun guy. Ray Gilbert was one of my coaches and he is retired now from the City of Lawrence his wife is retired and was in the nurse's department at the Greater Lawrence Technical School. Ray was part of the Inspectional Service Department for the City. Manny Lavoie was a pitcher originally from Haverhill where he starred as a hard running fullback in football. He would only pitch for me if someone came up hurt and could give us a few innings. He became the trainer for the Lawrence High teams and also the Lawrence Legion teams that had Nazy Brucato, Jimmy Twoomey, Mike Riccio, and Billy Callagy as the coaching staff.

The Hancock's was again favored to win this league but Simonian and company, Wilson, Timmons and that crew along with Dave Miller were saying, "Oh yeah, they have to beat us first". A great playoffs was on tap for all the Lawrence fans.

## Getting Started Now is Key to Success NFCC Offers Tips for Getting Your Financial House in Order

A few simple steps can make a dramatic difference in one's financial life, and there's no better time than now to get pointed in the right direction. The National Foundation for Credit Counseling (NFCC) recommends that consumers review where they are in order to determine where they're headed, and encourages them to consider implementing the following tips.

- Get organized. It doesn't matter if it's a full-blown home office or a shoebox, put all of your financial papers in one place. This will save you time, as you'll never have to search for misplaced documents.
- Commit to visiting your financial center at least once each week. Review any bills that have arrived, noting their due date. Plan to mail the payment 7 to 10 business days in advance of the due date if using traditional mail. Write the date that the bill needs to be mailed underneath where the stamp will go. File in chronological order and mail on time to avoid any late fees.
- Consider online bill paying through your bank. This is particularly useful for people who travel, are forgetful, or are procrastinators. The system is ideal for payments that are the same each month such as car and mortgage payments.
- Balance your checkbook each time you make a deposit. This should go a long way toward preventing overdrafts and incurring unnecessary fees.
- Reconcile your bank statement the day it arrives. This is not a task that anyone looks forward to, but it's easier to tackle it one month at a time rather than spending hours chasing down that penny from several months back.
- Create a budget. Call it a spending plan if that is more palatable. Contrary to what many think, a budget isn't restrictive. It actually allows you to spend your hard-earned money the way you want to, often stretching it even farther. Most importantly, it puts you in control of your finances.
- Track your spending. It's not the large expenses that trip us up. It's the small things, and the periodic payments. Commit to writing down every cent you spend for 30 days. Go back and review your expenses to see how much you were over or under your projected

spending for each category in your budget. Since you're now in control of your money, you can make the necessary changes to stay on track.

- Start saving. Put 10 percent of your take-home pay into an interest bearing account each month and forget it's there. This is your emergency fund. Promise yourself that you will not pull any money out short of a true emergency.
- Find money to save. Your budget's already tight, so where are you going to find the money to begin saving? Devote any windfall money to savings. This includes raises, bonuses, and birthday checks from Aunt Hazel.
- Contribute the maximum to your company's retirement plan. The maximum commitment is your goal, but short of that, make sure that you're contributing at least the amount the company will match. If not, you're throwing away free money.
- Have an insurance check-up. No one wants to be over-insured or under-insured. Schedule an annual visit with your insurance provider to make sure your policies are in line with your needs.
- Tackle debt. It is likely that credit card debt is preventing you from achieving many of your goals. When you're in a financial hole, stop digging. This means no more charging. It is impossible to become debt free while still adding to your debt load each month. Make your purchases with cash or a debit card. This way, when the money's gone, the spending stops.
- Review your credit report. Americans are allowed one free credit report from each of the major bureaus every 12 months. Go to [www.annualcreditreport.com](http://www.annualcreditreport.com) to access the reports online. Caution: there are many bogus sites with similar addresses trying to steal your personal information. Go to this site and only this site.

## My Point of View

# A seed planted by a man named Martin

On April 4, 1968, almost forty years ago, Dr. Martin Luther King Jr. was assassinated. This month, on January 15 1929 he was born in Atlanta, Georgia, and the country that witnessed his long dedication and arduous path to martyrdom that has become his mark on this earth stops for a few hours to light a candle on the third week to remember him with respect.

I don't believe I am capable or even authorized to write about the life of this man and reflect about the true measure

and dimension of his life. But that is OK. Others have done so with more prose and flavor than me, perhaps with more right as well. But I think I can share a thought or two with my readers about a life that has become a beacon of hope for humanity, a beacon that was extinguished by the hand of a criminal who represented the worst in all of us, but a beacon that continues to shine to this day.

It is easy to reflect on his life and lose the real meaning and reach of what he did. One remembers the tired and angry faces of those who marched with him and may reach the erroneous conclusion that he was fighting a black cause alone. Don't get me wrong, his immediate goal was to raise the living condition of those who shared his roots and his race, but his train was not meant to stop at that station. His goal was to liberate all of us. I don't care if our skin is white or brown, if we suffer an injustice he died for us as well.

This month, as we sit and watch the normal political controversies that surround our nation's electoral primary process, we see a new nation, the 21st Century America, taking shape in front of us and we have no recourse other than to marvel at the vision that sustained Dr. King on his way to eternity. We now know what maintained his hope: "I have a dream," he said in Washington on August 28, 1963, "that my four little children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character." For the first time in our history we see an African American and a woman vying for the top leadership position in the country and we believe it is possible that they might succeed.

Of course, there are still those who hate and wallow in the mud of prejudice because they have no other reason to express their weak beliefs and confuse tradition with inaction. But those sands of ignorance and misunderstanding are being wiped out by a tsunami like ocean of faith in the American future. And there are many more that are willing to raise their eyes and see now the top of the mountain that became Dr. King's sole revelation at the time. We don't know the details of where this newfound hope is going to lead us. We cannot fathom the end of the road in terms of personalities, actually that is irrelevant, but we are absolutely sure that this new paradigm is the harvest from the seed planted by a man named Martin who was not afraid to die for his dream. Death, after all, befalls us all sooner or later; immortality only a few.

And that is my point of view today.

## Owner and Manager of Springfield Rental Property Fined \$18,000 for Asbestos Violations

The Massachusetts Department of Environmental (MassDEP) has levied an \$18,000 fine against Belkis DeLeon of Methuen and Raphael DeLeon of Lawrence for violating state asbestos regulations. Rafael DeLeon is the owner and Belkis DeLeon is the manager of rental property at 25 Whittier St., Springfield.

Based on a complaint that illegal asbestos removal had occurred at the rental property, MassDEP conducted an inspection on January 30, 2007 and found that an asbestos-insulated boiler was replaced with a new boiler without instituting the appropriate asbestos handling and disposal procedures. MassDEP found extensive asbestos contamination within the stairwell and basement of the building, as well as outside of the building and in the city's wheeled trash containers.

"The failure to adhere to the specific requirements regarding the management of asbestos may impact the public health and the environment," said Michael Gorski, director of MassDEP's Western Regional Office in Springfield. "The asbestos regulations are very prescriptive in terms of proper removal and disposal of asbestos-containing materials so that asbestos fibers do not become airborne."

At the MassDEP's directive, Ms. DeLeon promptly retained a licensed asbestos abatement contractor to clean up the property.

Property owners or contractors with questions about asbestos-containing materials, notification requirements, proper removal, handling, packaging, storage and disposal procedures, or the asbestos regulations are encouraged to contact the appropriate MassDEP regional office for assistance. Stankovich is recognized for his 'no-nonsense' approach to public works management, his success in negotiating collective bargaining agreements, systems reform, as well as his technical expertise in Massachusetts Chapter 90 and 30B procurement procedures. He will be moving to the City and beginning work in February.

Fiorentini said that what impressed him most about Stankovich was his work in turning a troubled DPW in North Attleboro around.

"Nine years ago, the Department of Public works in North Attleboro was going through a series of difficulties and scandals, all too similar to the problems Haverhill is facing today. North Attleboro decided to

turn to an outside professional, Michael Stankovich, to turn their DPW around. In nine (9) years, he turned a troubled department into a top notch public works department, recognized as one of the best in the State. Mr. Stankovich turned around North Attleboro, and I am confident he can do the same in Haverhill."

Fiorentini said that at the same time as the nomination, he would submit to the city council a plan to reorganize the Department of Public works. The reorganization will eliminate several unfilled positions, and change the current position of Water, Waste Water director to Deputy Director of Public Works.

Fiorentini said that if the reorganization is approved, he will promote current water, waste water director Robert Ward to that position. "Robert Ward has done an excellent job in filling in a highway director, and acting director of the Department of public works." Mayor Fiorentini said. "I truly appreciate all that Bob has done and, if the reorganization is approved, I will promote him to the position of Deputy DPW director."

"Together, Mike Stankovich and Bob Ward create a 'dynamic duo' whose collective talents will positively impact the lives of all of the citizens of the City," lauded the Mayor.

Under the city charter, the appointment of Mr. Stankovich does not require city council approval. The reorganization requires council approval.

members of the Haverhill High Boys Swim Team, back to the renovated and improved Charles White Memorial Swimming Pool and Haverhill High School today.

The Pool has seen several improvements as part of the \$27 million upgrade to the Haverhill High School facilities, designed to eliminate any possible accreditation issues. Improvements include better lighting, electrical and fire safety upgrades, increased handicapped accessibility and heating, cooling and plumbing improvements. The pool received a 60-day temporary occupancy permit while other building issues are completed. A high school swim meet regularly scheduled for today was held.

"I'm thrilled that the pool is open for swimmers, including our Haverhill High swim teams and the private clubs that pay to rent the pool from the City," exclaimed

Mayor Fiorentini. "Many unforeseen construction problems and delays affected the pool building, but I'm glad the City staff, including the Fire Chief and his Inspectional Team, our new Permitting Ombudsman and Building Inspectors worked together to get the facility open as soon as possible," added the Mayor.

"The White Pool is another signature milestone in our ongoing High School Renovation project," announced Superintendent Buchanan. "I'm looking forward to the Hillies' Swim Team regaining a 'home pool advantage' for the rest of the season in an improved facility."

The opening of the pool eliminates the need to bus swimmers to other practice facilities, and allows the City to receive rental payments from outside swim leagues. The overall high school renovation is expected to be on time and on budget.

### Change brings a new set of challenges

Today we have a changed city, but every change brings with it an entirely new set of challenges. Today, we are challenged to bring in new jobs at a time when our State economy teeters on the brink of recession. To do this, we need to open new industrial parks to business and we need to expand the Hildale Avenue Industrial Park. There are so many challenges to meet. I'd like to speak of one of them today.

How we preserved shoe shop era

Four years ago, I spoke to you of one the challenge of turning brownfields into greenfields and taking old shoe factory buildings and turning them into vibrant centers of commerce.

The odds were against us and they said it couldn't be done. They said that the buildings were polluted, there was no parking, and those buildings, many of which had been vacant for half a century, could never be used again. We worked together and today, the old Hamel Leather building is in the process of becoming the Forest City development, a \$70 million development, the largest investment in the history of our city.

### River city

Preserving the shoe shop era was important, but the shoe shop era was not the only important era in our city and it is not the only era we should preserve. Before Haverhill was a shoe city, Haverhill was a ship building city. By the late 1700s three shipyards were working full time in Haverhill, building tall sailing ships to go out to the Atlantic. In 100 years, 252 tall sailing ships were built in Haverhill. For two hundred years, our shipyards sent ships and molasses and sturgeon to Europe and brought in goods from Europe.

Over the decades, new bridges downriver blocked our tall ships from sailing to the Atlantic. The last tall ship sailed from Haverhill in 1909—and a little over 200 years after our ship building tradition started, it was over. Then for the next 100 years, walls were built and houses faced away from the river, and we turned our back to the Merrimack. In the 1970s, this began to change. We began to clean up our river; polluters moved or cleaned up their act. Today, we are spending millions of dollars to separate storm water from waste water, and soon, the Merrimack River will be clean enough to swim in for the first time in a century. Today, instead of turning our backs along the river, we are turning towards it. Today it's clear: The

river is back!

But like every other change, this change brings with it its own set of challenges. As we look up and down the Merrimack today, we see vast stretches of vacant land. Someday, these tracts of land will be developed. Now is time to make certain it is done right.

Today's challenge is clear: we need to revise our zoning laws so that future generations will always be able to seeing and walking along and boating along the Merrimack. We need to provide incentives for private developers to allow public views, public boating, public walkways and public trails along the river. Sometimes we will need to go further, and block development which is not in the public interest, or acquire land for parks and trails when the private industry can not.

This month, I will announce a Waterfront Development Task force, to develop those new waterfront zoning laws.

Later, I'll ask the city council to work with me to develop a Waterfront Commission, with powers to control, acquire and develop land, parks and trails along the river, using eminent domain powers if necessary, so that future generations will always be able to enjoy the river. The details are complicated and will require study and public hearings, but the overall concept is quite simple: the river belongs to all of us, not just to those private interests with the money to develop along the river. Our economic crisis

Make no mistake about it; preserving public access to the river will be difficult. It is much more difficult today because of the financial crisis facing every city in the State today.

Today, we live in the shadow of a recession, with growth slowed to a trickle. Today, every city in the State sees its fixed costs rising faster than its revenues.

On top of the challenges facing every city in the commonwealth, we have our own unique set of challenges caused by the collapse of our regional hospital, the Hale Hospital.

### Managed competition

To meet these challenges, we must constantly reinvent government. This year, we'll reorganize our public works

department, and then we will introduce managed competition: we will ask private industry and government to compete for some public jobs. Our goal is a government so efficient that we can beat the bid of any private industry that wants to do city work and pays fair wages and benefits.

Managed competition worked in Charlotte North Carolina, Phoenix Arizona, Indianapolis, San Diego and in Springfield, Massachusetts. It can work here today.

Call to work together

But managed competition is only part of the answer. Solving our financial problems will require that all of us work together in a common sense of shared sacrifice to solve our common problems. Today, I invite the city council, the school committee and our municipal unions to work with us to solve the greatest financial problem we face, controlling out of control health care costs. Municipal Partnership

That municipal partnership has to include our State and Federal officials. Part of the reasons we overcame the odds of four years ago, is the assistance we received from our State and Federal officials, we thank them for their help. That spirit of working together can bring us through the next crisis as well.

### Conclusion

But ultimately, this is not a government of Mayors and elected officials, this is your government. With your help, we overcame the great odds we faced four short years ago and today, Haverhill is a better and different place than it was just four years ago. Today more people are working, our children are getting a better education, we have more places to shop, and the Haverhill renaissance is alive and well.

With your help, we can overcome the odds that we face today. Now is our time, and now is your time. I can not promise you miracles, but I can promise you this. We are going to work as hard as we can over the next two years to make this city the great city we know it can be. Join with us, work with us, lend us your hand, your ideas, your energy and your input. This is a great city, and working together, we can make it better still.

On Tuesday, January 8th at the L/MCC offices located at 112A, East Haverhill St., in Lawrence, Neighbors in Action Block Captains were joined by Lawrence Mayor Michael J. Sullivan and Lawrence Police Chief John J. Romero to officially announce the beginning of the Neighbors in Action Block Watch project. Over the past year, the Lawrence/Methuen Community Coalition has worked closely with the Lawrence Police Department on a comprehensive plan to engage community residents in keeping their neighborhoods safe.

Residents have joined LMCC staff, neighborhood representatives and Lawrence Police, in raising public awareness about the program through local radio, coordinating Neighborhood Block walks with neighborhood leaders and City department heads, and facilitated a series of trainings for area residents on the reporting of suspicious activities.

Now, today, with the placing of the first new Neighbors in Action Block Watch sign, Block Captains who went through a four hour training, will now report suspicious activities through a special Block Watch Hotline located within the Lawrence Police dispatch center.

The Neighbors in Action Program was initiated by the requests from neighborhood association's leaders to re-institute the program after former Governor Mitt Romney eliminated the old Massachusetts Crimewatch Program under his tenure.

## MassDEP aerial surveillance tool reveals unauthorized alterations Methuen Resident Penalized \$10,225; Agrees to Restore Altered Wetlands

The Massachusetts Department of Environmental Protection (MassDEP) has penalized a Methuen resident, Lisa M. Pappalardo, of 221 Tyler Street, for the unauthorized alteration of a wetlands resource area. The violations were first brought to light using aerial surveillance, a tool that has allowed MassDEP to locate valuable resource areas that were altered or destroyed without approval.

On July 13, 2007, MassDEP inspected the site where an equestrian center is operating and confirmed that 2,086 of bordering vegetated wetlands (BVW) had been filled and graded. In addition to placing a horse paddocks on the filled area, an indoor riding arena (65 x 120 feet

in diameter) was constructed in the buffer zone to the BVW.

MassDEP determined that the area was filled in 2003 with wood chips, measuring, in parts, up to 12 feet in depth. Pappalardo conducted the work without required approval from the Methuen Conservation Commission.

In the wake of that inspection, Pappalardo subsequently moved to submit a restoration plan to MassDEP for the area that was altered and that plan was subsequently approved on November 7, 2007.

"Restoration of altered land after the fact is a last resort, and no one's preferred method, but residents have to realize these resource areas serve a vital public function

and if you wish to work in or around the resource area, you need to provide the local conservation commission a written request or notice - and follow through on obtaining approval," said Richard Chalpin director of MassDEP's Northeast Office in Wilmington.

Pappalardo has agreed to submit yearly monitoring reports in order to verify the long-term viability of the restored area. MassDEP has agreed to suspend \$8,225 of the penalty pending full compliance.

MassDEP is responsible for ensuring clean air and water, safe management and recycling of solid and hazardous wastes, timely cleanup of hazardous waste sites and spills, and the preservation of wetlands and coastal resources.






### BEANO, CAT - BLACK DSH, NEUTERED MALE






