Tsongas fue elegida en una elección especial en 2007 y se sienta en la misma silla que tres décadas antes fuera ocupada por su difunto esposo, el ex congresista de EE.UU., el Senador y Candidato Presidencial, Paul Tsongas.

La Congresista Tsongas sirve en el Comité de Servicios Armados, donde está trabajando para asegurar que nuestros hombres y mujeres tengan el equipo y protección que necesitan. También ella forma parte de la Comisión de Presupuestos, donde se centra en abordar el déficit y la devastadora deuda creados en los últimos ocho años, mientras que al mismo tiempo da forma a un presupuesto nacional que

fortalezca nuestra economía y cree puestos de trabajo.

En 2009, la Congresista Tsongas se unió al Comité de Recursos Naturales, que supervisa la legislación relacionada con la producción de energía nacional, parques nacionales, ríos, bosques, océanos y áreas silvestres.

Jon Golnik nació en Middletown, CT. De niño vivió en muchos lugares diferentes que incluyeron Tennessee, Nueva York, Nueva Jersey, Michigan y Florida.

Después de graduarse de la escuela secundaria pública en el centro de Florida en 1984, Jon tomó un año libre antes de asistir a la universidad. Sus padres le animaron a pasar su "año sabático" sabiamente y durante 6 meses se marchó a Cuernavaca, México, donde estudió español.

Al volver a casa por Navidad, pronto volvió a marcharse después de haber asegurado una pasantía en Chicago, patrocinado por la administración del Alcalde Harold Washington. El internado apoyaba a los jóvenes que irían a vivir y trabajar en los barrios hispanos de Chicago donde Jon trabajó como voluntario en Casa Central, una de las mayores agencias hispanas de servicio social en Chicago que ofrece programas para todas las edades.

Jon asistió a la Universidad Johns Hopkins, donde en 1992 recibió una maestría en Estudios Internacionales que se centró en Economía Internacional y Estudios Europeos. En 1993, se graduó de la Wharton School of Business de la Universidad de Pennsylvania con un MBA centrado en la gestión multinacional.

Aunque muy activo en la política mientras estaba en la escuela secundaria y la universidad, Jon creció cada vez más desilusionado con el proceso político. Los

"insultos" que acompañan el partidismo cada vez mayor en la política del país lograron ahogar los problemas críticos de nuestros tiempos.

Los desafíos de hoy son algunos de los más importantes que la población de Estados Unidos debe hacer frente en una generación y sin embargo nuestros funcionarios electos no han sido capaces de abordarlos, por lo que, más gente como Jon y otros, saben que tiene que haber un mejor camino hacia adelante.

Desde la asistencia sanitaria y el déficit del gasto a la inmigración y Afganistán e Irak, la elección de 2010 será la más importante en los últimos 30 años. 

Próxima reunión del Concilio

El Concejal del Distrito F Marc Laplante ha sugerido que la posición de Director de Desarrollo Económico debió haber sido ofrecida a Michael Sweeney, ex director del Departamento de Planificación a quien la Administración de Lantigua le dio lay off.

La ley dice que una persona en lay off debe ser considerada primero si surge un trabajo en la misma clase. Esos dos puestos de trabajo no están en la misma clase. Pero, Sweeney ni siquiera solicitó la plaza cuando fue anunciada. Por lo tanto no puede ser considerado. El requisito no es que una persona sea colocada en cualquier trabajo... solamente que sea considerado.

Hace un par de semanas, el Concilio de Lawrence estuvo debatiendo la supresión

de los teléfonos celulares durante sus reuniones. La propuesta fracasó ya que la mayoría de los concejales sienten que eso es parte de la vida moderna y que dependen de él. Algunas personas se han quejado de que los algunos concejales están recibiendo instrucciones por medio de mensajes de texto que influyen en su manera de votar.

Bueno, hice algunas investigaciones por mi cuenta y esto es lo que encontré: Los mensajes de texto son técnicamente récord público. Ellos deben ser preservados y conservados por el Escribano de la Ciudad como parte del récord de la sesión pública. Estoy segura de que nadie los mantiene, pero debían hacerlo.

El 1ro de julio pasado, nuevas regulaciones sobre la Ley de Reuniones Abiertas (Open Meeting Law) entraron en vigencia y la cuestión de la tecnología fue incluida. El uso del correo electrónico para preparar una reunión o desarrollar la política no está permitido, y la razón de esto es porque el público no puede ver lo que los miembros del comité están hablando a través de correo electrónico. La ley aprueba el uso del correo electrónico con el propósito de mandar por correo las agendas, actas de

Comisión de Derechos Humanos

La Comisión de Derechos Humanos se reúne lunes, 13 de septiembre en la Cámara del Concejo Municipal en el Ayuntamiento, a partir de las seis de la tarde. Regularmente se reúnen el primer lunes de cada mes, pero debido al feriado del Día del Trabajo, se aplazó para el lunes siguiente.

reuniones, material para el debate de la reunión, etc.

Otra forma positiva de usar la tecnología es con el uso de Skype. Un concejal en otra ciudad fue hospitalizado el invierno pasado y consultaron con el Fiscal de Distrito sobre el uso de cámaras para que le permitiera participar en la reunión de su cama del hospital y se la concedieron. Ahora, la Procuradora General va a proponer normas que permitan la participación a distancia por los miembros de las juntas, siempre y cuando todos puedan escucharlo.

Aunque el correo electrónico puede hacer más fácil y más rápido para comunicarse, pueden traer problemas a la gente. ¿Recuerda cuando los fiscales estatales incautaron e-mails en un escándalo que hizo que el ex presidente de la Cámara de Massachusetts Salvatore F. DiMasi, renunciara a su puesto? Y, el tribunal más alto del estado dictaminó recientemente que un comité escolar en un suburbio de Boston utilizó el e-mail para deliberar cometiendo una infracción de las Leyes de Reunión Abierta del estado.

Incluso mejor que ese fue el caso del Alcalde de Detroit Kwame Kilpatrick y su jefa de gabinete, Christine Beatty que estaban teniendo una aventura amorosa mientras estaban casados con otras personas. En 2002 dos oficiales de policía fueron despedidos y demandaron a la ciudad. Kilpatrick alegó que se había retirado voluntariamente por lo que los ex oficiales revelaron lo que sabían del romance, lo cual el alcalde y la Sra. Beatty negaron.

El periódico local publicó extractos obtenidos de 14,000 lujuriosos mensajes de texto enviados entre Kilpatrick y Beatty en 2002 y 2003. Así que, como se puede ver, nada es borrado para siempre. Mensajes de texto dejan un rastro de papel.

Naomi Stemberg, la abogada del Comité Escolar los ha amonestado diciendo: "Usted debe saber que está en violación de la Ley de Reunión Abierta", cada vez que oye hablar de correos electrónicos que se intercambian entre ellos.

Todas las conversaciones entre los miembros de una junta o comisión debe hacerse en público, esa es la mejor manera de evitar infringir la ley.





Sólo puedo imaginarme lo que veríamos si fueran vistos en público. Estoy segura de que mucha gente se sentiría avergonzada por lo que dicen.

Chief Romero, "No necesitamos un SubJefe"

Eso es lo que el Jefe de Policía John J. Romero dijo la semana pasada como consecuencia de las objeciones de algunos concejales al nombramiento permanente de Melix Bonilla para dicho puesto. El Chief Romero declaró que, puesto que 24 policías fueron despedidos, no hay necesidad de un SubJefe.

Esta afirmación me puso a pensar. En octubre del 2008, Lawrence tenía 140 oficiales y dos subjefes. Cuando el Deputy Chief Emil De Fusco se retiró, su posición fue eliminada por el Concilio sólo como un medio para ahorrar dinero, no porque él no fuera necesario. Ahora que hemos despedido a 24 policías, el jefe dice que no necesita a ninguno.

Quizás Chief Romero no tiene ningún tipo de esperanza que encontraremos los

fondos necesarios para poder restaurar a algunos de los oficiales de policía de la ciudad. Me pregunto qué pasaría si logramos traerlos de nuevo. ¿Tendríamos que empezar de nuevo creando el cargo a través del concilio para nombrar a un subjefe si éste se suprime ahora? ¿Podría regresar Bonilla a esa posición ya que fue la última persona que la ocupó?

Pagando impuestos atrasados

La lista recientemente publicada de las personas que deben impuestos y facturas de agua a la Ciudad de Lawrence es una vergüenza para el ayuntamiento por no hacer su trabajo durante los últimos veinte años. En junio del 2004, el Alcalde Michael Sullivan publicó una oferta para las personas que debían mucho por largo tiempo que les permitiría reducir la deuda por un 50% de la factura. Me pregunto cuántos se aprovecharon de esa oferta porque veo algunos de esos nombres de nuevo en esta lista.

Hace un par de años me llamaron toda clase de nombres porque dije que si una viejita no puede permitirse el lujo de pagar sus impuestos a la propiedad, ese es el momento de vender e irse a vivir en un hogar de ancianos o con familiares. ¡Ay, Dios mío! Fui atacada por todos los frentes, pero seamos realistas. Nosotros somos los contribuyentes de esta ciudad que pagamos

por todos los servicios públicos y los empleados municipales, pero no somos el departamento de bienestar público. ¿Cómo podemos prevalecer como ciudad si permitimos que eso suceda?

El propietario sabe cuáles son sus responsabilidades y si no puede cumplirlas, no tiene derecho a ser propietario. ¿Qué hay de malo en poner un gravamen sobre cada propiedad que debe dinero de los impuestos y las facturas de agua?

Ya que estamos hablando de esto, vamos a poner un gravamen sobre el nuevo Burger King en Broadway. Su propietario es Stephen Stapski de Andover, que también posee Merrimack Paper Co. en South Canal St., el sitio de varios incendios recientes. Ahora está diciendo que él no es el dueño del edificio, sino que ha sido la única persona que ha respondido a cada denuncia e hizo los arreglos para un plan de pagos con los bomberos por una deuda que tenía con ellos. Les debe \$150,000 y él está pagando \$1,000 mensuales.

Según Lenny Degnan, jefe de despacho del alcalde, "¿Por qué habría que organizar un plan de pago en un edificio que no posee?"

La eliminación del Programa ARC

La semana pasada escribí acerca de ARC (Anothr Route to College - Otra Ruta a la Universidad) en Lawrence High School y se me acercaron varias personas ya sea porque no estaban familiarizadas con este programa o querían saber más. Creo que todo lo que podamos hacer para guiar a nuestros jóvenes nunca se podrá considerar un derroche de fondos públicos, sobre todo si se trata de algo que se hace a través del departamento escolar. Este era un programa que sirve a 30 estudiantes en su último año de la escuela secundaria operando durante los últimos ocho años con una tasa de éxito del 100%. Todos ellos pasaron las pruebas del MCAS y se graduaron de la secundaria y algunos incluso fueron a la universidad.

La belleza del programa es que asistieron a clases en Northern Essex Community College en el Campus de Haverhill, iniciándolos en el ambiente universitario y la posibilidad de poder asistir a educación superior.

Cuando los miembros del comité escolar votaron a favor de eliminar el programa, se mencionó el ahorro de \$72,000 en gastos de transporte y serían capaces de contratar a un tercer maestro para continuar el programa en Lawrence High School y ampliarlo incluyendo a otros estudiantes. Bueno, ese no es el mismo tipo de programa porque no se encuentra en un ambiente universitario. Por cierto, con la expansión de Northern Essex en el Riverwalk, hay espacio suficiente para sostener el programa en Lawrence, sin necesidad de transporte.

La escuela está a punto de comenzar y no he oído decir que habían contratado a ese tercer maestro de MCAS.

El IMC es una forma de comprobar si un niño tiene un peso saludable en comparación con otros niños de su misma edad y sexo. Los resultados se enviarán por correo o serán directamente notificados a los padres o tutores de cada estudiante evaluado.

Los niños con un IMC elevado tienen mayores probabilidades de convertirse en adultos obesos o con sobrepeso, así como de padecer diabetes, enfermedades cardíacas y algunos tipos de cáncer. Ayudar a los niños a alcanzar y mantener un peso saludable ahora puede prevenir enfermedades graves en el futuro. Lawrence City Councilors meet with FEMA to fund flooding repairs

Lawrence City Councilors Marc Laplante (District F) and Eileen Bernal (District E) met with the Federal Emergency Management Agency (FEMA) and Lawrence city officials on August 25 to ensure that Lawrence receives Federal reimbursement for costs associated with repairing the damage from the March 12 floods.

"Every dollar is critical in our City's budget crisis, and had Councilor Bernal and I not intervened, Lawrence was in extreme jeopardy of forfeiting the federal money allocated to reimburse the City for repairs from the March floods," said Councilor Laplante.

The spring flood damaged the Route 114 sewer pumping station on the North Andover line and the Lisa Lane pump station on Mount Vernon. The costs for replacing the pumps stations are about \$50k with the possibility of funding a more permanent solution that would cost approximately \$500K.

"Having FEMA come in and sit down with us to map out a time line to ensure that these costs are covered is crucial, especially with the state of the City's finances," said Councilor Bernal. "The DPW staff was very responsive in providing needed information. This was a team effort that will directly benefit our districts."

The sewer pump repairs are critical in alleviating sewer backups from the residences and Lawrence businesses along

Route 114 and the Lisa Lane area of Mount Vernon.

"These repairs not only help the neighbors who live in the Lawrence housing complexes along the Andover and North Andover line, but also the small business owners who need to shell out sorely needed cash to cleanup their businesses after a sewer backup event. Flooding along the Shawsheen River and Route 114 has been far too prevalent the past few years, and these small businesses and home owners deserve a permanent fix," stated Laplante.

"The Lisa Lane pump station was devastated by the spring flooding," added Bernal. "Getting that back on line at full capacity will bring a true sense of security to the residents in that area whose homes are directly impacted by it, as well as alleviate a burden for the DPW staff who now need to constantly monitor it in its current state." The \$50k to \$500k savings can be put toward repairing other critical sewer infrastructure such as the malfunctioning sewer lift station in Lawrence's Colonial Heights.

Laplante is in his third term on the Lawrence City Council. He is the Chairman of the Lawrence City Council Housing Committee, and also serves on the Lawrence City Council Personnel Committee. 

Next Council meeting

District F Councilor Marc Laplante has suggested that the position of Economic Development Director should have been offered to Michael Sweeney, former director of the Planning Department who was laid off by the Lantigua Administration.

The law reads that a person laid off should be given first consideration for a job in the same class. Those two jobs are not in the same class. Nonetheless, Sweeney did not even apply for it. If he did not, then he can't be considered for it. It does not require that a person be hired for ANY job... just considered.

I will report more on the September 7th City Council meeting next week.

Please, please, use your cell phones at meetings!

A couple of weeks ago, the Lawrence City Council discussed the abolition of cell telephones during their meetings. The proposal fell through because most of the councilors feel that they are part

of modern life and they depend on it. A few people have complained that certain councilors are getting instructions via text messages influencing the way they vote. Well, I did some research on my own and this is what I found: Those text messages are technically public records. They should be preserved and held by the City Clerk as a record of the public meeting. I am sure that no one keeps them but they should.

Last July 1st, new regulations on the Open Meeting Law became effective and the issue of technology was addressed. The use of email to prepare for a meeting or develop policy is not permitted; the reason for that is because the public can't see what committee members are talking about via email. The law approves the use of email for the purpose of mailing out the agendas, meeting minutes, materials for discussion at the meeting, etc.

Another positive way of using technology is with the use of Skype. A Selectman in another town was hospitalized last winter and they consulted with the District Attorney about the use of cameras to allow him to participate in their meeting from his hospital bed and it was granted.



Human Rights Commission

Human Rights Commission meets Monday, September 13th in the City Council Chambers at City Hall, beginning at 6 o'clock. They regularly meet on the first Monday of each month but due to the Labor Day holiday, it was postponed for the following Monday.

Now, the Attorney General is going to propose regulations that would allow remote participation by members of boards as long as everyone is able to hear.

While e-mails can make it easier and faster to communicate, they can get people in trouble. Remember when state prosecutors seized e-mails in a scandal that prompted the resignation of Former Massachusetts House Speaker Salvatore F. DiMasi? And, the state's highest court recently ruled that a school committee in a suburb of Boston used e-mail to deliberate in an infraction of the state's Open Meeting Law.

Even better than that was the case of Detroit Mayor Kwame Kilpatrick and his Chief of Staff, Christine Beatty, were

having an affair while they were married to other people. In 2002 two police officers were fired and sued the city. Kilpatrick claimed that they had retired voluntarily so they revealed what they knew of the liaison which the mayor and Ms. Beatty denied.

The local newspaper obtained and released excerpts from 14,000 very steamy text messages sent between Kilpatrick and Beatty during 2002 and 2003. So, as you can see, nothing is ever permanently deleted. Text messages leave a paper trail. Naomi Stomberg, the School Committee attorney has admonished them by saying, "You should know that you are in violation of the Open Meeting Law," whenever she hears of emails being exchanged among them.

All conversations among board or committee members should be in public; that's the best way to avoid breaking the law.

If anyone has questions about a vote taken (including other councilors), they could demand seeing the hand-written notes, emails and text messages councilors received during that meeting and probably discover that they were just following instructions on how to proceed from someone not involved in local government. I can only imagine what we would see if they were viewed publicly. I am sure that many people would be embarrassed by what they say.

Chief Romero, "We don't need a Deputy Chief"

That is what Police Chief John J. Romero said last week as a result of the objections from some city councilors to Melix Bonilla's permanent appointment to that post. Chief Romero declared that, since 24 police officers were laid off, there is no need for a Deputy Chief.

That statement got me thinking. In October of 2008 Lawrence had 140 officers and two deputy chiefs. When Deputy Chief Emil De Fusco retired, his position was eliminated by the City Council only as a means to save money, not because he was not needed. Now that we laid off 24 officers, the Chief says he doesn't need any at all.

Perhaps Chief Romero doesn't have any hope for funding to be found that can restore some of those officers to the city's police force. I wonder what would happen if we manage to bring them back. Would he have to start from scratch creating the position through the City Council to appoint a deputy chief if this one is abolished? Would Melix be then returned to that position being the last person who held it?

Paying back taxes

The recently released list of the people who owe back taxes and water bills to the

City of Lawrence is an embarrassment to City Hall for not doing its job for the past twenty years. In June of 2004, Mayor Michael Sullivan issued an offer to the long-term debt beats allowing them to take off 50% of the bill. I wonder how many paid up because I see some of those names back on this list.

A couple of years ago I was called by several names because I said that if a little old lady cannot afford to pay her property taxes, it's time to sell and go to live in a nursing home or with relatives. Oh, my God! I was attacked by all fronts but let's be realistic. We are the taxpayers of this city supporting all public services and municipal employees, but we are not the welfare department. How could we prevail as a city if we allow that to happen?

A property owner knows what his responsibilities are and if they cannot live by them, they have no right to ownership. What's wrong with placing a lien on every piece of property that owes money for taxes and water bills?

While we are at it, let's put a lien on the new Burger King on Broadway. Its owner is Stephen Stapski of Andover, who also owns Merrimack Paper Co. on South Canal St., the site of several recent fires. He's now saying that he doesn't own the building but he has been the one facing every complaint and arranging a payment plan with the fire department for a fire watch detail. He owes \$150,000 on that and he is paying \$1,000 each month.

According to Lenny Degnan, the mayor's chief of staff, "Why would he be arranging for a payment plan on a building that he doesn't own?"

The elimination of the ARC Program

Last week I wrote about the ARC (Another Route to College) Program at Lawrence High School and several people approached me either because they were not familiar with it or wanted to know more.

I just think that anything extra that we can do to guide our young people is never a waste of public funds, particularly if it is something done through the school department. This was a program serving just 30 students in their senior year of high school for the past eight years with a 100% success rate. They all passed the MCAS tests and graduated from high school and some even went to college.

The beauty of the program is that they attended classes in the Haverhill Campus of Northern Essex Community College, introducing them to the college atmosphere and the possibility of being able to attend higher education.

When the members of the school committee voted to eliminate the program, they mentioned the savings of \$72,000 in transportation charges and they would be able to hire a third teacher to continue the program at Lawrence High School and expand it to other students. Well, that is not the same kind of program because it is not in a college environment. By the way, with Northern Essex's expansion to the Riverwalk, there is ample space to hold the program in Lawrence with no need for transportation.

School is about to start and I have not heard that they had hired that third MCAS teacher.



Environmentally Friendly Courses Offered to NECC Students

Northern Essex Community College students have always been friendly, now they have the opportunity to be eco-friendly.

This fall, as part of the college's green initiative, students will be offered a series of green courses infused with an eco-friendly theme. At least 15 percent of each course will be "green" focused and students will have the opportunity to either, perform environmentally friendly service learning, develop a green project, or present a green presentation. This is the second semester that a series of green courses have been taught at the college.

"These courses are one of the ways in which Northern Essex is addressing the need for a more environmentally sustainable society," according to NECC professor Paul Chanley. "Federal, state, and local governments, businesses, and non-profit organizations are realizing that such a green approach is not only good for the planet and people, but good for the economy and jobs. It is clear that many professions and careers-including business, engineering, science, computers and technology-will require knowledge and understanding of environmental sustainability issues, policies, and practices. Such a background may provide a significant advantage for NECC graduates in the job market".

The fall courses include Marine Biology, Intro to Business, Computer Applications, Integrated Computer Applications, Information Security, Internet/HTML, Introduction to Info Technology, Introduction to Geography, and Statistics.

In addition, students may sign up for a "Space on Earth" Learning Community featuring English Composition I, Environmental Issues, and Basic Algebra II. In order to participate in the Learning community, students must sign up for all three courses.

"Free" Grant Writing Workshops for Non-Profits: Offered at NECC in Lawrence

Nonprofits eager to break into the grant writing arena can send participants to attend a series of free workshops, sponsored by the Associated Grant Makers, Jericho Road of Lawrence,

and Northern Essex Community College. The workshops will be held at Northern Essex Community College's Lawrence campuses, beginning in October.

The first class, Introduction to Grants Research, will be held on Friday, October 1st, from 9 to 11 a.m. This workshop introduces participants to the world of philanthropy. It will cover grants research and how to approach foundations. In addition, participants will learn how to tell an organization's story for best effect. There will be a demonstration of several databases that are critical to finding the right grant maker for an organization.

The second class, Grants Research Databases - An In-Depth Look, will be held Friday, October 8th, in one of two sessions, 8:30 to 10:30 a.m. or 11 a.m. to 1 p.m. This workshop will take a detailed look at the AGM Grant Makers Databases and the Foundation Center's Foundation Directory Online, the two key databases used to conduct grants research. This workshop provides hands-on experience using an organization's needs for funds to create the search strategies. Participants will be able to take research results home with them at the end of the workshop.

The third class, Introduction to Grant Writing, will be held Friday, October 22nd, from 9 to 11 a.m. Participants will learn how to create a winning grant proposal. Different types of grant proposals will be examined including the typical components of a proposal and the steps in the process.

The fourth and final class, Grant Writing II, will be offered Friday, November 5, from 9 to 12noon. This is for individuals who already have some experience in grant writing, but would like to take it to the next level. During this two-hour workshop individuals will learn how to plan a grant for maximum funding success; the secret language used by successful grant writers; how to think like a reviewer; simple ways to package a grant for maximum effect; grant writing do's and don'ts based upon well written sample grants. The workshop will provide time for interaction with concrete examples and lively discussion.

All classes will be held at NECC's Louise Haffner Fournier Education Center, 78 Amesbury St., Lawrence except for Grants Research Databases-An In-Depth Look, which will be held at the college's Dimitry Building, 45 Franklin St., Lawrence.

Seats in these courses are limited so those interested are encouraged to register early by sending an email with the subject line "AGM workshops registration."


Mugsley
