Cerca de 300 personas se reunieron en el Centro de Tecnología recién nombrado David Hartleb Technology Center en Haverhill, el miércoles, 23 de junio 2011, para decir adiós a David Hartleb, que ha sido presidente de Northern Essex Community College durante los últimos 15 años y se retiró el pasado 30 de junio este año.

El sucesor del presidente Hartleb, el Dr. Lane Glenn, presidente de la universidad y actual vicepresidente de asuntos académicos, fue el anfitrión del evento que se destacó por comentarios y artículos de regalo, una presentación de diapositivas con la historia de Hartleb como presidente, y el nombre del Centro de Tecnología en su honor.

Glenn acreditó a Hartleb con la creación de nuevos programas innovadores en los campos de alta demanda tales como la tecnología del sueño, la tecnología de paramédicos, la informática forense, laboratorio de ciencias y la educación, la apertura de nuevas y renovadas instalaciones en Haverhill y Lawrence, inicio de asociaciones públicas/privadas frente a una economía en cuesta abajo como una forma de no sólo sobrevivir, sino prosperar en tiempos difíciles, y aumentar significativamente la matrícula, especialmente entre los estudiantes de las minorías.

"Me han dicho no una, sino muchas, muchas veces en los últimos meses que tengo unos zapatos muy grandes para llenar, y estoy de acuerdo", dijo Glenn. "El mejor

Close to 300 people gathered in the newly named David Hartleb Technology Center in Haverhill on Wednesday, June 23rd, 2011, to say farewell to David Hartleb, who has been president of Northern Essex Community College for the past 15 years and retired last June 30 of this year.

President Hartleb's successor, Dr. Lane Glenn, the college's current vice president of academic affairs, hosted the event which featured remarks and gifts, a slide show featuring Hartleb's tenure as president, and the naming of the Technology Center in his honor.

Glenn credited Hartleb with creating innovative new programs in high demand fields such as sleep technology, paramedic technology, computer forensics, lab science, and education; opening new and renovated facilities in Haverhill and Lawrence; initiating public/private partnerships in the face of a down economy as a way of not just surviving, but thriving in

Es irónico que cerremos el Centro de Ancianos a los políticos locales, pero está disponible para los candidatos de países extranjeros.

En la reunión mensual del Concejo de Ancianos del 28 de junio 2011, la junta votó por unanimidad solicitar una opinión legal del abogado de la ciudad en lo que respecta a esa materia.

Incluido en el dictamen es una petición sobre la hora que el centro debe ser alquilado cuando se va a utilizar para fiestas a las que asisten niños, ya que sus instalaciones son muy populares para celebraciones tales como bautizos, sweet 16 y quinceañeras.

Felicitemos al Concejo de Ancianos por su voto el que traerá al Centro de Ancianos dentro de cumplimiento con la ley y sobre todo, la igualdad para todos.

Politics at Boathouse and Senior Center

The Bashara Boathouse recently notified a candidate the day before a kick off celebration that it could not take place with the excuse that they cannot have political events.

HUMM! We seem to remember other political gatherings at the Boathouse. Anyone who may have had a similar experience with them should contact us.

Meanwhile, something similar happened at the Lawrence Senior Center. The Senior Center has a policy of not allowing political events in its facilities since it is part of the city government. Forums and or debates are allowed since is considered beneficial for the community at large and not for a specific candidate.

Last Saturday, June 25th, 2011, the former president of the Dominican Republic, who is again running for president, held a meeting there.

According to the administration, the political party reserved the hall saying that he was coming to speak about the current economy in the Dominican Republic. Instead he had a political rally with close to 800 followers in attendance.

It's ironic that we close the Senior Center to local politicians but it is available to candidates from foreign countries.

In the June 28th, 2011 monthly meeting of the Council on Aging, the board voted unanimously to request a legal opinion from the City Attorney in regard of that matter. Included in the opinion is a request about the hours the center should be rented when it's going to be use for parties where children are involved since their facilities are very popular for celebrations such as Christenings, Sweet 16s and Quinceañeras.

We congratulate the Council on Aging for their vote that will bring the Senior Center into legal compliance and above all equality for all.

City Clerk William Maloney explained the leader of the group, Rev. Edwin Rodriguez that he could not add one total to the other in order to come up to the 100+ signatures required and that he will have to consider each group separately.

Rev. Rodriguez decided not to file the signatures at this time but to come back the next day with the signatures on the appropriate form.


Audiencia de Educación en la Casa de Estado

El Comité Legislativo de Educación escuchó el testimonio de varios temas respecto a proyectos de ley que hay pendientes. Education hearing at State House

The Legislature's Committee on Education listened to testimony on several issues addressing pending bills. My former employer, Merrimack Valley Federal Credit Union invited me to take part on the Financial Literacy bill sponsored by Senator Barry Finegold asking for this type of education to be offered in the public schools system. Since that was part of my duties it was an honor for me and the student representing this area was selected from my group at the YMCA.

During my six-week presentation on financial literacy at the Y two years ago, there was one student who impressed me greatly. Emmanuel Castañeda was very attentive and when we play a game with fake





El significado de Estados Unidos

El 4 de julio, día de la Independencia de Estados Unidos, nos presenta no sólo la ocasión para celebrar nuestro gran país, sino también para reflexionar sobre su significado.

La división actual entre progresistas y conservadores no se reducen a las diferencias políticas. Es indicativo de un debate más profundo sobre el significado de Estados Unidos.

Tales debates no son nuevos.

Calvin Coolidge, nuestro trigésimo presidente, a menudo celebraba el cumpleaños de Estados Unidos (que coincidía con el suyo) defendiendo los principios de Estados Unidos contra rivales dentro del "movimiento progresista".

El movimiento progresista arrancó su andadura a principios del siglo XX e incluía académicos, periodistas y hasta políticos. Ellos afirmaban que Estados Unidos había avanzado más allá de los principios de la Declaración de Independencia. No todos los hombres fueron creados iguales; algunos pueblos fueron históricamente más avanzados que otros. Los derechos no provienen de la naturaleza, el gobierno crea derechos. La legislación no requiere el consentimiento del pueblo sino que requiere conocimientos técnicos para regular todos los aspectos de la vida. Estas proposiciones han tenido enormes implicaciones para el gobierno.

Por el contrario respondía Coolidge. Hay un carácter definitivo en la Declaración: "Si todos los hombres son creados iguales, eso es definitivo. Si están dotados con derechos inalienables, eso es definitivo. Si los gobiernos derivan sus justos poderes del consentimiento de los gobernados, eso es definitivo. No hay avance, no hay progreso que se pueda hacer más allá de estas propuestas".

Recordemos todas esas palabras este 4 de julio.

Keeping Sullivan honest

The media criticizes Mayor William Lantigua of not being accessible but former Mayor Michael Sullivan sins for the opposite reason. He is not only available but talks too much and usually lies; even worse than that is keeping quiet in order to pander to the audience when he knows things to be different. When his name is mentioned by the big newspapers, you have to wonder why we didn't make him mayor for life. To this day he denies leaving a \$24.5M deficit but I'm not going to get into that.

Please keep in mind that I am not trying to defend the mayor's actions in any way. I hate lies and the public has been manipulated by the press so the purpose of what I'm writing today is to prove how you are all being duped.

In recent articles as well as on his radio broadcast, he has given the impression that a new culture is emerging in Lawrence with a direct line between the city and the Dominican Republic. The most recent Boston Globe article uses the fact that radio stations in the Dominican Republic were campaigning for Lantigua. It is true. Dominicans are very political. Their candidates for the presidency travel to different cities in the United States with large percentage of Dominicans to raise funds and garner votes. People used to travel en masse during Dominican elections to be able to vote; now they can do it directly without having to travel.

That article contains a remarkable quote from Sullivan:

"There would be no way that a mayor—I'm speaking for myself now—would put pressure, ask or encourage a vendor to send a piece of their capital equipment anywhere," Sullivan said. "I know it's something I've never done."

I am not going to debate if the process of sending the trash truck from the company holding a city contract to the Dominican Republic began during his administration as Lantigua has said because I am not privy to that information. I am here to remind Mike that he did that several times. After doing a quick search in our website (and anyone can do it), I found on January 8, 2006, a

front page story with a picture of him and a dignitary from the Dominican Republic receiving two fire trucks.

The Globe article mentions a bus donated by North Reading Transportation which Lantigua told them would be sent to the Dominican Republic. That's a private company and just because they transport our school children, we don't own their buses. We also have a story on May 22, 2004, page 4, with Sullivan posing while Patriot Ambulance was donating an ambulance to Dominican officials. Patriot has been under contract with the city for a long time having donated five ambulances to date. Did he exert any influence to get them to donate?

Do a brief search on Google and you will find how much is donated by different cities and towns to that country. Fire trucks, ambulances, public transportation vehicles and yes, trash trucks, must abide by strict rules in this country so they cannot be donated to poorer towns or states because they have similar safety requirements.

As a result, the Dominican population has grown so much all over the United States that for local officials those items become vote-getters.

This so-called Dominican connection is not something that began 18 months ago. On the front page of our January 15, 2003 edition you will see Sullivan welcoming a mayor from Santo Domingo; on May 7, 2003, page 7, Sullivan is giving the key to the city to another Santo Domingo mayor. In that article, former Fire Chief Joseph Marquis promised to do due diligence to find two ambulances for them. There was even a training exchange among firefighters from both countries.

On November 3, 2003, Sullivan gives a presidential candidate a proclamation and again another one on January 22, 2005 to a member of the Dominican Senate. I am sure there are more if I search a little longer.

Our local Spanish radio stations are clogged with political ads supporting those candidates back home so it is not unusual for them to do that in support of our candidates here.

Last Tuesday I listened to Sullivan's

radio show for the first time and I encourage everyone to listen but instead of being gullible, to question everything he says. It inspired me enough to write this to set him straight.

The show was an embarrassing fanfare of lies but we are becoming so desensitized to them that they are dismissed and no one bothers to call in. The kicker was the interview with a Boston Herald reporter who was terribly misinformed and couldn't care less about the people whose reputation she damaged. Again, we are used to that. What really bothered me was the conversation about the jobs Lantigua has gotten for the women in his life. That was an opportunity for Sullivan to clarify that he appointed Mayra Lantigua to the Licensing Commission in 2005. He should also be aware that his first wife has been with the Police Department for about ten years and his daughter is a substitute teacher who gets laid off every year in June. Right now she is in lay off status. Don't you think she would have a permanent teaching position by now? Wilfredo Laboy did that with his daughter the moment he arrived even though she didn't even have credentials.

Regarding his current relationship, he met her while she was already employed at City Hall.

Last Wednesday, during the broadcast of CrossOver on WCCM, Richard and I received a call from Matt wondering why if we always debunk what the big media outlets publish, they don't consult with us for accuracy. The answer is simple: they don't want the truth because it doesn't sell papers.

1967 SOCIAL LEAGUE SOFTBALL

The Social League Softball finds the Jeff's of So. Lawrence and St. Michael's tied for first place as the mid season All Star Game is approaching. In a surprising upset the red hot Manhattan team shut out the Jeff's 1/0 behind the hitting and pitching of Steve Borys, it was the fifth win in a row for the young upstarts who mostly came from the Southside of the City.

Taking the loss for the Jeffs was Dick Krauss who hadn't lost a game since the league opener a year ago. Borys was an electrician, and later an owner of the Calumet Club that is still located on So. B'way. He passed away at a young age and it was a shock to all who knew him.

Krauss who then worked and later retired from Raytheon was one of the league's all time greats and had already thrown 3 no-hitters in his career. A Hall of Famer at Methuen High School he went on to play two sports at Boston University. Dick taught himself the art of pitching a softball and used a tire tied on a rope to aim his great drop pitch that would later gain him many victories throughout the State. Borys was an infielder who tried his luck on the mound and became a good one; he had the potential to become a great one.

The league officers, led by Gene Mc Aullife a local funeral director, were as

follows: Nick Garnett, an outfielder for the Concordia Club was the secretary.

Ray Tremblay was the treasurer; he's a New Hampshire resident these days and was also the field manager of the St. Michael's team.

Billy Callagy one of the famous Callagy athletic family from Tower Hill and later a teacher coach in the future a principal at LHS, was on the board. He hosted a talk show called "Let's Talk Sports" on WCCM and did many games of local interest for years.

Guess who tried to fill his shoes and they were big ones on the airways? Harold Whitworth a local owner of a sporting goods store on Essex St. provided trophies for the league winners and MVP's.

Disk LaPierre was the umpire in chief and he worked at Western Electric for years before retiring to Atkinson, NH. He also refereed basketball games.

Jerry Iskolls was an officer at the now defunct Jewish Community Center on Haverhill St.

Lyle Connors of Haverhill was also the A.S.A. Commissioner for the area.

Ronnie Parrino who still has a towing

company in the Methuen Valley area.

Dick Hazetine from Haverhill also officiated in football, Eddie Alekal who was also the City's Veteran Affairs Commissioner, Lou Tremblay, Charlie Hill and Dave Arakalian were all the men in blue.

This league was as good as there was in the area and much credit must go to the caliber of talent but also to the work and time put in by the umpires and the President Mc Aullife and his board. I think this writer might have been thrown out of games by each of those umpires and can really say they have never held any animosity towards my wild antics on the field. Only one who wasn't part of La Pierre's group could be considered to be of questionable integrity and he'll remain nameless.

In featuring the glue of the league did you think I'd forget to mention Jo Jo Abdinooor? Not a chance! He was as important to the league as any of us. He made sure to pick the bases up from Tom's store on Lawrence St. and put them in their places on the field; he took up the collections and also turned the lights on and off each night when instructed to do so by the umpires. No, I didn't and won't ever forget Jo Jo who knew all the players but allowed me to be his friend.



Protegiendo a sus trabajadores

“Uno por no perder el trabajo tiene que arriesgarse... si no, te botan. No te van a botar a la clara para que tú no vayas a denunciarlo. Ellos tienen que decir otra cosa.”

Esta es la experiencia verdadera de trabajadores de construcción en Lawrence, Massachusetts. Muchos trabajadores de construcción, particularmente hispanos, trabajan en condiciones peligrosas y se sienten presionados a asumir riesgos para mantener sus empleos. Dicen que se ven obligados a usar equipo roto y no recibir suficiente entrenamiento de seguridad. Según un trabajador, “la mayoría de los accidentes suceden cuando el contratista no está preparado. Ellos demandan que el trabajo se haga pero muchas veces no se puede porque el lugar no es seguro.” Muchos contratistas no entienden cómo proteger a los trabajadores contra caídas.

Demasiado a menudo, los trabajadores de construcción se encuentran en las salas de urgencia a causa de accidentes relacionados con el trabajo. Sólo en Lawrence, de 2003 a 2005, la sala de emergencias trató a 360 trabajadores con lesiones por caídas. Protección en Construcción: una Agrupación para la Seguridad del Trabajador Latino (PenC) ha escuchado las

experiencias de trabajadores hispanos de construcción y está trabajando para mejorar la seguridad en sitios de construcción. El riesgo de caídas es uno de los grandes peligros que enfrentan los trabajadores de construcción. En Massachusetts, las caídas resultan en la cifra más alta de muertes en la construcción. La oficina del U.S. Bureau of Labor Statistics informó que en 2009, 645 trabajadores de construcción murieron después de caerse. Trabajadores latinos se encuentran particularmente expuestos a peligro; los trabajadores hispanos mueren en accidentes del trabajo tres veces más que trabajadores no hispanos.

La construcción es peligrosa pero los contratistas son requeridos cumplir con las reglas del gobierno para reducir los riesgos. La ley establece que, si los trabajadores trabajan a una altura de seis pies o más, el contratista necesita tener un sistema de barandillas protectoras, redes de seguridad o un sistema anticaídas personal para los trabajadores. Un sistema de anticaídas incluye un punto de anclaje seguro, una línea de seguridad y un arnés de cuerpo completo.

Como David Michaels, Secretario Auxiliar de la Administración de Seguridad y Salud Ocupacional (OSHA), ha declarado: “No podemos tolerar las muertes de trabajadores en construcción residencial cuando los medios eficaces están disponibles para prevenir esas muertes.” OSHA ha dicho que tiene la intención de hacer cumplir esta ley en nuestro área y todos contratistas deben cumplir para el 15 de septiembre.

Protección en Construcción está reclutando a contratistas que quieren la ayuda gratis para prevenir caídas. Los contratistas que trabajan con el agrupación pueden mejorar sus negocios a través de la mejora de seguridad. Protecting your employees

“In order to keep the job, one must take risks... If not, they'll fire you. They won't fire you outright, so you cannot report them. They'll give a different reason.”

This is the experience of real construction workers in Lawrence. Many construction workers, and especially Hispanics, work under hazardous conditions and feel pressure to take risks to keep their jobs. They say they are forced to use broken equipment and don't get enough safety training. As one worker said “The majority of accidents occur when the contractor is not prepared. They demand that the work is done, but many times it is not possible because the place is unsafe.” Many contractors do not understand how to protect workers from falls.

Too often, construction workers find themselves in local emergency rooms

Substance Abuse Prevention Task Force Sponsors Forum

The Liquor License Establishment Informational Forum sponsored by Lawrence/Methuen Community Coalition was attended by 7 area establishments.

Harold Magoon, executive director of LMCC opened the forum with a description of their mission, what they have been doing and how they want to work together with the liquor licensed establishment owners/managers.

Delilah Rivera, LMCC Substance Abuse Prevention Coordinator presented information from the Serve Smart Toolkit, Massachusetts General Laws and the MA Superior Court Department Civil Action No. 04-5182E, Bornstein, Zinck vs. White and Gateway Liquor Store.

The presentation provided information on how to serve/sell alcohol, how to identify fake IDs, how to identify body language of users of fake IDs and patrons that walk in already intoxicated, how to deal with patrons and when to seek help from the manager/owner, the presentation also went into details of the consequences of breaking various laws pertaining to the sale of alcohol, a civil action was presented to show the trail back to the liquor store who sold to a minor with a fake ID, a list of useful resources were provided, the participants were also informed that we have staff that are certified TiPS Trainers. Richard presented the information regarding Sticker Shocks.

Next steps included additional follow up with all establishments. Despite two rounds of mailings and multiple phone calls the forum netted less than 7 percent of license holders. While license holders are not mandated to attend trainings, given the high level of incidents occurring in the neighborhoods, expectations were for a greater amount of participants.

The task force is reviewing potential policy changes to reflect mandated training and attendance for alcohol liquor licensed establishments and developing TIPS trainings locally for establishments. The Massachusetts Alcohol beverage and Control Commission along with the Lawrence Police Department will be invited to the next meeting which will be on Tuesday, September 13, 2011 from 6-7:30PM at the Lawrence Library, 51 Lawrence St. Lawrence, MA 01841

CONSTRUCTION: Protecting your employees

from work-related accidents. In Lawrence alone, from 2003 to 2005, the emergency departments saw 360 workers with fall injuries. Protección en Construcción: the Lawrence Latino Safety Partnership (PenC) has listened to the experiences of Hispanic construction workers and is working on solutions that improve safety conditions at construction sites. The risk of falling is one of the greatest dangers facing construction workers. In Massachusetts, the highest number of deaths in construction work is due to falls. The U.S. Bureau of Labor Statistics reported that in the U.S. in 2009, 645 construction workers died after falling

on the job. Latino workers are especially at risk; Hispanic workers die in work-related accidents three times more often than non-Hispanic workers.

Construction is dangerous but contractors are required to follow government rules to reduce the hazards. The law states that if workers are working at a height of 6 feet or more, the contractor must have a guardrail system, safety net, or a Personal Fall Arrest System for them. A Personal Fall Arrest System includes a secure anchor point, a safety line, and a full-body harness. As David Michaels, the head of the U.S. Occupational Health and Safety

Administration (OSHA), has stated, "We cannot tolerate workers getting killed in residential construction when effective means are readily available to prevent those deaths." OSHA has said that they intend to start actively enforcing this requirement in our area and all residential contractors must comply by September 15th.

Protección en Construcción is recruiting contractors who want free help to prevent falls. Contractors who work with the partnership can improve their business by improving their safety. If they complete the program they will become certified as Leaders in Safe Construction. Contact us at 1-888-977-2250 (in Spanish or English).

En muchas ocasiones, la televisión es el medio de llenar el tiempo libre y allí los televidentes ven películas, tertulias de carácter político, partidos de fútbol, de tenis y otros programas divertidos. Esto favorece formas de vida sedentaria que perjudica la salud.

En cuanto a los niños, un uso abusivo les lleva a perder los hábitos de lectura y a la pérdida de hábitos de lectura, a aumentar las faltas de ortografía, a hacer poco deporte y a carecer de aficiones. Como la televisión les quita mucho tiempo, terminan cayendo en el fracaso escolar.

La televisión también les afecta a la formación de la personalidad y a la pérdida

de hábitos. Viendo la tele se cae en la pasividad y la comodidad y se incapacita para el necesario esfuerzo que exige el estudio.

Después de dos o tres horas viendo la televisión es difícil ponerse a estudiar y pasar de una postura pasiva en la que todo lo recibe a otra situación en la que estudiante lo tiene que hacer todo para comprender libros, analizar las ideas, relacionarlas, expresarlas y recordarlas.

Por fin, podemos decir que en el cuarto de estudio nunca puede estar la tele encendida porque el chico no puede ver y entender a la vez la pantalla y el libro.

¿Con todo lo anterior se llega a la conclusión de que la tele es nefasta? No, sino que es positiva con un uso adecuado, pero cuando se relaciona con el estudio las consecuencias nunca son positivas.

Television and studying

Television is a technological medium of great importance in the lives of people, because it provides information, sports and entertainment among other things. However, it may be the main cause of school failure for many students. Here are some facts.

All surveys of children concluded that most children watch too much TV programs appropriate to their age and adults.

Research on the subject says that when you watch too much TV without control can produce a unit, called TV addiction, with mental fatigue, especially in children.

Many families eat their meals in front of the TV to save time, to receive information or enjoying an entertainment program. But along with this, it also makes communication between people difficult and usually all members of the family remain silent.

In many cases, television is the means to fill the free time and where viewers watch movies, political gatherings, football, tennis and other fun programs. This promotes sedentary lifestyles that harm health.

As for children, abused of that time makes them lose the reading habit and the loss of reading habits increases the spelling mistakes, practice little sports and have no hobbies. As television takes away too much time, they end up failing in school.

Lawrence Delegation Announces Funds to Combat Youth Violence

New program to target communities with high number of youth homicides

Ranked No. 5 in youth murders in the state over the past five years, Lawrence could benefit from a new law that provides \$10 million in violence-prevention grants for cities. Senator Barry Finegold (D—Andover), Rep. David Torrisi (D—North Andover) and Rep. Marcos Devers (D—Lawrence) voted in favor of a bill that would give funds to organizations that combat youth violence.

"Young people are the most at-risk population when it comes to violence and gang activity. Lack of funding and a scarce job market have left students with more free time and less supports in place," Finegold said. "I hope Lawrence can restore some of its youth violence programs with this grant and get our children off the streets and back on a solid path."

Governor Deval Patrick signed the bill on Tuesday that includes \$10 million for a new program that would target grants to communities with the highest number of youth homicides and serious assaults. According to statistics, Lawrence had 11 murders of people less than 23 years old from 2006 to 2010, with 4 of those happening in 2010.

"I am pleased that my colleagues and I were able to provide this level of funding to such a crucial program. I am hopeful that these grants will keep our young people safe and provide them with many opportunities to find success," said Representative Torrisi.

"I am very joyful and grateful with the decision made by His Excellency, Gov. Deval Patrick. The city of Lawrence, which I represent, will greatly benefit and will have a sense of relief, safety and hope with this passage. I am very much looking forward to a stronger and safer community for Lawrence and across the Commonwealth," added Representative Marcos Devers.

Other communities with high youth homicide rates over the past 5 years include Boston, with 142; Springfield, with 24; Brockton, with 16; Worcester, 13; and Lowell, 10.

The youth violence and prevention grants will be based on a competitive application process focused on improving existing infrastructures or creating them.

Nuestras estaciones locales de radio en español están obstruidas con los anuncios de política de apoyo a los candidatos de allá por lo que no es inusual que lo hagan en favor de nuestros candidatos aquí.

El martes pasado escuché el programa de radio de Sullivan por primera vez y animo a todos a escucharlo, pero en lugar de creer todo lo que les dice, cuestionen todo lo que diga. Eso me inspiró para escribir esto y enderezarlo.

El espectáculo fue una fanfarria de mentiras vergonzosas, pero estamos llegando a ser tan insensible a lo que escuchamos que nadie se molesta en llamarlo. Lo peor fue la entrevista con una reportera del Boston Herald, que estaba terriblemente mal informada y no le importa nada la reputación de las personas a quienes hizo daño. Una vez más, estamos acostumbrados a eso. Lo que realmente me molestó fue la conversación sobre los trabajos que Lantigua consiguió para las mujeres en su vida. Esa fue una oportunidad para que Sullivan aclarara que él fue quien nombró a Mayra Lantigua a la Comisión de Licencias en el 2005. También debe ser consciente de que su primera esposa ha estado con el Departamento de Policía por 10 años y su hija es una maestra sustituta que le dan lay off todos los años en junio. En este momento

está en estado de lay off. ¿No cree que ella tuviera un puesto de maestra permanente a estas alturas? Wilfredo Laboy lo hizo con su hija el momento en que llegó a pesar de que ni siquiera tenía credenciales.

En cuanto a su relación actual, la conoció cuando ella ya estaba trabajando en el Ayuntamiento.

El miércoles pasado, durante la emisión de CrossOver en WCCM, Richard y yo recibimos una llamada de Matt preguntándose por qué si siempre desacreditamos lo que los grandes medios de comunicación publican, no nos consultan para mayor exactitud. La respuesta es simple: no quieren la verdad, ya que no vende periódicos.

Demanda ridícula

Es encomiable que nuestro sistema judicial da igualdad de acceso a todo el mundo - no importa cuán tonto o inútil.

Tal es el caso de Hodayoun Maali demandando a la Dra. Mary Lou Bergeron, superintendente escolar de Lawrence por "violar los derechos de los estudiantes manteniendo a nuestros niños en la escuela Robert Frost en las aulas con la temperatura superior a 100 grados y poniendo en peligro la seguridad de nuestros hijos..."

En resumen, está demandándola a ella, no al departamento escolar o la ciudad por negarse a instalar aire acondicionado en el edificio.

Bergeron.

La asociación de padres (PTO) es muy activa en la Escuela Frost y en esos días ofrecen refrescos y duro frío a los estudiantes.

La Escuela Frost no es la única en la ciudad sin aire acondicionado. Otras escuelas sólo tienen un sistema de aire fresco que se incluyó cuando fueron construidas.

Lo que es difícil de entender es la razón detrás de esta demanda, citando sólo a la superintendente, en lugar de la Ciudad de Lawrence ya que todas las reparaciones en los edificios escolares es responsabilidad del Departamento de Obras Públicas. Él

suíng Dr. Mary Lou Bergeron, Lawrence superintendent of schools for “violating students’ rights by keeping our children at the Robert Frost School in classrooms with the temperature exceeding 100 degrees and endangering safety of our children...”

In short, he is suíng her, not the school department or the city itself for refusing to install air conditioning in the building.

Dr. Bergeron told me that she looked into this issue 4 years ago and the estimate was of 4 to 5 million dollars to retrofit the school and considering that in June and September we may have only 4 or 5 days of excessive temperatures, it is not logical.

When asked about the current policy on hot days, she said that, “teachers have been given authority to relax the dress code in favor of more comfortable clothing. Also, they move the students to other areas of the building where they can maintain a 78-80 degrees temperature, in compliance with the Massachusetts Environmental Protection Agency’s recommendation,” stated Dr. Bergeron.

The PTO is very active at the Frost School and on those days they offer refreshments and cool pops to the students.

The Frost School is not the only one in the city without air conditioning. Other schools only have a cool air system that was included when they were built.

What is difficult to understand is

the rationale behind this lawsuit, citing only the superintendent, instead of the City of Lawrence since all repairs in school buildings are the responsibility of the Department of Public Works. He is probably trying to get the Commonwealth to pay for it since we all know that the city has no money for something like that.

My personal viewpoint on this is that early dismissal will impose on working parents, only to have the children go to probably a home with no air conditioning, anyway. But if a parent is so concerned about a child becoming ill from attending school on a hot day, they can always exercise their right to keep them at home.

Or is it just because his running for School Committee? Oh, I get it; I just gave him some free publicity.

What a waste of public and court resources!

Statement from Secretary Jay Gonzalez

Governor Deval Patrick filed an interim budget of \$1.25 billion today to ensure that the state government has the means to continue providing critical services through July 10, 2011.

This funding will ensure that core services such as health care payments to providers for services to children, families, unemployed adults, and the disabled as well as cash assistance for low-income families and seniors did not run out.

This interim budget will also fund emergency and first response services including State Police operations, and will provide funding for state obligations for debt service which must be paid early in FY12.

“We remain hopeful that the Legislature will be able to resolve their differences and submit the FY12 budget to Governor Patrick for review within the next few days,” said Secretary Gonzalez.

El Gobernador Deval Patrick presentó un presupuesto provisional de \$1.25 billones para asegurar que el gobierno estatal tiene los medios para continuar proporcionando servicios críticos hasta el 10 de julio 2011.

money, he concentrated as if it were real. He considered his decisions carefully and to him it was not just a game. When Jennifer Grenier, AVP for Marketing asked me if anyone I met stood out in all the places I taught it, I eagerly mentioned him.

Emmanuel wrote a one-page statement explaining how unprepared today’s youth are to make adequate decisions relative to money. They are spending time and resources for a search because of a flyer that invites educators, parents and other citizens of Lawrence to join a stand out for Higher Standards in Education that took place on Essex Street before a School Committee meeting. Mr. Gray calls this a campaign against him? Why is he guilty of something

or against Higher Standards for Education? Or is he paranoid about losing in the next election so he is bringing up 2009 issues in 2011 to help his campaign? Also just because he calls this flyer political campaigning against him, that doesn't make it so! He is not the campaign police, although he thinks he is!

Also one of the last policy issues that I dealt with as a former School Committee Member and Chairman of the Lawrence School Safety Sub-Committee, (which this current School Committee has done away with), was to improve the policy on use of school computers by students and staff.

There are now very strict rules prohibiting the use of computers for anything else than sharing or gathering school related information. Mr. Vittorioso voted in favor of it, he must have just forgotten.

One more thing, hopefully this is the last time I have to say this: I am not a candidate for any elective office in 2011.



hard times; and significantly increasing enrollments, especially among minority students.

"I have been told not once, but many, many times over the past few months that I have some very large shoes to fill, and I agree," said Glenn. "The best advice I have received so far is to be yourself (and wear extra socks)."

Dr. Richard Freeland, the commissioner of higher education in Massachusetts, called Hartleb "the genuine article...thoroughly decent and thoroughly caring in addition to being a highly effective administrator."

A highlight of the event was when Joseph Edwards, chairman of the NECC Board of Trustees, announced that the Technology Center, which opened in September of 2005, will be named in Hartleb's honor. "This project would not have been possible without the support of our donors and our legislative delegation, of course, but David provided the leadership and vision that made it all happen," he said.

Edwards unveiled new lettering on the building which now reads The David Hartleb Technology Center and a plaque honoring Hartleb which is located in the lobby of the building.

Hartleb, who has lived in Haverhill, came to Northern Essex after a 28-year career at the University of Cincinnati and will return to Ohio after retiring from Northern Essex.

A resident of Amesbury, Glenn currently serves as vice president of academic affairs at Northern Essex, a position which he has held since 2006. Prior to that, he was dean of academic and student services at Oakland Community College in Michigan. He has also served as director of learning services at Lansing Community College, also in Michigan. Glenn holds a Ph.D. in theater from Michigan State University.

In his four years at the college, Glenn has focused on student success, including increasing support for underprepared students. He has also expanded the college's relationships with local high schools and partnered with local employers, such as Raytheon, to develop programs that deliver the skills most needed in the job market.

Hartleb received warm wishes from the Board of Trustees, the Alumni Association, the NECC Foundation, the Women of NECC, the All College Assembly, the NECC Administrators Association, and the NECC Professionals Association.

Calling his position as president of Northern Essex "the best job I ever had," Hartleb credited others for what has been accomplished during his time at the college. "Upon reflecting about my career, I am struck that none of my accomplishments would have happened without tremendous support from many, many people, quite a few of whom are here today. My only claim for success is that I have always been surrounded by wonderful, energetic, bright, fantastic friends and colleagues."




