Greg Mills, propietario de Mills Machine Works ha creado una galería de héroes que contiene 48 fotos de soldados del Valle de Merrimack que han servido en el Ejército, la Armada, la Fuerza Aérea, la Infantería de Marina y la Guardia Costera durante la Segunda Guerra Mundial, Vietnam, Corea, Irak y/o Afganistán. Algunos se han jubilado, otros fueron muertos en la acción, como el sargento del Ejército Alex Jiménez, de Lawrence, muerto en Irak cuyos restos fueron encontrados en julio, 2008.

Mills Machine Works está situado en el 30 de la Calle Carver, en Lawrence, MA donde fabrican piezas utilizadas en el servicio militar. Greg Mills, su propietario, es un teniente de la Patrulla Aérea Civil de Estados Unidos estacionados en el aeropuerto de Lawrence.

Cuando preguntamos por qué de esta galería de héroes, Mills respondió: "Mi opinión es que no se les agradece lo suficiente."

En una ceremonia realizada el sábado, 27 de agosto, varios familiares de los hombres y mujeres recibieron una colcha de manos del concejal de la ciudad Roger Twomey hechos por su propia hija, Lisa Faulkner de Colorado.

## Honoring our Heroes

Greg Mills, owner of Mills Machine Works has created a Gallery of Heroes which contains 48 photos of Merrimack Valley servicemen who had served in the Army, Navy, Air Force, Marines and the Coast Guard during World War II, Vietnam, Korea, Iraq or Afghanistan. Some have retired; others were killed in action, like Army Sgt. Alex Jimenez of Lawrence, whose remains were founded in Iraq in July 2008.

Mills Machine Works is located at 30 Carver St., Lawrence, MA where they manufacture parts used in the military. Greg Mills, its owner is a Lt. with the US Civil Air Patrol stationed at Lawrence Airport.

When asked about the purpose for this gallery of heroes, Mills responded: "In my opinion, they are not thanked enough."

At a ceremony held Saturday, August 27th, several relatives of the servicemen and women being honored received a quilt from Lawrence City Councilor at-Large Roger Twomey made by his own daughter Lisa Faulkner of Colorado.

# Lawrence: Todo el mundo tiene una opinión

Y aquí vienen de nuevo los políticos de afuera con sus opiniones, llamando por la intervención del gobernador haciendo caso omiso de la capacidad de nuestros funcionarios electos para actuar y resolver la situación.

Le agradecemos su preocupación, pero aquellos en posiciones de alcanzar el oído del Gobernador nos ayudarán mejor si le recuerdan su promesa de campaña de contratar 1,000 policías más para las ciudades y pueblos.

Por cierto, de los candidatos que hablaron en favor de la intervención en nuestra ciudad, si nuestra memoria nos sirve bien, ninguno fue elegido, especialmente el más notorio.

# Lawrence: Everybody has an opinion

In our editorial of September 22nd, 2010 entitled 'C'mon, tell me the truth,' we said that politicians running for office from the governor's seat down to the local representatives, are using Lawrence's problems to promote themselves. The most notorious was Gubernatorial Candidate Charles D. Baker.

In those days, our problems were fires, bars and night clubs, gangs, drugs and prostitution activity going on in the city as a direct consequence of the safety personnel shortage.

The rest of the list remains the same, except that lately, night club patrons are creating more problems than the ordinary.


And here comes the opinionated outsider politicians calling for the governor's intervention ignoring our own elected officials' capacity to act and cope with the situation.

# Desde Mi Esquina

## Irregularidades en tiempo de elecciones

El 24 de agosto, tomé parte en una práctica muy interesante en la que yo no había estado involucrada antes: Desafiando a candidatos en la boleta electoral. Hubo varios y fue el proceso muy ilustrativo y educativo que pienso que debe ser aprendido por todos los candidatos para un cargo público.

La Junta de Registradores se reunió en la Cámara del Concejo Municipal para escuchar el testimonio y las objeciones de los candidatos y los ciudadanos con respecto a las irregularidades e incluso acusaciones de fraude en los documentos de nominación para el Concilio y los asientos del comité escolar. Este consejo está formado por tres personas: Ronald Martin, presidente, Lynne García y Esvelia López. El Escribano de la Ciudad William Maloney sirve también como Ex Oficio/Registrador. Ellos tienen autoridad para hacer cambios, basados en la documentación o testimonio que sea presentada de cualquier certificación previamente otorgada.

Hemos oído hablar del caso de Sammy Reyes (el candidato a Concejal por el Distrito D) con los nombres de varios miembros de

la familia de la actual Concejala del Distrito D Oneida Aquino, uno de los cuales murió en febrero y otro que se encontraba en la República Dominicana en el momento de la recogida las firmas. Eso me motivó a buscar los papeles de los otros candidatos para ver si podía descubrir alguna otra irregularidad.

Cuando los nombres de la familia en cuestión fueron llevados a la atención de la Junta, ellos pudieron confirmar que no eran firmas válidas y retiraron la certificación anterior. Sammy había entregado 69 firmas y, aunque doce de ellos fueron declarados "no original" y los removieron, lo dejó con 57 cuando necesitaba sólo 50 firmas certificadas para ser considerado un candidato en la boleta electoral del 20 de septiembre.

Aprendí sobre la importancia de la coherencia en la documentación. La ley exige que el nombre propio de la posición que él o ella ha escogido está escrito correctamente.

En el caso de Denise Perrault, Gary Mannion, otro candidato para la misma posición que manifestó que cada página

debería indicar "Greater Lawrence Technical School Committee." Algunos de sus papeles leían "School Committee Greater Lawrence Technical School", "School Committee Lawrence Voke" y "School Committee - Voke" y otras variaciones con el nombre de la escuela escritos de mano diferente.

Normalmente, esta falta de coherencia podría causar que las firmas de los documentos de nominación sean eliminados, pero en este caso se decidió que los diferentes títulos utilizados no dejan ninguna duda de para qué posición se está postulando y se las permitieron.

El Sr. Mannion señaló también que uno de los documentos de nominación de la Sra. Perrault, con cinco firmas no tenían títulos en el encabezado.

Ellos leyeron la reciente decisión de Rojas del 2007, que fue similar y su página fue descertificada.

Había otras firmas declaró que "no



## La huelga de 1912 y la comunidad lituana

Lituania es un país pequeño en el norte de Europa, situado en el Mar Báltico. La emigración de Lituania a Lawrence comenzó en la década de 1890. En 1910, con la apertura de los nuevos mega-talleres en Lawrence, su población alcanzaría a casi 4,000. Establecieron dos parroquias, un club de Ciudadanos Lituania-Americanos, un cementerio y tres parques recreativos en los bosques en Methuen equivalente a treinta hectáreas, también una gran granja en el oeste de Andover. La emigración de Lituania fue el

resultado de un fallido levantamiento contra la ocupación zarista en 1905 y un proyecto zarista rígido, además de la persecución cultural y del idioma.

Desde el principio, hubo una tensa relación entre los obispos y los sacerdotes locales de Boston con los lituanos. Ellos querían un fuerte consejo parroquial en la parroquia que controla el dinero, prescindir de un sueldo al sacerdote y que le proporcionaran la vivienda. Así, durante la huelga, el pastor Jusaitis y el Padre O'Reilly no eran partidarios de los objetivos de los

huelguistas lituanos y sus aspiraciones.

Cuando la huelga se inició el 12 de enero de 1912 en el taller de Everett Duck, que fue el primer lugar donde los lituanos fueron a trabajar. Eso los puso en medio de la actividad huelguística. Ellos ayudaron a difundir la huelga a la fábrica de Arlington (hoy Malden Mills), donde durante los enfrentamientos, los lituanos

They would establish two parishes, a large Lithuanian-American Citizens' Club, a cemetery and three recreational parks and woods in Methuen equaling thirty acres, also a large farm in West Andover. The emigration from Lithuania was a result on an unsuccessful 1905 revolt against the tsarist occupation and a stiff tsarist draft, plus a language and cultural persecution.

From the start, there was a strained relationship between the Boston bishops and local priests with the Lithuanians. They wanted a strong parish council in

# Las consecuencias de la caída libre y la solución sencilla de un sistema de protección personal contra caídas

"Cuando los trabajadores trabajan en lugares sin seguridad, es un milagro que los accidentes no ocurren" – Sunilda Peguero, Protección en Construcción

**I**magínese trabajando en un techo cuando el pie resbala. Usted está cayendo unos seis metros. El segundo parece lento cuando se da cuenta que no hay nada que le impida, nada para evitar que estrellarse contra el suelo. Desde una altura de veinte pies, golpear el suelo sería como ser atropellado por un camión que iba a unas cuarenta millas por hora. Nadie piensa que el riesgo que asume en esta ocasión terminará en un desastre. Pero la mayoría de las veces las caídas ocurren en un día como cualquier otro, cuando la casualidad convierte al mal riesgo.

La mayoría de las caídas fatales ocurren a alturas más bajas, entre 11 y 30 pies. Sólo el 40 por ciento de las caídas fatales son de más de 40 pies. Cualquier persona que trabaja seis pies por encima de un nivel inferior debe tener protección contra

caídas. Una barrera de seguridad, una red de seguridad o un sistema de protección personal contra caídas puede proteger a los trabajadores de las caídas. A sólo 11 metros sólo hay una probabilidad del 50 por ciento de que un trabajador que cae va a sobrevivir. Se puede imaginarse cómo la probabilidad de supervivencia disminuye mientras las alturas de caídas aumentan.

La buena noticia es que la mayoría de las caídas son evitables y pueden evitarse a través de buenas prácticas de seguridad. Una manera en que muchos contratistas optan evitar las caídas es a través de un sistema de protección personal contra caídas (SPDC). SPDC consisten en un punto de anclaje seguro, una línea fuerte, un cordón de amortiguación y un arnés utilizados por los trabajadores. Recientemente, Protección en Construcción hizo demostraciones de entrenamiento para mostrar el uso correcto de un SPDC. Las demostraciones en Jackson Lumber en Lawrence mostraron cómo diferentes tipos de cordones pueden ser usados para asegurar que el impacto de una caída es absorbido

por el sistema en lugar del trabajador. Si un trabajador que pesa 220 libras se cae seis pies sin protección tendrá un impacto de más de 4,000 libras. Mientras que los SPDC no impiden que un trabajador caiga - a diferencia de una barrera de protección - evitará que el trabajador golpee el suelo y se haga daño.

Antes de utilizar un PFAS hay varias características claves para verificar. En primer lugar, las correas del arnés se deben revisar para asegurarse de que ninguno se encuentra gastado o dañado. El D-ring en la parte posterior del arnés debe estar bien sujetado, sin doblar y situado hacia la parte superior de la espalda del trabajador. Todo el equipo debe ser revisado por los rasgos, las puntadas que falten en las costuras o cualquier otro daño o defecto. El extremo de la cuerda con el amortiguador debe estar siempre unido al de los trabajadores, mientras que el otro extremo se une a la de anclaje. Si una caída ocurre, después

# From My Corner

## Election time irregularities

On August 24th, I took part in a very interesting practice in which I had not been involved before: challenging candidates' names on the ballot. There were several and it was the most enlightening and educational process which should be learned by all potential candidates for public office.

The Board of Registrars met in the City Council chambers to hear testimony and objections from candidates and citizens regarding irregularities or even accusations of fraud in the nomination papers for city council and school committee seats. This board is made up of three individuals: Ronald Martin, chairman, Lynne García and Esvelia Lopez. City Clerk William Maloney serves also as Ex Oficio/Registrar. They have authority to make changes, based on documentation or testimony of any previous certification granted.

We have heard about the Sammy Reyes (candidate for District D City Council) case having the names of several members of current District D Councilor Oneida Aquino's family, one of which died in February and another who was in the Dominican Republic at the time he collected the signatures. That motivated me into looking at other candidates' papers to see if

I could discover any improprieties.

When the names of the family in question was brought to the attention of the Board, they were able to confirm that they were not valid signatures and were removed from the previous certification. Sammy had turned in 69 signatures and even though twelve of them were declared "non-genuine" and removed, that left him with 57 when he needed only 50 certified signatures to be considered a candidate on the September 20th ballot.

I learned about the importance of consistency in the paperwork. The law requires that the proper name of the position for which he or she is being nominated is written correctly.

In the case of Denise Perrault, Gary Mannion, another candidate for the same position stated that each page should have stated "Greater Lawrence Technical School Committee." Some of her papers used "School Committee Greater Lawrence Technical School," "School Committee Lawrence Voke," "School Committee – Voke," and other variations with the name of that school in different hand writings.

Normally, this inconsistency would cause the signatures on these nomination

papers to be removed but in this case it was decided that the different titles used leave no doubt as to which office she is pursuing and they were allowed.

Mr. Mannion also pointed out that one of Ms. Perrault's nomination papers with five signatures had no title on the heading.

They read the recent Rojas decision of 2007 which was similar and her page was decertified.

There were other signatures declared "non-genuine" but, because Ms. Perrault had delivered 142 signatures of the 100 required, she was able to stay in the race.

Mr. Mannion had a similar objection over the nomination papers of Alejandro Feliciano for the Greater Lawrence Technical School Committee since he had written "Greater Lawrence Technical High School Committee" and "Greater Lawrence Vocational Committee" but, as in the previous case with Denise Perrault, they were allowed because people would

# THE METHUEN MIDWAYS 1941 Y CHAMPS/LAWRENCE HIGH 1956 COUNTY CHAMPS

**T**he late Joe Ciras formerly of Methuen and his high school teammates Bucky Boehem, now of Lowell, and Bob Medauer were playing their last game as a team. This trio had outstanding careers while wearing the colors of the Methuen Rangers.

They were to meet the Tower Hill Boys Club for the Lawrence YMCA junior title. This was big and a fan-favorite tournament and had all the best players of the local high school who after completing their schools seasons were all looking forward to this event. It took place in the old "bandbox" gym on Lawrence St. The local team featured Henry Reilly, Andy Gibbons, Billy Sawyer, Gagnon, and Frasca.

The Midways would win this game by a 32/25 score. The suburban team clung to an 8/6 score at end of the first quarter. Tower Hill came back to lead at the half 16/12. Hall of Famers now at Methuen Ciras and Boehem hit for back-to-back set shots to tie it to start the second half. Bucky hits a 15 foot jumper at the third period's end and gives the Midways a 20/19 lead.

Bucky and Joe hit again and Medauer a slashing drive to the hoop and a set shot and the former players at MHS smell a win. The final is 32/25 Midways. The winners received jackets compliments of the Eagle-Tribune and the Hillies were awarded miniature gold basketballs. The winners had only three scorers in the game, Ciras hit for 12, Boehem 10 and Bob Medauer 10.

The Lawrence team scorers were

Sawyer with 8, Gibbons 6, Reilly had 4. In a second game there was an exhibition game between the YMCA varsity versus the "old timers". The veterans tied a slow down game, but it didn't deter the younger team. The legendary Soccer Lynch wearing the same uniform he wore at his last game at the Y in 1919 showed he could still shoot the rock as he hit for 10 baskets.

Al Vaisknoris scored 16, Tom Kilbeldis 6, Soccer 12, Eddie Webb a future LHS hoop coach scored 2, George Grimshaw 15, Fred Coleman threw in 13 and Charlie Karekas tossed in 10 for the winners. Dolph Medalinskas a future LHS Hall of Famer and Bruce Leach and Lambert rounded out the "old timers' squad" in a losing cause. The Y varsity wins 50/39 against a game veteran team.

The Lawrence High Lancers won the 1956 Essex County League Basketball title led by now retired as a guard at Raytheon Barnsey O'Neil, Ronnie Rochon and the great George Maroun and coached by Basil Bova who was Joe DiSalvo of Methuen's Father in law. The opponent was the Hillies of Haverhill and they were big rivals of the local team. Lawrence had beaten the brown and gold downriver team a week previous in a thriller. The blue and white would up their record to 14/5 with this win and a title for Hall of Famer at LHS coach Bova.

Don White a legendary three sporter at HHS and Huberdeau were looking to derail the Lancers and to avenge the previous week's loss. White who went to and played at Notre Dame started strong and his team had the blue and white behind and it looked like his team wanted to run Lawrence right

out of the gym.

The Bova team took a slim 11/8 lead at the first quarter's end. Behind Bill Simes and Huberdeau the downriver boys took a 31/27 lead at halftime. Big Ed Lonardo and Jimmy "snowshoes" McCarthy were trying to stem the tide and keep from getting swamped at the Haverhill gym.

Lonardo did his Bill Russell impersonation as he was blocking everything that came his way; he was at his defensive best. White was pushing his team and it was clicking on all cylinders.

The Lancers trailed by a score of 51/43 with just 3 minutes left. Rochon, who lived near the Essex Projects, starts warming up and the diminutive guard and Barnsey hit for 13 points, Ron for 7 and the former 3 sport star from So Lawrence hit for 6.

Bova has the team in a full court press and it pays dividends; Lawrence was climbing to a one point lead and the Haverhill's with the ball had 50 seconds left on the game clock. George Maroun a clutch player in all three sports steals the ball and goes to the cup unmolested to clinch the win and the title for Lawrence.

Maroun played football and baseball at LHS and later went to Michigan State to play football and still later after watching his son lead Salem, NH high school to a State Title, he became a Sulky jockey. He was no stranger to big plays in his career and I'll bet he'll always remember the game winning clincher that gave Lawrence High School the Essex County League title in 1956. The score again was Lawrence 60, Haverhill 57.

## Governor Patrick's Safe and Successful Youth Initiative

Governor Patrick emphasized his concern in his state of the Commonwealth address in January.

Since the announcement of the initiative in July, Mayor Lantigua has been working closely with the Lawrence Police Department, the Community Development Department and other interested leaders around the city to develop a strategy to address violence in the city.

In announcing the request to the state Mayor Lantigua stated: "Our youth are our most precious asset and our pathway to the future and no child is expendable. We owe our youth the best we can offer, all the time, every day. It is with this over riding belief that I am submitting this request for assistance for funding under Governor Patrick's Safe and Successful Youth Initiative. We have designated our strategy as 'OUR PROMISE TO YOUTH' and our approach will be

'whatever it takes, wherever it is needed, for as long as necessary'. The great city of Lawrence intends to keep this promise."

Mayor Lantigua wishes to thank the civic leaders and public servants who have worked with him so tirelessly in the past month to develop the OUR PROMISE TO YOUTH strategy. Mayor Lantigua went on to say, "The great city of Lawrence is blessed by many strong and effective community based and faith based organizations and many dedicated public servants committed to helping our youth. Our residents and business leaders are proud of and committed to our city.

OUR PROMISE TO YOUTH will capture that strong sense of collaboration and go into the streets where our troubled young men are. OUR PROMISE TO YOUTH will also be a key part of the city's economic development strategy of the city by focusing on providing these young men with educational opportunity, job training and job placement along with the necessary social services to support them and their families.

Police Chief John Romero has given his full support to the request. In submitting the request Chief Romero stated, "This recent upturn in violence is staggering and physically punishing for a City like Lawrence. However, it is imperative that we stay ahead of the curve and actively employ more preventive techniques and increase our presence in our schools, both in an official capacity as law enforcement officers but also in a more informal role to find ways to engage our youth in constructive activities and personal relationships. 

have no doubt as to the position for which he is a candidate.

Four names were removed, though, after finding that they were "not-genuine" leaving Mr. Feliciano with 113 signatures when the requirement is 100.

The last case involved my objection to four names on Mark Gray's nomination papers that showed the same handwriting. Mr. Gray is currently the District E School Committeemember looking to be re-elected. He has two opponents: Homayoun Maali and Jennifer Cooper.

The Board decided that one of the signatures on file matched one of the residents whose name appeared on that list. Since the other three were in the same handwriting, it was estimated that she signed for the other members of the family which is not allowed by law.

When I asked the Elections Coordinator Rafael Tejeda and City Clerk Maloney about this, their response was that all they do is match the name and address on the nomination papers with those on the computer and certify that they are registered voters. I argued that in that case, there is no need to walk around collecting signatures when all we need is to copy names and addresses from the voters list, confident that it will not be compared to the originals.

The petitions contain a warning that there could be a fine and criminal penalties for persons who perpetrated a fraud on the petitions. It also explains that individuals could receive a \$1,000 fine and up to one year in jail but it has become common practice in this city.

Ms. Cooper had noticed that someone who had signed her nomination papers also signed Mr. Gray's. She filed her nomination papers and they were certified on June 29, 2011, while Mr. Gray waited until the very end to start collecting his signatures and turned them in for certification on the last day – August 2, 2011.

Ms. Cooper believed that his signature should be deleted from the total because state law indicates that residents cannot sign nomination papers for more candidates than the number they will be able to elect. For example, we can only vote for one member of the school committee or district council; we should not give our signature to more than one candidate for those positions or run the risk of having it thrown out. In the case of city council at-large, we can vote for three candidates because there are three positions available on Election Day so, we

When the names of the family in question was brought to the attention of the Board, they were able to confirm that they were not valid signatures and were removed from the previous certification. Sammy had turned in 69 signatures and even though twelve of them were declared "non-genuine" and removed, that left him with 57 when he needed only 50 certified signatures to be considered a candidate on the September 20th ballot.

can sign three nomination papers.

City Clerk Maloney explained that historically, in Lawrence we sign everybody's nomination papers and there is ignorance of that law. Now that someone has brought it to our attention, the city must abide by it in the future.

Mr. Gray had turned in 53 signatures in total and after losing three as a result of my objection, he had the minimum number left but upon having Ms. Cooper's objection decided, his number of signatures was reduced to 49 thus leaving him out of the ballot during the Primary Elections.

Let that be a lesson to potential candidates in the future!

Something truly appalling was learning of the number of signatures removed from Perrault and Feliciano's papers as a result of these objections for not being registered voters at all and yet, they had been certified.

A group of us has been trying for years to establish a Voter ID system in this city and have run into stumbling blocks from our own politicians. Now, after going through that experience I believe that we need a lot more than that. Before any signature is certified, the Elections Department must compare it to that on their files to guarantee the integrity of the process.



originales”, pero porque la Sra. Perrault había entregado 142 firmas de las 100 requeridas, fue capaz de mantenerse en la contienda.

El Sr. Mannion tuvo una objeción similar en los documentos de nominación de Alejandro Feliciano para el Comité Escolar de la Escuela Técnica de Lawrence ya que había escrito “Greater Lawrence Technical High School Committee” y “Greater Lawrence Vocational Committee” pero, como en el caso anterior con Denise Perrault, se les permitió porque la gente no tendría ninguna duda en cuanto a la posición para la que es un candidato.

Cuatro nombres fueron eliminados, sin embargo, después de encontrar que “no eran originales”, dejando el Sr. Feliciano con 113 firmas, cuando el requisito es de 100.

El último caso fue sobre mi objeción a cuatro nombres en los documentos de nominación de Mark Gray, que mostraban haber sido escritos con la misma letra. El Sr. Gray es actualmente miembro del Comité Escolar por el Distrito E que busca ser reelegido. Él tiene dos rivales: Homayoun Maali y Jennifer Cooper.

La Junta decidió que una de las firmas en sus archivos es igual a la de una residente cuyo nombre apareció en la lista. Ya que los otros tres estaban en la misma letra, se estimó que ella firmó por los demás miembros de la familia lo cual no está permitido por la ley.

Cuando le pregunté al coordinador de las elecciones, Rafael Tejeda y al Escribano de la Ciudad Maloney acerca de esto, su respuesta fue que lo único que hacen es ver que el nombre y dirección en los documentos de nominación coincida con los de la computadora y certifican que son votantes registrados. Yo argumenté que, en ese caso, no hay necesidad de caminar alrededor recogiendo firmas si todo lo que necesitamos es copiar nombres y direcciones de la lista de votantes, confiados en que no van a ser comparadas con los originales.

Las peticiones contienen una advertencia de que podría haber una multa y sanciones penales para las personas que perpetraron un fraude en las peticiones. También explica que las personas pueden recibir una multa de 1.000 dólares y hasta un año de prisión, pero se ha convertido en una práctica común en esta ciudad.

La Sra. Cooper había notado que alguien que había firmado sus papeles de

nominación también firmó los del señor Gray. Ella presentó sus documentos de nominación y fueron certificados el 29 de junio de 2011, mientras que el Sr. Gray esperó hasta el final para comenzar a recoger sus firmas y las fue a entregar para que fueran certificadas el último día – el 2 de agosto de 2011.

La Sra. Cooper cree que su firma debe ser eliminada de la total, porque la ley estatal indica que los residentes no pueden firmar los papeles de nominación por más candidatos que el número que se podrán elegir. Por ejemplo, sólo podemos votar por un miembro del comité escolar o por un concejal de distrito, no debemos dar nuestra firma a más de un candidato para esos puestos o correr el riesgo de que no sea aprobado. En el caso de concilio “at-large”, se puede votar por tres candidatos, porque hay tres plazas disponibles el día de las elecciones así, podemos firmar tres documentos de nominación.

El Escribano de la Ciudad Maloney explicó que históricamente, en Lawrence firmamos los papeles de nominación de todos y hay mucha ignorancia de esa ley. Ahora que alguien lo ha traído a nuestra atención, la ciudad debe cumplir con él en el futuro.

El Sr. Gray había entregado 53 firmas en total, y después de perder tres, como resultado de mi objeción, le había dejado el número mínimo, pero al tener la objeción de la señora Cooper decidida, el número de firmas se redujo a 49 por lo tanto lo dejó fuera de boleta en las elecciones preliminares.

¡Que les sirva de lección a los candidatos en el futuro!

Algo verdaderamente lamentable fue ver la cantidad de firmas retiradas de los documentos de Perrault y Feliciano como resultado de estas objeciones, por no ser votantes registrados y, sin embargo, habían sido certificadas.

Un grupo de nosotros ha estado intentando durante años establecer un sistema de identificación de votantes en esta ciudad y se han topado con tropiezos por parte de nuestros políticos. Ahora, después de pasar por esa experiencia yo creo que necesitamos mucho más que eso. Antes que cualquier firma sea certificada, el Departamento de Elecciones debe compararla con la de sus archivos para garantizar la integridad del proceso.

# ACT propone nueva forma de medir la disparidad entre la oferta y la demanda de destrezas laborales

El informe contiene instrumentos para analizar la brecha en cuatro sectores industriales

**A**CT Inc. propuso hoy medidas específicas para analizar la brecha entre las competencias laborales que requieren cuatro sectores industriales principales y las que ofrece la fuerza laboral. En un informe titulado "A Better Measure of Skills Gap" (Una manera mejor de medir la brecha entre la oferta y la demanda de competencias laborales), ACT recomienda un nuevo enfoque para analizar esta brecha.

En momentos en que el país lucha por superar los efectos de la recesión más profunda que se recuerde, los encargados de formular políticas se esfuerzan por encontrar formas de integrar a los millones de trabajadores desempleados cuyas actuales destrezas pueden no ser adecuadas. La nueva realidad es que un segmento importante de la fuerza laboral de hoy no tiene las destrezas requeridas por los empleadores.

Al enfoque equilibrado que plantea ACT se incorporan métodos cuantitativos rigurosos con un énfasis en la aplicación práctica. El informe está concebido para ayudar a los especialistas en desarrollo de la fuerza laboral y en el desarrollo económico del país que deben enfrentar esta creciente disparidad.

"Con demasiada frecuencia y por demasiado tiempo, los especialistas en desarrollo de la fuerza laboral y desarrollo económico se han basado en datos relativos al nivel académico de los trabajadores, procedentes de fuentes del gobierno como el Censo o la Oficina de Estadísticas Laborales, para representar el nivel de destrezas", dice Martin Scaglione, vicepresidente del área de Desarrollo de la Fuerza Laboral de ACT.

Scaglione agrega: "Nosotros planteamos que el análisis de la brecha entre la demanda y la oferta de competencias laborales debe enfocarse en destrezas precisas e identificables y que estos niveles de destrezas pueden y deben medirse de modo independiente del nivel académico".

De hecho, Según Scaglione, los estudios realizados desde 2007 indican sin lugar a dudas que las labores involucradas en el trabajo y las destrezas necesarias para ejecutarlas son una mejor variable para predecir el crecimiento del empleo y los salarios que el nivel académico o el nombre de la ocupación.

El informe de ACT propone una definición sencilla para describir el fenómeno de la brecha entre la oferta y la demanda de destrezas y enumera medidas detalladas y específicas para analizar esa disparidad en cuatro sectores industriales importantes.

Tres de las conclusiones clave del informe son:

- Se detectaron diferencias significativas entre las destrezas fundamentales que tenían los trabajadores y aspirantes a empleos de los Estados Unidos que tomaron las pruebas WorkKeys (cuyo nivel académico era mediano o alto) y los empleos que requieren un nivel académico similar.

- En el caso de las ocupaciones seleccionadas en los sectores de manufactura, servicios de salud, construcción y energía que requerían un nivel académico mediano o alto, la mayoría de las personas que tomaron la prueba WorkKeys no pudieron demostrar el nivel de destrezas requerido para localizar información. Esta destreza implica la capacidad para localizar, sintetizar y utilizar información de materiales gráficos comunes en los lugares de trabajo, como gráficas, tablas, formularios, flujogramas,

diagramas, diagramas de plantas, mapas e indicadores de determinados instrumentos.

- Se debe mostrar prudencia al considerar el uso de medidas indirectas de las destrezas como sustituto del verdadero nivel de destrezas. Los resultados del análisis de ACT implican que el nivel académico no guarda necesariamente relación con la brecha entre sus destrezas y las competencias fundamentales que demandan los empleos; de hecho, parece que la brecha se hace más grande a medida que aumenta el nivel académico.

ACT cuenta con una amplia base de datos de perfiles ocupacionales para identificar los niveles de destrezas fundamentales necesarias para tener éxito en cada ocupación. Estos niveles de destrezas, que se basan en las pruebas WorkKeys de ACT y constituyen los cimientos del National Career Readiness Certificate (certificado nacional de preparación para el empleo), son medios para identificar las competencias de la fuerza laboral, al igual que la movilidad dentro de ella, a medida que los trabajadores consideran la posibilidad de capacitarse para ocupaciones nuevas que tengan alta demanda.

## SULLIVAN: The Consequences of Free Falling and the Easy Solution of a Personal Fall Arrest System

risk bad.

Most fatal falls occur at lower heights, between 11 and 30 feet. Only 40 percent of fatal falls are from over 40 feet. Anyone working six feet above a lower level should have fall safety protection. A guardrail, a safety net, or a personal fall arrest system can protect workers from falls. At just 11 feet there is only a 50 percent chance that a falling worker will survive. One can imagine how the likelihood of survival decreases as fall heights rise.

The good news is that most falls are avoidable and can be prevented by safe practices. One way that many contractors choose to prevent falls is by having workers use a Personal Fall Arrest system (PFAS). PFAS consist of a secure anchor point, a strong line, a shock-absorbing lanyard and a harness worn by the worker. Protección en Construcción recently held training demonstrations to show the proper use of a PFAS. Demonstrators at Jackson Lumber in Lawrence showed how different lanyards may be used to ensure that the shock of a fall is absorbed by the system rather than the falling worker. A worker that weighs 220 pounds dropped six feet without protection will impact the ground at over 4,000 pounds. While the PFAS doesn't prevent a worker from falling – unlike a guardrail – it will prevent the worker from hitting the ground and getting hurt.

Before using a PFAS there are several key features to check. First, the harness straps should be checked to make sure none are frayed or broken. The D-ring on the back of the harness must be securely attached, unbent and located towards the upper part of the worker's back. All equipment should be checked for tears, missing stitches or any other damage or defects. The end of the lanyard with the shock absorber should always be attached to the worker while the other end is attached to the anchor. If a fall occurs the lanyard must be exchanged afterwards for an unused shock absorber. Anchors must be secure and capable of holding 5,000 pounds. They should not be attached to scaffolding or ladders – but to a secure point on the building. PFAS are available at Jackson Lumber and cost around \$150 for a complete kit.

As promotora, Ceferina Williams described, "These workers repeat the need for safety at work. No one wants to return to their home injured or to never return and leave their family in mourning." Falls are preventable. Education and the effective use of safety equipment are the solution. Contractors can meet fall prevention requirements efficiently and affordably.

Protección en Construcción is recruiting contractors who want free help to prevent falls. Contractors who work with the partnership can improve their business by improving their safety. ## STUNDZIA: La huelga de 1912 y la comunidad lituana

fueron algunos de los primeros que fueron detenidos. Las jóvenes lituanas lucharon con los esquirolas (rompehuelgas) mediante el uso de pimienta molida que le echaban en los ojos a los y palos de escoba cortados que escondieron en sus enaguas para golpear a los rompehuelgas.

Alrededor de un centenar de estudiantes de Harvard llegaron a Lawrence y recibieron crédito académico "por su aventura con esa gente". Se unieron a la milicia del estado para intimidar a los trabajadores, muchos de ellos a caballo. La milicia atacaba a los piqueteros y los golpearon con palos. Mi abuela Anne, fue una de las personas golpeadas. Los dirigentes sindicales de los Trabajadores Industriales del Mundo (Industrial Workers of the World - IWW) llevó a los hombres de nuevo a las líneas al frente de las marchas de protesta. En un caso, las chicas gaidys (gallitos de pelea) utilizaron los alfileres largos de sus sombreros pinchando el trasero de los caballos para romper para contrarrestar los ataques. Esto no estaba en el manual. Se les recordará siempre con el humor de sus actos.

En el relato de un periódico, una manifestación comenzó en el Salón Lituano Chibas en la esquina de las calles Elm y Short. Subieron y bajaron por las calles llamando la atención. Hicieron un llamamiento a los trabajadores a salir a marchar. Cuando finalmente llegaron a la comisaría de policía en las calles Common y Lawrence, para ese momento era un grupo mixto fuerte de 3,000 personas. Se reían y burlaban de los líderes de las milicias que miraban desde las ventanas, alzando sus puños y agitando las banderas de Estados Unidos cantando.

Como una nota aparte, los lituanos cantaban canciones revolucionarias del 1905 que estaban frescas en sus mentes. Muchos de los lituanos tenían miedo de salir a la calle, intimidados por las bayonetas y las milicias. Un pariente dijo más tarde, debido al miedo, la familia se quedó en su casa en Lowell Street. Su alimento principal fue una bolsa de cincuenta libras de zanahorias. De más está decir que mi tía Ursula tenía un desdén tremendo por las zanahorias por el resto de su vida.

La huelga de ocho semanas en medio de un invierno frío fue difícil para todos. Dinero de ayuda se recolectó en las colonias de Lituania desde lugares tan lejanos como Alberta, Canadá, hasta las minas de carbón de Pennsylvania. La Familia Ramanauskas reunió dinero y trabajando con la IWW. Uno de los principales dirigentes fue Big Bill Hayward, que tuvo que escapar de la policía, pero estuvo escondido en la escalera trasera del Salón de Lituania. Hayward dio muchos discursos allí. El pidió a los lituanos que se pusieran en contacto con amigos y familiares para trabajar lentamente y crear un "retraso en la producción" en otros talleres textiles de Nueva Inglaterra, para forzarlos a prestar atención a la huelga de Lawrence.

Otra táctica en la que los lituanos participaron fue el envío de los niños a familias trabajadoras que simpatizaban con los sindicatos en otras ciudades. Más tarde los niños hablaron de los cuidados y la alimentación que recibieron en los malos tiempos.

El 12 de marzo de 1912 la demanda

their parish that would control the money, dispense a pay to the priest and provide him housing. Thus, during the strike, the pastor Jusaitis and Fr. O'Reilly were not supportive of the Lithuanian strikers' goals and aspirations.

When the strike started in January 12, 1912 in the Everett Duck Mills, it was the location where the Lithuanians worked. Thus they were in the midst of the strike activity. They helped spread the strike to the Arlington Mill (today's Malden Mills), where during the confrontations, the Lithuanians were some of the first who were arrested. The young Lithuanian girls fought with the scabs (strike breakers) by using ground pepper to toss into the scabs eyes, and cut off broom sticks which they hid in their petticoats to hit the scabs.

About one hundred Harvard students came to Lawrence, and received classroom credit "to have their fling with those people". They joined with the state militia to intimidate the workers, many of them on horseback. The militia would attack the picketers and beat them with clubs. My grandmother Anne was one of those beaten. The Industrial Workers of the World (I.W.W.) union leaders brought the men back to the front lines of the protest marches. In one case the GAIIDS girls used their long hat pins to disrupt the cavalry line by jabbing the horse buttock to counteract the attacks. This was not in the manual. They were long remembered with humor for their deeds.

In one newspaper account, a rally started at the Lithuanian Chibas Hall on the corner of Short and Elm streets. It went up and down the streets gathering momentum. They called out to workers to come out and march. When they finally got to the police station at Lawrence and Common Streets, by this time they were a mixed group of 3,000 strong. They jeered and mocked the militia leaders that watched from the windows, by raising their fists waving their American flags and chanting.

As a footnote, the Lithuanians chanted 1905 revolutionary songs that were fresh in their minds. Many of the Lith's were fearful to go out into the street, intimidated by the bayonets and militia. One relative later stated, due to the fear, the family stayed in their house on Lowell Street. Their main staple was a fifty pound bag of carrots. Needless to say my grand aunt Ursula grew a disdain for carrots for the rest of her life.

The eight week strike in the dead of

a cold winter was difficult for all. Relief money was collected from Lithuanian colonies from as far away as Alberta, Canada, to the coal mines of Pennsylvania. The Ramanauskas raised the money and worked with the I.W.W. One of the main leaders was Big Bill Hayward who had to escape from the police, but he was hidden in the Lithuanian Hall's back staircase. Hayward gave many speeches there. He asked the Lith's to contact friends and relatives to create a "Work Slow Down" in other N.E Textile Mills, to force attention to the strike in Lawrence.

Another tactic the Lith's participated in, was the shipping out of the children to sympathetic union worker families in other cities. Later in life those children spoke of the care and food they received in those bad times.

By March 12, 1912 the demand of the strikers were met, but the tension was still high in Lawrence. In the fall of 1912, the I.W.W. Union leaders were still in jail in Salem, Massachusetts for causing the death of Anne Lopizzo. About the same time, small groups of local hoods went into the Lithuanian neighborhood of Elm and Lawrence Streets to "Beat up some Lithuanians". They met up with one Lithuanian, Jonas Smolskas, which they attacked and beat because he was wearing an I.W.W. button. Smolskas later died from

his injuries and became the third victim of the Lawrence textile strike. His attackers were later charged with manslaughter, because one was an amateur boxer and his hands were considered deadly weapons.

"Big Bill" presided over the funeral of Smolskas at the Immaculate Conception Cemetery. Red carnations were tossed into the grave and farewells were bestowed as Smolskas was declared a victim of the strike. The I.W.W leaders were found not guilty in Salem.

In fact, this would not be the end of the labor tensions for the Lithuanians. Many like Ambrose Stravinskas, a labor activist, were blackballed and unable to get work in Lawrence, according to mill exclusion lists. The Lith's felt empowered and became more active in the 1919 strike, and several were deported by the Palmer raids. Today the Lithuanian community is raising money and asking others to assist in the creation of a permanent memorial to the strikers in the north common. This striker's monument will recognize the courage and tenacity of the mill workers in Lawrence during the great strike of 1912, and become a focal point of our city's history.

de los huelguistas fue cumplida, pero la tensión siguió elevada en Lawrence. Para el otoño de 1912, los líderes sindicales de I.W.W. seguían en la cárcel de Salem, Massachusetts por causar la muerte de Anne Lopizzo. Casi al mismo tiempo, pequeños grupos de delincuentes locales entraron en el barrio lituano en las calles Elm y Lawrence para "dar una paliza a algún lituano". Se encontraron con un lituano, Jonas Smolskas, al que atacaron y golpearon porque llevaba un botón de IWW. Smolskas más tarde murió de sus heridas y se convirtió en la tercera víctima de la huelga textil de Lawrence. Sus agresores fueron acusados posteriormente de homicidio, porque uno

era un boxeador amateur y sus manos eran consideradas armas letales.

"Big Bill" presidió el funeral de Smolskas en el cementerio de la Inmaculada Concepción. Claveles rojos fueron arrojados a la tumba y Smolskas fue declarado víctima de la huelga. Los líderes de I.W.W. fueron declarados no culpables en Salem.

De hecho, este no sería el fin de las tensiones de trabajo de los lituanos. Muchos, como Ambrosio Stravinskas, activista sindical, fue vetado y no pudo volver a conseguir trabajo en Lawrence de acuerdo con las listas de exclusión del molino. Los lituanos se sintieron fortalecidos y se

activaron más en la huelga de 1919, cuando varios fueron deportados por las redadas de Palmer. Hoy en día la comunidad lituana está recaudando dinero y pidiendo ayuda a los demás para la creación de un monumento permanente a los huelguistas en el parque del norte. Este monumento reconocerá el valor y la tenacidad de los trabajadores de los talleres de Lawrence durante la gran huelga de 1912, y se convertirá en un punto central de la historia de nuestra ciudad.

**PLESHAW: Festival Pan y Rosas: Su Historia**

reconoce y honra al trabajador. Siempre el festival ha sido gratuito y abierto al público. Siempre se ha negado a recibir patrocinios ni publicidad de compañías tabacaleras y de bebidas alcohólicas. Siempre ha sido orientado a la familia.

El festival comenzó a raíz de un creciente interés en la Huelga Textil del 1912, conocida como la Huelga de Pan y Rosas, en los últimos años de la década del 70 y principios de la década de los 80. El padre del festival fue John Corliss, quien visualizó el festival como una forma de celebrar la inauguración del parque estatal Lawrence Heritage State Park en el Día del trabajo en el 1985. Muchos pensaron que esto sería cuestión de una sola celebración, pero John junto a su colaborador Russell Aminzade, decidió intentarlo una vez más. Ya el resto es historia.

Durante los primeros años, figuras legendarias de la música folklórica tales como Pete Seeger, Arlo Guthrie, Judy Collins, Odetta y Tom Rush se dieron paso por la tarima del festival. Estos primeros años también fueron testigos de festivales dos en uno, literalmente. Estos comenzaban en el Parque Campagnone y culminaban en el Parque Pemberton a orillas del Río Merrimack.

Aunque siempre se ha mantenido una conexión con la música folklórica y la música inspirada en la lucha obrera, a través de los años el festival ha venido reflejando la vida y cultura del Lawrence

contemporáneo. Con esta nueva reflexión, las bailarinas irlandesas y los violinistas de Quebec se unieron a los ritmos latinos de salsa y merengue.

Aunque la música todavía predomina en el festival, el baile también ha sido parte clave de la celebración. Las obras teatrales también han tenido un espacio importante. En el 2001, un grupo de estudiantes de la Winthrop High School interpretaron una pieza original basada en la Huelga Textil del 1912. En el 2006, el grupo de teatro de Lawrence Acting Out interpretó piezas basadas en la huelga textil.

Otros eventos e instituciones han surgido en los últimos años. La Historia de Lawrence en Vivo (Lawrence History Live) ha traído al festival a autores, historiadores, y artistas con el propósito de enaltecer el legado de la huelga del 1912. Además, el Salón de la Fama Pan y Rosas honra a personas que no deben ser olvidadas por sus contribuciones directas a los eventos del 1912 y su compromiso de preservar el legado de la huelga.

El año 2012 marcará el centenario de la Huelga Textil del 1912 y el vigésimo octavo aniversario del Festival Pan y Rosas. Mucho ha cambiado en veintiocho años, y mucho más en cien años, pero algo nunca cambiará: El Festival Anual Pan y Rosas continuará conmemorando lo que aconteció en la Ciudad de Lawrence en el 1912 y celebrará las vidas de aquellos que vivieron, viven, y vivirán aquí.

## PLESHAW: The Bread & Roses Labor Day Heritage Festival: The History

no one left from the original group that organized the first Festival still associated with its operation today.

Of course, that's just the way it is. People who weren't born when the first Festival took place in 1985 are now within reach of their thirtieth birthdays. People who were in the dawn of their adulthoods in the mid-1980's are now in the late afternoons of their lives. For the Bread & Roses Festival, as for everyone and everything, times, and people, have changed.

Yet, for all the changes, in the world and in itself, the Festival lives on. Why? How? There are probably as many answers to that question as there are people who have worked on the Festival through the years, but one thing has remained the same.

That has been the ongoing, never-ending, never-altering commitment to the core mission of the Festival: to commemorate the Great Lawrence Textile Workers' Strike of 1912, and to celebrate the artistic and cultural heritage of all the people who lived and worked in Lawrence then... and in all the years since, right to the present day.

Other things have stayed the same as well. The Festival, befitting its name, is still held on Labor Day, the national holiday that recognizes and honors the American worker. It has always been free of charge. It has always refused alcohol and tobacco advertising and sponsorship. And it has always been family-oriented.

The Festival started in the aftermath of the great revival of interest in the Great Strike of 1912—popularly known as the “Bread and Roses Strike”—in the late-1970's and early-1980's. The first official Festival was held in 1985, but the event really came into its own the following year. The father of the Festival was John Corliss, who saw it as a way to help celebrate the opening of the Lawrence Heritage State Park on Labor Day, 1986. Many thought that that would be the end of the Festival, but John and his chief collaborator, Russell Aminzade, decided to keep it going for another year. And another. And another.

The early years saw the appearances of such immortal folk music legends as Pete Seeger, Arlo Guthrie, Judy Collins, Odetta and Tom Rush. They also saw, literally, two Festivals in one, as the day would begin with the performances on Campagnone Common, downtown Lawrence's city park, followed by a nighttime migration to a stage

in Pemberton Park, along the Merrimack River.

While always maintaining a relationship with acoustic folk and labor-inspired music, through the years the Festival came to reflect the life, lives and culture of contemporary Lawrence, as Irish step-dancers and Quebecois fiddlers were joined by such Latin rhythms as salsa and merengue.

While music still predominates at the Festival, dance has always been an important part of the festivities. Theatrical performances have also become a part of the Festival. A group of students from Winthrop High School performed an original play based on the 1912 Lawrence Strike in 2001. In 2006, the Lawrence theater group Acting Out performed pieces based on the Strike.

Along with the artistic performances, the Festival has also been actively involved in preserving and publicizing important (and sometimes neglected and even forgotten) people and episodes essential to the telling of the full story of the Strike. It has collaborated with Jonas Stundza's efforts to commemorate the three victims of the Strike: Annie Lopizzo, John Rami and Jonas Smolskas (who was killed in the post-Strike repression). Mr. Stundza arranged to have fabricated new gravestones memorializing their roles in the Strike. These were displayed at consecutive Festivals, and were then placed at the grave sites in St. Mary's/Immaculate Conception Cemetery.

Other events and institutions have emerged in recent years. Lawrence History Live brings authors, historians and artists to the Festival to illuminate the meaning of the 1912 Strike, for both the past and the present. And the annual Bread & Roses Hall of Fame Award remembers those individuals whose contributions to the events of 1912, and to preserving its memory and meaning in the years since, should not be forgotten.

2012 will mark the 100th Anniversary of the Great Lawrence Textile Workers' Strike of 1912. It will also mark the 28th year for the Bread & Roses Labor Day Heritage Festival. A lot can change in twenty-eight years, to say nothing of one hundred. But one thing will never change. The Annual Bread & Roses Labor Day Festival will continue to commemorate what happened in the city of Lawrence in 1912, and celebrate the lives of those who lived in the city then, since, and now.




