## LGH cuts ribbon of newly renovated Pediatric Center

Thursday, January 19, 2012, Lawrence General Hospital hosted a ribbon cutting ceremony for its newly renovated Pediatric Center to formally open the new center.

Dianne J. Anderson, Lawrence General Hospital President and Chief Executive Officer, thanked the support of individual and community donors and to the talented physicians, dedicated nurses and staff, and the innovative administration at both Lawrence General Hospital and Floating Hospital for Children at Tufts Medical Center who believe in a community-centered model of health care.

The Pediatric Center offers a family-centered experience with five new private rooms, bathroom renovations, fold down

tables for puzzles and games, flat-screen televisions with interactive educational programming as well as sleeper sofas for parents. Medical equipment is kept in the background until needed, and includes bedside EMR, and enhanced lighting for improved patient observation.

The Center received fresh paint, new flooring, and lighting; and this winter additional enhancements are planned as 10 year old local High Plain Elementary student, Sana Nadkarni will be painting custom artwork for the Center. Leading the team of Pediatric Hospitalists from Floating Hospital for Children is Dan Charles Hale, MD, FAAP.

## Merrimack Valley Cities win Health District Grant

The Cities of Methuen, Haverhill, and Lawrence have received a grant from the Massachusetts Department of Public Health to create the Merrimack Valley Health District. The grant will enable the three cities to enter into long-term agreements for sharing of resources and coordinating public health services.

The Public Health District Incentive Grant program is made possible by federal funding from the U.S. Department of Health and Human Services and is aimed at strengthening local public health infrastructures across the nation. Massachusetts is one of only 14 states that received funding for the initiative, which was made possible through the Prevention and Public Health Fund created by the Patient Protection and Affordable Care Act of 2010. Methuen, Haverhill and Lawrence received one of only five grants awarded in the state of Massachusetts.

"This is a great opportunity for Methuen to join with our Merrimack Valley neighbors in strengthening public health in our region," said Mayor Stephen Zanni. "I am really excited for our cities to be getting this funding."

"This is a perfect example of municipalities collaborating on a regional level to ensure the best possible health services to our citizenry" stated Mayor

William Lantigua of Lawrence.

The newly created Public Health Districts will receive a total of \$325,000 over the course of four years, beginning with a \$100,000 grant in 2012. The funding will help to assure that the three cities can address core responsibilities of health departments, including communicable disease control, environmental health protection, and chronic disease reduction. The grant will fund a full-time public health nurse and part-time environmental health inspector. The new health district will work with community partners, including local hospitals and health centers to develop a community health assessment that will identify priority public health needs.

The three city health departments play vital roles in preventing communicable diseases, such as H1N1 flu, West Nile virus, EEE and diseases spread by ticks, and the prevalence of diseases associated with obesity, underscore the importance of maintaining public health services. Recent food related outbreaks also call for strong enforcement of food safety regulations. The Merrimack Valley Health District grant will enable the three cities to expand their limited resources to meet these public health demands for the residents of Methuen, Haverhill, and Lawrence.

# Lawrence: Centro para la Educación

La historia nos dice que en 1912, Lawrence fue un gran centro textil. Los talleres de lana y algodón empleaban a más de 40,000 personas, la mayoría de ellos eran trabajadores de muchas nacionalidades, que habían venido de Europa alrededor del 1900, atraídos por las promesas de trabajo en la industria textil en expansión en Massachusetts.

La Huelga de Pan y Rosas de 1912, la cual estamos conmemorando su primer centenario este año trajo cambios con respecto a las condiciones de trabajo y, sobre todo en los salarios.

Una vez que el sector se desplomó y cerró la producción, dejó a miles de trabajadores no calificados en busca de trabajo. No sucedió de la noche a la mañana, pero a partir de una industria de producción nos hemos convertido en una industria de servicios y alta tecnología, para la cual nuestra fuerza de trabajo no estaba preparada.

Afortunadamente, en el Valle de Merrimack tenemos a Northern Essex Community College. Con sede en Haverhill, pero con una gran expansión en Lawrence, a pesar de reducciones significativas de apoyo financiero del estado en los últimos cinco años, nuestras escuelas están listas para empezar a cerrar la brecha de esa habilidad.

Con el fin de ayudar a los colegios de la comunidad a cumplir con esta misión, en su discurso sobre el estado del Estado, el Gobernador Patrick propuso un aumento de \$10 millones en financiación, así como un presupuesto ágil y proceso de selección de liderazgo para los colegios comunitarios.

Damos la bienvenida a la propuesta del gobernador Patrick. Es hora de poner a nuestra gente a trabajar.

## Lawrence: Center for Education

History tells us that in 1912, Lawrence was a great textile center. The woolen and cotton mills employed over 40,000 persons; most of them were unskilled workers of many nationalities, who had come from Europe around 1900, attracted by the promises of work in the expanding textile industry in Massachusetts.

The Bread and Roses Strike of 1912, which we are commemorating in its first centennial this year brought changes regarding working conditions and particularly in salaries.

Once the industry collapsed and closed the production it left thousands of unskilled workers looking for jobs. It did not happen overnight, but from a production industry we have become a service and high tech industry, for which our workforce was not prepare.

Fortunately, in the Merrimack Valley we have Northern Essex Community College. Based in Haverhill with a vast expansion in Lawrence, despite significant cuts in state financial support over the last five years, our campuses are ready to start closing that skill's gap.

In order to help the community colleges meet this mission, in his State of the State speech, Governor Patrick proposed a \$10 million increase in funding as well as a streamlined budget and leadership selection process for the community colleges campuses.

We welcome Governor Patrick proposal. It's time to put our people back to work.

Muchas personas se han metido en problemas con la Comisión de Ética por menos que eso!

El 30 de enero, la Concejala Aquino finalmente entregó el informe financiero que se venció el 20 de enero y los barriles no están allí.

# Formar el criterio

## Forming the criterion

In the society we live in, children and young people receive many messages and phrases that convey ideals, which are not always positive to form the personality, or to help them be happy.

It is therefore important that children learn to form a personal opinion to distinguish right from wrong between what they see on the street, television and friends. And after knowing what is good and positive, will develop the willpower to carry out what they think they should do, but find it annoying or expensive.

The work of teachers cannot keep on saying repeatedly, "this is not right" or "I do not like" without arguing or giving reasons to explain this statement. Along the negative aspect is more important to educate positive, ie, to show the beauty of virtue cheerful and serene, without fear or inhibition. Doing good things and service to others is much more attractive and joyful act incorrectly, although in certain environments where stated otherwise.

Children need the example of their parents and teachers who see the rock based on the most authentic values. They must be, for his integrity and coherence of life, the foundation on which to lean and rest small. Children need strong parents,

to withstand the daily turmoil and can convey strength, confidence, protection and guidance to their children.

Given the facts that come to us by television and other means, one must ask why these behaviors, to discover the potential injustice, envy, pride, etc., that caused them. And we need each personally examine the actions we have done and that can hurt others or offend God, to apologize to one or the other. There are psychiatrists who say that it is necessary and healthy to accept the sense of sin. This avoids the guilt complex and distressing feeling of being wrong, accompanied by fear or shame.

You have to provide the means to the little ones and gradually will feel more free and responsible for their actions.

# US Attorney Carmen Ortiz will Speak in Lawrence as Part of NECC White Fund Lecture Series

Carmen Ortiz, the first Hispanic and the first woman to represent Massachusetts as United States (U.S.) Attorney, will be the featured speaker at Northern Essex Community College's White Fund Lecture Series on Friday, February 17 from 8:45 to 10 a.m. at the Lawrence High School/Performing Arts Academy, 70-72 Parish Road, Lawrence. Free and open to the public, Ortiz's presentation is titled "A Morning with U.S. Attorney Carmen M. Ortiz: Top Priorities of a Federal Prosecutor."

Ortiz will talk about the role of the federal prosecutor as well as share her personal journey - with a special message for young people about making the right choices at an early age.

Her 45-minute presentation will be followed by a question and answer period moderated by Attorney Magdalena Suarez-Shannon, a member of the NECC criminal justice faculty.

Nominated by President Barack Obama, as the U. S. Attorney for the District of Massachusetts, Ortiz was confirmed by the U.S. Senate in November 2009

As the chief federal law enforcement officer in the state, she supervises the prosecution of all federal crimes and the litigation of all civil matters in which the federal government has an interest.

This past December, Ortiz was named "Bostonian of the Year" by the Boston Globe Magazine. Citing her successful prosecutions of Salvatore DiMasi, former speaker of the MassHouse, Diane Wilkerson,

former state senator, Chuck Turner, former Boston city councilor, and Tarek Mahenna of Sudbury, the Globe wrote "She has sent an unambiguous message to the Massachusetts political class to behave, ramped up prosecutions of white-collar crime, and built a new civil rights enforcement team. For all of these reasons, she is our Bostonian of the Year."

Prior to becoming U.S. Attorney, Ortiz was an assistant U.S. attorney in the Economic Crimes Unit of the U.S. Attorney's Office (Massachusetts), and also served as the grand jury supervisor. In addition to her federal service, Ortiz served as an assistant district attorney in Middlesex County, where she worked for eight years, overseeing the District Court and prosecuting homicides, sexual assaults, robberies and other felony cases.

A native of New York, Ortiz is a graduate of Adelphi University (B.B.A.) and George Washington University Law School (J.D.).

This event is free and open to the public. The White Fund's purpose is to have a free series of interactive presentations for Lawrence area adults, youth, and



children. The audience is encouraged to seek wisdom, cultural enrichment, and intellectual enhancement by attending and participating.



## Alerta al consumidor sobre leche no pasteurizada tras posible contaminación de brucella

El Departamento de Salud Pública de Massachusetts (DPH, por sus siglas en inglés) y el Departamento de Recursos Agrícolas de Massachusetts (DAR, por sus siglas en inglés) están llevando a cabo una investigación en la granja "Twin River", ubicada en el 1272 de Rannapo Road en Ashley Falls, MA porque existe la posibilidad de que la leche no pasteurizada de ese centro esté contaminada con la bacteria Brucella. La investigación responde a un presunto caso humano que habría tenido contacto con esta granja.

La presencia de Brucella en la leche que no ha sido pasteurizada representa un riesgo importante para la salud pública.

La Brucelosis es una infección bacteriana que puede causar una serie de síntomas. Los primeros síntomas se parecen a los de la gripe e incluyen fiebre, sudores, dolor de cabeza, inflamación de los ganglios linfáticos, dolor de espalda y debilitamiento físico. Es posible que se experimenten asimismo infecciones de carácter grave en el sistema nervioso, los huesos o el corazón.

La Brucelosis también puede ocasionar síntomas a largo plazo o crónicos que incluyen fiebre persistente, dolor de articulaciones y fatiga. Los niños tienen una mayor probabilidad de experimentar síntomas menos severos de la enfermedad, aunque es posible que los adultos se enfermen de gravedad.

La leche no pasteurizada de la granja

"Twin River" se vende en envases de plástico y está disponible en botellas tanto de medio como de un galón. Este aviso no afecta a la leche pasteurizada, la cual es segura y apta para el consumo.

DPH aconseja a los consumidores que hayan adquirido leche cruda de esta granja que la desechen. Aquellas personas que crean haberse enfermado tras consumir leche sin pasteurizar deben solicitar atención médica de manera inmediata y deben, asimismo, notificar a su junta local de salud o al Programa de Protección Alimentaria de DPH al 617-983-6712.

## Consumer alert for raw milk due to the possibility of brucella contamination

The Massachusetts Department of Public Health (MDPH) and Massachusetts Department of Agricultural Resources (DAR) are conducting an investigation at Twin River Farms located at 1272 Rannapo Road, in Ashley Falls, MA due to the possibility of raw milk being contaminated with Brucella. This investigation is being conducted in response to a reported suspect human case who had contact with this farm.

The presence of Brucella in raw milk represents a significant danger to public health.

Brucellosis is a bacterial infection that can cause a range of symptoms. Early symptoms are similar to the flu and may include fever, sweats, headaches, swollen lymph nodes, back pains, and physical weakness. Severe infections of the central nervous systems, bone or heart may occur.

Brucellosis can also cause long-lasting or chronic symptoms that include recurrent fevers, joint pain, and fatigue. Children are more likely to experience mild disease while adults may become more severely ill.

Raw milk from Twin Rivers Farm is sold in plastic containers, and is available in half gallon and gallon bottles. This product

is not sold in retail stores. This advisory does not apply to pasteurized milk, which is safe to consume.

MDPH is advising consumers who have purchased raw milk from this Farm to discard it. Persons who believe they have become ill from drinking raw milk should seek immediate medical attention, and should then notify their local board of health or the MDPH Food Protection Program at 617-983-6712 or the Epidemiology Program at 617-983-6800.

# Meehan Recognized for Outstanding Contributions

### Remembering Anna LoPizzo

This past Sunday, January 29, 2012 a group of local residents gathered at the corner of Union and Garden Streets to commemorate the one hundredth anniversary of the death of Anna LoPizzo.

Anna's death occurred when a shot was fired into a crowd of scuffling strikers and police. LoPizzo, 34, a bystander, was struck in the chest by the bullet and died. Strikers claimed the shot came from police

and police accused the strikers.

To this day the incident is a mystery (more information is available online at the Bread and Roses Centennial Exhibit).

Afterward guests were invited to go and see "Short pay! All out!" The Great Lawrence Strike of 1912 exhibit now open on the 6th floor of the Everett Mill, located at 15 Union Street, Lawrence, Massachusetts.

### Extractos de la presentación por el Senador Barry Finegold en Heritage State Park.

Este día marca la celebración de la Huelga de Pan y Rosas de 1912. A pesar de que ocurrió hace 100 años, las lecciones que aprendimos en ese entonces siguen siendo válidas hoy.

La huelga inspiró a las masas y el pueblo de Lawrence. La industrialización dio a luz a una nueva nación, una nueva forma de vida, y una nueva fuerza de trabajo.

La ciudad de Lawrence fue, y sigue siendo, una puerta de entrada para nuevos estadounidenses conocida como la Ciudad de Inmigrantes, Lawrence ha tenido un alto porcentaje de residentes extranjeros.

Durante la huelga, las diferencias culturales no fueron un obstáculo en la lucha por el respeto y la equidad. Se trataba de la unificación. Los líderes de los diferentes grupos promovían la participación en la huelga, se acercaron a las organizaciones comunitarias con recursos, dieron alivio y fundaron la solidaridad dentro de los vecindarios étnicos.

Los verdaderos héroes de esta huelga fueron las mujeres de la ciudad. Las asociaciones de mujeres del barrio se centraban más en la feminidad que en la identidad étnica.

El movimiento fue incluyente y

unificador. Las mujeres eran las fuerzas prolíficas en los piquetes. Día tras día, se fueron ellas quienes llevaron a cabo feroces manifestaciones.

Los trabajadores en huelga demostraron una gran lección: Aunque los grupos tradicionalmente sin poder, como las mujeres y los inmigrantes recientes podría prevalecer si trabajaban juntos.

La historia detrás de esta ciudad es la clave para su futuro. Hoy en día, los desafíos que confrontamos no son diferentes a los de la Huelga de Pan y Rosas. Podemos superar estos retos si nos unimos en contra de los desafíos y grandes cosas están sucediendo en la ciudad.

Cuando estamos unidos bajo un objetivo común, podemos hacer las cosas a cabo, nos basamos en los sueños de nuestros antepasados mediante la creación de cambio a través de la educación, la propiedad, el crecimiento sostenible y una adecuada representación.

La huelga nos ha enseñado que son más fuertes cuando nuestras todas las facciones están trabajando juntos.

Así es como podemos llevar esta ciudad hacia adelante.

### Excerpts of the presentation by Senator Barry Finegold at Heritage State Park

This day marks the celebration of The Bread and Roses Strike of 1912. Even though it happened 100 years ago, the lessons we learned back then still apply today.

The strike inspired the masses and the people of Lawrence. Industrialization gave birth to a new nation, a new way of life, and a new workforce.

The City of Lawrence was, and still is, a gateway for new Americans known as the Immigrant City, Lawrence has always had a high percentage of foreign-born residents.

During the strike, cultural differences were not a barrier in the battle for respect and equity. It was about unification. Leaders from different groups promoted participation in the strike, tapped the resources community organizations, administered relief and enforced solidarity within the ethnic neighborhoods.

The true heroes of this strike were the women of the city. Women's neighborhood associations were focused more on womanhood than ethnic identity.

The movement was inclusive and unifying. Women were prolific forces on the picket lines. Day after day, they led fierce demonstrations.

The striking workers had demonstrated a powerful lesson: even traditionally powerless groups such as women and recent immigrants could prevail if they worked together.

The history behind this city holds the key to its future. Today, the challenges we are meeting are not unlike those of the Bread and Roses Strike. We can overcome these challenges; if we unite against them, great things are happening in the city.

When we are unified under a common goal, we can get things accomplished; we are building on the dreams of our predecessors by creating change through education, ownership, sustainable growth and proper representation.

The strike taught us that we are at our strongest when all factions are working together.

That is how we can bring this city forward.

## Mayor announces crime is down again!

Mayor James J. Fiorentini announced that total crimes in the City of Haverhill are down a total of 11% for 2011 compared to 2010. Crime has continued to maintain its decline.

The percentage of decrease is between 32% and 40%. The largest decrease in crime was in burglaries, they dropped 40%. There were 319 fewer burglaries in 2011 compared to 2010.

The Mayor has always prioritized public safety and has never laid off a single police officer. Haverhill should be proud and celebrate this success!

Mayor Fiorentini stated: "Public safety continues to be a top priority of my administration. The decline for 2011 compared to 2010 is attributed to our police department and how they continue to do an excellent job keeping our city safe. Crime cycles go up and down depending on economic trends. We are hopeful that the crime rate will continue to go down. Our dedicated police department works hard to keep crime at a low level and we know Haverhill is moving in the right direction."

Police Chief Alan DeNaro stated: "We are pleased that the numbers are declining and we will work hard to keep them low."

## 1967 Social League Leaders

The Jeff's Tavern softball team was the league leaders in the late stages of summer and were preparing for the playoffs. The sponsor was Mort Donohue and Jeff's Tavern was located on So. Union St. and is now called the Lightship.

Dan's Café was across the street; Jennie's was down the street and is a pizza place these days. The Whippet Club also was a stone's throw away from these other bars. Each of these places at one time or another had sponsored a softball team and many of the city's best players came from this area.

The Luchessis owned Jennie's and brothers Vic and Nello ran the place. Brother Mac owned and operated a place at Salisbury beach and in Lowell. Jim Cahill was a popular bartender at Jennie's and worked for and lived in the town of Andover during the day.

Tending the wood at Jeff's was Frank Costello a former softball player himself. Dan's Café was owned and operated by Sam Abbott and Bobby Matthews and Sonny Hatfield tended the wood. The Whippet Club or Gilligan's had Billy Bateman, Joe Carroll and Billy Gilligan himself doing the serving.

Hayes Tavern also in the immediate area was a meeting place for politicians and city employees and to this day I think a hole in the floor is filled in with "hot patch" usually used on the roads to fill ruts in the spring. I don't think the city ever charged the owners for the job done by a city crew. Sonny Bonnano now owns the place.

Members of the Jeff's team were as follows: Rocky Quinn now passed away was an outfielder and a former LHS footballer. Chris DeCesare was one who could play any position and play it well, he's retired now and played many years of fast pitch and must be considered one of the best at the game. He's into golf and has been for many years and they tell me he's good at that game as well, he formerly owned Chris' Ace of Clubs and one of his teams he sponsored went to the Softball World Series in New Mexico.

Dick Krauss whose name must be brought up when all time great pitchers from Lawrence are mentioned, was a great athlete at Methuen High school and later starred in two sports at Boston University. While pitching in our league he worked and now is retired from Raytheon, he now lives in Florida.

I have not in my career as a softball manager seen anyone better prepared to pitch a game each time out.

Don Overka was another player who could play any position and better than most, his speed, hitting, bunting, and competitive attitude made him a guy opponents hated to play against. He also had a great brain for playing this game and while playing as a catcher he would be an asset to any pitcher, he also played for the great traveling team from Lowell The Monument Club.

Dennis McCarthy was an excellent third baseman and played for many years in the leagues of the city, he was equally adept at fielding bunts or line drives. His

brother Sean was a fine athlete and baseball coach at both LHS and Tewksbury High School as well as a fine catcher for the Turn Hall footballers. Dennis also left early for that big softball heaven in the sky, his sister Pat was a hostess at Mary Claire Kennedy's Cedar Crest. Her husband Joe was a regular at the Crest as well.

Dennis was one of the most popular players in the city and one great guy. John Lenihan was from So. Lawrence and played first base and was as good a left-handed hitter as there was around, you could pencil him in to be your cleanup hitter and forget it, he had a sweet swing and hit line drives to all fields and could crank a long ball to a different zip code area. He is retired from the New England Power Company these days.

John Kelleher was another great athlete that started his softball career with Dennis Mc Carthy with the upstart "Hadley Whiz Kids" a team of really young players that the recently passed Billy Ruffen coached, they almost upset all the favorites in the league. Kel was a great teammate and bad knees and all he never gave an inch, would have loved to see him perform with two good wheels in any sport, the injuries took away some of his playing days at LHS. He did however coach girls and boys basketball at his high school and later football. He could drop a bunt with the best of them and he

There is so much that I can say about the latest controversy of Isabel leaving her daughter as the new director of the Spanish Center she ran for a long time but the best I can do is to refer you to the daily articles by Keith Eddings of the Eagle-Tribune beginning January 26. He has done in 24 hours the research Greater Lawrence Community Action Council and its appointing team could not bother to do.

Read yourselves the press release we received on Tuesday afternoon on page 17. I didn't bother translating it because it contains many errors and I didn't want to be blamed for the inaccuracies. For example, it says twice at the beginning that she has been volunteering at the agency for 38 years and then further down it says it was 30. If she's 49 years old, that means she started working as a volunteer at 11. And, what about the 20 years she lived in Florida? Her home and children are still there because she doesn't have a home here as yet.

Among the comments on the Trib, someone posted four articles from the Sun Sentinel, a Florida newspaper that was an eye opener as to the activities and behavior of this family. If you want to do a search on People Search or Spokeo, you may have to use the names of Marisela, Maricela, Maritza, Marisa, Marisabel and the last names of Melendez and Range. She has used these names at different times.

At the Community Center, clients pay for services in cash. She will remain active at the Center helping her daughter, doing her radio show and running the taxpayer funded General Donovan school; yes, we pay for the electricity, heat, water and snow removal to make her look good.

In some people's mind, Isabel can do no wrong. My conversations with Christian Dame have been intense and he knows too well who she is and what she has done but chooses to ignore it. He refuses to release any information on Marisela's resume or salary because he claims that this is a private agency. Not so. They received state and federal funding which is the reason for the overhaul they went through last year. We, the taxpayers who support them, demand more transparency.

### The world doesn't revolve around Payano

The new Receiver/School Superintendent Jeffrey Riley is planning to set up a meeting with the members of the school committee but he put it on the back burner until Pavel Payano returns from India.

Is Payano so vital that things come to a halt in his absence?

Mayor William Lantigua had appointed three members of the school committee to a stakeholder board at each of the Level 5 schools, namely Francisco Zurillo to the Leonard School, James Blatchford to the International High School and Pavel to the Business and Management High School. These boards have to come up with a turnaround plan in the span of 45 days in order to make changes at those three schools for the next year. The Leonard and International High School are working on their plans but things cannot progress while Payano is away.

He had said that he didn't think necessary to continue meeting as a body twice a month, something totally unreasonable because now we need more communication between the administration and the community than ever before. Then, this trip to India without having the courtesy of letting the rest of the committee members know that he would be traveling. Total arrogance!

If Pavel Payano doesn't have the time to dedicate to the school committee or found that this turned out to be a real commitment, not just a show and became bored with it, he should allow for someone else to be appointed to replace him.

Mayor Lantigua, please, at least replace him in that special committee at the Business and Management High School for someone willing to work.

### Sandy vs Fielding

Last week I mentioned that Rick Fielding is out of control – what an understatement!

District A Councilor Sandy Almonte has sent a letter to Mayor Lantigua and the rest of the council members addressing the insults of which she was victim at the Licensing Board meeting of January 11. She wrote, "Mr. Fielding stated loudly, in the live microphone and while on camera

words to the effect of, 'Isn't this the woman who was in a cage, having balls thrown at her so she could drop into a tank of water?' The audacity of some people!"

A few days ago, it was posted on the city's website that they will be going again on February 23rd and the public has a deadline of February 9th to purchase the 97 tickets available. The interesting thing is that at the top of the page, a sign indicates they are "Sold Out."

It is a wonder how they could be sold out so quickly without being publicized to the general public. Through the years we have been requesting the Recreation Department to send us notices or announcements for publication free of charge and have never received anything from them. I guess it is one of those departments that operate in secret.

### Also not responding...

Inspectional Services is another department that doesn't respond to requests for answers. For example, I have been asking Commissioner Peter Blanchette about Oneida Aquino's political signs still out on the streets (trash barrels) and he has not called me back. Preferential treatment?

When I mentioned the trash barrels last year, Councilor Aquino went on the radio defensively. You would have thought that I was wrong! The issue is that those signs painted on them are political material and they were to be removed 30 days after the November 8 elections. I also questioned how they were acquired because they were not listed on her previous financial report.

After her long discourse on Microfono Abierto with Carmen Chalas on WCEC 1490 AM, she assured everyone that she has a canceled check paying for them (she insists that they cost her \$10 each.) She went on to explain that she saves the income from the city council in a separate account for expenses connected with her activities in the council. That sounds illegal to me! ## Commit to quit for New Year's

Each year the decision to quit smoking remains one of the most popular New Year's resolutions. In a recent survey by the Massachusetts Department of Public Health, 77 percent of adult smokers in Massachusetts say they want to quit and the New Year's holiday provides many of them with the fresh start needed to quit for good. Quitting smoking will be hard, but there are ways to make it easier. If you've made the decision to quit smoking in 2012, try these five steps to improve your chances of quitting for good:

1. Make a quit plan. Decide on a specific date when you will quit. If you've tried to quit before, use your past experience to think about what helped you the first time and what you'll do differently this time. Visit [makesmokinghistory.org](http://makesmokinghistory.org) to learn more about creating a quit plan.

2. Know your triggers. Triggers are certain times, places, people, or feelings that make you want to smoke. Common triggers include: stress, drinking alcohol, driving, and after eating a meal. Plan ahead to deal with your triggers.

3. Get support from family and friends. Think about who you want to tell about your plans to quit smoking. Ask them for positive support and encouragement. Think about how they can help, whether it's going for a walk, calling you, or if you'd rather they didn't make a big deal of it, tell them that too.

4. Get help from a trained professional. Using counseling support or cessation medicines can make you twice as likely to quit for good. Ask your insurance provider what types of benefits you are eligible for or ask your pharmacist about over-the-counter stop-smoking medicines. You can also get free support through the MA Smokers' Helpline at 1-800-QUIT-NOW.

5. Don't give up. If you slip and smoke a cigarette after your quit date, it doesn't mean you have failed. Many smokers have to try several times before they quit for good. Remind yourself of the reasons why you want to quit and keep moving forward with your plan.

# Holy Family physicians travel to Vietnam, Dominican Republic to care for local villagers and train local clinicians



Urologists Liam Hurley, MD and Steven Previte, MD and Audiologist Dierdre Anderson, Au.D., donate time and expertise.

For many physicians at Holy Family Hospital, their commitment to community health care extends beyond the Merrimack Valley and southern New Hampshire into small villages of countries where health resources and access to care are extremely limited. They donate their time and service to care for patients and share their medical expertise with local clinicians. Three well-respected physicians recently made their journeys overseas:

Urologists Liam Hurley, MD and Steven Previte, MD Travel to Hue, Vietnam.

Seven-day mission trip with the non-profit group, IVUmed, an organization committed to making quality urological care available to people worldwide. In fulfilling their mission, IVUmed provides medical and surgical education to physicians and nurses and treatment to thousands of suffering children and adults.

For their mission, Dr.'s Hurley and Previte traveled to Vietnam's largest urology hospital, a 300-bed facility that serves adults and children from throughout the Hue region. The doctors performed approximately 20 surgeries, providing treatment for villagers with cancer, kidney stones and other urological conditions. They also provided medical training and critical decision support to the hospital's medical team.

In Hue, Vietnam, the average life expectancy is late 50's to early 60's. "Most people have such limited access to health care as a result of where they live and their socioeconomic status," explained Dr. Previte. "They don't see physicians for decades and when they finally seek treatment, the disease is so far advanced that there is little hope for a cure."

This was Dr. Hurley and Dr. Previte's first mission. "It really takes you back to see how many people are afflicted with

health conditions that are treatable and even curable," said Dr. Hurley. "The conditions in which the physicians treat patients – the low quality equipment and poor working environment – make it immensely challenging to provide timely treatment. Yet, although their technology and even technique are significantly behind what we are able to do using minimally invasive procedures, it is remarkable how quickly and precisely they perform very complex procedures."

The doctors also explained that the people of Hue are very proud and don't often ask for help. "Towards the end of the trip, a resident was clearly struggling on a case and invited us to help," said Dr. Hurley. "There's this threshold where you earn trust and the right to be invited in to help. This was a pivotal moment. Now, months after returning, we continue to communicate with him by email."

"If we are ever invited back it would be a privilege to go," said Dr. Previte. "Everyone wants to be invited."

Audiologist Dr. Anderson returns to a School in San Andreas, Dominican Republic

Seven-day mission trip with the non-profit group, Partners for a Greater Voice, an organization dedicated to advancing the deaf or hard of hearing child's spoken language and education achievement in developing countries.

Dr. Anderson recently returned to a San Andreas school where 50 deaf students ranging in age from three to 20 attend. She had the opportunity to examine students she had treated and fit with a single hearing aid during her last mission and provided many of them with a second hearing aid donated by Siemens Hearing Instruments. New students were also treated and provided hearing aids.

"For these children, who are affected by a severe to profound hearing loss, use of a hearing aid allows them to learn and recognize sounds. The extent of their condition will never allow for speech clarity but the ability to decipher sound puts them in touch with the world," said Dr. Anderson. "Having this new and expanded awareness of their surroundings also creates a safer environment for these children."

While in San Andreas, Dr. Anderson also provided an aspiring Dominican audiologist with additional training so that

he can continue to maintain the hearing technology for these children. "Even though I feel like I can't do much in one week, it was extremely comforting to know that there is an audiologist there to help these children between missions," expressed Dr. Anderson. "I've maintained contact with him over Facebook and we continue to work together for the benefit of these children." Dr. Anderson, audiologists who participated in this program and Partners for a Greater Voice have successfully secured funding and permission for this aspiring audiologist to join them at a conference in Boston this spring.

"It's truly inspiring to see how happy these children are despite their disability and the poverty conditions they live in," explained Dr. Anderson. "Seeing the smiles on their faces when they could hear their surroundings was just amazing. I know I've changed their lives for the better."

# La MSPCA en la Granja Nevins auspicia el Día de la Esterilización

## La clínica de bajo costo se centra en los gatos machos

La MSPCA en la Granja Nevins anuncia su primera campaña de esterilización de gatos por \$10 en reconocimiento del Día de la Esterilización, un evento nacional para animar a los propietarios de mascotas para esterilizar o castrar a sus animales y reducir las camadas no deseadas. Durante el mes de febrero, los dueños de gatos de bajos ingresos pueden participar en el programa sin cita para que su gato sea castrado y vacunado por sólo \$10. Financiado por el apoyo de los donantes, el esfuerzo tiene la función de controlar el tema de la sobrepoblación felina.

Mike Keiley, Director del Centro de Adopción de la Familia Noble del MSPCA en la Granja Nevins, tiene la esperanza de que el nuevo enfoque sobre la superpoblación de gatos en esta región tenga como resultado que menos gatos son entregados a los refugios de la región.

Mientras que muchos dueños de gatos ver el mérito en la castración de una gata para evitar una camada no deseada, al igual que muchos pueden pasar por alto el papel del gato en la producción de crías, y pueden optar por una cirugía de esterilización para ahorrar dinero. "Un gato macho puede fecundar a cualquier número de hembras si se les permite vagar por la libre, aunque sea una vez al mes, produciendo docenas de crías cada año. Muchos de estos gatitos pueden terminar en un refugio de animales, o peor aún, ser dejados a su suerte en las calles", dijo Keiley. Keiley anticipa que la campaña de castración de gatos por 10 dólares se traducirá en cerca de 400 cirugías, y potencialmente salvar la vida de miles de animales.

Este es el quinto año que la MSPCA en la Granja Nevins ha participado en el Día de la Esterilización. Ese día, veterinarios y su personal, los profesionales de bienestar de los animales, los propietarios de empresas y ciudadanos se unen en todo el país para proveer servicios de esterilización o castración y para promover la esterilización y castración como un componente esencial de un buen cuidado médico del animal doméstico, así como una medida eficaz y humana de disminuir la eutanasia de los animales abandonados en refugios. El año pasado, la clínica ofreció un maratón de 24 horas en la MSPCA en la Granja Nevins prestando servicios a 213 animales.

Los residentes del área que deseen castrar a sus gatos machos pueden dejar a su gato en el centro de adopción en el MSPCA

en la Granja Nevins entre las 9 a.m. y las 11 a.m. entre martes y viernes, durante el mes de febrero, a partir del 1 de febrero. Los gatos pueden ser recogidos el mismo día, entre las 4 pm y las 5pm. El costo de la cirugía de \$10 incluye la cirugía castración, vacunación contra la rabia, la vacunación contra el moquillo, la prevención de pulgas, tratamiento de ácaros de los oídos si es necesario, y una identificación con microchip.

Para aquellos que necesitan ayuda financiera para esterilizaciones gatas o cirugía de esterilización o castración para cachorros de Pit Bull, habrá un número limitado disponibles el sábado, 4 de febrero y el domingo, 5 de febrero, gracias a los esfuerzos voluntarios de Médicos Veterinarios y técnicos que se donando sus servicios.

Las citas deben hacerse con anticipación, y se llenarán según vayan llegando. Las personas deben visitar el Centro de Adopción en la Granja Nevins para llenar una solicitud para uno de los horarios disponibles para la cirugía. Keiley también refiere al público a una serie de otros programas locales de esterilización y castración, incluyendo el programa de SNAP del MSPCA-Angell, para aquellos que puede que no sean elegibles para la próxima clínica.


#### Shelley: Brown Tabby Female

## MSPCA at Nevins Farm Hosts SPAY DAY USA

### Low Cost Clinic Focuses on Male Cats

The MSPCA at Nevins Farm is announcing its first-ever \$10 Cat Neuter campaign in recognition of Spay Day USA, a national event aimed at encouraging pet owners to spay or neuter their animals and reduce unwanted litters. During the month of February, low-income cat owners can take part in the no-appointment program to have their male cat neutered and vaccinated for only \$10. Funded by donor support, the effort targets a male cat's role in the feline overpopulation issue.

Mike Keiley, Director of the MSPCA's Noble Family Adoption Center at Nevins Farm, is hoping that the novel approach to the region's cat overpopulation issue will ultimately result in fewer cats being surrendered to the region's shelters.

While many cat owners see the merit in spaying a female cat to prevent an unwanted litter, just as many may overlook the male cat's role in producing offspring, and may opt out of a neuter surgery to save money. "A male cat can impregnate any number of females if allowed to roam outdoors even once a month, producing dozens of offspring each year. Many of these kittens can end up in an animal shelter, or worse, be left to fend for themselves on the streets," said Keiley. Keiley is anticipating that the \$10 Cat Neuter Campaign will result in close to 400 surgeries, and potentially saving thousands of animals' lives.

This is the 5th year that the MSPCA at Nevins Farm has participated in Spay Day USA. During Spay Day USA, veterinarians and their staff, animal welfare professionals, business owners, and citizens join forces nationwide to provide spay/neuter services and to promote spay/neuter as an essential component of good pet health care, as well as an effective and humane means of decreasing the euthanasia of homeless animals in shelters. Last year's 24 hour marathon clinic held at the MSPCA at Nevins Farm provided services for 213 animals.

Area residents wishing to neuter their male cats can drop off their cat at the adoption center at the MSPCA at Nevins Farm between 9am - 11am any Tuesday through Friday during February, beginning February 1st. Cats may be picked up the same day, between 4pm-5pm. The \$10 surgery fee includes neuter surgery, rabies vaccination, distemper vaccination, flea prevention, ear mite treatment if necessary, and a microchip ID.

For those who need financial assistance with female cat spays or spay-neuter surgeries for Pit Bull puppies, a limited number of surgery slots will be available

on Saturday February 4th and Sunday February 5th, thanks to the volunteer efforts of are veterinarians and technicians who are donating their services.

Appointments must be made in advance, and will be filled on a first-come, first-served basis. Individuals should visit the Adoption Center at Nevins Farm to fill out an application for one of the available surgery time slots. Keiley also refers the public to a number of other local spay-neuter programs, including the MSPCA-Angell's SNAP program, for those who may not be eligible for the upcoming clinic.

One of three MSPCA Animal Care and Adoption Centers statewide, the MSPCA at Nevins Farm in Methuen cared for more than 7,000 animals last year. 


