## **Local Business Leader Receives Honorary Degree**

In presenting the honor, Glenn said it is "based on your successful business career, the many contributions you have made to medical science, and your continued support of Northern Essex Community College.'

ActivMed is a clinical research trial company, with locations in Methuen, Lawrence, and Beverly, Massachusetts as well as Portsmouth, New Hampshire. The company is in the top 2% of women owned companies within the US and locally employs 36 people, working closely with local physicians and hospitals.

The company manages national and international research trials that are helping to discover treatments for diseases like Alzheimer's, diabetes, and heart disease.

Stubbs earned a certificate in medical transcribing from Northern Essex in 1984, and she went on to earn a certificate in medical assisting. After working in the research field, she and a partner founded ActivMed Practices & Research, Inc. in 1994.



#### La verdad sobre GLCAC

unos días, manifestación frente a las oficinas del Greater Lawrence Community Action Council que protestaban por lo que se ha dicho sobre la eliminación de programas destinados a los pobres en esta comunidad. Alrededor de 25 personas participaron en contra de lo que se ha dicho en la radio. Puede contarlos en los muchos vídeos que se encuentran en Facebook.

Para aquellos de ustedes que no saben, permítanme darles un poco de historia de cómo el Greater Lawrence Community Action Council, Inc. comenzó. Fue bajo la administración del Presidente Lyndon B. Johnson en 1965 y en enero de 1966 estableció el Greater Lawrence Community Action Council como un medio para combatir la guerra contra la pobreza. Entonces la comunidad latina era la verdadera minoría.

Su misión es fomentar y promover el mejoramiento de la vida comunitaria en Lawrence v sus alrededores, con especial énfasis en la iniciación de programas en educación, servicios sociales, cuidado de niños, salud, vivienda, empleo juvenil y áreas relacionadas. No sólo para los pobres de habla hispana, sino para todos los pobres de las comunidades establecidas en el área de Lawrence. Cuando se estableció la oficina hispana, muy pocos latinos vivían aquí y era apropiado tener una oficina para servirles. La ex directora afirmó que trabajó allí durante 39 años. Sin embargo, cuando se le preguntó por la radio cómo se establece la junta directiva, ella no lo sabía.

Las regulaciones federales requieren que las Agencias de Acción Comunitaria tengan una junta tripartita. Un tercio de los miembros son funcionarios electos o sus representantes; un tercio son representantes del sector privado y las empresas; Y un tercio de representantes de residentes de bajos ingresos, principalmente clientes de GLCAC. Es realmente triste que en 39 años ella nunca se molestara en aprender a colocar a la gente en esa junta.

directora ejecutiva de GLCAC, me enteré de que los empleados y programas alojados anteriormente en el programa hispano han sido trasladados dentro de la agencia. Se ha ampliado el programa de estabilización de viviendas; un programa de ESL y un programa de cuidado de niños han sido creados. Hay 825 niños siendo atendidos en los programas Head Start y Child Care. Y el trabajador que manejó la inmigración a tiempo parcial mientras hacía otro trabajo para el Departamento de Servicios Comunitarios, ahora está trabajando a tiempo completo haciendo el trabajo de inmigración y se le ha dado un asistente para cubrir el alto volumen de trabajo.

El Programa de Asistencia de Combustible sigue siendo el mismo porque es un programa federal y nada ha sido

Durante el 2015, la agencia atendió a 29,000 clientes y en 2016 aumentó por 2,000 a 31,000 clientes. Se entiende que Lawrence siendo mayoritariamente latino y la mayoría de los empleados de GLCAC siendo latinos, ya no se necesita una oficina hispana. De hecho, cuando las familias latinas necesitan servicios, simplemente van a ese departamento porque el 80% de los empleados son hispanohablantes en toda la agencia.



## **Graduation at Notre Dame Cristo Rey High School**

On June 1, the underclassmen of Notre Dame Cristo Rey High School were awarded over \$180,000 in scholarships to help offset the cost of the high school's Catholic, college preparatory tuition. These scholarships, ranging from \$500 for one year to the full family portion of tuition over four years (\$3,200 each year), have been gifted to the students from donors who are passionate about NDCR's mission to provide the opportunity for every student to graduate high school and pursue a college degree.

Due to the support of these scholarships and \$500,000 in tuition assistance given to families each year, students do not need to worry about the cost of tuition, but rather they can stay focused on their goal of a college education.

Students will not know they have received these scholarships until their names are called at the ceremony - sponsors will also be in attendance to meet the students.

## L'Italien obtiene fondos para estudiantes con dislexia, Alzheimer, niños con necesidades médicas y más en el presupuesto del Senado

El Senado del Estado de Massachusetts aprobó el presupuesto del estado, que incluyó varias enmiendas patrocinadas por la Senadora del 2do Condado de Essex y Middlesex Barbara L'Italien, D-Andover.



## L'Italien secures funding for students with Dyslexia, Alzheimer's Awareness, medically needy children, and more in **Senate Budget**

The Massachusetts State Senate today passed the state budget, which included several amendments sponsored by 2nd Essex and Middlesex Senator Barbara L'Italien, D-Andover.

After three long days of debating budget amendments, the upper legislative chamber settled on a document to pass on to conference committee with the House. Among those amendments adopted into the budget were Amendment 199 – Improving Literacy Programs, Amendment 505 -Alzheimer's Public Awareness, and 513 -Children with Complex Medical Needs II, all sponsored by State Senator L'Italien.

Senator L'Italien also secured funding in the Senate budget for several local non-profits and programs in Lawrence: \$15,000 for the Lawrence International Book Festival, \$50,000 for the Lawrence Family Development and Education Fund, \$50,000 for the Lawrence Partnership, \$30,000 for EforAll/EParaTodos, \$50,000 for Arlington Community Trabajando, and \$15,000 for Beyond Soccer.

"I'm proud of the amendments I passed and the taxpayer money I was able to return to the community of Lawrence," said L'Italien. "I'm thankful to my Senate colleagues for supporting my efforts to allocate much-needed funding for programs that do so much good in this community, from economic development to youth engagement to entrepreneurship opportunities. When we invest in gateway cities such as Lawrence, we get a great return on investment."

Amendment 199 ensures that literacy and early literacy programs in public schools meet the need of children who have dyslexia or are at-risk for dyslexia.

"Dyslexia is one of the most common learning disorders, and so I am glad to help ensure that children with dyslexia get the services they need at school, starting at a young age," said L'Italien.

Amendment 505 increases funding for the statewide Alzheimer's Disease public awareness and education campaign. As recommended by the CDC, the campaign is designed to educate the public about early warning signs of the disease, access to patient services, the importance of early diagnosis, and the importance of family caregiver education and support.

"Dyslexia is one of the most common learning disorders, and so I am glad to help ensure that children with dyslexia get the services they need at school, starting at a young age," said L'Italien.

Amendment 513 enables Commonwealth to examine the costs associated with providing care for children whose comprehensive needs require constant 24-hour care. The study will be completed by April 2018 and will help the commonwealth in determining how we can best care for these children at the lowest cost to MassHealth.

"Many families of the most medically needy children in Massachusetts, who require constant care, aren't able to fill their hours of approved nursing," said L'Italien. "Hopefully, we will be able to fill these hours, and allow these highly-skilled nurses to continue their profession, with adequate pay."



## **MassDOT Advisory: I-495 Bridge Work In Haverhill**

#### Repairs June through September will mean overnight lane closures on I-495

Massachusetts Department of Transportation (MassDOT) today announced that it will conduct repairs to the I-495 bridge over the Merrimack River in Haverhill which will continue into the fall and require overnight lane closures on I-495 in the area of the bridge which carries the highway over the Merrimack River near Exit 49 (Routes 110/113/River Street). Scheduled construction activities will still allow for travel on all lanes of I-495 in this area during high volume daytime hours.

"The Massachusetts Department of Transportation has scheduled the work in a way designed to have the least impact on vehicle travel as possible," said Acting Highway Administrator Jonathan Gulliver. "A full bridge replacement project will be undertaken in the future, but until then, these interim repairs in the overnight hours will ensure that the necessary maintenance we are aware of now is addressed as soon as possible until the major work can begin."

"I am happy to work with MassDOT, which continues to consider and respond to the concerns of our commuters by addressing these much needed repairs to the I-495 bridge," said State Representative Brian S. Dempsey. "These repairs will provide improvements that will ensure a safer and smother ride for all drivers."

The full scope of work from now until the end of September will consist of bridge deck and joint repairs along with structural steel repairs, followed by milling the existing wearing surface and installing new wearing surface using a waterproofing bituminous concrete pavement. In order allow crews and contractors to safely and effectively conduct these repair operations, overnight lane closures on I-495 in the area of the bridges will be necessary throughout the project. More information on traffic impacts will be provided as it becomes

"The bridge over I-495 has been a problem and a safety concern for our residents over the past year," said Haverhill Mayor James J. Fiorentini. "I met with Representative Dempsey and officials from MassDOT and they have committed to start working on the bridge immediately to prevent any further safety issues and work towards a permanent replacement in the

This \$2.9 Million repair project is being funded by a combination of federal and state money and is being completed as an interim, early action measure to improve the bridge condition in advance of a full bridge replacement project. That larger project is under development and is expected to be procured as a Design/Build contract which is anticipated to begin in 2018.

MassDOT encourages drivers to seek alternate routes, if possible, to avoid delays, during the overnight work at the I-495 bridge. Drivers that must travel through the affected area should expect delays, reduce speed and use caution while traveling through the work zone.





## The truth about GLCAC

A few days ago, there was a demonstration in front of the Greater Lawrence Community Action Council offices protesting what has been said about eliminating programs destined to the poor in this community. About 25 people participated contrary to what has been said on the radio. You may count them on the many videos found on Facebook.

For those of you that don't know, let me give you a little history of how the Greater Lawrence Community Action Council, Inc. started. It was under the administration of President Lyndon B. Johnson in 1965 and in Jan 1966 the Greater Lawrence Community Action Council was established as a means of fighting the war on poverty. Then the Latino community was the real minority.

Their mission is to encourage and promote the improvement of community life in Greater Lawrence with special emphasis on, but not limited to, the initiation of programs in education, social services, child care, health, housing, youth employment and related fields. Not for the Spanish-speaking poor only, but for all the poor in the communities that represent Greater Lawrence. When the Spanish office was established very few Latinos lived here and it was fitting to have an office to serve them. The former director claimed that she worked there for 39 years. However, when asked on the radio how the board is assembled, she didn't know.

Federal regulations require that Community Action Agencies have a tripartite board. One third of the members being elected officials or their representatives; one third being representatives of the private sector/business; and one third being representatives of low-income residents, mainly clients of GLCAC. Is really sad that in 39 years she never bothered to learn and place people on this board.

Upon contacting Evelyn Friedman, executive director of GLCAC, I found out that the employees and programs previously housed within the Spanish program have been moved inside the agency. The housing stabilization program has been expanded; an ESL program and a child care program have been created. There are 825 children being served in the Head Start and child care programs. And the worker who handled immigration on a part-time basis while doing other work for the Community Services Department, is now working full-time doing immigration work and he has been given an assistant to cover the high volume of work.

The Fuel Assistance Program remains the same because that is a federal program and nothing has been eliminated.

During 2015, the agency served 29,000 clients and in 2016 it went up by 2,000 to 31,000 clients. We understand that Lawrence being mostly Latino and most of the employees of GLCAC being Latinos, we no longer need a Spanish Office. In fact, when our Latino families need services, they simply go to that department because 80% of the employees are Spanish-speakers throughout the agency.

Some of the complaints are that Ms. Friedman doesn't live in Lawrence, but in Boston. I would like to see a survey of directors of local social services agencies to find out how many of them live here. Be real, people! That's not a job requirement.




