El huracán María azotó a Puerto Rico el 20 de septiembre, menos de dos semanas después del impacto del Huracán Irma. Muchos de los tres millones de habitantes del territorio de los Estados Unidos aún carecen de fuentes confiables de energía, refugio, agua potable, alimentos y atención médica. La comunicación y el transporte están también severamente limitados.

"No creo que podamos comprender plenamente la magnitud de la devastación en Puerto Rico, pero tenemos en nuestro poder como ciudad y sistema escolar hacer que sea un poco más fácil para cualquier familia que llegue a Lawrence", dijo el Superintendente de LPS Jeffrey C. Lawrence Public Schools prepared to welcome new arrivals from **Puerto Rico**

With a pair of devastating recent hurricanes forcing many Puerto Ricans to evacuate to the continental U.S., the Lawrence Public Schools would like to assure local affected families that the district is prepared for all new arrivals and encourage them to contact its Family Resource Center as soon as they are able.

The FRC is located at 60 Island Street and can be reached by phone at 978-975-5900. Families in this circumstance will be given immediate school assignment, as well as school supplies and help connecting with other city support agencies.

"It's important in this time of need that we do all we can locally to give our fellow citizens a soft place to land," said Mayor Daniel Rivera. "It's not a question of if they come, just when. Given all that they have been through, the Superintendent and I want to ensure the kids have a smooth transition."

Hurricane Maria slammed into Puerto Rico on Sept. 20, less than two weeks after the impact of Hurricane Irma. Many of the U.S. territory's 3-plus million residents still lack reliable sources of power, shelter, drinking water, food and medical care. Communication and transportation are also severely limited.

"I don't think we can comprehend the extent of the devastation in Puerto Rico, but we have it in our power as a city and school system to make it a little bit easier for any families arriving in Lawrence," said LPS Superintendent Jeffrey C. Riley. "Getting their children quickly settled in school is one less thing they'll have to worry about."





To mention just a few examples of


- Some students used their class writing time to pen notes of encouragement to hurricane victims.

"They said, 'Welcome to the club,' and I thought I was in heaven," recalled De La Cruz, now a resident of Methuen and a principal at DLC Law Group in Lawrence. "Whenever you walked in, there would be a big smile and a hug. I met my closest friends there. I was raised there. It changed my life.'

To give back to the club which taught him so many life and business skills, De La Cruz is leading a team from the Lawrence Bar Association in the fourth annual BGCL Take Action Walkathon on Sunday, Oct. 15 from 9 a.m. to 12 p.m. The two-mile walk along the Merrimack River will begin and end at the club located at 136 Water St. in Lawrence, with music, face-painting, games and other family activities.

The event has raised nearly \$60,000 since its inception. Proceeds support more than 4,400 youth members who depend on the club for supper each night, homework help, fitness and nutrition programs, college and career planning, and lasting personal relationships with caring volunteers and staff members.

Prior to joining the club, De La Cruz recalls often being alone at the Hancock Housing Projects in Lawrence while his single mother worked two and sometimes three jobs to provide for her two sons. "Going to the club helped me feel sheltered, wanted and protected, like I was part of a bigger family that was genuinely looking out for me," he said. "It felt like home."

De La Cruz participated in reading and other academic enrichment programs, leadership clubs and community service at BGCL, but the activity he loved most was basketball. "I played day in, day out," he noted, "but I learned so much more than basketball: discipline, dedication, leadership, teamwork, finishing what you start and humility. I can't put into words the impact those qualities have had on my entire life."

But Marie's interests and concerns were not limited to her district. Marie cared about every district in Lawrence.

Marie was an outspoken and effective city councilor who was not hesitant to go against the tide. Marie was a generous person who performed many acts of kindness. She chartered a bus for a day trip to Foxwoods Casino. Everyone had a wonderful time and enjoyed a delicious buffet meal, interesting conversation and the scenery. We both took many photographs.

Marie was a St. Mary High School girl, but it made no difference to her if a girl was a Lawrence High School girl. Marie was an excellent golfer, and her scores were always above par. But to her, everyone was on an equal par. Marie was the first "Lady Agent" at Met Life Insurance, where she was employed for forty years. However, she never let her employment longevity define her. Tsongas' 11th Annual River Day in Andover, Haverhill

Events promote key role Rivers play in local economy, culture and environment

Congresswoman Niki Tsongas hosted her Eleventh Annual River Day Saturday, September 23, in celebration of the rivers that connect the Third Congressional

The day started at the end of Dale Street in Andover, where Congresswoman Tsongas met with young people from the Groundwork Lawrence Green Team and the Shawsheen River Junior Rangers, two community youth organizations focused on river clean-up and conservation. The Congresswoman also presented them with special Congressional recognition awards.

The second stop was at the Haverhill River Ruckus, where the Congresswoman met with members of Team Haverhill to discuss the innovative ways the city has utilized the Merrimack River for economic development.

The third stop was at the Bill Ashe Visitor Facility in Devens, where the Congresswoman participated in a canoe paddle on the Nashua River and met with volunteers dedicated to protecting this waterway. Many of these volunteers have been engaged in a year-long effort to clean the river of invasive species. The Congresswoman also was joined by Carolyn Choate, a breast cancer survivor who undertook a 300-mile kayaking trip this summer from New Hampshire to Baltimore, Maryland to raise money for cancer research.

Congresswoman Tsongas said: "Our rivers have served us well for centuries, playing an important role throughout our region's history. They powered the

clean drinking water, created tremendous recreational and economic opportunities, and brought natural beauty to our daily life. I host River Day each year because it highlights this great contribution, as well as the extraordinary efforts of local organizations and individuals who have dedicated themselves to preserving our natural treasures. We all share a tremendous responsibility to sustain and preserve the integrity of these resources for future generations. Through commitment, creativity and collaboration, we can ensure the health of our rivers keeps flowing in a positive direction."

Over the past eleven years, River Day has made stops in more than a dozen communities across the district, traversing each of the main rivers that form the region's important network of waterways. Congresswoman Tsongas has met with hundreds of environmentalists, business owners, students, volunteer organizations, local officials and constituents since she began hosting the event in 2007, to discuss how we can collaboratively protect and enhance these waterways for future

The Congresswoman has been a strong advocate for the region's waterways since being elected. She is a senior member of the House Natural Resources Committee and previously served as the top Democrat on the Natural Resources Federal Lands Subcommittee, which oversees public lands, such as national parks, wildlife refuges and more. In 2015, the Congresswoman led the mills of the industrial revolution, have effort to reauthorize one of our nation's

the Land and Water Conservation Fund (LWCF). That year, she also hosted then-Secretary of the Interior Sally Jewell at River Day.

In June, 2014 the House of Representatives passed a bill authored by The Nashua River Wild and Scenic River the second year of the three year study.





City's Civil Engineer

Not too long after Dan Rivera became mayor, he fired the Assistant City Engineer Andrew Wall because he had not been able to pass the examination for his state civil engineer license.

Mr. Wall had worked for the city for 17 years, covered by the City Engineer Santo Nicolosi's license which was a legal practice while he tried to get his own. Mr. Nicolosi retired, Mr. Wall was fired and the city was left without a functional civil engineer.

Then, the mayor decided to appoint his office clerk Theodoro Rosario, an agronomist with no knowledge of the city's intimate details as Mr. Wall acquired through the years.

Last February, a qualified civil engineer was hired, Milagros Puello, although there was a glitch on the night that she was confirmed by the city council. That night, it was learned that she did not have a license, either. Councilor Jeovanny Rodriguez was very convincing explaining that it was a matter of presenting her New Hampshire license to the Massachusetts authorities, in order to get one.

She was approved with a salary of \$80,000 and a \$15,000 a year stipend to compensate the previous employer who committed to work for a certain period of

En general, el IRS ahora está proporcionando alivio a individuos y negocios en cualquier parte de la Florida, Georgia, Puerto Rico y las Islas Vírgenes de los EE. UU., así como partes de Texas.


Youth Writing Workshop
