Editorial

El Poder del Pueblo

Esta semana que pasó los medios de comunicaciones estuvieron saturados con algo feo que necesitaba ser dicho. No, no era que los negros tienen pelo malo sino que reírse de la gente hiere.

Don Imus, quien por más de 30 años se ha ganado la vida riéndose de toda clase de gente y de ser vulgar, llamó a un equipo de baloncesto femenino "prostitutas de pelo malo" y fue el fin de su carrera en radio y televisión.

Quizá el tratamiento que le impusieron a Don Imus fue severo o no lo suficiente, eso no tiene relevancia. Lo importante aquí es que lo que se dijo obligó al país entero a hablar de este tema. Por años, los raperos y otros músicos han estado usando esas palabras para describir a las mujeres y nadie las ha notado. Las féminas son siempre utilizadas como objetos sexuales y mujeres semidesnudas son exhibidas en televisión como si lo que está dentro de una bikini tiene más importancia que lo que está debajo de su cabellera – y vamos en silencio en busca de más liposucción y silicona.

Tal vez esto sea lo mejor que ha pasado en este país. Ahora estamos hablando que cuando nuestros niños están expuestos a esas imágenes, su autoestima se disminuye. ¿Puede usted igualar eso al aumento en la violencia y los embarazos prematuros entre nuestros jóvenes? Es cuestión de buenos ejemplos.

Vamos a limpiar nuestros medios de comunicación locales de todo lo que pueda ser ofensivo a cualquiera de nosotros. Apenas la semana pasada, WNNW-AM permitió que durante un programa miembros del público llamaran diciendo atrocidades de las mujeres puertorriqueñas, incluyendo que engañan a los maridos causando ira en hombres y mujeres por igual.

Si no hay oyentes, no puede haber auspiciadores y cuando no hay apoyo comercial, la basura tiene que salir del aire.

Imus puede que vuelva o no a trabajar y depende de nosotros si hemos de escucharlo pero nos ha demostrado el poder que tiene el pueblo.

People Power

This past week the media was saturated with something ugly that needed to be said. No, not that Black people have "nappy" hair but that making fun of people hurts.

Don Imus, who for over 30 years have earned a living making fun of all kinds of people and being vulgar, called a mostly black basketball female team "nappy headed hos" and it was the end of his radio and television career.

Perhaps the treatment inflicted on Don Imus was severe or not enough, that is irrelevant. The important thing here is that what he said brought the whole nation into talks about this topic. For years, rappers and other musicians have been using words like those to describe women and have gone unnoticed. Women are always used as sex objects and scantily-clad women are paraded on television as if what is inside a bikini is more important than under their hair – and we quietly go for more liposuction and silicone.

Maybe, this is the best thing that happened in this country. We are now talking about the fact that when children are exposed to those images, their self esteem is diminished. Can you equate that to the increase in violence and teenage pregnancy among our youngsters? It's all about role models.

Let's clean up our local media of anything that can be offensive to any of us. Just last week WNNW-AM allowed during a call-in show atrocities to be said about Puerto Rican women including that they are "cheaters" causing the ire of men and women alike.

If there are no listeners, there could be no sponsors and when there is no commercial support, the trash will be off the air.


Imus may be back or not on the airwaves and it is up to us to watch him but he showed us the power of the people.

Un artículo que apareció en la edición de Rumbo el 15 de marzo, 2007, sobre nieve que traían de Methuen y la arrojaban en Lawrence, llamó la atención de la Comisión de Conservación de Lawrence y lo están analizando.

La nieve, la traían en camiones desde Mills Falls, un complejo habitacional en Methuen, a Island Street en Lawrence, por el jardinero Darren Caruso y la apilaban contra una pared de retención cerca del Río Merrimack, en un lote adyacente a la fábrica Southwick Clothing.

Tennis Lilly, director de la Comisión de Conservación trajo este asunto ante la junta el martes, 10 de abril, 2007. Lilly expresó su preocupación por el impacto que nieve apilada tan cerca del río pudiera tener en este. "Hay una preocupación por la potencial contaminación del río", expresó Lilly. "A pesar de que en el lote no hay un desagüe que vaya hacia el río, la pared de retención por el lado del lote tiene solo alrededor de un pie de alto, por lo que existe la posibilidad de que alguna sal y/o sedimento haya sido arrojada, por encima de la pared dentro del río, cuando la empujaban para limpiar su propio lote, o cuando la arrojaban de los camiones", dijo Lilly.

Después de deliberar, los miembros

de la comisión estuvieron de acuerdo, primero, averiguar quién es el propietario del lote que está siendo usado por Caruso y su compañía de jardinería, Caruso Brothers. La razón de esto, de acuerdo con Lilly, es la de estar seguros a quién la comisión debe dirigir sus preocupaciones y/o recomendaciones en caso de que hubiera alguna. Segundo, averiguar con el abogado de la ciudad, acerca de la legalidad de traer nieve de fuera de la ciudad y arrojarla en Lawrence.

Todo lo que averigüen será traído a la reunión del martes, 1ro. de mayo, 2007, cuando la Comisión de Conservación vuelve a reunirse. Que conste, el jardinero Darren Caruso fue invitado a participar de esta reunión por Tennis Lilly, Director de la Comisión de Conservación a través de este reportero, pero declinó la invitación. "No tengo que ir a ninguna reunión. Yo pregunté a la Comisión y me dijeron que no había hecho nada ilegal", fue su respuesta.

Darren Caruso también expresó su disgusto ya que estaba esperando una "retracción" del artículo de Rumbo, ya que de acuerdo con él, lo mostraba en una forma contraria a como es él. "Yo no soy una mala persona, yo vivo en Lawrence y adoro esta ciudad", él dijo.

Rumbo nunca escribió nada derogatorio en contra de Caruso. En nuestro artículo dijimos que de acuerdo con Myles Burke, Comisionado Suplente de Inspectional Services, "no luce que el jardinero haya cometido una falta".

Rumbo pidió al Sr. Caruso que escribiera una carta al editor, y refutara el artículo en sus propias palabras. Él no lo ha hecho hasta ahora.

Eileen Donoghue lanza campaña en Lawrence

Eileen Donoghue, Alcaldesa por dos veces y Concejal de la Ciudad de Lowell por 12 años, hizo una parada en Lawrence el jueves, 12 de abril, 2007 para lanzar su candidatura por la silla del 5to Distrito del Congreso. Según lo anunciado, a las 3: 00 P.M. a pesar del invernal día de primavera, Donoghue entró a la oficina del Representante William Lantigua, localizada en el 225 de la Calle Essex, en Lawrence, acompañada de su esposo John J. O'Connor, donde un grupo de amigos de Lantigua esperaban para conocer a la candidata.

“Cuando yo sueno la alarma la gente viene”, dijo Lantigua, pasando a explicar que debido a que esta fue una visita de último minuto sin mucho tiempo para planearla. “Así y todo, a pesar del mal tiempo, muchos de ustedes vinieron, por lo que les estoy agradecido”, dijo Lantigua a un grupo entre los que se encontraban el Director del Departamento de Recursos Humanos de Lawrence, Frank Bonet; el abogado Richard D’Agostino y Domingo Mejía, Vice-Consul de la República Dominicana en Boston, entre otros.

“Necesito su ayuda, pero estoy aquí para escuchar las necesidades de Lawrence”, dijo Donoghue en español. “Ella habló en español no para hacer su campaña y decir hola, yo soy Eileen”, interrumpió Lantigua, “sino trabajando con los dueños de negocios para atraerlos a la ciudad”.

Donoghue nació el 15 de febrero de 1954, en Holyoke, Massachusetts, donde ella y sus 6 hermanas y 2 hermanos se criaron, aprendiendo español mientras crecía. Ella ha sido una abogada por los últimos 28 años, y recibió su Doctorado en Suffolk Law School, en Boston. En 1991,

ella inició su práctica legal en la Ciudad de Lowell, donde ha residido con su esposo John J. O’Connor desde 1988.

“Me gusta representar a la gente que necesita ayuda con el lenguaje, ya que yo no necesito interprete”, dijo Donoghue y añadió, “Yo comprendo que las personas necesitan trabajos, que es muy difícil para que las personas tengan su propia casa y que es muy difícil para que los estudiantes vayan a la universidad y creo que su representante en Washington debe ser el portador de esos deseos ante el gobierno”.

Donoghue ha sido concejal de Lowell desde 1996 y el 5 de enero de 1998, se convirtió en la segunda mujer jamás electa como Alcaldesa de Lowell, desde que la ciudad fue fundada en 1823. Ella ha servido en numerosos subcomités incluyendo el de Finanzas, Desarrollo Económico, Seguridad Pública y el de Vecindarios y Relaciones Universitarias.

A nivel estatal, Donoghue ha servido como Presidenta del Equipo de Transición del Gobernador Paul Cellucci y la Vicegobernadora Jane Swift. Donoghue

es miembro del Colegio de Abogados, La Asociación de Abogados del área de Lowell y de la Junta de Justicia Criminal de la Corte del Distrito de Massachusetts.

Donoghue también sirve en Juntas de Directores de varias organizaciones del área, incluyendo: The Whistler House Museum of Art, Girls Incorporated of Greater Lowell, Saints Memorial Medical Center, y Merrimack River Valley House.

“Quiero darles las gracias a todos por

haber venido y quiero darle las gracias al Representante Estatal William Lantigua. El es el mejor representante que ustedes pueden tener”, terminó Donoghue.

Ayudan a familias a conocer y preparar las planillas en oficinas locales de Asistencia Voluntaria con la Preparación de Impuestos (VITA). Miles de familias trabajadoras han descubierto que las oficinas locales de VITA son un recurso importante para la preparación de sus planillas. La labor de las oficinas locales de VITA con la colaboración de los socios del CDF fue responsable por más de \$170 millones en devoluciones sólo el año pasado.

"Hoy más que nunca, tenemos que asegurarnos que a la familia trabajadora le devuelvan cada dólar que le corresponda para ayudarle a cubrir gastos tales como

los de la alimentación, el alquiler, servicios básicos (luz, teléfono, agua) y el cuidado médico," dice la presidenta del CDF Marian Wright Edelman.

Durante la temporada de declaración de ingresos, millones de familias solicitarán miles de millones de dólares en reembolso por el Crédito de Impuesto del Ingreso Ganado (EITC, siglas en inglés), un "crédito" o descuento de contribuciones federales cuyo propósito es aumentar el ingreso de trabajadores de sueldos bajos y módicos. Cierta porción de estos trabajadores pagan una suma exorbitante por la preparación de sus planillas y reciben su reembolso en menos tiempo, a menudo adquiriendo un Préstamo Anticipado de Reembolso (RAL, siglas en inglés)--un préstamo en base al reembolso anticipado--de alto interés. Se calcula que familias de todas partes del país perdieron unos 2.9 mil millones de dólares por el costo de la preparación de las planillas y los préstamos RAL en el año fiscal del 2004.

Con el propósito, en parte, de contrarrestar el impacto negativo de los préstamos RAL y asistir a familias para que retengan más del ingreso duramente obtenido, el CDF se ha aliado una vez más al IRS y a grupos comunitarios a través de los Estados Unidos para ayudar gratuitamente a familias de bajos ingresos a mejor conocer y a preparar sus planillas

en oficinas locales de VITA. A la hora de pagar los impuestos, estos locales le brindan más opciones a los contribuyentes ofreciendo formularios electrónicos y el depósito de devoluciones directamente en sus cuentas de banco. Esto hace posible que el contribuyente reciba su dinero en unos 10 días sin costo adicional. Sólo el año pasado, las oficinas locales de VITA con que colaboró el CDF ayudó a muchas familias a reclamar casi \$170 millones en reembolsos.





Aumenta el Uso de la Página del IRS ¿Dónde Está mi Reembolso?

El Servicio de Impuestos Internos (IRS) publicó estadísticas que muestran que el uso de IRS.gov <http://www.irs.gov/>, que incluye herramientas tales como ¿Dónde Está mi Reembolso? va en aumento. El uso del sitio Web del IRS ha aumentado un 9% en comparación con la misma fecha el año pasado, a 83.3 millones de visitas.

¿Dónde Está mi Reembolso? es el servicio a través del Internet del IRS que permite revisar el estado de su reembolso federal de impuestos.

"Habiendo presentado sus impuestos muchos esperan ansiosos el dinero que tienen de reembolso. Para aliviarles la espera el IRS los mantiene informados electrónicamente", dijo Sara Eguren, portavoz del IRS. "Puede verificar cuándo sus reembolsos serán depositados o enviados por correo, iniciar la búsqueda de un reembolso perdido o no recibido, y/o para notificar al IRS acerca de un cambio de domicilio", añadió.

Se han recibido casi 21 millones de solicitudes en ¿Dónde Está mi Reembolso? este año, incrementando en más de 3.9 millones de usuarios comparado con el año pasado.

Los contribuyentes pueden ver el

estado de su reembolso siete días después de declarar electrónicamente. Si presentaron una declaración de papel, pueden revisar cuatro a seis semanas después de haberla enviado. Obtienen información de manera segura, ingresando su número de Seguro Social, su estado civil tributario, y la cantidad exacta de su reembolso. Esta información secreta, que sólo comparten el contribuyente y el IRS, verifica que la persona está autorizada para ingresar a la cuenta.

El IRS recuerda a los contribuyentes que pueden evitar problemas de los cheques de reembolso no recibidos si escogen el depósito directo a su cuenta corriente o de ahorros. El depósito directo también protege contra el robo o pérdida de cheques de reembolso y está disponible tanto para declaraciones en papel como las presentadas electrónicamente.

Wednesday, April 18th, representatives of the American Civil Liberties Union will be visiting Casa Dominicana, 225 Essex St. to hear testimonies about abuses from local residents. I am planning to be there since I have been quite vocal before the city council and on my radio show "CrossOver".

They say "you can't fight City Hall" but I am very confident that something will come out from this meeting. The ACLU works through volunteers and the police department is strong but we should show up to prove that we are no longer afraid.

route of making a living without giving a second thought to the impact they are having of young viewers. We now have a generation that is lacking parental skills and their children are being brought up... well, by their TV set.

Our Spanish-speaking community has been quick to copy such a bad example in radio programming where body parts and functions as well as explicit sexual encounters are common topics of conversation. Just this past week, the Puerto Rican community was outraged with insulting comments delivered during a show on WNNW-AM hosted by Santiago Matías, Ritchie Herrera and Milagros Dominguez. Such comments were of a sexual and moral nature regarding Puerto Rican women, bringing an onslaught of complaints against them.

JOB IN THE SCHOOL DEPARTMENT

Speaking of bad examples in the media, Santiago Matías was offered a job in Lawrence's school department to be in charge of Spanish programming at Channel 10, their educational station. Ghettos del alma

En días recientes fuimos testigos de una controversia sobre el conocimiento del idioma inglés que ha tocado una herida abierta particularmente dentro de la población Latina: el uso ampliamente reportado de la palabra “ghetto” describiendo a aquellos que no hablan inglés por parte de Newton Gingrich. Pero antes de proceder con este artículo debemos crear un contexto apropiado. No estamos hablando informalmente de “Newt” Gingrich, nada de eso; hablamos de Newton Gingrich, PhD, un hombre que debe saber leer y escribir.

El disturbio creado por el antiguo Presidente de la Cámara de Representantes fue inmediato. Primero, la indignación más profunda y la queja más ruidosa provinieron de los líderes de la comunidad latina. No vi reacción similar alguna por parte de otros grupos étnicos diferentes que salpican nuestros mayores centros de población y que hablan diferente también. Por favor noten que dije “no vi.” Eso no significa que no ocurrió; no lo vi y estoy dispuesto a reconocer que me equivoco si usted tiene otra información. Ese tema sensible será parte de un artículo futuro.

La causa de que las voces ofendidas vinieron principalmente por parte de un solo color del arco iris cultural es clara. Las palabras fueron interpretadas como si fueran saetas lanzadas en nuestra dirección, no la de otros. En estos días de profundas convicciones políticas polarizadas expresadas apasionadamente, los latinos nos hemos convertido en las víctimas propiciatorias de conveniencia. Nuestros líderes pueden reconocer los golpes, los sospechan, y reaccionan rápidamente al menor síntoma o huella de ello.

No es difícil llenar horas vacías y sin valor de programación radial o televisión con acusaciones de conflictos reales o imaginarios que carecen de solución y que uno puede achacar a otros grupos de personas. Es particularmente conveniente cuando nos referimos a aquellos que no oyen o leen lo que se dice de ellos en ese momento porque están ocupados, o no pueden alzarse indignados en su propia defensa aunque lo quisieran porque miran constantemente sobre sus hombros para evitar que se les separe de sus familias y sean deportados o están simplemente en un peldaño diferente de la escala social y preocupados sobre la fuente del próximo bocado de comida.

Yo vi y escuché los comentarios del Dr. Gingrich; muchos líderes de nuestra comunidad lo hicieron también. Pero lo cierto es que aquellos que podrían haberse beneficiado por sus palabras, si hubieran

contenido algo beneficioso, estaban demasiado ocupados tratando de ganarse la vida para poder escucharlas o aplicar estas cansadas y usadas soluciones de sabiduría de esquina.

Y después que toda su perorata terminó, las palabras del Dr. Gingrich obtuvieron sus objetivos extremistas de sonido electoral, los Bill O'Reillys, Rush Limbaughs, Lou Dobbs y Ann Coulters del mundo obtuvieron el pie para continuar su habladuría de basura destinada a incrementar sus números de televidentes y oyentes, pero al día siguiente el mundo no era mejor que el día anterior, la verdadera medida de nuestras acciones. Y desde luego, su retracción, no una disculpa, sino una clarificación, fue emitida en ambos idiomas-la ofensa no lo fue-para probar, como dijo, que “él está todavía tratando de aprender el español.” ¿Ustedes creen que esté planeando mudarse para el barrio pronto?

Yo me sonríe filosóficamente entre dientes cuando pienso en la coincidencia histórica de que William Shakespeare y Miguel De Cervantes, las figuras estelares de la literatura inglesa y española, murieron el mismo día: Abril 23, 1616. ¿Usted lo sabía? Estaban en lugares diferentes de este planeta, pero obviamente eran la misma estrella sobre el firmamento lingüístico y su labor se completó básicamente en este mundo el mismo día. Es una de esas coincidencias que me hace sospechar que existe alguien que no puedo tocar o ver y que está tomando esas decisiones.

Yo estoy seguro que el Dr. Gingrich no estaba diciendo que un idioma era mejor que el otro, y él lo indicó en su “clarificación” cuando expresó que no estaba diciendo que el español no era un “idioma bello.” Bueno, eso me hace dormir mucho mejor. Muchos de aquellos que reaccionaron a sus palabras originales estaban en muchos casos respondiendo a esa interpretación limitada.

Parte del problema con este argumento sobre el conocimiento necesario del idioma fue el uso de la palabra explosiva “ghetto.” Yo siempre he estado convencido que las palabras conllevan alusiones emocionales dadas a ellas por las personas en ciertos momentos históricos que continúan asociándose con ellas mucho después que el significado original se ha perdido y se han hecho inservibles. Es como un olor o un sabor que no parece desaparecer por mucho que lo lavemos.

Tal vez sea tiempo de volver a visitar el concepto y origen de la palabra y tratar de averiguar si tiene el mismo significado en el mundo de hoy y refleja los pensamientos actuales. En otras palabras, ¿es el ghetto un lugar material o un lugar mental? Quién sabe si descubriremos que el Dr. Gingrich está habitando en un ghetto similar al que él mismo edificó descuidada pero astutamente para establecer su posición política extremista. Un poco de historia y etimología nos ayudará.

De acuerdo con Wikipedia (<http://www.wikipedia.com>), “Un Ghetto es un área donde la gente de un medio ambiente

similar de una cultura o religión vive como un grupo, voluntaria o involuntariamente, en apacible o estricta reclusión. La palabra históricamente se refería específicamente al Ghetto Veneciano en Venecia, Italia, donde a los judíos se les requería vivir. Después se aplicó a los vecindarios en otras ciudades también donde a los judíos se les requería vivir... el término se hizo popular en todo el mundo durante la Segunda Guerra Mundial en referencia a los Ghettos nazis.”

“La descripción ahora se da a cualquier área afectada por la pobreza urbana. En los Estados Unidos los medios de comunicación crearon términos como “ghettos rurales” para describir parques de hogares móviles, casas de cosecheros agrícolas y reservaciones indias para indicar que las áreas más pobres de los Estados Unidos no estaban dentro de las ciudades mayores. En los Estados Unidos, vecindarios urbanos donde los inmigrantes hispanos se establecieron al final del siglo veinte (llamados barrios) se decía que eran comparables a los ghettos porque los inmigrantes forman un enclave cultural aislado y pueden escoger quedarse allí o asociarse con su propio grupo.” Nota: los caracteres en cursiva son míos. Por favor note que el final de la oración anterior se refiere a “su propio grupo” no “su propia familia o parentela.”

“Ghetto” es también usado como una metáfora para describir áreas geográficas con una concentración de cualquier tipo de persona, con o sin pobreza (i.e. “ghetto gay”) o por categorías no geográficas (i.e. “ghetto de ciencia ficción.”) El término se usa también para describir una cosa o una acción como barata o endeble. Algunos consideran ese uso del lenguaje una mala aplicación ofensiva.”

Ahora bien, usted puede escoger cualquiera de las interpretaciones que prefiera de las definiciones generales que presenté arriba sobre la palabra “ghetto,” pero el uso del Dr. Gingrich fue no solo insensible sino también innecesario y totalmente ignorante vieniendo de un hombre de sus credenciales educacionales. En los párrafos que pedí prestado de Wikipedia arriba, usted puede ver que obscurécí las palabras “voluntaria, involuntariamente, requería y escoger.” Es decir, los ghettos son tan productos voluntarios de las comunidades como el escoger forzado lo es, y las razones económicas y religiosas, no el lenguaje, eran más a menudo las causas de las condiciones del ghetto.

El uso de la palabra “Ghetto” en el

contexto del discurso pronunciado por el Dr. Gingrich fue constreñido, fijándolo implícitamente en la principal comunidad que se halla en el presente envuelta en una controversia política creada por asuntos de legalidad y reforma de inmigración que son difíciles de resolver y sobre los que la mayoría de las personas están conscientes pero nada pueden hacer.

Yo creo que la palabra “ghetto” en el mundo de hoy se aplica no solamente a la localidad física en el interior de las ciudades del país sino al estado de mente de “pensamiento-de-grupo” por parte de ciertos individuos, sean éstos extranjeros recién llegados de sus países que carecen de educación, o un PhD que vive aisladamente en un ghetto mental decidido como otras personas son o deben ser, criticándolos y después volviendo la espalda para hacer otras cosas, en el proceso no contribuyendo nada útil para corregir la situación.

No importa que miles de personas hayan sido matadas en la guerra de Irak y el final no se vea pronto; que el mundo se está calentando cada día y a nadie le interesa porque no lo creen o no se preocupan por ello; que el SIDA continúa infestando a más seres humanos en el planeta o que cientos de miles de niños se van a la cama todas las noches hambrientos quizás sin poder despertarse al día siguiente: el problema real que enfrentamos es el idioma: el nuestro y el de ellos. Ajá, muy inteligente.

Dentro de ese contenido, las palabras del Dr. Gingrich pueden haber sonado intencionalmente dirigidas a nosotros los latinos y nuestro uso del idioma inglés, pero en realidad fueron dedicadas al corazón de cualquiera que sea diferente, suene diferente y luzca diferente, se den cuenta o no; aquellos que hablaron y aquellos que no lo hicieron. 

Snow being brought and dumped in Lawrence, Part II

An article appearing on Rumbo's edition of March 15, 2007 about snow from Methuen being dumped in Lawrence, prompted the Lawrence Conservation Commission to look into it.

The snow was brought in trucks from Mills Falls, an elderly housing complex in Methuen, to Island Street in Lawrence, by Landscaper Darren Caruso, and piled by a retaining wall by the Merrimack River, in a lot next to Southwick Clothing.

Tennis Lilly, head of the Conservation Commission brought this matter before the board on Tuesday, April 10, 2007. Lilly expressed his concern about the impact that piling snow into the buffer zone might do to the river. "There is a concern of potential contamination to the river", expressed Lilly. "Even when there is no water drainage in the lot going into the river, the retaining wall on the lot's side is only about a foot high, posing a possibility of some silt and salt being pushed over into the river, when cleaning the lot or dumping the snow", said Lilly.




This picture was taken 03/27/07, seven days after the storm, from the opposite side of the river, that shows a dark spot by the retaining wall, that could be silt been pushed from the lot, over the retaining wall.

After deliberation, members of the commission agreed on first, to find out who owns the lot being used by Caruso and his landscaping company Caruso Brothers. The reason for this, according to Lilly, is to make sure to whom the commission should address its concerns or recommendations, if any. Second, find out from the City Attorney, the legality of trucking snow into Lawrence from outside of the city.

These findings will continue on the next Lawrence Conservation Commission when they meet again, on Tuesday, May 1,

2007. For the record, landscaper Darren Caruso was invited by Tennis Lilly, head of the Conservation Commission through this reporter to attend this meeting but he declined. "I don't have to go to any meetings. I checked with the Commission and they told me that I have done nothing illegal," was his response.

Darren Caruso also expressed his disappointment because he was expecting a "retraction" of the Rumbo article that according to him put him in a bad light. "I'm not a bad guy; I live in Lawrence and




This picture was taken 03/20/07, the morning after the storm, and shows the truck dumping the snow very close to the retaining wall.

I love the city," he said.

Rumbo never wrote any derogatory remarks toward Mr. Caruso. In our article we said that according to Myles Burke, Acting Commissioner of Inspectional Services. "The landscaper seems not to be at fault."

Two-term Mayor and City of Lowell Councilor for 12 years, Eileen Donoghue, stopped by Lawrence on Thursday, April 12, 2007, to launch her campaign to lead the 5th Congressional District.

As announced, at 3:00 P.M. despite of the wintry spring weather, Donoghue walked into State Representative William Lantigua's headquarters, located at 225 Essex Street, in Lawrence, accompanied by her husband, John J. O'Connor, where a group of Lantigua's followers were waiting to meet the candidate.

"When I sound the alarm, people do come," said Lantigua when introducing Donoghue. Lantigua was referring to that this was a last minute visit with not too much time for planning. "Still, many of you showed up regardless of the weather, for what I'm thankful," said Lantigua to a group which included Lawrence Human Resources Director Frank Bonet, Atty. Richard D'Agostino and Domingo Mejía, Vice-Consul of the Dominican Republic in Boston, among others.

"I'm looking for your help, but I'm here to listen to what is needed in Lawrence," said Donoghue in fluent Spanish. "She spoke in Spanish not to run the campaign and say 'Hola, yo soy Eileen' (Hello, I'm Eileen)", interrupted Lantigua, "but by working with business to attract them to the city."

Donoghue, was born on February 15, 1954 in Holyoke, Massachusetts, where she and her siblings (six girls and 2 boys) grew up, learning Spanish in the process. She has been a lawyer for 28 years, receiving her Juris Doctor at Suffolk Law School in Boston. In 1991, she opened her own practice in the City of Lowell where she has resided with her husband John J. O'Connor since 1988.

"I like to represent people who need help with the language since I don't need interpreter", said Donoghue and added, "I understand that people need jobs; it is very difficult for people to have their own home,

Donoghue has been on the Lowell City Council since 1996 and on January 5, 1998, she became the second woman ever elected Mayor of the City of Lowell, Massachusetts since its inception in 1823. She has served on numerous subcommittees including Finance, Economic Development, Public Safety, and the Neighborhoods and University Relations.

On a statewide level, Donoghue served as Chairperson of the Transition Team for Governor Paul Cellucci and Lieutenant Governor Jane Swift. Donoghue is a member of the Massachusetts Bar Association, the Greater Lowell Bar Association, and the Criminal Justice Act Board – United States District Court, District of Massachusetts.

Donoghue also serves on the Board of Directors of several area organizations, including: The Whistler House Museum of Art, Girls Incorporated of Greater Lowell, Saints Memorial Medical Center, and Merrimack River Valley House. "I want to thank you all for coming and I want to say thank you to State Representative William Lantigua. He is the best representative you can have", ended Donoghue.

"All I wanted was for these friends to listen what you have to say. Now they can make their own decisions. Mine is made up: I'm supporting Eileen Donoghue", said Lantigua.

coterie of haters peddle and deny it a foothold amongst our citizenry.

Earlier this year so-called Latino leaders in print and on the radio peddled the message that a certain multi-million dollar mill redevelopment was simply a scheme cooked up by the Anglo overseers in Lawrence to squeeze Latinos out of our city, thereby reducing the Latino cultural and political influence in our community.

Now it is the likes of Mr. Maldonado telling us that this same Anglo conspiracy is at work again, purposely using higher property taxes and water/sewer rates to push Latino property owners out of their homes and businesses. Apparently Mr. Maldonado's recent water and sewer bills are clear and convincing evidence of such a conspiracy.

To Mr. Maldonado and his ilk I say, "Don't let the facts stand in your way."

On at least two occasions now I have seen him address the issue of his water and sewer bills before the City Council. Clearly there is something wrong with the billing

process and perhaps even with the water and sewer infrastructure in his building. But his approach is not to investigate what is causing the spikes in his bills. His approach now is to blame these higher bills on a concerted racist effort at City Hall to drive him and those like him out of the city. Interestingly, when speaking to the Council he never mentioned this racist conspiracy. His racist rants are reserved for the Latino media outlets.

For years the State Department of Revenue has been pushing the city to go to the maximum limit on property tax assessments. Our city is almost entirely dependent on state revenues to finance our government. For the city to go to the full limit of the tax levy seems a reasonable requirement for the DOR to ask us to do. Since Deval Patrick took office in January – the first black to serve as governor of our Commonwealth – DOR's call to go to the full limit has increased not lessened. Mr. Maldonado, is Governor Patrick secretly in on this Anglo conspiracy against you and your poison peddlers?

A number of years ago the city, required by the state to upgrade its water delivery services, chose not to privatize those services but instead to take on the commitment of building a new water plant in the city. This was done knowing there would be considerable expense to the city and subsequently upon her ratepayers. Now that the bill is due on the new plant, apparently this is a wonderful opportunity by the Anglo overseers to use it to selectively push Latino homeowners and businesses out of the city.

Finally, Mr. Maldonado advocates for the election of only Latinos to the City Council in November's elections. Mr. Maldonado feels that the Anglo members of the Council only speak for the Anglo citizens in their districts and our city. I feel badly that Mr. Maldonado suffers such clouded thoughts. The Lawrencians I know and associate with vote not for the Irish or Italian or Latino candidate. The Lawrencians I know, when they vote, simply want the candidates they support to do the job they should do – pay attention to our neighborhoods and city and do the right thing for all her citizens. A naïve thought perhaps, but it is after all what they are elected to do.

For now I would like to think that Mr. Maldonado and his brand of racism finds a home in a small element of our city. If left unchecked, however, I fear it will overwhelm the good that a lot of us in our community are trying to promote for ALL Lawrencians.

Mr. Maldonado, it will not be higher property taxes and water/sewer rates that drive you from our city. Hopefully it will be an overwhelming reaction against you and your ilk that drives you to move on and try to peddle your poison elsewhere.



APRIL 8–14 IS HEALTH INFORMATION PRIVACY AND SECURITY WEEK

As the healthcare industry moves closer to electronic health information systems, concerns for privacy of health information continue to be an important issue. The increased availability of electronic health information carries significant benefits, but you need to maintain a healthy awareness of the risks and play an active role in monitoring your health information. With the week of April 8-14 being designated "Health Information Privacy and Security Week", the health information management professionals at the Greater Lawrence Family Health Center are providing tips for protecting your personal health information:

1. Understand your information rights as a healthcare consumer. You have the right to view and receive copies of your medical information; request amendments or

corrections of information you believe to be incorrect; know who has reviewed or received copies of your medical information; and the right to complain about medical privacy practices or breaches of privacy.

2. Read the Notice of Privacy Practices that your healthcare provider and health plan are required to provide to you at the time of service or upon request. Understand your rights, what types of information are maintained, and how each entity uses or handles it.
3. Be aware that not all organizations or entities that collect and maintain your health information are covered by federal or state privacy laws.
4. Obtain and maintain copies of your medical records and information so you can use the information to monitor your care and spot any errors in the information.

Michelle LaMothe, HIPAA

Compliance and Privacy Officer for GLFHC, notes that GLFHC has additional responsibilities when it comes to Spanish-speaking clients. "Patients are issued our Notice of Privacy Practices (NOPP), which is written in English and Spanish, when they first register with GLFHC. This document lists the patients' rights and GLFHC's responsibilities under the Health Insurance Portability and Accountability Act (HIPAA) that went into effect April 14, 2003. The NOPP lists all of the ways that GLFHC may ever use their information." Some examples would be for treatment of the patient, to submit bills for reimbursement by the patient's insurance, and to do quality reviews to validate that patients are provided the best possible care.

LaMothe points out that patients have the right to access their information. According to LaMothe, "If patients want a copy of their medical records, they must sign an authorization at the Health Information Management department at the site at which they are seen or they may come to our office at 11 Lawrence St. to submit the request. Patients should expect to receive copies of their records within 10 business days. Patients will need to bring a photo id with them to pick up the records." There is no fee for the first copy in a 12 month period.

Health Information Privacy and Security Week is sponsored by the American Health Information Management Association (AHIMA). This year's theme is "Keeping It Personal—Health Information You Can Trust." The week is designed to raise awareness among the public about the importance of personal health information privacy and security.

Andover PTO Offering Hearth Screening Program

MISS MASSACHUSETTS, MICHAELA GAGNE TO APPEAR—SUFFERS FROM HEART CONDITION

The Andover Parent-Teacher Organization (PTO) will sponsor a Healthy Heart Screening Program on April 24, 25, 26, and 28 at the West Middle School Cafeteria at 70 Shawsheen Road. The screening sessions are open to the public and will be held from 4-8 PM. on Tuesday April 24, Wednesday April 26, and Thursday April 26, as well as 9 A.M. – 1 P.M. on Saturday April 28.

Saturday's screenings will be attended by the 2006 Miss Massachusetts, Michaela Gagne. When she was 17 years old, Gagne was diagnosed with Long QT Syndrome, a disorder of the heart's electrical rhythm. Long QT Syndrome is a heart irregularity that can be vulnerable to fainting, sudden cardiac arrest, or even death during vigorous exercise or intense physical activity. It is one of the "sudden death" causes that affect young athletes, and can be detected by an electrocardiogram (ECG), such as those used in the heart screenings being offered.

The PTO is partnering with Andover's HeartScreen America, Inc. to offer preventive heart screenings for residents ages 6 and up. Registration is required by April 22 at www.HeartScreenAmerica.com or by calling 978-474-8008.

Sudden Cardiac Arrest (SCA) claims over 5,000 young American lives each year. Many seemingly healthy children die suddenly and unexpectedly every year from a heart problem that can often be detected with a simple, painless, non-invasive test, the electrocardiogram (ECG).

PTO President Bill Pennington sees the program as an investment in the well-being of Andover youth, and helped bring the program to Andover after losing a very close friend who died shortly after running on a treadmill. "As a coach of that age group, one of my greatest fears is that it could happen to one of my players," says Pennington. "I lost one of my best friends that way."

The screening program, which includes an electrocardiogram, is open to all Andover residents. Screenings cost \$44.95 for children (age 6+) and \$64.95 for adults. Ghettos of the soul

The past few days brought with them a new controversy about the use of the English language that seemed to touch a raw nerve, particularly within the Latino population: Newton Gingrich's widely reported use of the word "ghetto" to describe those who do not speak English. But before I proceed with my article let's create the proper context. We are not talking about Newt Gingrich, not at all; we are talking about Newton Gingrich, PhD a man who should know his ps and qs.

The disturbance created by the former Speaker of the House of Representatives was swift. First, the deepest outrage felt and loudest reaction expressed came from leaders of the Latino community. I failed to see a similar response from the many ethnically different groups that pepper our major centers of population and speak differently as well. Please notice that I say "failed." That does not mean it did not happen; I just did not see it and am willing to stand corrected if you know better. That issue will be part o a future article.

The reason why the voices of complain came mostly from one color of the cultural rainbow is apparent. The words were interpreted as arrows coming in our direction, not others'. In these days of polarized deep political convictions and deeper ways to convey them, Latinos have become the whipping group of convenience. Our leaders can recognize the poundings, suspect them or react quickly to the slightest trace of them.

It is easy to fill otherwise empty and meaningless hours of radio or television programming with accusations of real or imagined conflicts that defy solution and you can place the fault on someone you find out there. It is particularly convenient when you speak about those who don't hear or read what is being said about them at the moment because they are busy, or can't stand up in their own defense even if they could because some of them have to look constantly over their shoulders to avoid being separated from their families and being deported or are simply on a different step of the social ladder and concerned about where the next morsel of food is coming from.

I saw and heard Dr. Gingrich's comments; many leaders of our community did as well. But the reality is that those who could have benefited from his words, if they had truly been of any help, were too busy making a living to listen, never mind apply his tired and baseless words of street corner wisdom. After all was said and done, Dr. Gingrich got his sound bite of extremist political opportunism, the Bill O'Reillys, Rush Limbaughs, Lou Dobbs,

and Ann Coulter of the world got their cue for more useless rating-driven babble and the world was no better than day than the day before, the true measure of our actions. And, of course, his retraction of sorts, not quite an apology, but a clarification, was issued in both languages-his offense wasn't-to prove, as he put it, that "he is still trying to learn how to speak Spanish." Is he planning to move to the barrio soon?

I get a philosophical chuckle from the historical coincidence that William Shakespeare and Miguel de Cervantes, the towering figures of our English and Spanish literatures, died on the same date: April 23, 1616. Did you know that? They were in different places of this planet but obviously on the same star over the language firmament and their work was basically done in this world on the same day. It is one of those rare coincidences that makes me suspect that there is someone I can't touch or see makings those kinds of decisions. I am sure that Dr. Gingrich was not saying that one tongue was better than the other, and he pointed it in his "clarification" when he stated that he was not saying that Spanish was not a "beautiful language." Well, that makes me sleep much better. Many of us who reacted to his original statement were in some cases taking offense on that narrow scholarly interpretation.

Part of the problem with the argument was his use of the explosive word "ghetto." I have always been convinced that words carry with them emotional overtones given to them by folks in certain times that continue to be associated with those words for a long time after the original meaning is lost and becomes useless. It is like a smell or a taste that does not seem to go away no matter how much you wash it. Perhaps it is time to revisit the concept of that word and try to figure out whether it has meaning in today's world and measures today's thinking. In other words, is ghetto a physical place or a mental place? Perhaps we could discover that Dr. Gingrich is as much in a ghetto himself as those he so carelessly but craftily placed in that category to stake his political ground. Perhaps a bit of history and etymology will help.

According to Wikipedia (<http://www.wikipedia.com>), "A ghetto is an area where people from a specific racial or ethnic background united in a given culture or religion lives as a group, voluntarily or involuntarily, in milder or stricter seclusion. The word historically referred specifically to the Venetian Ghetto in Venice, Italy, where Jews were required to live. It was later applied to neighborhoods in other cities as well where Jews were required to live.... The term came into popular, worldwide use during World War II, in reference to Nazi ghettos."

"The term now commonly labels any poverty-stricken urban area. In the U.S. the news media created terms like rural ghetto to describe mobile home parks, farm labor housing tracts and Indian reservations to indicate that the poorest areas in the U.S. aren't within major cities. In the United States, urban neighborhoods

where Hispanic immigrants settled in the late 20th century (called barrios) are said to be comparable to ghettos, because most immigrants form a culturally isolated enclave and may choose to remain there or associate with their own group." Note: Bold characters are my choice. Please notice that the ending above refers to "their own group" not "their own extended family."

"Ghetto" is also used figuratively to indicate geographic areas with a concentration of any type of person, with or without poverty (e.g. "gay ghetto") or for non-geographic categories (e.g. "sci-fi ghetto"). The term is also used to describe an item or an action as cheap or flimsy. Some consider this use of language to be an offensive misapplication".

Now, you may pick and choose whatever interpretation you want from the above general definitions of the word ghetto, but certainly Dr. Gingrich's use was not only insensitive but also unnecessary and flatly ignorant coming from a man of his educational credentials. On the paragraphs I borrowed from Wikipedia above, you see that I highlighted the words "voluntary, involuntarily, required and choose." So the ghettos are as much a voluntary outgrowth of the communities as forced choice is, and economic and religious reasons, not language, were more often the cause of the ghetto condition.

The use of the word in Dr. Gingrich's context was narrow, pointing implicitly to the one community that is now in the middle of political controversy created by issues of immigration legality and reform difficult to solve that most people are aware of but can do nothing to correct. I believe that the word ghetto in today's world applies not to the physical location of inner cities or reservations alone but also to a "group-

think" state of mind of certain individuals, whether it is a recently arrived alien who has little if any education or a PhD. who lives in his own isolated mental ghetto deciding how other people are or should be, criticizes them and then turns around to do other things, in the process providing nothing useful to correct the situation.

Never mind that thousands of people have been killed in the Iraq war and the end is not in sight any time soon; that the world is getting warmer and nobody cares because they don't believe it or don't worry; that AIDS keeps infecting more and more people in the world or that hundreds of thousands of children go to bed each night hungry perhaps not to awake the next day: The real problem we face is one of language: ours versus theirs. Hmm, smart.

Within that context, Dr. Gingrich's words may have sound, perhaps intentionally, to be directed only to us Latinos and our use of the English language, but they really went straight to the heart of anyone who is different, sounds different and looks different, whether they realized it or not; those who spoke and those who didn't. And that is all of us. Dr. Gingrich characterized anyone who has ever lived in a so-called ghetto as indolent and impotent and fully responsible for his or her circumstances.

Those words blanketed any human being who has ever lived under those conditions. And no one is going to forget it. He will have to revisit and discuss this issue if he decides to run for the Republican presidential nomination in 2008. And the folks who will want that revisit are part of the forty-five-million strong Latino community in the United States who vote. Comprende Dr. Gingrich?

And that is my Point of view today.

TO BUILD AND DISPLAY 'GREEN' GREETERS CENTER FOR IRONSTONE FARM

Students from several career areas at Greater Lawrence Technical School are learning about everything from horsemanship to "green" building through the SkillsUSA Community Service project, to create a Greeters Center for Ironstone Farm in Andover, an equestrian facility that offers a well-respected riding program for the handicapped.

This is the second time Greater Lawrence Technical School has partnered with Ironstone Farm on a Community Service project. In 2005, students from the GLTS chapter of SkillsUSA, a student organization, worked with the Andover facility to provide volunteer horse handlers, sew blankets for horses, and construct a handicapped access mounting ramp for clients taking horseback riding lessons. A presentation team took the project to the state competition of SkillsUSA and won gold medals, then mined gold again at the national contest.

Through the www.volunteermatch.com site, a hyperlink from the Timberland website, GLTS learned about a need this year for a greeters Center at Ironstone Farm. The 8 x 12' structure will be used as a starting point to direct visitors around the farm, which now includes a large new indoor ring that was built partially with

recycled materials.

Timberland is also a repeat partner, along with the Andover Education Improvement Association. Timberland has provided 28 pairs of boots for student volunteers, and the AEIA awarded a \$500 grant that the team will use to incorporate technology into a display at the state

competition of SkillsUSA in Marlborough April 26-28.

State Competition April 26-28

The display will include a section of the new building, placed adjacent to the Team Works building competition, to show the methods and benefits of environmentally friendly construction. A new partner for

the Community Service team, the non-profit Conservation Services Group (CSG) will sponsor the display, with a goal of introducing green methods to the future construction professionals who compete at SkillsUSA.

On April 27, the Community Service presentation team of Peter Clancy of Methuen, Margie Colon of Lawrence, and Katherine Perez of Lawrence will give a PowerPoint presentation outlining the activities of not only the team trio, but also the dozens of students involved in the project who worked on planning and promotion (sponsors and students from Graphic Communications, Metal Fabrication, and Allied Health), design (Machine Technology), and construction and painting (Carpentry, Electrical, Building & Property Management, Metal Fabrication). Others will get involved with finishing details as well as sewing horse-theme pillows for some of the young visitors to Ironstone (Fashion Design) and preparing food for a ribbon cutting ceremony (Culinary Arts & Hospitality). Should the judges award them gold medals for their project and presentation, the team will take "Green Greeters Center" to the national SkillsUSA Championships in Kansas City, June 18-23. Greater Lawrence Technical School has been a national competitor in Community Service for four years and won gold in both 2005 and 2006, last year earning the highest point score of 52 teams.

The students who constructed the building will also present at SkillsUSA, through the Tech Prep Showcase event, demonstrating how they used their technical skills to bring the project from idea to reality. Jose Santana, Jose Guzman, and Carlos Rivera of Lawrence and David Michienzi of Methuen will be the presenters. Energy efficiency and green house building are now part of the Massachusetts Frameworks for construction education.

The Green Greeters Center uses SIPS, a Structurally Insulated Panel System that resembles a giant ice cream sandwich. Polystyrene, available in different R-values for insulation, makes up the "ice cream," with OSB, Oriented Strand Board as the "chocolate wafers," which can be covered with such materials as plywood or drywall. SIPS construction is speedy, and Construction Cluster Leader Richard Krafton says sometimes a SIPS house can be built in three days. The final assembly of the Green Greeters Center will be done on the Ironstone Farm property.

"It has been very exciting to see the progress," said Wolff, who brought CSG staff to the project twice this past week to demonstrate techniques and products. Wolff also cited Foard Panel, a Connecticut firm that donated the SIPS panels and loaned tools for the project as a "terrific ally."

Paul Wolff of CSG and his colleagues have worked with the GLTS Carpentry department through the Technical School Outreach program, sponsored by National Grid. In addition to providing personnel who demonstrate green techniques, CSG supported field trips to construction trade shows in Boston.

OPEN HOUSE LAUNCHES FREE TESTING SERVICES FOR STI'S

VACCINATIONS AND EDUCATIONAL MATERIALS AVAILABLE ON FRIDAY APRIL 20TH

"Knowing is Healthy" is the theme of the Open House planned by the Community Support Services (CSS) Program of the Greater Lawrence Family Health Center for April 20th from 9:30 AM – Noon at the 11 Lawrence Street (3rd floor) location. As part of the event, people will be encouraged to learn more about free testing services that will be taking place for a variety of Sexually Transmitted Infections (STI) beginning Monday April 23rd, 2007.

Gerardo Zayas is the CSS Community Based Program Manager. He says while numbers in Lawrence are high, programs like the free testing service being highlighted will allow people to educate themselves and learn what services are available within their community. "In 2005, the city of Lawrence was ranked as one of the highest cities in the Commonwealth of Massachusetts of reported sexually transmitted infections. (Statistics provided by the Mass. Bureau of Communicable Disease Control Office of Integrated Surveillance and Information Services.) The CSS Prevention & Education Department motto of "Knowing is Healthy" emphasizes the importance and normalcy of being tested for STI."

Zayas also stresses the need to remove the dark cloud that comes with using the services, and hopes that the Open House will invite people to be comfortable in learning more about what is being offered. "'Knowing is healthy' also relates to reducing the stigma of accessing testing services and follow up medical care for all STI. The primary goal of testing is to assist community members to access free, confidential, safe individual counseling sessions. We're also focused on providing comfortable group education sessions on how to identify risks and create a plan on how to reduce exposure of new infections."

Beginning at 9:30AM, educational materials and information will be offered for a variety of STI including Chlamydia, Gonorrhea, Syphilis, and Hepatitis C. Vaccinations for Hepatitis A and B will also be available at that time. As part of the educational feature of CSS, a workshop on Sexually Transmitted Infections will be held later in the afternoon from 12:15 PM until 1:30 PM. All services and educational materials are provided free of charge, in both English and Spanish, and on a confidential basis.
