Los Pastores Dispuestos de Jesucristo, el Capítulo de la Orden de Saint Dominic que recientemente se mudó para la Iglesia del Sagrado Corazón en Lawrence abrieron una tienda de regalos en la Rectoría con regalos religiosos (estatuas, medallas, rosarios y agua bendita, oraciones, crucifijos, etc.) así como excelentes libros sobre los santos y la fe.

La Hermana Mary Bernadette y la Hermana Tracy saludaban a visitantes atraídos por el letrero hecho a mano en la acera en S. Broadway que señala la tienda de regalos. El sábado, 12 de mayo, fue la gran apertura y una entrada constante de clientes las mantuvieron ocupadas toda la tarde. Sr. Bernadette, una combinación perfecta de anfitriona y dependienta, explicó orgullosamente que algunos de los rosarios en venta (ya bendecidos) fueron hechos por su madre.

Cuando el Hermano Gerard Francis me ofreció una visita a ver la iglesia yo no estaba preparada para las emociones que me invadirían. Entrar a la iglesia me llevó a mis últimos días en Cuba cuando la Revolución destruyó la iglesia donde íbamos cuando era niña, tirando las estatuas en un camión.

La Archidiócesis Católica Romana de Boston está atravesando problemas financieros tan grandes que ellos tuvieron que clausurar la iglesia y vendieron la propiedad entera que consiste en cinco edificios a ETC Development Corp. de Boston. Para prevenir que el edificio fuese utilizado como iglesia otra vez, destruyeron los altares de mármol y estatuas. Los bancos y las ventanas fueron sacados y todo luce terriblemente triste. Esta enorme y hermosa

iglesia fue destripada pero esta vez fue hecho por la Arquidiócesis. ¿Quién habría pensado que la Archidiócesis destruiría una de sus propias iglesias?

El corazón me dio un vuelco cuando me acerqué al altar principal con sus entrepieños de mármol quebrantados. Alguien tomó un martillo y demolió todo lo que tuviera algo de significado religioso. Las estatuas fueron arrancadas de las paredes destrozando en el proceso parte de la arquitectura.

Esto todo sucedió en los últimos dos años. Ahora esta Orden de Saint Dominic quiere restaurarla y traer las misas al estilo antiguo pero la Iglesia Católica no los considera parte de ellos porque no siguen los cambios aprobados por el Vaticano II.

Mi tiempo en la tienda de regalos fue bien empleado mirando el número de personas que entraban felices de haber visto el letrero en la acera. Tres viejos amigos empezaron una extensa conversación no habiéndose visto uno al otro desde que dejaron de dar misas en el Sagrado Corazón. De repente, el sonido melifluido de las campanas de la iglesia comenzó a tocar y todos los hermanos y las hermanas fueron a cantar afuera en celebración. Ellos habían estado tratando de hacerlos funcionar por los pasados dos meses y finalmente lo lograron. Fue un momento mágico para ellos que fui afortunada en capturar.

Las reparaciones son tan extensivas que no están seguros de cuan pronto podrán recaudar los fondos necesarios para hacer el trabajo que se requiere. Entretanto, ellos están satisfechos con poder mostrar las condiciones de la iglesia a cualquier persona porque necesitan toda la ayuda que puedan encontrar para poder regresar esa maravillosa estructura a lo que estaba destinada a hacer: unirnos a Dios.

## EDITORIAL

### UNA BUENA OPORTUNIDAD DESPERDICIA DA

En su primera visita a Lawrence después de ser elegido, el Gobernador Mitt Romney visitó un restaurante de lujo para reunirse durante un almuerzo, con el Alcalde Michael J. Sullivan, el Superintendente Escolar Wilfredo T. Laboy y un muy exclusivo círculo de oficiales de la ciudad. A los miembros de la prensa no se les permitió entrar, bueno, debo decir que a Rumbo se le dijo: “espere afuera hasta que terminen el almuerzo”.

¡Que diferencia con la visita del nuevo Gobernador Deval Patrick! Fue abierta a toda la prensa y aunque él vino a reunirse con el pueblo, no hay excusa para que el alcalde, el superintendente escolar y el jefe de policía no estuvieran allí.

Más de 300 personas llenaron el centro y muchas de ellas bombardearon al gobernador con toda clase de quejas legítimas. Desafortunadamente, dos asuntos importantes, Malden Mills no fue mencionado y la brutalidad policíaca fue rápidamente barrida bajo la alfombra cuando Alicia Lugo lo trajo a colación. El Concejal Nunzio DiMarca estaba preparado para darle una completa explicación al gobernador pero fue rápidamente interrumpido por la Concejal Nilka Álvarez-Rodríguez, diciendo que todo estaba bajo control desde la visita de ACLU.

Fue muy refrescante saber que el gobernador “no abandonará a Lawrence”, y planea traer, por lo menos una de las compañías de bio-tech que él está promoviendo a Lawrence. Pero eso todavía está en la mesa de dibujo y debimos decirle al gobernador acerca de lo inseguros que se sienten nuestros trabajadores de la Malden Mills. Primero, tenemos que asegurar lo que tenemos, antes de soñar despiertos acerca del futuro.

No podemos darnos el lujo de desperdiciar más oportunidades.

### A GOLDEN OPPORTUNITY, MISSED!

In his first visit to Lawrence after his election, Governor Mitt Romney visited an upscale restaurant to meet, over a private lunch, with Mayor, Michael J. Sullivan, the School Superintendent Wilfredo T. Laboy and a very exclusive circle of city officials. Members of the press were not allowed, well, I should say, Rumbo was told to “wait outside until they were finished.”

What a difference with the new Governor Deval Patrick’s visit! It was open to all the press and even when he came to meet with the people, there was no excuse for the mayor, the superintendent of schools and the chief of police for not being there.

More than 300 people packed the center and many of them bombarded the governor with legitimate concerns. Unfortunately, two important issues, Malden Mills were not mentioned and police brutality was quickly brushed under the rug when Alicia Lugo brought it up. Councilor Nunzio DiMarca was getting ready to give an earful to the governor but he was quickly interrupted by Councilor Nilka Alvarez-Rodriguez, saying that everything was under control since the ACLU visit.

It was refreshing to know that the governor is “not giving up in Lawrence”, and plans to bring at least one of the bio-tech companies he is proposing to Lawrence. But that is still in the drawing board and we should have let the governor know about how insecure our workers from Malden Mills feel. First, we must secure what we have, before day dreaming about the future.

We cannot afford to miss any more opportunities.

## BEATRIZ PEREZ: Gobernador Patrick escucha A residentes del Valle

En dicha reunión Deval Patrick escuchó por espacio de una hora las quejas y preocupaciones de muchos de los presentes, tópicos que iban desde la brutalidad policial, hasta la falta de alternativas que permitan a los jóvenes realizar actividades de recreación.

El gobernador fue recibido en el Lawrence Senior Center por una significativa cantidad de personas que estaban ansiosas por presentar sus quejas a Patrick y por varios oficiales electos locales y estatales.

Sin embargo el gran ausente fue el alcalde de la Ciudad Michael J. Sullivan, la que generó algunos comentarios negativos entre los asistentes.

En un breve discurso del gobernador ante los asistentes, el ejecutivo estatal, se refirió a los principales temas que fundamentaron su campaña y que ha puesto sobre el relieve durante su gestión, así como sus proyecciones para mejorar el status de vida de los habitantes de este estado.

Estos temas están enfocados hacia el aspecto laboral; un nuevo sistema de seguro de salud, el medio ambiente, haciendo hincapié en la promoción de la limpieza y la utilización de fuentes alternativas de energía.

Uno de los temas más controversiales de esa noche fue el concerniente a las denuncias sobre el maltrato policial, algunos de los cuales han sido denunciados por personas que alegan haber sido abusados física y verbalmente por algunos oficiales de policía.

Con relación a este tema el Gobernador dijo desconocer que esto estaba pasando en esta ciudad y de inmediato estableció la posibilidad de que algunos miembros del Concejo Municipal presentes hicieran algún comentario sobre el tema; lo que evidenció una ignorancia total lo que ha estado ocurriendo en la ciudad sobre el particular.

La Concejal At-Large Nilka Álvarez, de inmediato reaccionó diciendo que este problema estaba en vías de solucionarse y que el Concejo había tomado cartas en el asunto.

No obstante, a esta aseveración, muchos de los asistentes consideraron que el problema realmente apenas empieza, aduciendo el hecho de que hasta el momento el jefe de la policía, John Romero, no se ha

ocupado de pronunciarse sobre el tema, pese a las frecuentes denuncias sobre la brutalidad policial y de que el mismo ha llegado hasta la corte, incluyendo una demanda que la ciudad enfrenta por dos millones de dólares.

En tanto, la educadora María De la Cruz se refirió a la frustración que siente ante la falta de oportunidades para que los jóvenes realicen de actividades de recreación bajo techo.

Luego de escuchar la exposición de la educadora, el gobernador tomó la decisión de crear un comité integrado por seis personas, el cual se encargará de estudiar esta problemática, buscar vías que conduzcan a su solución, y explorar los pasos que hay que dar para ello.

Otra de las quejas estuvo dirigida a las dificultades que enfrentan ciertas personas al llenar una solicitud para el seguro de salud, ya que la misma y el proceso a seguir resultan muy complicados.

Finalmente otro de los tópicos tratados y presentados al gobernador estuvo dirigido a los costos elevados que pagan los residentes por el servicio de calefacción.

## No hay justicia en las Escuelas Públicas de Lawrence

Laboy sacó a través de la Internet de Nova University) y ella es la que sale despedida. ¿Cuántos estudiantes usted conoce que se gradúan de Harvard y regresan a Lawrence a enseñar?

# Mayo es el Mes Nacional de Crianza Temporal

## IRS RECUERDA A PADRES DE CRIANZA QUE PODRÍAN SER ELEGIBLES PARA CRÉDITO TRIBUTARIO POR INGRESO DEL TRABAJO

Siendo Mayo el Mes Nacional de Crianza Temporal, es conveniente recordar a familias trabajadoras que han aceptado en sus hogares a un menor con la generosidad de su corazón pero también con ciertas limitaciones económicas, que podrían ser elegibles para recibir el Crédito Tributario por Ingreso del Trabajo (EITC).

El EITC beneficia a familias trabajadoras que necesitan ayuda adicional para que les alcance el dinero. Para las declaraciones del 2006, el Crédito Tributario por Ingreso del Trabajo proporcionó un beneficio reembolsable de hasta \$4,536 para familias calificadas. Sin embargo, puede que muchos padres de crianza no sepan nada del EITC o que no lo reclamaran porque no sabían cómo hacerlo. Por suerte, aún están a tiempo de solicitarlo e incluso puede hacerlo gratis y electrónicamente a través del servicio de Free File en [www.irs.gov](http://www.irs.gov).

“En necesario alertar a las personas que no sabían que tenían al IRS extendiéndoles una mano y también a aquellos que están considerando compartir su cariño y su techo con uno de los 92,000 niños hispanos en el sistema de crianza temporal o foster care”, dijo Sara Eguren, portavoz del Servicio de Impuestos Internos (IRS).

El EITC es llamado crédito por “ingreso del trabajo” porque el solicitante debe haber trabajado y obtenido ingresos. El límite máximo de ingresos es \$38,348 para un matrimonio que declara conjuntamente con más de un niño calificado, incluyendo hijos de crianza, sin incluir en esta cifra los pagos exentos de impuestos por cuidados de hijos de crianza. Para efectos de este crédito, un hijo o hija de crianza es cualquier menor colocado en un hogar por una agencia

autorizada o un tribunal.

Para 2005, 22 millones de declaraciones recibieron más de \$41 mil millones en EITC. Sin embargo, el IRS también calcula hasta 25 por ciento de todos los contribuyentes elegibles para este programa no reclama el crédito tributario.

Quienes califiquen deben cumplir ciertos requisitos y presentar una declaración de impuestos, aunque no estén obligados a hacerlo debido a que no ganaron lo suficiente, y tener un número de seguro social válido. Existen límites de edad, reglas de residencia, y normas en caso dos o más personas tengan el mismo hijo calificado y deben decidir quién reclamará los beneficios. El EITC no afecta la mayoría de beneficios de bienestar social.

Pagos por Adelantado del Crédito Tributario por Ingreso del Trabajo

El pago por adelantado del EITC (AEITC) permite a ciertos contribuyentes recibir su EITC a plazos a lo largo del año, hasta por un monto de \$1,712, en lugar de una cantidad global durante la siguiente temporada de declaraciones.

Para solicitar el AEITC, los contribuyentes deben:

- Esperar que sus ingresos para 2007 sean menos de \$33,241 ó \$35,241 si es casado y declara conjuntamente;
- Tener por los menos un niño calificado;
- Calificar para el EITC; y
- Completar la Forma W-5SP, Certificado del Pago por Adelantado del Crédito por Ingreso del Trabajo.

# 41 centavos no es barato

Es muy posible que la mayoría de los americanos simplemente se encojan de hombros cuando el precio de la estampilla de 39 centavos salte a los 41. Después de todo, ya tenemos la "Forever Stamp" que favorece al consumidor, y finalmente, ¿qué son 41 centavos cuando nos gastamos tan fácilmente tres o cuatro dólares en una taza de café espumoso y caliente?

Sin embargo, esos 41 centavos no le van a parecer baratos al cliente del USPS (Servicio Postal de Los Estados Unidos, por su sigla en inglés), cuando se entere que cada estampilla "First-Class" ayuda a pagar la entrega de correo-basura, publicidad, publicaciones periódicas, correo priorizado y la mayoría de las otras clases de correo que existe.

El más reciente Estado Financiero del USPS, correspondiente al año fiscal 2006, contiene algunas cifras que dejan a uno en la perplejidad. En particular, hay una estadística que la llaman "cobertura de costos", que debería llamar la atención de toda persona que se encuentre en la cola en una oficina del correo.

La "cobertura de costos" es simplemente el resultado de la división entre el dinero que ingresa, por concepto de un producto; dividido por los costos que se le atribuyen al proceso y entrega de ese mismo producto. El correo de Primera Clase, -el que utilizamos para enviar invitaciones de matrimonio, para pagar las cuentas, y para enviar esas reliquias del pasado, las cartas escritas a mano- tuvo un costo promedio de 157%. Entonces, en este caso, por cada 100 dólares que se gastó en correo Primera Clase, los consumidores pusieron 157 dólares.

El servicio de paquetes apenas cubrió sus costos, con un 106 por ciento. El correo regular o estándar, el que nos trae todo lo menos útil, tuvo un cobertura del 150%. Por otro lado, las publicaciones periódicas, fueron las que remolcaron al sistema. Tuvo una cobertura de costo que promedia el 86%, esto indica que lo que pagaron los usuarios de este rubro que sirve para envío de revistas y otras publicaciones, fue inferior a lo que costó enviarlas y entregarlas.

Todo esto quiere decir que los 41 centavos que estamos a punto de pagar por la nueva estampilla de correo de Primera Clase, irán a ayudar a pagar el transporte y la entrega de correo inútil, publicidad y catálogos, que quizá ni siquiera queremos recibir.

Los leales servidores públicos del USPS, han anunciado recientemente que van a expandir sus servicios "Priority" y "Express" al mercado internacional. Aunque ellos lo plantean como algo que simplifica la vida del consumidor, las expansiones de servicios de correo internacional son problemáticas.

Históricamente, las finanzas del correo internacional, han sido guardadas en secreto por la administración postal. Aunque, las cifras de cobertura de costos para el correo internacional, están disponibles (se

quedan bastante por detrás de Primera Clase), la administración ha mantenido la información sobre estos productos, bajo una política de presentarla cuando "se necesita conocer".

En cualquier caso, dados los tremendos costos asociados con la entrega de correo internacional, hace falta preguntarse si esta será otra aventura subsidiada por nosotros, los clientes del monopolio del servicio de Primera Clase.

El correo internacional es solamente otro ejemplo de los frustrantes informes financieros del USPS, que se caracterizan por ser poco claros. Muchas personas que hacen seguimiento cercano al gobierno, se escandalizan con el hecho de que el Servicio Postal atribuye solamente un 56% de sus costos a gastos específicos, mientras el resto se incluye en "gastos generales". No sorprende que los precios sigan subiendo, cuando más de un 40% de los gastos del USPS no son atribuibles a algo en particular.

A pesar de que el tema de los costos no-atribuidos, fue reconocido como una fuente de "insatisfacción generalizada", por el propio Presidente del Directorio del USPS, James Millar III; el USPS ha insistido en llevar adelante cuestionables estrategias de marketing como el auspicio a deportes y la campaña de Guerra de las Galaxias, donde los buzones de correo se parecen al personaje-robot R2D2.

Por supuesto que tales campañas pueden ser entretenidas, pero no son la forma en que el Servicio asuma el control de sus gastos, donde ahora necesita elevar precios al consumidor. Además, el Servicio de Postal ha sido muy resistente en presentar los costos específicos de tales campañas promocionales y auspicios.

Por eso, esta semana, cuando usted reciba en su correo otro montón de de papelería inútil, considere la posibilidad de que la carta de la abuela, con su flamante estampilla de 41 centavos, haya aportado a pagar ese montón de propaganda de tarjetas de crédito y otras cosas que llamamos "correo basura".

The Willing Shepherds of Jesus Christ, Chapter of the Order of Saint Dominic that recently moved into the Sacred Heart Church in Lawrence opened a gift store in the Rectory with religious gifts (statues, medals, rosaries and holy water fonts, spirituals, crucifixes, etc.) and excellent books on the saints and faith.

Sr. Mary Bernadette and Sr. Tracy were greeting visitors attracted by the handmade sign on the sidewalk on S. Broadway pointing to the gift store. Saturday, May 12 was the grand opening and a constant streaming of customers kept them busy all afternoon. Sr. Bernadette, a perfect mix of hostess and sales clerk, proudly explained that some of the rosary beads for sale (already blessed) were made by her mother.

When Br. Gerard Francis offered me a tour of the church I was not prepared for the emotions that would invade me. Entering the church brought me back to my last days in Cuba when the Revolution destroyed the church where we used to go as a child, dumping the statues into a truck.

The Roman Catholic Archdiocese of Boston is in such a financial mess that they had to close it down and sold the entire property consisting of five buildings to ETC Development Corp. of Boston. In order to prevent it from being used as a church again, they destroyed the marble altars and statues. The pews and windows were taken out and it is awfully sad. This beautiful, enormous church was gutted but this time it was done by the Archdiocese. Who would have thought that the Archdiocese would destroy one of its own churches?

My heart sank as I approached the main altar with its shattered marble panels. Someone had taken a sledge hammer and crushed anything of religious significance. The statues were torn away from the walls taking with them part of the architecture.

This all happened within the past two years. Now this Dominican Order wants to restore it and bring back the old-style

masses but the Catholic Church doesn't consider them part of it because they don't follow the changes brought on by Vatican II.

My time spent in the gift shop was well spent, watching the number of people coming in happy to have seen the sign on the sidewalk. Three old friends started a lengthy conversation not having seen each

other for a while since masses stopped at Sacred Heart. Suddenly, the mellifluous sound of the church bells began to chime and all the brothers and sisters went outside to sing in celebration. They had been trying to make them work for the past two months and finally figured it out. It was a magical moment for them that I was fortunate to capture.

The repairs are so extensive that they are not sure how long it will take for the funding to be raised and the work to be done. Meanwhile, they are happy to show anyone the conditions of the church because they need all the help they can find in order to turn it back to what that magnificent structure was meant to do: to unite us all with God.

# “Palos y piedras pueden romper mis huesos...”

...pero las palabras nunca me herirán.” ¿Cómo dice? Cuando escribí recientemente un artículo sobre Newton Gingrich y su torpe manejo de la palabra “ghetto” como atributo de algunas comunidades de habla hispana no esperaba una secuela. Creí que el uso ofensivo de palabras inútiles como tema había llegado a su fin, hecho, “finito,” y que cualquier discusión ulterior no era necesaria. Supongo que me equivoqué una vez más. Bueno, los mejores bateadores de pelota dan un hit una de cada tres veces que van al bate para alcanzar un average de trescientos, entonces ¿qué es tan malo para el mío?

Los comentarios de ese hombre dieron el blanco con el diagnóstico sino el estereotipo de la causa de los fracasos de los latinos en la educación, los trabajos y la civilidad de acuerdo con su punto de vista. Nosotros vivimos en grupos.

Pero otros que usan un idioma diferente al inglés en sus hogares, tal vez hasta votan en las elecciones usando boletas en lengua extranjera, se hubieran ofendido también o haber sido más comprensivos si no simpatizantes de nuestros sentimientos y podían haber expresado esa simpatía. Nada de eso, y me rasqué la cabeza varias veces tratando de figurar el por qué. ¿Estarían demasiado ocupados?, me pregunté. ¿No se habían dado cuenta? ¿Se les escaparon

las implicaciones para nosotros y para ellos también? Yo estaba confuso pero les di el beneficio de la duda.

Los desafortunados comentarios de Don Imus sobre un grupo de mujeres jóvenes jugadoras de baloncesto del equipo de la Universidad de Rutgers en New Jersey no mucho después del comentario sobre el “ghetto” de Gingrich fueron evidencia ulterior de nuestra falta de conexión entre nuestros cerebros y nuestras lenguas o, ¿lo estamos? Repentinamente las razones del silencio por parte de aquellos que oyeron la balada de ghetto del Dr. Gingrich se hizo bien clara para mí. Estamos hablando de ignorancia aquí, señores. Y esa no es toda la enchilada; hay salsa racial e indiferente mezclada con ella también.

Desafortunadamente los eventos trágicos de Virginia Tech y los consecuentes comentarios y soluciones fáciles para evitar tragedias similares me dieron un piñazo en el estomago y me vi obligado a expresar mi punto de vista entonces, pero estoy montando de nuevo la montura del “ghetto” como se dice. Por favor, ¿montarían ustedes conmigo una vez más?

¿Por qué ignorancia, se preguntará usted? En el instante que escuché las infames palabras describiendo a las jugadoras de baloncesto como “nappy headed hors” me hice de tripas corazón tratando de averiguar lo que en verdad significaban semántica y emocionalmente. Confieso que no lo sabía.

Yo he estado en este país desde 1962, tengo una educación decente, he leído mucho por décadas y he escrito mucho por los últimos once años. Además, he participado en muchas actividades y proyectos que tratan de acercarnos sin importar nuestra raza, nuestra religión, nuestra política, nuestra diferenciación de género u orientación sexual, pero esas tres palabras no significaban nada para mí. Estaba insensible y confuso, no siendo capaz de entender qué era y porqué se había formado ese lío. Esa es la triste noticia.

Desde luego, la buena noticia es que jamás había usado u oído esas palabras en mi ambiente anteriormente. La mala noticia es que no sabiendo lo que significaban

podían haberme convertido en cómplice silencioso de la ofensa simplemente porque no podía reconocerla desde el principio, la podía ignorar y no era capaz de hacer algo para arrestarla. Buscando por expresiones de indignación en la programación de la radio y la televisión hispanas sin encontrar alguna (nuestro periódico Rumbo sí lo mencionó editorialmente y no tengo manera de confirmar toda excepción adicional) me hizo preguntar si la ignorancia no era solo mía.

¿Fue esta situación reciente similar al silencio a los comentarios del Dr. Gingrich que fueron la reacción de nuestros amigos e iguales en medio ambiente? ¿Estamos divididos por ríos de separación que claman por la edificación de puentes de entendimiento? ¿Nos perdimos la barca por que no sabíamos que había navegado?


Sabiendo que la única pregunta estúpida es la que no se hace, como siempre digo a mis alumnos, me olvidé de mi sentido de vergüenza y comencé a buscar por una explicación haciendo la pregunta específicamente a una amiga que se dedica al campo de la diversidad. forma ofensiva y derogatoria de describir el cabello de los afro-americanos. La tercera palabra es todavía más ofensiva en que su intención era describir el mismo sonido de un equivalente de la palabra prostituta que no se puede publicar. Ahora bien, quién en su mente lógica y normal es capaz de describir a un equipo femenino de jóvenes estudiantes jugadoras de baloncesto usando esas palabras se me hace incomprensible.

La reacción de indignación a las palabras del señor Imus fue instantánea, como lo fueron las palabras de aquellos que lo condenaban a una desaparición de las ondas radiales como eventualmente ocurrió. Pero este artículo no es sobre el señor Imus. Parece que el famoso personaje de radio y televisión había acumulado por sus buenas obras en su vida personal y profesional suficientes indulgencias que le garantizarían un asiento de primera fila en el paraíso. Ese era el lado positivo.

Es decir, desde el principio, el rasero que se usó para determinar su último destino

“Today I say,” said the Governor talking to Lupoli, “that one of these companies will move into your building.”





## There's no justice at Lawrence Public Schools

A few days ago I received an email regarding the case of Nicole Shadeed, the Lawrence High School teacher who wrote a Letter to the Editor of the Eagle-Tribune and soon thereafter received a pink slip.

In her letter, Ms. Shadeed was critical of the way things are in the Lawrence school system and, if you open your mouth with the truth in the Lawrence School Department, you get fired.

Nicole Shadeed, a Lawrence bred student came up through the Frost School and LHS where she was Valedictorian of her class in 2000. She was a brilliant student and went to Harvard University, got a real Ivy League degree (unlike School Superintendent Wilfredo T. Six teachers were let go at Lawrence High the Friday before vacation. Laboy likes to let them go just before they go on vacation. It has a tremendous psychological impact on the rest of the staff.

### Laboy thinks he's Donald Trump

Meanwhile Mayor Michael J. Sullivan states that the School Committee has no say in these matters because since the Education Reform Law of 1993, that power has been taken away from local school committees. It's true. Laboy can let teachers go who don't have professional status and he doesn't have to give a reason. He is allowed to do that by the Education Reform Law. He loves to hire and fire. There are all sorts of problems with Ms. Rice. I guess in Lawrence it's who you know and she is Mayor Sullivan's girlfriend. She is making life miserable for the students and teachers at the Bruce School. She is making teachers in the lower school collect all kinds of statistics, fill out all kind of charts, and complete all kinds of forms, then she is passing in all this material as her Master's project.

The current Bruce School principal (loved and respected by the staff) is William Sullivan and people believe that he is afraid of Kristin because she constantly drops the mayor's name and threatens to "call Michael." I met him during my days in the school system when my favorite school to visit was Bruce. The staff there was wonderful and many still remain to this day.

Laboy is doing this strictly because she's the Mayor's girlfriend. What I hear from my friends is that she holds the record for most grievances in the shortest amount of time.






## “Sticks and stones may break my bones...”

...but words will never hurt me.” Are you kidding? When I wrote a recent article about Newton Gingrich and his mishandling of the word “ghetto” as an attribute of some Spanish-speaking communities I did not expect to write a sequel. I thought the offensive use of useless words as a subject was finished, done, “finito,” and further discussion was not necessary. I guess I was wrong one more time. Well, the best baseball batters hit one out of three to be in the three hundreds, so what is so bad about me?

I had mentioned briefly in that article my inability to discern any message of support for Latinos from other language communities. I suppose it did not surprise me that the English literate population was satisfied that Dr. Gingrich was not talking about them, just about us, so why bother? The man’s comments were on target with the diagnosis if not the stereotype of the cause of Latino failures in education, jobs and civility as they saw it. We are “groupies.”

But others who use a different language at home, maybe even vote using foreign language ballots in elections, might have taken offense or be more understanding if not sympathetic to our feelings and could have expressed that sympathy. No such thing and I scratched my head several times trying to figure out why. Were they too busy? I asked. Were they unaware? Did they miss the implications for us and for them as well? I was confused but I also gave them the benefit of the doubt.

The unfortunate comments of Don Imus about a group of young women basketball players from Rutgers University, New Jersey, not long after the “ghetto” thing from Dr. Gingrich were further evidence that we seem to be disconnected between our brains and our mouths or, are we? Suddenly the reason for the silence of those who heard our ghetto ballad from Dr. Gingrich became crystal clear to me. We are talking about ignorance here folks. And that is not the whole enchilada; there is racial and indifference salsa to go with it as well.

Unfortunately the tragic events of Virginia Tech and the aftermath of commentaries and easy solutions to avoid similar tragedies hit me in my teaching gut and I felt compelled to express my point of view at the time, but I am back on the “ghetto” saddle so to speak. So please, would you ride with me once more?

Why ignorance you may say? The moment I heard the infamous three words describing the basketball players as “nappy headed hors” I found myself wondering what they really meant semantically and emotionally. I confess that I did not know. I have been in this country since 1962, have a decent and varied education, have read for

decades and have written much for the past eleven years and I also have participated in many activities and projects that try to get us closer together regardless of race, religion, politics, gender or sexual orientation but the three words meant nothing to me. I was insensible and confused, not being able to understand what the big fuss was all about. That is the sad news.

Of course, the good news is that I had never used or heard those words in my environment before. The bad news is that not knowing what they meant could have made me silent accessory to the offense simply because I could not recognize them from the get go, ignored them and did nothing to stop them. Looking for expressions of outrage or condemnation from Spanish radio and television programs about the Imus incident and finding none (our Rumbo paper picked it up editorially, and I have no means to note any other exception) made me wonder if the ignorance was not mine alone.

Was that situation similar to the silence to Dr. Gingrich’s ghetto remarks that were the reaction of our friends and equals in background? Are we divided by rivers of alienation that are crying for bridges of understanding? Did we miss the boat without realizing it had sailed?

Knowing that the only stupid question is the one that never gets asked, as I always tell my students, I broke through my sense of embarrassment and went looking for an explanation and posed the query specifically to a friend who is in the business of diversity full time. The first part of the expression, “nappy headed”, is an offensive and derogatory way to describe the hair of African-Americans. The third word was still more offensive where the intention was to describe the same sound as an unprintable equivalent of the word prostitute, “whores” in plain English. Now, who in his right mind is willing to describe a team of young university female students using those words is beyond my comprehension.

The reaction of outrage to Mr. Imus words was instant, and so were the words of those who were condemning the man to air wave’s oblivion as it eventually happened, but this article is not about Mr. Imus, not at all. It seems that the famous radio and television personality had accumulated enough good deeds and indulgences in his professional and personal life to earn him front seat in paradise. That was the positive side.

So from the beginning, the leveler that was used to gauge his ultimate destiny went from hell to heaven and back again, and giving him a second chance (this was not the first serious incident in his program) became a plausible option, the forgiving alternative so to speak.

Unfortunately, and probably deservedly for Mr. Imus, the problem was not the words alone. It seems that his long standing career of contractual irreverence was not the issue, and neither was his recognized continuous concern for children and wounded veterans of war and others. According to Mark Twain, the famous American author, “Irreverence is the champion of liberty and its one sure

defense.” Would Mr. Twain have gone so far these days?

Mr. Imus had become the poster boy for anyone’s right to use profanity in public radio and television stations and channels to offend someone else. So only one basic question drove this process: Should anyone’s famous acknowledged economic and charitable contribution to society be an excuse to forgive that anyone for offending other people’s good names and reputations? Should welfare be the measure we use to judge others’ behavior? Should that measure allow you to get away with murder?

The staple source and destination of this type of conduct is not only the one that says that my race is better than yours. It is the one that says that my gender, my religion, my ethnicity, my language and my-anything-else I want to use is better than yours as well. It separates us. We live under the constant illusion that it is not our basic humanity that is full of foibles, but the clothing in color or gender that dresses that humanity that does. So I am bad or funny because I have an accent; stand, kneel, seat or lie down when I pray to God; or because I look different from my neighbors. The descriptive rungs on the ladder that we have to use to climb to make war to each other start with those silly notions. The killing appears at the end.

They become rationalizations and justifications to destroy each other later on. If you think that starting a war in Iraq was not founded on the basic belief that

we were better than them, then think again. Just look at the metamorphosis of reasons of the past four years. We have to be sensitive to the wounds of those who claim to be wounded. We must know what those lesions are and how to protect them from bleeding any further. Never mind that we don’t understand the causes or think they don’t apply to us. Whether it is a ghetto term tagged on those who get closer to each other because they need company, feel alone or want to be with their families and friends we should not allow words to be the measure of our differences. At least not the ones used to demean others we don’t know or understand.

Now that you know what the words mean, would you have liked to see your daughters or sons described as “nappy headed hors” by any big shot? Would you have allowed it because those celebrities are economically or intellectually prosperous? Why then did we remain silent and let it fester without joining the chorus of those who saw abuse and violation in those words from the get go? And, what are we going to do tomorrow when we see it happen again? Will we let it rain because it is not on our parade? No, sticks and stones will hurt my bones, but words will add insult to the injury.

A few hours before his death, Dr. Martin Luther King claimed to have seen the Promised Land from his mountain. For our own good, I hope he was right. And that is my Point of view today.

# The 41-cent Stamp—Not So Good a Deal After All?

Most Americans will likely shrug their shoulders when stamp prices jump from 39 to 41 cents this week [May 14]. After all, we already have the consumer-friendly "Forever Stamp." And what's 41 cents when many of us could easily spend three or four bucks on a lukewarm cup of foamy coffee?

But 41 cents may not seem like such a bargain for postal consumers when they learn that each first-class stamp subsidizes the delivery of junk mail, periodicals, priority mail and most other classes of mail.

The latest financial statements from the Postal Service, for fiscal year 2006, contain some startling figures, particularly regarding a statistic called "cost coverage," that ought to make anyone who stands in lines at post offices take notice.

Cost coverage is simply the amount of revenue taken in from a particular product divided by the costs attributed to processing and delivering that product. First-class letter mail—the mail we use for wedding invitations, bill paying, and that old relic the handwritten letter—had a cost coverage of about 157 percent. So in this case, for every \$100 attributed to first-class mail's costs, consumers provided \$157 of revenue. Does that sound like a good deal to you?

Package services barely broke even, with a coverage of only 106 percent. Regular standard mail—or more affectionately, junk mail—had a coverage figure of 150 percent. And periodicals actually dragged on the system. With a cost coverage of 86 percent, the fees paid by mailers to send magazines and other periodicals were actually less than the amount required to deliver them.

All of this means that a big portion of the 41 cents we're about to drop on a first-class stamp will help pay for the delivery of catalogs and junk mail that we may not want in the first place.

The loyal public servants who run the Post Office also recently announced that they would expand the familiar

priority and express classes of mail into the international market. Although they describe it as a simplification for consumers, expansions into the international market are actually troubling.

Historically, postal management has kept the finances of international mail shrouded in secrecy. Although cost coverage figures are available for international mail (it trails First Class substantially), postal management has kept most data for these products on a strict "need to know" basis.

In any event, given the tremendous costs associated with international delivery, it's important to wonder whether this expansion will be yet another venture subsidized by we consumers of the Postal Service's first-class mail monopoly.

International mail is just one example of the Postal Service's frustratingly cloudy financial reports. Many who follow government closely have expressed dismay with the fact that the USPS only attributes 56 percent of its costs to specific expenses, while the rest are termed as general "overhead." It's no wonder that prices continue to rise when over 40 percent of the Postal Service's expenses are not attributed to anything in particular.

Despite the row over unattributed costs, which even USPS Board of Governors Chairman James Miller III acknowledges as a source of "widespread dissatisfaction," the USPS has pressed ahead with such dubious marketing ploys as sports sponsorship and the Star Wars campaign where it painted mailboxes to look like the character R2D2.

Granted, such campaigns may be entertaining, but they are no way for the Postal Service to gain a hold on the runaway costs that necessitate rate hikes. And USPS has been less than forthcoming with the specific costs associated with its sponsorships and promotions, declaring them "proprietary."

So this week, when you open your mailbox to find yet another round of junk mail, consider the possibility that your letter from Grandma with the new 41-cent stamp affixed to it may have helped deliver a new stack of credit card applications and advertising.




