

Incendio en casa de Pedro Sabino

“Estábamos en la iglesia cuando nos llegó la noticia de que había fuego en nuestra casa”, dijo Pedro Sabino cuando habló con Rumbo por teléfono. “Imagínese, llegar allí y encontrar que su casa está ardiendo y está rodeada de aparatos de incendio”.

Pedro Sabino, conocida personalidad de la radio, que produce el “Noticiero Panamericano” de lunes a viernes por WCEC-1110-AM de 12 del mediodía a 1 de la tarde, rentaba el primer piso de la casa situada en el 1062 de la Calle Essex, esquina con la Nesmith.

Sabino y familia (esposa y dos jovencitas de 11 y 13 años) están viviendo temporalmente en un hotel.

De acuerdo con el reporte del Departamento de Incendios el fuego comenzó en el ático y se expandió hacia el cielo raso y las paredes del segundo piso, “allí es donde el fuego causó más daño. Nuestro daño fue causado más bien por agua, por lo que pudimos salvar algunos muebles, ropas, libros y electrodomésticos”, dijo Sabino, que en el presente se encuentra buscando un apartamento para mudar a su familia.

Fire at Pedro Sabino's house

“We were all in church when we were told that our house was on fire”, said Pedro Sabino when he spoke to Rumbo by phone. “Imagine, getting there to find your house on fire and surrounded by fire apparatus.”

Pedro Sabino, a well known radio personality, who produces “Noticiero Panamericano” from Monday through Friday by WCEC-1110AM from 12Noon to 1:00P.M., used to rent the first floor at 1062 Essex at the corner of Nesmith St.

Sabino and his family, (wife and two daughters, 11 and 13) are living in a hotel

temporarily.

According to the Fire Department report, the fire started in the attic and spread to the second floor ceiling and walls. “That is where most of the fire damage is. Our damage was caused by water. We were able to save some furniture and clothes, books and appliances”, said Sabino who at the present time is frantically looking for an apartment to move his family into.

The fire caused \$100,000 in damages and is under investigation, according to the Fire Department report.



EDITORIAL

CANSADOS DE LAS MENTIRAS DE LABOY

En la reunión del Comité Escolar de Lawrence del jueves pasado, fuimos testigos del más vergonzoso despliegue de demagogia por parte del Superintendente Escolar Wilfredo Laboy. Al final de su sermón lo único que faltó fue un “¡Aleluya!” de la audiencia pero parece que ellos se están espabilando y se dan cuenta de sus mentiras como la mayoría de nosotros.

Hubo toda clase de fallos en sus comentarios con respecto a los “estudiantes recién llegados” y la Escuela Internacional. Conocemos a un muchacho de 16 años de edad a quien le han negado entrada en el sistema escolar por año y medio. En una reciente reunión con la directora de la Escuela Internacional y algunos padres, un estudiante dijo que su maestro ha recomendado varias veces que sea transferido a otra academia pero eso es imposible.

Sabemos de muchos estudiantes de 18 años de edad que están siendo obligados a tomar el examen de GED en español para deshacerse de ellos. Les daremos más ejemplos la semana próxima pero por ahora debemos enfocarnos en las acusaciones personales que Laboy ha lanzado en contra de nosotros.

Laboy acusó a Rumbo de no imprimir una carta que nos envió y que fue publicada por otros dos periódicos. Si a Rumbo le hubiese sido permitido entrar al Salón del Comité Escolar, hubiésemos podido responderle que él nunca nos mandó tal carta. Tenemos posesión de ella porque tan pronto como la recibieron otros miembros de la facultad, varias personas nos la enviaron. Inclusive hablamos de ella en nuestro programa de radio el pasado viernes y dijimos que era una vergüenza que estando en la industria de la educación, no dejó que por lo menos una secretaria se la chequeara. Esa carta simboliza el por qué Laboy no pudo pasar el examen de inglés que hizo noticia a nivel nacional.

Como esa carta no fue enviada a nosotros para ser publicada, no nos vimos en la obligación de hacerlo (a menos que fuera con la intención de abochornarlo), pero si lo hubiese hecho, con gusto que le daríamos todo el espacio que requiera.

TIRED OF LABOY'S LIES

At Thursday's Lawrence School Committee meeting we witnessed the most shameful display of demagoguery from the Superintendent of Schools Wilfredo Laboy. At the end of his disgraceful preaching the only thing missing was a loud “Alleluia!” from the audience but they are probably getting smart and could read through his lies like most of us.

There were all kinds of gaffes in his statements regarding the “newly arrived students” and the International School. We know a 16-year-old boy who has been refused admission in the school system for one and a half years. At a recent meeting with the International School principal and some parents, a student said that his teacher had recommended several times that he should be transferred out into another academy but that is impossible.

We heard from many 18-year-olds who are being forced to take the GED exam in Spanish to get rid of them. We will give you more examples next week but for now we must focus on the personal accusations Laboy launched against us.

Laboy accused Rumbo of not printing a letter he sent us and that was published by two other newspapers. Had Rumbo been allowed to enter the School Committee Room, we would have been able to yell right back that he never sent us such a letter. We had possession of it because as soon as it was sent to the staff, several people forwarded it to us. We even talked about it on our radio show last Friday and we said that it was a disgrace that being in the business of education, it was not proofread by at least a secretary. That letter symbolizes why Laboy could not pass the English test that made news nation wide.

Since that letter was not sent to us for publication, we didn't feel the obligation to do so (unless it was for the purpose of embarrassing him), but if he had done so, we would gladly give him all the space he requires.

En 1911, el Reverendo William E. Wolcott, el Pastor de la Lawrence Street Congregational Church en Lawrence, Massachusetts, legó una colección de diecisiete pinturas de impresionistas americanos y europeos del siglo XIX a la White Fund de Lawrence. La colección, que incluye pinturas por Claude Monet y Camille Pissarro, está actualmente siendo mostrada en el museo hasta el 31 de julio en una exhibición titulada El Legado Impresionista: Las Pinturas de la White Fund de Lawrence.

La exhibición marca la primera vez en casi 100 años que esta colección especial ha estado en exhibición en el Valle de Merrimack y para celebrar el acontecimiento, la organización Artes Para Lawrence invitó a los miembros de la Iglesia de Dios a viajar el museo y aprender acerca del tesoro que poseemos.

El Rev. Wolcott estudió en Phillips cuando era un seminario y entonces fue a Lawrence donde él creó su primera iglesia la cual se perdió en un incendio. Su segunda iglesia es la actual que construyó frente a Lawrence High School y el Parque Campagnone conocida como Iglesia de Dios.

105 personas asistieron a esta sesión privada un sábado por la tarde con el Profesor David Meehan de Lawrence High School quien les explicó la historia de las pinturas y la contienda judicial que Artes Para Lawrence ganaron recientemente

contra la ex Alcaldesa Patricia Dowling y la Junta Directiva de la White Fund que estuvieron la idea de venderlos y utilizar el dinero para propósitos educativos.

Estas pinturas han de permanecer en el Museo de Bellas Artes en Boston hasta que un lugar seguro y conveniente pueda ser construido en Lawrence. Al visitarlos en Boston, las personas advierten la inscripción que dice que ellos están allí "como préstamo de los residentes de Lawrence".



La seguridad durante la ola de calor

El atractivo del sol del verano a menudo puede opacar la preocupación por la salud cuando las temperaturas empiezan a elevarse. Richard Zane, MD, el vicepresidente del departamento de la Medicina de la Emergencia en Brigham & Women's Hospital, advierte a pacientes acerca de la oleada inevitable de enfermedades relacionadas al calor que ocurren durante los días de triples dígitos cuando el cuerpo calienta más rápido de lo que puede enfriarse. Desgraciadamente, muchos pacientes terminan en departamentos de emergencia con graves, pero evitables, enfermedades relacionadas al calor. El Dr. Zane está disponible para compartir información acerca de estas enfermedades y puntos para prevenirlos. ¡La estrategia más importante es la prevención!

Al dirigirse afuera al sol, el Dr. Zane ofrece estos consejos para su seguridad:

- Beba mucha agua, incluso si usted no se sienta sediento. La sed es una indicación tardía que su cuerpo está ya bajo en líquidos. Para ayudar la absorción, beba pequeñas cantidades frecuentes de agua o una bebida baja en azúcar (cerca de 8 oz por hora) en vez de cantidades grandes y

esporádicas.

- Evite las bebidas que lo deshidratan porque contienen alcohol, la cafeína o altas cantidades de azúcar.
- Lleve la ropa floja, ligera y de color claro y póngase un bronceador con un SPF de 15 ó más alto. Lleve un sombrero y busque sombra con un paraguas, si es posible.
- No tome tabletas de sal, que no reemplazan la pérdida de agua y pueden aumentar la presión arterial, irrita el estómago y afectan gravemente a las personas con una historia de enfermedades cardíacas.
- Quédese adentro por el calor del día, entre las horas de 10 de la mañana y 3 de la tarde. Limite las actividades al aire libre y el ejercicio físico a las horas de la mañana y nocturnas.
- Tenga cuidado especial verificando las condiciones de individuos que pueden estar en mayor riesgo de enfermedades relacionadas al calor: niños, los personas de edad avanzada, y las personas que tienen una enfermedad mental o están físicamente enfermas, especialmente los que sufren de obesidad, la enfermedad cardíaca o la hipertensión. Los pacientes que toman medicinas para enfermedades psiquiátricas o la hipertensión pueden estar en el riesgo particular para la hipertermia.
- El Dr. Zane aconseja a los pacientes que deben saber las señales de alerta de las

enfermedades relacionadas al calor para buscar el cuidado médico temprano si una enfermedad significativa está presente:

- El Sarpullido (fiebre miliar): Un sarpullido rojo o rosado es el resultado de los conductos bloqueados e hinchados de sudor; causa molestia y picazón.
- Caliente Edema (hinchándose): Las manos y los pies se hinchan después de permanecer parado o sentado por espacios de tiempo muy largos en el calor cuando los vasos sanguíneos se dilatan y la gravedad lleva los líquidos a las extremidades del cuerpo.
- Dolores Musculares: Pueden ocurrir en los músculos después de ejercitarlos en el calor si el cuerpo pierde el exceso de líquidos y electrolitos. Las señales incluyen los espasmos de músculo, músculos que se sienten débiles, duros o apelotonados, siente náusea y deseos de vomitar, debilidad y fatiga.
- Síncope (desmayo): Es típicamente el resultado del esfuerzo en un ambiente caliente. Las señales que indican un síncope de calor incluyen piel pálida, fresca y húmeda y un sentimiento del mareo, al cambiar especialmente las posiciones (moviéndose de acostarse a pararse).
- Agotamiento por Calor: Ocurre típicamente después del esfuerzo intenso y sudar mucho cuando el cuerpo no puede enfriarse suficientemente y como

resultado los órganos esenciales no reciben el flujo de sangre necesario. Los síntomas de agotamiento por calor pueden incluir sudor excesivo, piel fresca, húmeda, pálida o ruborizada, dolor de cabeza, mareo o debilidad y náusea. La temperatura corporal es generalmente cerca de lo normal. El agotamiento por calor es una condición grave que puede llevar a la parálisis. Una persona que experimenta agotamiento por calor debe ser velada muy de cerca y debe recibir atención médica.

- Ataque de apoplejía o parálisis (heat stroke): Esta es una enfermedad que amenaza la vida y requiere tratamiento de la emergencia. Busque ayuda inmediatamente si usted o un ser querido experimenta una temperatura corporal alta (hasta 105 grados), está ruborizado, caliente, tiene la piel seca sin sudor, vomita, tiene un pulso débil y rápido, no se ve alerta, pierde el conocimiento y tiene respiración superficial y rápido. La señal clave para distinguir el "heat stroke" de otras enfermedades moderadas de calor es un cambio notable en la posición mental (la desorientación, la confusión, el pensamiento dañado).

Salud financiera en todo momento

Ahora que las graduaciones de escuelas y universidades están en marcha, los estudiantes y sus familias por todos los Estados Unidos están eufóricos, debido a que la graduación representa un logro importante en la vida de cualquier joven. Las invitaciones para la ceremonia de graduación, la toga y el birrete, los planes para la celebración y otros detalles son las cosas que los graduados tienen en la mente, y todos los que participan están emocionados. - Abra una cuenta de cheques. Si un recién graduado no lo ha hecho todavía, ésta es una manera fácil de vigilar los gastos. Los cheques de pago se depositan directamente en la cuenta, lo que da la opción de tener acceso al dinero usando las tarjetas check card que el banco proporciona, y cuando se realizan las transacciones, el dinero se deduce automáticamente de la cuenta. Los alimentos, los muebles y

la ropa se pueden comprar utilizando una tarjeta check card. Asimismo, los padres pueden depositar dinero fácilmente en la cuenta.

- Abra una cuenta de ahorros. Separar dinero para el futuro o para acontecimientos inesperados lo protegerá contra una carga económica. Es tan importante planear para el futuro como lo es planear para el presente. Separar cualquier cantidad de dinero sí tiene una gran importancia.

El administrar un presupuesto, una cuenta de cheques y una cuenta de ahorros requiere del mismo grado de dedicación, ya sea graduado de la escuela secundaria o de la universidad. Un presupuesto tiene el propósito de mantener a una persona dentro de ciertos límites de gastos, pero sólo funciona si hay dedicación.

El completar la escuela secundaria o la universidad es un momento para celebrar, pero también es el principio de los próximos capítulos de la vida. Es bueno vivir y disfrutar hoy, pero si un graduado piensa a largo plazo y toma decisiones financieras sensatas cosechará más recompensas a la larga.

sólo interés y los de tasa ajustable con pagos opcionales, comienzan con mensualidades de bajo monto que en realidad pueden aumentar el capital.

6. EL PAGO DE MI PRÉSTAMO NUNCA VARÍA

Falso. Esto solamente es cierto para los préstamos a tasa fija y sólo para el capital e intereses; los impuestos y el seguro del propietario habitualmente aumentan cada año. Si no tiene un préstamo de tasa fija, su tasa de interés—y los pagos—aumentarán.

Es beneficioso hacer sus tareas. "La compra de una vivienda es una decisión emocional", dice Olson. "Determine cuánto puede pagar antes de empezar a ver viviendas, de modo de que la casa que lo enamore sea una que efectivamente usted puede afrontar con comodidad."

IRS Advierte Acerca de Nuevas Estafas por E-Mail

El Servicio de Impuestos Internos (IRS) alertó hoy acerca de las últimas estafas por "e-mail" que pretenden engañar a las personas, haciéndoles creer que están siendo investigadas por la división de Investigación Criminal de la agencia.

El e-mail, alegando ser de la Investigación Criminal del IRS, miente que la persona está siendo examinada criminalmente por presentar una declaración de impuestos falsa al Franchise Tax Board, (departamento de rentas internas) de California. El e-mail busca convencer a las personas de ingresar a un enlace incluido para más información acerca de la queja en su contra. El IRS advirtió que el enlace es un código maligno Trojan Horse que puede apoderarse del disco duro permitiendo a un tercero accederlo remotamente.

El IRS urgió no ingresar al enlace que aparece en el e-mail. Variaciones similares, dirigidas a empresas e individuos, sugieren que un cliente ha presentado una queja y que el IRS puede intervenir como árbitro.

"Todos deben estar alertas a estos estafadores", dijo Kevin M. Brown, Comisionado Interino del IRS. "Siempre ejercite cautela cuando reciba e-mail que no ha solicitado o mensajes de e-mail de quienes no conoce".

El IRS no envía e-mails sin que sean solicitados ni pide información personal o financiera detallada. Además, el IRS nunca solicita PINs, códigos de acceso u otra información secreta para ingresar a su cuenta de tarjeta de crédito, banco u otras cuentas financieras.

Quienes reciban e-mail sospechoso que afirma venir del IRS no deben abrir anexos ni enlaces. Deben enviarlo a phishing@irs.gov. El IRS también ve estafas por e-mail que engañan a víctimas

para que revelen información personal y financiera por Internet, que se conoce como "phishing", un juego de palabras en inglés por la pesca de información.

"Desde el año pasado, el IRS ha recibido más de 17,700 e-mail reportando más de 240 casos separados de 'phishing' e identificando fraudes en al menos 27 países, además de los Estados Unidos", comentó la portavoz del IRS Sara Eiguren.

El IRS y el Inspector General de la Administración de Impuestos (TIGTA) trabajan con el Equipo de U.S. Computer Emergency Readiness (US-CERT) y varios proveedores de servicios de Internet y equipos CERT internacionales que se aseguran de que los sitios de 'phishing' sean removidos en cuanto son reportados.

Otros fraudes tratan de que los contribuyentes ingresen a un sitio que usa el nombre del IRS y piden números de cuentas bancarias. Otro informa que el IRS le tiene un reembolso (usualmente \$63.80) y busca información financiera. Aun otro afirma que 'la comisión contra-fraudes' del IRS está investigando sus declaraciones de impuestos.

Article VI of the City of Lawrence Zoning Ordinance in its Section 29-20 regulates all about signs in the city. This sign is described in the Section A, article (13) as an Off-premise sign: "an off-premise sign is a sign which advertises or announces a use conducted or goods that are available elsewhere than within the building, structure or lot on which the sign is located. A political sign shall not constitute an off-premise sign."

Section B, Prohibited Signs, Article (1) declares Off-premise sign, PROHIBITED.

Honestly, I don't know if signs like this, announcing yard sales are exempt of these regulations. All I know is, if the person who put it up a week ago in the pole in front of my house hasn't come back to retrieve it, it will be up to me, either to take it off or wait until the wind rips it up, lands in my front yard and becomes MY trash.

Now that the city is so desperately looking for money, I think it could be a good idea to find out if this neighbor paid for a yard sale permit and if not, fine them accordingly.



De las minorías y el idioma inglés; un poco de esto y un poco de aquello

Los debates presentes sobre la inmigración- y hay muchos sabores y colores para sus consumidores- cubren un amplio campo y numerosos contenidos que quiero discutir hoy. Comencemos con el concepto de minoría primeramente. A las minorías se les maligna, se les ofende, se les critica, se les acusa de oportunismo, en fin, la lista de acusaciones es larga. Si usted nació en el extranjero, es gay, de color negro, carmelita o amarillo, cualquiera que sea el sello de minoría que le sirva, es frecuentemente el objetivo de "la mayoría." Además, si usted posee varias de esas descripciones la cosa se pone peor. ¿Qué tal si es extranjero, gay y de color? Pero hablemos un poco de las mayorías. ¿Quiénes son ellos? ¿Son reales? ¿Es ser minoría también estar equivocado? ¿Qué tal si la mayoría está siempre correcta?

Por ejemplo, podría resultar una sorpresa para algunos que los Peregrinos que viajaron a Norte América en el Mayflower eran una minoría (religiosa) en las islas británicas y siguieron siendo una minoría en esta tierra donde los americanos nativos eran una mayoría desde miles de años atrás. El hecho de que hubo guerras que eventualmente eliminaron o exterminaron a esa mayoría no la priva de esa definición. La minoría se convirtió en mayoría y son estas siempre las que escriben la historia o proveen su nueva base moral. El Mayflower no fue un crucero de recreo. Fue un velero muy peligroso y poco confortable navegarlo, casi tan difícil y riesgoso como lo es cruzar nuestras fronteras hoy día. Desde luego, entonces no existía "la migra" y era más fácil relocalizarse en esta gran nación sin

necesidad de pasaporte.

La Revolución Estadounidense que surgió de la nación que había comenzado en Plymouth Rock por esa minoría fue una revolución minoritaria. La Carta de Declaración de Derechos fue un documento minoritario, era un objetivo para alcanzar el nivel de mayoría, no una expresión de posición mayoritaria. Las causas grandes son comenzadas siempre por los pocos. Cuando la Carta de Declaración de Derechos se "declaró" no habían "derechos;" esos comenzaron entonces y todavía estamos luchando por alcanzar algunos de ellos.

Nuestros padres fundadores fueron pocos; nada más que teníamos una minoría selecta. La mayoría del resto de la población era "fundadora" de nada. Nuestro concepto de libertad es también un concepto minoritario en este planeta, porque el mundo entero (una mayoría) no practica nuestros principios democráticos. Cuenten el número de gentes que viven bajo un sistema constitucional democrático que se asemeje ligeramente al nuestro y compárenlo con aquellos que no se parecen. Nosotros, usted y yo, somos minorías.

Volvamos a visitar la controversia del idioma inglés. Hablemos primeramente de la economía. Hace solamente dos años un estudio de la alfabetización en este país produjo resultados interesantes. Pero antes de describirlos debemos de definir lo siguiente: el estudio del alfabetismo es por definición un estudio sobre el analfabetismo. Resultó que, como promedio, el 65 por ciento de los que ganan más de \$60,000 anualmente estaban en la categoría alta en el conocimiento de la prosa del inglés, la documentación y los números. El cuarenta y tres por ciento de los que ganan entre \$0 y \$15,000 estaban en la escala baja de los mismos conocimientos. Y el resto está en el medio de esas categorías.

No se necesita mucho cerebro para llegar a la conclusión de que existe una fuerte relación positiva entre el alfabetismo y el ingreso económico y usted necesita usar muy poco de esa materia cerebral para

decidir que se debe cambiar el peso en la escala desde ligero a pesado. Ésta es un área donde estar de sobrepeso paga muchos dividendos. Así que aquellos extranjeros que no quisiéramos aprender el idioma inglés debíamos pensarlo de nuevo; y aquellos de nosotros que no lo hiciéramos por razones que no están fuera de nuestro control es mejor que lo recojamos todo y nos vayamos con la música a otra parte. Yo, por mi parte, jamás he encontrado a persona alguna que se oponga a aprender el idioma de Shakespeare.

Y hablando de Shakespeare, los que siguen luchando por hacer del hablar inglés el lenguaje "oficial" y están preocupados sobre la posibilidad de que el idioma desaparezca, tienen mucho trabajo que hacer. La primera pregunta que viene a la mente es: ¿Cuál es el inglés al que se refieren? Revisitemos al aterrizaje de los Peregrinos en este artículo. Cuando esos hombres y mujeres de coraje llegaron a Plymouth, se encontraron un idioma local que se llamaba... sí, Massachusetts. Sí mi amigo, un idioma nativo; el nombre del estado donde usted y yo vivimos vino más tarde.

El idioma inglés es probablemente la lengua más evolucionista de todas en este planeta. ¿Estarán pensando sobre un inglés puro? ¿Será ese el que carece de su semilla germánica o el impacto de la

influencia escandinava tal vez? ¿Y qué tal de las palabras de sabor latino oriundas del Imperio Romano? Ni hablemos de los Normandos y el francés. Cuando nuestro Congreso decidió tontamente hace cuatro o cinco años eliminar el nombre de "francesas" de las papas fritas de su menú fueron muy cuidadosos, o muy ignorantes, de no jugar con el resto de la influencia francesa en nuestro vocabulario inglés. Desde luego, la palabra "menú" misma es francesa. ¿Acaso tengo que decir más?

Lea esta historieta de ficción que acabo de escribir para usted: "Anoche, un empresario muy conocido de Boston, fue llevado de emergencia en ambulancia a un hospital local desde un cabaret famoso de Boston después de comer bizcochos y uvas que eran parte de los hors d'ouvres en el menú. Su chofer lo siguió en ruta al hospital y fue capaz de proveernos con los detalles."



In response to the recent deaths of New England student-athletes, an Editorial Roundtable Breakfast: "Sudden Cardiac Arrest (SCA) and the Adolescent Population, Issues and Solutions," is being held.



NECC Launches Online Degree in Criminal Justice

This fall, Northern Essex Community College will launch its first fully online degree: an associate of science degree in criminal justice.

Students interested in preparing for careers in fields such as law enforcement, security or corrections will now be able to earn an associate degree at Northern Essex by taking all courses online.

Prior to this, students could take selected courses online but needed to take some traditional classroom courses to complete their degree.

"Our students love the online courses and they've been combining them with courses on campus," says Carol Liebman, coordinator of the criminal justice program at Northern Essex. "There is a great demand for a fully online program, especially among students who are already working fulltime in the field and appreciate the flexibility of online courses."

According to Liebman, opportunities for employment in the criminal justice field are continuing to grow with the ongoing focus on homeland security. "You can prepare for a career as a municipal police officer, state trooper, correction officer,

or insurance investigator." Other options include probation, parole, the court system, and security, says Liebman.

The associate degree is also transferable to a bachelor's degree and seventy-five percent of graduates continue their education after Northern Essex.

Demand for online learning is increasing rapidly and unlikely to plateau anytime soon, according to "Making the Grade: Online Education in the U.S. 2006", a study released by the Sloan Consortium and the College Board. The number of U.S. college students taking a least one course online increased from 2.3 million in the fall of 2005 to 3.2 million in the fall of 2006.

At Northern Essex, the number of students enrolled in online courses increased 24 percent from 1277 in the fall of 2005 to 1588 in the fall of 2006, when online courses represented nine percent of the total classes offered.

In the fall, the college will offer 72 courses online, ranging from Introduction to Accounting I to American Literature to US History. Five courses in the criminal justice curriculum will be offered online in the fall, including Introduction to Criminal Justice,

Incarceration & Alternatives, Modern Policing, Critical Incident Response, and Criminal Law.

Northern Essex was able to offer the fully online associate degree in criminal justice after collaborating with three other Massachusetts community colleges. The colleges-Bunker Hill, Middlesex, Quinsigamond, and Northern Essex-are now sharing courses in the criminal justice curriculum. The partnership was facilitated by Massachusetts Colleges Online (MCO), a consortium of the state and community colleges. "Getting a course ready for online delivery takes time and money," says David Kelley, executive director of MCO. "This partnership allows the community colleges to launch an online degree much more quickly and efficiently."

While this is Northern Essex's first fully online program, the college hopes to announce additional programs in the near future, says Alan Foucault, director of the college's center for instructional technology. "Access is a very important part of the community college mission and we believe that online degree options remove the barriers to higher education for many students who can't come on campus for a number of different reasons."

NECC Joins National Initiative to Help Students Succeed

Northern Essex Community College has been selected to join Achieving the Dream: Community Colleges Count, a national initiative to help more community college students succeed. NECC will receive \$450,000 over the next four years to plan, launch, and implement student success strategies on both the Haverhill and Lawrence campuses.

NECC is one of four Massachusetts community colleges added to the national initiative's latest expansion, which has added 24 colleges in eight states. This brings the total number of participating institutions to 82 colleges in 15 states. This marks the initiative's first expansion into Massachusetts. Bunker Hill Community College in Boston, Roxbury Community College in Roxbury, and Springfield Technical Community College in Springfield have also joined the initiative.

Achieving the Dream provides participating colleges with support to implement strategies designed to help more students - particularly minority and low-income students - earn degrees, complete certificates, or transfer to other institutions to continue their studies. Achieving the Dream emphasizes building a culture of evidence, in which colleges use data to identify effective practices, improve student success rates and close achievement gaps.

"Insuring student success is a priority at Northern Essex and this grant will help us improve what we're currently doing, especially with minority and low income students," says David Hartleb, NECC President. "The jobs in today's workplace require a college education. With the help of this grant, more students will graduate from Northern Essex and/or transfer to four-year colleges and universities."

NECC will receive a \$50,000 grant from Lumina Foundation for Education to plan and launch Achieving the Dream on its campus this year, and will then become eligible for an implementation grant worth up to \$400,000 over four years from The Lloyd G. Balfour Foundation, The Boston Foundation, TERI, and The Irene E. & George A. Davis Foundation.

As part of its participation, NECC will work closely with an Achieving the Dream coach, many of whom are former college presidents, and a data facilitator who provides hands-on help with the use of data. Additional information regarding Achieving the Dream, including a full list of participants, can be found online at www.achievingthedream.org.

Achieving the Dream was launched in 2004 with start-up funding from Lumina Foundation, which continues to fund aspects of the initiative. Seventeen additional funding sources have since joined the initiative, bringing additional institutions and states into Achieving the Dream.

Eight national partner organizations work with Lumina to guide the initiative and provide technical and other support to the colleges and states. They are: the American Association of Community Colleges; the Community College Leadership Program at the University of Texas-Austin; the Community College Research Center, Teachers College, Columbia University; Institute for Higher Education at the University of Florida; Jobs for the Future; MDC; MDRC; and Public Agenda.




Mr. B's Sports Memories

Bits and Pieces

First of all, I want to thank all the readers that have told me how much they enjoy this column; it is a fun project for me. Secondly, I am not bothered by corrections or letters to Rumbo regarding a mistake. Most of my writing is done in real late nights when sleep is hard to come by. Not an excuse. Most of my stuff is from memory and sometimes memory takes a vacation at this age. I encourage letters for any reason i.e. corrections or compliments.

To see recently that Mickey Spillane died brought the memories of years ago when we all read his books starting with "I The Jury" with his star detective Mike Hammer. We, as teenagers couldn't get enough of these novels and many of the copies became frayed and badly worn from people loaning them out. There was much violence in Spillane's writings and just enough sex to warrant us young readers to hide them from our parents.

Our parents and other grown ups were doing the same thing with a book called Peyton Place a book written by a woman who either had the goods on a small New Hampshire town or had an X rated imagination, her name Grace Metalious. Movies and TV series were made of each book with Peyton Place the most popular by far.

Switching gears this humidity and heat reminded me of the years past when there weren't many air conditioners in any neighborhoods and fans seemed to be the thing most families used. Some of us lived in three-deckers and even four-deckers close quartered areas. Screened windows and doors were left open day and night and when a rain storm appeared people would be scurrying home to close them. Fat chance you could leave them open these days even in the best parts of this or any other city.

On our street we had a lady who used to sit on her downstairs porch and kick back with a "brewski" or two and was scared to death of thunder and lightning. Every so often when we would pass by her (and her name was "Lil" and very nice to us kids by the way), we would stop, talk and after a few minutes of this one of us (my pals and I) would say, "What was that?" Another would say, "I think it's thunder. "Lil would say "Oh, my God no; I hope not!" and would start picking up her quarts of beer and start really moving to her second floor apartment and we could hear her closing the windows and watch as she shut of the lights probably thinking the lightning wouldn't find her in the dark. In fairness to her though, people were told to put off their lights during an

electrical storm. Sometimes as we stopped to talk to her someone would say what a storm up in Lowell and its heading our way and in a New York minute she was on her way upstairs again.

Poor Lil; we had so many laughs at her expense and I'm sure she is in heaven and probably waiting for us street urchins to show so she can confront us. I don't think many of us are headed in that direction though.

Speaking of electrical storms I had lunch with a few friends last week, "Red" McGovern being one and he is approaching the century mark in age. He used to call my show occasionally and he also played a mean game of tennis until recently. Well, he brought up the story of a young Lawrence High School baseball player whose name was Donovan and was electrocuted at O'Sullivan's Park while playing for Mark Devlin's team. This happened as a bolt of lightning hit the field and threw many of the players in different directions and stunned them but killed the young Donovan boy. The park was where the Boys Club stands today on Water St.

Switch gears again; do any of you recall Spike Jones and his band and their rendition of the standard "Cocktails for Two"? How about Frankie Laine or in those days called "Mr. Rythmn"? He recorded many hits including "That's My Desire", "That Lucky Old Sun", "Jezebel", and "Mule Train". He performed at a Boston club that featured many big stars it was called Blinstrubs.

Locally it was Frankie Cav and the Playboys and they were a good group and Frankie Cavallaro was the one the group was named after. Mickey, Larry and the Exciters played at the Peppermint lounge in Lowell and also Jennies at Salisbury Beach and Mac Jenny was their manager. He later managed Mac's Mob.

Gloria was famous belly dancer at the SAC club in Lawrence and Little Betty a Lawrencian to this day was part of this show.

Getting back to the heat Lawrence had 4 city pools one in each corner of the city, we also had two wading pools one in the North Common and one in the South Common. On these dog days of summer all these pools would be mobbed. The large pools would have girls' days and boys' days and if girls' days were at two pools it was boys' days at the other two. The pools personnel were made up of high school athletes and school teachers for the most part.

Charlie Rappaport a fine man was the pool superintendent and he ruled with a

strong will. Bob Bunting took over when Charlie retired and he proved to be a good replacement. Swimming lessons were given free of charge and each pool had a courtyard at which people would stretch out towel and lay in the sun to get a great tan. Ending the swimming season brought on the city races usually held at the Allicon pool now torn down but formerly where the State Park is now at the corners of Sanborn and Rowe Sts.

There were all kinds of races and a greased watermelon contest and also two canoes with lifeguards in each with long poles with a boxing glove on the end and the object was to tip your opponent's canoe over, this was a big crowd pleaser as the lifeguards were from different pools. The main event was a ten-lap race for men for endurance and speed.

DuckyBibeau, Kenny Mulligan were great swimmers who won this race maybe twice each. Neither was a match for the future electrician from North Lawrence who won it maybe four or five times, his name Frank McCarthy, the fastest swimmer I've ever seen on this level.

Seeing this is the 60th birthday of the Bikini bathing suit I would be remiss if I didn't mention the beautiful Rita Suslovich who was a lifeguard at the Allicon and a great model for this type suit. Well she waited for race night to break out this apparel and it was fluorescent orange and Stevie Wonder could have spied her with her great tan and blonde hair and it was under the lights. Most of us young guys were agog at this vision and maybe it was just puberty kicking it to us teenagers but, what the heck, Happy Birthday Bikini and as for Rita, I last met her at her new place in Hollywood, Florida, where she moved after retiring from the Parks and Property Department of the City of Lawrence as nice as ever, I had been a family friend for years and she was still a beauty. I think I thanked her for all the Crosby St. boys she mesmerized that night.

Finally, an elderly lady called 911 to report her car had been broken into. She was hysterical as she explains to the dispatcher that, "They've stolen the stereo, the steering wheel, the break pedal, and even the accelerator," she cried. The dispatcher tries to calm her down and tells her an officer is on his way. A few minutes later the responding officer calls in and says, "Disregard." He says, "She got into the back seat by mistake".

This getting old stuff is not always fun!

Social Services Partnership Solicits Community Input on Issues

Lawrence, MA; Saturday, May 19, 2007: A coalition of social service agencies welcomed the community in developing services for a new community program. "Community Cares" was one of the first community-based events to be held in a newly created, neighborhood-focused office based on the English "PATCH" model.

The PATCH model represents a shift in organizational dynamics in social service provision. Rather than agencies determining the needs of the community, the PATCH model expects grass-roots involvement by the residents of the neighborhood that the office serves.

The Open Space Forum was a way to empower local residents to express what they see as the issues and needs facing children and families in their neighborhoods, and how to address these needs. There were 60+ adults and youth who participated in this event.

The goal is to have community members be equal partners with social service agencies and have a strong voice, and stake in, deciding how best to serve their neighborhoods. Several community based strategies will evolve from the project that will take direction from community residents, Neighborhood Committee, Parent Council, and a Youth Council.

This program is a partnership between the Lawrence/Methuen Community Coalition, Community Day Care, TAM Presbyterian Church, the Department of Social Services and the Greater Lawrence Community Action Council which serves as the fiscal lead agency for the PATCH Project.

About the New Office: The new office is sited at the TAM Presbyterian Church, 96 East Haverhill Street in the Prospect Hill area of Lawrence. It is the third such office that has been developed in the state of Massachusetts.

The PATCH concept is to create community ownership, hope, self-determination and pride where children and families are safe and have meaningful futures through collaboration and mutual responsibility. The office will achieve this goal through promoting empowerment and involvement of community members who seek support.



Heat Wave Safety

The lure of summer sun can often overshadow health concerns when temperatures start to soar. Richard Zane, MD, vice chairman of the department of Emergency Medicine at Brigham and Women's Hospital, cautions patients about the inevitable surge in heat-related illnesses that occurs during scorching triple-digit days when the body heats up faster than it can cool down. Unfortunately, many patients end up in emergency departments with serious, yet preventable, heat-related

illnesses. Dr. Zane is available to share information about heat-related illnesses and tips to prevent them.

The most important strategy is prevention! When heading out into the sun, Dr. Zane offers these safety tips:

- Drink plenty of water, even if you do not feel thirsty. Thirst is a late indication that your body is already low on fluids. To aid absorption, drink frequent, small amounts of water or a low-sugar sports beverage (about 8 oz per hour) instead of large, sporadic amounts.
- Avoid dehydrating drinks that contain alcohol, caffeine or high amounts of sugar.

- Wear loose, lightweight, light-colored clothing and put on sunscreen with an SPF of 15 or higher. Wear a hat and shade yourself with an umbrella, if possible.
- Do not take salt tablets, which do not replace water loss and can increase blood pressure, irritate the stomach and seriously affect people with a history of heart disease.
- Remain indoors for the heat of the day, between the hours of 10 a.m. and 3 p.m. Try to limit strenuous outdoor activities and physical exercise to morning and evening hours.
- Take special care to check on individuals who may be at greater risk for heat-related illnesses: children, senior citizens, and

- people who have a mental illness or are physically ill, especially those who suffer from obesity, heart disease or high blood pressure. Patients on medications for psychiatric illness or hypertension may be at particular risk for hyperthermia.
- Dr. Zane advises patients to know the warning signs of heat-related illnesses and to seek medical care early if significant illness is present:
- Heat Rash (prickly heat): A red or pink rash resulting from blocked and swollen sweat ducts; causes discomfort and itching.
- Heat Edema (swelling): Hands and feet swell after standing or sitting for long periods of time in the heat when blood vessels dilate and gravity pulls body fluids to extremities.
- Heat Cramps: Can occur in the muscles after exercising in the heat if the body loses excess fluid and electrolytes. Signals include muscle spasms, muscles that feel tender, hard or lumpy, nausea and vomiting, weakness and fatigue.
- Heat Syncope (fainting): Results from exertion in a hot environment. Signs leading to heat syncope include pale, cool and moist skin and a feeling of lightheadedness, especially when changing positions (moving from lying down to standing up).
- Heat Exhaustion: Typically occurs after intense exertion and heavy sweating when the body fails to sufficiently cool down and results in a form of shock due to decreased blood flow to vital organs. Symptoms of heat exhaustion may include heavy sweating, cool, moist, pale or flushed skin, headache, dizziness or weakness and nausea. Body temperature is usually near normal. Heat exhaustion is a serious condition that may lead to heat stroke. A person experiencing heat exhaustion should be monitored closely and should receive medical attention.
- Heat Stroke: Heat Stroke is a life-threatening illness that requires emergency treatment. Seek help immediately if you or a loved one experience a high body temperature (up to 105 degrees), flushed, hot, dry skin with no sweating, vomiting, a weak, rapid pulse, decreased alertness, changes in consciousness and shallow, rapid breathing. The key sign that distinguishes heat stroke from moderate heat illnesses is a noticeable change in mental status (disorientation, confusion, impaired thinking).



Of Minorities and English language; a little bit of this and a little bit of that

The current immigration debates, and there are many flavors for different folks, cover a lot of ground and issues and we want to discuss two today. Let's start with the concept of minorities first. Minorities are often maligned, smeared, criticized, accused of opportunism, you name it. Whether you are foreign born, gay, black, brown, yellow, whatever minority label fits you, you are always the target of "the majority." In addition, if you happen to have several labels it gets worse. How is foreign born, gay and black? So let us talk about majorities. Who are they? Are they real? Does minority mean wrong? How about majority meaning right?

For instance, it may come as a surprise to some that the Pilgrims who traveled to America in the Mayflower were a (religious) minority in the British Isles and then became a new minority in America, where the Native Americans were a numerical majority. The fact that there were wars that eventually eliminated or exterminated the majority does not retract from the early definition. The minority became the majority and it is the majority that always writes history or provides its moral basis. The Mayflower was not a cruise liner. It was a very uncomfortable and dangerous ship, almost as difficult and dangerous as crossing our borders today. Of course, there were no "migras" then, so it was easy to settle on this land without a passport.

The American Revolution that evolved from the nation started in Plymouth Rock by this minority was a minority revolution. The Bill of Rights was a minority document, it was a goal to strive for, not a majority position. Great causes are always started by the few. When the Bill of Rights was declared there were no rights, the rights started then and we are still fighting for some. Our Founding fathers were only a few; we only had a selected minority. Most of the rest of the population were not founding anything.

Our concept of freedom is also a minority concept on this planet, because the entire world (a majority) does not practice our democratic principles. Count the number of folks who live under a democratic constitutional system that looks even close to ours and compare with those who do not. We, you and I, are all minorities.

Let's revisit the English language only controversy. First let's talk economics. As recent as two years ago, a study of literacy in this country produced some interesting facts. But before we list those findings let's

make sure we also mention that a study about literacy is by definition a study of illiteracy. It seems that, as an average, 65 percent of those who were making \$60,000 or over per year were high in the prose (English,) document and quantitative scales of literacy. Forty three percent of those making between \$0 and \$15,000 were on the low on the same literacy scales. Then there are those others in the "between" category.

It does not take too much brain to come to the conclusion that there is a strong positive correlation between literacy and income and you have to have very little of that brain stuff not to work as hard as you can to change your weight on the scale from light to heavy. This is an area where being overweight pays large dividends. So those who think foreigners do not want to learn English better think again; and those of us who refuse to learn the language for reasons beyond our circumstances might as well pick up and go. I, for one, have never encountered anyone who is against learning Shakespeare's tongue.

And speaking of Shakespeare, the concerned one who want to make English the "official" language of this land and are worried about the possibility that English will disappear have further work to do. First of all, what English are they talking about? Let's revisit the Pilgrim's landing in this article one more time. When those brave folks landed in Plymouth they encountered a local non-English language by the name of... yes, Massachusetts. Yes siree, a native language; the name of the state came later.

The English language is probably one of the most evolutionary languages on this planet today. Are they thinking of "pure" English? Is that a language devoid of its early Germanic seeds or the impact of Scandinavian influence perhaps? How about the Latin words from the Roman Empire? Never mind the Normans and the French. When Congress decided four or five years ago to replace the term "French" fries from their menus they were very careful, or very ignorant, not to trample with the rest of the French influence in our English language vocabulary. Of course, the "menu" word itself is French. Will ignorant wonders ever cease?

Read the following fictional story I just wrote for you: "Last evening, a well known Boston entrepreneur had to be carried from a familiar downtown cabaret in an ambulance to the local hospital after having been affected by eating biscuits, and grapes that were part of the hors d'oeuvre in the menu. His chauffeur followed him en route to the hospital and was able to provide us with the details."

Just as a teaser for you, we will reproduce the same sentence and will extract all the French words in that paragraph and see whether it makes sense to you. See if you can identify the missing French words

before reading this sentence: "Last evening, a well known Boston ... had to be carried from a familiar downtown ... in an... to the local hospital after having been affected by eating ..., and... that were part of the... in the His... followed him... to the hospital and was able to provide us with the details." Does it make sense? OK my friends, is this the English language we want to make official?

Hidden behind the controversy of the English language nonsense is purely an old and insecure discriminatory attitude. Small rivers of foreign languages that flow into a three hundred million people ocean of English language tradition would not even get close to corrupting those idiomatic waters. Be not afraid. English is not a language of the past; it is a language of technology for the future. It is not to be spoken in caverns but in "O beautiful for spacious skies, ample skies" as in America the Beautiful. Your English Honor, the defense rests.

Next week, our nation celebrates two hundred and thirty one years since that unique moment when we declared ourselves to be Independent. That day we were not; we intended to be so. Much has happened since and many lives have been lost on this land and others to bring meaning to that declaration so eloquently described in the words of its last paragraph as "...with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor." And the word "our" means all of us.

I can not think of a better way to describe this nation of minorities, majorities and folks who speak many languages that mean the same. Have a great Fourth of July! Happy Birthday, my dear country! And that is my point of view today.

Every writer knows there can be more than one ending to a story

For Dr. Kristine Doll, who wrote a children's story called *The Mermaid of Pondsides*, there are now about a dozen possibilities, thanks to the efforts of students at Greater Lawrence Technical School, Andover.

Rose Smith, who teaches English Language Learners (ELL) at GLTS, was also a master's degree candidate this year at Salem State College, where Dr. Doll teaches and publishes stories in *The Sextant*, a college publication.

To encourage their creativity and enhance their writing skills in English, Mrs. Smith asked her students, who are natives of Honduras, the Dominican Republic, and Puerto Rico, to craft an ending to the tale, which is about a mermaid who lost her love years ago and was still looking for him.

"Some students wrote that the mermaid found her love and had human children while others concluded that the mermaid fell in love with one of the young characters in the story," Mrs. Smith said. In one telling, the mermaid moved with her new love to New York, and in another the title character

learned Spanish dances, including the meringue, salsa, and bachata. In a darker, but eventually ethereal ending, the mermaid is killed in a jealous episode, but later she and her lover are turned into shooting stars that guide lost ships at sea.

Mrs. Smith noted that GLTS had adopted the corporate "Fish" philosophy this year, "so I decided to end the fourth term with a topic with relevance to fish," she said.

At her master's degree ceremony, Mrs. Smith told Dr. Doll about the project, and with encouragement from another professor, Dr. Ellen Rintell, arrangements were made for the author to visit the students and see their work. Mrs. Smith also worked with students on producing cover designs for the completed stories.

"The students were excited to meet the Mermaid author," Mrs. Smith said. "They never had had this experience. Now many of them said they would love to write more stories."

Arsenault and Julie Desjardins of Methuen, Kim Cushing and Rebecca Hope of North Andover, and Kim Beaton of Salem, NH.







Estas alternativas fueron rechazadas por las siguientes razones: (1) el bajo y moderado ingreso de la población a que está dirigida existe en muchas áreas de la ciudad, a pesar de la localización con respecto al plan de inundaciones, y todas las propiedades y áreas elegibles deben ser consideradas para elevar al máximo la eficacia del programa de viviendas y desarrollo comunitario; (2) El costo es prohibitivo y no es posible mover físicamente o construir estructuras fuera del plano de inundación; (3) la alternativa de "no acción" no contemplará la necesidad de viviendas y facilidades públicas y diferirá los problemas de mantenimiento de la comunidad. Para minimizar la potencial pérdida de vidas, salud e inversión financiera, propietarios e inquilinos serán notificados de que sus unidades están localizadas en el plano de inundación por lo que seguro contra inundaciones será una eventualidad requerida. La cantidad y el período de cobertura serán de acuerdo con lo requerido por el National Flood Insurance Program.

Un Récord de la Revisión Ambiental (ERR) con respecto a los mencionados proyectos están disponibles por la jurisdicción que aparece más arriba cuyos documentos del plan de inundaciones contienen una descripción completa de las acciones propuestas.
