“Este sitio es fantástico”, dijo Hector Christin, 11, cuando entró al centro.

“Yo voy a venir todos los días de la semana”, dijo mientras caminaba por la biblioteca. Christin es uno de 40 a 70 niños que vienen diariamente al Lena Lahey Community Center a jugar, después que terminan con sus tareas escolares.

La celebración de la gran apertura del centro comunitario para jóvenes y niños del vecindario de Arlington en Methuen, fundado con más de \$540,000 en donaciones públicas y privadas, localizado en el 141 de la Calle Tenney y administrado por Methuen Arlington Neighborhood, Inc. (MAN, Inc) se llevó a cabo el martes, 12 de febrero, 2008.

Durante una recepción ofrecida para celebrar la inauguración, el Director del Centro, Joan Mejía, el Alcalde de Methuen, William M. Manzi III, la Representante Estatal Linda Dean Campbell y el Representante Estatal Robert A. DeLeo, y Chairman of the Committee on Ways and Means, destacaron la importancia del proyecto.

La misión de MAN, Inc. es mejorar los niveles económicos, educacionales y sociales, de los residentes de bajos ingresos del vecindario de Arlington en Methuen. Las áreas de enfoque incluyen seguridad pública, programas juveniles, viviendas a precios razonables, servicios sociales, transportación, empleo y cuidando infantil.

Con la apertura del Lena Lahey Community Center, MAN Inc. tendrá 1,630

pies cuadrados más que su local original del 1 de Broadway. Además, 1,580 pies cuadrados serán añadidos en la primavera en el segundo piso con la instalación de un nuevo elevador. Este nuevo espacio permitirá a MAN, Inc., brindar los siguientes programas de vecindario con más efectividad: Un programa de karate con la Escuela de Karate de Methuen, una biblioteca satélite en combinación con Nevins Memorial Library, la Liga de Baloncesto de la Policía de Methuen, el centro de computadoras y trabajo escolar, el programa de parques en el verano, sábados de películas y trabajos manuales, Noche Nacional Afuera, ferias de trabajo, fiestas de cuadra, entrenamiento de trabajo y programa de donación de cestas de comida.

La construcción del Centro del Vecindario Arlington Methuen se llevó a cabo gracias al Departamento de Viviendas y Desarrollo Urbano bajo el Programa de Community Development Block Grant del Título I del Acta de 1974 de Planeamiento y Desarrollo, a través del Departamento de Viviendas y Desarrollo Comunitario de la Ciudad de Methuen. También se recibieron fondos privados y donaciones por la suma de \$62,500 a través de la Fundación Paula Moore, la Fundación Pringle Foundation, TGIF donaciones y recaudaciones.

Milagro en la Calle Tenney

Con la inauguración del Centro Comunal Lena Lahey el pasado martes, 12 de febrero, la Ciudad de Methuen cerró un capítulo de decadencia social, de prostitución, drogas y pobreza en una de las áreas más densamente pobladas de la ciudad, muy cerca de los límites de Lawrence: la Calle Tenney.

“Esto es más que este edificio. Es más bien una comunidad. Nosotros hemos cambiado esta área con este vecindario”, dijo el Alcalde de Methuen William M. Manzi, III cuando dio la bienvenida a más de 200 personas que vinieron a admirar el nuevo centro de dos pisos, 1,630 pies cuadrados más grande del que estaban usando en el 1 de Broadway.

Y estaba en lo cierto; en 1992, nadie quería vivir en esa sección de la ciudad. El valor de la propiedad iba en descenso, los vecinos se estaban mudando hacia otros sitios, solo para ser remplazados por más vendedores de droga y más prostitutas. ¡Ya no más!

Una docena de bien merecidos reconocimientos fueron repartidos entre aquellas personas responsables del éxito del proyecto, pero uno fue dejado para el final, para ser entregado a la persona más merecedora. “Hemos avanzado mucho en 16 años y es por una persona”, dijo Richard Dewhirst, presidente de Methuen Arlington Neighborhood Inc., “Y esa persona es Linda Soucy”.

Methuen es dichoso de tener a Linda Soucy. Personas con la visión y tenacidad de ella, hacen que sucedan milagros.

Miracle in Tenney Street

With the inauguration of the Lena Lahey Community Center last Tuesday, February 12, the City of Methuen closed a chapter of social ills, prostitution, drugs and poverty in one of the most densely populated areas of the city, very close to the Lawrence limits: Tenney Street.

“This is more than a building. It is more of a community. We turned this area around with this neighborhood,” said Methuen Mayor William M. Manzi, III when he welcomed close to 200 guests who came to admire the new two-story center, 1,630 square feet larger than the one they used to have at 1 Broadway.

And he was right; in 1992 no one wanted to live in that section of the city. Property values were going down; people were moving out to be replaced by more drugs dealers and prostitutes. Not anymore!

A dozen of well-deserved awards were given away to a dozen of people involved in the success of the project, but one was saved for last and for the most deserving person. “We have come very far in 16 years and it is because of one person,” said Richard Dewhirst, President of Methuen Arlington Neighborhood, Inc. “And that person is Linda Soucy.”

Methuen is lucky to have Linda Soucy. People with her vision and tenacity make miracles happen.

Haverhill ahorra en transportación escolar

El Alcalde de Haverhill James J. Fiorentini alabó el ahorro generado por un nuevo plan llevado a cabo por su administración que ahorrará a los contribuyentes de Haverhill un estimado de \$14,600 este año. Fiorentino detalló las reformas que han tenido lugar en cuanto a la forma en que la ciudad paga por la gasolina para los autobuses escolares.

“Anteriormente, Coppola Bus Company, la cual provee la transportación para las Escuelas Públicas de Haverhill, pagaba altos precios por la gasolina de sus vehículos. Estos costos entonces se pasaban a la ciudad,” explicó el Alcalde Fiorentini. “Ahora, tenemos a la persona que provee la gasolina para la ciudad, Dennis K. Burke, entregando diesel directamente a Coppola en nombre del municipio. Las facturas por esta venta de petróleo son enviadas al Departamento Escolar, libres del impuesto federal en la gasolina.

El ahorro está estimado entre 24 centavos por galón,” concluyó el alcalde. “Quisiera agradecer a nuestro Director de Compras Bob DeFusco, la administración de Coppola y al Departamento Escolar por trabajar unidos para encontrar formas más eficientes de operar. Estas son algunas de las reformas y eficiencias en costos que necesitamos para sobrellevar estos tiempos difíciles,” anotó el alcalde.





Vez tras vez nuestros análisis nos dice que entre menos el gobierno interfiere, las economías más crecerán.

Uno de los mejores ejemplos de éxito es el país de Mauricio (es un país insular ubicado al suroeste del Océano Índico). Al efectuar reforma fiscal y acción punitiva para erradicar corrupción, Mauricio se encuentra en el número 18 ranking este año. IRS y los Pagos de Estímulo

IRS Enviará Pagos de Estímulo Automáticamente Desde Mayo; Debe Presentarse una Declaración para Recibirlo

El Servicio de Impuestos Internos (IRS) indicó que en la mayoría de los casos los contribuyentes no tendrán que hacer nada más que presentar su declaración de impuestos para recibir los pagos de estímulo económico a partir de mayo de este año.

El IRS usará la información de la declaración de impuestos de 2007 que

presente el contribuyente para determinar su elegibilidad y calcular su pago de estímulo. Los pagos a más de 130 millones de contribuyentes serán enviados durante varias semanas en la primavera y el verano o serán depositados directamente a cuentas bancarias para quienes seleccionan esta opción en su declaración, siendo ésta la manera más rápida para recibir su reembolso y también los pagos del estímulo.

En la mayoría de los casos, los pagos equivaldrán a la obligación tributaria en la declaración de impuestos, con un máximo

de \$600 para individuos (\$1,200 declarando juntos). Quienes califican también recibirán \$300 adicionales por cada niño elegible para el crédito tributario por hijos.

Los pagos a contribuyentes con ingresos más altos serán reducidos en 5 por ciento del monto de ingreso bruto ajustado por encima de \$75,000 para individuos y \$150,000 para quienes declaran juntos.

"La ley también permite pagos a ciertos contribuyentes sin obligación de impuestos, tal como trabajadores de bajos ingresos o aquellos que reciben ciertos beneficios", explicó Sara Eguren, portavoz del IRS. "Pero para esto debe presentarse una declaración de impuesto que incluya los beneficios que recibió la persona en el 2007", añadió.

Mientras que algunos contribuyentes de bajos ingresos o sin ingresos del trabajo podrían no estar obligados normalmente a presentar una declaración, el IRS enfatiza que deben hacerlo para recibir un pago de \$300 (\$600 en declaraciones conjuntas) si tuvieron ingresos calificados, como beneficios del Seguro Social, ciertas Jubilaciones Ferroviarias, y ciertos beneficios de veteranos, además de ingresos del trabajo, que sumen por lo menos \$3,000.

Es necesario tener un Número de Seguro Social válido para calificar para el pago de estímulo. Los contribuyentes que presentan sus declaraciones usando un Número de Identificación Personal del Contribuyente

(ITIN) emitido por el IRS, o cualquier número emitido por el IRS no califican. Tampoco son elegibles los individuos que pueden ser reclamados como dependientes por otra persona, o quienes presentan la Forma 1040-NR, 1040-PR o 1040-SS.

Para atender a quienes declaran impuestos más tarde en el año, el IRS continuará enviando pagos hasta el 31 de diciembre de 2008. El IRS también advierte a los contribuyentes que si presentan su declaración de impuestos para 2007 y luego se mudan que deben presentar al Servicio Postal de EE.UU. una tarjeta de cambio de dirección.

El IRS enviará dos notificaciones informativas a los contribuyentes alertándoles acerca de los pagos de estímulo. Sin embargo, los contribuyentes deben mantenerse alerta acerca de estafas de reembolsos o "rebates", como llamadas telefónicas o e-mails alegando provenir del IRS y solicitando información sensible. 

SENECA: Observaciones de una reciente reunión del concilio

Mark Andres, el cual designará más de 30 puntos "decisivos" que llegarán a tiempo para balancear el año fiscal 2009. Este documento fue sujeto de discusión en la reunión del Comité de Presupuesto y Finanzas la semana siguiente. Hubo muchas exclamaciones de "uuuh" y "aaah" por el simple hecho de que un documento como ese exista, que la gente se impresione con que un programa de esa índole esté en funcionamiento para guiarlos en este proceso. nuestra no sirve, pónganlo en la de Methuen o de Andover si es necesario. Las de ellos son fáciles de manejar.

Unos cuantos puntos a prisa. Felicitaciones a Nilka Alvarez Rodríguez por debatir contra el presidente del concilio Patrick Blanchette por la forma tan irrespetuosa y sarcástica con que la trató. Es un día triste cuando los concejales no pueden hacer su trabajo y expresar su apoyo por las causas que son clave a sus constituyentes sin tener que confrontar innecesarios ataques personales del que tiene el martillo.

“This place is awesome,” said Hector Christin, 11, when he entered the Center. “I’ll be here everyday of the week,” he said while walking into the library. Christin is one of about 40 to 70 children who come to the Lena Lahey Community Center, on a daily basis to play, after they do their school work.

The grand opening celebration of the community center for young children in the Methuen Arlington neighborhood, funded by over \$540,000 in public-private donations, located at 141 Tenney Street, managed by Methuen Arlington Neighborhood, Inc. (MAN, Inc.) was held on Tuesday, February 12th, 2008.

An open house of the new building followed with remarks from Center Director Joan Mejia, Methuen Mayor William M. Manzi III, State Representative Linda Dean Campbell and State Representative Robert A. DeLeo, Chairman of the Committee on Ways and Means.

The mission of MAN, Inc. is to improve the economic, educational, and social levels of low-moderate income residents of the Methuen Arlington Neighborhood. Main focus areas include Public Safety, youth programs, affordable housing, social services, transportation, employment, and child care.

With the opening of the Lena Lahey Community Center, MAN Inc. will gain 1,630 square feet from its previous location at 1 Broadway Street. An additional 1,580 square feet will be added on the second floor in the spring with the

installation of a new elevator. This new found space will enable MAN, Inc. to run the following neighborhood programs more efficiently: a karate program with Methuen Karate School, a satellite library with Nevins Memorial Library, the Methuen Police Basketball League, the safe haven computer and homework center, a summer parks program, Saturday movies and crafts, National Night Out, job fairs, block parties, job training, and a food basket/giving program.

The construction of the Methuen Arlington Neighborhood Center was primarily funded by United States Department of Housing & Urban Development under the Community Development Block Grant Program provisions of Title I of the Planning and Development Act of 1974 as amended, through the Massachusetts Department of Housing and Community Development and the City of Methuen Community Development Department. Also private donations in the amount of \$62,500 through the Paula Moore Foundation, the Pringle Foundation, TGIF donation and fundraising efforts.

On Monday, February 11, 2008, the Government Affairs Committee of the Merrimack Valley Chamber of Commerce presented its annual event, "A Special Report from Washington," during a breakfast at the Wyndham Hotel in Andover, with Congresswoman Niki Tsongas and Congressman John Tierney with Attorney Warren E. Tolman as moderator.

Congressman Tierney spoke about the recession we are in due to the fact that we are spending in Iraq what we should be spending here. "The good news is that we have an opportunity to do something about it," he said.

Tierney said that we have to find leaders that can take us out of this situation while recognizing that we have to get actively engaged in stabilizing the region (Iraq). Tierney is pro-cut subsidies to big companies. "The money is going out the door and we need this money to put it to work here".

Congresswoman Tsongas spoke about her first vote she took, to override President Bush's veto of a measure to add millions of children to a federally funded health insurance program. About her experience as new congresswoman, she realized how easy it is to vote just by pressing buttons but how big the consequences are when you press them.

As a member of the Armed Services and Budget Committees, Tsongas went to Iraq as part of a bipartisan group and upon landing, she said she was impressed with the military might and specially impressed with our armed forces deployed in that area. "We needs to put in place a time table to bring our troops back and implement stabilization in the region," said Tsongas, and added, "We tried to engage other countries in the process of war, we should try to have them involved in the matter of peace."





Merrimack Valley Hospice Volunteers Learn About Hospice House Project



Hull and members of the Merrimack Valley Hospice House Campaign will be available to answer questions about the Hospice House.



Doctors at the Lowell Community Health Center are sending their youngest patients home with free books and important advice for their parents – "Read to your children every day." Today, Senator Steven C. Panagiotakos (D-Lowell) visited the health center and read to a group of young children, emphasizing the importance of reading aloud.

Lowell Community Health Center participates in ReachOutandRead(ROR), a national children's literacy program that focuses on young children at risk of entering school unprepared to learn. At every checkup, doctors participating in ROR guide and encourage parents to read aloud to their young children every day, and give each child a carefully selected new, developmentally and culturally appropriate book. By the time that child enters school, he or she will have a home library of up to 10 books.

Reach Out and Read has one of the strongest records of research support of any school readiness intervention. Studies show that parents who get books and counseling on reading aloud from their doctors and nurses are more likely to read to their young children, read to them more often, and provide more books in the home. Children exposed to Reach Out and Read show improved language development, giving a child as young as 2-year-old a 6 month head start developmentally.

The program has gained broad bipartisan support in Massachusetts, and Senator Panagiotakos, Chairman of the Senate Committee on Ways and Means, has been a leading advocate for

the program's state funding. "Senator Panagiotakos has been a terrific champion for Reach Out and Read for many years now," said Dr. Barry Zuckerman, founder and CEO of the program. "We're grateful for his leadership on behalf of young children."

"I commend the Lowell Community Health Center for responsibly prescribing a healthy dose of story-time," said Senator Panagiotakos. "Reach Out and Read has consistently worked with local medical professionals to ensure our communities maintain a healthy attitude towards literacy; reminding us all that reading is a cornerstone of developmental skills and later school success."

Lowell Community Health Center is one of 3 sites in Senator Panagiotakos' district that participate in Reach Out and Read, that together provide books to nearly 11,000 children annually. Across the state, 199 Reach Out and Read sites serve over 158,664 low-income infants, toddlers and preschoolers annually.

Nationally, thousands of doctors this year will give 4.9 million new books to 3 million low-income families at more than 3,500 health care sites nationwide. Reach Out and Read serves about 25 percent of America's at-risk infants, toddlers and preschoolers. Endorsed by the American Academy of Pediatrics, Reach Out and Read was the only American literacy program featured at the recent White House Conference on Global Literacy.

Since it was founded in 1989, Reach Out and Read has trained more than 47,000 doctors and nurses who have given over 20 million books to children in all 50 states, the District of Columbia, Guam, Puerto Rico, and the United States Virgin Islands. that have been streaming into the United States.

The delegation has signed on to co-sponsor An Act Relative to Children's Safety. The legislative measure classifies an item as unsafe if: it does not conform to all federal laws and regulations setting forth standards for children's products; it has been recalled for any reason by the federal government or manufacturer and the recall has not been rescinded; or if an agency of the federal government has issued a warning that the product's use poses a safety hazard and the warning has not been rescinded.

"This bill makes good, honest sense," said Finegold. "I have two young children of my own and represent scores of parents here in Lawrence, Tewksbury and Andover. If there is a step that I can take to ensure the safety of children across the Commonwealth, I'm going to take it."

Representative Lantigua echoed Finegold's sentiment. "This legislation is a significant step toward protecting children, the most vulnerable segment of our population," said Lantigua. "By working together with the federal government, manufacturers, and retailers, the Department of Public Safety will be able to provide the latest possible information about unsafe products to those responsible for the care of children."

"I am a proud cosponsor of this important bill," said Senator Sue Tucker. "While the federal government does its part to ensure the safety of our children, it's only right that we in the legislature take positive steps to do our part."

Under this bill, the Department of Public Health will make available on its website a list of unsafe children's products and notify licensed or registered day care providers and pediatricians of the listed products. If passed, Massachusetts would become the ninth state nationwide to ban the sale of recalled products.

1963 Social League Softball

It was portrayed as an easy going fun league and was put on a par with softball games that were played at outings and family get togethers. Games were played at city parks throughout the city. The Social League was considered to be a higher league than the Y Industrial League but lower than the Lawrence Fast Pitch League. Many people and players felt the Social League was beneath them even though some of the area's best players were playing for the allegedly inferior teams.

It was a time when the city league had shrunken to four teams. The social league was growing and featured teams from throughout the area. The Concordia Club, Parker Tavern, Post 122 of Methuen, the Ward 6 Club, the East End Club, and the Town Tavern of Andover were some of the teams that made up the league. Games were played at the Gill Avenue field in Methuen, the Sargent Club field also in Methuen, the Lorenz on Prospect Hill, the O'Connell in South Lawrence, the Steven Barker, and an occasional game at the Mecca of local softball, the hallowed Hayden Schofield.

These games brought howls from the players of the dying league that was on its last leg.

One move made a big difference for the fledgling league was when prominent business man Gene McAuliffe was named the league president. Billy Callagy served as his aide. Both men were highly respected former athletes of our city. League meetings were held at Gene's place of business which was a funeral parlor conveniently located across the street from the park on Lawrence Street.

One of the league's rules was win or lose the team that was the visitors would have to go to the home teams bar after the game. A rule that would not only create a better camaraderie with the teams but also to help the sponsors because this rule meant many pitchers and bottles of "brewskis" could make a slow night a good night for an owner.

The caliber of ball picked up as players from the other league decided to come "down" to the Social League. The Concordia Club, Sweetheart Inn, Post 122 and the Andover team were the top teams and The Jeff's formerly The Jennie's were making their presence felt. Players that eventually came to the upstart league were perennial all stars Tommy DiResta a great and gifted player who was a pitcher but

could play any position on the field and in most cases better than anyone.

Don Overka was also a player of any position. Larry Klimas the former great Methuen High coach who has passed away also came into the league, the Methuen Fieldhouse bears his name to this day. His great pal and high school teammate also a great Coach at LHS came into the league with his buddy Larry and they were also premier players. I'm talking about John Kelleher, of course, and he also joined Larry in heaven at a much too young age. I believe with all the construction of school buildings that Kell should be honored with a field or gym bearing his name.

Billy Timmons, Dickie Lynch and Dickie McCarron were other stars that came into the social league. A year or two later the great pitcher Dick Krausse joined in and so did Lowell's great pitching star Ernie Wilson he of the tantalizing off speed stuff that could drive batters crazy.

Dave Downey was spinning his magic for the Concordias and he was no walk in the park. Buddy Ralph, Jimmy Wefers, Willie Cartier, Irv Wermers, Nick Carnett all played on the two fisted beer drinkers club of which it is said "that this team would spill more hops than most teams would drink." They didn't miss any "Hops" on the field.

Ray Tremblay managed the Post 122 and had now retired from the telephone company and still lives in Methuen. Dick Drummond, as his pitcher and brother Don an all time great, still talked about as one of Central Catholic's all time greats. He lives in Florida now and a few years ago he led a senior citizens team to a national championship in slow pitch softball.

Barney Reilly called "Buckshot Barney" in those days. Barney was better in all sports than most players in the area; he was an excellent shortstop. He's the city's director of the aging these days. The Sweetheart Inn featured Bobby Fitzgerald a former Lancer and Northeastern University star who became the Athletic Director at Greater Lawrence Technical School; he now is probably swapping game strategies in heaven with Klimas and Kelleher two of the many players he coached at LHS.

Barney Parley a transplanted New Yorker and Raytheon retiree, Terry Keaney and former Central Catholic great three-sporter Freddie Nader who has just seen his grandson off to college at University

of Maine, Orono. There were many fine players and Al Kraunelis pitched for some of the teams and he has now gone to the great cigar store in the sky.

Bob Ryan now retired from Pease air force base pitched in the league first for the Merrimack Club and later for the Jennie's and The Jeff's. Jackie Poremba was a pitcher for a short time for the Jennie's and his brother Bob called "Satch" was a hurler for both the Jennie's and Jeff's. The Poremba family owned the Richwood hotel and bowling alleys on South Union St.

Jack Gushing (I think he came from North Andover) was a pitcher as was Bob Fanning a retired cop from Andover. I don't recall who Gushing pitched for but Fanning pitched for me while I managed the South Lawrence teams.

The Ward Six team had some young and potentially great players and the late Stevie Borys had the tools to be a fine pitcher and was a fine shortstop, he was the owner of the Calumet Club that's still on the corner of Shattuck and Broadway in South Lawrence. His wife Cathy is a retired school principal and his father in law was Gene McCarthy a fine Lawrencian.

Jack Gage a former LHS athlete played a strong third base and that team was always a threat to beat to top teams in the circuit. They were close friends and even after a loss they would handle it with class and enjoy whatever club they would be visiting.

In the future I'll try to bring more social league stories of the early days and if you see me and care to refresh my memories days, feel free to do so.

Mayor Officially Invites Verizon FiOs to Provide Telecommunications in City

Mayor James J. Fiorentini announced that the City had extended a formal invitation to Verizon to bring its FiOs fiberoptic telecommunications network to Haverhill. Recently, Mayor Fiorentini met with Verizon External Affairs Regional Director Stan Usovitz, a former mayor of Salem, urging him to consider expanding Verizon's services into Haverhill and its growing market.

"I am committed to working with the Cable Television Advisory Committee in expanding choice for television, internet and other telecommunication services for Haverhill residents," Mayor Fiorentini stated. "Greater competition means lower rates and more value for residents, providing an even greater emphasis on quality and customer service. I hear from many residents who are very satisfied with Comcast, but many others have expressed to me that they would like a choice of cable and internet providers, and choice is what we are seeking to provide," noted the Mayor.

"While only Verizon will determine if they do in fact come to Haverhill, it is at least technically feasible as the fiberoptic network is already in the adjacent communities of Methuen and West Newbury," the Mayor pointed out.

The fiberoptic lines run contiguously from one community to another.

"If Verizon does decide to come to Haverhill, they would provide coverage throughout the entire City, leaving no neighborhoods without the service, which is one of my conditions," stated the Mayor.

The Mayor also emphasized the economic development value in fiberoptics.

In addition, at his meeting with Usovitz, the Mayor called on Verizon to reduce the number of 'double' utility poles located throughout the City. There have been numerous constituent complaints about the appearance of these poles.

City of Haverhill Saves Thousands in Fuel Costs under New School Bus Plan

Mayor James J. Fiorentini lauded the savings generated by a new plan undertaken by his administration that will save Haverhill taxpayers an estimated \$14,600 this year. Fiorentini detailed the reforms undertaken with the manner in which the City pays for gasoline for City school buses.

"Previously, Coppola Bus Company, which provides school bus transportation for the Haverhill Public Schools, would fuel up their own vehicles, paying taxes and high retail gas prices. These costs were then passed onto the City," Mayor Fiorentini explained. "Now, we have the City's fuel supplier (Dennis K. Burke) delivering diesel fuel directly to Coppola on the City's behalf. The invoices for this wholesale fuel are sent to and paid by School Department, free from Federal gasoline Excise Tax."

The savings are estimated at over 24 cents per gallon, with the school buses

using approximately 60,000 gallons a year.

"The savings equates to over \$14,600 a year," concluded the Mayor. "I'd like to thank our new Purchasing Director Bob DeFusco, the administration at Coppola Bus and the School Department for working together to find more efficient ways of doing business. These are the sorts of reforms and cost efficiencies we need to get us through these challenging fiscal times," noted the Mayor.

Mayor Orders Hiring and Spending Freeze for City of Haverhill

Mayor James J. Fiorentini today announced that he is immediately ordering a hiring and spending freeze for the remainder of the fiscal year.

Fiorentini ordered a freeze on all new, non-essential hires. The hiring freeze will leave a number of positions in the City vacant.

Fiorentini also ordered that all expenditures of \$500 or more must be personally reviewed and signed by him.

The Mayor said that he was determined to strictly limit all spending in the City prior to next year budget.

Fiorentini stated: "I have ordered an immediate freeze on all hires in the City. We will leave a number of positions vacant until we put together the FY09 Budget. We know that we will have a large budget deficit in FY09. We have seen this coming for some time and have been planning for it. We've been building up our tax base, making structural changes to health insurance and reorganizing city government. Even with these long-term structural changes, we know we have a deficit in FY09. It would be foolish to hire people at this point since under our union agreements the last people hired are the first ones let go in a lay-off."

Observations of a Recent City Council Meeting

There I sat awaiting the start of what would be a council meeting with the semblance of a meaty agenda that did not involve tax hikes and budget cuts. While watching our Lawrence city council in action recently there were some interesting events at the council's February 6th meeting that provoked bemusement, head scratching, and wariness. Regardless of what you thought, we taxpayers really need to be on the alert before the rest of the contents in our ever-shrinking wallets are seized.

First it's good to see that at least one councilor – Grisel Silva – seems to take her job seriously and has demonstrated a willingness to work with the mayor's office on bringing some sanity to the perennial running joke known as the city's budget process. This year, however, love is in the air as the councilors – for now – are communicating with the administration without the rancor and venom that has visited the chamber in the past.

But keep your radar up. At the council meeting Silva presented a document for review that apparently has been worked out in advance with the city's budget director, Mark Andrews, that would designate over 30 "decisional" points in a schedule for the city to hit in order to make the FY09 budget come in on time and balanced. This document was the subject of discussion at the Budget and Finance subcommittee meeting the following week. There seems to be a lot of "oohs" and "aahs" that such a

document exists, that people are impressed with the fact that a schedule could be in place to guide everyone in this process. Wow! Managers actually managing. Could this be a first? However, if everyone just focused on following state law and the city charter the city could have its budget in place by July 1 like it is supposed to with plenty of time to spare and without all the fanfare and slight of hand.

Where the taxpayers should be concerned are on two fronts. First Andrews kept saying at both meetings that he would be talking with the unionized city employees to get their ideas on cuts and consolidations. If you actually think the unions would contemplate a reduction in their compensation, there is a bridge for sale in Brooklyn you can buy for a \$1. All Andrews – and the mayor for that matter – should be telling them is that come the next negotiation their contracts would be more in line with the private sector – no raises and a 50/50 sharing of health care costs. Why during a recession while all the rest of us are going without should municipal employees keep getting raises? If they don't like it, they can go find a job somewhere else – no one has a right to a cushy city job. Further, at a minimum, Andrews should get a hold of the list of cuts and consolidations that Silva and former councilor Nunzio DiMarca put forth last year as a good starting point. The wheel does not need to be re-invented.

Second, there seemed to be a lot of talk of meetings with councilors and Andrews outside the scope of a public scrutiny. The reduction of transparency in the process, again, cannot mean a good thing for the taxpayers. The taxpayers need to make sure

that they have more – not less – say in the manner in which the budget is going to be developed. Councilors and taxpayers need to be sure not to be lulled into a false sense of security brought on by the smooth talk and excessive flattery the budget director throws around each night at the council meetings.

Finally, if the councilors are going to be presenting and discussing major documents like this, it would be nice if they made it onto the city's website so that all of us can look at what is being proposed. Short of driving down to the clerk's office during the middle of the day and hoping that it is open, we have no other way of obtaining such documents. Just put everything on the website! If the city's website won't work, put it on Methuen's or Andover's website if you need to. Theirs are pretty good and are easy to work.

A few quick points. Kudos to Nilka Alvarez Rodriguez for fighting back against council president Patrick Blanchette for the disrespectful and sarcastic manner in which he treated her. It is a sad day when councilors cannot do their job and articulate their support for issues key to their constituencies without having to face the unnecessary personal attacks from the one wielding the gavel.

In a sign the Nick Kolofoles clearly has lost something on his fastball, he admitted that as chair of the Ordinance subcommittee he put out a document favorably from committee naming a certain park using a Spanish word he had no clue as to what it meant. No intellectual curiosity lost on him. No due diligence need apply at the Ordinance committee. Repeat after me, "esperanza" means "hope".

And then in a sign that councilor Kolofoles can no longer hit the curve ball, he let go of a matter that would have implications on our badly strained budget situation. At one point in the discussion regarding the development of a park at the old Covanta site, it came out that the property owner had a fire watch lien on certain property he owned (it was unclear whether this property involved the park project or was adjacent to the park project). The total of the lien - \$87,000. However, city attorney Charles Boddy let it slip that the lien was satisfied by the property owner for an amount less than the total owed. Kolofoles asked several times what the settlement amount was. But each time Boddy was prevented from answering the question by president Blanchette. Why? Who was Blanchette protecting - perhaps his good buddy the budget director, Mark Andrews, who had to sign off on the lower amount? What is the big secret? How bad (for the taxpayer) was the reduction? Perhaps we have such big budget surpluses now that we can give money away? Why did you drop the bone, councilor Kolofoles, once it was firmly wedged in your mouth?

Finally, instead of handing out citations each week to city employees who are simply doing what they are paid to do, howabout next time looking into why some fire hydrants did not work at the Park Street fire and the Millenium night club inferno? Hopefully your neighborhood won't be next.

This facility will also be the first Hospice House in the state with some of the rooms specifically designed for the needs of pediatric hospice patients and their families.

Throughout the year, Home Health VNA patients have benefited from the

support of the Griffin White organization in many ways. The Griffin White Foundation offers discretionary funds for the agency's clinical staff to use for patients. One recent example of this generosity was when a visiting nurse noticed that a patient would benefit from the use of a lift chair. The patient was mobile once in a standing position, but struggled a great deal to get there. She was aware of the funding from the Griffin White Foundation, and immediately mentioned it to her manager. Funds from the Griffin White Foundation were used to purchase a \$1600 chair for the patient, and her quality of life has improved tremendously.

"The Griffin White Foundation has partnered with us in the past to bring the best quality of life we can to our patients," said Joan Styges Hull, RN, MBA, President /CEO of Merrimack Valley Hospice and the Home Health Foundation. "And we are thrilled with their pledge of \$50,000 to our Hospice House project. Journalist, Authority on Irish Affairs to Speak at NECC

Internationally recognized journalist Kevin Cullen will share his observations of today's Ireland in a lecture "A Terrible Beauty: Ireland in the 21st Century" during Northern Essex Community College's White Fund lecture on Sunday, March 2, at 2 p.m. in the White Fund Room at 78-82 Amesbury St., in the Louise Haffner Fournier Education Center in Lawrence.

Cullen lived in Ireland experiencing its people and culture, first as a student and then as a journalist. He witnessed the transformation as Western Europe's poorest country became its richest. Ireland has gone from an agrarian economy to one that is second only to the United States in the manufacturing of software. Cullen explores the arrival of this primitive little island entrenched in poverty to a country with a per capita wealth index second only to Japan.

"It is a story," Cullen says, "that draws on and draws portraits of harried Dubliners, righteous Bible thumpers in mid-Ulster, former terrorists, self-made millionaires, barstool philosophers, and, as Sting once put it, poets, priests, and politicians."

Cullen has worked for the Boston Globe since 1985. He completed

several stints in the Globe's investigative unit, the Spotlight Team, and was part of the team that exposed mobster James "Whitey" Bulger as an informer who was protected by the FBI.

He covered the conflict in Northern Ireland for more than 20 years. In 1995 he was awarded the citation of excellence by the Overseas Press Club of America for interpretive reporting in Northern Ireland. In 1997-1998, he was the Globe's Dublin bureau chief, then moved to London to serve as the paper's chief European correspondent, covering the war in the former Yugoslavia.

The Irish Times described him as "the most informed American journalist on Irish affairs," while the media critic at the Independent of

London called him "the most astute observer of Irish affairs in the American media...and one of the most level-headed commentators on Northern Ireland on either side of the Atlantic."

Cullen is a frequent commentator on the BBC, RTE, and National Public Radio, and a regular contributor to the Sunday Business Post and The Irish Times.

In 2001, after four years abroad, he returned to Boston and joined the Globe's investigative team that broke open the sexual abuse scandal in the Catholic Church, for which the team received the 2003 Pulitzer Prize for Public Service. In more recent years, he has reported from Iraq and in July 2007 was appointed as a metro columnist.

Born in Boston, he grew up in Malden

and graduated from the University of Massachusetts, attended Trinity College in Dublin, and was a Nieman Fellow at Harvard University. He is co-author of "Betrayal: The Crisis in the Catholic Church," and was a contributor to the book, "Britain and Ireland: Lives Entwined II."

The White Fund's purpose is to have a free series of interactive presentations for Lawrence area adults, youth, and children. The audience is encouraged to seek wisdom, cultural enrichment, and intellectual enhancement by attending and participating.

Funded by a generous financial gift from the Honorable Daniel Appleton White, the White Fund Lecture Series has provided cultural conversation featuring well-known lecturers in fields such as history, literature, travel, the arts, and politics. The White Fund is collaborating with Northern Essex on this series.


COCO
