# Comerciantes, tengan cuidado

**Ú**ltimamente hemos estado recibiendo llamadas de comerciantes que se han sentido intimidados, por los que ellos creen que son empleados de la ciudad o inspectores del estado, que vienen y les ofrecen sus servicios.

De acuerdo con Yolanda Rodríguez, propietaria del Four Seasons Laundromat, localizado en el 149 de la Calle Lawrence, en Lawrence, MA, el sábado, 15 de marzo, 2008, "Isaías Mencía, propietario de Mencía Fire Appliances, localizado en el 157 de la Calle Lawrence, en Lawrence, MA, entró en su tienda acompañado de otro hombre, fue directamente hacia los extintores, removió las tarjetas diciendo que la inspección había caducado, las remplazó con las de su compañía, los cambió de sitio y se marchó, no sin antes dejar una cuenta de \$75.00 por sus servicios".

Rodríguez dijo que, al día siguiente, ella había rehusado pagarle a Mencía cuando vino a cobrar. "Yo le dije que la inspección había sido hecha sin mi autorización. Sólo la persona que atiende el lugar estaba aquí y ella se había llevado la impresión de que eran dos inspectores de la ciudad", dijo.

Mencía de puso de mal humor, removió sus tarjetas de los extintores y se marchó, no sin antes decirme a mí y a otra persona que estaba aquí que no quiso ser identificada, que yo, como dominicana debía hacer negocios con él, no con otra compañía tan distante".

Cuando contactamos a Isaías Mencía, nos dijo que el hombre que estaba con él era alguien que había comenzado a trabajar recientemente con él. No facilitó su nombre. "Cuando entramos en el Laundromat, pedimos permiso para hacer la inspección y se nos fue otorgado por el novio de Yolanda

Rodríguez, que estaba allí", dijo Mencía y añadió, "Yo le hice un favor, ya que las etiquetas de los extintores estaban vencidas y los extintores estaban colocados muy alto. Ahora están donde deben estar de acuerdo con el código", dijo Mencía.

Rumbo se puso en contacto con Dick Mohahan, Manager de Keane Fire Safety, localizado en el 1500 de la Main Street, en Waltham, MA, la compañía que inspecciona los extintores de Four Seasons Laundromat. "Esas tarjetas fueron colocadas en los extintores durante mi última visita el 27 de septiembre, 2007 y eran buenas hasta septiembre del 2008. Es ilegal removerlas, a menos que lo autorice el dueño del local", dijo Monahan, que prometió venir al Laundromat a reemplazar las tarjetas.

Rumbo se puso en contacto con el Inspector de Incendios, Ray Silva, en el Departamento de Incendios de Lawrence, que dijo no estar al tanto de que Mencía tuviera licencia para inspeccionar extintores.

Mencía está en total desacuerdo con esta afirmación. Él dijo que el Departamento de Incendios de Lawrence no es el que emite esos permisos y es la razón por la que Silva no lo sabe. "Ese ha sido un permiso que yo siempre he tenido pero que no me había decidido a hacer inspecciones de extintores hasta recientemente", dijo y añadió, "Yo tengo 5 permisos diferentes de supresión de incendios".

"Yo nunca vi ese permiso", dijo Silva. Rumbo solicitó de Mencía el número de ese permiso, pero dijo no recordarlo. Cuando se

# La verdad sobre la violencia escolar

**P**orque me preocupa la violencia que existe en las escuelas públicas de Lawrence y cómo tratan de taparla, envié un mensaje electrónico a todos los oficiales electos en Lawrence el 15 de marzo del 2008. Todos sabemos que hay una comunicación directa entre la oficina del alcalde y el Departamento de Policía con el diario de la ciudad cuando ellos quieren a un fotógrafo en el sitio y ellos se callan cuando la administración no quiere que las cosas se sepan.

Tal es el caso con estos ataques recientes. Los padres deben enterarse de las condiciones en las escuelas donde sus niños asisten siempre. Yo tenía la esperanza, que como funcionarios elegidos, ellos tomarían una posición en este asunto y me lo dejarían saber. Aquí están algunos de los ejemplos de incidentes recientes:

El viernes, 13 de marzo, dos muchachas fueron sacadas de la escuela esposada. El incidente implicó a una de ellas que estaba castigada en la oficina (vestida de uniforme completo) y asaltó a otra hembra. "La pelea fue feroz y peligrosa," según un maestro. La chica que fue atacada está embarazada. El Subdirector Ed Reynoso recibió varios puñetazos y fue lesionado tratando de separar la pelea. "Pareció como si todo

el personal trabajando el turno del día en la Policía de Lawrence se apareció en la escuela para restaurar la calma," un maestro me dijo. Nada estuvo en el periódico.

La semana pasada una estudiante vigiló a otra chica. Esto fue también una pelea salvaje. La chica que fue atacada aventajó a su atacante porque se quedó con puñados de su pelo. Varios maestros y miembros del cuerpo de seguridad fueron lesionados al tratar de separar la pelea. Nada apareció en el periódico.

El mes pasado un estudiante masculino acaparó a otro estudiante en la escalera de la Escuela de BMF y le dio una serie de puñetazos tan salvajemente en la cara del otro estudiante que había sangre por todas partes. Esto fue un acto de venganza por un asalto sexual por parte de la víctima a la novia del atacador. Nada de eso salió en el periódico local.

En la Escuela Frost una chica de séptimo del grado fue asaltada sexualmente. Eso salió en el periódico. Que sus atacadores volvieran a la escuela no salió mencionado en el periódico.

El Dr. Laboy distribuyó un video inadecuado muy gráfico que muestra a un estudiante escondiendo numerosas armas en sus pantalones anchos. El video es

apropiado para entrenar a policías pero no lo es para los estudiantes. El Comité Escolar probablemente no vio el video y tuvo que depender de la descripción del superintendente pero le permitieron hablar y disculpar sus acciones.

En otra brillante movida de proeza trivial, el Comité Escolar de Lawrence estaba tan preocupado por un accidente de tráfico en Randolph, MA que ellos votaron de dar los estudiantes dos días más de vacaciones. Un estudiante resultó golpeado por un coche cuando alguien fue a votar, por lo tanto ellos decidieron cancelar las clases el Día de las Elecciones. Si ellos estaban tan preocupados por la seguridad de ellos,

los habrían mantenido seguro en la escuela mientras sus padres están en el trabajo. Los muchachos van a estar sin supervisión en las calles en vez de en las escuelas.

La Unidad de Pandillas de la Policía de Lawrence estuvo en las escuelas el lunes pasado, el 10 de marzo, y se reunió con todos los maestros. Les dijeron claramente que hay un problema grave de pandillas en Lawrence y en el high school. Of decir que la presentación de PowerPoint estaba escalofriante.

Para mi sorpresa, el lunes por la mañana, el Superintendente Escolar Wilfredo T. Laboy me había mandado un mensaje. Si fui sorprendida conque él me hubiese mandado un correo electrónico, yo me horroricé del contenido. El dijo, "Parece que los líderes de la ciudad están cansados de su sensacionalismo sobre las Escuelas Públicas de Lawrence. ¿Por qué no encuentra usted algo más positivo que hacer con su vida? ¡Por qué no se convierte en una voz para la resolución de problemas en vez de ser una constante cínica y crítica!"

De esa manera respondió a los

# IRS Enviará Pagos de Estímulo Automáticamente Desde Mayo

Debe Presentarse una Declaración para Recibirlo

**E**l Servicio de Impuestos Internos (IRS) indicó que en la mayoría de los casos los contribuyentes no tendrán que hacer nada más que presentar su declaración de impuestos para recibir los pagos de estímulo económico a partir de mayo de este año.

El IRS usará la información de la declaración de impuestos de 2007 que presente el contribuyente para determinar su elegibilidad y calcular su pago de estímulo. Los pagos a más de 130 millones de contribuyentes serán enviados durante varias semanas en la primavera y el verano o serán depositados directamente a cuentas bancarias para quienes seleccionan esta opción en su declaración, siendo ésta la manera más rápida para recibir su reembolso y también los pagos del estímulo.

En la mayoría de los casos, los pagos equivaldrán a la obligación tributaria en la declaración de impuestos, con un máximo de \$600 para individuos (\$1,200 declarando juntos). Quienes califican también recibirán \$300 adicionales por cada niño elegible

para el crédito tributario por hijos.

Los pagos a contribuyentes con ingresos más altos serán reducidos en 5 por ciento del monto de ingreso bruto ajustado por encima de \$75,000 para individuos y \$150,000 para quienes declaran juntos.

"La ley también permite pagos a ciertos contribuyentes sin obligación de impuestos, tal como trabajadores de bajos ingresos o aquellos que reciben ciertos beneficios", explicó Sara Eguren, portavoz del IRS. "Pero para esto debe presentarse una declaración de impuesto que incluya los beneficios que recibió la persona en el 2007", añadió.

Mientras que algunos contribuyentes de bajos ingresos o sin ingresos del trabajo podrían no estar obligados normalmente a presentar una declaración, el IRS enfatiza que deben hacerlo para recibir un pago de \$300 (\$600 en declaraciones conjuntas) si tuvieron ingresos calificados, como beneficios del Seguro Social, ciertas Jubilaciones Ferroviarias, y ciertos

# Cartas acerca del Estímulo Económico Especial Llegarán a Buzones en Marzo

**M**ás de 130 millones de hogares en los Estados Unidos comenzarán a recibir cartas del Servicio de Impuestos Internos (IRS) la próxima semana recordándoles que presenten una declaración de impuestos de 2007 para recibir un pago de estímulo económico de 2008.

"La notificación es informativa y no solicitará datos financieros de los contribuyentes", dijo Sara Eguren, portavoz del IRS, alertando al público a estar conscientes de que siempre hay estafadores al asecho. "Si le exigen algo más que llenar una declaración de impuestos federales para recibir su pago de estímulo hágase saber al IRS escribiendo a [phishing@irs.gov](mailto:phishing@irs.gov)", agregó.

Los envíos postales del IRS comenzarán la primera semana de marzo y continuarán durante todo el mes. Además, se dividirán en tres grupos semanales, y el envío principal será dirigido a quienes presentaron una declaración el año pasado. La notificación informativa,

titulada Notificación del Pago de Estímulo Económico (Economic Stimulus Payment Notice en inglés), alerta a las personas de que podrían ser elegibles por vez única para un pago de estímulo económico de hasta \$600 (\$1.200 casados declarando juntos) comenzando en mayo. También hay un pago de \$300 por cada niño calificado menor de 17 años de edad.

'Para recibir un pago en 2008, los individuos que califiquen no tendrán que hacer nada más que presentar una declaración de impuestos para 2007. El IRS determinará la elegibilidad, calculará el monto y enviará el pago', señala la notificación. 'Este pago no debe ser confundido con cualquier reembolso de impuestos de 2007 que el gobierno federal le deba a usted. Los reembolsos de impuestos por ingresos de 2007 se harán por separado de este pago único'.

Sin embargo, las personas que no suelen presentar declaraciones de impuestos deben tomar un paso adicional este año para recibir un pago de estímulo. A fines de marzo, el IRS enviará una notificación especial a ciertos destinatarios del Seguro Social y el Departamento de Asuntos de Veteranos. Por lo general, esos beneficios no están sujetos a impuestos y los destinatarios no presentan declaraciones. Para recibir un pago de estímulo, las personas en este grupo necesitan presentar una declaración si tienen por lo menos \$3.000 de la combinación de ciertos beneficios del Seguro Social, beneficios de veteranos e ingresos del trabajo. El pago de estímulo mínimo para estas personas es \$300 (\$600, casados declarando juntos).

Pronto estarán disponibles más detalles acerca del envío especial para destinatarios del Seguro Social y de beneficios de veteranos.

# Cámara aprueba resolución para ayuda local

\$5.26 billones presupuestados; las ciudades y pueblos no sufrieron a pesar de la insuficiencia de renta

**E**l Representante Estatal William Lantigua (D-Lawrence) se unió a sus colegas en la Cámara de Representantes para pasar una resolución local de ayuda temprana que aumentará la asistencia estatal a ciudades y pueblos en el presupuesto del año fiscal 2009 por \$223 millones. La resolución fue concordada por escritores de presupuesto de la Cámara y el Senado y esperan que sea debatido en el Senado en las próximas semanas.

La resolución proporciona un aumento en la ayuda local que representa un 4.43 por ciento sobre el año pasado e incluye las tres categorías mayores de la ayuda local – financiación del Capítulo 70 para escuelas públicas, la ayuda de la lotería y ayuda adicional. La aprobación de una resolución local de ayuda casi cuatro meses antes del comienzo del año fiscal ayudará a Lawrence a planear su presupuesto municipal con más confianza y certeza. Garantiza que

Lawrence recibirá \$136 millones en el Capítulo 70 ayuda educacional, \$190,699 en fondos de asistencia adicional de ayuda, y \$24.2 millones en la ayuda de la lotería, para una suma de \$160.4 millones en el año fiscal 2009. Greater Lawrence Technical School recibirá \$21.4 millones en el Capítulo 70 financiación.

"La aprobación de esta resolución casi dos meses antes de nosotros debatir el presupuesto es un signo claro que la Cámara ha puesto las necesidades de las ciudades y pueblos muy altos en el orden del día," Lantigua dijo. "A pesar de un clima fiscal duro nuestro apoyo para la ayuda local se queda y hemos proporcionado un aumento sostenible a la vez cuando muchas otras partes del presupuesto pueden ver las reducciones".

"Las ciudades y los pueblos necesitan nuestra ayuda y una vez más, la Legislatura aumenta las dos necesidades críticas de los municipios – las escuelas y la ayuda local," dijo el Speaker de la Cámara Salvatore DiMasi (D-Boston). "Mientras que este año difícil en el presupuesto demanda cortes, a

través de la eficiencia y el gasto sabio el gobierno del estado, y me complace que este acuerdo asegura que cada comunidad en el estado verá un aumento en la ayuda local basada en formas fiables de renta".

"El Representante Estatal Lantigua se ha unido a nosotros hoy para asegurar que las ciudades y pueblos del estado son protegidos aún en estos tiempos de dificultad e incertidumbre fiscales. # House Passes Early Local Aid Resolution

\$5.26 Billion Budgeted; Cities and Towns Held Harmless Despite Revenue Shortfall

**S**tate Rep. William Lantigua (D-Lawrence) joined his colleagues in the House of Representatives to pass an early local aid resolution that will increase state aid to cities and towns in the fiscal year 2009 budget by \$223 million. The resolution was agreed to by House and Senate budget writers and is expected to be debated in the Senate in the coming weeks.


The resolution provides an increase in local aid representing a 4.43 percent hike over last year and includes the three major categories of local aid – Chapter 70 funding for public schools, lottery aid and additional assistance. Passage of a local aid resolution nearly four months before the start of the fiscal year will help Lawrence craft its municipal budget with greater confidence and accuracy. It guarantees that Lawrence will receive \$136 million in Chapter 70 educational aid, \$190,699 in additional assistance funding, and \$24.2 million in lottery aid, for a total of \$160.4 million in fiscal 2009. Greater Lawrence Technical School will receive \$21.4 million in Chapter 70 funding.

"Passage of this resolution nearly two months before we even debate the budget is a clear sign that the House has put addressing the needs of cities and towns high on the agenda," Lantigua said. "Despite a tough fiscal climate our support for local aid remains and we have provided a sustainable increase at a time when many other parts of the budget may see reductions."

"Cities and towns need our help and, once again, the Legislature is increasing the two most critical needs of municipalities – schools and local aid," said House Speaker Salvatore DiMasi (D-Boston). "While this difficult budget year demands cuts, efficiencies and wise spending throughout state government, I am pleased that this agreement ensures every community in the Commonwealth will see an increase in local aid based on dependable forms of revenue."

"Rep. Lantigua has joined with us today in ensuring the Bay State's cities and towns are protected even in these times of fiscal difficulty and uncertainty. Our resolve to help cities and towns has never been stronger and we demonstrate that local aid is a top priority year after year by giving municipalities billions of state dollars to help pay for basic local services," said Representative Robert A. DeLeo (D-Winthrop), chairman of the House Committee on Ways and Means.

The resolution guarantees cities and towns will receive \$935 million in unrestricted local aid, \$811 million of which is generated by the Massachusetts Lottery and \$124 million of which is allocated from the Commonwealth's General Fund. Since the lottery was "uncapped" by the Legislature in fiscal 2007, all revenue other than prize money and a small amount for administration goes to municipalities.

Si ellos no pueden, que se comuniquen de inmediato con esta oficina o que den parte a la Policía de Lawrence", dijo Burke y añadió, "También, nuestro personal ha sido oficialmente entrenado para recibir o pedir pagos en efectivo. Todos los pagos han de ser pagaderos a la Ciudad de Lawrence, por medio de cheques o Money Orders", terminó Burke. Mientras nos encontrábamos en el Ayuntamiento de la Ciudad de Lawrence, el Code Enforcement Inspector Jorge A. De Jesús reportó que otro comerciante, el Sr. Marco Polo Rodríguez el cual está remodelando su antiguo negocio (El Gallinazo) localizado en el 326 de la Calle Lowell, había tenido un problema con un individuo que entró a su tienda a hacer una inspección, vestido con una chaqueta roja y letras amarillas que decían "Fire Marshall". Rodríguez, que no lo conoce, fue informado de que antes de que reabriera, tenía que reemplazar toda la cocina, y comenzó a darle precios.

Aquellos que conocen a Marco Polo Rodríguez, que por su propia admisión dice "no tenerle miedo a nadie", mandó al individuo a hacer buñuelos. "La ciudad debía hacer algo para protegernos de personas como ésta".

"Creanme", dijo el Comisionado Burke. "Estamos tratando. Oímos esos rumores todo el tiempo pero necesitamos la ayuda del pueblo, necesitamos que las personas nos traigan sus quejas y cualquier información que tengan. Es la única forma que podemos ayudarlos".

## AYUDA: Cámara aprueba resolución para ayuda local

ciudades y pueblos recibirán \$935 millones en la ayuda local sin restricción, \$811 millones que son generados por la Lotería de Massachusetts y \$124 millones de que son asignados de los Fondos Generales del estado. Desde que la Legislatura le quitó el máximo a la lotería en el año fiscal 2007, todo el dinero aparte de los premios y una pequeña cantidad para la administración, va a municipios.

beneficios de veteranos, además de ingresos del trabajo, que sumen por lo menos \$3,000.

Es necesario tener un Número de Seguro Social válido para calificar para el pago de estímulo. Los contribuyentes que presentan sus declaraciones usando un Número de Identificación Personal del Contribuyente (ITIN) emitido por el IRS, o cualquier número emitido por el IRS no califican. Tampoco son elegibles los individuos que pueden ser reclamados como dependientes por otra persona, o quienes presentan la Forma 1040-NR, 1040-PR o 1040-SS.

Para atender a quienes declaran impuestos más tarde en el año, el IRS continuará enviando pagos hasta el 31 de diciembre de 2008. El IRS también advierte a los contribuyentes que si presentan su declaración de impuestos para 2007 y luego

se mudan que deben presentar al Servicio Postal de EE.UU. una tarjeta de cambio de dirección.

El IRS enviará dos notificaciones informativas a los contribuyentes alertándoles acerca de los pagos de estímulo. 



# The truth about school violence

**B**ecause I am very concerned about the violence going on in the Lawrence Public Schools and how it is covered up, I sent an email to all elected officials in Lawrence on March 15, 2008. We all know that there's direct communication between the mayor's office and the police department with the daily newspaper when they want a photographer on site and they keep quiet when the administration doesn't want things to get out.

Such is the case with these recent attacks. Parents should be made aware of the conditions at the schools where their children attend at all times. It was my hope, as elected officials, that they would take a stand on this issue and let me know their position. Here are some examples of recent incidents:

On Friday, March 13, two girls were taken out of the school in handcuffs. The incident involved a girl who left in-house suspension (in full uniform) and assaulted another female. "The fight was vicious and dangerous," according to a teacher. The girl that was attacked is pregnant. Assistant Principal Ed Reynoso received several punches and was hurt breaking up the fight. "The entire day shift of the Lawrence Police Department showed up at the school to

restore calm," a teacher told me. Nothing was in the paper.

Last week a female student stalked another girl. This was also a vicious fight. The girl who was attacked got the best of her stalker by pulling out fistfuls of her hair. Teachers and security were hurt breaking up that fight. Nothing was in the paper.

Last month a male student cornered another student in the stairwell of the BMF School and savagely punched the face of another student. There was blood everywhere. This act was in retaliation for a sexual assault by the victim to the attacker's girlfriend. Nothing was in the paper.

At the Frost School a 7th grade girl was sexually assaulted. That made the paper. Her attackers returning back to school didn't make the paper.

Mr. Laboy distributed an inappropriate and graphic video showing a student hiding numerous weapons in his baggy pants. The video is fine for police training but it is inappropriate for a school setting. The committee probably didn't see the video and had to rely on the superintendent's description of it. The school committee allowed him to talk his way out of it.

In another brilliant move of trivial prowess, the Lawrence School Committee

was so worried about a car accident in Randolph, MA that they voted to give the students two more holidays. A student was hit by a car when someone was on his way to vote, so they decided to cancel classes on Election Day. If they were so concerned about their safety, they would have kept them safe at school while their parents are at work. Unsupervised children will be on the streets instead of in schools.

The Lawrence Police Gang Unit was in the schools last Monday, March 10, and met with all teachers. They were told there is a serious gang problem in Lawrence and

the high school. I heard the PowerPoint presentation was chilling.

To my surprise, by Monday morning, School Superintendent Wilfredo T. Laboy had sent me a message. If I was surprised that he had sent me an email, I was shocked at the content. He said, "It seems that city leaders are truly tired of your sensationalism of Lawrence Public Schools. Why don't you find something more positive to do with your life? Why don't you become a voice for problem solving and instead of being a constant cynic and critic!"

That was his way of responding to the real incidents that I outlined. All I am doing is exposing the corruption that he has instituted and that all the public officials, elected or appointed, are willing to overlook. After seven years in this system, Lawrence is still at the bottom - if not getting worse – according to the Department of Education.

It is a "black mark" against the teacher who tries to discipline a student. It doesn't "look good" for the system just like keeping track of the attendance or the drop out rate at the high school. The discipline committee

## It's All About Right(s)

This article was published on March 15, 2002. Nothing has changed and the public should be aware of this so, why write a new one?

### The secret of 4 Gleason Street

A big dirty secret. Four years ago, when I found the town to be derelict in their duty to protect the health and safety of its citizens, I began watching the goings-on very closely. Much of the time it has been a bumpy ride, but if we the citizens do not hold our elected and appointed officials accountable, ultimately we have no one else to blame but ourselves when our hired help oversteps their bounds.

The story I am about to tell is once again about the utter audacity this administration has when it comes to informing the people and protecting their safety and well being. After all, it is the only reason this bureaucracy exists in the first place.

4 Gleason Street is located in the Central District. It is a little dead-end street located directly across from Friendly's Ice Cream Shoppe. The street consists of on one side an old defunct gas station and an old factory at the end which once housed the company Unitrode, and more recently Shear Metals. The other side of the street is lined with houses, where mothers and fathers live with their children.

On January 9, 2001, David Skelly, Health Inspector came in front of the Town Council, requesting a Declaration of Nuisance, 4 Gleason Street. As I stated above, I have been keeping a keen eye on what is going on around me. I cannot be everywhere at one time, so a couple of years ago, when a resident at 15 Gleason Street, Linda Gerard, called me and relayed a story that would raise the hair on the back of your neck, we agreed at that time she would keep me posted as to the disposition



of this property, 4 Gleason Street. Council kept a low profile on this item, and agreed to table this request. The subject dropped, and I thought no more about it at the time, until I received a call from Linda Gerard.

Jump in the way back machine with me. The year is 2000, the date is October 17. Front-page news in the Eagle Tribune reads, CHEMICALS BEING LEFT ON EMPTY LOT. "Her neighbor, Mark, who requested his last name not be used, said he smelled a 'strong chemical smell' coming from the old factory late at night last week, at approximately the same time when he saw several people walking around the property on Gleason Street."

"Earlier this month, Conservation Officer Joseph Giarrusso found 11 50-gallon barrels, of what he said appears to be waste oil, illegally dumped on the sight of the Shears Metal," stated the Eagle-Tribune article.

The same article also said that, "Mrs. Gerard and several of her grandchildren said they have seen people on several occasions unloading barrels on the property, but Mr. Giarrusso said this was the first time he has found anything illegally dumped there.

Mr. Giarrusso said illegal dumping is 'unfortunately not as uncommon' as he would like and has found barrels in other locations in Methuen."

Linda Gerard has been calling the town officials since July 2000, reporting trucks coming and going all hours of the night. Linda Gerard describes the fact that trucks loaded with waste barrels drive onto an abandoned factory site across from her house and then leave without the barrels.

Did I forget to tell you that this building did not have electricity? Tell me what kind of clean up could one be doing in the dark of night? These boys must have had X-ray vision or miner's hats at the very least!

Let's fast forward to the present, and I will now relay what our investigation has uncovered. On March 1, 2002, Linda Gerard and I visited the offices of the DEP, (Department of Environmental



# Merchants be aware

**L**ately, we have been receiving calls from merchants who feel intimidated by, what they believed are City or State inspectors, offering them their services.

According to Yolanda Rodriguez, owner of Four Seasons Laundromat, located at 149 Lawrence St., Lawrence, MA, on Saturday, March 15, 2008, "Isaias Mencia, owner of Mencia Fire Appliances, located at 157 Lawrence St., Lawrence, MA, walked into her shop, accompanied by another man, went directly to the fire extinguishers, removed the tags saying the inspections had expired, replaced them with his company tags, moved them to another location, and left, not before leaving an invoice for \$75.00 for his services."

Rodriguez said that she refused to pay Mencia next day, when he came to get paid. "I told him that the inspection was done without my permission. Only the attendant was here and she was under the impression that they were city inspectors," she said. "Mencia got very angry, removed his tags from the extinguishers and left, not before telling me and another customer who was present but who doesn't want to be identified, that I, as Dominican, should do business with him, also a Dominican, not

with another far away company."

Isaias Mencia, when contacted, said that the man with him was somebody who just started working with him. No name was given. "When we went into the Laundromat we requested permission to inspect the fire extinguishers and permission was granted by Yolanda Rodriguez's boyfriend, who was there," said Mencia and added, "I did her a favor, since the inspection was overdue and the fire extinguishers were placed too high from the floor. Now they are within code," said Mencia.

Rumbo contacted Dick Monahan, Service Manager of Keane Fire Safety, located at 1500, Main Street, Waltham, MA, the company who inspected the Four Seasons Laundromat's fire extinguishers. "Those stickers were placed on the fire extinguishers during my last visit there on September 27, 2007 and were good until September 2008. It's illegal to remove them, unless authorized by the Laundromat's owner," said Monahan who promised to come by the Laundromat to replace the stickers.

Rumbo contacted Fire Inspector Ray Silva at the Lawrence Fire Department who said that he was not aware if Mencia is licensed to inspect fire extinguishers.




Mencia strongly disagreed with this statement. He said that the Lawrence Fire Department is not the one who issues those permits, and that is why Silva didn't know. "This is the permit I always had, but not until recently I decided to do fire extinguisher inspections," he said. "I have

five different fire suppression permits," he added.

"I never saw that permit," said Silva.



Rumbo requested from Mencia the permit number but said that he did not remember it. When we asked him to fax it, he said, "My lawyer advised me not to do it," but gave us the names of several merchants where we could check his work, and prove him right.

Amongst them, El Típico Restaurante, next to the Laundromat. They refused to give any information or allow this reporter to walk into their kitchen. "The owner will comeback in two weeks," they said.

Another place was Marabú, on the corner of Union and Methuen streets. It was closed. Then, Rumbo went to Las Palmas Restaurant on Essex Street, where Mencia Fire Appliance did and maintain all the fire suppression needed to safely operate the business, including the fire extinguishers. Las Palmas restaurant owner was visibly upset with the Rumbo reporter's visit, and became irate when Fire Inspector Ray Silva showed up to check on a sticker placed by AAA State Fire Marshall, located in Lynnfield, MA. "This man, dressed in a T-shirt with the name Fire Marshall printed on it, came in, removed Mencia Fire Appliance's sticker, put his stickers on, and started giving me prices of what needs to be done. I thought he was a firefighter and then I realized he was not," she explained to Silva.

Since the operator of the Laundromat confused the two men who walked at their place with city inspectors, Rumbo contacted Inspectional Services Commissioner, Myles Burke who emphatically denied it. "All

City Inspectors carry a badge with their name and also a personal identification with their picture on, recently issued. I strongly suggest to any merchant who receives a visit from somebody saying that they are City Inspectors, to request from them those identifications. If they can't provide it, call this office immediately or report them to the Lawrence Police Department," said Burke. "Also, all our staff is officially trained not to receive or request payments in cash. All payments must be done by check or money order payable to the City of Lawrence," concluded Burke.

While at Lawrence City Hall, Code Enforcement Inspector Jorge A. De Jesus reported that another merchant, Marco Polo Rodriguez, who is remodeling his business located at 326 Lowell St. (Formerly El Gallinazo Restaurante) had a problem with a vendor who entered his business, clad in a red coat with yellow lettering printed "Fire Marshall" to do an inspection.

Rodriguez, who doesn't know the individual, was told that before he reopens, he has to replace the entire kitchen, and started giving him prices. Those who know Marco Polo Rodriguez, who by his own admission, "Is not afraid of anybody," told the man to "get lost." "The city should do something to protect us," said Rodriguez.

"Believe me", said Commissioner Burke, "We are trying. We hear these rumors all the time but need the help of the people; we need the people to come forward with any information they have. That is the only way we can help."

## LOCAL AID: Lantigua, House Pass Early Local Aid Resolution

In fiscal 2009, however, only \$811 million is projected to be generated – \$124 million less than was allocated last year. The Legislature's budget will ensure the additional \$124 million is distributed and that cities and towns are held harmless to last year's allotment.

The local aid resolution also maintains a commitment made by the Legislature

three years ago by increasing Chapter 70 allocations by \$223 million to \$3.95 billion. The increase comes as part of a five year plan to move individual school districts toward their target-aid contribution level. Under the Legislature's plan, each school district would see an increase in Chapter 70 funding over last year.

Protection), to view the file that existed on the property at 4 Gleason Street. THE FILE WAS NINE INCHES THICK! The latest documents in the possession of the DEP were dated in 1995.

Bottom line is Antimony, Arsenic, Beryllium, Cadmium, Chromium, Copper, Lead, Mercury, Nickel, Silver and Zinc was detected. Some were trace amounts, but nevertheless these substances were detected. (I will provide to anyone who requests the report from the DEP.) Other test showed tetrachloroethene, trichloroethylene, dichlorobenzene, and methylene chloride. The report shows that some of these substances were found in the ground water and the sewer system.

It is hard to decipher the information, because the PUBLIC INFORMATION, supplied by Methuen's own Health Department had been sanitized! I'M SHOCKED! The fact remains that according to the document I received from the DEP, only approximately 40 cubic yards of soil was excavated from a 17- by 24-foot area to depths ranging from 2 to 3 feet.

There was a Uniform Hazardous Waste Manifest, which stated the barrels that had mysteriously appeared at 4 Gleason Street contained 3 barrels of waste oil, 8 barrels of Trichloroethylene. Hey! Isn't that the same stuff that was detected in the soil in the 1995 report? Can you imagine, what a coincidence!

Another piece of information was an e-mail from the owner of the property, David P. Spada, to our very own Building Commissioner, Gerald Deschene. It is a friendly e-mail, sent by two people who obviously know each other. It starts out with, "I tried to call you but no answer." I'll just bet that queenie is kicking herself for the first time for closing down town hall

It is hard to decipher the information, because the PUBLIC INFORMATION, supplied by Methuen's own Health Department had been sanitized! I'M SHOCKED! The fact remains that according to the document I received from the DEP, only approximately 40 cubic yards of soil was excavated from a 17- by 24-foot area to depths ranging from 2 to 3 feet.

at 12 noon on Fridays, because if town hall had been opened, there would never have been any proof of this conversation! Back to the e-mail.

Spada is recalling a conversation with William (Baby Buck) Buckley, where BB informed him that "You People" want the building at 4 Gleason Street torn down immediately. Or else the town would go into court and tear down the building and sell the property. This e-mail is dated 1/4/02. It goes on to say that Spada also received a call from the Badge Boy Giarrusso, he suspects the same subject.


This is a line that I particularly found intriguing, "It sounds as though some folks are pretty upset with me (?). Bill made it seem as though I have not delivered on previous commitments - which I do not understand. I think that I have." It goes on, "Please be clear that I have been diligently pursuing a development plan for Gleason Street and have spent in excess of \$85,000 (in addition to the original cost of purchasing both sites) removing debris, undertaking a civil engineering study and survey, wetlands flagging, HUD (assisted living) appraisal and extensive DEP and EPA testing (ongoing over the last year) to get both parcels "out of the DEP Loop." "In fact, I filed my last report with the DEP providing a year's worth of data and analysis this past December 15th, 2001 and the (6 month, 10K) HUD demographic demand/supply study came back very positive with respect to the HUD parameters necessary for the approval for an assisted living senior housing project at that location."

The funny part about all these documents that Mr. Spada has filed on 12/15/01, not a one of them are on record at the DEP, or in the town records. For all my loyal readers, I am sure that you are all aware that HUD is FEDERAL MONEY, FUNDED BY OUR TAX DOLLARS! Isn't it amazing that it appears Spada is going to get away with tearing down a building, not cleaning up a toxic site, having the town of Methuen officials be accomplices in the deal, and install our elderly on a contaminated site, with us funding the project. How sweet it is!

I spoke with someone today that mentioned that line from the Christmas Carol, when Scrooge says there is a need to deplete the overburdened population. Is this how we are supposed to think about it, the elderly are old anyhow; they are going to die anyhow, who cares if a little toxicity contributes to their demise. Imagine less drain on the social security and Medicare rolls.
