**EDITORIAL | EDITORIAL****Cuando vote, ¡vote con su propio cerebro!**

**E**l cuarto de noviembre, día de las Elecciones Presidenciales, vamos a escoger no solo a un nuevo presidente y vicepresidente sino que será una decisión que hará a los historiadores escribir de nuevo la historia americana. Ese día vamos a escoger bien a un hombre con raíces afro-americanas para dirigir al país, o vamos a situar a una mujer en la posición de vicepresidenta, una novedad en la que no soñábamos hace unos cuantos años atrás,

En el sector local, también tenemos importantes decisiones que tomar. Hay tres preguntas las cuales debe contestar al momento de votar. La pregunta 1 se refiere a cortar el impuesto personal estatal en un 2.65% comenzando el 1ro de enero, 2009 y eliminaría totalmente el impuesto después del 1 de enero, 2010.

Si usted vota NO, no haría ningún cambio en la ley de impuestos del estado; pero si vota SI, estaría ahorrando 41% que desperdicia el gobierno del Estado de Massachusetts, de acuerdo a un estudio llevado a cabo por lo que proponen la idea. Votando SI, le devolvería \$3,700 como promedio a más de 3 millones de personas que pagan impuestos cada año en Massachusetts, ¡includiendo a USTED! Muy tentador, ¿verdad?

Muchas voces se han alzado en contra de votar SI en la pregunta uno. Ellos argumentan que esto recortaría los ingresos del estado en más de \$12 billones –casi 40% del presupuesto estatal, creando un efecto de dominó en cuanto a dramáticos cortes en la ayuda estatal a ciudades y pueblos, haciendo que aumenten los impuestos a la propiedad y reduciendo los fondos para servicios vitales locales.

La pregunta 2 es más sobre un punto de vista moral. Tiene que ver con legalizar la posesión de una onza o menos de marihuana. Votar SI eliminaría el peligro de arresto, cárcel, pérdida de préstamos estudiantiles y una larga lista de sanciones incluyendo la eliminación permanente de récord personal o CORI.

El argumento de los que se oponen es que aprobar la pregunta sería endosar el uso de sustancias nocivas y envía un mensaje erróneo a la juventud. Despenalizarla daría confianza a los vendedores de drogas y posee una amenaza a la seguridad pública y a la salud.

La pregunta 3 es tal vez la más difícil de todas, ya que estaríamos haciendo decisiones por otros, en este caso perros de carrera, que no pueden defenderse por sí mismos. Un voto de SI prohibiría a partir del 1ro de enero, 2010, las carreras de perros en sitios donde ocurran apuestas. Argumentos a favor incluyen crueldad y tratamiento inhumano de perros que merecen protección.

Un voto de NO, no cambiaría las leyes actuales que gobiernan las carreras de perros. Los que proponen votar NO, opinan que por miles de años estos perros (greyhounds) han sido criados para cazar por su velocidad, más rápida que las presas, y que los perros que corren en Massachusetts son propiedad de sus dueños, no de los establos y que no existe tal maltrato a los animales como dicen los activistas.

Antes de que usted se dirija a las urnas, asegúrese de que va con una clara noción de por quién y por qué usted va a votar. Ha habido una abundancia enorme de información disponible para ayudar a los votantes a tomar una decisión.

Como de costumbre, Rumbo no impondrá su opinión a los votantes. Consideramos que eso sería insultar su inteligencia. En vez, les presentamos ambos lados y dejamos que ellos decidan.

**EDITORIAL | EDITORIAL****When voting, vote with your own brains!**

**O**n November 4, on Presidential Election, we will be choosing not only a new president and vice-president but a decision that will make historians re-write the American history books. On that day we will be choosing either a man of Afro-American roots to lead the country or place a woman in the position of vice-president, a novelty unthinkable just a few years ago.

In the local arena, we also have important decisions to make. There are three questions that you will be asked to vote for. Question 1 in the ballot refers to cutting state personal income tax to 2.65% for the tax year beginning on January, 1, 2009, and would eliminate the tax for all tax years beginning on or after January 1, 2010.

If you vote NO, you would make no changes in state income tax law; but if you vote YES, you'll be cutting 41% waste in Massachusetts state government, according to a study made by the proponents of the idea. Your YES vote will give back \$3,700 to more than 3 millions Massachusetts taxpayers every year, including YOU! Very tempting, right?

Many voices have risen against the yes vote on Question 1. The argument is that it will slash state revenues by more than \$12 billion – nearly 40% of the state budget, creating a domino effect in dramatic cuts in state aids to cities and towns, driving up property taxes and reducing funding for vital local services.

Question 2 is one of a moral standpoint. It has to do with decriminalization of marijuana for the possession of one ounce or less. A YES vote will remove the threat of arrest, jail, and loss of student loans and a long list of sanctions including the elimination of permanent record (CORI).

Those opposed argue that the passing of the question will be an endorsement of substance abuse and sends a wrong message to young people. Decriminalization emboldens drug dealers and poses a threat to public health and safety.

Question 3, is perhaps the most difficult of all, because we will be making a decision for someone, in this case racing dogs, that can't defend for themselves. A YES vote would prohibit dog races on which betting or wagering occurs, effective January 1, 2010. Arguments in favor include cruelty and inhumane treatment of dogs that deserve protection.

A NO vote would not change the actual laws governing dog racing. Proponents of a no vote argue that for thousands of years greyhounds have been bred to hunt by outrunning their prey and that the dogs racing in Massachusetts are owned by caring dog owners, not tracks. There is no mistreatment of the dogs as animal activists claim.

Before you head to the polls, make sure you go with a clear notion of how and for whom you will vote. There has been an abundance of information available to help voters make their decisions.

As usual, Rumbo won't impose its opinion on the voters. We consider that an insult to their intelligence. Rather, we present them with both sides facts, and have them decide. ¡Vote, but vote with your own brains!

seguridad aún visibles alrededor de su cuello, su madre, María Alicea, lo llevó de regreso a la escuela a fin de que la directora Samaria Taveras-Hashem pudiera ver su estado y, desde allí, directamente a Lawrence Hospital General. El es un oficial de policía frustrado que fue despedido del Departamento de Policía de Plaistow en New Hampshire por haber usado fuerza bruta contra los ciudadanos, y ahora no lo quieren en la Policía de Lawrence a pesar de haber sacado la puntuación más alta en el examen.

En los años que ha estado trabajando

para el departamento escolar (aproximadamente desde 1996) ha tenido varios problemas. Sus supervisores han pedido su destitución, pero el Superintendente Wilfredo Laboy lo protege. Mis fuentes me han dicho que McCabe tiene el apoyo del superintendente por ser su informante.

Él tiene una larga lista de infracciones, tales como haber participado en un acoso sexual mientras se encontraba trabajando en la Escuela Frost en el 2003, pero fue protegido por Laboy. La directora de la escuela, Ellen Baranowski hizo que McCabe fuera removido de su escuela, pero fue ascendido por Laboy a la Oficina Central y a cargo de los guardias de seguridad. Más tarde fue degradado a guardia por su mala conducta como supervisor de los guardias y reasignado a una escuela.

Mientras tanto, McCabe se está atendiendo su negocio personal de construcción desde sus horas de trabajo.

## La Sociedad Americana del Cáncer alienta a las mujeres a que asuman el control de la salud de sus senos

La detección temprana es la clave para la reducción de los fallecimientos por cáncer del seno

A hora que el país va a celebrar el Mes Nacional de la Lucha Contra el Cáncer del Seno este mes de octubre, la Sociedad Americana del Cáncer (American Cancer Society) alienta a las mujeres a que combatan el cáncer del seno asumiendo el control de la salud de sus senos y apoyando los esfuerzos en la lucha contra esta enfermedad. La Sociedad está recordando a las mujeres de 40 años de edad y más la importancia de someterse anualmente a una mamografía para detectar el cáncer del seno en su etapa más temprana y tratable. Se espera que en el 2008 ocurran aproximadamente 182,460 casos nuevos de cáncer invasor del seno entre las mujeres de Estados Unidos, y que ocurran aproximadamente 40,480 fallecimientos a causa de esta enfermedad.

Los estudios han demostrado claramente que la detección temprana del cáncer del seno mediante mamografías mejora significativamente las opciones de tratamiento, las probabilidades de que el tratamiento tenga éxito y sobrevivan. El cáncer del seno en sus etapas tempranas típicamente no provoca síntomas cuando el tumor es pequeño y más tratable, así que es importante que las mujeres sigan los lineamientos recomendados para detectar el cáncer del seno antes de que presenten síntomas. En promedio, la mamografía detecta aproximadamente de 80 a 90 por ciento de los casos de cáncer de seno en mujeres que aún no presentan síntomas.

**HALLOWEEN, ¿ES UNA FIESTA QUE LA PUEDE CELEBRAR UN CRISTIANO?**

Puede parecer divertido disfrazar a los pequeños de la casa y salir a pedir dulces por las calles. Sin embargo, las fiestas que celebramos reflejan quiénes somos e influyen en nuestros valores.

Se hacen proposiciones indecentes con mayor impunidad, con frecuencia es un pretexto para esconderse y aprovechar la situación.

"No te dejes vencer por el mal, más bien derrota el mal con el bien" Romanos 12:21. Más que combatir la forma en que hoy se celebra Halloween, que nada tiene que ver con nuestras costumbres y valores, debemos retomar el verdadero y real sentido original de esta fecha, celebremos la "Fiesta de todos los Santos".

Celebremos esta fiesta en forma positiva, entretenida, sana y alegre y más acorde con nuestras costumbres y valores. Mantengamos los elementos buenos y positivos; celebrar, disfrazarse y compartir pero proponemos cambiar lo negativo.

Muerte y oscuridad, por vida; terror y miedo, por alegría; violencia, por paz y amor; amedrentamiento y chantaje, por respeto y entrega. Proponemos una celebración amplia, a la cual todos se sumen alegremente independientes de su cercanía con la religión.



# Aviones de juguete y medicamentos complicados

Un avión de juguete está formado de unas cuantas piezas. Un Boeing 747 tiene varios millones de piezas.

Tiene lógica. Los aviones de juguete son modelos pequeños y sencillos, las 747 son aeronaves grandes de alto rendimiento. El modelo, de fácil fabricación, cuesta unos pocos dólares. La fabricación de un avión 747 cuesta unos \$225 millones, debido a su complejidad.

Conviene recordar esta comparación al tratar del debate sobre los "medicamentos biológicos biosimilares" ["follow-on biologics"]. Los medicamentos biológicos constituyen los remedios de avanzada más complejos para el tratamiento del cáncer, la esclerosis múltiple y otras enfermedades de este tipo. Los medicamentos biosimilares son copias inexactas de dichos remedios.

Actualmente, el Congreso está considerando legislación que permitiría la venta de medicamentos biológicos biosimilares sin exigir la realización previa de pruebas exhaustivas, o sea, esencialmente tratando los medicamentos biosimilares como si fueran medicamentos genéricos tradicionales.

Desafortunadamente, confundir un medicamento "genérico" con un medicamento "biosimilar" es como confundir un 747 con un avión de juguete. He aquí el motivo: La mayoría de los medicamentos que conocemos son medicamentos de "molécula pequeña". La aspirina, por ejemplo, está compuesta de 21 átomos. Por lo tanto, la fabricación de dichos medicamentos es fácil y los fabricantes de medicamentos genéricos pueden copiarlos a la perfección. Como la configuración genérica es idéntica a la de sus predecesores de marca, no hace falta llevar a cabo pruebas de seguridad adicionales.

Pero los medicamentos biosimilares, por otra parte, son compuestos complejos, mucho más grandes, fabricados a partir de organismos vivos. El Herceptin por ejemplo, un medicamento anticánceroso de amplio uso, está compuesto de 25,000



# Consumer Reports: Algunos cereales mercadeados a niños contienen más de 50 por ciento de azúcar

Estudio disponible en Consumer Reports en Español forma parte de un esfuerzo redoblado de proporcionar a los hispanos información relevante acerca de la salud

**U**n nuevo estudio realizado por Consumer Reports revela que algunos cereales mercadeados agresivamente a niños contienen más de 50 por ciento de azúcar, y que sólo cuatro de los 27 cereales estudiados recibieron una calificación nutritiva de Muy Bueno.

Consumer Reports encontró que dos cereales, Post Golden Crisp y Kellogg's Honey Smacks, contienen más de 50 por ciento de azúcar y que nueve cereales más contienen por los menos un 40 por ciento de azúcar. Es más, 23 de los 27 cereales mercadeados más agresivamente a niños recibieron una calificación nutritiva de Bueno o Satisfactorio. Consumer Reports encontró que hay tanto o más azúcar en una porción de Kellogg's Honey Smacks y 10 de los otros cereales estudiados que en una dona glaseada de Dunkin' Donuts.

El reporte entero, publicado en la sección de salud del sitio de Consumer Reports en Español, www.consumerreportsenespanol.org, que celebra su primer aniversario este mes, también critica el nivel de sodio de los cereales examinados. Por ejemplo, Kellogg's Rice Krispies tiene sólo 4 gramos de azúcar por porción, pero recibió una calificación de Satisfactorio dado su alto contenido de sodio y sus cero gramos de fibra. Los cereales peor calificados - ambos recibiendo una calificación de Satisfactorio - fueron Kellogg's Honey Smacks, con 15

gramos de azúcar y un gramo de fibra por porción; y Kellogg's Corn Pops, con 12 gramos de azúcar y cero gramos de fibra por porción.

Cheerios (General Mills) recibió la mejor calificación otorgada por Consumer Reports gracias a sus tres gramos de fibra por porción y sólo un gramo de azúcar, las dos categorías consideradas más importantes en el estudio de Consumer Reports. Kix y Honey Nut Cheerios (ambos de la marca General Mills) y Life (Quaker Oats) tuvieron un contenido de azúcar relativamente más bajo y un contenido de fibra relativamente más alto. Todos estos cuatro cereales recibieron una calificación nutritiva de Muy Bueno.

La disponibilidad de este importante estudio en www.consumerreportsenespanol.org refleja un esfuerzo redoblado por Consumer Reports a llenar el vacío de información objetiva y en español acerca de la salud. Citando estadísticas del Departamento de Salud de Estados Unidos, Elena Chávez, Gerente de Iniciativas Hispanas para Consumer Reports, dijo que a pesar de las grandes discrepancias entre los hispanos y blancos no hispanos en incidencia de enfermedades cardiovasculares, diabetes, prevención y tratamiento del cáncer y cesación de fumar, una falta de información en español aunada a barreras de idioma entre los pacientes hispanoparlantes y sus médicos significa que a menudo, los hispanos no reciben respuestas a sus preguntas acerca de la

salud.

Empezando en octubre, www.consumerreportsenespanol.org ofrecerá varios artículos por mes bajo los temas de Vida Sana, Condiciones y Tratamientos, Medicamento y Seguros, dijo Chávez, agregando que el sitio también ofrecerá a los visitantes la oportunidad de compartir sus experiencias de salud con otros lectores.

átomos. Su tamaño, y las variaciones en las células vivas que lo componen, impiden fabricar una copia exacta. Por eso es posible que los medicamentos biosimilares difieran significativamente de los medicamentos originales y que induzcan reacciones adversas impredecibles.

Hace varios años, por ejemplo, se otorgó una licencia para reproducción en Europa de un medicamento biológico creado en este país, utilizando tecnología compartida. Pero la versión europea causó en ciertos casos una "aplasia pura de los glóbulos rojos", que impidió la producción de glóbulos rojos en dichos pacientes. Algunos de los pacientes fallecieron, mientras que otros sufrieron lesiones permanentes. Actualmente, a pesar de 8 años de estudios de investigación, aún no se conoce la causa de estas reacciones.

El problema que enfrentan los legisladores consiste en crear una norma que garantice la seguridad de todos los medicamentos biosimilares que se introduzcan en el mercado. Actualmente no existe una tecnología que permita duplicar la naturaleza exacta de un medicamento biológico de molécula grande en comparación con otro. Como consecuencia

de ello, el examen de la seguridad de los productos no da resultados exactos.

Si los medicamentos biológicos de una empresa pueden producir reacciones adversas cuando los produce bajo licencia otra empresa, las configuraciones biosimilares que no se basen en tecnología compartida deben resultar preocupantes. De hecho, en vista de lo dicho, la Unión Europea ha creado un sistema de evaluación que exige la realización de pruebas clínicas antes de que se aprueben medicamentos biosimilares. Los Estados Unidos deberían adoptar la misma norma.

Al mismo tiempo, el Congreso debería esforzarse por apoyar la innovación de avanzada en biotecnología. En general, puesto que los medicamentos biológicos son tan complejos, crear un medicamento biológico cuesta un 50% más que la creación de un medicamento convencional. Por lo tanto, invertir tiempo y capital en la creación de nuevos medicamentos biológicos de avanzada es extremadamente caro.

Por suerte, ya hemos adoptado un método para proporcionar incentivos en la inversión dentro del mundo de los medicamentos de molécula pequeña. Dicha

estrategia se denomina "exclusividad de los datos". Se trata de un mecanismo legal que permite que las empresas mantengan en secreto durante varios años los datos relacionados con el desarrollo de determinado medicamento. La exclusividad de los datos ha estimulado la innovación en el campo de los medicamentos de molécula pequeña, y convendría aplicarla también a los medicamentos biológicos.

Es aconsejable que los legisladores estadounidenses exijan la presentación de datos y pruebas clínicas pertinentes para garantizar la seguridad en todos los medicamentos biológicos biosimilares. Al mismo tiempo, convendrá establecer un sistema adecuado de exclusividad de datos para promover la innovación.

Si los medicamentos químicos fueran aviones de juguete, los medicamentos biológicos serían aviones 747. Es necesario que lo recordemos al considerar cuáles sistemas se deberán usar para garantizar la seguridad en el campo de los medicamentos biológicos biosimilares.

del seno son significativamente mayores cuando el cáncer no se ha propagado”, dijo Janet McGrail, Vicepresidenta en Massachusetts de Iniciativas para la Salud de la Sociedad Americana del Cáncer. “Numerosos estudios han demostrado que la detección temprana aumenta las opciones de tratamiento y puede salvar vidas. Por ello es tan importante que las mujeres de 40 años de edad y más se sometan a una mamografía anual.”

La Sociedad Americana del Cáncer recomienda mamografías anuales y exámenes clínicos del seno para las mujeres de 40 años de edad y más, y un examen clínico del seno al menos una vez cada tres años para las mujeres entre los 20 y los 39 años de edad. La Sociedad también recomienda pruebas de imágenes por resonancia magnética (magnetic resonance imaging, MRI) para ciertas mujeres que corren alto riesgo. Las mujeres con riesgo moderado deben hablar con su médico sobre los beneficios y limitaciones de añadir exámenes exploratorios de MRI a su mamografía anual.

Aunque aún no sabemos cómo prevenir el cáncer del seno, sabemos que las mujeres que mantienen un peso saludable, una alimentación bien balanceada y son físicamente activas de 45 a 60 minutos en cinco o más días de la semana, pueden reducir su riesgo de desarrollar cáncer del seno. Además, la limitación del consumo de alcohol puede reducir el riesgo de cáncer del seno, dos o más tragos al día puede aumentar un 21 por ciento el riesgo de cáncer del seno.

La Sociedad Americana del Cáncer y la organización filial de defensa, American Cancer Society Cancer Action Network SM (ACS CAN), continúan realizando actividades para aumentar el financiamiento del Programa Nacional de Detección Temprana de Cáncer de Cuello Uterino y del Seno. Este importante programa proporciona a las mujeres de bajos ingresos, sin seguro y con seguro insuficiente, acceso a mamografías, pruebas de Papanicolaou, atención de seguimiento y tratamiento cuando es necesario. El financiamiento actual sólo permite que el programa dé servicio a una de cada cinco mujeres elegibles de 50 a 64 años de todo el país, y por primera vez desde el inicio del programa, ahora menos mujeres reciben este beneficio debido a las tasas de financiamiento insuficientes y a los recortes del financiamiento en los últimos cinco años.

Este programa que salva vidas no puede tener éxito total si las mujeres elegibles no pueden someterse a pruebas de detección temprana debido a un financiamiento insuficiente. ACS CAN alienta a todas aquellas personas afectadas por esta enfermedad a que hagan saber al Congreso que el apoyo del NCCEDP es importante, y que el aumento del financiamiento de este programa, a \$250 millones, es vital para su continuación. Cuanto más rápidamente los miembros del Congreso hagan un compromiso para apoyarlo, el programa podrá servir mejor a nuestras madres, hermanas, hijas y amigas.

# Aproveche al máximo ayuda del IRS a Familias Trabajadoras

## Crédito Tributario por Ingreso del Trabajo

Esta es la ayuda más significativa que ofrece el gobierno federal a familias trabajadoras y estadísticas muestran que 46 por ciento de trabajadores asalariados son padres de familia, con niños menores de 18 años que viven con ellos al menos la mitad del tiempo. Si sus ingresos en el 2008 son de \$39,783 o menos, podrían calificar para recibir el crédito tributario por ingreso del trabajo (EITC) al presentar su declaración de impuestos en el 2009. Incluso podrían recibir parte de su EITC ahora, solicitándolo por adelantado de su empleador. Existen varias reglas pero tratándose de una ayuda que podría ser de hasta \$4,716, vale la pena informarse utilizando la herramienta en español Asistente EITC en IRS.gov o solicitando la Publicación 596(SP).

## Crédito por el Cuidado de Menores y Dependientes

Una de cada cuatro personas en los EE.UU. aproximadamente -más de 45 millones de personas en el país-coordinaron o brindaron el cuidado de un miembro de su familia o amigo, mientras que continúa incrementándose la cantidad de personas que deben encargarse del cuidado de padres mayores. Si usted paga a alguien para que cuide a una persona calificada, de modo que usted (y su cónyuge) puedan trabajar o buscar trabajo, posiblemente pueda reclamar el crédito por gastos de cuidado de hijos menores y dependientes. Para cerciorarse de cumplir los requisitos necesarios y no desperdiciar esta oportunidad vea el Tema 602 en IRS.gov o solicite la Publicación 503.

## Crédito para Primeros Compradores de Vivienda

Según la recién decretada Ley de Vivienda y Recuperación Económica de 2008, quienes compran un hogar por primera vez después del 8 de abril de 2008, y antes de julio de 2009 podrían aprovechar un nuevo crédito que reduce la cuenta de impuestos del contribuyente o incrementa su reembolso, dólar por dólar y es completamente reembolsable, lo cual significa que pueden reclamarse, aun sin adeudar impuestos o si el crédito resulta más que el impuesto adeudado.

Funciona muy semejante a un préstamo libre de intereses, porque debe pagarse a lo largo de 15 años. Por ejemplo, un contribuyente que compra una vivienda y reclama el crédito máximo de \$7500 en su declaración de 2008 debe comenzar a pagar \$500 como un impuesto adicional en su declaración de 2010. Las familias o las personas elegibles reclamarán el crédito en el nuevo Formulario 5405 del IRS, que estarán disponibles a finales de este año en IRS.gov.



No one enjoys paying taxes, particularly when individuals and families are facing their own financial difficulties. But the passage of question 1 to eliminate the state income tax would be devastating for all Massachusetts citizens. Consider the following if question 1 is approved:

- The state budget will have to be cut by 40% - roughly \$12 to \$13 billion. This 40% reduction is on top of recent 9C cuts instituted by Governor Patrick to address the current shortfall in state revenue. Further reductions through Question 1, means dramatic cuts in local aid for schools, police and fire departments, road and bridge repairs, day care programs, services for the disabled, seniors, and community colleges and universities. Everyone whose life is touched by state services or programs will be affected.
- Question 1 offers no alternative source of support to fund critical services which residents rely on daily. The fiscal burden would shift by increasing property taxes or sales taxes. This could potentially force individuals out of their homes, and is certain to increase the cost of groceries, clothing, fuel, and basic necessities.

It is difficult to pinpoint where the most damage would occur, but there is no doubt that the cut in state revenue, will be felt by just about every citizen in the Commonwealth – from the student seeking a college loan, to a senior needing help in their home to manage their daily lives. It is important to remember that when large amounts of state aid are cut, it is people who are hurt, not faceless bureaucracies. Our friends, neighbors and family members will all feel the impact.

It is reckless to put our fragile economy at greater risk. Times are hard enough. Let's not make them worse.

## Free Birth Control a Boon in Economic Downturn

**H**ealth Quarters will continue to offer a three-month supply of birth control methods at no cost through the end of the year to new patients at its Lawrence health center at 101 Amesbury Street and Haverhill health center at 215 Summer Street.

"We are offering free birth control at a time of need," said Health Quarters Executive Director Lianne Cook. "As money becomes tighter, we want to ensure that affordable GYN exams and contraception are accessible to as many women as possible. Cutting back on contraception because of cost can lead to the high price of unintended pregnancy."

Until the end of 2008, women who come into Health Quarters for their first appointment are eligible to receive birth control methods known as the Pill, Patch, Ring and Depo at no cost for the first three months. Patients will receive the birth control after a required clinical assessment, which can be paid for with a sliding fee scale or billed to MassHealth and some insurance plans. After the introductory period, patients can continue to obtain their brand name birth control method from Health Quarters at prices below most pharmacies.

Existing Health Quarters patients also can take advantage of this offer if they direct a friend to Health Quarters for a birth control visit.

Established in 1971, Health Quarters is a federal-and state-funded provider of gynecological exams; health education; and prevention services such as birth control and emergency contraception, cervical and breast cancer screening, STD testing and treatment, and rapid HIV and pregnancy testing and counseling.

(DSS). I wrote about this case two weeks ago; you can find it in the October 15, 2008 edition on page 3.

When Jose Rivera came home beat up and with the security guard's hands still visible around his neck, his mother, Maria Alicea, drove him back to school so that Principal Samaria Taveras-Hashem could see his condition and from there, straight to Lawrence General Hospital. Doctors verified in writing the marks around his neck and that he presented minor head injuries.

The principal did what the circumstances required and filed a 51-A with DSS. An investigation ensued and the results were known right away. We just have to watch where he will be transferred to because Mr. McCabe has a history of being protected by the school department.

A frustrated police officer who was fired from the Plaistow Police Department in New Hampshire for using brute force against the citizens, he is not wanted in the Lawrence Police even though he scored on

top on the test.

In the years he has been working for the school department (approximately since 1996) he has been in trouble several times. His supervisors have asked for his dismissal but Superintendent Wilfredo Laboy protected him. My sources have told me that McCabe has the superintendent's support because he is his informant.

He has a long list of infractions such as being involved in a sexual harassment while he was working at the Frost School in 2003 but it was covered up by Laboy. Principal Ellen Baranowski had McCabe removed from his duty at the school but he was promoted to Central Office and in charge of security guards by Laboy. He was later demoted to a guard for his misconduct as supervisor of guards and reassigned to a school.

Meanwhile, McCabe is running his personal construction business on school department time.

# For Revenge No, Mr. Laboy

**A**s a teacher at Lawrence Public Schools for over 12 years, as a commentator for the local media, as a writer, as a singer, as a business owner and above all, because I have had the privilege of living in the heart of this great community of immigrants, I have had the opportunity to gain the love and respect, not only of my students and their families, but of the community as a whole. This community sees me as the prototype of the Latino immigrant that comes to this country to work very hard with honesty, courage and great determination to reach the American dream.

Born from a low income family in the Dominican Republic, I was registered in an elementary school for the first time, at age 16. I learn how to read and write by myself. I went to evening school while working ten hours a day. Today, after lots of sacrifices, I hold a Bachelor Degree in Economics, a Master Degree in Education from Salem State College. I am a Certified Teacher in Math and Social Studies at a secondary level and a successful real estate broker.

Because of my talents, my sacrifices, my hard work and achievements, I can be the type of role model that our students need. Even though all of the above credentials and qualifications, my cultural connections with the students and the fact that I have lived in this city for over 15 years, Wilfredo Laboy, for reasons of revenge, refused to give me the opportunity to continue teaching the children I love. My only sin seems to be having criticized him for my disagreement with the dictatorial way in which he is leading the school system.

With my credentials and teaching experience, I could find a job anywhere else but this is my city and I want to continue teaching the children of Lawrence. I don't know if you have heard about more than one hundred teaching positions that were vacant for the present school year. I attended an educational recruiting fair that was held by the school system at South Lawrence East School last May and applied for four different Social Studies openings. Even with

my teaching credentials and experience, I was not considered for any of these jobs. Most of these vacancies were filled with unqualified young teachers, with no experience or certifications. Having said that, I believe that I was discriminated against by the superintendent of school as retaliation, age and national origin; my rights were violated. For that reason, I decided to file a discrimination complaint at the federal agency Equal Employment Opportunity Commission (EEOC) to investigate the matter.

I believe that the main purpose of a school superintendent must be to work on the best interest of the students, the parents and the community that he serves. A good superintendent must develop an interactive and productive relationship within the community, in order to build a leadership that allows him to manage the available resources creating a saved environment in which teaching and learning can take place. An efficient school administrator always tries to promote parents participation and involvement in their own children's education. A superintendent of school must obey the school laws and regulations hiring the most qualified teachers to deliver quality education for every student.

For a Latino immigrant to get a job in Lawrence Public Schools, he or she must be one of the superintendent's relatives or has to be well connected to someone close to him.

Wilfredo Laboy is leading our school system as if it were his own plantation in which the teachers, I mean his peasants, have no right to disagree with the great Lord.

# Toy Planes and Complicated Drugs

**A** toy plane has a handful of parts. A Boeing 747 has several million. This makes sense. Toy planes are small, simple models, while 747s are large, high-performance aircraft. The model costs a few dollars because it's easy to manufacture. The 747 costs about \$225 million due to its complexity.

This comparison is worth keeping in mind in the debate over "follow-on biologics." Biologics are today's most complex and cutting-edge medicines for treating diseases like cancer and multiple sclerosis. Follow-on biologics are inexact copies of these drugs.

Congress is currently considering legislation that would allow the sale of follow-on biologics without requiring extensive testing—essentially treating follow-ons like traditional generic drugs. Unfortunately, confusing a "generic" with a "follow-on" is like confusing a 747 with a model airplane.

Here's why: Most drugs we're familiar with are "small-molecule" drugs. Aspirin, for example, is composed of just 21 atoms. So they are easily manufactured and can be identically copied by generic drug manufacturers. Since the generic forms are identical to their brand-name predecessors, they don't need their own safety tests.

Biologics, on the other hand, are complex, much larger compounds made from living organisms. Herceptin, for instance, a widely-used cancer drug, is composed of 25,000 atoms. This size, and the variation of living cells making the drug, makes biologics impossible to copy exactly. That's why follow-on biologics can differ significantly from the original drug - and induce unpredictable adverse reactions.

For example, several years ago, a fully-tested biologic created here was licensed to be made in Europe using shared technology. But the European version resulted in patients suffering "pure red cell aplasia," where their bodies couldn't make red blood cells. Patients died, and many were permanently injured.

Today, even after 8 years of research, the cause of these reactions is still unknown.

The challenge for lawmakers is to create a policy that ensures that all follow-on biologics that enter the market are safe. Presently, the technology to map out the exact nature of one large biologic versus another is not available. That makes safety reviews inexact.

If biologics licensed from one company to another can produce adverse reactions, then follow-on forms that don't use shared technology should be of concern. In fact, recognizing this, the EU has developed a system of assessment that requires clinical testing before follow-ons are approved. The U.S. should do the same.

Congress should also work to support cutting-edge innovation in biotechnology. Since biologic drugs are so complex, it costs, on average, 50% more to develop a biologic than a conventional drug. As a result, it is extremely expensive to invest the time and capital to create new, breakthrough biologic drugs.

Thankfully, we already employ a method to provide incentives for this investment in the small molecule medicine world. The strategy is called "data exclusivity." This is a legal mechanism that allows a company to keep the data associated with a drug's development confidential for several years. Data exclusivity has spurred small molecule drug innovation, and should be applied to biologic drugs as well.

U.S. policymakers should require relevant clinical data and testing to ensure safety of all follow-on biologics. And appropriate data exclusivity should be put in place to foster innovation.

If chemical drugs were toy planes, biologics would be 747s. We need to remember that when we consider what systems to employ to ensure follow-on biologic safety.

The City's current form of government was approved by "special act" of the Massachusetts State Legislature in 1983. This special legislation was approved by the Voters of Lawrence in November 1983, and put into effect January 1, 1986 with the election of a 9 member Part Time City Council elected through districts and at-large City Councilors as well as School Committee members to be elected all at-large.

At a recent meeting on September 25, 2008, the Committee of the Whole, chaired by Vice President Nicholas J. Kolofoles by virtue of the City Charter, the committee approved a motion to hold a Public Meeting for informational purposes to change its form of Government.

The Lawrence City Council's Sub-Committee of the Whole will meet on the night of November 3, 2008 at 7:00 P.M. to hold a public forum on the topic of a possible Charter Change from a 9 member legislative council members and a four year strong mayor form of government to that of a City Manager.

This meeting is open to all.

District in the Democratic Primary Election held in Lawrence on September 16, 2008.

This case document, No. 08-02123A, involves a dispute over the results of such election. The plaintiff, Marcos A. Devers seek injunctive and equitable relief pursuant to G.L. c. 54, § 103 and G.L. c. 56, § 59 and brings this cause against Representative William Lantigua, Lawrence City Clerk, William Maloney and Rafael Tejeda, director or coordinator of the Lawrence Election Division.

In his claim, the plaintiff requests

that the court grants the following relief: 1- Determine that irregularities had put the election in doubt. 2- Set aside the results of the September 16, 2008 Democratic primary election for the 16th Essex congressional seat. 3- Order a new election.

To support the above claim, Atty. Guerrera states in the document that in the weeks leading up to the election and in the election itself, the defendant, Lantigua and his agents and campaign workers acted in concert, jointly and severally or conspired with the defendants Maloney and Tejeda to solicit, secure and count votes by absentee

ballot from voters who were not lawfully entitled to vote by absentee ballot and attempt unlawfully to suppress, interfere with, and obstruct votes by supporters of Marcos Devers as set forth in the accompanying affidavits of Annia Lembert, Mery Rivas, Modesto Maldonado, Nereyda Trempe, Marisol Rodriguez, Rosa Ortiz, Jose Rodriguez, Octavio Cabrera and Ruben D. Perez.

## Looking into the past

In the old days many neighborhoods formed their own sports teams and also social clubs. The Arlington Club was primarily an Irish club, the LaSalle was French, the Mason St. Club was also primarily French, Hermann Hall was a German club, the Hibernians Irish, the British was a multi cultured club and the Turn Hall had many Germans as members. The Turn Verien as it was called was a strong gymnastic club winning many meets. The French Social Club featured a bowling league downstairs and also softball teams.

The Hermann Hall also featured bowling alleys and softball teams in its day before a fire turned the place into ashes. The LaSalle Club sponsored many years of softball and produced a few championship teams. Most clubs would run penny socials around the Christmas Holidays and also ran some great bean suppers. Politicians would rent these clubs to have get togethers with their would-be-voters.

Some like the Turn Hall would put on shows and I remember going as a kid to one at the Hall sponsored by the AFL/CIO the unions of the woolen industry that employed most of the people of the City. Some ran Minstrel shows now a thing of the past as the performers were all in black face and long before we ever considered racism these were comical shows. Some of our local Minstrel performers were great on stage and to this day I'll bet there wasn't one thought of it being a slur but just a fun time enjoyed by many.

Jimmy Devlin of Crosby St. was a fine tenor and worked for the telephone company, the Blanchette brothers Joe and Buddy were fine entertainers and Joe still sings with his son and grandson for the elderly and at age homes. Young Billy is the manager at the Beacon Projects for the LHA.

In North Lawrence a young group formed a team called Panther Athletic Club and it was very successful in football and softball. The 1935 football team featured the coach Larry Harmon, assistant John Toomey, Tony Naugy, Clovo Sauter, Vi Boyhajian who later became the public address announcer for all Lawrence High School games; in 1992 he received a plaque from LHS Athletic Director Carmen Iannuccilli for his dedication to the job. Vi had announced every game since 1957. He also served as the President of the Greater Lawrence fast pitch softball league.

John Karz and Algy Kaupinis, Bill Tirwaga, Stan Bush, Mike Salayko, Jim Harmon, all were part of the Panthers team. Other team members included Roger Beaulieu, Mike Koren, Al Suslovich and a young quarterback with great talent who became a multi talented athlete in the city's history. Joe Platek now retired from the State of Massachusetts can still be found at the Lawrence Elks on River Road almost every day working out in the gym. Always with a smile, Joe was a tremendous softball player and I'm told the leader of the Panthers. This group and many of their competitors met

for many years after their playing days and filled banquet halls with a night called "Our Gang" nights.

Many of these players would find themselves serving their country after the Japs bombed Pearl Harbor in 1941. The U.S. eventually declared war on Japan. A loaf of bread cost 8 cents.

The music of the day featured Artie Shaw's rendition of Stardust, and Harry James and his trumpet belted out You Made Me Love You. The Andrew Sisters had the hit Boogie Woogie Bugle Boy, Jimmy Dorsey, Bob Eberly and Helen O'Connell got together to record Green Eyes. Monroe had a hit with Racing with the Moon and if you had a nose cold you could just like him. Duke Ellington's Take the "A" Train and Tommy Dorsey featured a skinny kid singer named Frank Sinatra singing This Love of Mine.

A little story about an Italian love affair: For several years a wealthy man was having tryst with an Italian young lady. One night she informed him that she was having a baby. Not wanting to ruin his reputation or his marriage, he explained to the girl he would pay big money if she would go to Italy to secretly have the child. If she stayed in Italy to raise the child he would also provide child support until the child turned 18. She agrees to the terms, but asks how he would know when the baby is born.

To keep it discreet he tells her to simply mail a postcard and write "spaghetti" on the back. He would then start sending the child support checks to her.

About 9 months later he came home to a confused wife. She says "honey you received this strange card today and I don't understand it. The cheater says "Oh, just give it to me and I'll explain it to you."

She hands him the card and watches him turn white and then collapse.

On the card was written, "Spaghetti, Spaghetti, Spaghetti. Two with meatballs, one without! Request bread."

In 1948 Polaroid camera is introduced, Velcro is invented and Xerox company

introduces 'Xeroxing'. The songs we were humming were Doris Day Freckles and all singing It's Magic, Nature Boy by Nat "King" Cole, Buttons and Bows by Dinah Shore long before she made the saying "See the USA in Your Chevrolet". Sammy Kaye and Don Cornell recorded Serenade of the Bells, and Art Mooney made Baby Face a big hit.

In 1944 the Allies invaded Normandy on D-Day. Rationing of food and gasoline is started and the Battle of the Bulge turns the war against Hitler and the Germans. Americans were whistling and singing songs like I Couldn't Sleep a Wink Last Night recorded by Frank Sinatra and the women were shrieking and swooning and fainting. Besame Mucho was a Jimmy Dorsey, Bob Eberly, and Kitty Kallen hit. Mairzy Doats by the Merry Macs had people tapping their toes and so did Judy Garland's rendition of The Trolley Song. Russ Morgan had a hit called Dance With the Dolly With a Hole in her Stocking. Andrew Sisters and the "old groaner" Bing Crosby made one of their many duets this one called Don't Fence Me In, this became a big hit on all the juke boxes everywhere.

Much of this music was played at the "Old Gang" reunion held in 1973 at the Jewish Community Center. People from the corner of Hampshire and Myrtle Streets to Willow and Park and also Alder Street attended.

They spoke of places like King Tut's, Flynn's Drugstore and Pierce Cumming's, Hale's, Pete's, and Skeezo.

It was the fifth annual get together and the orchestra played the music of the past to the crowd who dined on a roast beef dinner. The band threw in a few polkas, some oriental songs and Lebanese, Irish, Armenian and Greek songs, too.

Guys like Vi Bohayjian, Joe Platek, Sam Carter a Bolta Rubber retiree, Henry Mandel a Hampshire St. jail guard and many others stood proud as they again came together to celebrate a great and historical era of our city.

So let's go to vote on Tuesday for the candidate and the ballot issues of our choice. America is waiting for us. And in doing so, remember the prophetic words of the famous British writer and wit, Oscar Wilde when he advised one hundred years ago that people should stop hoping for what they wanted: they might get it and then find out how bitterly disappointing this hope is likely to be.

But of course, we can wait for the new process four years from now, can't we? Things will get better then.

And this is my Point of View today.

## Massachusetts Kicks Off 2008-2009 Flu Prevention Campaign

Vaccine plentiful, and expected to be more effective this year.

**T**he Massachusetts Department of Public Health (DPH) today launched the Commonwealth's 2008-2009 flu prevention efforts at the William A. Hinton State Laboratory Institute in Jamaica Plain.

DPH Commissioner John Auerbach was joined by Secretary of Elder Affairs Michael Festa, State Epidemiologist Dr. Al Demaria, and DPH Medical Director Dr. Lauren Smith.

"Getting vaccinated is the single most effective way to avoid the flu," said Commissioner Auerbach. "This year, we expect there will be more than enough flu vaccine to go around, and what's more, the vaccine may provide even better protection than in previous years."

Influenza vaccine is recommended for everyone who wants to avoid becoming ill with the flu. It is especially important for people in the following groups to be vaccinated:

- o Children 6 months to 18 years of age.
- o People 50 years of age and older.
- o Pregnant women.
- o Anyone with a chronic medical condition, such as asthma, diabetes and chronic

medical conditions of the heart, lungs, kidneys, blood or immune system.

The Centers for Disease Control and Prevention (CDC) has expanded its recommendations for who should receive a flu shot. CDC now recommends that children aged 6 months all the way to 18 years of age should be vaccinated; in previous years, CDC recommended flu shots for children 6 months to 5 years old.

Vaccine production has gone smoothly this year. Up to 150 million doses of vaccine are expected to be available nationwide this year, with more than 2.2 million doses in Massachusetts alone. Of these 2.2 million, DPH will be providing more than 800,000 doses to support local flu clinics -- 100,000 more than last year. The remaining 1.4 million doses have been privately purchased by health care providers.

All doses of MDPH-supplied vaccine have already been allocated. Health care providers who wish to purchase additional doses of seasonal flu vaccine can visit <http://www.preventinfluenza.org/ivats/>

Health officials are optimistic that this year's flu vaccine will prove more effective

against the particular strain of flu virus that is expected this season. "This year the vaccine is covering three of the newest flu strains so we think it will be even more effective than usual," said State Epidemiologist Dr. Al Demaria.

Flu season does not usually peak until February in Massachusetts, so getting a flu shot anytime between October and January can be helpful in preventing illness. In addition to getting vaccinated, other ways to stop the spread of flu include: staying at home when sick to avoid spreading illness to co-workers or friends; practicing good "cough etiquette" by coughing into your sleeve or a tissue and not into your hands; and frequent hand washing with soap and warm water. Alcohol-based hand sanitizer can also be used when water is not available.

## Take Full Advantage of IRS Help to Working Families

### Earned Income Tax Credit (EITC)

This is the most significant hel offered by the Federal government to working families and statistics show that 46 percent of wage and salaried workers are parents with children under the age of 18 who live with them at least half time. If your 2008 income is \$39,783 or less, you may qualify for the Earned Income Tax Credit (EITC) when filing your 2009 tax return. You may even be able to get a portion of your EITC now, requesting it in advanced from your employer. There are several requirements and rules, but since it could add up to \$4,716, it would be worth the effort to learn more about it with the electronic tool "EITC Assistant" available in IRS.gov or requesting Publication 596.

### Child and Dependent Care Credit

Nearly one out of every four Americans-over 45 million nationwide-provided or arranged care for a family member or friend in the past year, while more and more Americans are faced with the challenge of caring for older parents. If you paid someone to care for a child under age 13 or a qualifying spouse or dependent so you could work or look for work, you may be able to reduce your tax by claiming the Child and Dependent Care Credit on your tax return. To make sure that you are keeping with the necessary requirements and do not waste this opportunity you should check Tax Topic 602 in IRS.gov or request Publication 503.

### First-Time Homebuyers Credit

According to the recently enacted Housing and Economic Recovery Act of 2008, those who purchase a home for the first time after April 8, 2008, and before July 2009, may be able to take advantage of a new tax credit. This would reduce a taxpayer's tax bill or increases his or her refund, dollar for dollar and is fully refundable, meaning that the credit will be paid out even if they owe no tax or the credit is more than the tax that they owe.

It operates much like an interest-free loan, because it must be repaid over a 15-year period. So, for example, an eligible taxpayer who buys a home today and claims the maximum available credit of \$7,500 on his or her 2008 tax return must begin repaying the credit by including \$500 as an additional tax on his or her 2010 return. Eligible families and individuals will claim the credit on new IRS Form 5405, which will be available later this year at IRS.gov.

"There is much more help available, and this is a perfect opportunity to make sure your family is getting all the help for which it is egleble," suggested IRS spokeswoman Sara Eguren.

## MSPCA Recognizes National Pit Bull Awareness Day



**Biggie**, a gorgeous 7 months old white male pit-bull is extremely gentle with women, children, cats, other dogs and everybody else but is afraid of men and is asking for your understanding.

Doble the puppy anxiously awaits a home at the Noble Family Animal Care & Adoption Center at the MSPCA, but his wait could be longer than the average puppy since he just happens to be a pit bull. But the breed with a bad rap may benefit from the second annual "National Pit Bull Awareness Day", held on Saturday, October 25th, as advocates for the breed unite to create awareness and dispel myths about pit bulls.

The staff and volunteers at MSPCA at Nevins Farm have long been working to educate the public about this misunderstood breed which has suffered from negative publicity and irresponsible owners.

"Just like any other dogs, pit bulls can be devoted, loyal family pets and in the hands of a responsible owner, can be the best companion you could ever ask for, provided they are lucky enough to have responsible owners," says Mike Keiley, Manager of the Noble Family Animal Care & Adoption Center at Nevins Farm.


"They are just unfortunate victims of a society that is exploiting them as status symbols and as agents for deviant behavior," added Keiley.

Keiley explains: "The aggression seen in pit bulls is often sensationalized due to the media's portrayal of the breed, but like any dog, failure to spay and neuter, properly train and socialize, as well as housing behind barriers are the leading contributors to any dog aggression, with pit bulls being no exception to this rule."

As part of their efforts to change the stereotype improve things for pit bulls in Lawrence, where the pit bull population is the highest and in need of the most help, the MSPCA at Nevins has been working closely with Lawrence Animal Control Office Dave Parsons to reach out to pit bull owners in the city.

Education about basic dog care and the need to spay and neuter their dogs has helped make strides to create responsible owners. Parsons has solicited the help of the MSPCA at Nevins to establish a low cost spay and neuter program for Lawrence pit bull owners.

The seasoned Animal Control Officer regularly seeks out individuals who may need some financial support to get their dog spayed or neutered, and will set up a surgery appointment at Nevins Farm on their behalf. Parsons will even provide transportation for the dog if needed, all with the goal of

creating great canine citizens and changing the image of pit bulls at a local level.

The MSPCA at Nevins Farm has several pit bulls available for adoption at the Noble Family Animal Care & Adoption Center. Potential adopters should be prepared with proof of homeownership or landlord contact information and proof of vaccinations for current pets in the home. Keiley also recommends that the entire family be present to choose their new canine companion.

One of seven MSPCA Animal Care and Adoption Centers statewide, the MSPCA at Nevins Farm in Methuen cared for more than 8,500 animals last year. The MSPCA does not receive state or federal funding and continues its work based solely on the generosity of its supporters.




