

Más de 40 miembros representantes de distintos medios de comunicación étnica de Massachusetts, se reunieron en la Casa del Estado con el Gobernador Deval Patrick, el viernes, 24 de abril, 2009.

Una de las primeras preguntas que le hicieron al gobernador por uno de los periodistas fue, "que si la razón de la reunión era porque él, el gobernador, estaba perdiendo popularidad con miembros de la prensa más reconocidos.

"No es verdad", fue su respuesta. "En efecto, yo me he reunido con algunos de ustedes", dijo el gobernador y sugirió continuar con estas reuniones en el futuro, tal vez cada tres meses.

El gobernador Patrick contestó una amplia variedad de preguntas incluyendo in-state tuition, que permite a alumnos indocumentados pagar los mismos precios por su educación que pagan aquellos que son residentes documentados; licencias de conducción para los indocumentados, impuesto sobre las ventas, y boletas electorales impresas en idioma chino, entre otras.

Patrick dijo que él favorece in-state tuition para estudiantes indocumentados y que él trató de implementarlo promulgando una orden ejecutiva pero se encontró con una severa oposición por parte de la legislatura.

"Yo creo que todo aquel que conduce por nuestras carreteras debe de tener una licencia de conducción, pero tenemos nuestras manos atadas ya que hay leyes federales que lo prohíben", fue su respuesta a la pregunta de si él favorecía la idea de emitir licencias de conducción a extranjeros indocumentados.

"No estoy convencido de que incrementar el impuesto sobre las ventas es la mejor opción para resolver nuestra situación económica", dijo Patrick y añadió que nuestra economía está en una situación desplorable y que aún con el paquete de estímulo recibido del gobierno federal, no es suficiente. En su lugar él se inclina a

gravar artículos como la soda y los dulces por gastos específicos.

Patrick está de acuerdo con la idea de imprimir las boletas en idioma chino. Él dijo a los periodistas que desde que él trabajaba en el Departamento de Justicia ya él abogaba para que todas las boletas fueran impresas en todos los idiomas.

Rumbo pidió ayuda al gobernador respecto al asunto que ahora se conoce como "Snoop list", o lista de nombres chequeados por el departamento escolar de Lawrence, donde más de 400 personas fueron investigadas por dos empleados. El gobernador admitió que lo había leído en los periódicos y que "también mi nombre está en la lista".

"En Lawrence, con cualquiera que usted habla piensa que la investigación debe ser llevada por el estado y no por la policía local. Todos, exceptuando la administración, creen que todo terminará barrido bajo la alfombra. Lo más significante de todo es el hecho de que el que delató el delito fue despedido inmediatamente sin embargo, la otra persona, responsable de haber hecho la mayoría de las investigaciones se le permitió renunciar", expliqué al Gobernador Patrick.

"Yo tengo bastante con gobernar el estado. No creo que deba ir a gobernar a Lawrence. Todo lo que sé es lo que dicen los periódicos y estaba bajo la impresión de que las autoridades de Lawrence tenían todo bajo control. Algo que no sabía era que el delator había sido despedido. ¡Y voy a parar ahí mismo!", dijo el gobernador terminando la conversación sobre ese tema.

Autoridades confirman primer caso de gripe porcina en Massachusetts

CDC confirma gripe porcina en dos niños de edad escolar residentes del condado de Middlesex. Se espera su recuperación completa.

La administración del gobernador Patrick anunció hoy los dos primeros casos confirmados de la influenza porcina en Massachusetts. Según información del Departamento de Salud Pública de Massachusetts (DPH), los pacientes, dos niños residentes del condado de Middlesex, presentan casos moderados de la enfermedad y se espera que se recuperen por completo. Ninguno de los dos niños acudió a la escuela en ningún momento de su enfermedad, y sus padres tampoco fueron a trabajar durante el mismo periodo. Massachusetts es el sexto estado a confirmar casos de la gripe porcina. Hasta el momento se han confirmado 66 casos en Estados Unidos.

"Afortunadamente, los pacientes no han sido hospitalizados y anticipamos su recuperación completa", dijo el Gobernador Deval Patrick. "Continuaremos monitoreando la situación y trabajando estrechamente con nuestras autoridades de salud y demás para limitar la propagación del virus".

Autoridades del DPH continúan tomando medidas para aumentar la vigilancia de enfermedades del tipo

gripal en Massachusetts. Se ha pedido que proveedores de servicios de salud y personal de salas de urgencias estén atentos a pacientes que presenten síntomas gripales -especialmente en personas que han viajado recientemente para México o para cualquiera de los estados del país donde se han confirmado casos de la gripe. Si un proveedor de servicios de salud sospecha que su paciente se ha contagiado la gripe porcina, el DPH requiere que el proveedor colecte una muestra de secreción nasal del paciente y la envíe al laboratorio para hacer un análisis.

"Continuamos trabajando en conjunto con nuestros colegas a nivel local, estatal y federal para controlar la propagación de la gripe porcina y estamos actuando rápidamente para detener el contagio", dijo el comisionado del DPH, John Auerbach. "Todos los residentes de Massachusetts pueden asumir un rol fundamental en ayudarnos en nuestro trabajo al tomar precauciones simples para evitar contagiarse y contagiar a los demás de la gripe".

Las precauciones incluyen:

- Lavarse las manos con frecuencia con



agua y jabón o usar un desinfectante para manos a base de alcohol

- Cubrirse la boca y la nariz al toser o estornudar con un pañuelo de papel o con el interior del codo, en vez de hacerlo sobre la mano
- Si usted se enferma, quédese en la casa. No vaya al trabajo o a la escuela y evite el contacto con las personas para no contagiarlos.

En el gobierno federal, los Centros para el Control y la Prevención de

Enfermedades (CDC) han comenzado a enviar grandes cantidades de materiales a los estados -incluso a Massachusetts- para ayudar en la preparación y respuesta contra la propagación de la gripe porcina. Los materiales incluyen medicamentos antivirales para el tratamiento de individuos con la enfermedad además de equipos y materiales sanitarios que puedan ser necesarios.

La influenza porcina es una enfermedad respiratoria de los cerdos causada por los virus de la influenza tipo A. Brotes de esta enfermedad ocurren regularmente entre los cerdos. Las personas normalmente no contraen la gripe porcina, pero a veces los seres humanos sí pueden contagiarse. Por lo general, las personas que contraen la gripe porcina son personas que están en contacto con los cerdos, pero es posible que el virus de la gripe porcina se transmita de persona a persona también. La gripe porcina no puede contagiarse por comer carne de cerdo o productos que contengan cerdo.

El Greater Lawrence Family Health Center (GLFHC) está trabajando con oficiales estatales y federales para ampliar el conocimiento e informar a los residentes de la región sobre lo que está sucediendo y de cómo prevenir el contraer esta enfermedad que es llevada por el viento.

Robert Ingala, Chief Executive Officer, declaró que el centro comunitario de salud está en contacto directo con oficiales concerniente a las últimas noticias nacionales. "En los últimos días, oficiales del Departamento de Salud Pública se han comunicado con los proveedores de cuidado de la salud alrededor del estado, proveyendo información sobre la gripe porcina, cuáles son sus síntomas y cómo reportar casos sospechosos. Estamos en constante contacto con DPH (siglas en inglés) y proveeremos cualquier información disponible al público".

He aquí algunos pasos que todos debemos tomar para evitar el no contagiarnos o dispersar cualquier tipo de influenza.

- Lávese las manos a menudo con jabón y agua, especialmente cuando haya tosido o estornudado. Líquidos para las manos a base de alcohol también son efectivos.

- Practique una buena etiqueta cuando estornude o tosa, hágalo sobre su codo y no en sus manos. Trate de mantenerse alejado de personas enfermas.
- Si se enferma, quédese en la casa. No vaya ni al trabajo ni a la escuela y limite su contacto con otros para evitar contagiarlos.

La gripe porcina no se transmite comiendo carne de cerdo o sus productos derivados. Los síntomas de la fiebre porcina en las personas son similares a los síntomas de la influenza e incluye fiebre, tos, garganta irritada, dolor en el cuerpo, dolor de cabeza, temblores y fatiga. Algunas personas han reportado diarrea y vómitos asociados con la gripe porcina. Igual que la gripe de estación, la gripe porcina puede causar un empeoramiento de algunas condiciones crónicas.



Lantigua presenta plan del presupuesto; continúa buscando solución a la vivienda

El Representante Estatal William Lantigua (D-Lawrence) ha presentado sus solicitudes del presupuesto para el año fiscal del 2010 en una carta al Presidente de la Comisión de Medios y Arbitrios ante la Cámara Charles Murphy (D-Burlington), y ha presentado enmiendas a la oficina del Secretario de la Cámara de Representantes con la esperanza de su inclusión en el presupuesto del estado.

Lantigua dijo que está buscando el financiamiento local de más de \$4.5 millones, la mayoría de los cuales se distribuirían a Lawrence a base de organizaciones sin fines de lucro, escuelas y programas educativos, iniciativas de capacitación laboral, capital y proyectos de mejora. Al mismo tiempo, dijo que continuará promoviendo una legislación que detendrá temporalmente las ejecuciones bancarias a través de Massachusetts.

"Este es el clima económico más duro que he visto nunca", dijo Lantigua. "Ahora, tanto como antes, estoy luchando para ayudar al pueblo de Lawrence. Estoy haciendo esto no sólo por tratar de obtener dinero para las organizaciones que hacen trabajos tan importantes para ellos, sino por tratar de ayudar a las personas y las familias a mantener sus hogares."

En cada uno de los dos últimos períodos de sesiones legislativas, Lantigua

ha presentado un proyecto de ley que establecería una moratoria de 180 días en las ejecuciones, dándole seis meses a los prestatarios para trabajar con los prestamistas a modificar sus hipotecas. También ha presentado una petición que obligaría la revisión judicial de las ejecuciones, requeriría una causa justa para el desalojo, y establecería una moratoria en la hipoteca de 180 días Lawrence. Las tres peticiones fueron aprobadas por el Concilio de la Ciudad de Lawrence el año pasado.

Además, Lantigua presentó una modificación presupuestaria que restauraría \$2 millones en fondos para servicios de educación estatal de vivienda. Dijo que el programa piloto ha sido especialmente eficaz en la enseñanza a los participantes en evitar errores en el proceso de compra y de endeudamiento que podría ponerlos en riesgo de exclusión.

Para el año fiscal 2010, Lantigua busca 1 millón de dólares para la Academia Esperanza, una escuela gratuita para niñas de 10 a 14 años, y \$500,000 para ayudar a financiar el estudio y la construcción de un puente sobre el Canal Sur. Lantigua también ha pedido \$193,000 para AMEDAL, una organización de dirigentes comunitarios en la ciudad, \$160,000 para el Lawrence / Methuen Community Coalition, \$83,000 para la Liga Atlética de Policía de

Lawrence, y \$100,000 para Merrimack Valley Community Service Corps.

Lantigua dijo que ha pedido \$163,642 para el Instituto Internacional, que apoya a los niños y las familias, ofreciendo capacitación laboral, asistencia jurídica y otros servicios, \$135,000 para la Cámara de Comercio Latina del Valle de Merrimack y \$100,000 para la Massachusetts Hispanic Law Enforcement Asociación. Lantigua también ha solicitado \$225,000 para financiar un programa de becas de perdón de préstamos diseñado para ayudar a Lawrence y otras ciudades en todo el estado para atraer y retener a profesionales de salud mental de habla española los en centros de salud comunitarios.

Además de las mencionadas solicitudes, Lantigua dijo que espera obtener financiamiento para los siguientes programas:



Lantigua dijo que planea trabajar con Murphy y la delegación legislativa de Lawrence para asegurar la mayor cantidad de fondos para la ciudad como sea posible, a pesar de la fuerte recesión económica. Agregó que los recortes a la ayuda local y el reportado déficit de \$3.6 millones en los ingresos no lo han disuadido de presentar enmiendas al presupuesto.

"No es ningún secreto, esto será una batalla difícil", dijo. "Sólo porque los tiempos son difíciles, no significa el pueblo de Lawrence se están dando por vencidos diciendo: 'Me rindo'. No voy a renunciar tampoco".





Señoras y señores:

Mi nombre es Algird Sunskis. Durante siete años he sido un profesor de educación de tecnología de Lawrence High School. Hoy estoy reportando los siguientes incidentes de malos tratos físicos infligidos a un estudiante masculino en la escuela secundaria MST por parte de mi Directora, la Sra. Dianne Cruz de la Escuela Secundaria de Matemática, Ciencia y Tecnología.

Que yo sepa no se ha rendido un informe previo sobre este incidente, ni la policía o el departamento de servicios para la juventud fueron notificados, ni se ha hecho una investigación o cargos que hayan emprendido los superiores inmediatos y supervisores de nuestra principal Dianne Cruz en el nuevo Campus de Lawrence High School. No tengo ni idea de qué pasó con el chico que fue maltratado físicamente

en varias ocasiones.

El siguiente incidente fue presenciado por (1) todos los estudiantes asignados al equipo de trabajo en el Laboratorio C-303, (2) por mí, y (3) por la Sra. Connie Reusch de la Escuela Superior de Matemáticas, Ciencia y Tecnología. Este incidente se produjo en el laboratorio de computación MST C-303 durante el primer día pruebas del semestre de otoño del MAP (Medida de Progreso Académico) en el Lawrence High School de Matemáticas, Ciencia y Tecnología:

Uno de mis colegas fue asignado a disciplinar la mañana las pruebas del MAP en el Laboratorio C-303. Por alguna razón no pudo lograr que el nuevo equipo funcionara en todas las estaciones de trabajo en el laboratorio. En este ensayo de MAP el tiempo es un factor crítico, ella me pidió que me pusiera en contacto de inmediato con la Sra. Connie Reusch y le pidiera que viniera al C-303 para ayudarnos. Así lo hice. Entre tanto los estudiantes entraron en el laboratorio y se dirigieron a sus puestos asignados.

Cuando la Sra. Reusch llegó al C-303 ella habló brevemente con el encargado de la disciplina y luego me pidió que llamara a la Principal Dianne Cruz para que nos asistiera. Así lo hice. La Principal Cruz llegó al C-303 y entre ella y la Sra. Reusch y comenzaron a trabajar juntas en el problema. Durante este tiempo yo estaba de pie delante de la estación #1 del

Laboratorio de Computación en el C-303.

En el proceso de su lucha por arreglar los problemas técnicos del ordenador, un joven que estaba obviamente agitado y estresado sentado en la estación #10 habló y pidió permiso para salir de la sala. Dianne Cruz negó su solicitud. Un minuto más o menos este mismo alumno volvió a pedir que lo dejaran abandonar la sala. De nuevo le fue negado por la Principal Cruz.

Con la Sra. Reusch observando desde su posición inmediata en la fila de atrás del laboratorio de computación, donde estaba de pie junto a la estación #21, y yo observando de mi posición el frente del laboratorio, este mismo alumno se levantó y anunció que tenía que dejar el laboratorio. La Principal Cruz le dijo que se sentara. El estudiante insistió que tenía que salir. En ese momento la Principal Cruz se le paró al frente al joven y lo empujó en el asiento donde permaneció brevemente una vez más antes de anunciar que tenía que marcharse. El estudiante se puso de pie y de nuevo como antes, la Principal Cruz lo detuvo con sus manos sobre este estudiante, que le obligó de nuevo hacia su silla. Él trató de pasar, pero ella lo bloqueó, lo empujó de nuevo y luego le gritó a tomar su asiento y permanecer sentado. Sé que la Sra. Reusch estaba preocupada por esta acción porque ella y yo intercambiábamos miradas.

Como yo no era parte de esta prueba específica de MAP, Principal Dianne Cruz me dijo que saliera. Así lo hice.

Governor met Ethnic Media

More than 40 members representing Massachusetts ethnic media met at the State House with Governor Deval Patrick, on Friday, April 24, 2009.

One of the first questions the governor was asked from one of the members was if the reason for the meeting was because he, the governor, was losing popularity with the main stream media. "Not at all," was his response. "In fact, I already met with some of you before", said the Governor and suggested having similar gatherings like this in the future, perhaps on a quarterly basis.

Governor Patrick answered a wide range of questions including in-state tuition, which would permit undocumented students pay the same school tuition than documented residents; driver's licenses to undocumented residents, sales tax, and ballots printed in Chinese, among others.

Patrick said that he believes in in-state tuition for undocumented students and that he had tried to implement it by an executive order but found a huge opposition from the legislature.

"I think that every one driving in our roads should have a driver's license, but we have our hands tied since there are federal laws that prohibits it", was

Patrick's response to the driver's license for undocumented aliens issue.

"I am not convinced that sales tax is the best option to solve our economic situation," Patrick said and added that our economy is in a very tough shape and even with a stimulus package received from the federal government, it's not enough. Instead he is inclined to tax soda and candy for specific expenses.

Patrick agreed with the idea of having

ballots printed in the Chinese language also. He told to the group of journalists that since he was working at the Justice Department he advocated that all ballots should be printed in all languages.

Rumbo asked the governor for help in the matter of what is now known as the "Snooper list" or names checked by Lawrence School Department, where more than 400 people were looked into by two employees. The governor acknowledged that he read about that in the papers and "even my name was in that list."

"In Lawrence, everybody you talk to, thinks that an investigation should be conducted by the state, not the local police. Everybody, except the administration, believes that it will end up in a big cover-up, that it will be brushed under the rug. Most significant is the fact that the "whistleblower" was fired on the spot while the person who had performed most inquires was given the option to resign," I explained to the Governor.

"I have enough with managing The Commonwealth. I'm not going to go into managing Lawrence. All I know is what is on the papers and I was under the impression that Lawrence authorities were taking care of that. Something I didn't know was that the "whistleblower" was fired. I'm going to stop right there! The governor said ending the conversation on that topic.

Lawrence Family Health Center (GLFHC) is working with state and federal officials to step up their awareness and inform residents of the region as to what is going on and how to prevent getting the airborne illness.

Robert Ingala, Chief Executive Officer, states that the Community Health Center is in direct contact with officials regarding the continual updates across the country. "Over the past several days officials with the state Department of Public Health communicated with health care providers around the state, providing information on swine flu, what symptoms to look for, and how to report suspect cases. We are in close contact with DPH and will provide the public with updates as new information becomes available."

Here are steps that everyone can take to help keep from getting or spreading any type of influenza:

- Wash your hands often with soap and water, especially after you cough or sneeze. Alcohol-based hand cleaners are also effective.
- Practice good cough etiquette by coughing or sneezing into your elbow rather than your hand. Try to avoid close contact with sick people.
- If you get sick, stay home from work or school and limit contact with others to avoid infecting them.

Swine influenza cannot be transmitted from eating pork or pork products. The symptoms of swine flu in people appear to be similar to the symptoms of regular human flu and include fever, cough, sore throat, body aches, headache, chills and fatigue. Some people have reported diarrhea and vomiting associated with swine flu. Like seasonal flu, swine flu may cause a worsening of underlying chronic medical conditions.



He later became national chaplain of the American Legion. Fr. Carney was a long-time member of the faculty of Merrimack College. The scholarship is given each year to an outstanding student.

Something stinks...



MR. B'S SPORT STORIES

BASEBALL & SOFTBALL PITCHERS

Over the years with my affiliation to baseball and softball teams I got to see catch and manage some of the great pitchers of our area.

I'm sure you will say, "What about so and so. Why didn't you mention him?" Well, this story is not about my favorites although a few of them certainly made the list. The North Andover Town team that played in the old City League baseball had a pitcher named Benny Hay. I remember seeing him pitch more than once at the South Common and I'm told he only had one eye but he was good. His team featured the late greats Artie Mawson and Billy Glendenning. Bill was the last player I ever saw use a "bottle bat" most of today's player probably never heard of such a bat.

I could tell you about Art and Bill as hitters but I'm going to try to write about pitchers of the local leagues. Dick Kowalski and Gerry Callegy were a one two pitching tandem for Lawrence High School when playing for the immortal Mark Devlin at O'Sullivan Park on Water St. Dick had a blazing fastball and pinpoint control, Gerry was pretty fast but had a great curve and would fight you with every pitch. Sadly Dick gets killed while working on a summer construction site in his early college years. To this day people talk in awe of him and agree that he had Major League stamped all over him. Johnny Broaca pitched for Phillips Academy and became a Yale boxing champ before playing for the New York Yankees and even pitched in the World Series before getting traded to the Cleveland Indians and I'm told he never reported to the Indians and never pitched anywhere again.

The Lawrence playgrounds had leagues and some fine pitchers who never went to high school among them. Jackie Blackwell of South Broadway could throw and he was wild enough to keep the batter on edge. When in the Navy and pitching for the Navy Team he once lost a game to the Yankee great "Whitey" Ford by a 2-1 score. Dinny Dinicola played for the O'Connell team and he could throw any pitch, curve, drop, smoking fastball and could thread a needle on an electric sewing machine with his control. George Faucher from the Sacred Heart

area played did base but every so often he would go to the mound, to this day I don't think I've ever seen a livelier fast ball and what was a rocket arm from third base was ten times faster from the mound and his wildness would have had hitters wearing swim fins and a snorkel as they were ready to dive away from one of this righties wild heaters.

I am going to softball pitchers now and promise to come back with more baseball hurlers either in this column or in another issue. When I first saw grown men playing softball it was called "kitten ball" and was considered an old timer's game. When many former city athletes returned from WW2 the game took a new look and many companies and clubs throughout the state had league springing up and in some places drew some big crowds - Lawrence, Lowell and Haverhill among them. The Begley boys Kevin, Gerry and Paul played at the Wetherbee field, a place that I frequented where Paul was the pitcher and his brothers were infielders. In those years a rise ball, drop, or change up was unheard of. Pitchers got by with control and plenty of spin on the ball. A good defense was necessary when playing "kitten ball".

The Playstead on Lawrence St. became a hotbed for the game as did the South Common. I went there a few times and saw guys like Jack Cushing and Joe Quarterone pitching, in those days there weren't any lights at the park but somehow the got through double headers before the sun went down. Joe Platek, the Censullos, Archie Conroy, Frank Costello were the "Boys of Summer" with a lot of fans on hand.

Eventually the city took the lights and poles that the Lawrence Millionaires used and brought them to the Hayden Schofield and voila! Night softball. Teams like the Holihans, Dan's Café, the Deluca's and many others joined in. The pitching started to change and guys like Phil Corriveau and Tommy Diresa became the main hurlers of the league. More pitchers started to infiltrate the league and some pitchers from out of town wanted to be part of what was becoming the most competitive league around.

Eventually a national organization signs many softball teams to a unification deal, this so rules would be the same whenever you traveled to another area. This group

was called the A.S.A. (American Softball Assoc.).

The ASA would sponsor state area tournaments and I remember seeing a team from Salem MA bring in a pitcher who pitched three games in one day something not many of us had seen any one do. This became commonplace in softball because the pitching motion didn't bother your arm the way pitching a baseball did. The Salem pitcher was about six-foot-three and in great shape and he could really throw heat. The thing about him was he didn't wear a glove which had all of the watchers mesmerized. His opponents tried to bunt on him but he was like a cat off the mound. I got to know him in later years and he was a great guy who came from the southwest originally and hardly any pitchers in those leagues wore a glove.

There was an Army group called Climatic Research and one year Doyle Bird pitched for them and when he got out of the Army he went to work as a lineman for Mass Electrical. A couple of years later the name Wes Kooken appeared in the newspaper box scores. He was standing the league on its head pitching for the Army team that he had been transferred to. He brought with him a rise ball that none of the local guys had ever seen. His team was to face an excellent Raytheon team in the playoffs with the pride of Lawrence Softball to pitch in this best of five championship series. Tommy Diresa and his team were decided underdogs against Kooken and his sharp hitting team.

With the series tied at 2 apiece and not a seat to be had at the old ball yard there was the diminutive Diresa matching the Army's super star and team pitch for pitch. When the dust cleared the Raytheons won the game and the series and Tommy became a local legend registering all to: win some the locals started to see the rise ball on a nightly basis they started hitting the offerings of Kooken.

Wes never again pitched in our city and I think he got a transfer and although people still talk of him nobody seems to know of his whereabouts. He must be rise ball to



Formerly known by Christmas in April, it has been in operation since 1991. This group of volunteers join forces the last Saturday of April to tackle home repairs for homeowners who cannot afford to do it themselves. The mission of Rebuilding Together is to preserve and revitalize houses and communities assuring that low income homeowners, particularly those who are elderly, disabled or families with small children live in warmth, safety, and independence.

The priority is to provide free home repairs that enable these homeowners to remain in their homes longer. Each

this credited with bringing that area and the very next season many hurlers were using it. For a while there were people from Lowell coming to pitch in our league and Harry Allen who has a field named for him right on route 110 near UMass/Lowell and Ernie Wilson also came from the Lowell area. Ernie was a junk ball pitcher and loved to get those free swingers to try to hit his drop after throwing a tantalizing change up. He would grimace and show almost all his teeth and just go inning after inning without walking anyone. We use to say, "A little teeth, a little spin, a drop and sit down." He was a great guy and competitor and he also came from out west somewhere.

Dave Downey was not overpowering but had good control and could help himself with a bat. Ronnie Davis, a huge construction worker from Haverhill had a ball so fast he could throw it through a car wash and it wouldn't get wet. He had humongous arms and I don't know if he was a weightlifter or not but I know he had a great personality and always wore a smile. I don't think he threw too many breaking pitches because he could and would fire the fast ball all night with great control.

Steve Borys was a young pitcher who, if he really got serious about it, could've been a real good one. Frank McCarthy and Al Kraunelis were guys who gave the game their all and they didn't have to win at all costs.

The Porembas both Jackie the older one and Bobby could pitch, their family owned the Richwood Hotel and bowling alley/pool room on So. Union St. Jack was also an excellent baseball pitcher and could throw any pitch imaginable. Wins and losses meant little to him as he just wanted to have a good time and he did. One time at the Playstead from the softball mound Jackie threw a pitch that went over the backstop across Lawrence St and hit Zanfagna's drugstore on one hop. Everyone who saw it was amazed. Jack? He was on the mound laughing like hell.

Joe Drummond pitched a couple of years in the league and so did Andover Policeman Bob Fanning. It's funny when you go to a fast pitch game before it starts you can see many of the athletes on the sideline with great form emulating pitchers but it all changes when a batter and an umpire appears.

I must end this pitching chapter now because it's too long already. Keep watching for our next time when we talk of some old time mounds men.

WHERE HAVE YOU GONE ANDY CALLAHAN

In 2003 the Lawrence History Center received a bronze plaque from Gerard Ryan of Pembroke, MA commemorating the life of Andy Callahan. The Lawrence volunteers knew Andy Callahan was a boxer but where the plaque came from remained a mystery - something to do with the Big Dig. Further investigation revealed the plaque had hung on the wall of the old Boston Garden. The fact that this was a mystery to anyone in Lawrence shows how far out of the mainstream consciousness boxing and Andy Callahan have fallen.

Lawrence, Massachusetts is a tough former mill city located 27 miles north of Boston. Incorporated in 1853, the merchant founders built huge factories that were powered by the waters of the Merrimack River. Boxing has had a long presence in Lawrence: the earliest record was a 1860s prizefight that ended in a draw between Lawrencian Frank AcAleer and Bostonian Professor Levett.


In 1887, in an effort to avoid unfriendly police interference, Lawrence was chosen as the location for the World Lightweight title fight between Jack McAuliffe and Canadian challenger Harry Gilmore. The fight was staged in a blacksmith shop on the corner of Broadway and Merrimack Street, where White Street Paint currently operates. The ring consisted of three ropes and a solid brick wall that was put to clever use by both boxers throughout the 28-round fight. McAuliffe won and Lawrence further established its reputation as a fight-friendly town.

Born in 1910, Andy Callahan came of age in a time and a town where boys were more likely to don boxing gloves than baseball mitts. Callahan became the best fighter to come out of New England in his day (1928-1938). He held three titles simultaneously: New England Lightweight, Middleweight and Welterweight. He was afraid of nothing and often met opponents who outweighed him by as much as twenty pounds. He was the first New England boxer to die in WWII. His status as hometown hero became mythic and for many years Lawrencians would mark the anniversary of his death with solemn dedications and fond newspaper remembrances.

Andy Callahan grew up in the Irish Prospect Hill neighborhood. His father Peter worked as a stoker in the Lawrence Gas Works and possessed the same incredible endurance his son displayed in the ring. Andy was a rather unremarkable student at the parish school of St. Laurence O'Toole and spent a good deal of his time getting his knuckles rapped by Sister Ellen Patricia.

At the age of 14, Andy began visiting the gym at the old St. Anne's on Haverhill Street, home of the current Lawrence Boxing Club. He traveled the local circuit garnering his share of wins and losses. Callahan's training improved when, at age 16, he received tutelage from a local promoter, William (Tee Hee) McDonough, manager of Lawrence great Tommy "Kloby" Corcoran and Arthur Flynn.

In the spring of 1927 Andy Callahan won the amateur New England

featherweight championship at the old Boston Arena, and soon after began his professional career KO'ing Joe Morandi in one round at nearby Salisbury Beach.

Callahan's wallet had a picture of his idol, Mickey Walker, an Irish-American welterweight from Elizabeth, NJ who fought and beat several heavyweight contenders. Like Walker, Andy picked up the moniker "The Toy Bulldog" for his small stature, aggressive attack and fearless demeanor. (Callahan was only 5ft 6 inches tall, but unlike most lightweights, he had massive shoulders.) Also like Walker, Callahan fought men who outweighed him by 20 pounds and won.

The 19-year-old pro became part of renowned Boston manager John Buckley's stable and plowed through opponents, building quite a reputation with fans and the press. Throughout much of his career, Callahan had to do without sparring partners due to his inability to hold back in training. While preparing for a March 1929 fight with Baby Stribling, (younger brother of W. L. Stribling), as part of the Sharkey/W. L. Stribling card in Miami, Sharkey's sparring partner, a plus-200 pound man named Hoffman offered to spar with Callahan, strictly for laughs. Callahan flattened Hoffman with a left and the big man went down, apparently for quite awhile. (Callahan was to have trouble with his left hand after this event.)

Baby Stribling's camp heard about the incident and it was reported that Baby came down with a quick case of the measles and was replaced by a Joe McKenzie. It appeared to those in the audience that Callahan had his hands full with McKenzie. Buckley, sitting behind a reporter, yelled some instruction to Callahan during the second round. Callahan turned his back to his opponent and shouted to Buckley "Watch this one," and without stopping

to look around knocked McKenzie down with a stiff right. At 19, Callahan's raucous demeanor and winning record helped him build a large fan base.

Callahan's first major loss was in December, 1929 to Louis Kaplan, featherweight champion from Meriden, CT. Callahan broke his left hand on Kaplan's jaw in the first round, (the same left he damaged sparring with Hoffman) knocking Kaplan down for the first time in his career. Callahan proceeded to battle for nine more rounds with a broken hand and lost by decision.

After taking some time off to heal, Callahan came back and in May of 1930 began what would be the first of seven matches against Italian featherweight Sammy Fuller. The rivalry between the fighters and their fan base was intense. Promoters knew that matching an Irish-American fighter with either an Italian-American or Jewish-American fighter would guarantee big box office money. Callahan won and the two met again later in November of 1931, resulting in Callahan winning Fuller's New England Lightweight title.

This set him up for a New England title fight that many felt was insane, a match with New England middleweight and welterweight champ, Lou Brouillard. The larger and stronger of the two, Brouillard was thought to have the ability to seriously hurt Callahan. Even Manager Buckley began to have his doubts leading up to the match. The only person unconcerned was Callahan, who turned to his nervous manager before climbing between the ropes: "So, you're leading a lamb to slaughter, eh?"

Brouillard's team shouted to Lou to

Lantigua Files Budget Requests, Continues to Seek Foreclosure Solutions

State Representative William Lantigua (D-Lawrence) has submitted his budget requests for fiscal 2010 in a letter to House Committee on Ways and Means Chairman Charles Murphy (D-Burlington), and has filed amendments with the House Clerk's office in hopes of including them in the state budget.

Lantigua said he is seeking local funding of more than \$4.5 million, most of which would be distributed to Lawrence-based non-profit organizations, schools and educational programs, job-training initiatives, and capital improvement projects. At the same time, he said he would continue to promote legislation that would temporarily halt foreclosures across Massachusetts.

"This is the toughest economic climate I've ever seen," Lantigua said. "Now as much as ever, I'm fighting to help the people of Lawrence. I can do this not only by trying to get money for the organizations that do such important work for them, but by trying to help individuals and families keep their homes."

In each of the last two legislative sessions, Lantigua has filed a bill that would establish a 180-day moratorium on foreclosures, giving borrowers six months to work with lenders to modify their mortgages. He also has filed home-rule petitions that would mandate judicial review of foreclosures, require just cause for evictions, and establish a 180-day foreclosure moratorium in Lawrence. The three petitions were approved by the Lawrence City Council last year.

Additionally, Lantigua filed a budget amendment that would restore \$2 million in funding for statewide homeownership education services. He said that the pilot program has been especially effective in teaching participants to avoid mistakes in the buying and borrowing process that could put them at risk of foreclosure.

For fiscal year 2010, Lantigua is seeking \$1 million for Esperanza Academy School of Hope, a tuition-free school for girls aged 10 to 14, and \$500,000 to help fund the study and construction of a bridge over the South Canal. Lantigua also has asked for \$193,000 for AMEDAL, a citywide organization of community leaders, \$160,000 for the Lawrence/Methuen Community Coalition, \$83,000 for the Lawrence Police Athletic League, and \$100,000 for the Merrimack Valley Community Service Corps.

Lantigua said he has asked for \$163,642 for the International Institute, which supports children and families by offering job training, legal assistance, and other services; \$135,000 for the Merrimack Valley Latino Chamber of Commerce; and \$100,000 for the Massachusetts Hispanic Law Enforcement Association. Lantigua also has requested \$225,000 to fund a loan forgiveness scholarship program designed to help Lawrence and other cities across the state attract and retain Spanish-speaking mental health professionals in community health centers.

In addition to the above requests, Lantigua said he hopes to obtain funding for the following programs:

- Movement City Program, \$150,000;
- New England Puerto Rican Alliance, \$150,000;
- Lawrence Learning Center and Community Development, \$145,000;

- Neighbors in Need, \$100,000;
- New Skills Academy, \$100,000;
- Community Service Agency, Inc., \$100,000;
- De La Mano, a Spanish-language battered women's hotline, \$75,000;
- Family Service, Inc. of Lawrence, \$50,000; and
- Lawrence Senior Center, \$49,322.

Lantigua said he plans to work with Murphy and the Lawrence legislative delegation to secure as much funding for the city as possible, despite the steep economic downturn. He added that cuts to local aid and a reported \$3.6 billion revenue shortfall had not deterred him from filing amendments to the budget.

"It's no secret, this will be an uphill battle," he said. "Just because times are hard doesn't mean the people of Lawrence are throwing up their hands and saying, 'I give up.' I won't give up, either."

LEWIS: Where have you gone Andy Callahan

"Watch out for his left," but Callahan's trainers had anticipated their opponent's strategy and adjusted brilliantly. Andy Callahan was a southpaw but his right was just as powerful as his left and he used this to his advantage. Brouillard was unable to figure out how to avoid Callahan's stinging right. Camp Brouillard also warned their fighter to watch out for a wild, swinging battler; instead, Callahan carefully and thoughtfully out-boxed the bigger man. Andy Callahan won eight of the twelve rounds and walked out of the ring a triple-crown winner.

Buckley worked his managerial magic and finagled a title fight for Callahan with World Middleweight Champ, Vince Dundee. Many in the matchmaking process felt Callahan was too small to fight 158-pound Dundee, but were surprised when Andy weighed in at 150 pounds. Over \$20,000 worth of seats had been sold when Buckley fessed up to the promoter that Callahan really weighed 136 and that he'd altered the weight used on the scale. By drilling out the weight and padding it with Mercury or some other substance, Buckley had managed to add 15 pounds to Callahan's 136, bringing

him within 8 pounds of his opponent, thus satisfying weight restrictions mandated by the boxing commission rules.

It was too late to call the match off; the two men proceeded, knowing they had to perform some serious trickery to change out the weight for the scale while distracting the ever-present press. The first round was all Callahan with Andy knocking Dundee to the mat and winning 10 out of the 15 rounds. The judges, who were handpicked by Dundee, gave the fight to Dundee by one point and all hell broke lose. A furious Buckley jumped up on a table as the crowd was filing out of the Garden and shouted, "They give it to me tonight... Callahan weighed only 135!" The aftermath found Buckley fined and suspended for six months. It has been said by those who knew him best that Andy Callahan was heartbroken and this started him on the road to ruin.

Author's note: I became involved in boxing research after seeing a picture of Andy Callahan and finding very little written on this very engaging character. I don't feel I can rest till there is permanent, un-erasable documentation of this great Lawrencian...or at the very least, a garage band named the Andy Callahan's.

LHS Concerned Teachers

(First issued to Eagle Tribune: October 2008
Re-issued to all Lawrence Media: April 29, 2009)

PREAMBLE

Even though this group of concerned teachers is comprised of members of the Lawrence Teachers Union and the Massachusetts Federation of Teachers, we do not have the endorsement of Mr. Frank McLaughlin and the Lawrence Teachers Union and the endorsement of the Massachusetts Federation of Teachers. The Lawrence High School concerned teachers have acted to save our school because neither the LTU nor the MFT is willing to stand and deliver on behalf of the children attending Lawrence High School.

ISSUE ONE:

The concerned teachers state that anybody present at the main entrance to the campus between 8:00 and 8:30 am on the morning of Wednesday, September 24, 2008 could not help but notice that the students entering this high school were being totally ignored by the half dozen posted administrators and staff assigned to the Campus main entranceway. Even though they were there to make sure that all students entering this campus were dressed according to tie established high school dress code and carrying no contraband, they were too busy talking with each other to notice. Their combined inattention allowed

students to enter and passing into the high school buildings openly displaying chains, brass knuckles, and gang paraphernalia dangling from their oversized belts and belt buckles, as well as being intolerably out of the dress code. The teachers had to spend the rest of the day dealing with these issues when we should have been teaching these students.

ISSUE TWO:

The Lawrence high school concerned teachers state that never before has the level of student profanity and vulgar language been as high as it is now. This is because since last year the administrators, LTU, and MFT all have refused to address the ever increasing occurrences of student profanity in our classrooms and directed towards teachers and our innocent students. Our hallways and classrooms and testing rooms where school wide MCAS and MAPS tests are in progress, continue to echo with calls of "F--- Y--and A-H-- and F--Y--N--er!" being shouted at us teachers and our kids. And no one's doing anything about it. It's out of control. The principals and administrators of LHS, the officers and officials of the LTU, and MFT continue to turn a deaf ear to us teachers and our plea for them to bring order to our hallways and classrooms. Their

and the Administration's apparent high level of tolerance are indicators that our school is not a school we can be proud of.

ISSUE THREE:

This year thousands of dollars of the money that was available specifically to teachers for their annual purchases of Lesson/activity related "Consumables" for their kids to learn with, has been instead used by the normally set aside and made High School's Principals for capital expenditures for their individual schools. Because of this our students do not have the materials to learn with. We concerned teachers call upon the State of Massachusetts to investigate the diversion of funds for student learning/activities, and to audit this and last year's school budget purchases to identify and list said purchases and to prosecute those responsible for diverting "student learning" funds to capital purchases,

ISSUE FOUR:

The monthly attendance figures for our individual schools and LHS as a whole are nothing more than a conscious lie being perpetrated upon the people of Lawrence and the Commonwealth of Massachusetts. There is no way the student attendance figures can be accurate. With or without Dr. Sharkey's full knowledge and consent, the principals of our schools are doctoring the daily, weekly, and / monthly student attendance figures to make the daily 20 percent classroom absenteeism look more like the fictitious 6 percent classroom absenteeism the administrators have been claiming. This action, taken in addition to the security failures consistent within the "Powerschool" attendance record keeping system, constitute fraud.

An independent group of present and former LHS teachers have studied the absenteeism issue and have demonstrated that the average LHS student annually misses over 45 hours of classroom instruction per class per year. That means the average LHS student misses over 45 days of the state required 185 day school year. That alone is 25% absenteeism! Still we are confronted with the 6% absenteeism now being recorded by the various school Principals. And yet we teachers are still being blamed as the cause for little Juan's and Juanita's failure to learn.

ISSUE FIVE: UNIFORMS

Every day since the first day of this academic school year more than one of our high school administrators have been guilty of consciously and actively currying favor with the students by letting them wear their uniforms. Their actions amount to no more than a continuation of last year's ineptitude. And this is happening at the same time we teachers are being forced by our administrators to "strictly enforce" the uniform policy under threat of punishment.

It is well known to all our students, faculty, and staff that our Principals openly-and in some cases directly in front of the students in our classes- overrule us teachers on uniform issues and allow students to wear their coats, hoods, sweaters, and various expressly forbidden garments in our classrooms and hallways. It was reported to the Committee that during this week's afternoons, during 79 degree sunny weather, Principals Michael Fiato and Dianne Cruz both overruled their teachers and enabled a small number of students to openly mock the school's uniform policy by allowing them to wear their long sleeved, turtlenecked, "fullfleece" cold weather, jackets into the classrooms. This was done in direct contradiction to Dr. Laboy's written directives that permit these jackets to be worn only during cold and inclement weather.

Dr. Laboy's "fleece jacket for inclement weather" policy further states that the students' shirt collars must be visible at all times when they are wearing the fleece jackets. However, in spite of the specifics of that directive, Principal Fiato and Cruz verbally told their students that they were appropriately dressed for class and allowed that the four inch, fully zipped, turtleneck collars that obscured the students' shirt collars was permitted.

As a result, we are seeing a recurrence of screaming students.

This Committee calls for the establishment of an independent LHS Parents Committee to make unannounced monthly tours of our brand new high school so that they can see for themselves the vandalism and trashing of student bathrooms and school hallways.

RE: Open letter on Student Physical Abuse

Ladies and Gentlemen:

My Name is Algird Sunskis. For seven years I have been a technology education teacher at Lawrence High School. I am today reporting the following incident of physical abuse inflicted upon a male MST high school student by my Principal, Ms. Dianne Cruz of the Math, Science and Technology High School.

To my knowledge no previous report of this incident was ever issued, neither were the police or the department of youth services ever notified, nor were any investigations/charges ever initiated by MST Principal Dianne Cruz's immediate superiors/supervisors at the new Lawrence High School Campus. I have no idea what happened to the boy who was repeatedly physically abused.

The following incident was witnessed by (1) all the students assigned to computer workstations in Lab C-303, (2) by me, and (3) by Ms. Connie Reusch of the Math, Science and Technology high school. This incident occurred in MST computer lab C-303 during the first day of the fall semester's MAP (Measure of Academic Progress) testing in the Lawrence High School of Math, Science and Technology:

One of my colleagues was assigned to proctor the morning's MAP testing in Lab C303. For some reason she was unable to get the new, computer-based testing program running on all workstations in the lab. As this MAP testing was time-critical, she asked me to immediately contact Ms. Connie Reusch and ask her to come to C-303 to help out. I did so. In the meantime students arrived in the lab and were directed to go to their assigned, and posted, testing workstations.

When Ms. Reusch arrived in C-303 she conferred briefly with the proctor and then asked me to call MST Principal Dianne

Cruz for assistance. I did so. Principal Cruz arrived in C-303 and she and Ms. Reusch together started working the problem. Throughout this time I was standing in front of Computer Lab C-303 at workstation #1.

In the process of their struggling to fix the computer glitches, an obviously test-agitated and stressed-out male student sitting at station #10 spoke up and asked permission to leave the room. Dianne Cruz denied his request. A minute or so later this same male student again asked to leave the room. Again he was denied by Principal Cruz.

With Ms. Reusch observing from her immediate position in the back row of the computer lab where she was standing next to computer workstation #21, and me observing from my immediate position in front of the lab, this same male student stood up and announced that he had to leave the lab. Principal Cruz told him to sit down. The student insisted that he had to leave. At that time Principal Cruz stepped right up in front of the boy and pushed the boy back towards his seat where he remained briefly before announcing once again that he had to leave. The student again stood up and as before, Principal Cruz stopped him and with both her hands on this student, she again forced him back towards his chair.

He attempted to get passed her, but she blocked him, pushed him back and then yelled at him to take his seat and to remain seated. I know Ms. Reusch was concerned about this action because she and I both exchanged concerned glances.

As I was not part this specific MAP testing, I was subsequently directed by Principal Dianne Cruz to leave. I did so.


