# Comenzó la carrera en el Distrito 16

**D**espués de la renuncia del representante William Lantigua a su puesto en la Casa del Estado, el viernes 12 de febrero, 2010 antes de completar su término, la ley dice que una elección especial debe realizarse con el objeto de cubrir su posición.

De acuerdo con Rafael Tejeda, Coordinador del Departamento de Elecciones, House Speaker Robert A. DeLeo debe convocar la elección, de acuerdo a lo establecido en el Capítulo 54, Sección 141 de las Leyes Estatales.

"Otra cosa que todavía está por determinarse es si los candidatos que ya sacaron papeles de nominación para el Distrito 16, para las Primarias de septiembre 14, y las Elecciones Finales de noviembre 3, podrían utilizar estos mismos papeles para la especial o si necesitan sacar nuevos", dijo Tejeda.

Tejeda dijo que la fecha de la elección especial es también muy importante, ya que los candidatos necesitan saber cuándo deben regresar los documentos con las firmas y el Departamento de Elecciones necesita tiempo para imprimir las boletas.

El Ing. Marcos Devers, quien recibió el apoyo de Lantigua el mismo día de su renuncia y Rafael Gadea, un electricista que trabaja para la Ciudad de Lawrence son, según Tejeda, los dos únicos candidatos que ya sacaron papeles de nominación.

Tejeda entiende que Lesly Meléndez, Francisco Brea y Enrique Matos están considerando lanzarse a la contienda y que hay una posibilidad de que algunos de los candidatos no se presenten en la elección especial, sino sólo en la elección ordinaria.

"Espero que tengamos algunas respuestas la próxima semana", finalizó Tejeda.

## District 16 race started

**A**fter the resignation of Representative William Lantigua to his seat in the House of Representatives, on Friday, February 12, 2010, before completing his time, the law calls for a special election should be held to fill his position.

According to Rafael Tejeda, Election Division Coordinator, the election has to be called by House Speaker Robert A. DeLeo, as established in Chapter 54, Section 141 of the State Law.

"Another thing that still needs to be determined is whether the nomination papers for District 16 already pulled by the applicants for the September 14th Primary and the General Election of November 3rd could be used for the Special Election or need to pull new ones," said Tejeda.

Tejeda said that the date for the special election is also very important, since the candidates need to know when to return the papers with the signatures and the election department needs time to print the ballots.

Ing. Marcos Devers, who received Lantigua's endorsement the same day of his resignation and Rafael Gadea, an electrician working for the City of Lawrence are, according to Tejeda, the only two candidates who already pulled nomination papers.

Tejeda's understanding is that Lesly Meléndez, Francisco Brea and Enrique Matos are considering running and that there is a possibility that some of the candidates might not run in the special election, but only in the regular election.

"Hopefully we will have some answers next week," ended Tejeda.

## ¿Podríamos tener una elección especial?

Si bien los medios de comunicación estaban exigiendo a gritos la renuncia de William Lantigua de su posición como Representante Estatal del Distrito 16, de repente se callaron dando por sentado que fue un hecho el viernes, 12 de febrero. ¿No sería divertido si Lantigua recupera la carta diciendo que él cambió de idea? ¡Por supuesto, sólo estoy bromeando! El hecho es que él presentó su carta al Presidente de la Cámara Robert DeLeo y él la archivó, pero la Legislatura no la ha leído, y mucho menos aceptado.

Si Lantigua hubiese renunciado después del 31 de mayo, no sería un problema; pero como quedan más de seis meses de su mandato, debe celebrarse una elección especial hasta que un representante permanente pueda ser elegido en el otoño para el período oficial de dos años a menos que la Cámara decida otra cosa.

Ahora bien, hay un signo de interrogación en cuanto a si habrá o no una elección especial en Lawrence para llenar la posición del Representante Estatal. La

Cámara de Representantes se encontraba de vacaciones escolares y se reunirá esta semana para discutir si ha tratado de ser aprobada (después de aprobar la renuncia de Lantigua).

Dada la situación financiera de Lawrence, algunos funcionarios de la ciudad esperan que la Cámara de Representantes decida esperar a la Primaria de septiembre y las Elecciones Generales de noviembre. Se ha sugerido en la Casa de Estado que la Ciudad de Lawrence no está representada por un solo miembro y los Representantes Barry Finegold y David Torrisi, así como la Senadora Susan Tucker pueden proteger los intereses de nuestra ciudad, en caso de haber una necesidad de representación.

Una solución que no preferida, ni está siendo discutida es la de nombrar a un representante estatal en forma provisional hasta las elecciones de otoño.



## CAPÍTULO 54. ELECCIONES

PROCEDIMIENTO EN CASO DE NO ELEGIR, Y VACANTES EN LAS OFICINAS DEL ESTADO

Capítulo 54: Sección 141. Representantes en el tribunal general, las vacantes

Sección 141. Cuando haya una vacante en el cargo de representante en el tribunal general o en caso de fallo en elegir, el presidente de la Cámara de Representantes deberá emitir preceptos a los concejales de cada ciudad y los regidores de cada municipio que comprende el distrito o parte de él, indicando el tiempo en que la Cámara de Representantes ordenará una elección para cubrir dicha vacante; siempre que si la vacante se produce durante un receso entre los períodos de sesiones anuales primero y segundo del tribunal general, el presidente puede fijar la fecha para una elección para cubrir dicha vacante. Todas las elecciones se celebrarán en martes. Tras la recibo de tales preceptos, los concejales o los regidores deberán convocar a elecciones, que se celebrarán en conformidad con los preceptos.

# Talento de Lawrence se une en canción de caridad

Hace unas semanas, Bylli Crayone de Lawrence, quien es una sensación dentro de la música bailable, se le ocurrió la idea de grabar una canción de caridad con todos los ingresos destinados a Haití y se la presentó a varios de los artistas de la zona representando varios géneros de la música.

Los artistas establecidos, así como los que apenas están comenzando en la escena musical, veinte artistas, cantantes y raperos se reunieron durante semanas para analizar la canción, escribir un plan, el proceso de la grabación y el proyecto global en sí. En pocos días, la radio local, periódicos y la televisión estaban apoyando el proyecto. De hecho, Bylli Crayone y el grupo se reunieron con el Alcalde William Lantigua, quien les dio su bendición y mostró un gran apoyo.

El sábado, 20 de febrero, la Ciudad de Lawrence hizo historia en la música. Los 20 artistas fueron a Insight Studios en Manchester, NH para grabar la canción "Trust And Believe" (Confiar y Creer). Fue producido por Jerel "Proff" Norris y Bylli Crayone. Bylli Crayone también fue director musical de este proyecto orientando y dirigiendo a los artistas.

Originalmente, Bylli no quiso estar involucrado con esa parte de la canción ya que él ya tenía bastante trabajo con toda la publicidad y la promoción del proyecto. De hecho, ni siquiera quería estar en la canción. "Yo quería ser como Quincy Jones, el hombre detrás de la escena cabiéndolo todo posible", dijo Bylli. "Escribí el coro y eso es todo lo que quería hacer, pero en el último minuto, las cosas cambiaron: yo estoy en la canción", agregó.

El sábado fue una sesión de grabación de todo el día, de 11am a 8pm. Todos los artistas se unieron como si fueran de la familia. "No hubo egos, no hubo drama, no hubo problemas. Todo resultó muy fácil", dijo Bylli. "El proceso de grabación fue mágico! Cuando todos estaban en la cabina cantando a coro por primera vez, nos entraron escalofríos y nos sorprendió la energía que todos ellos añadieron a la canción", agregó.

## Lawrence talent unite for charity song

A few weeks ago, dance music sensation Bylli Crayone of Lawrence, came up with the idea of recording a charity song with all proceeds going to Haiti and reached out to several of the area's recording artists from various genres of music.

Established artists as well as new comers to the music scene, twenty artists, singers and rappers met for weeks discussing the song, writing plans, recording process and the overall project itself. Within days, local radio, newspapers and television were supporting the project. In fact, Bylli Crayone and the group met the Mayor William Lantigua who gave them his blessings and showed great support.

On Saturday, February 20th, music history was made for the City of Lawrence. The 20 artists went to Insight Studios in Manchester, NH to record the song "Trust And Believe". **E**l 16 de febrero se cumplió el 92 aniversario de la restauración de la independencia de Lituania. ## Lithuanian Independence Day honored

**F**ebruary 16th was the 92nd Anniversary of the 1918 restoration of independence to Lithuania. Having been occupied by Communist Russian troops during the Second World War, it was not until 1991, that the citizens of Lithuania finally achieved the restoration of their free, independent and democratic nation as declared in 1918.

Whereas, February 16, 2010, marks the 92nd anniversary of the 1918 restoration of independence to Lithuania; and,

**L**a razón más importante para poner este tema en la agenda del día fue para abordar el mayor obstáculo que impide que la Legislatura del Estado permita que nuestra ciudad continúe autónoma y conservar así la voz de nuestra comunidad - ese obstáculo era el alcalde que ocupaba dos puestos como alcalde y representante estatal. La Legislatura del Estado envió una señal muy fuerte de que si el alcalde no renunciaba a una de sus posiciones, le quitarían al Concilio y el Alcalde la habilidad de fijar la política de nuestra ciudad. El viernes, el alcalde tomó la decisión correcta y renunció a su escaño como representante estatal. Esperemos que, esta acción ayudará a la ciudad a mantener su autogobierno. Doy la bienvenida a un supervisor del estado, y creo que si escuchamos la experiencia de este gerente profesional, podemos seguir gobernando libremente, dar a nuestros constituyentes una voz en la toma de decisiones, y,

finalmente, tomar las decisiones difíciles que mejorarán la condición financiera de nuestra ciudad.

Sin embargo, no se equivoquen que cuando hablamos, nuestra audiencia no es sólo nuestros constituyentes, sino también las fuerzas en Beacon Hill y en Wall Street. Beacon Hill, a través de la ayuda estatal, no sólo contribuye con más del 70% de nuestros ingresos, sino que también afectarán directamente a nuestro estilo de gobierno representativo cuando regresen de las vacaciones de febrero. Así que si nuestro objetivo es continuar autónomos con un supervisor, debemos adoptar nuevas medidas que deben dar confianza al resto del estado de que podemos y debemos gobernarnos.

#### 1. Tenemos que sanarnos.

Beacon Hill conoce de estas acciones y por desgracia, promueve una opinión poco halagüeña de nuestra ciudad.

Concejales, como líderes, tenemos que animar al alcalde a tomar medidas que no sólo sanen a nuestra ciudad, sino también repudiar la política al viejo estilo. 

6. Contribuciones de efectivo hechas a través de mensajes de texto, cheques, tarjetas de crédito o de débito pueden ser reclamadas en su declaración de impuestos federales.
7. Usted debe detallar sus deducciones para reclamar estos donativos en su declaración de impuestos.
8. Usted tiene la opción de deducir estas contribuciones ya sea en su declaración de impuestos del 2009 o del 2010, pero no en ambas.
9. Contribuciones hechas a organizaciones extranjeras por lo general no pueden deducirse. Usted puede obtener información acerca de organizaciones ayudando a víctimas del terremoto en Haití de agencias tales como U.S. Agency for International Development ([www.usaid.gov](http://www.usaid.gov)).

### Would we have a Special Election?

While the media went into a frenzy demanding William Lantigua's resignation from his position as State Representative of District 16th, they suddenly went quiet taking it for granted that it was a done deal on Friday, February 12th. Wouldn't it be funny if Lantigua retrieves the letter saying that he changed his mind? Of course, I'm only kidding! The fact remains that he tendered his letter to the Speaker Robert DeLeo and he filed it but the Legislature has not read it, let alone accepted it.

Had Lantigua resigned after May 31, there would not be a problem; but because we have more than six months left in his term, a special election must be held until a permanent representative can be elected for the official two-year term in the fall unless the House decides otherwise.

Now, there is a question mark as to whether or not there will be a special election in Lawrence to fill the position of State Representative. The House of Representatives was on school vacation and will be meeting this week to discuss if it is to be approved (after they approve Lantigua's resignation).

Given the financial situation of Lawrence, some city officials are hoping that the House of Representatives decides to forgo that process and wait for the September Primary and November General Elections. There have been suggestions at the State House that the City of Lawrence is not represented by only one member and Representatives Barry Finegold and David Torrisi, as well as Senator Susan Tucker can protect the interests of our city, should there be a need of representation.

A solution that is neither wanted nor being discussed is that of appointing a state representative on an interim basis until the fall elections.

### Councilor Laplante's comments

At the end of last Wednesday's City Council meeting, District F Councilor Marc Laplante read a statement complaining about Mayor William Lantigua for not reaching out to the English-language media. We agree.

If Lantigua did not want to grant interviews during the campaign (for whatever the reason) to the "newspaper

of record," as he called it, he is now the mayor of a city that needs a lot of support. Opening up to the media is the best way to eliminate the lies and conjectures that we are so tired of hearing locally and through the Boston media.

We recommend that you read Laplante's statement on page 17 and notice how ironic it seems that he wants to abolish "doing politics as usual" but is OK to pander to "Beacon Hill power brokers" as he calls our state politicians. That sounds to me like doing politics as usual.

Now, let me clarify some points he made there. I don't know what defines "the newspaper of record." Is the biggest? The most widely circulated? Well, Rumbo covers Lawrence and with regard to the residents of District F "who do not understand Spanish," perhaps Councilor Laplante has never read Rumbo because he would have noticed that it is bilingual in Spanish and English. So, by reaching

### CHAPTER 54. ELECTIONS

PROCEEDINGS UPON FAILURE TO ELECT, AND VACANCIES IN STATE OFFICES

Chapter 54: Section 141. Representatives in general court; vacancies  
Section 141. Upon a vacancy in the office of representative in the general court or upon failure to elect, the speaker of the house of representatives shall issue precepts to the aldermen of each city and the selectmen of each town comprising the district or any part thereof, appointing such time as the house of representatives may order for an election to fill such vacancy; provided, that if such vacancy occurs during a recess between the first and second annual sessions of the same general court, the speaker may fix the time for an election to fill such vacancy. All such elections shall be held on a Tuesday. Upon receipt of such precepts, the aldermen or the selectmen shall call an election, which shall be held in accordance with the precepts.

Whenever the financial situation does stabilize, however I expect we will plunge right away into budget preparation. This is never easy for anyone but it needs to be done. I would like to take an opportunity to preempt the inevitable issue of the Branch Library, especially as I see more of the Boston Public Branches are being threatened. The case is different here in Lawrence. We employ no extra personnel to run the Branch—Maureen and Rosemary

who work there are on our regular staff and would be working anyway for the same hours at the same rate. On the plus side we provide a very popular (and growing) service to the south side and we house the beautiful Irish collection which is the finest such one north of Boston. Maintaining the Branch is all advantage—no disadvantage.

Sharon has served the City Of Lawrence in this library for over forty years. Twice she has stepped in and acted as Interim Director. "It means the world to us that this club wanted to make such a generous gift in honor of Jeff," said Hull. "This gift is a tribute to the person he was. This donation will help us continue our mission of providing end-of-life care to patients with terminal illness and their families."

Gail praised the organization for the care both she and Jeff received while he was a resident of the Merrimack Valley Hospice House.

"Without the staff at the Hospice House I wouldn't have been able to go through this," recalled Gail of her time spent with Jeff while he was at the Merrimack Valley Hospice House. "They were truly amazing, and helped me through the whole thing."

The Kingston Veterans Club is located in Kingston, New Hampshire. The club was established in 1946, by a group of

local, returning, WWII Veterans. They are a nonprofit organization that supports our local community through various events and programs. Membership to the club is open to all honorable discharged veterans.

The hospice house is staffed with specially trained nurses who provide 24 hour care in collaboration with a team of physicians, aides, social workers, chaplains and volunteers.

Together the three agencies serve more than 80 communities throughout the Merrimack Valley, Northeastern Massachusetts and Southern New Hampshire. # Comments before the Lawrence City Council

The most significant reason for placing this item on the agenda was to address the biggest obstacle preventing the State Legislature from allowing our City to continue self-governing and therefore retaining the voice of our community – that obstacle was the Mayor occupying dual positions as mayor and state representative. The State Legislature sent very strong signals that if the mayor did not resign one of his positions, that they would take away the Council and Mayor's ability to set policy for our city. On Friday, the mayor made the right decision and resigned his seat as a state representative. Hopefully, this action will help the city retain self governance. I welcome a state overseer, and believe that if we listen to the experience of this professional manager, we can continue to self govern, give our constituents a voice at the decision making table, and ultimately make the tough decisions that will dramatically improve our City's financial condition.

However, make no mistake that when we speak, our audience is not only our constituents, but also the powers on Beacon Hill and Wall Street. Beacon Hill, through state aid, not only contributes over 70% of our revenues, but they will also directly impact our representative style of government when they reconvene after their February break. So if our goal is to continue self governing with an overseer, then further steps need to be taken to provide confidence to the Commonwealth that we can and should self govern.

## 1. We need to heal.

After the November election, it appeared that the mayor did not want to speak to the newspaper of record. I

applaud the mayor for reaching out to the Spanish speaking media, but he should also reach out to the English speaking media. Frankly, the English speaking media is read by the power brokers on Beacon Hill and Wall Street, and significantly impacts their opinions. The mayor needs to be as accessible to the English speaking media as he is to the Spanish speaking media. Not only will this help us communicate a positive message to Beacon Hill, it also allows the Mayor to communicate to the thousands in my district who do not understand Spanish.

## 2. We need to show Beacon Hill that Lawrence is not conducting politics as usual.

The mayor has an opportunity to improve our political culture. Old style politics would require that any perceived political enemies be terminated, and friends or cronies would be hired to replace them. However, in these unique times, this conduct is counterproductive since Beacon Hill, and the people we represent, expect more. So far, the mayor has laid off one individual (who the council voted to retain), and has fired several others, all in

the name of saving money. However, many of these positions have been posted to be re-filled. This questions the costs savings explanation, and allows for the criticism that the terminations were political vendettas. Also, the job postings were not published in the newspaper of record, which has a wide circulation through its print and web readership. In addition, we are 45 days into the Administration's term, and the Mayor has department heads working in "acting" or "interim" capacities without sending their names before the City Council for approval as required by the City Charter. Beacon Hill knows of these actions, and it unfortunately promotes an unflattering opinion of our City.

Councilors, as leaders, we need to encourage the mayor to take the actions that will not only heal our city, but also repudiate old style politics. Beacon Hill is watching and the municipal bond brokers on Wall Street are watching. The mayor made the right decision to resign from the State Representative's position, and he needs to continue taking actions that build confidence not only among our constituents, but also the power brokers on Beacon Hill and Wall Street.

- 2009 tax return, donations must be made after Jan. 11, 2010 and before March 1, 2010.
4. In order to be deductible, contributions must be made to qualified charities and can not be designated for the benefit of specific individuals or families.
  5. The new law applies only to cash contributions.
  6. Cash contributions made by text message, check, credit card or debit card may be claimed on your federal tax return.
  7. You must itemize your deductions in order to claim these donations on your tax return.
  8. You have the option of deducting these contributions on either your 2009 or 2010 tax return, but not both.
  9. Contributions made to foreign organizations generally are not deductible. You can find out more about organizations helping Haitian earthquake victims from agencies such as the U.S. Agency for International Development ([www.usaid.gov](http://www.usaid.gov))
  10. Federal law requires that you keep



# Governor Patrick Keeps Focus on Reducing Small Business Health Care Costs, Launches Second Set of Hearings

Insurance Commissioner to lead statewide sessions with business leaders; Effort part of Governor's work to improve business climate, create jobs

**C**ontinuing his focus on reducing small business health care costs, Governor Deval Patrick today announced that the Commissioner of Insurance will launch a second set of hearings to review the double-digit premium increases burdening small businesses across Massachusetts. This effort - the latest in a series of initiatives the Governor has introduced to improve the state's business climate - is designed to control costs and fuel the job creation that will drive the Commonwealth's economic recovery.

"Small businesses and working families need relief from skyrocketing health care costs and they need it now," said Governor Patrick.

The hearings will take place on Monday, March 1st in Hyannis; Tuesday, March 2nd in Boston; Wednesday, March 3rd in Pittsfield; Thursday, March 4th in Lawrence; Friday, March 5th in Framingham; and Monday, March 8th in Fitchburg. Locations will be available later this week at [www.mass.gov/doe](http://www.mass.gov/doe).

"These sessions with business leaders will continue our conversations with a variety of stakeholders about the root causes of premium increases," said Insurance Commissioner Joseph G. Murphy.

"In this tough economy, small businesses and their employees have been disproportionately hit with double digit health insurance premium increases, the levels of which have not been felt by big business and big government purchasers," said Jon Hurst, President of the Retailers Association of Massachusetts. "At a time when we require everyone to have health insurance, it is imperative that we have the tools available to make insurers give small employers comparable coverage for comparable premiums. We thank the Governor for making this a top priority of his Administration."

At the Governor's direction, the Division of Insurance launched its first set of statewide hearings in November. The hearings, which took place in Lowell, Bridgewater, Worcester, Springfield and

Boston, examined factors that are leading to health insurance premium increases, concentrating on small group premiums and actions that carriers are taking to address costs.

Simultaneously, the Division held a series of special sessions on group purchasing cooperatives. The cooperatives would allow small businesses and individuals to combine their purchasing power and seek lower premiums through a larger entity, while also including protection from membership restrictions and allowing the cooperatives to choose and sponsor their own health products and health promotions.

In an address to the Greater Boston Chamber of Commerce on February 10th, Governor Patrick unveiled his small business jobs incentive plan aimed at helping small businesses hire new workers and reduce the cost of doing business. The proposal includes the following measures designed to control health care costs:

- Using existing authority, the Governor directed the Insurance Commissioner to immediately file an emergency regulation requiring health insurance companies to file proposed changes in small business premiums with the Division of Insurance in advance of their taking effect so the Commissioner can review and disapprove rates that are excessive or unreasonable in relation to the benefit provided.
- Legislation to trigger a presumptive disapproval of health insurer rates that are significantly above the Consumer Price Index for Medical Services. The Governor's bill also provides for similar oversight of provider rates to ensure shared responsibility for controlling costs.
- Gives smaller companies the choice of more affordable plans beginning this July by requiring health insurance carriers in

the small group market to offer at least one selective network plan with premiums that are at least 10 percent lower than the premiums for the full network product. The Governor's proposal also allows insurers to set up bi-annual open enrollment periods to encourage people to get and keep health insurance.

- Grants the Insurance Commissioner the authority to examine small business health insurance premiums and prevent any duplicative or unjustified administrative charges that drive up costs for small businesses. The Governor's plan also empowers the Commissioner to protect small businesses from drastic increases in their premiums driven by changes in the composition of their workforces (particularly the age of their workforces).

Governor Patrick has maintained a strong focus on creating the conditions for business growth and job creation since the start of his administration. The Governor has lowered the corporate tax rate, streamlined permitting and cut state permitting time to six months or less and invested in the state's broken roads and bridges by putting people to work on hundreds of infrastructure projects across the state.

Additionally, he has invested in the Life Sciences, Clean Energy and other innovation industries that promise to be the Commonwealth's anchor employers of tomorrow and are driving the state's recovery today. Just last week, the Governor signed legislation to provide immediate relief to Massachusetts businesses by freezing their contributions to the Unemployment Insurance Trust Fund at current levels. The new law prevents a scheduled rate hike from taking effect, saving businesses almost \$400 million this year. 
