## EDITORIAL | EDITORIAL

### La controversia nos mantiene vivos

Mirando hacia atrás en el año que acaba de terminar, honestamente no podemos decir que ha sido un año muy bueno para Lawrence, especialmente para algunos lawrencianos. Ciertamente, mientras que algunos de los objetivos para la Ciudad de Lawrence se llevaron a cabo, esos mismos logros colocaron a algunos de sus ciudadanos en una situación sombría.

No es un secreto que la administración del Alcalde William Lantigua heredó un enorme déficit que obligó a la ciudad para solicitar la autorización de la Legislatura para pedir prestado hasta \$35 millones para cubrir el déficit y equilibrar el presupuesto de 2011.

Mientras que el presupuesto fue equilibrado, muchos empleados de la ciudad fueron despedidos o suspendidos, sobre todo, y el más doloroso de todos, los bomberos y agentes de la policía dejando a muchas unidades del departamento desmanteladas.

Las negociaciones con los sindicatos de bomberos dio lugar a la reincorporación de todos ellos, con algunos nuevos yendo a la academia, mientras que las conversaciones con los sindicatos policiales han dado lugar a un callejón sin salida, sin concesiones a la vista, con la administración y los sindicatos policiales acusándose el uno al otro por la falta de progreso.

En todas partes la delincuencia de todo tipo aumentó durante el año. En Lawrence, llevó a los opuestos a los despidos de policías a decir que fue una consecuencia directa de la reducción de la fuerza. Eso y una larga lista de otras razones motivó a un grupo llamado It's Your Right - Es tu Derecho a revocar al Alcalde Lantigua. El intento fracasó y de inmediato un nuevo grupo llamado Uniendo a Lawrence se formó, presidido por Josué Hernández, que está llevando la antorcha hacia el 2012.

Apesar de los tiempos de ferreño bloqueo económico, los recortes presupuestarios y otros elementos negativos que afectan a ciudades de todo el país y su desarrollo, 2011 fue un año muy exitoso para el desarrollo de la ciudad de Lawrence, de acuerdo con el Departamento de Desarrollo Comunitario de Lawrence. Entre ellos, con una subvención recibida del Departamento de Vivienda y Desarrollo Comunitario de Massachusetts la ciudad construyó un puente vehicular y peatonal de 3 carriles a través del Canal del Norte para mejorar la calle Island y servir la infraestructura relacionada con el Union Crossing Development, que se inauguró el 13 de diciembre.

La toma de nuestro sistema escolar por el Estado y los parquímetros instalados en algunas calles están trayendo otro tipo de controversia en el Año Nuevo. Parece que la polémica es parte de la cultura de Lawrence. Debemos estar agradecidos por el hecho de que podemos expresar abiertamente nuestras opiniones sin temor a las consecuencias, con la esperanza de que con ello traeremos los cambios necesarios para mejorar nuestra calidad de vida.

### Controversy, it keeps us alive

Looking back at the year that just ended, we cannot honestly say that it was a very good year for Lawrence, especially for some Lawrencians. Certainly, while some of the goals for the City of Lawrence were accomplished; those same accomplishments left some citizens in a grim situation.

It is not a secret that the administration of Mayor William Lantigua inherited an enormous deficit that forced the city to request permission from the Legislature to borrow up to \$35 million in order to cover the deficit and balance the 2011 budget.

While the budget was balanced, many city employees were fired or laid off, especially and the most painful of all, firefighters and police officers, leaving many department units dismantled.

Negotiations with the firefighters unions resulted in the rehiring of all of them, with some new ones going to the academy while conversations with the police unions have resulted in a dead end with no concessions in sight, with both, the administration and the police unions pointing fingers at each other for the lack of progress.

All over, crime of all sorts climbed during the year. In Lawrence, this prompted those in opposition to police layoffs to say that it was a direct consequence of the reduction in enforcement. That and a long list of other reasons prompted a group called It's Your Right - Es tu Derecho to recall Mayor Lantigua. The attempt failed and immediately a new group, named Uniting Lawrence was formed, presided by Josue Hernandez who is taking the torch into the 2012.

Despite the harsh economic times, budget cuts and other negative elements that affect cities all around the nation and its development, 2011 was a very successful year for the development of the City of Lawrence, according to the Lawrence Community Development Department. Amongst them, a grant from Massachusetts Department of Housing and Community Development, allowed the city to build a 3-lane vehicular and pedestrian bridge across the North Canal to improve Island Street and related infrastructure and serve the new Union Crossing Development, which was inaugurated on December 13th.

The taking of our school system by the state and the new parking meters installed in selected streets are bringing additional controversy into the New Year. It seems that controversy is part of Lawrence's culture. We must be thankful for the fact that we can openly express our opinions without fear of consequences, with the hope that it will bring the necessary changes to improve our quality of life.



# Lawrence seguirá avanzando con o sin el Jefe Romero

Desde que asumió el gobierno de la Ciudad de Lawrence en enero del 2010, el Alcalde William Lantigua ha tenido que tomar importantes y hasta impopulares decisiones para echar esta ciudad hacia delante por el camino correcto. Estas acciones han afectado no sólo al departamento de policía, sino a cada departamento de la ciudad y a muchos de sus residentes.

Mike Sullivan, el peor administrador que Lawrence haya tenido en el pasado, dejó nuestra ciudad al borde de la bancarrota con un déficit de 24.5 millones de dólares. Y no sólo eso, la organización de los departamentos en el City Hall era un verdadero desastre. Cada jefe de departamento era un gobierno aparte con muchos funcionarios y empleados que solo les interesaba su cheque cada dos semanas.

Alguien con gran valentía y sin miedo a ganarse enemigos, o a perder apoyo político en ciertos sectores tuvo que intervenir y hacer los cambios necesarios para hacer el gobierno más eficiente y mejorar los servicios a la comunidad. Los

resultados están ahí: Dos años consecutivos con presupuestos balanceados con cifras reales, dos años consecutivos con más de 10 millones de dólares en superávit, mejoras considerables en la calidad de los servicios municipales, reparaciones de calles y avenidas que tenían décadas de deterioro y mucho más.

Solo la lectura del título del editorial del Eagle-Tribune del día 26 de diciembre pasado, podría ser realmente aterrador, aunque no para los residentes de Lawrence que ya estamos acostumbrados a este tipo de publicaciones de este periódico: "La ciudad debe estar en guardia contra los planes para sacar al jefe de policía". Esto suena como una catástrofe que nos arropará a todos y que marcará el fin del mundo.

Se habla de unos rumores que circulan por ahí anunciando el reemplazo de John Romero como jefe de la policía de Lawrence. El editorial advierte sobre la existencia de "un complot para derrocar al Jefe de Policía John Romero" orquestado por el Alcalde Lantigua y miembros del Concejo Municipal. El Eagle-Tribune, no sólo se hace eco del chisme para sus lectores, sino que los insta a "estar en guardia contra cualquier intento de sustituir al jefe policial"

Pero el Eagle-Tribune olvida de nuevo un punto muy importante, como lo hizo durante las últimas elecciones municipales en Lawrence. No sólo apoyaron directamente a todos los

candidatos perdedores que participaron en los esfuerzos para derrocar al Alcalde Lantigua, sino que pidió a los lectores votar en contra de los candidatos apoyados por el alcalde. El Eagle-Tribune parece olvidar que vivimos en una democracia en la que el poder está en el pueblo y no en un individuo en particular.

John Romero no es un oficial elegido por el voto del pueblo; ni fue nombrado por el alcalde de entonces, para ocupar el cargo de por vida. El Jefe Romero no es un caudillo con poderes ilimitados heredados de sus abuelos. El Jefe Romero no está ni debe estar por encima de otros jefes de departamentos en la administración de William Lantigua como Alcalde de Lawrence. La Carta Constitucional de la Ciudad es clara y precisa al describir la posición de jefe de policía. Los candidatos deben ser nominados por el alcalde y confirmado por el Concejo Municipal, eso es todo. Es la forma en que funciona la democracia.



## FEMINISMO RADICAL

Uno de los hechos que caracterizan nuestro tiempo es la manipulación del lenguaje y la confusión de los conceptos. Las palabras quedan vacías de su sentido original y toman otros contenidos nuevos.

Algo de esto ocurre con el feminismo original y el feminismo radical, que ha derivado del anterior. Para Cristina Hoff Sommers, el feminismo es la creencia en la igualdad legal y moral de los sexos. Es un movimiento de la historia, espontáneo, que es protagonizado por mujeres y no tiene carácter político, sino que tiene que ver con todos los campos de la vida, y persigue la justa reinvocación de la igualdad jurídica, social y política de la mujer y el hombre.

El feminismo radical es una ideología política sustituta del marxismo en el imaginario teórico de la izquierda progresista. Lo mismo que hay ricos

opresores y pobres oprimidos, también la mujer está presa en un sistema patriarcal opresivo. El nivel de radicalidad de este feminismo puede tener distintos grados de desarrollo, desde lo más elemental hasta los casos más extremos y radicales, de carácter maoísta.

De los restos del feminismo radical surgió en Estados Unidos la ideología de género, que hoy día comprende a otros movimientos feministas. La feminista M<sup>a</sup> Giovanna Nocelli llega a afirmar que "aceptar la ideología de género es, para el feminismo, una forma de suicidio".

La ideología de género ha desarrollado los modelos de emancipación de la mujer, que pretende el igualitarismo entre hombres y mujeres, aunque en realidad termina reduciéndose a "imitar al varón".

Radical feminism is a political ideology of Marxism substitute the imaginary theory of the progressive left. As there are wealthy oppressors and oppressed poor, the woman also is caught in an oppressive patriarchal system. The level of this radical feminism can have different degrees of development, from the elementary to the most extreme and radical Maoist character.

Of the remnants of radical feminism emerged in the United States gender ideology, which today includes other feminist movements. The feminist Maria Giovanna Nocelli claims that "to accept the ideology of gender is to feminism, a form of suicide."

The gender ideology has developed models of emancipation of women, which aims to egalitarianism between men and women, but actually ends up being reduced to "mimic man".



## NOTES FROM YOUR LIBRARIAN

Hello Rumbo readers. I hope you all had a wonderful Christmas and wish you all the best for the New Year. Besides my own family, I know quite a number of other people who lost friends, family and loved ones this past year. For all of us there will be some melancholy in celebrating the holidays this time around. All I can say is we each need to value even more the ones we still do have.

Good news for the library! We received our waiver from the state and so will be safe from decertification for another year. I have explained the waiver process in the past but, briefly: each city and town in the commonwealth needs to finance its library to a level that satisfies an equation set by the Commonwealth Board of Library Commissioners. Also we have to abide by standards regarding the number of hours open during a normal week and the percentage of the overall annual budget used for the purchase of books and subscriptions. While I have managed to arrange things (not without difficulty I assure you!) to satisfy these two latter requirements we have not been able to meet the first one in years. Lawrence is far from being alone in this situation. Between a third and a half of all libraries in the commonwealth have had to apply for a waiver this year.

To me, this indicates a problem. If such a large percentage of Massachusetts libraries cannot meet the standard set by the board perhaps the standard needs to change to adapt to the realities of the current world. When I was first named director here, in 2005, the state was giving out only

eleven waivers per year. This year it will be over one hundred and twenty. While I have no complaint with the state regarding the availability of the waivers—they have been generous and the requests are rarely denied—there is something wrong with the system. Each of the one hundred and twenty odd libraries applying for the waiver must go through complex and time consuming paperwork and data gathering in order to correspond to the strictures of a model that is no longer appropriate for our current economic situation.

I know I get a bit intense on this subject but every year I see a couple of towns actually lose their library certification. Usually the victims are smaller communities whose economic pictures are scaled down and who have less flexibility as to the division of the community economic pie. I believe it is the right of every person in this commonwealth to have access to library services. I hope one day to see our system reformed so that no one is without that service. I mean to make no complaint against the people who work for the Board of Library Commissioners. They are a tremendously helpful and supportive crew. My issue is with the rules governing the board and with what was originally a plan to protect libraries becoming an annual ordeal for us and our city governments to prevent being decertified.

This is my first article for 2012. It just occurred to me that I have been writing for Rumbo for seven straight years. I consider it quite a privilege to be allowed this forum and as we go forward into 2012 I hope to continue to "See you at the library."

In addition to Mayor Lantigua, State Senator Barry Finegold, State Representative Paul Adams and President of the City Council, Frank Moran, attended the ceremony and took the floor to recognize the outgoing diplomat.

Speaking to those present, Dominico Cabral said he was pleased to have done his duty and encouraged all Dominicans to honor the country where they were born. "It has been an honor for me to have been present as the Dominican General Consul when this City of Lawrence made history by electing the first Latino mayor of New England, which for the honor of our country happens to be Dominican," he said.

## NOTAS DE SU BIBLIOTECARIA

Hola, lectores de Rumbo. Espero que todos hayan tenido una feliz Navidad y les deseo un prospero año nuevo. Además de mi familia, conozco a muchas personas que perdieron familiares, amigos, y seres queridos este año. Para todos nosotros, habrá cierta melancolía en la celebración de las fiestas durante esta época. Lo que quiero decir es que todos nosotros debemos valorar a los familiares que todavía están con nosotros.

¡Buenas noticias para la biblioteca! Hemos recibido nuestro documento de exención por parte del estado y así tenemos la certificación a salvo por otro año. Le he explicado el proceso de exención en el pasado, pero les voy a explicar de nuevo en pocas palabras: cada ciudad y pueblo del estado tiene que financiar su biblioteca a un nivel que satisface una ecuación establecida por la Junta de Comisionados de las bibliotecas del estado. También tenemos que cumplir con las normas en cuanto al número de horas de apertura durante una semana normal y el porcentaje del presupuesto total anual utilizado para la compra de libros y suscripciones. Aunque he podido arreglar las cosas (¡no sin dificultad les aseguro!) para satisfacer estos dos últimos requisitos, no hemos podido cumplir con la primera en muchos años. Lawrence no es la única en esta situación. Entre un tercio y la mitad de todas las bibliotecas en el estado han tenido que solicitar una exención este año.

Para mí, esto indica un problema. Si un porcentaje tan grande de las bibliotecas de Massachusetts no puede cumplir con la norma establecida por la junta, tal vez

la norma debe cambiar para adaptarse a las realidades del mundo actual. Cuando fui nombrada directora aquí en el año 2005, el estado estaba dando tan sólo once exenciones por año. Este año el estado dará más de ciento veinte. Aunque no tengo ninguna queja con el estado respecto a la disponibilidad de las exenciones - que ha sido generoso y rara vez las solicitudes son negadas - hay algo erróneo con el sistema. Cada una de las ciento veinte bibliotecas que solicita la exención, tiene que pasar por un papeleo complejo y lento y la recolección de datos con el fin de cumplir con las restricciones de un modelo que ya no es apropiado para nuestra situación económica actual.

Sé que este es un asunto delicado, pero me preocupa cuando cada año veo que las bibliotecas en algunas ciudades pierden su certificación. # Declaración del Comisionado de Educación Primaria y Secundaria Mitchell Chester sobre las Escuelas Públicas de Lawrence:

"Estoy en la fase final de conseguir un receptor para las Escuelas Públicas de Lawrence y la elaboración de los términos de un contrato con la persona que en última instancia nombraré. Me preocupan profundamente los estudiantes y educadores de Lawrence y estoy interesado personalmente en este proceso. Estoy muy contento con los candidatos de calidad que están interesados en el papel de receptor de Lawrence. Los estoy considerando con cuidado. El nombramiento de un receptor de Lawrence es un momento crucial en el proceso de recuperación del distrito, y esta es una decisión que quiero hacerla bien.

Aunque me había propuesto haber nombrado ya a un receptor, los requerimientos del proceso de selección, debido al calendario de las fiestas ha retrasado el nombramiento. Para evitar cualquier juicio apresurado en un asunto tan completo como esto, justifica la decisión de no nombrar un receptor para el 1 de enero de 2012.

Por lo tanto, el 1 de enero de 2012, yo ejerceré las facultades y obligaciones del receptor por un período de tiempo limitado que permita finalizar el nombramiento del

receptor real. En esta capacidad, desplegaré a personas para llevar a cabo las funciones de día a día del distrito y revisaré y firmaré cualquier decisión crítica. Con respecto al proceso de cambio de Nivel 5, voy a empezar el proceso de consultas locales que se explica en el estatuto.

El 1 de enero de 2012, Mary Lou Bergeron reanudará su papel de asistente del superintendente. Aprecio el servicio de la Dra. Bergeron como superintendente interina y su voluntad de continuar sirviendo como importante líder administrativo en el distrito bajo mi dirección.

Como Comisionado de Educación Primaria y Secundaria del Commonwealth, tengo la responsabilidad de supervisar 1,800 escuelas públicas de cerca de 400 distritos escolares y 1 millón de estudiantes. Durante este período de transición corto, en espera del nombramiento de un receptor, dependeré en gran medida en los conocimientos del personal del Departamento y el personal del distrito para ayudar en nuestros esfuerzos colectivos para mover las Escuelas Públicas de Lawrence en el camino a una rápida mejora para todos los estudiantes."

# Statement of Elementary and Secondary Education Commissioner Mitchell Chester on the Lawrence Public Schools:

"I am in the final stages of securing a receiver for the Lawrence Public Schools and drawing up the terms of a contract for the individual that I will ultimately appoint. I care deeply about the students and educators in Lawrence and have been personally invested in this process. I am delighted with the many high quality candidates who are interested in the Lawrence receiver role. I am considering them carefully. The appointment of a receiver for Lawrence is a pivotal moment in the district's recovery process, and this is a decision I want to get right.

While I had intended to name a receiver by now, the due diligence required of the selection process coupled with the timing of the holidays has slowed the finalization of the appointment. To avoid any rush to judgment and to be as thorough as this decision warrants, I will not name a receiver by January 1, 2012.


Therefore, effective January 1, 2012, I will exercise the powers and duties of the receiver for a limited timeframe that allows the appointment of the actual receiver to

be finalized. In this capacity, I will deploy people to carry out the day-to-day functions of the district and I will review and sign off on any critical decisions. With respect to the Level 5 turnaround process, I will start the local stakeholder process that is spelled out in statute.


Effective January 1, 2012, Mary Lou Bergeron will resume her role as assistant superintendent. I appreciate Dr. Bergeron's service as interim superintendent and her willingness to continue to serve as senior administrative leader in the district under my direction.

As Commissioner of Elementary and Secondary Education for the entire Commonwealth, I have the responsibility to oversee 1,800 public schools, nearly 400 school districts, and 1 million students. During this short interim period while we await the appointment of a receiver, I will rely heavily on the expertise of Department staff and district staff to assist in our collective efforts to move Lawrence Public Schools on the path to rapid improvement for all students."

# InTown Mall Demolition will begin January 3

On Tuesday, January 3, demolition will begin on the InTown Mall on Common Street in Lawrence, which is being torn down to make way for Northern Essex Community College's El-Hefni Health & Technology Center. The public is invited to attend a brief ceremony which will begin at 9 a.m. on the corner of Hampshire and Common Streets.

When completed in the fall of 2013, the \$27.4 million El Hefni Health & Technology Center will house the majority of the college's 17 health care certificates and associate degrees. The 44,000 foot facility will feature a Health Education Simulation Center, where health care students will receive hands-on experience in simulated environments such as a hospital intensive care unit and operating room, an ambulance, and a doctor's office. The building will also include classrooms and computer labs and a Career Planning and Advising Center where students will receive academic and career counseling.

Architects Miller Dyer Spears—who also designed the Hartleb Technology Center on the college's Haverhill Campus—have completed designs for the building. It is a silver LEED project that takes full advantage of the sun as a source of energy.

"This is very exciting news for the college and the residents of Lawrence," said Northern Essex President Lane Glenn. "It would not have been possible without the support we have received from the city, our local representatives, area businesses and service organizations, and private donors."

When completed, the building—a three-story contemporary structure featuring sleek silver accents—will be a welcome addition to downtown Lawrence. Inside the center, local residents will prepare for careers in high demand health fields such as respiratory care, nursing, and sleep technology.

The El-Hefni Health & Technology Center is part of a larger plan for growth in Lawrence, according to Glenn. In recent months, Northern Essex has renovated its Louise Haffner Fournier Education Center on Amesbury Street, adding a new chemistry lab for students studying health and sciences, and opened a leased facility on Franklin Street to house iHealth@NECC. NECC Riverwalk on Merrimack Street opened in the fall of 2010. The college also recently purchased the Registry of Deeds Building in Lawrence with plans to create an open green space.

"Enrollments in the city have been exploding," said Glenn, who cites a 19% enrollment growth in the city in five years.

Students with a Lawrence zip code now represent nearly 25 percent of the college's more than 7,000 students.

These columns are to remind readers of the many exceptional athletes that performed in this and many other softball leagues throughout the City. It must be noted that most of these players held full time jobs and only after a day's work would come to play at a very high level. They also were parents that gave much time to this game. Remember that, in spite of rumors throughout the years, I did not know of any player being paid to perform.

The Sargent Club in the valley sponsored a very strong and athletic group. The club is still situated in the same spot and I'm told that one could get some fine Italian food there.

Turk Mustapha was an outfielder and a veteran in the game, he has been known to roam the outfield barefooted and it didn't slow him down at all; he could flat out fly. He is now retired from the New England Power Co.

Buddy Erban also patrolled the digs and was another speedster; he still lives in the area.

Barney Reilly played for many teams as an infielder and was one of the best athletes around, he was the executive director of the Council on Aging in the City of Lawrence and in those days he was called "Buckshot Barney".

Eddie Aziz was a 3rd baseman and a

good one he was a big time power hitter and fierce competitor. Ed is semi retired and is still a Methuenite.

Mike Polizzotti was in the outfield and had all the tools. His father Leo was a stalwart for the Methuen Little Leagues and has a field named for him. Many Methuen parents including this one remember his wisdom and guiding hand shown to all the participants of his LL teams over the years.

Dave Brown was a reserve and John Bloomquist came out of nowhere to play the infield and a big time power hitter.

Al Picone was an infielder who played a good first base both offensively and on defense. Al still lives in the area and can be found at the sports dinners at the Lawrence Elks.

Bobby Carrier was another reserve and big time hitter and former LHS star Dennis Homa was an infielder. Eddie Mustapha, Turks' younger brother was also a utility man.

Jimmy Taft, a big bruising type guy was a catcher, he was a big star in Haverhill sports and was living in Salem, NH, while playing for the Sargents. Taft came to play and played hard every night. He became a big man in the paper industry and was transferred to Maine for a good many years. He became a great golfer and with his good friend Dick Reming won a big celebrity

tournament in Hawaii, I think it was called the NFL Tourney. Unfortunately a stroke cut his life short.

John Rimas was a pitcher and a teacher coach at Methuen High school.

Bob O'Neal was a left handed pitcher and now retired from teaching at the CGS School in Methuen. He and longtime wife Nancy reside fulltime at the beach.

He still is the assigner, however, for most of the football, basketball, and softball leagues throughout the Valley.

Frank Carpaco was a reserve and Al Rizzo was the assistant manager as he was called. Always had his trademark stogie in his mouth and was an asset to any team. He worked until his retirement at the old Essem packing plant on Beacon St. Most of us were brought up on Essem franks.

Billy Zoulis was pitcher from Haverhill and had good stuff, he managed some big grocery store in the area and his motion on the mound featured one of the highest leg kicks this writer has ever seen.

There you have the 1969 Sargent Club team who in every season would be tough competition; a group that played a tough and fundamentally strong season.





# Open Letter to Cardinal Sean O'Malley

Dear Cardinal O'Malley:

We, the Quijote group of the City of Lawrence, came about because we feel the need to be heard as a result of the decisions that were made without the consideration of those who live within this hardworking community.

Five months ago, Father Jorge Reyes was dismissed from the St. Mary of the Assumption Church without explanation. The community anticipated his return. This past summer, during a Sunday morning, the parishioners expected the arrival of their priest as usual and he never came. On the following Sundays the priests, Carlos Urbina, Juan and Bill announced that they would meet the parishioners to console the community that cries and acclaims the arrival of whom did not say goodbye to his community, the beloved Father Jorge Reyes.

The reunion announced by various Sundays, came after several weeks. The town was in search of reasons why our priest was taken away. In this reunion we expected explanations of this eviction. These meetings confused the parishioners and many refused to return to the Catholic Church.

We expect your quick response and we will celebrate together the arrival of a true follower that pursues the mandates of Jesus our Father. Amen.

Es un hecho, que durante sus trece años de servicio en Lawrence, el jefe Romero ha avanzado mucho en la lucha contra el crimen y como líder del Departamento de Policía, y no creo que alguien trate de desconocerlo; pero ese éxito de los hombres y mujeres bajo su mando tenemos que

verlo como parte de su trabajo contractual. Para eso fue contratado, para garantizar la seguridad ciudadana. No debemos tratar de endiosarlo por eso pues, a pesar de una década de gloria, el Jefe Romero no parece ser muy popular entre la comunidad latina que constituye el 73.8% de la población que le ha tocado proteger.

Los contribuyentes han desperdiciado millones de dólares para resolver decenas de casos de brutalidad policial y de abuso de poder contra los ciudadanos de Lawrence y el Jefe Romero no ha sido muy abierto con la comunidad en cuanto a la explicación y prevención de esos casos. Muchos de nosotros tenemos la sensación de que el Jefe Romero ha hecho muy pocos esfuerzos para complacer a nuestra comunidad.

Sin embargo, parece ser que la Asociación de vecinos de Mount Vernon, los Sindicatos de Oficiales de la Policía y el Eagle-Tribune lo prefieren sin reservas. Por desgracia, y aquí hay otro punto que el Eagle-Tribune no analiza en su página editorial, ellos no constituyen la mayoría del pueblo de Lawrence. Lawrence seguirá avanzando con o sin John Romero.

two consecutive years with over 10 million dollars in surplus, substantial improvements in the quality of municipal services, repairs of streets and avenues that had decades of deterioration and much more.

Just by reading the title of the Eagle-Tribune editorial on December 26, 2011 could be really scary, but not for Lawrence residents who already are accustomed to this kind of publication in this newspaper: "The city must be on guard against effort to undermine police chief." It sounds like a catastrophe that will end the world.

This editorial talked about rumors circulating around announcing the replacement of John Romero as Lawrence Chief of Police. The editorial warns about the existence of "a plot to oust Police Chief John Romero" orchestrated by the mayor and city council members. The Eagle-Tribune, not only echoes the readers' gossip, but urges them to be "on guard against any attempt to replace the police chief."

But the Eagle-Tribune missed an important point again, as it did during the last municipal elections in Lawrence. They not only gave direct support to all the losing candidates who participated in the effort to oust Mayor Lantigua, but asked readers to vote against candidates backed by Mayor Lantigua. The Eagle-Tribune seems to miss that we live in a democracy in which power is vested in the people and not in a particular individual.

John Romero is not an elected official and he was appointed by the mayor at the time, but not to hold office for life. Chief Romero is not a leader with unlimited powers inherited from his grandparents. Chief Romero is not and should not be over other department heads in Mayor Lantigua's administration. The City Charter is clear and precise in describing the position of the police chief. Candidates must be nominated or appointed by the mayor and confirmed by the City Council, that's all. It is how democracy works.

Lawrence Police Department belongs to the City of Lawrence. Its great mission is to protect our citizens. Mayor Lantigua is the head of the executive branch of our municipal government representing every

one of us, the voters who chose him as our mayor. Lawrence Police Department is not and will not be an untouchable and separate department in our city.

If Mayor Lantigua needs to remove John Romero from his position in order to continue moving this city forward for the sake of the community, be sure that he will make the decision with the same courage and determination with which it has done it in the past; without the need for a plot. He just has to send his file down to the Council with reasons to dismiss him and the City Council will confirm it or reject it, always taking into account the interests of the people in the community. Public officials in a democracy are not forever; replacing them is not the end of the world – it is just business as usual.

It is a fact that during his thirteen years in Lawrence, Chief Romero has made great progress fighting crimes and as a leader of the Police Department, and no one could refuse to give him a lot of credits for that; but the success of the men and women under his command have to be seen as part of his job. He was hired to ensure public safety. We should not treat him in a godlike manner for his service. Despite a decade of glory, Chief Romero does not seem to be very popular among the Latino community, which constitutes 73.8% of the population that he has had to protect.

Taxpayers have wasted millions of dollars to settle dozens of cases of police brutality and abuse of power against the citizens of Lawrence and Chief Romero has not been very open to the community explaining and preventing such cases. Many of us have the feeling that Chief Romero has made few efforts to please our community.

However, it appears that the Mount Vernon Neighborhood Association, the Police Unions and the Eagle-Tribune, support him without reservation. Unfortunately, and here's another point that the Eagle-Tribune is missing, they do not constitute the majority of the people living in Lawrence. Lawrence will continue moving forward with or without Chief Romero.

# Adición de un amigo con plumas a la familia

Este mes de enero, la MSPCA está celebrando el mes de "Adopte un Pájaro", anunciando las muchas palomas, periquitos, jilgueros y otros pájaros mascotas que tenemos disponibles para adopción. Estos pequeños animales de compañía puede ser una gran adición a la familia, pero es importante saber la mejor manera de cuidarlos.

Las aves son una opción popular como mascota para personas que no pueden tener perros y gatos debido a alergias o restricciones del propietario. Pero ser pequeño y vivir en una jaula no significa que las aves son más fáciles que otras mascotas.

La mayoría de los pájaros viven más tiempo que la gente piensa. Pequeñas aves como pericos y canarios pueden vivir por 12 ó 14 años, las cacatúas pueden vivir hasta 25 años, y los loros grandes más de 60 años. Esto significa que, si usted adquiere un Gray African joven siendo usted adulto, es muy probable que el pájaro le sobreviva. Siempre es triste cuando un ave de 30 años ó 40 años de edad es entregado a la MSPCA porque su propietario ha fallecido. Es muy difícil para ellos hacerle frente a la pérdida de su "padre", y puede hacer la tarea de volver a casa con una nueva familia más difícil.

Para las personas con mucha experiencia en el cuidado de las aves más grandes, y los recursos para satisfacer sus necesidades especiales de las jaulas, dieta y ejercicio, la adopción de un ave adulta es una gran opción. El beneficio para la adopción de un ave mayor es que ella tiene una personalidad establecida para que pueda decidir si se trata de una buena selección. Y aves de mayor edad suelen tener ya algún tipo de entrenamiento.

Si usted es nuevo en el cuidado de aves, considere un ave menos complicado - un par de periquitos o una cacatúa. El cuidado de más de unos cuantos pájaros lleva mucho tiempo, dinero y espacio, así que es mejor quedarse con un pequeño número. Y pequeñas aves pueden ser igual de entretenidas como los más grandes, así que no los pasen por alto!

Muchos de los animales "exóticos", incluyendo aves y reptiles, son animales salvajes que han sido arrancados de su hábitat natural y se espera que crezcan en cautiverio. En la mayoría de los casos, esto es ilegal, pero es difícil controlar el comercio de mascotas con cuidado. Por esta razón, es mejor para las aves dondequiera si usted adopta un pájaro sin hogar en lugar de comprar uno en una tienda de mascotas.

## Adding a Feathered Friend to the Family

This January, the MSPCA is celebrating "Adopt-a-Bird" month by highlighting the many doves, parakeets, finches, and other pet birds we have available for adoption. These small pets can be a great addition to the family, but it's important to know the best way to care for them.

Birds are a popular pet choice for people who cannot have cats or dogs due to allergies or landlord restrictions. But being small and living in a cage doesn't mean that birds are easier than other pets.

Most birds live longer than people realize. Smaller birds like parakeets and canaries can live as many as 12-14 years, cockatiels as long as 25 years, and large parrots upwards of 60 years. This means that, if you acquire an African Grey chick when you're an adult, the bird is very likely to outlive you! It's always sad when a 30 or 40 year old bird is surrendered to the MSPCA because its owner has passed away. It is very difficult for them to cope with losing their "parent", and that can make it more difficult to re-home them with a new family.

For people with plenty of experience caring for larger birds, and the resources to meet their special needs for caging, diet, and exercise, adopting an adult is a great option. The benefit to adopting an older bird is that she has an established personality, so you can decide if it's a good match. And older birds often already have some training.

If you're new to bird caregiving, consider a "starter" bird – a pair of parakeets or a cockatiel. Caring for more than just a few birds takes a lot of time, money, and space, so it's best to stick with a small number. And little birds can be just as entertaining and hand-friendly as the larger guys, so don't overlook them!

Many "exotic" pets, including birds and reptiles, are wild animals who have been plucked from their natural environment and expected to thrive in captivity. In most cases, this is illegal, but it's difficult to monitor the pet trade carefully. For this reason, it's better for birds everywhere if you adopt a homeless bird instead of purchasing one from a pet store.




