

Con todo éxito se llevó a cabo la 7ma Feria Internacional del Libro en Lawrence, durante los días 21 al 23 de septiembre, 2012, donde altas figuras de la literatura española se dieron cita.

En el lugar de honor se encontraban el escritor argentino Luis Alberto Ambroggio y el puertorriqueño Jacobo Morales, sin olvidar a José Balbuena, a quien se le hizo un homenaje póstumo por su labor de diseminar la cultura española en la Ciudad de Lawrence a través de su librería Nobel que estuvo localizada en el 466 de la Calle Haverhill, en Lawrence.

El primer día del evento se llevó a cabo en el Teatro Garden, en el 198 de la calle del mismo nombre, en Lawrence. Luego de escuchar al coro femenino de la LHS, el Padre Joel Almonó, director de la FIL dio la bienvenida a los presentes e hizo entrega

de placas a los escritores homenajeados en ferias anteriores así como un reconocimiento a José Balbuena.

Acto seguido, el Representante Estatal Marcos Devers entregó proclamas estatales a los escritores homenajeados, Ambroggio y Morales. Ellos también recibieron proclamas de la ciudad de manos de José Jaime que se encontraba representando al Alcalde de la ciudad, el Sr. William Lantigua.

## The 7th International Book Fair

The 7th International Book Fair in Lawrence was successfully held during September 21-23, 2012, where senior figures of Spanish literature gathered.

In the place of honor were the Argentine writer Luis Alberto Ambroggio and Puerto Rican Jacobo Morales, not forgetting Jose Balbuena, who received a posthumous tribute for his work to spread Spanish culture in the City of Lawrence for many years through his Nobel Bookstore, located at 466 Haverhill Street in Lawrence.

The first day of the event was held at the Garden Theatre, located at 198, the street of the same name, in Lawrence. After listening to the LHS female choir, Father Joel Almonó, director of the book fair, welcomed those present and delivered awards to writers honored at previous fairs as well as recognition of Jose Balbuena.

Then State Representative Marcos Devers delivered state proclamations to the writers honored, Ambroggio and Morales. They also received proclamations from the city from José Jaime, who was representing Mayor William Lantigua.

On Saturday 22, the Senior Center

became the epicenter of Spanish Literature that already resides in the city of Lawrence. In addition to the honorees Ambroggio and Morales, were globally recognized names like Cesar Sanchez Beras, Yanitzia Canetti, Zoé Valdes, Armando Lucas Correa, among other illustrious writers.

Saturday night was dedicated to recreation and fellowship. There were no long speeches or delivery of awards, just good food and music. And what music! Delivered by Xiomara Laugart, a prominent Cuban singer who played brilliantly the immortal Celia Cruz in a Broadway musical. Laugart was accompanied by the musical group led by her son, pianist/soloist Axel Tosca, the guitar (bass) of Lazaro Pla and the battery of Willy Rodriguez.

The hall of the Bashara Boathouse, located at 1 Eaton Street in Lawrence, was small. At first, the organizers thought of making this dinner a private event, so they chose this room with a capacity of 130 people. "Well, this is an experience for next year," said Father Joel Almonó, who promised to make next year event, a better and bigger one!

### Lawrence, Meca de la Literatura Internacional

Si en temor a equivocarnos, luego de ser testigos de lo acontecido durante los días 21, 22 y 23 del pasado mes de septiembre del corriente año, cuando se celebró en Lawrence la 7ma Feria Internacional del Libro, estamos convencidos que Lawrence se ha ganado ese título.

Ha pasado una semana y aún nos parece increíble que el equipo que se comprometió a que la feria fuera un éxito, al frente del cual se encontraba el Padre Joel Almonó, haya podido reunir en esta pequeña ciudad, la mejor representación de la literatura española de la América Latina.

Comenzando por los homenajeados, Luis Alberto Ambroggio y Jacobo Morales. El primero, poeta y escritor natural de Argentina miembro de la Academia Norteamericana de la Lengua Española y de la Real Academia Española. Sus trabajos están registrados en los archivos de la Biblioteca del Congreso de los Estados Unidos.

Igualmente impresionante es el récord de Jacobo Morales. Natural de Lajas, Puerto Rico comenzó a actuar en radio a la edad de 14 años y en 1954, cuando se iniciaba la televisión, trabajó como actor, escritor y director. En 1970 el mundo conoció a Morales cuando triunfó en Hollywood en producciones junto a Woody Allen y Barbra Streisand.

Como si fuera poco, a estos nombres se añadieron el de la poetisa y guionista cubana Zoé Valdés, que viajó desde París para estar en Lawrence con sus colegas. Armando Lucas Correa, escritor, editor y crítico de teatro y danza, también cubano, ahora se desempeña como director editorial de la Revista People en Español.

Continuando la lista de grandes, el poeta, escritor y autor César Sánchez Beras, dominicano, que para nuestra suerte, reside, escribe, compone y enseña en Lawrence.

Yanitzia Canetti, autora, traductora y editora de nacionalidad cubana. Ella es la presidenta de su propia editorial Cambridge Brickhouse, Inc. en Lawrence. Sus obras publicadas incluyen tres novelas y una colección de cuentos cortos narrativos. El Padre Joel Almonó, que no solo es buen organizador sino un talentoso escritor y poeta.

Y para cerrar esta intensa jornada literaria, la interpretación de la destacada cantante cubana Xiomara Laugart que nos deleitó con su contagioso ritmo tropical. Laugart, bajo contrato con Phillips Morris, interrumpió su gira por el Japón para viajar a Lawrence por este día.

Fueron tres días inolvidables que el Padre Almonó y su equipo nos regaló y prometió repetir el año que viene, más grande y aún mejor.

No sabemos cómo, pero conociéndolos, sabemos que lo lograrán.

### Lawrence, Mecca of International Literature

Without a doubt, after witnessing what happened during the days 21, 22 and 23 of last September of this year, when Lawrence held the 7th International Book Fair, we are convinced that Lawrence has earned that title.

A week has passed and we still cannot believe that the team that was committed to a successful event, headed by Father Joel Almonó, has been able to gather in this small town, the best representation of Spanish literature from Latin America.

Starting with the honorees Luis Alberto Ambroggio and Jacobo Morales; the first, a poet and writer born in Argentina, is member of the American Academy of the Spanish Language and the Royal Spanish Academy. His works are recorded in the archives of the Library of Congress of the United States.

Equally impressive is the record of Jacobo Morales. Natural from Lajas, Puerto Rico began acting in radio at the age of 14, and in 1954, when television began, he worked as an actor, writer and director. In 1970 the world was introduced to Morales when he triumphed in Hollywood productions with Woody Allen and Barbra Streisand.

To these figures, the name of Cuban poet and writer Zoé Valdés was added. Valdés traveled from Paris to be with her colleagues in Lawrence. Armando Lucas Correa, writer, editor and critic of theater and dance, also Cuban, now serves as managing editor of People magazine in Spanish.

Continuing the list of greats, poet, writer and author Cesar Sanchez Beras, Dominican, who luckily for us resides, writes, composes and teaches in Lawrence.

Also Yanitzia Canetti, author, translator and editor of Cuban nationality. She is the president of her own publishing company Cambridge Brickhouse, Inc. in Lawrence. Her published works include three novels and a collection of short narratives. Father Joel Almonó is not only a good organizer but a gifted writer and poet.

And to close this busy literary weekend, the interpretation of the prominent Cuban singer Xiomara Laugart who delighted us with her contagious tropical rhythm. Laugart, under actual contract with Phillips Morris, interrupted her tour of Japan to travel to Lawrence for this day.

Three unforgettable days Father Almonó and his team gave us and promised to repeat it next year, bigger and even better.

We don't know how, but knowing them, we know that they will succeed.

# Desde Mi Esquina

## García en la Junta de Licencias

A William Lantigua le gusta provocar controversias - ¡Eso lo sabemos! Esta semana, nombró a José Alfonso García, con carácter de urgencia para que la Junta de Licencias pueda abordar su agenda atrasada porque varias organizaciones se van a ver afectadas por esta falta de acción.

No tenía por qué llegar a este punto porque el Alcalde Lantigua ha estado luchando con esta decisión durante meses. El concejo municipal ya ha rechazado al Sr. García por lo que debe enviarles un par de nombres muy pronto para su aprobación.

Mientras tanto, muchas buenas decisiones fueron tomadas el miércoles por la noche, tal vez esa es la razón por la que no se dieron a conocer.

La Junta aprobó un permiso de un día para el Essex Art Center, el Boys & Girls Club y un evento de dos días de duración en la Portuguese American Holy Ghost Fraternity. Además, las licencias de víveres para el mercado de La Nueva Esquina Meat Market (alcohol no fue aprobado), y el Mercado Carliliz. También el cambio de la propiedad de Mid City Rooming House, Willie Glover dba G & G Auto Sales, y Michael Kassas dba M & K Auto.

La Junta pospuso hasta la próxima reunión una nueva aplicación para La Cantina Sports Bar (el antiguo Italian Tripoli Club), y una audiencia para licencia de bar sin alcohol para el PRSD Club (Miguel Tavares).

El Sr. García dio su consentimiento, pero sólo sujeto a su revisión ya que no había tenido tiempo de revisar todo el papeleo de la transferencia de propiedad de la tienda Sweeney's Package Store, y de New C1 Buffet.

Pero lo más importante fue la revocación de 336 São Paulo - Paul Martins, por vender al por menor en violación de su licencia y el club nocturno JOWA, en el 336 Common Street por estar sobre su capacidad y violaciones del código de incendios. Esta fue la tercera violación de JOWA. El Departamento de Bomberos fue al club y encontró las puertas cerradas desde el interior. Cuando por fin abrieron, contaron cuidadosamente las personas mientras salían del edificio y eran 140 sobre el número permitido de usuarios.

En ambos casos, la Junta acató la recomendación del Departamento de Bomberos de revocar las licencias.

El Sr. García ha sido criticado por ser amigo de Lantigua. Me dijo que, "Ser un amigo personal o político del alcalde no me excluye de hacer un buen trabajo mientras yo sirva a la Comisión de Licencias".

## La FCC y la doctrina de la imparcialidad

Hay un artículo interesante sobre el plan de la Comisión Federal de Comunicaciones (Federal Communications Commission – FCC) para traer de vuelta la doctrina de la imparcialidad en la página 7. Este es un tema muy controvertido e insto a todos a leerlo.

Esta medida se estableció en los primeros días de la radio y la televisión para asegurar al público que recibiría un equilibrio en las

historias y noticias cubiertas. En 1987, fue eliminada ya que la FCC estimaba que con la llegada de la televisión por cable y la proliferación de estaciones de radio en todo el país, la gente podía encontrar todos los puntos de vista representados.

No hay necesidad de volver a eso y les recomiendo que lo lean.

## El servicio militar obligatorio

Representante Charlie Rangel (D-NY) ha presentado legislación para reinstaurar el servicio militar varias veces desde enero de 2003, durante el período previo a la invasión de Irak. En el 2004, la Cámara de Representantes votó en contra de su medida con un voto de 2-402.

Rep. Rangel lo promueve como "servicio nacional" para el Estado y requiere que todas las personas en los Estados Unidos entre las edades de 18 y 25, si fuera solicitado por el Presidente durante una declaración de guerra sean conscriptos por dos años con pocas excepciones.

Esto reducirá el número de veces que las tropas tienen que servir debido a la escasez de efectivos.

Eso me hizo pensar en las veces que he escuchado gente que se queja en la radio en español de los Estados Unidos, hasta el punto de decir (y esto es una cita directa de alguien que conozco) "¡Nunca voy a hacer nada por este país!"

Como parte de la apertura de la Convención Demócrata en Charlotte, Carolina del Norte, un grupo de estudiantes se manifestaron con el lema de "sin papeles y sin miedo" usando camisetas con una foto de Fidel Castro. Incluso dijeron a Rafael Prieto Zarraga de The Huffington Post que apoyan a Fidel Castro, Hugo Chávez y están en contra del imperialismo.

Me pregunto cómo esas declaraciones y manifestaciones afectarán la legalización de su situación, si desde el principio demuestran lealtad hacia el enemigo.

Una cosa es segura: si las personas entre los 18 y 25 años de edad en este país se ven obligados a servir en el servicio militar, esto tendrá efecto en la inmigración ilegal.

Este establecimiento está localizado en So. Broadway, justo antes de llegar a la Rt. 495. Ha estado vacío por varios años y la ciudad ha puesto muchas trabas a su dueña para venderlo.

Alguien echó un sofá y días más tarde, tiraron un televisor. Ya la ciudad los recogió después de mi queja a los concejales del área



## Basurero ilegal en So. Lawrence

Unos días atrás, envié estas fotos a los Concejales del Sur de Lawrence, Eileen Bernal, Rivera Dan, Marc Laplante y Roger Twomey, con el fin de que tomen conciencia de las condiciones de la tienda de Julie y Wendy. Este sitio ha estado vacío durante unos años; han tratado de venderlo y en un momento, hubo una familia del sur Lawrence dispuesta a abrir otra tienda similar a lo que había sido durante años.

El gobierno, que no es favorable a las empresas, ha hecho que sea muy difícil para este propietario vender esta propiedad que se ha convertido en una monstruosidad.

La Concejal Bernal respondió: "Este propietario ha estado repetidamente en busca de ayuda de las juntas de zonificación y planificación, y sugiero que el departamento de planificación se ponga en contacto con ella. Como ciudad, debemos ser conscientes de qué tipo de propietario se trata cuando le damos ese tipo de asistencia".

Pero el Concejal Laplante, dijo: "Mi recomendación es no simplemente recoger los materiales que se dejan allí, sino tener una conversación y una advertencia al dueño de la propiedad que tienen la responsabilidad de asegurar su área. La recomendación sería que la ciudad lo recoja una vez, pero si no son proactivos, entonces puede suceder en violaciones del Servicios de Inspección en el futuro. Por lo menos deberían instalar cámaras para identificar a las personas que están botando la basura. No es justo para los demás contribuyentes de la ciudad que tienen que pagar por la limpieza de la propiedad privada. Deberíamos ver un poco más de esfuerzo con este (o cualquier) dueño de negocio privado para trabajar con la ciudad para tratar de mejorar sus propiedades y para disuadir a los vertidos ilegales."

La Ciudad de Lawrence gasta alrededor de \$250,000 en el manejo de desechos ilegales por toda la ciudad. Una forma de evitar que estas zonas se conviertan en un vertedero es ayudando a las empresas para que no permanezcan inactivas durante años.

## SEGURO PARA PEQUEÑAS EMPRESAS

Los contratistas lo necesitan para proteger a sus clientes. Muchas ciudades y pueblos requieren Certificados de Seguros de los contratistas cuando solicitan permisos.

**INCENDIO/PELIGROS:** Si usted pide prestado dinero para iniciar su negocio o comprar un inmueble, el banco requerirá que usted tenga seguro contra incendios (igual que cuando usted pide prestado para comprar una casa).

**ROBO:** La cobertura de robo por lo general se puede adquirir junto con el seguro contra incendios. A menudo es necesario contar con una alarma antirrobo para comprar cobertura de robo.

**TRABAJADORES DE COMPENSACIÓN:** Si usted decide contratar a alguien o tiene familia que ayuda, es necesario adquirir un seguro de indemnización laboral. Esto protege al trabajador si se lesionan en el trabajo. No sólo son los gastos médicos pagados, sino los salarios también se pagan al empleado lesionado en caso de tener que faltar al trabajo. El costo se basa en el tipo de negocio y la nómina real. Las empresas deben adquirir esta cobertura. Empresas LLC y los propietarios no tienen que protegerse a sí mismos, pero deben comprar una póliza para los trabajadores que contratan.

**PÉRDIDA DE ALQUILERES/ENTRADAS:** Si su ingreso de alquiler o producto de ventas paga las facturas entonces usted necesita para asegurarse de que su póliza incluya esta cobertura. ¡Esto no se incluye automáticamente!

Un numeroso grupo de mujeres, la mayoría de ellas vestidas en trajes de novia blanco, marcharon desde la Plaza 114 al Senior Center de Lawrence el miércoles, 26 de septiembre, 2012. Estaban recordando el brutal asesinato en Nueva York el 26 de septiembre de 1999 de Gladys Ricart, de 39 años, una mujer dominicana que fue asesinada por su ex novio el día que Gladys estaba a punto de casarse con otra persona.

Cuando los manifestantes entraron en el Centro de Ancianos, fueron recibidos por diecinueve velas en el suelo, en representación de las últimas víctimas de la violencia doméstica desde el 1 de octubre 2011 al 31 de agosto, 2012. Las velas fueron encendidas una a una, mientras que los nombres de las víctimas eran leídos en voz alta.

Una marcha similar entró en vigor por primera vez en 2001 en la Ciudad de Nueva York, organizada por Josie Ashton, una residente de Florida.

En el año 2003, y organizado por Delamano, con el apoyo de YWCA of Greater Lawrence, City of Lawrence Mayor's Health Taskforce y del Lawrence

Senior Center, la ciudad de Lawrence se convirtió en parte de la lucha para prevenir la violencia doméstica. Desde entonces, cada año, el evento de la marcha crece en volumen a medida que aumenta la conciencia. Digno de mención es el número de hombres vestidos de negro, que participó este año en apoyo de las mujeres.

El Alcalde de Lawrence William Lantigua, el Representante Estatal Marcos Devers, los Concejales Frank Moran, Kendrys Vázquez y Danny Rivera; el miembro del Comité Escolar Frank Surillo, el Padre Joel Almonó, pastor de Grace Episcopal Church en Lawrence, el Rev. Víctor Jarvis; Stephen Ives, Presidente/CEO y Gary Morelli, Vicepresidente, ambos de YMCA y Dionis Mezquita fueron algunos de los hombres que caminaron junto a las mujeres.

- 02/06/12 – Belinda Torres, 40, of Worcester killed by her boyfriend Jose Soto. Later on, he was found dead.
- 02/10/12 – Lisa Stilkey, 44, of Douglas. She jumped out of a window during an argument with her husband Allen Stilkey, 40.
- 02/20/12 – Jessica Ann Pripstein, 39, of Easthampton, stabbed to death by her boyfriend Ryan Welch, 36.
- 03/03/12 – Jessica Rojas, 25, of Springfield stabbed by her boyfriend Jose C. Santiago, 30.
- 04/09/12 – Lori Levangie, 41, of Hopkinton killed at home by her husband Todd Vogel, 43 who then killed himself.
- 05/03/12 – Kristen Pulisciano, 38, of Burlington stabbed by her partner Christopher Piantedosi.
- 06/04/12 – Officer Kevin E. Ambrose, 56, of Springfield was shot in the line of duty by Shawn Bryan, 35, when Ambrose responded to a 911 call. Later on, Bryan killed himself.
- 06/24/12 – Jessica Dana, 30, of Huntington killed by her boyfriend Jeb Daly, 36.
- 07/21/12 – Christine Bolduc, 51, of Worcester died of brain injuries caused by her boyfriend Robert Bell, 56.
- 07/28/12 – Abigail Benway, 7, of Oxford shot and killed by her own father Darryl Benway, 41 after he separated from her mother. Before killing himself, he also shot his other son Owen, 9.
- 08/10/12 – Cecilia Yakubu, 58, of Malden, strangled by her living boyfriend William Bryant Moseley, 45, at their home. From 1996-2007, William had served a sentence for a non-fatal shooting of his former wife.

Three candles were added and lighted up to remember Milka Rivera, 39, of Lawrence, and her two children Sachary Montañez and Ariel Max Montañez, allegedly killed by Rivera's boyfriend José Luis Tejeda on September 5, 2011.

## Nineteen Candles on the floor...

*"I promise to never commit, condone or remain silent about men's violence against women. From this day forward, I promise to the community and to my family, to be a part of the solution,"* Joshua Alba.

A large group of women, most of them dressed in white wedding gowns, marched from Plaza 114 to the Lawrence Senior Center on Wednesday, September 26, 2012. They were remembering the brutal assassination in New York City on September 26, 1999 of Gladys Ricart, 39, a Dominican woman who was murdered by her former boyfriend the day Gladys was getting ready to marry someone else.

When the marchers entered the Senior Center, they were greeted by nineteen candles on the floor, representing the latest victims of domestic violence since October 1, 2011 to August 31, 2012. They were lighted one at a time while the names of the victims were read aloud.

A similar march took effect for the first time in 2001 in the city of New York, organized by Josie Ashton, a Florida resident.

In 2003, and organized by DeLamano, with the support of YWCA of Greater Lawrence, the City of Lawrence Mayor's Health Taskforce and the Lawrence Senior Center, the City of Lawrence became part of the fight to prevent domestic violence. Since then, every year the march event grows in volume as awareness increases. Worthy of mention is the number of men dressed in black, who walked this year in support of the women.

Lawrence Mayor William Lantigua, State Representative Marcos Devers, Lawrence Councilors Frank Moran, Kendrys Vazquez and Danny Rivera; School committee Member Frank Surillo; Father Joel Almonó, Pastor of Grace Episcopal Church in Lawrence; Rev. Victor Jarvis; Stephen Ives, President/CEO and Gary Morelli, Vice president, both of the YMCA; and Dionis Mezquita were among the men who walked the distance.

"The march is meaningless unless we change," a taxi driver told to Father Almonó while driving him to the Plaza

114. "I realized that there was some change when I got to the place and saw more than thirty men ready to march with the women," said Father Almonó between sobs. "Lord, in the name of Jesus, we beg you to stop these killings, here and in the Dominican Republic and all over the world."

Reading from a written statement, Luis Martinez expressed: "I'm proud to stand before you today and pledge to do my part to eradicate violence against women and domestic violence. Here in the United States, every 9 seconds a woman falls victim of this crime!"

Unfortunately, we have all been touched by this epidemic of violence against women. All of us here today know of female friends, coworkers or family members who have experienced the horror of violence.

We have all been affected by this silent epidemic that is clearly a violation of human rights, social justice, gender equity and a public health safety issue for all.

As a man and member of this community, I invite all men here today for whom gender violence is as concerning issue and together, take part in my personal pledge that: We will never remain idle or silent. We will never allow this crime to be overlooked or ignored, and we will never allow the voice of a woman to be silenced, diminished nor devalue their emotions, their pain or their tears.

I affirmed this pledge and lend my voice to the survivors of these crimes so that we may finally eradicate Violence against Women," ended Martinez.

Martinez was introduced by Vilma Lora, Co-Director of Women's Services of the YWCA of Greater Lawrence as "my

# Si es reelegido, Obama debe poner fin a la amenaza de la FCC de restringir noticias en TV y prensa

Corydon Dunham es un ex ejecutivo y abogado general de una cadena de televisión y autor del libro *El Control de las Noticias por el Gobierno*.

El martes, el Presidente Obama pasó gran parte de su discurso ante la Asamblea General de las Naciones Unidas discutiendo la libertad de expresión en la era de la comunicación instantánea global.

"Sé que no todos los países de este cuerpo comparten esta comprensión particular de la protección de la libertad de expresión", dijo.

Mientras tanto, bajo su administración, la FCC está llevando a cabo un plan para una nueva regla de equilibrio, diversidad y localismo que permita al gobierno de EE.UU. ahogar las noticias de televisión y restringir el discurso.

La nueva regla es similar a la antigua Doctrina de la Imparcialidad (Fairness Doctrine) que la FCC y los tribunales revocaron en 1987, cuando encontraron que estaba en contra del interés público. Investigaciones de la FCC habían disuadido y suprimido noticias en televisión, restringido la libre expresión, e impidió la crítica a las administraciones.

Como bien mi libro revela, el nuevo localismo tendría resultados similares o peores. Un nuevo miembro del personal de la FCC que ayudó a redactar la norma sobre localismo ha escrito que la libertad de expresión y de prensa no es su "objetivo", y que la libertad de expresión "se ha pervertido,

para proteger a las corporaciones globales y bloquea las reglas que promuevan la gobernabilidad democrática." El también concluye que la nueva regla de localismo se podría utilizar para quitar licencias en lugar de la "mal nombrada Doctrina de la Imparcialidad".

Otro escribió que la televisión es una "poderosa fuente de homogeneización y pábulo", y recomendó el uso de una carga normativa de la FCC para "acelerar la desaparición de la radiodifusión" (más tarde reformulada.) Ese escritor aplaudió una norma que haría la transmisión de acontecimientos locales más difícil, por lo tanto "los televidentes son menos propensos a ver las emisoras locales".

Un informe especial recomendó en junio de 2011 que pongan fin al procedimiento del localismo debido a sus destructivas cargas. Aún después de la oposición de los otros comisionados, el presidente de la FCC designado por el Presidente Obama siguió planeándolo y, después de las elecciones de noviembre, la FCC podría pasar a adoptarlo.

El Jefe de la Oficina de Asuntos de Información y Regulación de la Casa Blanca, profesor de derecho y compañero del Presidente Obama, ha insistido en que el gobierno debe tomar el control de nuevo para lograr sus fines políticos y sociales. Otro ex profesor de derecho, ya nombrado por el Presidente Obama a la Corte Suprema, escribió un artículo también instando al gobierno a manipular noticias, diciendo que esto sería constitucional si la cobertura de noticias no era "ideal" en un momento determinado, y el gobierno estaba cambiando las noticias con ese fin.

El gran historiador Gordon S. Wood escribe: "Recuerde que los Estados Unidos siempre ha sido para nosotros y para el mundo primordialmente una idea." Acabar con la libertad de prensa de este país y las tradiciones de libertad de expresión, sin duda destruiría esa idea.

## If re-elected, Obama should end FCC threat to restrict TV news, press

Corydon Dunham is a former TV network executive and general counsel and author of, "Government Control of News."

On Tuesday, President Obama spent much of his address to the United Nations General Assembly discussing free speech in an era of global instant communication.

"I know that not all countries in this body share this particular understanding of the protection of free speech," he said.

Meanwhile, under his administration the FCC is holding a plan for a new balance, diversity and localism rule that would enable the U.S. government to suppress television news and restrict speech.


The new rule is similar to the old Fairness Doctrine, which the FCC and courts revoked in 1987 when they found it was against the public interest. FCC investigations had deterred and suppressed television news, restricted speech, and prevented criticism of incumbent administrations.

As my book reveals, the new localism rule would have similar results or worse. One new member of the FCC staff who helped draft the localism rule has written that freedom of speech and press is not his "objective," and that free speech "is warped to protect global corporations and block rules that would promote democratic governance." He also concludes the new localism rule could be used to take away licenses in place of the "misnamed Fairness Doctrine."

Another wrote that television is a "powerful source of homogenization and pabulum," and recommended using burdensome FCC regulations to "hasten the demise of broadcasting" (later reworded.) That writer applauded a rule which would make broadcasting local events more difficult so "local viewers are less likely to watch the local broadcasters."

A special report recommended in June 2011 that the localism proceeding be ended because of its destructive burdens. Over opposition from other commissioners, the FCC chairman appointed by President Obama continued it and, after the November election, the FCC could move to adopt it.

The Chief of the White House Office of Information and Regulatory Affairs, a fellow law professor of President Obama, has long urged that the government



should take control of news to achieve its political and social purposes. Another former law professor, since appointed by President Obama to the Supreme Court, wrote an article also urging the government to manage news, saying this would be constitutional if news coverage were not "ideal" at a particular time, and government was changing news to that end.

The great historian Gordon S. Wood writes, "Remember that the United States has always been to ourselves and to the world primarily an idea." Ending this country's free press and free speech traditions would certainly destroy that idea.

partner in life."

# Honorable Mayor William Lantigua The Great City of Lawrence Waste & Recycling Information 2012-2013



**Beginning October 1, 2012 E.L. Harvey & Sons, Inc. will begin providing the City of Lawrence waste and recycling services for all eligible residences.**

This guide is designed to provide you with all the necessary information in order for you to get the most of your service.

All residents should have the following:

- One (1) 65 Gallon Cart with lid for Trash
- 18 Gallon Bins OR containers with recycling stickers for Single Stream Recycling

The City has a 1 waste barrel limit per unit. If you need more than this allotted amount you will have to purchase an additional container or overflow bags. However, the City has unlimited Single Stream recycling.

## Waste & Recycling Collection

Your solid waste and recycling will be picked up on the same day. Please see Schedule by Day to find the collection day for your street. All recyclables will be collected in one container (Mixed paper, cardboard, glass, aluminum, and plastic items all in the same bin!). There is no limit on the amount of recyclables collected curbside from residents as long as it is generated at that location.

## Solid Waste

Areas not previously automated will receive City-issued containers. Items outside of the provided cart(s) will NOT be collected unless in a City-approved overflow bag.

## Preparing your Solid Waste

- Bag your trash before placing it in the cart
- Bagging your trash will help keep the cart clean and sanitary, and prevent litter on windy days

## De las creencias y el poder

Los recientes incidentes trágicos en el mundo árabe donde nuestro embajador y otros diplomáticos en Libia fueron víctimas de un ataque terrorista y otras embajadas y consulados objetos de violentas demostraciones, son razones para preguntarnos una vez más sobre nuestra inhabilidad humana de mantener nuestras creencias circunscritas a los recintos de nuestras propias mentes donde ellas pertenecen, en vez de tratar de hacerlas parte del sistema ambiental donde tenemos y debemos vivir en paz los unos con los otros. Pero las causas en realidad van más allá de las reflexiones filosóficas.

La razón por la que estoy diciendo esto es porque dejamos de ver, olvidémonos siquiera de entender completamente, la acción recíproca entre algunos de los atributos que caracterizan una creencia y como esos rasgos operan en realidad como armas de la base del poder bruto que componen las tiranías donde esos incidentes se han llevado a cabo. Las tres palabras que tengo en mi mente son la ortodoxia, la blasfemia y la herejía, todas combinadas en un paquete atractivo de disparates. Comencemos con la ortodoxia.

Ese término se define como la condición, calidad o práctica de conformarse, especialmente en las creencias religiosas. No hay ambigüedad en esa definición. La palabra llave es "conformarse". Sea en escritos o tradiciones, quiere decir practicar todas las creencias de acuerdo con sancionados y aprobados textos o costumbres que definen esa idea. La mayoría de las creencias universales están grabadas en libros que son considerados sagrados, mientras otras están impregnadas en las palabras que se pasan de una

generación a otra verbalmente y que son consideradas tan importantes como la palabra escrita. Cualquier desvío de la ortodoxia, dependiendo de su fuente de origen, abre las puertas de la definición de una u otra de las otras dos que aparecen en el paquete atractivo mencionado más arriba.

Permítaseme continuar con la blasfemia. El término cubre toda clase de ofensas externas contra la reconocida y aceptada ortodoxia: exclamaciones impías o acciones relacionadas con la divinidad o las cosas sagradas; un acto de insultar u ofender a Dios o sus profetas; el crimen de asumir los derechos y cualidades de Dios; comportamiento irreverente contra cualquier cosa sagrada, despreciándolo. Si leemos estas definiciones cuidadosamente, podemos ver que se refieren a los ataques que vienen de afuera hacia adentro. Si yo soy cristiano, por ejemplo, un ataque de los no creyentes contra Cristo sería considerado una blasfemia.

En cuanto a la herejía, no es difícil definir su relación con la ortodoxia como un ataque que viene de adentro, no de afuera. Los heréticos son el comején que pudre la ortodoxia hasta su misma médula. Son el comportamiento traidor de los creyentes locales que se han desviado y deben ser arrancados y castigados antes que las células cancerosas hagan metástasis y destruyan la vivienda ortodoxa como si fuera una casa de cartas de baraja. Es probablemente el factor primordial donde la palabra transgredir viene a juego con más fuerza, aquella que nos fuerza a pedir perdón porque hemos pecado. Pero déjese llegar finalmente al poder y ver como todas estas tres definiciones mencionadas previamente

se combinan para mantenerlo.

Las sociedades y culturas que no proveen eficientes, efectivas y abiertas opciones para escoger a sus líderes y renovarse desde dentro sin conflicto o guerras intestinas, tienen que depender de paredes y murallas de creencias ortodoxas tiránicas creadas con el objetivo de proteger sus existencias contra el ataque de fuerzas externas. La blasfemia se usa intencional o oportunamente como una conveniente excusa para reforzar y proteger la fundación de esa ortodoxia y así evitar su derrumbamiento. Es la que recluta y llama a su ciudadanía para la batalla. El caballo de Troya viene a la mente como el mejor uso instrumental de la blasfemia. Usada apropiadamente, la blasfemia es una llamada de acción a un grupo de creyentes para que permanezcan vigilantes contra lo extraño, se mantengan unidos y luchen.

La herejía, por otra parte, es el instrumento protector interno que mantiene alejados a los peligros externos, asegurando que el grupo permanezca como una fuerza cohesiva y previsible que no se disolverá y que estará siempre dispuesto a pelear y rechazar lo blasfemo y, al final, lo herético también. Si la pena de muerte es la última penalidad impuesta a los que se desvían, entonces eliminando la herejía será una tarea más fácil. ¿Podemos sorprendernos que las masas se mantengan silenciosas cuando imaginadas o reales violaciones son usadas como excusas para atacar embajadas, consulados, negocios y otros símbolos convenientes de blasfemia? Los silenciosos no están necesariamente de acuerdo con el ruidoso clamor, pero tienen que permanecer

## Of beliefs and power

The recent tragic incidents in the Arab world where our ambassador and other diplomats to Libya were victims of a terrorist attack and other American and western embassies and consulates were the object of violent demonstrations, are reasons to make us ponder one more time about our human inability to keep our beliefs restricted to the compounds of our own minds where they belong, instead of trying to make them part of the environmental system where we must and should live in peace with others. But the causes actually go beyond philosophical reflections.

The reason why I'm saying this is because we fail to see, never mind understand fully, the interaction between some of the attributes that characterize a belief and how those traits truly operate as tools of the basis of raw power that tyrannies are made of in those places where the incidents took place. The three words I have in mind are orthodoxy, blasphemy and heresy, all rolled into one nice package of nonsense. Let's start with orthodoxy.

That term is defined as the condition, quality, or practice of conforming, especially in religious belief. There is no ambiguity on that definition. The key word is "conforming." Be it in writings or traditions, it means to practice the entire set of beliefs according to officially sanctioned texts or customs that define the belief. Most universal beliefs are dogmas etched in books that are considered sacred, while others are ingrained in the word of mouth passed from generation to generation and considered as important as the written word. Any deviation from orthodoxy, depending on its source of origin, opens the door to the definition of one or the other two in the list of the package mentioned above.

Let's continue with blasphemy. The term encompasses all sorts of outside offenses against recognized and accepted orthodoxy: impious utterance or action concerning deity or sacred things; an act of cursing or reviling God or his prophets; the crime of assuming to oneself the rights or qualities of God; irreverent behavior toward anything held sacred, priceless, etc. If we read these definitions carefully, we can see that they refer to attacks from the outside in. If I am a Christian, for instance, an attack from nonbelievers in Jesus would be considered blasphemy.

As for heresy, it is not difficult to define its relationship with orthodoxy as an attack from within, not from without. Heretics are the traitors that rut orthodoxy to the core. They are the traitorous behavior of local believers who have gone astray and must be rooted out and punished before the cancerous cells metastasize internally destroying the abode of orthodoxy like a crumbling house of cards. It is probably the one factor where the word wrongdoing comes into play more forcefully, the one that forces us to ask forgiveness because we have sinned. But let's get to power finally and see how the three definitions above play together to keep it.

Societies and cultures that do not provide efficient, effective and open

## Twelve Hockey Games to be Televised; Seven Nationally, Most in Hockey East

#### Mark Devlin's 1949 Lawrence High Basketball team

This Lawrence High Hoop team was loaded with talent and although I can't name all of them I'll give you what I do know. The legendary Mark Devlin was the coach and he left his mark on 3 sports. He was known as the white fox and it seemed that football was his main sport.

Jimmy Jordan was his right hand man and he had served as head football coach of the now defunct St. James of Haverhill team. Jordan lived on Coolidge Street in So. Lawrence and in the summers he worked as a lifeguard at the city's swimming pools for the city's pool director Charlie Rappaport.

Jordan would later become the head coach of both football and baseball at Lawrence High.

The captain of this year's blue and white hoopsters was one of this school and the area's greatest athletes. To this day, there are legions of sports lovers who acclaim him as the best high school player to ever don the blue and white. This was the last of great athletic family from the Tower Hill area and was following his brothers John, Bill, Gene and Lennie performing three sports, yes Gerry would be this year's leader. His teammates would say he was a coach on the court, the diamond and the gridiron.

Jackie Donahue of Sanborn Street in South Lawrence would later become a

roundball captain and later became a letter carrier for the US Postal service a position he held until he retired. As an official for the carriers union Jack made sure that monies from their union Santa Fund were funneled to the city's youth league. A fact I know for sure as some of my youth programs were the recipients, Jack learned his giving ways as an assist man on Devlin's team and he was a good one.

Chuckie Rigoli of the Jackson St. area was also one of the fine guards on this team and he and Donahue could break down any defense thrown here way.

Bobby Fitzgerald Sr. is now a LHS Hall of Famer and rightfully so in 1949 Fitz could be on the gridiron, the baseball diamond, the hardwood and the wrestling mat. For good measure he could whip your butt on the tennis court on his home turf at Tower Hill. Bob played football at Northeastern and one night at a sports banquet in Boston I met and got to talk to the immortal Joe Zabilski and I asked the coach about Fitz and he replied one of the best I ever had. Bob later became the football coach and later the AD at Greater Lawrence and retired from that school. His soft spoken manner was such a different will and want to win.

Jerry Dineen was a big guy like Donahue Rigoli and me, meaning a

stretched five foot nine but he could play and also excelled as an infielder on Jordan's baseball teams. Jerry would bite your face off to win.

Johnny D'Angelo was and is still is known as the quiet man, probably the most underrated athlete the school has ever known, and a great friend of Rigoli's – in fact, he introduced me to Chuck a few years ago. John is retired from a government agency and partnered with Dickie Cain who does work for his son Alex these days. No one is surprise that John is also a multi sportster who is in the school's Hall of Fame. He lives in Methuen now and can be found at a Salem sports club showing his great skills in raquetball. He is known to be as expected by all who know him a much better than average player. Some surprise, huh!

Paul Derby and Jack Skelly would be the tall men on this team. Then Frankie Mayor will be ready to spell Donahue and Rigoli if Devy makes the call.



# From My Corner

## García on the Licensing Board

William Lantigua loves rattling cages – we know that! This week, he appointed Jose Alfonso Garcia on an emergency basis so that the board could tackle its overdue agenda because several organizations were going to be affected by this lack of action.

It didn't have to come to this point because Mayor Lantigua has been wrestling with this decision for months. The City Council already rejected Mr. Garcia so he should be submitting a couple of names very soon for approval.

Meanwhile, many good decisions were made Wednesday night; perhaps that's the reason why they were not publicized.

The Board approved a one-day permit for the Essex Art Center, the Boys & Girls Club and a 2-day event at the Portuguese American Holy Ghost Fraternity. Also, victualler licenses for La Nueva Esquina Meat Market (alcohol not approved), Carliliz Market; change of ownership of Mid City Rooming House; Willie Glover dba G & G Auto Sales and Michael Kassas dba M & K Auto.

The Board tabled until the next meeting a new application for La Cantina Sports Bar (formerly Italian Tripoli Club); and a hearing for Non-Alcohol Club License for PRSD Club (Miguel Tavares).

Mr. Garcia gave his consent but only subject to his review since he had not had time to check all the paperwork for Sweeney's Package Store's and New C1 Buffet transfer of ownership.

But most important was the revocation of 336 Sao Paulo – Paul Martins, for selling retail in violation of their license and JOWA Night Club on 336 Common St. for over capacity and fire code violations. This was the third such violation for JOWA. The Fire Department went to the club only to find the doors locked from inside. When they finally opened, they carefully counted guests as they exited the building and it was 140 over the allowed number of patrons.

In both cases, the Board abided by the recommendation of the Fire Department to revoke the licenses.

Mr. García has been criticized for being a friend of Lantigua's. He told me that, "Being a personal or political friend of the mayor's doesn't preclude me from doing a good job while I serve on the Licensing Commission."

## The FCC and the Fairness Doctrine

There's an interesting article on the Federal Communications Commission's plan to bring back the Fairness Doctrine on page 7. This is a highly controversial issue and I urge you all to read it.

This measure was established in the early days of radio and television to assure the public that they would be receiving a balance in the stories and news covered. In 1987, it was eliminated because the FCC estimated that with the advent of cable television and the proliferation of radio stations all over the country, people could find all viewpoints represented.

There's no need to go back to that and I recommend that you read it.

## Bringing back the draft

Rep. Charlie Rangel (D-NY) has submitted legislation to reinstate the military draft several times since January 2003 during the run-up to the invasion of Iraq. In 2004, the House of Representatives voted down his measure by a 2-402 vote.

Rep. Rangel is promoting it as "national service" to the state and requires all persons in the United States between the ages of 18 and 25 if called upon by the President during a declaration of war for two years with few exceptions.

This will cut down the number of deployments for active duty and reserve military units who now see multiple deployments during the course of their enlistment due to troop strength shortages.

That got me thinking about the times I have heard people complaining on Spanish radio about the United States, to the point of saying, (and this is a direct quote from someone I know) "I will never do anything for this country!"

As part of the opening of the Democratic Convention in Charlotte, North Carolina, a group of students demonstrated to the tune of "Without papers and without fear" while wearing T-shirts featuring Fidel Castro. They even said to Rafael Prieto Zartza of The Huffington Post how they support Fidel Castro, Hugo Chavez and against the imperialism.

I wonder how such statements and demonstrations will affect the legalization of their situation if from the start they show allegiance with the enemy.

One thing is for sure: if 18 to 25-year-olds in this country are forced to serve in the military service, it will put a dent on the illegal immigration issue.

This convenience store is located in So. Broadway, just before Rt. 495. It has been empty for a few years and the city has made it difficult for its owner to sell it.

Some threw out a sofa and a few days after that, it was joined by the television set. The city has already picked it up after I complained to the city councilors of that area.

## Illegal dumping in So. Lawrence

A few days ago, I sent these pictures to Councilors Eileen Bernal, Dan Rivera, Marc Laplante and Roger Twomey, the South Lawrence councilors in order to make them aware of the conditions of Julie and Wendy's Convenience Store. This site has been empty for a few years; they have tried selling it and at one point, there was a South Lawrence family willing to open another convenience store, just like it had been for years.

The administration, which is not business friendly, has made it so difficult for this owner to sell this property that it has become an eyesore.

Councilor Bernal responded, "As this property owner is repeatedly looking for relief from the zoning and planning boards, I was suggesting that the planning department make that outreach to her. As a city, we should be cognizant of what type of property owner we're dealing with when we grant that type of relief."

But Councilor Laplante said, "My recommendation is to not simply pick up the materials that are left there, but to have a conversation and a warning to the property owner that they have a responsibility to secure their area. The recommendation would be the city would pick it up this one time, but if they aren't proactive then they may incur inspectional services violations in the future. At the very least they should install cameras to identify people who are doing the dumping. It's not fair to the other taxpayers of the city that they have to pay for the cleanup of private property. We should see a little bit more of an effort with this (or any) private business owner to work with the city to try to improve their property and to deter illegal dumping."

The City of Lawrence spends around \$250,000 handling illegal dumping all over the city. One way to avoid making these areas a dumping ground is helping businesses not to stand idle for years.

# Lawrence Family Development Charter School ranked a Level One school (top 10% in Massachusetts)

**Designated a 2012 commendation school for significantly increasing student achievement and reducing the achievement gap.**

These are demonstrated by exceptional rankings of students attaining Advanced and Proficient levels across the grades from Grade 3 where the youngest grade of students assessed attained a 78% in ELA and 75% in Math to Grade 8 which achieved 94% in ELA and 81% in Math, both grade levels outperforming all public schools in Lawrence.

John Housianitis, President of the Board of Trustees and one of the school founders in 1995 stated at a reception to honor the school staff this past Friday, "Anyone who believes that youngsters who come from economic poverty or enter school when English was not their first language, somehow cannot succeed, must see that these results fly in the face of their mistaken understandings. The achievements of our teachers and students prove that the combined attention to quality education at school and in the home build a partnership for student success."

Mr. Housianitis further noted that: "Family is at the center of our name, and it is in working with parents who support our policies of attendance, homework and participation that we are able to achieve beyond the expectations of demographics."

Ralph Carrero, the Superintendent of the school, stated "Poverty has never been

a deterrence at LFDCS. In fact, it is one of the reasons we push our students so hard. We don't have a second chance; the quality education they receive at LFDCS is their ticket to a quality secondary high school and their opportunity to break the cycle of poverty."

Ms. Katherine Allen, Head of the Lower School, attributed the impressive rise in student growth to the rigor of teacher lesson plans, the focus on building background knowledge and vocabulary knowledge, and the school's RTI model which allows grade level staff to meet monthly and assess student performance with particular attention to students in Tier II and Tier III, those just below benchmark and those at Warning. Teachers create individual learning plans and put interventions and additional teaching time in place to eliminate learning gaps and improve performance.

As a result of the RTI and three tier model of instruction, the school reduced the percentage of students at Warning to below 5% during the 2012-13 school year.

The Department of Elementary and Secondary Education announced that LFDCS has been invited to move to the next stage of the 2012-2013 charter school application process and submit a final application for the YouthBuild Charter Academy Lawrence for the 2013 school year serving grades 9-12 with 173 students.

# Celebration for MCC's New Cambodian Ceramics Kiln



Edson Parker Foundation. Care and use of the kiln will be administered through MCC's Art Department.

Conceived and directed by MCC Art Professor Margaret Rack, the Cambodian Kiln Project is designed to help preserve the tradition of Cambodian ceramics, which dates back to the ancient Angkor Kingdom (802-1431). The idea grew out of a cultural-exchange trip to Cambodia Rack made in the summer of 2010. She was among 13 MCC and Lowell Public Schools teachers who took part in a U.S. Department of Education Fulbright-Hays Group Project Abroad to promote communication between American and Cambodian educators.

The kiln was built under the supervision of Lowell artist Yary Livan, a survivor of Cambodia's Pol Pot-era genocide and believed to be one of only four surviving masters of classical Cambodian ceramics. An adjunct ceramics instructor at Middlesex, Livan constructed the kiln with master kiln maker Proeung Kang, a visiting summer scholar from Cambodia.

Now that the environmentally friendly kiln -- dubbed "Yary's Kiln" -- is complete, Livan will be able to continue his work and pass on his skills as artist-in-residence. He will supervise all firings and teach Cambodian ceramics to MCC and Lowell Public Schools students, and the community.

A celebration and ribbon-cutting ceremony for Middlesex Community College's new Cambodian ceramics kiln will be held from 3 to 5 p.m. Wednesday, Oct. 3. Built on Lowell National Historical Park grounds, the kiln is located at 220 Aiken St. The celebration is free and open to the public.

Under construction since June, the smokeless, wood-fired kiln was built for college and community use. Funding was provided by Middlesex and the Theodore

Hacerlo destruiría nuestra propia habilidad de ser y permanecer como faros de libertad para aquellos que lo buscan.

Y ese es mi punto de vista hoy.


options to choose their leaders and renew themselves from within without conflict or warfare, must depend on created walls of tyrannical belief orthodoxies to avoid risking their existences from the attack of external forces. Blasphemy is then used intentionally or opportunistically as a convenient excuse to reinforce and protect the foundation of that orthodoxy and avoid its crumbling. It is the one that conscripts the citizenship to battle. The Trojan horse comes to mind as the ultimate blasphemy tool. Used appropriately, blasphemy is a call to action to a group of believers to remain vigilant from the extraneous, stand together and fight.

Heresy, on the other hand, is the internal protective device that keeps away the outside dangers by making sure that the group remains as a predictable and cohesive force that will not go astray and will always be ready to fight and reject the blasphemous and, in the end, the heretical as well. If death is the ultimate penalty imposed on the deviating, then stamping heresy out will be an easier task. Are we

then surprised to see how the masses remain silent when imagined or real desecrations are used as excuses to attack embassies, consulates, businesses and other convenient symbols of blasphemy? The silent do not necessarily agree with the noisy clamor, but they must remain voiceless and remain indifferent if they want to survive. What is more, orthodoxy knows that as well, and is perfectly happy to let fear be in charge of the confinement. The blow on the head is supported by the force of gravity, and that force is always cheap.

It is hard to see an end to those attacks against our symbolic institutions in the immediate future. Putting an end to it by the tyrants would open doors in those societies that might never be able to close again. So we have to be patient and hope for the best. What we cannot do is to play tit for tat and replace those orthodoxies, blasphemies and heresies with versions of our own. To do so would destroy our own ability to be, and remain, beacons of freedom for those who are looking for it.

And that is my point of view today.

# La FDA lanza campaña para proteger a los consumidores de los riesgos de las farmacias virtuales falsas

## Encuesta revela una falta de confianza en la compra de medicinas en el Internet

La Administración de Alimentos y Medicamentos de los Estados Unidos lanzó hoy una campaña nacional para concientizar al público sobre la predominación de las farmacias virtuales fraudulentas, que pueden ser peligrosas para la salud del paciente y para ayudar a los consumidores a comprar medicamentos de manera segura.

Ojo con las medicinas del Internet – Conozca sus farmacias virtuales2 proporciona recursos para los pacientes y los proveedores de cuidado que deseen comprar medicinas en Internet para que comprendan mejor a quién le están comprando y para cerciorarse de que las medicinas que compran sean las que le recetó su médico.

Casi 1 de 4 consumidores en Internet ha comprado medicamentos bajo receta médica a través del Internet, de acuerdo con una nueva encuesta de la FDA. Al mismo tiempo, casi el 30 por ciento de los consumidores dijeron que no tenían confianza sobre la seguridad de las compras en el Internet. El riesgo de comprar medicinas a un vendedor virtual deshonesto es alto. La Asociación Nacional de Consejos de Farmacéuticos reporta que menos del 3 por ciento de

las farmacias virtuales cumplen con la legislación estatal y federal.

“Comprar medicinas de farmacias virtuales deshonestas puede ser peligroso porque pueden vender productos falsos, vencidos, contaminados, no aprobados por la FDA, o que de otra manera, son productos que no son seguros y peligrosos para los pacientes”, dijo la Comisionada de la FDA, la Dra. Margaret Hamburg. “Las farmacias virtuales fraudulentas e ilegales frecuentemente ofrecen productos con descuentos bastante grandes. Si los precios bajos parecen ser demasiado buenos para poder ser verdad, lo más probable es que los productos no son verdaderos. La campaña Ojo con las medicinas del Internet de la FDA está diseñada para ayudar a los pacientes a que aprendan cómo evitar estos riesgos”.

Las farmacias virtuales fraudulentas usan métodos de comercialización sofisticada o portales de Internet falsos que parecen ser legítimos. Los pacientes que compran medicinas en estos sitios Web pueden poner en riesgo su salud porque los productos pueden contener ingredientes falsos, contener muy poco, mucho o nada de los ingredientes activos, o estar elaborados con otros ingredientes nocivos para la salud.

Los pacientes sólo deben comprar

medicinas bajo receta médica a través de farmacias que:

- Requieran una receta válida de un médico o de otro profesional del cuidado de la salud;
- Estén ubicadas en los Estados Unidos;
- Tengan un farmacéutico con licencia disponible para consultas; y
- Tengan licencia del Consejo Estatal de Farmacias.

Además de estos consejos para los pacientes y los cuidadores, la FDA también desarrolló materiales educativos como parte de la campaña Ojo con las medicinas del Internet para que otras agencias federales, organizaciones sin fines de lucro y privadas puedan utilizarlos en sus propios esfuerzos educativos. **FDA campaign aims to protect consumers from the risks of fake online pharmacies**

## Survey data shows lack of confidence in purchasing drugs over the Internet

The U.S. Food and Drug Administration today launched a national campaign to raise public awareness about the prevalence of fraudulent Internet pharmacies, which can be dangerous to patient health, and to help consumers make safe purchases.

BeSafeRx – Know Your Online Pharmacy2 provides resources for patients and caregivers who might purchase medication online to better understand who they are buying from, and that the medication they buy matches what their doctor prescribed.

Nearly 1 in 4 Internet consumers has purchased prescription medicine online, according to a new FDA survey. At the same time, nearly 30 percent said they lacked confidence about how to make safe online purchases. The risk of purchasing from a rogue seller is high, with the National Association of Boards of Pharmacy reporting that less than 3 percent of online pharmacies meet state and federal laws.

“Buying medicines from rogue online pharmacies can be risky because they may sell fake, expired, contaminated, not approved by FDA, or otherwise unsafe products that are dangerous to patients,” said FDA Commissioner Margaret Hamburg, M.D. “Fraudulent and illegal online pharmacies often offer deeply discounted products. If the low prices seem too good to be true, they probably are. FDA’s BeSafeRx campaign is designed to help patients learn how to avoid these risks.”

Fraudulent online pharmacies use sophisticated marketing efforts or phony web storefronts to appear legitimate. Patients who buy medicines from these websites may be putting their health at risk because the products may contain the wrong ingredients, contain too little, too much, or no active ingredient at all, or be made with other harmful ingredients.

Patients should only buy prescription medicine through online pharmacies that:

- require a valid prescription from a doctor or other health care professional;
- are located in the United States;
- have a licensed pharmacist available for consultation; and
- are licensed by the patient’s state board of pharmacy.

In addition to tips and for patients and caregivers, the FDA has also developed BeSafeRx campaign materials for other federal agencies, nonprofit and private organizations to use for their own educational efforts. These resources can be found at [www.FDA.gov/BeSafeRx3](http://www.FDA.gov/BeSafeRx3).

The FDA, an agency within the U.S. Department of Health and Human Services, protects the public health by assuring the safety, effectiveness, and security of human and veterinary drugs, vaccines and other biological products for human use, and medical devices. 
