YouthBuild Lawrence recibió dádiva federal

La Congresista Niki Tsongas entregó un cheque por \$1,100,000 a YouthBuild Lawrence para ayudar a proporcionar formación profesional y capacitación en el aula en los jóvenes en situación de riesgo entre las edades de 16 a 24 años.

El evento se llevó a cabo el pasado 27 de septiembre, 2011 con la presencia de Charlotte Golar Richie, Senior Vice President for Public Policy, Advocacy and Government Relations at YouthBuild USA; el Senador Estatal Barry Finegold, el Representante Estatal Marcos Devers, el Concejal at Large y Presidente del Concilio Frank Morán, el también Concejal at-Large, Roger Twomey, Patricia Karl, Co-Fundadora Jubilada como Superintendente de Lawrence Family Development Charter School; Ralph Carrero, actual Director/Superintendente de Lawrence Family Development Charter School; John Housianitis, Presidente de la junta directiva, personal y alumnos.

En agosto, la Secretaria del Trabajo,

Hilda Solís, anunció que \$75 millones en subvenciones a YouthBuild estaban siendo distribuidos a nivel nacional para ayudar a jóvenes que estaban fuera de la escuela a ganar un diploma de GED mientras aprenden habilidades críticas en construcción, salud, tecnología informática y otros campos. Las subvenciones van desde \$700,000 a \$ 1.1 millones y se adjudicaron a 74 programas de YouthBuild en 28 estados y el Distrito de Columbia.

Como parte de este proceso, YouthBuild Lawrence recibió una subvención de \$1.1 millones en tres años. La Congresista Tsongas apoyó firmemente la aplicación para la subvención a YouthBuild Lawrence.

La entrega del cheque tuvo lugar en una casa unifamiliar ubicada en el 189 de la Calle West, Lawrence, MA, que fue construida por una clase previa de los estudiantes de YouthBuild. La casa será vendida a una familia de primeros compradores de bajos ingresos. Un ex participante de YouthBuild se desempeñó como contratista general del proyecto.

¡Diga NO al arrojo ilegal de basura!

Durante años, el vertido ilegal de todo tipo de materiales (basura) ha sido un problema en nuestra ciudad. Muchas organizaciones y cientos de voluntarios han donado su tiempo en un esfuerzo por mantener la ciudad limpia.

Todos los años, hemos escuchado la misma historia. Después de una campaña de limpieza, al día siguiente, los montones de basura estaban por doquier. Esta práctica no sólo consume una gran cantidad de nuestros recursos y energía, sino que contribuye a la mala imagen que le da a la ciudad.

Esta práctica puede llegar a su fin gracias a MassDEP, en un esfuerzo conjunto con los Servicios de Inspección de la Ciudad de Lawrence.

"Los que egoístamente vuelcan residuos en la vía pública deben saber que van a quedar atrapados, simplemente porque ahora tenemos las herramientas necesarias para poner fin a esta práctica ilegal", dijo Pamela Talbot, director de la Fuerza de Ataque del Medio Ambiente del MassDEP.

Las "herramientas" de la cual la Sra. Talbot está hablando son pequeñas cámaras digitales que funcionan con pilas activadas por sensores de movimiento instalados a principios de junio de 2012. Estas cámaras tienen la tecnología de lectura de matrículas, lo que ha contribuido a aumentar la tasa de identificación de camiones por la noche.

Más de una docena de incidentes de desechos fueron captados por las cámaras, con nueve de los violadores identificados hasta el momento. Estos violadores recibieron un mínimo de una multa de \$300 por cada violación por parte de la Ciudad de Lawrence. En un caso, un camión fue confiscado y puesto en libertad tras el pago de multas correspondientes.

El hecho de que tenemos varias cámaras distribuidas por la ciudad no es suficiente. Necesitamos la participación cívica de los ciudadanos. Debemos permanecer vigilantes, día y noche, y asegurarnos que los infractores sean identificados y penalizados.

¡Esto es tarea de todos, no sólo de unos pocos!

Say NO to illegal dumping!

For years, the illegal dumping of all kind of materials has been a problem in our city. Many organizations and hundreds of volunteers have donated their time in an effort to keep the city clean.

Every year, we heard the same story. After a clean-up drive, the next day, piles of trash were all over the place. This practice not only consumes a lot of our resources and energy, but contributes to the bad image the city is known for.

This will come to an end thanks to MassDEP, in a cooperative effort with the City of Lawrence Inspectional Services.

"Those who selfishly dump debris in public spaces should know that you will get caught, simply because we now have the tools to put an end to this illegal practice," said Pamela Talbot, director of MassDEP's Environmental Strike Force.

The "tools" Ms. Talbot is talking about are small battery-operated digital cameras triggered by motion sensors installed at the beginning of June 2012. These cameras have license plate-reading technology, which has helped increase the rate of identification of dumpers at night.


More than a dozen incidents of dumping were captured by the cameras, with nine of the dumpers identified thus far. The dumpers were issued a minimum of a \$300 fine per violation by the City of Lawrence. In one instance, a truck was impounded and released upon payment of fines.

The fact that we have several cameras distributed around the city is not enough. We need civic participation from our citizens. We must remain vigilant, day and night, watching for those scofflaws to be identified and penalized.

This is everybody's job, not only of a few!

La temporada de gripe se acerca - ¡Vacúñese Hoy!

No se deje engañar por las cálidas temperaturas. La temporada de gripe estará aquí antes de que usted se de cuenta. La mejor manera de protegerse contra la influenza es vacunarse antes de que comience la temporada gripe. Esto es cierto incluso si se vacunó el año pasado. Los expertos en salud de los Centros para el Control y Prevención de Enfermedades (CDC, por sus siglas en inglés) recomiendan que todas las personas de 6 meses de edad o más, reciban la vacuna contra la gripe cada año.

Eso es porque la gripe puede ser muy grave. Cada año en Massachusetts, un promedio de 5,000 personas son hospitalizadas debido a complicaciones de la gripe, lo que provoca más de 800 muertes. La buena noticia es que muchas de estas hospitalizaciones y muertes se pueden

prevenir. Durante esta temporada, usted y su familia se pueden mantener saludable vacunándose.

Esto es aún más importante si usted o alguien en su familia:

- Está embarazada.
- Tiene una condición crónica de salud como el asma, la diabetes o enfermedad renal, del corazón, los pulmones o del hígado.
- Tiene el sistema inmunitario deprimido.
- Está sobre peso; o
- Es mayor de 50 años de edad.

Vacunación contra la gripe también es sumamente importante para los niños menores de 5 años de edad, ya que corren un riesgo mayor de tener complicaciones si contraen la gripe. Por este mismo motivo si usted es familiar o cuida de niños menores de cinco años de edad, es importante que también se vacune.

La vacuna contra la gripe es segura, eficaz y la puede conseguir con facilidad. Este año hay más vacunas disponibles que nunca.





Usando vigilancia remota, MassDEP y la Ciudad de Lawrence persiguen los basureros ilegales en espacios públicos

Camaras secretas permiten que los violadores sean identificados, penalizados por descargas de escombros.

En un esfuerzo de cooperación para luchar contra los basureros ilegales en la Ciudad de Lawrence, el Departamento de Protección Ambiental de Massachusetts (MassDEP) ha instalado cámaras ocultas en lugares de alto riesgo que capturó imágenes de varias personas responsables que fueron multados con posterioridad, y en algunos casos, los trajeron de vuelta a limpiar lo que ensucian.

MassDEP trabajó con el Servicio de Inspección de Lawrence para instalar unas cámaras digitales pequeñas que funcionan con baterías en vías públicas las cuales son provocadas por sensores de movimiento. MassDEP compartió sus nuevas cámaras con tecnología de lectura de placas, lo que ha contribuido a aumentar la tasa de identificación de camiones por la noche.

"Los que egoístamente echan basura en la vía pública deben saber que van a quedar atrapados, simplemente porque ahora tenemos las herramientas necesarias para poner fin a esta práctica ilegal", dijo Pamela Talbot, directora de la Fuerza de Ataque del Medio Ambiente (Environmental Strike Force) de MassDEP.

El vertedero seleccionado es adyacente a un nuevo paseo público en el Río Spicket. Después de instalar las cámaras, MassDEP y la ciudad encontraron infractores frecuentes botando escombros de construcción, neumáticos, electrodomésticos, muebles y basura doméstica. Lawrence ha luchado contra los vertidos ilegales, al igual que otros municipios urbanos, incurriendo en cientos de miles de dólares en costos de limpieza pagado por los contribuyente en varios sitios públicos.

Además de aumentar los costos de eliminación de la ciudad, los equipos de

obras públicas están siendo desviados de los trabajos de mantenimiento importantes en carreteras, alcantarillas y líneas de agua, para solamente lidiar con la limpieza de escombros cuyo origen, la procedencia y el contenido era desconocido.

"Desde que asumí el cargo, siempre he dicho que los basureros ilegales no serán tolerados en nuestra ciudad", dijo el Alcalde de Lawrence William Lantigua. "Estoy agradecido a MassDEP y nuestros inspectores locales que han trabajado incansablemente para ayudar a combatir este problema de calidad de vida. Vamos a seguir vigilando y penalizando a los que no muestren ningún respeto por nuestra gran Ciudad de Lawrence."

A partir de junio del 2012, dos cámaras fueron instaladas por la Environmental Strike Force y el Servicio de Inspección de Lawrence en el vertedero escogido. Las cámaras son capaces de tomar decenas de miles de imágenes de alta resolución durante muchas semanas en un solo juego de pilas. Están equipadas con capacidad de visión nocturna infrarroja y una de las cámaras está especialmente diseñada para leer las matrículas de los autos en la noche.

Más de una docena de incidentes fueron capturados por las cámaras, con nueve de los violadores identificados hasta el momento. A los infractores se les emitió una multa de un mínimo de \$300 por la Ciudad de Lawrence.

Los incidentes más descarados se muestran en las fotos que acompañan este artículo.

Los residuos que fueron abandonados allí, en muchos casos, se hubiesen podido deshacer de ellos de forma gratuita simplemente contactando al Departamento de Obras Públicas de Lawrence o mediante la obtención de una etiqueta por un precio mínimo. Lawrence se encuentra en proceso de actualización de su reglamento para

Using Remote Surveillance, MassDEP and City of Lawrence Target Illegal Dumping in Public Spaces

Hidden cameras allow scofflaws to be identified, penalized for dumping debris

In a cooperative effort to combat illegal dumping in the City of Lawrence, the Massachusetts Department of Environmental Protection (MassDEP) installed hidden cameras in high-risk locales that captured images of multiple perpetrators who were subsequently fined, and in some cases, brought back to clean up their mess.

MassDEP worked with the Lawrence Inspectional Services to install small battery-operated digital cameras in public rights-of-way that were triggered by motion sensors. MassDEP shared its new cameras with license plate-reading technology, which has helped increase the rate of identification of dumpers at night.

"Those who selfishly dump debris in public spaces should know that you will get caught, simply because we now have the tools to put an end to this illegal practice," said Pamela Talbot, director of MassDEP's Environmental Strike Force.

The dumping site selected is adjacent to a new public walking trail on the Spicket River. After installing the cameras, MassDEP and the city found frequent scofflaws who dumped construction debris, tires, appliances, household garbage and furniture. Lawrence has struggled with illegal dumping, just like other urban municipalities, incurring hundreds of thousands of dollars in taxpayer cleanup costs at several public sites.

In addition to increasing the city's disposal costs, public works crews are being diverted from important maintenance work on roads, sewers and water lines, simply to deal with the cleanup of debris whose

origin, source and content previously had been unknown.

"Since taking office, I have long stated that illegal dumping will not be tolerated in our city," said Lawrence Mayor William Lantigua. "I'm thankful for MassDEP and our local inspectors who have worked tirelessly to help fight this quality-of-life issue. We will continue to monitor and penalize those that show no respect for our Great City of Lawrence."

Beginning in June 2012, two cameras were installed by the Environmental Strike Force and Lawrence Inspectional Services at the subject dumpsite. The cameras are capable of taking tens of thousands of high resolution pictures over many weeks on a single set of batteries. They are equipped with infrared night vision capability and one of the cameras is specially designed to read license plates at night.

More than a dozen incidents of dumping were captured by the cameras, with nine of the dumpers identified thus far. The dumpers were issued a minimum of a \$300 citation by the City of Lawrence.

The more brazen incidents are shown here accompanying this article.

The waste that was dumped could, in many cases, have been disposed of for free by simply contacting the Lawrence Department of Public Works or by obtaining a bulk item sticker for a nominal fee. Lawrence is in the process of upgrading its dumping bylaw and is updating its own camera program to catch future dumpers.

Since the start of the "Candid Camera" program in 2005, MassDEP has partnered with more than 20 municipalities at frequent

City to smoke test sewers



The Department of Public Works announced that the City will conduct smoke testing of certain sewers in October and November 2012. The work is part of a program to improve operation of the sewer and storm drainage systems.

These investigations will be performed in several areas throughout the City. Notices will be distributed directly to the affected buildings 24 to 72 hours before smoke testing is performed. Public Works officials advise that residents do not have to be at the premises during the test. However, residents with pets should ventilate the area where the pet will be.

During large rainstorms, flow increases markedly in the City's sanitary sewer and storm drain piping. At times these systems become overwhelmed. In extreme cases, the system's capacity is exceeded and flooding and wastewater treatment problems occur. Where the testing will occur, the sanitary sewer network was designed to carry wastewater from sinks, toilets and other household fixtures, and the storm drain network was designed to carry surface waters from streets, parking lots and other areas. The purpose of smoke testing is to find improper interconnections between the two systems that may contribute to high flows in the area.

AECOM (the City's consulting engineer) and its subcontractor, Flow Assessment Services, will be performing the tests. During smoke testing, white smoke is passed through the sanitary sewer system and out through improper connections

such as drain inlets and roof drains. During this procedure, white smoke will also be venting through holes in manhole covers located in the street and through plumbing vent pipes located on or near the surface of your roof. This is normal and should not be cause for alarm. Smoke should not enter buildings unless there is a plumbing defect or a dry trap in an unused fixture, however, the smoke is environmentally safe and non-toxic. The Department of Public Works advises pouring water down unused plumbing fixtures to ensure that the drain trap will be effective.

Prior to smoke testing, the City wishes to identify locations of persons with poor health conditions who may be affected by the testing. Although the smoke is non-toxic and non-staining, and it is unlikely to enter your premises, it is capable of causing minor throat and lung irritation, especially to those with lung ailments such as asthma or emphysema. Please contact the Department of Public Works at 978-620-3090 if you have these or similar health conditions, so that appropriate precautions can be taken.

Ciudad realizará prueba de humo en alcantarillado



El Departamento de Obras Públicas anunció que estará llevando a cabo pruebas de humo en determinadas alcantarillas de la ciudad durante los meses de octubre y noviembre 2012. El trabajo es parte de un programa para mejorar el funcionamiento de la red de alcantarillado y sistemas de drenaje pluvial en la ciudad. Estas investigaciones se llevarán a cabo en varias zonas.

La ciudad enviará notificaciones directamente a los edificios afectados 24 a 72 horas antes de que se realice la prueba de humo, dijeron funcionarios del DPW. Dijeron que los residentes no tienen que estar en el edificio durante la prueba. Sin embargo, recomiendan a los residentes con mascotas a que ventilen el área donde estará el animal o animales.

Durante grandes aguaceros, el flujo aumenta notablemente en alcantarillado sanitario de la Ciudad y en las tuberías del drenaje de aguas pluviales. A veces estos sistemas se sobrecargan de agua y, en casos extremos, se producen problemas de inundaciones y de tratamiento de las aguas residuales.

La red de alcantarillado sanitario fue diseñada para llevar las aguas residuales de fregaderos, inodoros, bañeras y otros artefactos de uso doméstico, mientras que la red de drenaje pluvial fue diseñada para llevar las aguas superficiales de las calles, estacionamientos y otras áreas. El propósito de las pruebas de humo es encontrar interconexiones defectuosas o inadecuadas entre los dos sistemas que pueden contribuir a altos flujos en la zona.

AECOM (la firma de ingenieros consultora de la Ciudad) y su subcontratista, Flow Assessment Services, estarán realizando las pruebas del humo.

Durante las pruebas, el humo blanco pasará a través del sistema del alcantarillado sanitario y saldrá por conexiones incorrectas, tales como las tomas de drenaje y desagües del techo. Durante este procedimiento, el humo blanco será visto también saliendo a través de los agujeros de las tapas de la alcantarilla ubicada en la calle y por las tuberías de ventilación de la plomería situados en el techo. Esto es normal y no debe ser motivo de preocupación. El humo no debe entrar en los edificios a menos que haya un defecto en la plomería o una trampa seca en un artefacto de agua sin usar. Este humo no es tóxico y es ambientalmente seguro. El Departamento de Obras Públicas aconseja verter agua por cañerías no utilizadas para asegurar que la trampa del drenaje será eficaz.

Antes de la prueba del humo, la Ciudad quiere identificar lugares donde haya personas con ciertas condiciones de salud que puedan verse afectados por las pruebas. Aunque el humo no es tóxico, no mancha, y es poco probable que entre a la propiedad, éste puede causar irritaciones leves de la garganta y los pulmones, especialmente a aquellas personas con enfermedades pulmonares tales como asma o enfisema. Departamento de Educación revisará el sistema escolar de Lawrence

El Superintendente Jeffrey Riley fue informado por el Departamento de Educación Elemental y Secundaria sobre una próxima revisión de Programas Coordinados en las Escuelas Públicas de Lawrence, la cual se llevará a cabo durante este año escolar. Como parte de esta Revisión de Programas Coordinados, el personal del Departamento visitará al distrito durante la semana del 22 al 26 de octubre de 2012. Tales visitas tendrán lugar rutinariamente por el Departamento para satisfacer los requisitos federales y estatales para la revisión periódica de programas de educación y servicios en

específicos en las escuelas a través de todo el Estado. El Departamento estará revisando varios programas durante una sola visita con el fin de utilizar el tiempo del personal del Departamento y el personal escolar de manera más eficiente y fomentar fuertes vínculos entre los programas.

Utilizando una escala de calificaciones desde "Recomendable" a "No Implementado," el informe calificará la implementación de cada requisito revisado por el Departamento. Donde se encuentre que los requisitos no han sido implementados o solo parcialmente implementados, el distrito tendrá que proponerle al Departamento una acción correctiva para poner esas áreas en cumplimiento con los estatutos y reglamentos. Se les anima a los distritos y escuelas a incorporar la acción correctiva en el plan de mejora del distrito y de las escuelas y en el plan de desarrollo profesional. El distrito escolar le proporcionará asistencia técnica desde el Departamento en el desarrollo o lo que sea necesario de los planes de acción correctiva. Tanto el informe del Departamento como los planes de acción correctiva serán informaciones públicas y estarán a disposición del público que lo solicite. Los Informes Finales de la Revisión del Programa estarán también disponibles en el sitio web del Departamento en <http://www.doe.mass.edu/pqa/review/ieprireports>.

Dept. of Ed. will review Lawrence's school system

Superintendent Jeffrey Riley was informed by the Department of Elementary and Secondary Education of an upcoming Coordinated Program Review in the Lawrence Public Schools, which will be taking place this school year. As part of this Coordinated Program Review, Department staff will visit the district during the week of October 22-26, 2012. Such visits are routinely conducted by the Department to satisfy federal and state requirements for the periodic review of specific education programs and services in schools throughout the Commonwealth. The Department is reviewing several programs during a single visit in order to use Department and school staff's time most efficiently and to encourage strong connections among the programs.

The Department's Coordinated Program Review will address the following programs: Special Education, English Learner Education, and Civil Rights. After reviewing school district procedures for these programs, a Department team will make its onsite visit, during which it will review individual student records, interview administrators, teachers and paraprofessional staff, survey parents and observe instructional spaces. After the onsite visit, it will prepare a report for the superintendent and school committee with detailed findings for each program.

Using a scale of ratings ranging from "Commendable" to "Not Implemented," the report will rate the implementation of each requirement reviewed by the Department. Where requirements are found not implemented or only partially implemented, the district must propose to the Department corrective action to bring those areas into compliance with statutes and regulations. Districts and schools are encouraged to incorporate the corrective action into their district and school improvement plans and professional development plan. The school district will be provided with technical assistance from the Department in developing any necessary corrective action plans. Both the Department's report and any corrective action plans are public information and will be available to the public upon request. Program Review Final Reports are also available on the Department's Internet website at <http://www.cloe.mass.edu/pqa/review/ieprireports>.

Those wishing to be interviewed should call the superintendent's office at 978-975-5900 no later than Thursday, October 18, 2012 to leave their name and phone number, or they may call the Department of Elementary and Secondary Education at (781) 338-3703. A member of the visiting team will contact each person desiring an interview within two weeks after the completion of the onsite visit. Lawrence pierde miles de dólares

Supervisor fiscal exige cambios en procedimientos municipales

Estimados Concejales:

Esta carta es en referencia a cuestiones y preocupaciones relacionadas con el proceso de permisos de construcción en la Ciudad de Lawrence. El miércoles, 19 de septiembre, el equipo de finanzas se puso en conocimiento por parte de la Presidenta de la Junta de Asesores de la posibilidad de que el Departamento de Construcción no les envió ciertos permisos de construcción del año calendario 2011 para su atención. Esta inacción resultó tanto en ingresos perdidos y contabilidad inexacta de nuevo crecimiento. Además, priva a los residentes de Lawrence de una determinación justa y equitativa de los valores de sus propiedades.

Habiendo requerido una investigación más profunda, el viernes, 21 de septiembre recibí un informe con la escala y el alcance del problema de la Presidenta de la Junta de Asesores. Se determinó que un total de 302 permisos con un valor total de \$23'005,400 no se remitieron a la oficina de los evaluadores. Afortunadamente, debido a que la Junta de Asesores captó este error a tiempo y lo notificó al consultor de tasación de la ciudad, Real Estate Research Consultant (RRC), los 302 permisos en cuestión serán revisados y sus evaluaciones se incluirán en las cuentas del tercer y el cuarto trimestre de los impuestos a la propiedad para el Año Fiscal 2013. La ciudad no perderá este nuevo potencial de crecimiento de ingresos de aproximadamente \$200,000.

Con el fin de determinar el alcance del error, solicité al Comisionado de Construcción que hiciera una revisión de todos los controles internos, políticas, procedimientos y protocolos relativos a este tema y una auditoría del proceso de permisos que se remonta al año 2010. Yo también pedí una solución inmediata y de largo plazo con el fin de evitar cualquier problema futuro de contabilidad o procesamiento. Posteriormente, la revisión encontró que en el 2010, un total de 47 permisos por valor de \$10'347,817 no se remitieron a la oficina de

los evaluadores (Assessors' Office). RRC ahora revisará esas propiedades, pero esto significa una pérdida estimada de \$100,000 en ingresos para la ciudad que no fue ni podrá ser cobrado.

Para evitar que tales errores de procedimiento se repitan en el futuro, el Comisionado de Construcción ahora está trabajando con el Departamento de Tecnología Informática para mejorar el mantenimiento de registros y formalizar un proceso compartido "base de datos master" que esté disponible para todo el personal, incluyendo la oficina de los evaluadores para su revisión. Además, he alentado al Alcalde Lantigua para examinar y tomar medidas cuando corresponda en las cuestiones de personal que dieron lugar a este valor de la propiedad y los ingresos perdidos.

Desde un punto de vista fiscal, es imperativo que la ciudad implemente y mantenga de forma clara, responsable y eficaz un sistema electrónico de permisos que sea integrado con el sistema de MUNIS para que no se pierdan ingresos futuros. Esto requerirá una inversión inicial de fondos de la ciudad, requerirá un entrenamiento adecuado y la supervisión por parte del personal y probablemente evitará errores similares de contabilidad y procesamiento en el futuro. Para ello, dichos fondos se incluirán en una asignación suplementaria. También he pedido al Director de Finanzas que contrate a una empresa de auditoría para ayudar en una revisión adicional de las prácticas y procedimientos conexos en el Departamento de Construcción y llevar a cabo una auditoría de prueba de los años anteriores con fondos de la aprobación del Supervisor Fiscal.

Lawrence losses thousands of dollars

Fiscal Overseer requires changes in municipal processes

Dear Councilors:

This letter is in reference to issues and concerns related to the building permitting process in the City of Lawrence. On Wednesday, September 19th, the finance team was made aware by the Chair of the Board of Assessors of the possibility that certain building permits from calendar year 2011 were not forwarded from the Building Department to their attention. This inaction results in both lost revenue and inaccurate accounting of new growth. Further, it deprives the residents of Lawrence a fair and equitable determination of their property values.

Having requested further investigation, on Friday, September 21st, I received a report outlining the scale and scope of the issue from the Chair of the Board of Assessors. It was determined that 302 permits totaling \$23,005,400 in value were not forwarded to the Assessors' Office. Fortunately, because the Board of Assessors caught this error in time and notified the city's appraisal consultant, Real Estate Research Consultant (RRC), the 302 permits in question will be reviewed and their assessments will be included in the third and fourth quarter property tax bills for Fiscal Year 2013. The City will not lose this potential new growth revenue of an estimated \$200,000.

In order to determine the full extent of the issue, I requested a review by the Building Commissioner of all internal controls, policies, procedures and protocols relative to this matter and an audit of the permitting process extending back to calendar year 2010. I also asked for an immediate and long-term solution in order to prevent any future accounting or processing issues. Subsequently, the review found that in 2010, 47 permits totaling \$10,347,817 in value

were not forwarded to the Assessors' Office. RRC will now review those properties, but this means an estimated loss of \$100,000 in revenue for the city was not and cannot be collected.

To prevent the reoccurrence of any such future procedural errors, the Building Commissioner is now working with the IT Department to improve the record keeping process and formalize a shared "master database" that is available to all staff including the Assessors' Office for review. In addition, I have encouraged Mayor Lantigua to review and take action where appropriate on any personnel matters that resulted in this lost property value and revenue.

From a fiscal standpoint, it is imperative that the city implement and maintain a clear, accountable and efficient electronic permitting system integrated with the MUNIS system so that no future revenue is lost. This will necessitate an initial investment of funds from the city, require proper training and oversight by staff and likely prevent similar future accounting and processing errors. To that end, such funds will be included in a supplemental appropriation. I have also asked the Finance Director to contract with a third-party outside auditing firm to assist in an additional review of related practices and procedures in the Building Department and to conduct a test audit of previous calendar years using funds from the Fiscal Overseer appropriation.

illegal dumpsites. To date, the program has resulted in approximately 100 illegal dumpers being identified and fined by the communities or by MassDEP. The program continues to seek new municipal partners. Municipalities with a chronic dumpsite that they think might be a good candidate for the program, can contact the MassDEP Environmental Strike Force at 617-556-

1000.

MassDEP is responsible for ensuring clean air and water, safe management and recycling of solid and hazardous wastes, timely cleanup of hazardous waste sites and spills, and the preservation of wetlands and coastal resources.

The following individuals have been identified and penalized for illegal dumping in Lawrence under this initiative and paid a \$300 fine per infraction:

- * June 2, 4:06 p.m. - Jeovanny Gonzalez of 233 Andover St., Lawrence, dumped broken furniture and household trash from a rented truck.

Home Heating Aid Available from GLCAC for families in need

Applications for home heating assistance are now available from the Greater Lawrence Community Action Council Inc. Families meeting federal and state income guidelines may be eligible for financial assistance in paying part of their winter heating bills and are encouraged to contact GLCAC.

First-time applicants should call GLCAC at (978) 681-4950 to make an appointment to apply in person. Handicapped and elderly first-time applicants who are totally homebound may call GLCAC and request a home visit. Previous LIHEAP recipients will receive an application in the mail that can be returned to GLCAC by mail.

Households where heat is included in the rent may be eligible for assistance. The amount of heating assistance is based on a sliding scale and determined by the gross household income.

"The approaching cold temperatures, rising cost of energy and financial uncertainty for many families all combine to make home-heating assistance a critical lifeline for many low-income households," said Evelyn Friedman, Executive Director of the GLCAC Inc.

GLCAC Inc., a non-profit social services agency based in Lawrence, administers the federal Low Income Home Energy Assistance Program in Lawrence, Methuen, Andover, North Andover, Reading and North Reading.

As a federally funded and regulated program, GLCAC is required to follow the federal program rules. To be eligible for assistance with paying a portion of their heating bill, applicants must prove they meet federal and state income guidelines by providing documentation of the gross household income for all household members 18 years and older for a minimum of four weeks prior to their application date.

In the last heating season, GLCAC served 9,234 clients with LIHEAP grants totaling \$5.1 million. Of those assisted, 2,552 were disabled households, 2,511 had children under age 6, and 2,212 had adults age 60 or older.

15th Annual Robert Frost Festival

Day of Poetry At Robert Frost's Alma Mater

The Robert Frost Foundation will present the 15th Annual Robert Frost Festival consisting of a Day of Poetry at Lawrence High after regular classes from 8:30 through 3:07 p.m. on Friday, October 19, 2012 at the Performing and Fine Arts auditorium on North Parish Road, South Lawrence, MA.

This year the foundation will bring a special program to the school day, featuring many ideas that were developed during 15 years of poetry festivals. Students will develop poetry material in special workshops in their regularly scheduled English class. The workshops, facilitated by experienced guest artists, will be the first of many activities during joined by teachers and students that day.

Teachers and students from all six schools within Lawrence High School are expected to participate. An evening talk program open to the public will feature another performance by Gordon Clapp as Frost. Clapp is donating these performances to the high school and the people of Lawrence after an award-winning run of the production last year at Merrimack Repertory Theater.

The program will feature distinguished actor Gordon Clapp (NYPD Blue, Measure for Measure). The one-man show is based on "This Verse Business" by Andrew Dolan, a play that many Lawrence High students viewed as their first piece of live theatre on a field trip to the Merrimack Repertory Theatre in Lowell in 2011. While the show features some poems from Frost's early books, Boy's Will and North of Boston, that were written in Lawrence and Derry,


most of the show is based on remarks that Frost made in hundreds of public 'talks' on poetry late in his career.

One of these talks involved a visit to Lawrence and a reunion with his Lawrence High School students and teachers. Robert Frost and his wife Elinor White had been co-valetedors of the class of 1892, and Frost gave the commencement speech. The two married two years later.

For his commencement speech, Frost told his daughter Lesley that he had 'matched his mind to Emerson's' The result was an idealistic speech about a dreamer who learned to skip 'thought-stones' on the river. That dreamer would become America's favorite poet. Frost also wrote the school song for Lawrence High that was performed for the first time on that occasion.

The school song with Frost's lyrics will be part of a program brought to this year's Festival by the Lawrence High School Girls' Ensemble directed by Nancy McGhee. Other Performing and Fine Arts classes will bring material to the festival as well making it an example of integrated arts program. Maria Morgan's Dance class will choreograph two dance numbers to Frost poems, "Acquainted with the Night" and "Birches," both of which refer to Lawrence, may have been written in either Lawrence, or Derry, or both places.

Robert Frost and Elinor at Lawrence High reflect a modern love story. Special copies of Frost's first book, "A Boy's Will," will be available for students of Frost who want to closely examine the cycle of love poems for themselves.



Gordon Clapp (of NYPD Blue and Measure for Measure) will be the featured performer in a special cameo of his acclaimed one-man Robert Frost show at the 2012 Frost Festival on Friday, October 19 at 7pm in the Lecture Hall at Lawrence High School, 92 North Parish Road, Lawrence, MA.

The 15th Frost Festival culminates from 7pm-- 9 pm in Gordon Clapp's evening performance of his Robert Frost show. This performance followed by a community reading of Merrimack Valley poets. This event will take place in the Lecture Hall, a 150-person auditorium, on the second floor of the main Lawrence High building behind the security desk. The show is open to the public, parents of students, and lifetime students of Frost. The suggested donation, \$10, benefits the Robert Frost Foundation's programs for teacher-initiated activities in the Lawrence Schools.

LFDCS proposed high school invited to submit full application

The Department of Elementary and Secondary Education announced today that the founders of 12 proposed charter schools have been invited to move to the next stage of the 2012-2013 charter school application process and submit a final application.

Final applications are due on November 14, 2012. Those final applications will then be reviewed and evaluated by Department staff and external review panelists with expertise in education, business, law, and organizational structure. In addition, public hearings will be held in the areas where schools are proposed to be located, and a review of any public comments offered to the Department will be conducted. Commissioner of Elementary and Secondary Education Mitchell Chester will then review all of the materials and make his final recommendations to the Board of Elementary and Secondary Education. The Board will vote to award new charters at its February 26, 2013 meeting.

A total of 22 prospectuses had been submitted in July 2012 from groups hoping to ultimately receive approval this year to open new charter schools in Massachusetts.

In January 2010, the Patrick-Murray Administration raised the charter school cap in the lowest performing school districts and made a number of changes to the charter authorizing process. The cap on district net school spending under the Achievement Gap Act is being raised from 9 percent to a maximum of 18 percent through incremental steps. The cap lift only applies to districts with academic performance in the lowest 10 percent as measured by MCAS, and applicants under the cap lift must have a proven track record of success in increasing academic attainment

and commit to working with a diverse population of students. Sixteen new charters were awarded in February 2011, and an additional four were approved this past February.

For applicants that must demonstrate that they qualify as proven providers, an invitation to submit a final application is contingent on the Commissioner's granting of proven provider status. The determination of proven provider status will occur prior to the submission deadline for final applications.

The new YouthBuild Charter Academy Lawrence will serve 173 students between 9th and 12th grades and is expected to begin operations in 2013.



Vicente de la Rosa, de Lawrence, honrado por su trabajo como Asistente de Cuidado Personal

Vicente de la Rosa trabajó en un hospital de la República Dominicana por 10 años antes de emigrar a los Estados Unidos y convertirse en un Asistente de Cuidado Personal (PCA). Como PCA, que brinda atención diaria a dos clientes, que son capaces de vivir de manera independiente debido a su ayuda. De la Rosa, residente de Lawrence, fue homenajeado el mes pasado, el 19 de septiembre de 2012 por la administración Patrick-Murray por su dedicación y desempeño sobresaliente como PCA. De la Rosa fue una de las cinco personas de todo el estado que recibieron la tercera edición del Premio Paul Kahn para servicio PCA en un acto en la Casa de Gobierno.

PCAs brindan apoyo a ancianos e individuos de todas las edades que tienen discapacidades, ayudándoles con actividades de la vida diaria que no son capaces de hacerlo por sí mismos, tales como bañarse, vestirse, preparar la comida y las compras. Los PCAs también hacen posible que muchas personas con discapacidad puedan ir a trabajar, ayudándoles a prepararse para un día en el lugar de trabajo.

"Este premio reconoce el papel vital que desempeñan para ayudar a más de 20,000 residentes de Massachusetts con sus tareas de la vida cotidiana. También hacen posible que las personas vivan de forma independiente, con diferentes cantidades de ayuda", dice Elenore Parker, presidenta de Rewarding Work Resources y administradora de la auto-dirigida, Directorio de Massachusetts PCA. "Los PCAs hacen una gran diferencia en la

calidad de vida de tantas personas."

De la Rosa fue nominado para el premio por sus dos patronos, Juan Cosme y Juan Santos, ambos residentes de Lawrence, que dicen que Vicente se sale de lo corriente. Vicente asiste a las citas médicas con los hombres, les da medicamentos, y entrena a otros PCAs para trabajar con ellos. Cuando Cosme fue hospitalizado con pulmonía grave durante dos semanas, De la Rosa lo visitó y ofreció atención a él durante su estancia en el hospital, a pesar de que no recibiría pago por esas horas. De la Rosa dedica una parte de su tiempo libre a mejorar la calidad del trabajo de PCA, es miembro del comité de negociación colectiva para los trabajadores de la Unión 1199SEIU PCA, y también es miembro del comité de gestión del trabajo.

La ceremonia de premiación fue patrocinada por el Massachusetts PCA Quality Home Care Workforce Council, 1199SEIU Health Care Workers East, and Rewarding Work Resources. La idea de este evento fue iniciado por el trabajo gratificante, que creó y dirige el Concejo innovador, basado en la web del directorio (www.mass.gov/findpcas) para encontrar y contratar PCAs.

Los ganadores fueron seleccionados de las cinco regiones del estado, con De la Rosa en representación de la región noreste. Otros beneficiarios fueron: Caroline Craig de Weymouth (región sudeste), Doris Forcier de Leicester (región central); Wadson Michel de Woburn (región del Gran Boston), y Laurie Swaine de Hadley (región oeste).

Lawrence resident Vicente de la Rosa honored for work as personal care assistant

Vicente de la Rosa worked in a hospital in the Dominican Republic for 10 years before immigrating to the United States and becoming a Personal Care Assistant (PCA). As a PCA, he provides daily care to two clients, who are able to live independently because of his help. De la Rosa, a Lawrence resident, was honored last month (Sept. 19, 2012) by the Patrick-Murray Administration for his dedication and outstanding performance as a PCA. De la Rosa was one of five individuals from across the state receiving the third annual Paul Kahn Award for PCA Service at an event at the State House.

PCAs support elders and individuals of all ages who have disabilities by assisting them with activities of daily living that they are unable to do themselves, such as bathing, dressing, meal preparation and shopping. PCAs also make it possible for many people with disabilities to go to work by helping them prepare for a day in the workplace.

"This award acknowledges the vital role that PCAs play in assisting more than 20,000 Massachusetts residents with tasks of everyday living. PCAs make it possible for people to live independently, with varying amounts of assistance," says Elenore Parker, president of Rewarding Work Resources and administrator of the self-directed Massachusetts PCA Directory. "PCAs make a huge difference in the quality of life for so many."

De la Rosa was nominated for the award by both of his employers, Juan Cosme and Juan Santos, both Lawrence residents, who say that Vicente goes out of his way regularly. Vicente attends medical appointments with the men, gives out medications, and trains other PCAs to work with them. When Cosme was hospitalized with severe pneumonia for two weeks, De la Rosa visited him and provided care to him during his hospital stay, even though he could not be paid for those hours. De la Rosa commits a portion of his free time to improving the quality of PCA work, is a member of the collective bargaining committee for the PCA Worker's Union 1199SEIU, and also serves on the labor management committee.

The award ceremony was sponsored by the Massachusetts PCA Quality Home Care Workforce Council, 1199SEIU Health Care Workers East, and Rewarding Work Resources. The idea for this event was initiated by Rewarding Work, which created and manages the Council's innovative, web-based directory (www.mass.gov/findpcas) for finding and hiring PCAs.

Award recipients were chosen from five regions of the state, with de la Rosa representing the northeast region. Other recipients included: Caroline Craig of Weymouth (southeast region); Doris Forcier of Leicester (central region); Wadson Michel of Woburn (Greater Boston region); and Laurie Swaine of Hadley (west region).
