
## POW-MIA chair at Lawrence Stadium honoring Alex Jimenez

## Policía de Methuen homenajea a tres como oficiales del año

El Alcalde Stephen N. Zanni y el Jefe de Policía Joseph Solomon se complacieron en anunciar que tres oficiales de la policía de Methuen han sido nombrados como los oficiales de policía del año por el Methuen Exchange Club.

Los agentes de la policía de Methuen Shawn Tardif, Brian Hellman y Kenneth Pilz fueron honrados en un banquete de premios en Merrimack Valley Golf Club el martes, 14 de noviembre por ir más allá del deber durante un incendio en un edificio de apartamentos el año pasado.

Justo después de las 2 a.m. del 12 de noviembre de 2016, el oficial Tardif estaba de patrulla de rutina cuando notó una gran cantidad de humo espeso procedente del área de Park Street. Los oficiales Pilz y Hellman respondieron para ayudar a identificar la fuente del humo.

Cuando el oficial Pilz se acercó a Methuen Square, pudo ver que el edificio de apartamentos ubicado en 2 Pleasant St. estaba totalmente envuelto en llamas. El oficial Pilz notificó al despacho que había un incendio en esta dirección y de inmediato se acercó a la residencia y comenzó a abrir las puertas del edificio.

Varios residentes dentro del edificio

todavía estaban durmiendo y tuvieron que ser despertados por los tres oficiales que fueron a cada apartamento para asegurarse de que todos salieran del edificio de manera segura. Estos oficiales también evacuaron a todos los residentes que vivían en el edificio vecino, 4 Pleasant St., por exceso de precaución.

Después de que todos salieron de ambos edificios de manera segura, los oficiales Tardif, Hellman y Pilz hicieron arreglos para tener un refugio en la calle dentro de Red Tavern, donde los residentes, muchos de los cuales dejaban sus casas con la ropa en la que habían estado durmiendo, podrían mantenerse abrigados.

"Estamos muy orgullosos de estos tres oficiales por sus esfuerzos para salvar decenas de vidas durante el incendio del año pasado", dijo el alcalde Zanni. "Nuestro Departamento de Policía de Methuen está formado por oficiales de primera categoría que continúan demostrando ese hecho a través de acciones como estas".

"Me gustaría felicitar a los tres oficiales por recibir este premio", dijo el Jefe Solomon. "Mostraron coraje y valentía para asegurarse de que cada persona y mascota estuviera a salvo de esos dos edificios, y no podría estar más orgulloso de ellos".

by the three officers who went to every apartment to ensure that everyone had safely exited the building. These officers also evacuated all residents who lived in the neighboring building, 4 Pleasant St., out of an abundance of caution.

After everyone was safely out of both apartment buildings, Officers Tardif, Hellman and Pilz arranged to have a shelter set up across the street inside of the Red Tavern where residents, many of whom left their homes in the clothes they had been sleeping in, could stay warm.

"We are so proud of these three officers for their efforts in saving dozens of lives during the fire last year," Mayor Zanni said. "Our Methuen Police Department is made up of top-notch officers who continue to prove that fact through actions such as these."

"I would like to congratulate all three officers for receiving this award," Chief Solomon said. "They displayed courage and bravery in making sure that every single person and pet was safely out of those two buildings, and I couldn't be more proud of them."

Methuen Police Officers Shawn Tardif, Brian Hellman and Kenneth Pilz were honored at an awards banquet at the Merrimack Valley Golf Club on Tuesday, Nov. 14 for going above and beyond the call of duty during an apartment building fire last year.

Just after 2 a.m. on Nov. 12, 2016, Officer Tardif was on routine patrol when he noticed a large amount of thick smoke coming from the Park Street area. Officers Pilz and Hellman responded to help identify the source of the smoke.

When Officer Pilz approached Methuen Square he could see that the apartment building located at 2 Pleasant St. was fully engulfed in flames. Officer Pilz notified dispatch there was a working fire at this address and immediately approached the residence and began kicking open doors in the building.

Several residents inside the building were still sleeping and had to be woken up

### ¿Cómo celebra su día de Acción de Gracias?

El Día de Acción de Gracias traza sus orígenes a una celebración en 1621 en la Plantación de Plimoth, en Plymouth, Massachusetts, donde los colonizadores de Plymouth celebraron la fiesta de la cosecha después de un período de crecimiento exitoso. Esto se continuó en los últimos años, primero como una práctica religiosa improvisada, y más tarde como una tradición civil.

La primera fiesta de Acción de Gracias duró tres días con alimentos suficientes para 53 peregrinos y 90 americanos nativos. El menú consistió en aves de corral, carne de venado, pescado, langosta, almejas, bayas, frutas, calabaza, remolacha y pavo.

Después de que Estados Unidos obtuvo su independencia, el Congreso recomendó un día anual de acción de gracias común para toda la nación para celebrar y mostrar gratitud, estableciendo el día de Acción de Gracias el cuarto jueves del mes de noviembre de cada año.

De acuerdo con Hispanic News, publicado por JonGarrido.com, el legado de Acción de Gracias pertenece a los estadounidenses de origen hispano.

En un artículo publicado el 23 de noviembre de 2005 por St. Augustine Catholic, una publicación de la Diócesis Católica de San Agustín, Florida y reproducido por Hispanic News dice que "En Massachusetts, Michael Gannon dijo que a él se le conoce como El Grinch que robó Acción de Gracias."

Gannon, un profesor de historia de la Universidad de la Florida, insiste en que fue un grupo de exploradores españoles y no los peregrinos los que celebraron por primera vez el Día de Acción de Gracias en el Nuevo Mundo. "La fecha fue el 8 de septiembre de 1565, en St. Augustine, Florida, cuando Pedro Menéndez de Avilés y 800 colonos españoles, celebró una misa de acción de gracias e invitó a la tribu nativa Seloy que ocupaban el sitio", dijo.

"Fue el primer acto religioso comunitario de Acción de Gracias en el primer asentamiento europeo permanente en la tierra", escribió Gannon en su libro de 1965, "La Cruz en la Arena." Los peregrinos no tuvieron su primera cena de Acción de Gracias hasta 1621, 56 años después.

Menéndez y sus seguidores, probablemente cenaron cocido - un guiso de cerdo salado y garbanzos y mezclado con condimentos a base de ajo - galletas duras de mar y vino tinto", dijo Gannon.

Este año, celebramos un día más de Acción de Gracias. No importa si en su mesa hubo pavo o cocido. Lo importante es que haya tenido un día feliz, en unión de los suyos.

### How do you celebrate your Thanksgiving?

Thanksgiving Day traces its origins to a celebration in 1621 at the Plimoth Plantation, in Plymouth, Massachusetts, where the Plymouth settlers celebrated the harvest party after a period of successful growth. This was continued in recent years, first as an impromptu religious practice, and later as a civil tradition.

The first Thanksgiving feast lasted three days with enough food for 53 pilgrims and 90 Native Americans. The menu consisted of poultry, venison, fish, lobster, clams, berries, fruits, pumpkin, beetroot and turkey.

After the United States gained its independence, Congress recommended an annual day of common thanksgiving for the entire nation to celebrate and show gratitude, setting the day of Thanksgiving on the fourth Thursday of the month of November of each year.

According to Hispanic News, published by JonGarrido.com, the Thanksgiving legacy belongs to Americans of Hispanic origin.

In an article published on November 23, 2005 by St. Augustine Catholic, a publication of the Catholic Diocese of St. Augustine, Florida and reproduced by Hispanic News says that, "In Massachusetts, Michael Gannon said that he is known as The Grinch who stole Thanksgiving."

Gannon, a history professor at the University of Florida, insists that it was a group of Spanish explorers and not pilgrims who celebrated Thanksgiving in the New World for the first time. "The date was September 8, 1565, in St. Augustine, Florida, when Pedro Menendez de Aviles and 800 Spanish settlers held a mass of thanksgiving and invited the native Seloy tribe that occupied the site," he said.

"It was the first religious community act of Thanksgiving in the first permanent European settlement on earth," Gannon wrote in his 1965 book, "The Cross in the Sand." The pilgrims did not have their first Thanksgiving dinner until 1621, 56 years later.

Menendez and his followers probably dined *cocido* - a stew of salted pork and chickpeas and mixed with garlic-based condiments - hard sea biscuits and red wine," said Gannon.

This year, we celebrate one more Thanksgiving Day. It does not matter if there was turkey or *cocido* on your table. The important thing is that you all had a happy day, together surrounded by family.





# Celebrating National Adoption Day

## New lives, new families

Coffee, bagels, fruits and teas were being passed around. Children laughed, yelled, and played amongst each other while the occasional toddler worked the crowd, attracting attention while bumping into the legs of the many parents, social workers, attorneys, and judges who all worked together to prepare the children for a new tomorrow as the National Adoption Day ceremony was being recognized in their honor.

The sun penetrated through the transparent glass windows around the third floor of the judicial atrium at the Fenton Judicial Center on 2 Appleton Street, where the judges gathered round the podium, the flags of the United States and Massachusetts drooping behind them.

This past Friday, November 17, was National Adoption Day; a day where, for many children, mark the beginning of their lives.

"We [judges] just sign documents to make everything official, if you will," said Mary Anne Sahagian, a Family and Probate Judge for Essex County—the first female justice to service in this position. "But even before signing anything, you are all a family."

Soon-to-be adoptive parents from different perspectives and different walks of life came together to contribute to the lives of children who were once devoid of hope and a better tomorrow.

Chief Justice Mark Newman honored the parents who looked past the histories and traumas of the children they've chosen to accept into their homes. Judge Newman

even took a moment to congratulate the same-sex parents who were present at the event for their contribution to adopting and building strong parental foundations and lines of support for their children. "Same-sex couples have done a major contribution to adoptive community," he said.

The event was considered a success. Not in so much because the event attracted a large crowd of professionals who work day in and day out to better the lives of children. It was all a success because new lives were established as children who were once never considered for a second opportunity in the first place were accepted in a new home occupied by people who are ready to familiarize new members of the family with the family love they've given to their own.

It's a day to remember for many—even for the staff who helped put it all together. "We worked together, as a family. DCF, the judges, the Clerk's Office,

maintenance, Probation... we all made this event happen for the new families," said Grisel Lind, the judicial receptionist at Fenton. "We put it all together, but it wasn't us who made it successful. It was the children."

## My Philosophy and 3 Ways of Speaking so that WCEC 1490 would listen

### Creating a precedent

1. When you finally realize that it does not benefit Danny Rivera and it does not benefit William Lantigua that a media censors the freedom of the communicator, you will understand my philosophy.

2. When you understand that only by defending the right of others to express themselves, you guarantee your own right of expression, you will begin to understand my philosophy.

3. When you look at your job, your car payment, the mortgage, your bank account, your social position, your religion or belief, your prizes and diplomas, your children, your own respect, you will notice that they are represented on paper. That clean or wrinkled paper, old or new REPRESENTS your voice, the foundation of the so-called REPRESENTATIVE Democracy and it is not by whim that it is called like that. Your first right in the USA is that and it is guaranteed by the Constitution. All your other rights come from that right.

4. IN THE CASE OF THE STATION 1490 INTERFERING IN THE PROGRAMMING ON NOVEMBER 6 AND 7; SHOULD NOT BE TOLERATED NOT JUST FOR BEING AN INJUSTICE, IT IS MY FIRM BELIEVE THAT IT SHOULD NOT BE TOLERATED FOR BEING BOTH ILLEGAL AND IGNORANT. That a few people pretend that this ignominy benefits them, deserves much less attention than the importance of the precedent that we are already creating

to face or avoid that it happens again.

From this point on, I identify more with Altagracia Mayí's idea of creating a precedent.

5. Why so much noise over only two days of closure? Some of you would say. This is "Communication 101". The timing of the closing only aggravates the closing itself. Example: Donald Trump, the President of the United States, had his personal Twitter account closed for 11 minutes. Many were happy. Leaving joy aside and politics out; that is censorship. Period!

6. Another form of censorship: The Eagle-Tribune would interpret as a censure that a single person, suddenly bought all the copies of Monday's newspaper and kept them, preventing the public from reading them.

7. It is not to be debated that some programs at 1490 have very low standard, indeed. Nor is it debated that certain programs are inclined to support one candidate more than another. The radio has minimal criteria and allows for that. But since we are not in a dictatorship, it is the listener, the user who decides who pays attention. If you understand that my intention is not to decide what or who you listen to, but that you decide whether or not you want to do it, then you will understand my philosophy particularly because I do not have a program at 1490 AM.

8. They say that freedom of the press only exists for those who own media. There are

editors and publishers in the Merrimack Valley, who from time to time look the other way. They censor the news for unclear reasons. Sometimes they publish – and this is true - press releases and pictures that are painful to see. More than filling space, they are aware that the surest means of improving communication is practicing, professionalizing all of us and opening up more means of communications.

Con esto en mente, María busca recetas que se ajusten y ofrece opciones a sus alumnos para que ellos elijan. A lo largo del semestre, los estudiantes comienzan a ofrecer sus propias ideas, y María buscará las recetas correspondientes.

Este enfoque es simple, pero María dice que es esencial para asegurar que sus estudiantes sean curiosos y comprometidos. Al otorgarles autoridad para tomar decisiones, aprenden el poder de su elección y su voz. En Groundwork, nuestro objetivo es desarrollar a los líderes

del mañana. Darle a los jóvenes el poder y las habilidades para tomar decisiones saludables los conduce a un camino de salud y éxito para toda la vida. Este es el núcleo de cada programa educativo exitoso que ofrece Groundwork.

Otro gran socio, Lawrence High School, se acercó a nosotros al mismo tiempo, buscando incluirnos en sus nuevos programas Early College y Career Pathways, que tienen como objetivo preparar a la próxima generación para la fuerza de trabajo cambiante. ## Growing Minds, Cultivating Change

Last spring, the Lawrence Boys and Girls Club approached Groundwork Lawrence with an exciting opportunity. They asked GWL if they could expand their programming to include a nutrition class for the next school year. With quick mulling, we knew students would love learning in a Maria Kitchen.

Now, on Wednesdays, Guilmette Middle School students enjoy a nutrition class at the club with María, our Healthy Living Programs Manager. María has been teaching healthy cooking classes for adults at Groundwork for years, and relishes the chance to take her model and adapt it for her "smaller people." A María Kitchen buzzes with energy as students center on a mixing bowl, or cutting board, or try a hesitant spoonful, all while she smiles and coaxes out each child's inner chef.

Maria approaches each lesson with three things in mind:

1. Nutrition is key
2. Youth lead decision-making
3. A curious taster makes a seasoned chef

With these in mind, María searches for recipes that fit and offers options to her students for them to choose. Through the semester, students begin offering their own ideas, and María will look for matching recipes.

This approach is simple, but María says it's essential to ensuring her students are curious and engaged. By giving them decision-making authority, they learn the power of their choice and voice. At Groundwork, our goal is to develop tomorrow's leaders. Giving youth the power and skills to make healthy choices leads them on a pathway of lifelong health and success. This is the core to every successful education program Groundwork offers.

Another great partner, Lawrence High School, approached us around the same time, seeking to include us in their new Early College and Career Pathways programs, which aim to make the next generation prepared for the changing workforce. They asked us to lead sessions in a variety of fields, including public health, urban planning, and environment. We knew our approach to education and youth development would work wonderfully with Lawrence High School students. However, this new opportunity didn't have funding for program development or implementation.

# MCC's \$1.3 Million Math/Science TRIO Grant Targets LHS Students

Middlesex Community College has been awarded a five-year, \$1.3 million Upward Bound Math & Science TRIO program grant from the U.S. Department of Education to strengthen the math and science skills of participating Lowell High School students.

MCC's TRIO Upward Bound Math and Science (UBMS) program will provide participating students with a comprehensive and coordinated array of academic instruction, support and advising services, explained Colleen Winn, Director of MCC's Pre-Collegiate TRIO Program and GEAR UP Massachusetts.

"The goal of the program is to help students recognize and develop their potential to excel in math and science, and to encourage them to pursue post-secondary degrees in math and science – and ultimately careers in STEM (science, technology, engineering and math) professions," said Winn.

"The jobs of the future require a STEM education, so enabling more high school students to engage in math and science education will help prepare them for success at the college level and beyond," added U.S. Congresswoman Niki Tsongas.

"Using federal funds such as these to partner with local institutions to address the needs of the region, is a key tool in ensuring all people have the opportunity to pursue higher education. MCC exemplifies

the growing trend of Third District institutions becoming both academic and community leaders," said Tsongas. "I look forward to seeing the far-reaching impact of this funding take hold."

UBMS will target 60 TRIO-eligible low-income, first-generation LHS students with coordinated services, including individualized case management; and advising to ensure students enroll in courses comprising rigorous programs of study (including dual-enrollment courses), according to Winn.

Special services will also include individual and group tutoring; exposure to research in STEM fields; and workshops on academic skills, test preparation, financial literacy, and the college- and financial-aid application processes, she said.

Students will be required to participate in after-school and Saturday academic enrichment programs, and a six-week summer academic program focusing on STEM disciplines, Winn added. Also as part of the UBMS summer programming, students will have the opportunity to experience a one-week overnight trip to regional colleges throughout New England. Additionally, UBMS will provide college and cultural field trips.

Twice a week, Middlesex Community College Hospitality Management - Culinary Arts students can be found whisking, sautéing, baking and braising in UTEC's new 5,000 square-foot commercial kitchen in downtown Lowell.

They are playing musical chairs at the local, state and federal levels. Juana Matías hasn't gotten her feet wet and she wants to move up. Pavel Payano has not been sworn in as a city councilor and has announced that he'll be a candidate for State Senate (again) having lost to Barbara L'Italien who believes she can replace Niki Tsongas in Congress, just like Matías aspires to. If Payano loses the Senate race, his position in the Council is secured.

If Juana decides to run, she'll leave the doors open for Marcos Devers returning


# NECC Hosts Seasonal Luncheon

# NECC Presents Neil Simon Classic Comedy



Gardony's latest CD, "Serious Play,"


released in July, received four-star reviews in Downbeat and Jazz Journal.
