Esta pequeña ciudad es conocida por tener atletas notables, pero la gente generalmente piensa en el baloncesto, el voleibol o el béisbol. Nuestro campeón destacado es un estudiante de Andover High School, Elias Maita, campeón estatal de lucha libre de la División 1 que ha estado entrenando durante los últimos dos años con el club Firepit Wrestling.

El club Firepit Wrestling se inició hace siete años por Alexander Vargas, un bombero de Lawrence que trabaja en Engine 7 en Park St. Alex comenzó su entrenamiento mientras estudiaba en la Escuela Técnica de Greater Lawrence y más tarde en la Universidad Estatal de Bridgewater. Al ingresar al ejército de los EE.UU., continuó su amor por el entrenamiento deportivo con los militares, llevando su conocimiento a Lawrence High School como entrenador asistente. Alex recibió tanto apoyo de los bomberos que decidió tomar el examen y se unió a sus filas hace unos años.

Cuando comenzó su club, había unos diez luchadores y estaban recibiendo capacitación, uniformes y equipos de forma gratuita gracias a algunas donaciones que recibían. Hoy, el grupo ha crecido a más de 100 y están solicitando una tarifa de \$100 para cubrir los gastos, lo cual es una gana teniendo en cuenta que otras ciudades requieren \$300 por estudiante. Es por eso que los jóvenes de las ciudades y pueblos de los alrededores se están uniendo al club Firepit Wrestling; no son exclusivamente lawrencianos.

Su reputación ha crecido tanto que los atletas conocidos de diferentes disciplinas y artistas se han ofrecido para brindar charlas

inspiradoras al grupo sin costo alguno para ellos. Algunos son entrenadores olímpicos tales como Matt Smith, Dylan Palacio, Sobhan Soap Namvar, Donald McNeil, Corey Jantzen y Zach Bridson

El único inconveniente es no tener un lugar permanente para entrenar. Lawrence High School está comprometida con dos meses al año y luego tienen que encontrar otro lugar, pero a Alex le gustaría poder hacerlo durante todo el año.

Alex aprecia mucho la ayuda que siempre ha recibido de los entrenadores Matt Armano, entrenador asistente de Central Catholic High School y Michael Mena, entrenador asistente de Lawrence High School.

Están viendo los resultados de sus esfuerzos de voluntariado porque Elias Maita no fue el único ganador. Luis Mauricio quedó en 3er lugar y John Vasquez, en 4to en la División 1.



# Frank Bonet solicita que el Concejo Municipal cambie el Día de Colón al Día de los Pueblos Indígenas



El 27 de febrero de 2020, Frank Bonet presentó una solicitud, al Concejo Municipal de Lawrence, para cambiar el Día de Colón a el Día de los Pueblos Indígenas. Al solicitar este cambio como lo solicitan los pueblos indígenas para defender la verdad en la historia y reconocer las atrocidades que han sobrevivido como resultado de la colonización.

"Quiero que Lawrence se una a la lista de cientos de ciudades y docenas de estados para reconocer a los pueblos indígenas en lugar del Día de Colón. El Día de Colón fue elegido oficialmente como feriado federal en 1937, a pesar del hecho de que Colón no descubrió América del Norte, a pesar del hecho de que millones de personas ya vivían en América del Norte a su llegada a América, y a pesar de que Colón nunca pisó las costas de los Estados Unidos actuales."

Al hablar de Colón, debe tenerse en cuenta que este supuesto héroe fue un invasor en tierras indígenas y causó daños irreparables a través de la eliminación, explotación y actos inimaginables de abuso físico, mental y sexual que él y sus hombres infligieron a los habitantes originales de lo que llegaría a ser conocido como el Nuevo Mundo. Cristóbal Colón inició el comercio transatlántico de esclavos. La trata de esclavos nativos americanos de Colón se

transformó en la trata de esclavos africanos a mediados del siglo XVI. Además, hacer referencia a los Estados Unidos como una nación de inmigrantes borra no solo a los pueblos indígenas, sino también la historia de la esclavitud y la explotación económica.

## Frank Bonet requests City Council change Columbus Day to Indigenous Peoples Day

On February 27, 2020, Frank Bonet submitted a request, to the Lawrence City Council, to change Columbus Day into Indigenous People's Day. In requesting this change as called for by Indigenous Peoples to uphold truth in history and recognize the atrocities they have survived as a result of colonization.

"I want Lawrence to join the list of hundreds of cities and dozens of states in recognizing Indigenous People in place of Columbus Day. Columbus Day was officially chosen as a federal holiday in 1937, despite the fact Columbus did not discover North America, despite the fact millions of people were already living in North America upon his arrival to the Americas, and despite the fact Columbus never set foot on the shores of the current United States."

When discussing Columbus, it should be noted that this so-called hero was an invader upon Indigenous lands and caused irreparable damage through the removal, exploitation and unimaginable acts of physical, mental and sexual abuse he and his men inflicted upon the original habitants of what would become to be known as the New World. Christopher Columbus initiated the trans-Atlantic slave trade. Columbus's Native American slave trade morphed into

the African slave trade by the mid-16th century. Furthermore, referencing the United States as a nation of immigrants erases not only Indigenous Peoples but the history of chattel slavery and economic exploitation.

### ¡Por favor, el 3 de marzo, salga a votar!

Tradicionalmente, muchas personas en los Estados Unidos no salen a votar en Marzo durante las Elecciones Primarias para la Presidencia por no considerarlas tan importantes como las Elecciones Finales de noviembre.

Lo cierto es que éstas son aún más significativas que las Elecciones Finales ya que los votantes tienen la oportunidad de escoger a su candidato preferido en cada partido político y dependiendo de los resultados de las primarias, su candidato favorito puede o no, quedar eliminado.

Si no tiene un candidato de su predilección, no está obligado a escoger el que otra persona le indique. Su deber como ciudadano es educarse sobre quiénes son los candidatos y qué es lo que prometen. Analice si tiene sentido lo que ofrece ya que no han sido claros en cuanto a cómo van a pagar por lo que proponen.

Si aún después de estar escuchándolos por meses no se ha decidido, preséntese en el colegio electoral y de su nombre. Casi tan importante como llenar la boleta electoral es que su nombre quede plasmado en el registro de votantes. Esta es la oportunidad para los ciudadanos de habla española de ser contados donde realmente cuenta: en las urnas electorales.

En Lawrence, no significa nada que seamos la mayoría en números si no cumplimos con nuestra obligación de votar.

### Please, on March 3, go out to vote!

Traditionally, many people in the United States do not vote in March during the Primary Elections for the Presidency because they are not considered as important as the November Final Elections.

The truth is that these are even more significant than the Final Elections, since voters have the opportunity to choose their preferred candidate in each political party, and depending on the results of the primaries, their favorite candidate may or may not be on the ballot.

If you do not have a candidate of your choice, you are not required to choose the one indicated by another person. Your duty as a citizen is to educate yourself about who the candidates are and what they promise. Analyze if it makes sense what they offer since they have not been clear as to how they will pay for what they propose.

If even after listening to them for months, you have not made a decision, go to the polling station and give them your name. Almost as important as filling out the ballot is that your name is reflected in the voter registry. This is the opportunity for Spanish-speaking citizens to be told where it really counts: at the polls.

In Lawrence, it means nothing that we are the majority in numbers if we do not fulfill our obligation to vote.

## ¿Debemos preocuparnos por COVID-19?

Por doquier vemos noticias sobre el coronavirus alarma al público. Los casos están aumentando en los Estados Unidos y algunas publicaciones aconsejan cómo prevenirlo.

Las noticias de NBC dijeron en parte que los líderes empresariales deberían comenzar a considerar qué empleados podrían trabajar desde su casa. Quizás llegue el momento al igual que otros expertos dijeron que observar las prácticas y ceremonias religiosas en el hogar, en lugar de asistir a reuniones comunitarias más grandes en lugares de culto, sería una buena idea. También, las familias deberían comenzar a preguntarse cómo manejarían una o dos semanas en casa, sin tener que viajar distancias cortas en busca de comida, medicamentos o entretenimiento.

Para mí, eso suena alarmante, pero teniendo en cuenta el riesgo, es un buen consejo. Si planea obtener una máscara, no se moleste. No hay ninguna en ninguna farmacia o cadena de tiendas y una vacuna tardará más de un año en perfeccionarse para la dispensación humana.

Mientras tanto, el único reconocimiento que hemos escuchado de los funcionarios de nuestra ciudad es que Lawrence tiene un riesgo bajo. Aunque pienso que no hay nada de malo en prepararse para lo peor.

Nancy Messonnier, directora del Centro Nacional de Inmunización y Enfermedades Respiratorias de los CDC indicó que los padres/tutores de los estudiantes deben preguntar a las escuelas de sus hijos sobre los planes de cierre asociados con la posibilidad de propagación del coronavirus a nuestra comunidad. Advirtió que espera

que el coronavirus que ha provocado brotes en todo el mundo comience a propagarse a nivel comunitario en los Estados Unidos, ya que un alto funcionario dijo que las interrupciones en la vida diaria podrían ser graves.

¿Existe un plan o los padres/tutores tomarán la iniciativa de no enviar a un estudiante a la escuela al saber del primer caso que ocurra en Lawrence?

Hay un artículo muy informativo del Departamento de Salubridad de Massachusetts en la página 13 con información sobre prevención que le recomiendo que lea.

El verano pasado, MassHire publicó un puesto de director asistente e inmediatamente me pregunté quién será el afortunado amigo del Alcalde Danny. El requisito era una licenciatura y el salario en los \$60,000. Aparentemente, había tantas personas bien calificadas que optaron por cancelar la búsqueda con la excusa de "no tener la financiación".

Me decepcionó porque tenía que haber algo más detrás y, efectivamente, en noviembre se creó una nueva posición. El Coordinador de Alcance también tenía el requisito de licenciatura y un salario de alrededor de \$50,000. Hubo algunos solicitantes entrevistados y adivine quién fue elegido. ¡Wendy Luzón! La graduada de la secundaria que mintió en el pasado acerca de tener un título universitario.

El puesto fue creado para ella y el trabajo de director asistente todavía está vacío. Apuesto a que pronto será ascendida.

Además, el Concejo Municipal de Lawrence aconsejó al alcalde que no transfiriera a Lourdes Alvarado, la coordinadora de elecciones bilingüe al Departamento de Agua hasta después de las próximas elecciones.

Sí, obtuvo un ascenso y un trabajo seguro con protección de la SEIU.

En enero, el alcalde inventó el plan de la transferencia y publicó el puesto en el Departamento de Elecciones el 27 de enero. Esto creó un gran problema para el secretario municipal Bill Maloney porque la ciudad está bajo el mandato del Secretario de Estado de tener un mínimo de cuatro empleados en el Departamento de Elecciones.


Afortunadamente, el Concejo detuvo la transferencia hasta después de las elecciones del 3 de marzo.

# La vacuna contra zóster también puede reducir el riesgo de sufrir accidentes cerebrovasculares

Conferencia internacional sobre los accidentes cerebrovasculares de la American Stroke Association: presentación del póster TP493

### Aspectos destacados de la investigación:

Zóster, una infección vírica causada por el virus de la varicela, se relaciona con un mayor riesgo de sufrir un accidente cerebrovascular. Un nuevo estudio descubrió que la vacuna viva contra zóster, un tipo de vacunación contra zóster, puede evitar que algunos adultos mayores sufran un accidente cerebrovascular, de acuerdo con la investigación preliminar que se presentará en la "Conferencia internacional sobre los accidentes cerebrovasculares 2020" de la American Stroke Association del 19 al 21 de febrero, en Los Ángeles, una reunión mundial de primer nivel para investigadores y médicos dedicados a la ciencia de los accidentes cerebrovasculares y la salud cerebral.

Más del 99% de las personas de 40 años o más en Estados Unidos portan el virus inactivo de la varicela, también conocido como el virus varicela-zóster. Zóster es una reactivación del virus de la varicela y, por lo general, ocurre después de los 50 años. El riesgo de presentar zóster, una afección dolorosa que provoca ampollas en la piel y que puede tener complicaciones graves,

aumenta con la edad y otros estados de salud.

"Una de cada tres personas que han tenido varicela presentan zóster en su vida", dijo Quanhe Yang, Ph.D., autor principal del estudio e investigador senior en los Centros para el Control y la Prevención de Enfermedades (CDC, por sus siglas en inglés) en Atlanta, Georgia. "La vacuna viva contra zóster ayuda a prevenir zóster y reduce el riesgo de zóster en aproximadamente un 51%. Sin embargo, su efecto disminuye con el aumento de la edad, alrededor de un 64% en las personas de 60 a 69 años; alrededor de un 41% en personas de entre 70 y 79 años, y alrededor de un 18% en personas de 80 años o más".

Para ayudar a determinar si la vacuna contra zóster reduce el riesgo de accidente cerebrovascular, Yang y colegas revisaron los registros médicos de Medicare de más de un millón de beneficiarios de pago por servicio de Medicare, de 66 años o más, que no tenían antecedentes de accidente cerebrovascular y que recibieron la vacuna viva contra zóster entre el 2008 y el 2014, y los siguieron por un promedio de casi cuatro años. Ese grupo se emparejó con el mismo número de beneficiarios de la

tarifa por servicio de Medicare que no recibieron la vacuna contra zóster con el mismo seguimiento de cuatro años. Para examinar el efecto de la vacuna sobre el riesgo de accidentes cerebrovasculares, los investigadores controlaron la edad, el género, la raza, los medicamentos y las afecciones de salud coexistentes.

Los investigadores determinaron lo siguiente:

La recepción de la vacuna contra zóster redujo el riesgo de accidente cerebrovascular en aproximadamente un 16%, redujo el riesgo de accidente cerebrovascular isquémico (causado por coágulos) en aproximadamente un 18% y redujo el riesgo de accidente cerebrovascular hemorrágico (sangrado) en aproximadamente un 12%.

La protección de la vacuna fue más fuerte entre las personas de entre 66 y 79 años.

Entre aquellos menores de 80 años, la vacuna contra zóster redujo el riesgo de accidente cerebrovascular en casi un 20% y, en los de más de 80 años, redujo el riesgo en aproximadamente un 10%.

"La razón del mayor riesgo de accidente

cerebrovascular después de una infección por zóster puede deberse a la inflamación causada por el virus", según Yang.

"Aproximadamente un millón de personas en Estados Unidos sufre de zóster cada año, aunque hay una vacuna para ayudar a evitarlo", dijo Yang. "Los resultados del estudio pueden alentar a las personas de 50 años o más a seguir la recomendación y recibir la vacuna contra zóster. Reduce el riesgo de sufrir zóster y, al mismo tiempo, podría reducir el riesgo de sufrir un accidente cerebrovascular".

Este estudio se realizó cuando la única vacuna contra zóster era la vacuna viva contra zóster (disponible desde el 2006). La vacuna más reciente contra zóster, la vacuna recombinante no viva adyuvante contra zóster (disponible desde el 2017), confiere aún mayor protección y ahora es la vacuna preferida recomendada por el Comité Asesor sobre las Prácticas de Inmunización de los CDC. Dos dosis de vacuna recombinante no viva adyuvante contra zóster tienen una efectividad superior al 90% para prevenir zóster y se recomienda para adultos de 50 años o más.

# Hermanas de Notre Dame de Namur y de Presentation of Mary anuncian compra de cinco edificios escolares de PMA

Lawrence, MA/Methuen, MA—Las Hermanas de Notre Dame de Namur (SNDdeN) y las Hermanas de la Presentación de María anunciaron hoy que se han iniciado los procedimientos formales para el Colegio Secundario Notre Dame Cristo Rey (NDCR) patrocinada por SNDdeN para comprar los edificios escolares de la Academia de la Presentación de María (PMA) en Methuen. La sección del colegio del antiguo Searles Estate consta de 5 edificios, aproximadamente 5 acres de una propiedad de más de 24 acres que las Hermanas están vendiendo. Luego de haber proporcionado una educación católica para familias de Methuen y sus alrededores durante 60 años, ambas órdenes religiosas llegaron a un acuerdo inmediato de que NDCR, que ha estado buscando expandir el espacio y alcanzar su propia comunidad de colegio secundario, sería la opción perfecta para comprar los edificios escolares y llevar a cabo la misión de la educación católica en ese lugar.

“Las Hermanas de la Presentación de María no podrían estar más felices de recibir a las Hermanas de Notre Dame y su increíble comunidad escolar en nuestro campus” dijo la Hna. Helene Cote, Provincial de las Hermanas de la Presentación de María. “Como uno puede imaginar, ha sido y es un momento muy difícil para nosotros mientras nos preparamos para cerrar nuestro propio colegio después de tantos años. Durante esta transición deseamos permitir la gran misión de educación católica a los jóvenes a través del currículo de preparación universitaria

y profesional del Colegio Superior Notre Dame Cristo Rey”.



This small city is known for having remarkable athletes but people usually think of basketball, volleyball or baseball. Our featured champion is Elias Maita an Andover High School senior Division 1 State Champion of wrestling who has been training for the past two years with Firepit Wrestling club.

Firepit Wrestling club was started seven years ago by Alexander Vargas, a Lawrence Firefighter working out of Engine 7 on Park St. Alex started training while a student at Greater Lawrence Technical School and later at Bridgewater State University. Upon entering the U.S. Army, he continued his love for the sport training with the military, bringing his knowledge to Lawrence High School as assistant coach. Alex received so much support from firefighters that decided on taking the exam and joined their ranks a few years ago.

When he started his club there was about ten wrestlers and they were getting the training, uniforms and equipment free of charge thanks to some donations they received. Today, the group has grown to over 100 and they are requesting a \$100 fee to cover expenses which is a bargain considering that other towns require \$300 per student. That is why youngsters from surrounding cities and towns are joining the Firepit Wrestling club; they are not exclusively Lawrencians.

Their reputation has grown so much that well-known athletes of different disciplines and artists have volunteered to bring inspirational talks to the group at no

cost to them. Some of them are Olympic coaches such as Matt Smith, Dylan Palacio, Sobhan Soap Namvar, Donald McNeil, Corey Jantzen and Zach Bridson.

The only drawback is not having a permanent place to train. Lawrence High School is committed to two months out of the year and then they have to find another location but Alex would like to be able to do it year round.

Alex is very appreciative of the help he has always received from Coaches Matt Armano, assistant coach at Central Catholic High School and Michael Mena, Lawrence High School assistant coach.

They are seeing the results of their volunteering efforts because Elias Maita was not the only winner. Luis Mauricio came in 3rd place and John Vasquez 4th in Division 1.

## Sisters of Notre Dame de Namur and Sisters of the Presentation of Mary Announce Formal Proceedings Have Begun for NDCR Purchase of Five PMA School Buildings on Searles Estate

Lawrence, MA/Methuen, MA – The Sisters of Notre Dame de Namur (SNDdeN) and the Sisters of Presentation of Mary announced today that formal proceedings have begun for the SNDdeN sponsored Notre Dame Cristo Rey High School (NDCR) to purchase Presentation of Mary Academy's (PMA) school buildings in Methuen. The school section of the former Searles Estate consists of five buildings, approximately 5+acres of a 24+ acre property which the Sisters are selling. Having provided a Catholic education for families in and around Methuen for 60 years, both religious orders fell into immediate agreement that NDCR, who has been looking to expand space and reach for its own high school community, would be the perfect fit to purchase the school buildings and carry on the mission of Catholic education at this location.

"The Sisters of Presentation of Mary could not be happier to welcome the Sisters of Notre Dame and their incredible school community onto our campus," said Sr. Helene Cote, Provincial of the Sisters of Presentation of Mary. "As one can imagine, it has been and is a very difficult time for us as we prepare to close our own school after so many years. To allow the greater mission of Catholic education and identity to the youth in this area through Notre Dame Cristo Rey High School's college and career readiness

curriculum is exactly what we would want in this transition."

As part of NDCR's current five-year strategic plan, the SNDdeN Corporate Members, the Board of Directors, and the NDCR school leadership team spent the last few years researching the possibility of a new location for its entire school community. Limited in space, increased financial concerns at its current location and the inability to address the demands of enrollment, the Sisters of Notre Dame de Namur engaged in conversation with the Sisters of Presentation of Mary when news broke about them closing the school.

"While our hearts are heavy with the knowledge that Presentation of Mary Academy will be closing at the end of this school year, God has provided an opportunity for our school communities to turn a difficult situation into one of promise and hope," said Sr. Maryalyce Gilfeather, President of Notre Dame Cristo Rey High School. "So many of our friends in the community, our families, our students and even our alumni reached out to me about the possibility of purchasing PMA, knowing of its availability and size. To say we have the support of so many individuals on this move is an understatement."

The Sisters of Notre Dame de Namur, who have served the community of Lawrence

for over 160 years, are no strangers to the Methuen community as they also established and staffed Saint Monica School in 1958. The Sisters have been a constant and dedicated presence by educating local children and their families and spreading Catholic identity to both communities. Through Notre Dame Cristo Rey's Corporate Work Study Program, students from NDCR work in several Lawrence organizations as well as St. Monica's School and other Methuen organizations and businesses. The ability to continue serving both communities with more physical space to grow means more opportunities for more students and their families.

With a signed purchase and sales agreement between the two Religious Congregations, proceedings now begin for the 120-day inspection process of the five school buildings to be purchased. When asked how likely it will be for NDCR to begin the 2020-2021 school year at the new location, Sr. Maryalyce replied, "Given the support of our Good God, the Sisters of the Presentation of Mary, our SNDdeN Corporate Members, Board of Directors, donors, faculty, staff, students and families, and ALL the prayers we have offered during this time, I am confident that we will be able to welcome our students to their new home. I cannot thank the Sisters of Presentation of

Mary enough for working with us to provide this opportunity of growth for our NDCR mission. And I am so very grateful to have the support of both Mayor Dan Rivera of Lawrence and Mayor Neil Perry of Methuen as we move forward – we are blessed!"

# IRS aumenta visitas a contribuyentes de altos ingresos que no han presentado declaraciones de impuestos

WASHINGTON—Como parte de un mayor esfuerzo para asegurar el cumplimiento y la equidad, el Servicio de Impuestos Internos anunció hoy que intensificará los esfuerzos para visitar los contribuyentes de altos ingresos que en años anteriores no presentaron oportunamente una o más declaraciones de impuestos.

Luego de la reciente y continua contratación de personal de cumplimiento, los oficiales de ingresos del IRS en todo el país aumentarán sus visitas a contribuyentes de altos ingresos que no hayan presentado declaraciones de impuestos en 2018 o años anteriores. Estas visitas están dirigidas principalmente a informar a estos contribuyentes de sus obligaciones de presentación y pago de impuestos, y lograr que cumplan con sus responsabilidades tributarias.

"El IRS está comprometido con la equidad en el sistema tributario, y queremos recordarles a las personas de todas las categorías de ingresos que deben presentar sus impuestos", dijo Paul Mamo, Director de Operaciones de Cobros de la División de Pequeñas Empresas/Trabajadores Independientes. "Queremos asegurarnos de que los contribuyentes conozcan sus opciones para hacer lo correcto con sus impuestos y evitar problemas mayores más adelante".

Para la temporada actual de impuestos, el IRS les recuerda a los contribuyentes que deben presentar su declaración de impuestos de 2019 antes de la fecha límite de presentación del 15 de abril, independientemente de si pueden pagar en su totalidad. Las prórrogas de presentación de seis meses también están disponibles, aunque eso no extiende la fecha límite de abril para pagar los impuestos adeudados.

"Los contribuyentes que tienen obligaciones de pago o presentación morosa deben consultar a un asesor tributario competente antes de esperar a que un oficial de ingresos del IRS se comunique con ellos. Siempre vale la pena aprovechar los diversos métodos para presentar o cumplir con el pago antes de ser contactado personalmente por el IRS."

Para las nuevas visitas realizadas, los contribuyentes con altos ingresos que no presentaron son aquellos que generalmente recibieron ingresos mayores de \$100,000 durante un año tributario y no presentaron una declaración de impuestos ante el IRS. Los contribuyentes que ejercen sus mejores esfuerzos para presentar sus declaraciones de impuestos y pagar o entrar en acuerdos

para pagar sus impuestos, merecen saber que el IRS persigue agresivamente a otros que no han cumplido con sus obligaciones de presentación y pago.

Durante las visitas, los funcionarios de cobro de impuestos del IRS compartirán información y trabajarán con el contribuyente para resolver el problema de impuestos.

## ¿Cómo pagar?

Hay muchas opciones de pago para aquellos que tienen problemas para pagar su factura de impuestos. Los planes de pago a menudo se pueden configurar rápidamente en línea.

Una vez que se presentan las declaraciones o se produce una evaluación, hay varias opciones de pago en línea disponibles en IRS.gov, incluida el pago directo a través de una cuenta bancaria o con una tarjeta de débito o crédito. Otras formas de pago incluyen el Sistema electrónico de pago de impuestos federales (mejor opción para negocios o pagos grandes; se requiere inscripción), retiro electrónico de fondos (durante la presentación electrónica), transferencia electrónica el mismo día (pueden aplicarse cargos bancarios), y cheque o giro postal o efectivo (en un socio minorista participante). Aquellos que no pueden pagar de inmediato pueden cumplir con su obligación tributaria en cuotas mensuales mediante la solicitud de un plan de pago (incluidos los acuerdos de cuotas y los que deben menos de \$50,000), averiguar si califican para un ofrecimiento de transacción (una manera de liquidar su deuda tributaria por menos del monto total), o solicitar que el IRS demore temporalmente el cobro hasta que mejore su situación financiera.

Para aquellos que se niegan a pagar, el IRS tiene una serie de opciones disponibles bajo la ley, que van desde una serie de acciones de cobro civil y, cuando sea apropiado, perseguir casos criminales contra los contribuyentes. El personal de cumplimiento del IRS también trabaja más estrechamente con los investigadores criminales del IRS en asuntos de cumplimiento prioritario, que incluyen casos de altos ingresos.

"Estas visitas de cumplimiento acentúan la importancia de que las personas presenten sus impuestos este mes de abril, incluso si no pueden pagar la totalidad de los impuestos adeudados," dijo Hank Kea, Director de Operaciones de Cobro en el Campo, División de Pequeñas Empresas/Trabajadores Independientes. "No presentar y pagar impuestos empeora con el tiempo

a medida que aumentan los intereses y las multas. Tenemos muchas opciones de pago disponibles en IRS.gov para ayudar a los contribuyentes. Es mejor trabajar con estos temas por adelantado en lugar de ignorarlo y únicamente, llegar al punto de que el IRS tome medidas más serias. Nuestro uso continuo de tecnología cambiante junto con personal adicional de cumplimiento de ley sugiere que esperar no es una opción viable para la mayoría de los contribuyentes morosos."

## ¿Cuáles es el trabajo de un funcionario de cobro de impuestos del IRS?

Los funcionarios de cobro de impuestos del IRS son empleados capacitados de la aplicación civil que trabajan para resolver problemas de cumplimiento, tales como declaraciones de impuestos no presentadas y impuestos adeudados. Los funcionarios de cobro de impuestos del IRS realizan entrevistas para recopilar información financiera y proporcionar a los contribuyentes los pasos necesarios para cumplir con la ley y continuar cumpliendo con ésta. Cuando sea necesario, tomarán las medidas apropiadas para cobrar la cantidad adeudada, mientras respetan los derechos de los contribuyentes y siguen la ley.

## No se confunda: las visitas no son una estafa

Para esta nueva iniciativa, estos contribuyentes de altos ingresos recibieron típicamente numerosas cartas del IRS por un periodo de tiempo extendido, por lo que

generalmente están al tanto de que tienen un problema de impuestos.

Las visitas de los funcionarios de cobro de impuestos del IRS no deben confundirse con estafas. Esto es lo que debe buscar:

- Mientras que la mayoría de las visitas de un funcionario de cobro del IRS no se avisan, siempre proporcionará dos formas de credenciales oficiales, ambas incluyen un número de serie y una foto del empleado del IRS. Los contribuyentes tienen derecho a ver cada una de estas credenciales.

- Un funcionario legítimo de cobro de impuestos del IRS (en inglés) ayuda a los contribuyentes a entender y cumplir con sus obligaciones tributarias. El oficial explicará la responsabilidad al contribuyente, junto con las consecuencias de no cumplir con la ley. El empleado del IRS no hará amenazas ni exigirá una forma inusual de pago por una responsabilidad inexistente.

- Las visitas de los funcionarios de cobro de impuestos del IRS generalmente ocurren después de numerosos contactos por correo acerca de un problema de impuestos existente; los contribuyentes están conscientes de que tienen un problema de impuestos cuando se producen estas visitas.

- Si alguien tiene una deuda tributaria federal pendiente, el oficial visitante solicitará el pago, pero proporcionará una variedad de opciones, que incluyen el pago por cheque escrito al Tesoro de los Estados Unidos.

## Las muertes por sobredosis relacionadas con opioides en Massachusetts caen un 5 por ciento desde el pico en 2016

Los últimos datos trimestrales de opioides muestran el impacto continuo del fentanilo en las muertes por sobredosis

La tasa de muertes por sobredosis relacionadas con opioides en Massachusetts disminuyó aproximadamente un 5 por ciento desde su punto máximo en 2016, a pesar de la creciente presencia del opioide sintético fentanilo como un conductor de muertes por sobredosis relacionadas con opioides, según datos preliminares en el último informe trimestral de vigilancia de opioides publicado hoy por el Departamento de Salud Pública de Massachusetts.

En 2019, la tasa de mortalidad por sobredosis relacionada con opioides fue de 29 por 100,000 personas, en comparación con 30.5 por 100,000 personas en 2016. Los datos preliminares muestran que en 2019 hubo 2,023 muertes por sobredosis relacionadas con opioides confirmadas y estimadas, mientras que para el mismo período en 2016 hubo 2,097 muertes confirmadas por sobredosis relacionadas con opioides.

## Massachusetts Opioid-Related Overdose Deaths in Massachusetts Fall 5 Percent Since Peak in 2016

Latest quarterly opioid data shows continued impact of fentanyl in overdose deaths

The rate of opioid-related overdose deaths in Massachusetts fell an estimated 5 percent from its peak in 2016, despite the growing presence of the synthetic opioid fentanyl as a driver of opioid-related overdose deaths, according to preliminary data in the latest quarterly opioid surveillance report released today by the Massachusetts Department of Public

Health.

In 2019, the opioid-related overdose death rate was 29 per 100,000 people, compared to 30.5 per 100,000 people in 2016. Preliminary data shows that in 2019, there were 2,023 confirmed and estimated opioid-related overdose deaths, while for the same period in 2016 there were 2,097 confirmed opioid-related overdose deaths.

# Beatles Expert Rod Griffith to Address MCC MILES Spring Opener



Middlesex Community College will feature marketing and Beatles expert Rod Griffith as keynote speaker for the spring Opening Session of Middlesex Institute for Lifelong Education for Seniors (MILES) at 2 p.m. Wednesday, March 18, in the Bedford Campus Center's Café East.

Beatles and 60's enthusiasts – come to Middlesex Community College to hear the inside scoop from an expert and fellow fan Rod Griffith. Middlesex will feature Griffith as keynote speaker for the spring Opening Session of Middlesex Institute for Lifelong Education for Seniors (MILES) at 2 p.m. Wednesday, March 18, in the Bedford Campus Center's Café East, 591 Springs Road.

The event is free and open to the public. "I'll be providing a lot of interesting insights into the recording of the Beatles' final album together – Abbey Road," Griffith said. "We'll review all of the challenges that the band was facing by the end of 1968 – and how their lives began to diverge into different paths at that time and into 1969."

Griffith will discuss studio techniques and tidbits behind the making of classic songs "Come Together," "Something" and "Here Comes the Sun" among others. As a passionate collector of rare Beatles music and artifacts, Griffith was asked by the Beatles' record label to act as a consultant, which led him to a role at the estate of John Lennon.

"They had an ability to create melodies that are timeless. And they never stayed the same – they always wanted to try new things," he said. They weren't interested in repeating their same success over and over. And the result is an incredible body of work that – quite amazingly – was created in just a seven year period together!

"They have a song for every mood – as I say. So almost anyone can find Beatles songs that are meaningful to them at any given time in their lives."

Griffith spent 10 years in marketing positions at area technology companies before starting his own company 25 years ago – MarketReach in Nashua. Now a resident of Lowell and board member of the

Cultural Organization of Lowell (COOL), he grew up in the Berkshires where he earned money as a teenager dusting off paintings for his elderly neighbor – Norman Rockwell.

MCC's MILES program offers stimulating, interactive daytime seminars and workshops – with no term papers, tests or grades – for active, older adults ages 55+. This Opening Session provides community members an opportunity to learn more about MILES and the courses being offered – and is a good time to meet instructors and peers. Light refreshments will be served.

# Master Piano Classes Offered

# HOJA DE DATOS DE SALUD PÚBLICA DE MASSACHUSETTS

## Nuevo Coronavirus 2019 (2019-nCoV)

Un nuevo virus, conocido como Nuevo Coronavirus 2019 (2019-nCoV), es un tipo de virus respiratorio detectado por primera vez en Wuham, Provincia de Hubei, China. Este nuevo virus ha dado lugar a miles de infecciones humanas confirmadas, de las cuales más del 99 por ciento se encuentran en China. Otros países, incluyendo los Estados Unidos, han identificado un número de casos pequeño, pero en aumento, en personas que han viajado a China.

### ¿Cómo se propaga el Coronavirus?

El Coronavirus es un virus respiratorio y se propaga generalmente a través de las secreciones respiratorias (como las gotitas de tos y estornudos) de una persona infectada a otra persona. La información sobre cómo se propaga este Nuevo Coronavirus es todavía limitada.

### ¿Cuáles son los síntomas del Nuevo Coronavirus 2019?

Este Coronavirus provoca una infección respiratoria (pulmón). Los síntomas de esta infección son:

- fiebre
- tos
- falta de aire
- en casos severos, neumonía (infección en los pulmones)

Aunque la mayoría de las personas se recuperan de esta infección, algunos casos pueden provocar una enfermedad grave o muerte. Las personas mayores y las que tienen problemas médicos preexistentes parecen tener un mayor riesgo de padecer una enfermedad grave.

### ¿Cuáles son los tratamientos?

#### ¿Existe alguna vacuna?

No existe un tratamiento antiviral específico para la infección por el Nuevo Coronavirus 2019, más allá de los cuidados paliativos y el alivio de los síntomas. Por el momento no hay una vacuna disponible para proteger a las personas de la infección por el Nuevo Coronavirus 2019.

### ¿Cómo puedo protegerme?

Aunque el riesgo del Nuevo Coronavirus 2019 para los residentes de Massachusetts es bajo, las mismas precauciones que se aplican a la prevención de los resfriados y la gripe pueden ayudar a protegerse contra otros virus respiratorios.

- Lávese las manos frecuentemente con agua tibia y jabón por lo menos durante 20 segundos.
- Cúbrase la boca al toser y estornudar.
- Permanezca en su casa si está enfermo.

### ¿Debo usar una mascarilla para estar en lugares públicos?

El riesgo para la salud de los residentes de Massachusetts aún es bajo y en este momento no estamos recomendando que las personas utilicen mascarillas para estar en lugares públicos. Las mascarillas pueden ser útiles en algunos lugares, como por ejemplo la sala de espera de una clínica, para evitar que alguien que tenga una enfermedad respiratoria pueda contagiárla a otras personas. No hay evidencia sólida de que una persona que usa una mascarilla esté protegida fuera de los lugares de cuidados de la salud.

### ¿Cómo es la prueba en personas por el Nuevo Coronavirus 2019?

Las pruebas para el Nuevo Coronavirus 2019 solo están disponibles a través del Laboratorio de Salud Pública del Estado de Massachusetts y de los Centros para el Control y la Prevención de Enfermedades (CDC, por sus siglas en inglés). Cualquier proveedor de cuidados de la salud que sospeche que una persona está infectada con el Nuevo Coronavirus 2019 debe llamar al Departamento de Salud Pública de Massachusetts para analizar las pruebas al (617) 983-6800.



### ¿Debería hacerme la prueba por el Nuevo Coronavirus 2019?

Sólo quienes han estado en un lugar donde está ocurriendo el Nuevo Coronavirus 2019 o han tenido contacto cercano con alguien que lo tiene, y están experimentando síntomas similares a los de la gripe, deberían ser examinados.

### ¿Qué debo hacer si he visitado un lugar en el que está ocurriendo el Nuevo Coronavirus 2019 o si tuve contacto cercano con alguien que lo tiene?

Desde el 3 de febrero de 2020, si ha estado en un lugar en el que está ocurriendo el Nuevo Coronavirus 2019 o si ha tenido contacto cercano con alguien que lo tuvo, es posible que se le pida que evite parcial o totalmente el contacto con otras personas, dependiendo de su probabilidad de exposición. Usted también debería:

- Controlar su salud durante 14 días después de su última posible exposición.
- Estar atento a estos signos y síntomas
  - a. fiebre
  - b. tos
  - c. falta de aire o dificultad para respirar
- Otros síntomas iniciales pueden ser escalofríos, dolores corporales, dolor de garganta, dolor de cabeza, diarrea, náuseas/vómitos y secreción nasal.
- Si usted desarrolla cualquiera de estos síntomas llame a su proveedor de cuidados de la salud.
- Antes de concurrir a su cita médica, asegúrese de informarle a su proveedor de cuidados de la salud sobre su posible exposición al Nuevo Coronavirus 2019.

We are writing to you today with information and guidance regarding infection caused by the new coronavirus, now known as COVID-19, first identified in Wuhan, China in late December 2019.

At this time, Massachusetts has one confirmed case of COVID-19 and the risk to our residents remains low. At the same time, the risk for the influenza virus is very high.

The vast majority of reported cases of COVID-19 are in China. Confirmed cases of this respiratory virus associated with travel from Wuhan are also being reported in a growing number of countries, including the United States. Some person-to-person spread of this virus outside China has been detected but, again, the risk to Massachusetts residents remains low at this time.

We know that outbreaks of new virus infections are always of public health concern. The Massachusetts Department of Public Health (DPH) is working closely with the Centers for Disease Control and Prevention (CDC), other federal agencies, local boards of health, and our clinical partners to share the most up to date information available.

It is important to note that Massachusetts residents are much more likely to become sick with a cold or the flu than to be exposed to COVID-19. Many of the precautions that help prevent colds and the flu can help protect against other respiratory viruses.

Please share this with your school nurse and other school health personnel.

### Recommended guidance

As of this writing, it is extremely unlikely that anyone with travel to mainland China within the past 14 days would be at school. As of February 3, 2020, travelers from mainland China are arriving into the U.S. at 11 airports (not including Logan airport in Boston) and are being screened upon entry. Travelers who are ill or who have traveled in the high-risk area of Hubei Province are being quarantined at the point of entry. Travelers from other parts of China without symptoms are being told to stay at home for 14 days from day of arrival.

If students, staff or volunteers do come to the nurse's office with a fever, cough, or difficulty breathing AND have traveled from China in the last 14 days OR are ill with fever, cough, or difficulty breathing AND had recent close contact with a confirmed COVID-19 case or had recent close contact with someone under investigation by public health authorities for COVID-19, these are guidelines to follow:

- Place the individual in a private room, ask

them to wear a face mask and close the door.

- Ask the individual about symptoms of COVID-19 (fever, cough, difficulty breathing).

Other symptoms could include: chills, sore throat, headache, muscle aches, abdominal pain, vomiting, and diarrhea. If you are in the same room as the individual, wear a face mask and stand at least 6 feet away.

- If the individual requires immediate medical care, call 911 for an ambulance, inform EMS of the individual's recent travel to China.
- Call the DPH Epidemiology Line at 617-983-6800 or your local board of health for additional guidance.

The precautions to help prevent colds and the flu can help protect against COVID-19.

DPH recommends that schools continue education about good hygiene. Students, staff, and volunteers should be reminded to:

- Wash your hands often with soap and water for at least 20 seconds, if unable to wash, use alcohol-based hand sanitizers
- Avoid touching your eyes, nose, and mouth
- Cover your coughs or sneezes with a tissue or your sleeve (not with your hands)
- Stay away from people who are sick and stay home when you are sick

Schools should follow their regular cleaning and disinfection program.

- Clean hard surfaces (desks, tables, countertops, sinks). Clean and disinfect frequently touched surfaces (door handles, faucets, railings), bathrooms and health rooms. Use alcohol wipes to clean keyboards.

- Use "EPA-approved" disinfectant to clean high-touch surfaces and patient care areas.
- Clean the surface first to remove all organic matter. Thorough cleaning with soap and water will remove most microorganisms.
- Custodial staff is trained to use disinfectants in a safe and effective manner and to clean up potentially infectious materials and body fluid spills.

- o Acoso cibernetico - 15% de los padres (Hispanos en Estados Unidos – 18% de los padres)

## International Day of Security on Internet

- Parents' biggest challenge to ensuring their child has a healthy digital lifestyle:

- o Content I don't approve of or don't want them watching/using - 28%
- o Enforcing screen time limits - 25%
- o Setting a good example for my kids with screen time - 21%

## Funcionarios de salud pública confirmán la quinta muerte por una lesión pulmonar asociada a vapeo

El Departamento de Salud Pública de Massachusetts (DPH) anunció que una quinta persona murió por una lesión pulmonar asociada a vapeo. El paciente, un hombre de unos 40 años del condado de Suffolk, informó sobre el vaporizador de tetrahidrocannabinol (THC), un ingrediente que se encuentra en la marihuana. El caso se encuentra entre los 46 casos confirmados de cigarrillo electrónico o lesión pulmonar asociada a vapeo (EVALI) que DPH ha informado a los Centros para el Control y la Prevención de Enfermedades (CDC) de EE. UU. Desde el 11 de septiembre de 2019, cuando el estado comenzó a exigir a los médicos que Informe cualquier lesión pulmonar inexplicable en un paciente al departamento.

Desde que el estado comenzó a ordenar el informe, se han identificado 127 casos de EVALI, con 46 casos confirmados y 81

casos probables reportados a los CDC.

"Mis condolencias están con la familia de este paciente que murió por una lesión pulmonar asociada con el vapeo", dijo la comisionada de Salud Pública, Monica Bharel, MD, MPH. "Esta tragedia nos recuerda los peligros del vapeo y las razones por las que fortalecimos nuestras leyes con respecto a los productos de vapeo".

En enero, DPH informó la muerte de un hombre de unos 70 años del condado de Middlesex que informó de vapear THC. En noviembre, DPH informó sobre la muerte de un hombre de unos 50 años del condado de Worcester que informó de vapeo de nicotina y THC. En octubre, el estado informó sobre las muertes por lesiones pulmonares asociadas con el vapeo de una mujer de unos 40 años del condado de Middlesex y una mujer de 60 años del condado de Hampshire, quienes fumaron nicotina.

## State public health officials confirm fifth death from a vaping-associated lung injury

The Massachusetts Department of Public Health (DPH) has announced a fifth person has died of a vaping-associated lung injury. The patient, a man in his 40s from Suffolk County, reported vaping tetrahidrocannabinol (THC), an ingredient found in marijuana. The case is among the 46 confirmed cases of e-cigarette or vaping-associated lung injury (EVALI) that DPH has reported to the US Centers for Disease Control and Prevention (CDC) since September 11, 2019, when the state began requiring clinicians to report any unexplained lung injury in a patient to the department.

Since the state began mandating the report, 127 cases of EVALI have been identified, with 46 confirmed cases and 81 probable cases reported to the CDC.

"My condolences go out to the family of this patient who has died from a vaping-associated lung injury," said Public Health Commissioner Monica Bharel, MD, MPH. "This tragedy reminds us of the dangers of vaping and the reasons we strengthened our laws regarding vaping products."

In January, DPH reported the death of a man in his 70s from Middlesex County who reported vaping THC. In November, DPH reported the death of a man in his 50s from Worcester County who reported vaping both nicotine and THC. In October, the state reported the vaping-associated lung injury deaths of a woman in her 40s from Middlesex County and a woman in her 60s from Hampshire County, both of whom vaped nicotine.



# From My Corner

## Should we worry about COVID-19?

Everywhere we turn coronavirus is in the news alarming the public. Cases are increasing in the United States and some publications advise how to prevent it.

NBC news said in part, that business leaders should start considering which employees could work from home. Perhaps the time will come, and other experts said, to observe religious practices and ceremonies at home, rather than attend larger community gatherings at places of worship. And families should start asking themselves how they would handle a week or two at home, without traveling even short distances for food, medicine or entertainment.

To me, that sounds alarming but considering the risk, it's good advice. If you plan of getting a mask, don't bother. There are none at any drugstore or chain store and a vaccine will take over one year to be perfected for human dispensation.

Meanwhile, the only acknowledgment we've heard from our city officials is that Lawrence is at a low risk. Even though, there is nothing wrong with preparing for the worst.

Nancy Messonnier, director of CDC's National Center for Immunization and Respiratory Diseases indicated that parents/guardians of students should ask their children's schools about plans for closures associated with a possibility of coronavirus spreading to our community. She warned that it expects the coronavirus that has sparked outbreaks around the world to begin

spreading at a community level in the United States, as a top official said that disruptions to daily life could be severe.

Is there a plan or do parents/guardians take the initiative to not send a student to school on the onset of knowing of the first case that occurs in Lawrence?

There is a very informative article from the Center for Disease Control on page 13 with information about prevention that I recommend you read.

## It's all who you know

Let me tell you another story of manipulation in Lawrence.

Last summer, MassHire posted a position for assistant director and I immediately wondered who the lucky friend of Mayor Danny picked for that was. The requirement was a bachelor's degree and the salary in the \$60s. Apparently, there were so many well-qualified individuals that they opted for canceling the search with the excuse of "not having the funding."

I was disappointed because there had to be something else behind and sure enough by November, a new position was created. The Outreach Coordinator also had the bachelor's requirement and a salary in the mid \$50s. There were a few applicants interviewed and guess who was picked? Wendy Luzón! The flunkie high school graduate who lied in the past about having a college degree.

The position was created for her and the assistant director job is still empty. I bet she'll be promoted soon.

Also, the Lawrence City Council advised the mayor against transferring



# Student Cellist Excels With MCC's Dual Enrollment Program

When Nathaniel Abreu first started playing cello at 5 years old, the standard-size instrument was bigger than he was – thankfully they had smaller sizes available for children.

Born to a family of musicians, Abreu began by playing a violin like his sister Marisol, but he didn't care for the high sounds. Instead, he selected the deeper sounding cello.

"Not too much thought goes into it when you're that little, but the idea is that the sound speaks to you – and it still does," he said.

Abreu's dedication to his art – he needs to practice a lot – meant the average high school schedule wasn't a fit for him. His parents made the decision to take him out of the Somerville school system to home-school him.

The family turned to Middlesex Community College for their Dual Enrollment Program. Even though he is on the younger side, Abreu said Middlesex exposes him to the college learning environment – and his age doesn't matter.

"Everyone comes from different walks of life. It's not unusual to have either a high school student or someone in their fifties – it makes no difference, you're just here to learn," he said.

Middlesex's flexibility, affordability and customizable scheduling was ideal. Abreu says MCC is accommodating, well-managed and a supportive community. He quotes his mom in saying, "when you call, someone will answer the phone."

The ability to earn his associate's degree along with his diploma also appealed to him. Abreu had enough credits to graduate from high school early, but he continued at MCC to finish his associate's – something that will help him at a college or conservatory as many of the institutions will accept his time at Middlesex as two years of college.

As a Commonwealth Honors student majoring in Liberal Arts & Sciences, Abreu has enjoyed all of his courses and listed off a number of non-music classes as some of his favorites.

"It's much more difficult to find something I didn't like," he said.

Some standouts include an Honors Seminar on Latin American History & Literature with Professor Alejandro Raya, English with Professor Stephanie Pesce, and Anthropology with Professor Binnur Ercem.

Ercem's class left such an impression on him, Abreu recommended it to his sister – a former MCC Dual Enrollment student now at Brandeis – which inspired her to change majors. It was a nice experience to share classes and much of his time at MCC with his sister. While she spent her last two years of high school at Middlesex, Abreu came for his entire high school career.

Abreu also credits his relationships with Performing Arts Professors Carmen Rodriguez-Peralta and Orlando

Cela for opening up many opportunities for him.

"The music department here is really dedicated. I'm just so glad that a place like MCC – that thrives in all sorts of different fields – values the arts," he said.

Rodriguez-Peralta has invited Abreu to perform at college fundraising events and student recitals outside of class. Abreu has performed with Cela, including at a recent concert with the Lowell Chamber Orchestra at MCC's Academic Arts Center.

Beyond the cello, Abreu takes piano with Rodriguez-Peralta and conducted a small orchestra at Berklee College of Music with his classmates as part of Cela's course.

"It's fun to learn new instruments and challenging because you're not used to starting from the beginning after years of going deeper into studies of one particular instrument. It's a new feeling that is very helpful for growth," Abreu said.

Abreu welcomes a challenge. For auditions, he is working on a piece that was once believed to be "unplayable" – Russian composer Prokofiev's Cello Concerto.

"It's challenging, but a great piece of music, so it's rewarding to work very hard on it and be able to understand it more deeply," Abreu said.

He compares his selection of music to that of food preference – it depends on his mood. The amount of practice he does depends on the time of year – he'd guess between five to six hours a day – but he doesn't count the hours so much as finishes what he needs to do at the time.

In the summer, Abreu often plays at festivals, including at the Koussevitzsky Music Shed at Tanglewood in 2016 and as part of the Yellow Barn Young Artists Program – a chamber music festival. Abreu smiled when he said that in the barn, "the cello sounds very nice."

This year, Abreu was awarded an Honorable Mention for the YoungArts Foundation, which connects him to the program's many alumni. In the spring, he's looking forward to hearing from colleges and summer festivals.

Middlesex is just the starting point to Abreu achieving his dreams.

"I hope to be a performing musician," he said. "It would definitely be a classical music position, but I'm not sure the specifics of that – whether it be orchestra or chamber – that's what I hope to find out in college. Just make a living as a musician and do what I love to do and find my way."

# ALERTA DE ESTAFA: las estafas de Robocall se vuelven políticas

Entre los anuncios políticos y la cobertura de noticias, las elecciones presidenciales de 2020 son imposibles de ignorar. Pero los votantes no son los únicos que prestan atención. De acuerdo con informes recientes de BBB Scam Tracker, los estafadores están utilizando llamadas falsas de recaudación de fondos políticos para engañar a los estadounidenses para que "donen" a un candidato favorito.



## Cómo funciona la estafa

Recibe una llamada automática y contesta el teléfono. Es una voz grabada, tal vez incluso una que suena como uno de los candidatos presidenciales. Según la grabación, los rivales han estado recaudando mucho dinero. Para ver a su candidato favorito elegido, debe donar... inmediatamente.

Si ofrece dar, será transferido a una persona en vivo y le pedirá la información de su tarjeta de crédito. Pero su dinero no irá a apoyar la causa política. En cambio, la persona que llama por teléfono falsificará su dinero y/o información personal que puede ser utilizada para el robo de identidad. A medida que se calienta la campaña electoral de 2020, esté atento a más versiones de esta estafa.

## Cómo evitar las estafas de Robocall

- Filtrar sus llamadas telefónicas. Si recibe una llamada de un número que no reconoce, no responda. Incluso si el número le resulta familiar, tenga cuidado. Verifique el número en Whitepages.com (un negocio acreditado por BBB) para ver si se ha marcado con una alerta de fraude.
- No responda a llamadas automáticas no solicitadas. Si recibe una llamada automática no solicitada que parece provenir

de un negocio legítimo, tenga cuidado. Los estafadores pueden falsificar el identificador de llamadas, y las empresas solo pueden llamarlo por robocall con su permiso por escrito. Si alguien lo llama de la nada, lo más probable es que sea una estafa. La mejor práctica es colgar el teléfono sin interactuar con la llamada. No "presione 1 para ser eliminado de nuestra lista"; eso solo confirma al estafador que su número es bueno.

- Regístrese en el Registro de No Llamar. Este paso no evitara que los estafadores lo llamen, pero reducirá la cantidad de llamadas de marketing legítimas que reciba, lo que facilitará la identificación de las fraudulentas. Si vive en los Estados Unidos, llame al 888-382-1222 ó regístrese en línea en Donotcall.gov. Si vive en Canadá, visite la Lista Nacional de No Llamar.

# SCAM ALERT: Robocall Scams Get Political

Between the political ads and the news coverage, the 2020 presidential election is impossible to ignore. But voters aren't the only ones paying attention. According to recent BBB Scam Tracker reports, scammers are using phony political fundraising calls to trick Americans into "donating" to a favorite candidate.

## How the Scam Works

You receive a robocall and answer the phone. It's a recorded voice – perhaps even one that sounds just like one of the presidential candidates. According to the recording, rivals have been raising a lot of money. In order to see your favorite candidate elected, you need to donate... immediately.

If you offer to give, you'll be transferred to a live person and asked for your credit card information. But your money won't go to support the political cause. Instead, the phony caller will make off with your money and/or personal information that can be used for identity theft. As the 2020 election campaign heats up, be on the lookout for more versions of this con.

## How to Avoid Robocall Scams

- Screen your calls. If a call comes in from a number you don't recognize, don't answer. Even if the number looks familiar, be wary. Check the number on Whitepages.

com (a BBB Accredited Business) to see if it's been flagged with a fraud alert.

- Don't respond to unsolicited robocalls. If you receive an unsolicited robocall that seems to come from a legitimate business, be cautious. Scammers can fake caller ID, and businesses are only allowed to call you via robocall with your written permission. If someone is calling you out of the blue, it's most likely a scam. Best practice is to hang up the phone without interacting with the call. Don't "press 1 to be removed from our list;" that just confirms to the scammer that your number is good.

- Register with the Do Not Call Registry. This step won't prevent scammers from calling you, but it will reduce the number of legitimate marketing calls you receive, which will make it easier to identify the fraudulent ones. If you live in the United States, call 888-382-1222 or register online at Donotcall.gov. If you live in Canada, visit the National Do Not Call List.
