Hello Lawrence Public Schools families.

I am writing to inform you that Lawrence Public Schools, in coordination with neighboring school districts, will be closed for two weeks beginning this Monday. Currently, our anticipated return is Monday, March 30th.

While as of this morning we have not had any confirmed or presumed cases of COVID-19 in our area, this decision was made in response to the virus's extensive regional impacts and for the long-term health and safety of all our families and employees.

We know this will have a tremendous impact on our community, and will be sharing additional resources and details on this closure in the coming days and weeks. At this time, I would like to highlight the following key items:

- Throughout the closure, grab 'n go meals will be available for all Lawrence Public Schools students Monday through Friday, 11:00am – 1:00pm, at the Arlington complex, Parthum complex, Guimette complex and the Lawrence High School campus. Nursing and counseling staff will also be available for health- and wellness-related questions at the same times and sites.
- We have been sanitizing buildings throughout the past several weeks, and will use this time to continue a district-wide deep cleaning.
- Good hygiene and health practices remain the best way to prevent the spread of COVID-19, including frequent handwashing; coughing and sneezing into the crook of the elbow; staying home when sick; and limiting contact with people who are ill. People with fever, cough or shortness of breath should stay home from school, and are encouraged to call their healthcare provider (before visiting) and closely follow their guidance. Lawrence General Hospital has also established a COVID-19 screening line at (978) 946-8409.
- You will find updates and resources at our website, Lawrence.k12.ma.us, and are encouraged to follow the district's social media accounts on Twitter (@LPS\_Education) and Facebook (Lawrence Public Schools).

Thank you for your support and understanding throughout this unprecedented and constantly evolving challenge. We will continue to communicate with you throughout this closure, providing frequent updates and connections to any new resources as they become available.

Hola Familias de las Escuelas Públicas de Lawrence,

Les escribo para informarles que las Escuelas Públicas de Lawrence, en coordinación con los distritos escolares vecinos, estarán cerradas durante dos semanas a partir de este lunes. Anticipamos que el regreso a la escuela será el lunes 30 de marzo.

Aunque hasta el momento no hemos tenido ningún caso confirmado o presunto de COVID-19 en nuestra área, esta decisión fue tomada en respuesta a los extensos impactos regionales del virus y por la salud y seguridad de todas nuestras familias y empleados.

Sabemos que esto tendrá un tremendo impacto en nuestra comunidad, y estaremos compartiendo recursos adicionales y detalles sobre el cierre de nuestras escuelas en los próximos días y semanas.

En este momento, me gustaría destacar los siguientes puntos cruciales:

- Durante el cierre de escuelas tendremos almuerzo "grab 'n go" disponible para todos los estudiantes de lunes a viernes, 11am-1pm, en el complejo Arlington, complejo Parthum, complejo Guimette, y la escuela superior de Lawrence. Servicios de enfermería y consejería estarán disponible durante esas horas para preguntas relacionadas de salud física y mental.
- Hemos estado desinfectando las escuelas durante las últimas semanas, y usaremos este tiempo para continuar con la limpieza profunda en todo el distrito.
- Buenas prácticas de higiene y salud siguen siendo la mejor manera de prevenir la propagación de COVID-19, incluyendo lavarse las manos frecuentemente; toser y estornudar en el interior del codo; permaneciendo en casa si está enfermo; y limitando el contacto con personas enfermas. Las personas con fiebre, tos o dificultad para respirar deben quedarse en casa y no ir a la escuela, y se les recomienda que llamen a su médico (antes de visitarlo) y seguir de cerca su recomendación. El Hospital General de Lawrence ha establecido una línea de detección para el COVID-19 (978) 946-8409.
- A lo largo del cierre de escuelas podrá encontrar actualizaciones y recursos en nuestra página web, Lawrence.k12.ma.us, y se les anima a seguir las páginas de las redes sociales del distrito – Twitter (@LPS\_Education) y Facebook (Lawrence Public Schools).

### La primavera está en el aire

El título es una frase muy común que decimos y escuchamos cada año por estas fechas. Después de un largo y frío invierno, las primeras señales de la primavera están en el aire, con mañanas y tardes frías, mientras que la temperatura sube al mediodía. Estas señales son las que motivan a la mayoría de las personas a salir y comenzar a recoger lo que estaba escondido bajo la nieve.

Desafortunadamente, esta va a ser una primavera para ser recordada no por lo que vamos a disfrutar, sino por lo dejemos de hacer. Y todo por un "dichoso" virus, tan pequeño e invisible que no vemos ni sentimos cuando penetra en nuestro organismo, ni quien nos lo transmisió y que puede costarnos la vida.

Como medida preventiva, las autoridades han tomado medidas que parecen extremas, tan extremas que lucen incomprendibles, tales como prohibir aglomeraciones de personas no solo en espacios cerrados sino aquellas que se llevan a cabo en la intemperie, como juegos de pelota, soccer, y hasta golf.

Algo que extrañaremos enormemente es el desfile anual de San Patricio que en ciudades como New York se vienen celebrando desde 1762. En Lawrence, la decisión de cancelar el desfile se tomó con mucha precaución y en un esfuerzo por mantener saludables a los residentes de la Ciudad de Lawrence y el Gran Valle de Merrimack.

Como es lógico, las autoridades locales siguen el ejemplo de las autoridades que a nivel nacional están implantando, medidas radicales para proteger la ciudadanía, al igual que otros países que están siendo afectados, aún más que nosotros, y por evitar llegar a sus niveles.

El cólera, la peste bubónica, la viruela y la gripe son algunos de los asesinos más brutales de la historia humana. Los brotes de estas enfermedades a través de las fronteras internacionales, se definen adecuadamente como pandemia, especialmente la viruela, que a lo largo de la historia, ha matado entre 300-500 millones de personas en sus 12,000 años de existencia.

Afortunadamente, las autoridades a nivel mundial han aprendido del pasado, que la forma más efectiva de controlar las epidemias, es aislar a los infectados.

La recomendación que oímos de los expertos es distanciamiento social sobre todo para grupos vulnerables (personas mayores y personas con enfermedades crónicas), aislamiento de domicilios y eventualmente de pueblos o ciudades con un alto número de infecciones (como está haciendo Italia actualmente).

Mantengamos comunicación con nuestros seres queridos, familiares y amigos, estemos atentos de sus necesidades pero reservemos las visitas para cuando el tiempo mejore, es nuestra recomendación.

### Spring is in the air

The title is a very common phrase that we say and hear every year around this time. After a long and cold winter, the first signs of spring are in the air, with cold mornings and afternoons, while the temperature rises at noon. These signs are what motivate most people to go out and start collecting what was hidden under the snow.

Unfortunately, this is going to be a spring to be remembered not for what we are going to enjoy, but for what we won't be doing. And all because of a darned virus, so small and invisible, still lethal, that we do not see or feel when it enters our body, or who transmitted it to us and that it can cost us our lives.

As prevention, the authorities have taken measures that seem extreme, so extreme that they seem incomprehensible, such as prohibiting crowds of people not only in closed spaces but also those that take place in the open, such as baseball games, football, soccer, and even golf.

Something we will greatly miss is the annual St. Patrick's Day parade that has been held in cities like New York since 1762. In Lawrence, the decision to cancel the parade was made with great caution and in an effort to keep city residents from Lawrence and the Great Merrimack Valley healthy.

Local governments follow the example that national authorities are implementing with radical measures to protect citizens, while other countries are being affected, even more, thus avoiding reaching their levels.

Cholera, bubonic plague, smallpox, and the flu are some of the most brutal killers in human history. Outbreaks of these diseases across international borders are adequately defined as a pandemic, especially smallpox, which throughout history has killed 300-500 million people in its 12,000-year existence.

Fortunately, authorities worldwide have learned from the past, that the most effective way to control epidemics is to isolate the infected.

The recommendation that we hear from the experts is social distancing, especially for vulnerable groups (older people and people with chronic diseases), isolation of homes and eventually of towns or cities with a high number of infections (as Italy is currently doing).

Let us maintain communication with our loved ones, family and friends, be attentive to their needs but reserve visits for when the weather improves, it is our recommendation.

# Desde Mi Esquina

## No se asuste

Como diría Peggy Noonan (autora, columnista semanal de The Wall Street Journal), "No se asuste" es lo que dicen las personas nerviosas y defensivas cuando alguien advierte sobre problemas futuros. No quieren escucharlo, por lo que su mensaje es "No te preocupes como un cobarde, no te preocupes y alégrate como una persona valiente".

También escribe que así es como lo ha experimentado: "Capitán, parece haber un tempano". "No entre en pánico, oficial, a toda máquina" y, "Almirante, concentrar toda nuestra flota en un puerto es como tentar al enemigo". "No necesitamos sus fantasías alarmistas, alfárez", también "Estamos escuchando una charla en internet sobre una acción de al Qaeda". "Tu retorcimiento de manos está debidamente anotado".

Peggy afirma que "No se asuste", en la atmósfera actual, es una forma de callar a las personas que utilizan su imaginación como una herramienta de protección. Es una implicación de cobardía por cobardes.

El Alcalde Rivera no quiere que el público entre en pánico cayendo en este tipo de herramienta de protección hacia sus residentes y sus empleados. Les está diciendo a los empleados que no usen máscaras faciales, lo que aumenta cualquier posible transferencia de virus a sus residentes. Tampoco les dice a sus residentes ningún plan que la ciudad pueda tener en caso de problemas pequeños o importantes relacionados con este coronavirus.

Él habla de camas de hospital en las noticias, pero esto no es de su incumbencia. En una entrevista con Eagle-Tribune el miércoles pasado, dijo: "Los funcionarios de Holy Family y Lawrence General visitarán la Escuela Parthum el viernes porque ha sido designada como un lugar 'fuera del sitio' para camas de hospital adicionales si las instalaciones locales se quedan sin espacio." Los residentes y las empresas de Lawrence quieren saber cómo responderá el Alcalde Rivera y su gobierno local a un brote en la ciudad.

Llamé al Departamento de Relaciones Públicas de Lawrence General Hospital para que me dieran más detalles del plan para usar a la Escuela Parthum y me dijeron que me llamarían pero nadie lo hizo.

Lo entiendo, es difícil. Esta es una situación fluida y no quiero que crea que tengo todas las respuestas. Esta nación no ha visto nada a esta escala. Pero la Ciudad ha estado en esta situación antes y no ha aprendido nada sobre un plan escrito. La ciudad tuvo desde las explosiones de gas

de septiembre 2018 para elaborar planes de emergencia. No tienen ninguno. El director de emergencias de la Ciudad es el Jefe de Bomberos, que siempre es eclipsado por el alcalde. Él no tiene planes. El alcalde no tiene planes. Todo lo que pueden decir es que hablan con los dirigentes del estado a diario y toman su respuesta de ellos.

Por cierto, el Jefe de Bomberos Moriarty ha estado en el hospital durante unos días por una razón no relacionada, según él, pero el hecho es que se ha mantenido en secreto del público.

El Alcalde Rivera no quiere cerrar nada y no abordará esto porque para él es una cuestión de pérdida de negocios locales. Pero sin crear una fuerza de trabajo que pueda ir a cada negocio local con una herramienta de capacitación y recursos, es solo asesinato. Sin juego de palabras.

Los empleados no pueden usar una máscara. No cree que una máscara ayude a nadie. Tal vez debería hablar con el Concejal Payano, quien el año pasado recomendó que la ciudad adopte la ley de la Commonwealth en lo que respecta al Departamento de Salud y Servicios Humanos. El alcalde Rivera no adoptó la ley y aquí en la ciudad seguimos sin expertos médicos en su arsenal de armas para tratar este problema.

Estoy principalmente preocupada por nuestros hombres y mujeres del Departamento de Policía, Departamento de Bomberos, Obras Públicas y cualquier otro empleado que tenga interacción directa con el público. Sé que deben servir, ese es su trabajo, pase lo que pase. Pero, ¿dónde está su seguridad en todo esto?

Alcalde Dan Rivera, deje de tratar a los empleados de la ciudad como si fueran desecharables.

El jueves pasado, envió un mensaje a todos los empleados de la ciudad diciendo: "No hay una orden de mordaza con la prensa, pero si los medios se les acercan, por favor diríjanlos a Kate Reilly en mi oficina (kreilly@cityoflawrence.com - 978-620-3013). Seré la voz oficial del Gobierno de la Ciudad de Lawrence, para no generar confusión". Dudo que el alcalde comprenda qué es una orden de mordaza.

Todavía tiene que comunicarse con cualquiera de los edificios poblados de ancianos de la ciudad sobre la posibilidad de que sea necesaria la cuarentena o la evacuación. No ha discutido la posibilidad de los muertos con las funerarias locales. Todavía tiene que comunicarse con organizaciones sin fines de lucro que brindan servicios a los miles de personas mayores en la ciudad.

Tampoco se ha comunicado con la autoridad local de vivienda. Solo ha habido



### Tome Medidas para Prevenir la Exposición de los Trabajadores al Coronavirus (COVID-19)

El nuevo coronavirus (oficialmente llamado COVID-19) se cree que se está propagando de persona a persona, principalmente a través de gotitas de respiración producidas cuando una persona tose o estornuda. El virus también se puede propagar al tocar una superficie u objeto y luego tocarse la boca, nariz, o posiblemente los ojos.

Los patrones y trabajadores deben seguir estas prácticas generales para ayudar a prevenir la exposición al coronavirus:

- Lavarse las manos frecuentemente con agua y jabón por al menos 20 segundos.
- Si no cuenta con agua y jabón, use un desinfectante de manos que contenga al menos 60% de alcohol.
- Evitar tocarse los ojos, la nariz y la boca, si no se lavó las manos.
- Evitar el contacto cercano con personas enfermas.

Los patrones de los trabajadores que corren el riesgo ocupacional de estar expuesto

al coronavirus, deben seguir las siguientes medidas preventivas:

- Evaluar los peligros a cuáles los trabajadores pueden estar expuestos.
- Evaluar el riesgo de exposición.
- Seleccionar, implementar, y asegurar que los trabajadores estén tomando medidas de protección para prevenir la exposición, incluyendo usar barreras físicas para detener la propagación de gérmenes; limitar los contactos sociales; y usar un equipo de protección personal adecuado, higiene, y artículos de limpieza.

# Actualización de la política de visitantes temporales del Hospital General Lawrence en respuesta a COVID-19 (Coronavirus) 3-12-2020

En respuesta al estado de emergencia de COVID-19 (coronavirus) declarado en Massachusetts, el Lawrence General Hospital está implementando una política de visitantes temporales en todas las ubicaciones de pacientes hospitalizados y ambulatorios, con vigencia inmediata.

Para limitar la exposición potencial y proteger la salud de los pacientes y las familias que atendemos, la política actualizada limita a los pacientes en el hospital a un visitante adulto a la vez. Múltiples visitantes no pueden congregarse en las áreas de espera. Además, un paciente que llega a una cita no puede estar acompañado por más de un adulto. Los visitantes deben abandonar el hospital inmediatamente después de completar su visita.

El horario de visitas es ahora de 10 a.m. a 6 p.m., los siete días de la semana. La entrada para visitantes al campus principal de Lawrence General se limita temporalmente a la entrada del vestíbulo principal y la entrada del centro de emergencias.

Todos los visitantes deben estar sanos. Las entradas al hospital cuentan con personal de seguridad y personal clínico para evaluar a cada persona que ingresa al hospital. Nadie podrá visitar a un paciente si tiene signos o síntomas que incluyen fiebre,

tos, dolor de garganta, secreción nasal, falta de aliento, fatiga, escalofríos, vómitos o diarrea. Antes de autorizar a la persona a visitar, los evaluadores también confirmarán que el paciente que se está visitando no tiene otro visitante en ese momento.

Los pacientes que trabajan pueden tener una persona de apoyo durante el transcurso de su estadía. Se pueden hacer ciertas excepciones para los menores de 18 años que sean padres designados o tutores legales. De lo contrario, no se permiten visitantes menores de 18 años.

Se les pide a los familiares y amigos que deseen conectarse con un paciente hospitalizado que llamen o chateen por video al paciente como una forma de mantenerse conectado mientras limitan la exposición. Entendemos que estos cambios temporales pueden imponer un inconveniente a algunas familias, pero es un paso importante para mantener a todos lo más seguros y saludables posible. Agradecemos su ayuda para proteger a nuestros pacientes, familias y la comunidad en general.



# Lawrence General Hospital Temporary Visitor Policy Update in Response to COVID-19 (Coronavirus) 3-12-2020

In response to the COVID-19 (coronavirus) state of emergency declared in Massachusetts, Lawrence General Hospital is implementing a temporary visitor policy at all inpatient and outpatient locations, effective immediately.

To limit potential exposure and protect the health of patients and families we serve, the updated policy limits patients in the hospital to one adult visitor at a time. Multiple visitors cannot congregate in waiting areas. Additionally, a patient arriving for an appointment cannot be accompanied by more than one adult. Visitors must leave the hospital immediately after their visit is complete.

Hospital visiting hours are now 10 am to 6 pm, seven days a week. Entrance for visitors to Lawrence General's main campus is temporarily limited to the Main Lobby entrance and the Emergency Center entrance.

All visitors must be healthy. Hospital entrances are staffed by security and clinical staff to screen each person entering the hospital. No one will be permitted to visit a patient if they have signs or symptoms including fever, cough, sore throat, runny nose, shortness of breath, fatigue, chills, vomiting, or diarrhea. Before clearing the person to visit, screeners will also confirm that the patient being visited does not have another visitor at the time.

Laboring patients may have one support person throughout the course of their stay. Certain exceptions may be made for those under the age of 18 who are designated parents or legal guardians. Otherwise, visitors under the age of 18 are not permitted.

Family and friends who wish to connect with a hospitalized patient are asked to call or video chat the patient as one way to stay connected while limiting exposure.

We understand these temporary changes may impose an inconvenience to some families, but it's an important step to keep everyone as safe and healthy as possible. We appreciate your help protecting our patients, families and the greater community.

# MA: Restringen a los visitantes a hogares de ancianos y de reposo para reducir el riesgo de coronavirus

Administración emite nueva guía para proteger a la población vulnerable

BOSTON - (11 de marzo de 2020) Hoy, la Administración Baker-Polito publicó políticas que restringen a los visitantes a hogares de ancianos y hogares de reposo para proteger a los adultos mayores con mayor riesgo de coronavirus (COVID-19) y otras enfermedades respiratorias. La secretaria de Salud y Servicios Humanos, Marylou Sudders, la comisionada del Departamento de Salud Pública, Monica Bharel, y sus equipos revisaron la guía con operadores de centros de atención a largo plazo por teleconferencia hoy.

Esta acción sigue a la declaración del martes del gobernador Charlie Baker de un estado de emergencia en Massachusetts que fue ratificado por el Consejo de Salud Pública el día de hoy, otorgando al Comisionado de Salud Pública la autoridad para implementar el estado de emergencia del gobernador.

## MA: Restricting Visitors to Nursing Homes, Rest Homes to Reduce Risk of Coronavirus

Administration issues new guidance to protect vulnerable population

BOSTON – (March 11, 2020) Today the Baker-Polito Administration released policies restricting visitors to nursing homes and rest homes in order to protect older adults at higher risk for Coronavirus (COVID-19) and other respiratory illness. Health and Human Services Secretary Marylou Sudders, Department of Public Health Commissioner Monica Bharel and their teams reviewed the guidance with long term care facility operators via teleconference today.

This action follows Governor Charlie Baker's Tuesday declaration of a State of Emergency in Massachusetts that was ratified by the Public Health Council earlier today granting the Commissioner of Public Health with the authority to implement the Governor's State of Emergency.

With this authority, the Commissioner of Public Health issued an order requiring all facilities – nursing and rest homes – to actively screen all visitors and to take measures to restrict visitors under certain circumstances.

"Everyone has a role to play to mitigate the spread of the Coronavirus outbreak in Massachusetts, and it's particularly important that we take precautions to keep older adults and those with health conditions safe," said Governor Charlie Baker. "This new guidance for long-term care facilities is critical to protecting older adults from COVID-19 and we appreciate the public's willingness to observe these important rules for the foreseeable future."

"Today's actions are being taken to protect older adults that are particularly vulnerable to coronavirus and other respiratory diseases, as we have seen as its spread across the world, including the United States," said Secretary Marylou Sudders. "Massachusetts, as we all know has an aging population – with 20% of residents being over 60 – and so we needed to act to protect our older residents, especially those in long term care facilities."

This guidance outlines how these facilities should protect older adult residents,

who are at higher risk for Coronavirus. The guidance includes the following restrictions:

- Banning visitors who show signs or symptoms of a respiratory infection (fever, cough, shortness of breath, or sore throat)
- Visitors will be prohibited if in the last 14 days they had contact with someone with a confirmed diagnosis of COVID-19, are under investigation for COVID-19 or has been sick
- Visitors will be prohibited if they have travelled internationally in the last 14 days or are residing in a community where community-based spread of COVID-19 is occurring
- Visitors will not be allowed to visit long term care facilities if they currently feel sick or exhibit symptoms

In addition to specific recommendations for long term care facilities, the Administration updated its guidance to the general public, specifically urging older adults and those with health issues to avoid large crowds and events. Individuals who live in households with vulnerable people, like elderly parents, should also consider avoiding crowds to mitigate risk. This guidance is posted on the Department of Public Health's website, [www.mass.gov/2019coronavirus](http://www.mass.gov/2019coronavirus).

The public is reminded of steps to take to limit the spread of COVID-19:

- Cover your mouth – when you cough or sneeze use a tissue or your inner elbow, not your hands
- Wash your hands – with soap and warm water or use an alcohol-based sanitizing gel
- Stay home if you are sick – and avoid close contact with others

## Lawrence General Hospital Offering Coronavirus Community Screening Resources

Lawrence, MA-- On March 10, Massachusetts declared a state of emergency in response to COVID-19 (Coronavirus 2019). In response to growing community concern surrounding the disease, Lawrence General Hospital is now offering two new coronavirus community screening resources where patients, families, and providers in the community can obtain an assessment of a person's COVID-19 risk, possible need for testing, and recommendations for next steps.

"As with any health threat, Lawrence General Hospital wants to reassure the community that care and safety are top priorities," says George Kondylis, MD, chief of emergency medicine at Lawrence General. "The hospital continues to be vigilant in limiting risk of exposure of any highly contagious disease, including COVID-19."

If someone in the community is concerned they have or were possibly exposed to COVID-19, Kondylis recommends they first use one of Lawrence General's two new community screening resources to determine if they meet the CDC guidelines for testing based on symptoms, travel and exposures.

"It's important to keep in mind that the majority of COVID-19 cases nationwide are mild, much like the flu, and only a small percentage of patients will require hospitalization or even a trip to the emergency room," Says Kondylis. We've added these screening tools to provide guidance for those with symptoms to help limit risk of exposing others in the community."

While the hospital's COVID-19 screening resources do not provide medical

treatment, the nurses staffing the line will be able to help better determine if someone meets the criteria for testing and advise them on how to proceed with testing and/or treatment.

**BY PHONE:** The Lawrence General Hospital COVID-19 (Coronavirus 2019) Community Screening line is staffed by Lawrence General nurses 24 hours a day, 7 days a week and can be reached by calling (978) 946-8409. In an effort to reduce transmission, those with mild respiratory symptoms, fever and cough, are asked to call the screening line prior to seeking a COVID-19 screening at the hospital. Those experiencing severe illness or a medical emergency, in which case they should call 911.

**ONLINE:** The community can also use Lawrence General's new online screening tool at LawrenceGeneral.org, where they will be prompted to answer several screening questions before being contacted by a nurse for follow-up guidance.

Lawrence General Hospital has also activated its Emergency Preparedness Plan for optimal communication, collaboration and information sharing both inside the hospital and with state and local community leaders and health officials. Additionally, the hospital's infection control specialists, emergency specialists, and administrators continue to closely monitor the COVID-19 (Coronavirus 2019) outbreak. The hospital routinely conducts reviews around preparedness for coronavirus and has put in place safety protocols based on guidelines from the Centers for Disease Control and Prevention (CDC) and Massachusetts Department of Public Health (DPH).

# Massachusetts Issues Guidelines to Assisted Living Facilities, Community-Based Providers, and Other Caregivers to Reduce Risk of Coronavirus

Administration issues new guidance to protect residents served in communities

BOSTON – (March 12, 2020) Today the Baker-Polito Administration released new policies to further protect individuals served in community-based and congregate care settings from respiratory illnesses, including Coronavirus (COVID-19). The new guidance is for Assisted Living Residences, Congregate Care Settings, In-Home Caregivers and Workers (Agency Based and Non-Agency Based), and Community Day Program Settings. This follows Governor Charlie Baker's Tuesday declaration of a State of Emergency in Massachusetts that was ratified by the Public Health Council on Wednesday as a public health emergency.

"Everyone has a role to play to mitigate the spread of the Coronavirus outbreak in Massachusetts, and it's particularly important that we take precautions to keep older adults and those with health conditions safe," said Governor Charlie Baker. "This new guidance is critical to protecting residents served by community-based providers and other caregivers and those at assisted living residences, and we appreciate the public's willingness to observe these important rules for the foreseeable future."

"In Massachusetts we have a strong system of community-based health and human service providers. Recognizing that these services are vital for the residents they serve, we acted to develop guidance that will help organizations protect their employees, and to protect Massachusetts residents," said Secretary Marylou Sudders.

Earlier today, Commissioner Monica Bharel, MD, MPH signed a public health order requiring the restriction of visitation at Assisted Living Residences.

The guidance released today for Assisted Living Residences, as well as Congregate Care Settings, In-Home Caregivers and Workers (Agency Based and Non-Agency Based), and Community Day Program Settings, is based on what is currently known about the transmission and severity of COVID-19. As each industry group faces specific challenges associated with implementation based on its population and organizational needs, these guidelines have been tailored accordingly.

With today's release, the organizations and institutions are receiving specific guidance that addresses their industry's unique programming and services. All of these groups are strongly urged to follow core guidelines to reduce the risk of COVID-19 in these settings:

- Screen employees, vendors, and clients for sickness with fever, new respiratory illness, recent international travel, and close contact with a person diagnosed with COVID-19 within the past 14 days.
- Prepare and educate individuals with updated guidance and policies.

Avoid unnecessary out of state or international travel and avoid large gatherings or crowds, and reinforce the practice of good hygiene with staff, vendors, and clients.

Yesterday, the Executive Office of Health and Human Services released updated guidance for long term care facility policies to protect older adults at higher risk. The guidance was updated following an order by the Commissioner of Public Health requiring all facilities – nursing and rest homes – to actively screen all visitors and to take measures to restrict visitors under certain circumstances under her authority during this public health emergency.

In addition to specific policies for long term care facilities and other community-based providers, earlier this week, the Administration updated its guidance to the general public, specifically urging older adults and those with health issues to avoid large crowds and events. Individuals who live in households with vulnerable people, like elderly parents, should also consider avoiding crowds to mitigate risk. ## Proceso para acceder a los préstamos de socorro en casos de desastre por coronavirus (COVID-19) de la SBA

Estos préstamos se pueden usar para pagar deudas fijas, nóminas, cuentas por pagar y otras facturas que no se pueden pagar debido al impacto del desastre. La tasa de interés es del 3.75% para las pequeñas empresas sin crédito disponible en otros lugares; las empresas con crédito disponible en otros lugares no son elegibles. La tasa de interés para las organizaciones sin fines de lucro es de 2.75%.

## SBA to provide small businesses impacted by Coronavirus (COVID-19) up to \$2 Million in Disaster Assistance Loans

WASHINGTON—SBA Administrator Jovita Carranza issued the following statement today in response to the President's address to the nation:

"The President took bold, decisive action to make our 30 million small businesses more resilient to Coronavirus-related economic disruptions. Small businesses are vital economic engines in every community and state, and they have helped make our economy the strongest in the world. Our Agency will work directly with state Governors to provide targeted, low-interest disaster recovery loans to small businesses that have been severely impacted by the situation. Additionally, the SBA continues to assist small businesses with counseling and navigating their own preparedness plans through our network of 68 District Offices and numerous Resource Partners located around the country. The SBA will continue to provide every small business with the most effective and customer-focused response possible during these times of uncertainty."

### Process for Accessing SBA's Coronavirus (COVID-19) Disaster Relief Lending

The U.S. Small Business Administration is offering designated states and territories low-interest federal disaster loans for working capital to small businesses suffering substantial economic injury as a result of the Coronavirus (COVID-19). Upon a request received from a state's or territory's Governor, SBA will issue under its own authority, as provided by the Coronavirus Preparedness and Response Supplemental Appropriations Act that was recently signed by the President, an Economic Injury Disaster Loan declaration.

Any such Economic Injury Disaster Loan assistance declaration issued

by the SBA makes loans available to small businesses and private, non-profit organizations in designated areas of a state or territory to help alleviate economic injury caused by the Coronavirus (COVID-19).

SBA's Office of Disaster Assistance will coordinate with the state's or territory's Governor to submit the request for Economic Injury Disaster Loan assistance.

Once a declaration is made for designated areas within a state, the information on the application process for Economic Injury Disaster Loan assistance will be made available to all affected communities.

SBA's Economic Injury Disaster Loans offer up to \$2 million in assistance and can provide vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing.

These loans may be used to pay fixed debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact. The interest rate is 3.75% for small businesses without credit available elsewhere; businesses with credit available elsewhere are not eligible. The interest rate for non-profits is 2.75%.

SBA offers loans with long-term repayments in order to keep payments affordable, up to a maximum of 30 years. Terms are determined on a case-by-case basis, based upon each borrower's ability to repay.

SBA's Economic Injury Disaster Loans are just one piece of the expanded focus of the federal government's coordinated response, and the SBA is strongly committed to providing the most effective and customer-focused response possible.

# Estado funcionarios de salud anuncian el lanzamiento de 2-1-1 para proporcionar COVID-19 Información y Referencias 24/7

Dos laboratorios nacionales privados autorizados para llevar a cabo las pruebas en Massachusetts; Estado recibe envíos iniciales de equipo de protección personal de la Reserva Estratégica Nacional; Orientación emitido a las escuelas primarias y secundarias

BOSTON - El Departamento de Salud Pública (DPH) anunció que hoy Massachusetts Massachusetts 2-1-1 ahora proporcionará información en tiempo real COVID-19, recursos y referencias en varios idiomas. Esta expansión es el resultado de un aumento de la inversión en recursos dirigidos a esta línea telefónica apoyada por el estado 24 horas.

A través de esta asociación con Massachusetts 2-1-1, DPH expertos en la materia están expandiendo el acceso a la información 24/7, y capacitar a los operadores de llamadas para proporcionar la información más reciente sobre el estado de los esfuerzos COVID-19 de respuesta en Massachusetts. A veces pico de llamadas, el personal del Departamento de Salud Pública aumentará el equipo llamado a garantizar preguntas de los residentes son contestadas sin demora. Este nuevo servicio se suma a un sitio dedicado [mass.gov/covid19](http://mass.gov/covid19), que se actualiza diariamente con información y recursos.

A partir de hoy, los residentes pueden llamar al 2-1-1 para obtener más información sobre:

- Prevención COVID-19, síntomas y tratamiento
- Información sobre las pruebas
- Una guía para las personas que planean o que regresan de viajes

Massachusetts 2-1-1 está abierto a las personas que llaman las 24 horas del día, 7 días a la semana. Operadores con fluidez en español están disponibles, y otros más de 150 idiomas están soportados a través de una línea de servicios de interpretación que está disponible 24/7.

Los residentes que tengan preguntas deben llamar al 2-1-1 desde cualquier teléfono fijo o móvil. Las personas que llamen al 2-1-1 escucharán un menú automatizado de opciones. Las personas que llaman pulse 2-6 para coronavirus. Los residentes también pueden llegar a 2-1-1 a través de una opción de chat en vivo en el sitio web de Massachusetts 2-1-1.

Ayer, dos laboratorios recibieron la aprobación federal para las pruebas de conducta para COVID-19 en Massachusetts. Los médicos pueden enviar las muestras sospechosas de COVID-19 pacientes a los laboratorios comerciales que están ahora en marcha. Estas pruebas no tienen que ser aprobados por el DPH.

DPH también recibió un envío inicial de equipo de protección (PPE) de ayer personal, en respuesta a una solicitud formal al Departamento de Salud y Servicios Humanos de los Estados Unidos para el EPP necesario de la Reserva Estratégica Nacional. El envío incluye batas quirúrgicas,

guantes, protección para los ojos y máscaras, que están siendo distribuidos a los profesionales de la salud pública local. Una parte del cargamento fue acelerada a Berkshire Medical Center, que recibió ayer.

El día de hoy, el Departamento de Educación Primaria y Secundaria y DPH emitieron instrucciones y orientaciones a escuelas primarias y secundarias con respecto COVID-19, incluyendo:

Con efecto inmediato, todas las escuelas debe cancelar o reprogramar grandes eventos o reuniones (incluyendo asambleas) de 250 personas o más en el futuro previsible, y las escuelas se les insta encarecidamente a posponer o cancelar otros eventos si los participantes no pueden mantener el mínimo de 6 pies de distancia recomendada - conocida como "distanciamiento social".

Todas las escuelas deben implementar políticas de saneamiento ambiental ampliado, si hay o no ha habido un caso conocido de COVID-19 en la escuela. Las escuelas deben limpiar y desinfectar las superficies que se tocan con frecuencia diaria usando un desinfectante registrado por la EPA.

- En este momento, la administración no recomienda el cierre de escuelas en todo el estado, pero la orientación permite la flexibilidad dentro de los distritos escolares donde ha habido exposición a COVID-19.

- La guía completa se puede encontrar en línea en Orientación a escuelas primarias y secundarias Respecto COVID-19 .

- El martes, el gobernador Charlie Baker, declaró el estado de emergencia para apoyar la

respuesta de la Comunidad a coronavirus. La Administración ha actualizado orientación al público en general, instando específicamente los adultos mayores y las personas con problemas de salud para evitar las multitudes y eventos. La Administración también dio a conocer las nuevas políticas a individuos a proteger en instalaciones de cuidado a largo plazo , y los sirve en los centros de atención se congregan en la comunidad y de las enfermedades respiratorias.

## State Health Officials Announce Launch of 2-1-1 to Provide COVID-19 Information and Referrals 24/7

Two private national labs approved to conduct testing in Massachusetts; State receives initial shipments of personal protective equipment from Strategic National Stockpile; Guidance issued to elementary and secondary schools

BOSTON (March 13, 2020)– The Massachusetts Department of Public Health (DPH) today announced that Massachusetts 2-1-1 will now provide real-time COVID-19 information, resources, and referrals in multiple languages. This expansion is the result of an increased investment in resources directed towards this 24-hour state-supported telephone hotline.

Through this partnership with Massachusetts 2-1-1, DPH subject matter experts are expanding access to information 24/7, and empowering call operators to provide the latest information about the status of COVID-19 response efforts in Massachusetts. At peak call times, DPH staff will augment the call team to ensure residents' questions are answered without delay. This new service is in addition to a dedicated site [mass.gov/covid19](http://mass.gov/covid19), which is updated daily with information and resources.

"We are committed to providing the most updated and accurate information about COVID-19 response efforts in Massachusetts," said Public Health Commissioner Monica Bharel, MD, MPH. "Mass 2-1-1 is an invaluable partner in helping us to ensure that every resident of the Commonwealth has access to the information they need to keep themselves and their families healthy and safe."

Beginning today, residents can call 2-1-1 to learn more about:

- COVID-19 prevention, symptoms, and treatment
- Information about testing
- Guidance for people planning or returning from travel

Massachusetts 2-1-1 is open to callers 24 hours a day, 7 days a week. Operators fluent in Spanish are available, and more than 150 other languages are supported through an interpreter services line that is available 24/7.

Residents with questions should dial 2-1-1 from any landline or cellphone. Callers dialing 2-1-1 will hear an automated menu of options. Callers press 2-6 for coronavirus. Residents can also reach 2-1-1 through a live chat option on the Massachusetts 2-1-1 website.

Yesterday, two labs received federal approval to conduct testing for COVID-19 in Massachusetts. Clinicians can send specimens from suspected COVID-19 patients to commercial labs that are now up and running. These tests do not need to be approved by DPH.

DPH also received an initial shipment of personal protective equipment (PPE) yesterday, in response to a formal request to the U.S. Department of Health and Human Services for needed PPE from the National Strategic Stockpile. The shipment included surgical gowns, gloves, eye protection and masks, which are being distributed to local public health practitioners. A portion of

the shipment was expedited to Berkshire Medical Center, which received it yesterday.

Earlier today, the Department of Elementary and Secondary Education and DPH issued instructions and guidance to Elementary and Secondary Schools regarding COVID-19, including:

- Effective immediately, all schools must cancel or reschedule large events or gatherings (including assemblies) of 250 people or more for the foreseeable future, and schools are strongly urged to postpone or cancel other events if participants cannot maintain the recommended minimum 6 feet distance – known as “social distancing.”
- All schools must implement policies on expanded environmental cleaning, whether or not there has been a known case of COVID-19 in the school. Schools must clean and disinfect frequently touched surfaces daily using an EPA-registered disinfectant.
- At this time, the administration does not recommend school closures on a statewide basis, but the guidance allows for flexibility within school districts where there has been exposure to COVID-19.

On Tuesday, Governor Charlie Baker declared a State of Emergency to support the Commonwealth's response to coronavirus. The Administration has updated guidance to the general public, specifically urging

older adults and those with health issues to avoid large crowds and events. The Administration also released new policies to protect individuals in long-term care facilities, and those served in community-based and congregate care settings from respiratory illnesses.

Individuals who live in households with vulnerable people, like elderly parents, should also consider avoiding crowds to mitigate risk. This guidance is posted on the Department of Public Health's website, [mass.gov/covid19](http://mass.gov/covid19) .

# Se renuevan varios beneficios tributarios populares para 2019; IRS acepta declaraciones que reclaman estos beneficios

WASHINGTON — El Servicio de Impuestos Internos les recuerda a los contribuyentes que está procesando declaraciones de impuestos que reclaman beneficios extendidos o modificados por la reciente legislación. La mayoría de los contribuyentes pueden presentar una declaración cuando estén listos, y como lo harían normalmente, si son elegibles para uno o más de estos beneficios, deben reclamarlos en su declaración de impuestos federales de 2019.

## Ciertas disposiciones tributarias individuales extendidas

- Deducción por matrícula calificada y gastos relacionados reclamados en el Formulario 8917, Deducción de matrícula y tarifas (en inglés),
- Deducción por primas de seguro hipotecario tratadas como interés de residencia calificado, reclamadas en el Anexo A, Deducciones detalladas (en inglés),
- Deducción por gastos médicos y dentales no reembolsados, ya que la base se redujo al 7.5% del ingreso bruto ajustado y se reclamó en el Anexo A,
- Crédito por propiedad de energía no comercial reclamada en el Formulario 5695, Créditos de energía residencial (en inglés) y
- Exclusión de ingresos por deudas canceladas por endeudamiento de residencia principal calificado donde el contribuyente no cumplió con una hipoteca que sacó para comprar, construir o mejorar sustancialmente su vivienda principal reclamada en el Formulario 982, Reducción de atributos tributarios debido a la liquidación de endeudamiento (en inglés).

## Modificación de impuestos para niños

La legislación reciente también modificó las reglas relacionadas con lo que comúnmente se llama el "Kiddie tax" para ciertos niños que tienen ingresos no ganados, que permite una elección que calcule el impuesto a base de la tasa tributaria de los padres del niño. Para el año tributario 2019, los contribuyentes pueden elegir esta aplicación alternativa para el impuesto sobre sus ingresos no derivados del trabajo al completar el Formulario 8615, Impuesto para ciertos niños que tienen ingresos no derivados del trabajo (en inglés), de manera diferente según su elección. Vea las instrucciones del Formulario 8615 en Parte II Impuesto, para obtener más información. Los contribuyentes que hacen esta elección para 2019 deben incluir una declaración con su declaración de impuestos que especifique "election to modify tax of unearned income" ("elección para modificar el impuesto sobre el ingreso no derivado del trabajo".) La declaración puede hacerse en la declaración de impuestos (por ejemplo, en la línea 7 o

en la parte superior del Formulario 8615) o en un anexo presentado con la declaración de impuestos.

## Alivio tributario en situaciones de desastre

El alivio tributario en situaciones de desastre (PDF, en inglés) también se promulgó para aquellos afectados por ciertos desastres declarados por el gobierno federal. Esto incluye (PDF, en inglés) una mayor deducción estándar a base de pérdidas calificadas por desastre y una elección para usar el ingreso del trabajo de 2018 para calcular el crédito por ingreso del trabajo de 2019 y el crédito tributario adicional por hijos.

Ciertos contribuyentes afectados por desastres declarados por el gobierno federal pueden ser elegibles para una extensión automática de 60 días para presentar, pagar sus impuestos y otros plazos administrativos.

Se pueden aplicar reglas especiales para los contribuyentes que recibieron una distribución de un acuerdo de jubilación individual, un plan de participación en las ganancias o un plan de jubilación y su hogar principal estaba en una de las áreas de desastre declaradas por el gobierno federal elegibles para estas reglas especiales.

## Declaraciones enmendadas

Además, la legislación reciente generalmente cubre tres años tributarios: 2018, 2019 y 2020, ya que la mayoría de las disposiciones expiraron a fines de 2017. Si bien el IRS lanzó la gran mayoría de los productos del año tributario 2019, el IRS también debe actualizar los productos del impuestos de 2018 afectados por estos cambios legislativos. Los contribuyentes pueden tener que presentar una declaración enmendada para reclamar estos beneficios en su declaración de 2018. El Formulario 1040-X, Declaración enmendada de impuestos sobre el ingreso individual de EE. UU., está disponible en IRS.gov/Form1040X (en inglés). Los formularios, instrucciones y anexos impactados de 2018 se revisan para reflejar la legislación promulgada el 20 de diciembre de 2019. Las revisiones actualizadas de 2018 se publicarán en IRS.gov lo antes posible para que los contribuyentes presenten las enmiendas con precisión.

El IRS trabaja en colaboración con los profesionales de impuestos y socios en la preparación de declaraciones de impuestos y las industrias de software de impuestos para prepararse y abordar los problemas que pueden ocurrir durante la temporada de impuestos. Esta colaboración continua garantiza que los contribuyentes puedan seguir confiando en el IRS, los profesionales de impuestos y los programas de software de impuestos cuando sea el momento de presentar sus declaraciones. Como siempre, la presentación electrónica y la elección del depósito directo es la manera más rápida, precisa y conveniente de recibir un reembolso de impuestos.

# NECC Now Running Essex County Corrections Educational Programs

The recent PBS documentary series College Behind Bars claims that, as a country, we have failed to provide meaningful rehabilitation for the over two million people living behind bars. With its new partnership with the Essex County Sheriff's Department (ECSD), Northern Essex Community College is working to address this issue by providing flexible educational opportunities to Essex County inmates.

The college is now offering educational programming for up to 160 students at five locations county-wide. The classes include High School Equivalency (HiSET or GED prep); English for Speakers of Other Languages (ESOL), college and career readiness; computer literacy and applications, as well as college credit courses in English and US History.

Over 90% of the students served are housed at the Middleton House of Corrections, where the classes are voluntary. Classes are also offered at the Lawrence Pre-release and Re-entry Center on a voluntary basis and at the three Offices of Community Corrections in Lawrence, Lynn, and Salisbury, where classes are required by the courts as a condition of probation or parole.

"I am proud that our correctional facility in Middleton is home to the southern campus of Northern Essex Community College," said Essex County Sheriff Kevin Coppinger. "We've made a commitment to providing opportunities for inmates to improve themselves through our Consolidated Re-entry Services division with a continuum of services, including education services, career and college readiness advising, life skills, vocational training programs and more. Northern Essex is vital partner in

these efforts," said Coppinger. All programs are open enrollment, meaning new students may leave and join the classes on any given week. "This is due to the nature of the inmate population," said Adam Cutler, NECC's director of education, corrections. "Due to pre-trial status and sentence lengths, the inmate population is in a constant flux."

## The Goal is to Reduce the Recidivism Rate

It's not surprising that inmates who participate in educational programming while incarcerated are less likely to reoffend after they are released from prison.

A study by the RAND Corporation in 2013 found that inmates who were in correctional educational programs were 43% less likely to return to prison after being released.

Educational programs, like the one Northern Essex is implementing with the ECSD, help inmates create viable education and career pathways, according to Cutler. "Investments in education provide inmates with the tools needed to get a job and/or continue their education. The resulting outcomes can be life changing for individuals and their families while making our communities safer."

## NECC Selected as Part of a Competitive Grant Process

Northern Essex was selected to run the Essex County Sheriff's Department education programs after a competitive request for proposals.

The college is working in collaboration with the ECSD's Clinical Services provider Spectrum Health Systems, Inc., which offers



evidenced-based treatments and programs including parenting, life skills, alternatives to violence and other cognitive based therapies.

More than eighteen staff members have been hired, including four on-site academic and career advisors; teachers, law librarians for the inmate's law library, which Northern Essex manages; a community

advisor to help individuals transition from jail to the community; and Cutler, the program director. Cutler reports to Chalek, the college's Center for Adult Education Executive Director,

## Representative Frank A. Moran secures \$10 Million for district in Transportation Bond Bill

State Representative Frank A. Moran (D-Lawrence, Andover and Methuen) has authored amendments included in the final version of the House transportation bond bill totaling \$10 million for the 17th Essex District. The transportation bond bill - titled An Act authorizing and accelerating transportation investment - passed the House by a vote of 150-1.

"The transportation bond bill is an opportunity for the Commonwealth to address the ongoing issues of growing traffic congestion and a lack of adequate funding for our public transit systems," said Representative Moran. "This funding also provides the Legislature the ability to fund much needed, long-term investments to a number of projects throughout Massachusetts."

Representative Moran filed an amendment to secure \$3 million for the




construction and expansion of a rail trail in the City of Lawrence and an additional \$7 million for the construction of a highway noise barrier at the confluence of Interstates I-93 and I-495 in the Town of Andover.



# From My Corner

## Don't panic

As Peggy Noonan (author, weekly columnist for The Wall Street Journal) would say, "Don't panic" is what nervous, defensive people say when someone warns of coming trouble. They don't want to hear it, so their message is "Don't worry like a coward, be blithely unconcerned like a brave person."

She also writes that this is how she has experienced it: "Captain, there appears to be an iceberg." "Don't panic, officer, full steam ahead", and, "Admiral, concentrating our entire fleet in one port seems tempting fate." "We don't need your alarmist fantasies, ensign", also "We're picking up increased chatter about an al Qaeda action." "Your hand-wringing is duly noted."

Peggy states that "Don't panic," in the current atmosphere, is a way of shutting up people who are using their imaginations as a protective tool. It's an implication of cowardice by cowards.

Mayor Rivera does not want the public to panic falls into this type of protective tool towards its residents and its employees. He is telling employees not to use facial masks thereby increasing any potential transfer of virus to its residents. He is also not telling its residents of any plans that the city may have in case of small, or major, issues related to this coronavirus.

He speaks about hospital beds in the news, but this is none of his concern. In an Eagle-Tribune interview last Wednesday he said "Holy Family and Lawrence General officials will be touring the Parthum School

on Friday because it has been designated as an 'off-site' location for extra hospital beds if local facilities run out of space." Lawrence resident and businesses want to know how Mayor Rivera and his local government will respond to a city outbreak.

I called the public relations department at Lawrence General Hospital to get more details about the plans to use the Parthum School and I was told they would call me back but no one has called.

I get it, it's tough. This is a fluid situation and I don't want you to believe I have all the answers. This nation has not seen anything to this scale. But the City has been in this situation before and has not learned anything about a written plan. The City had since the September gas explosions to come up with emergency plans. They have none. The emergency director for the City is the Fire Chief who is always outshined by the mayor. He has no plans. The Mayor has no plans. All they can say is that they speak to the Commonwealths on a daily basis and take their response from them.

By the way, Chief Moriarty has been in the hospital for a few days for an unrelated reason, according to him, but the fact remains that it has been kept from the public.

Mayor Rivera does not want to shut anything down and will not address this because for him it's a matter of local businesses losing out. But without creating a task force that could go to each local business with a training tool and resources it's just murder. No pun intended.

Employees are not allowed to use a mask. He does not think a mask will help



anyone. Maybe he should speak to Councilor Payano, who last year recommended that the city adopt the Commonwealth law as it pertains to a Department of Health & Human Services. Mayor Rivera did not adopt the law and here in the city we continue without medical experts in its arsenal of weapons to deal with this issue.

I am mostly concern with our men and women of the Police Department, Fire Department, Public Works, and every other employee that has direct interaction with the public. I know that they must serve, that's their job, no matter what. But where is their safety in all of this?

Mayor Dan Rivera, please stop treating city employees like they are disposable.

Last Thursday, he sent a message to all city employees stating, "There is no gag order with the press, but if approached by media please feel to direct them to Kate Reilly in my office (kreilly@cityoflawrence.com - 978-620-3013). I will be the official voice of the Government of the City of Lawrence, so as not to breed confusion." I doubt the mayor understands what a gag order is.

He has yet to communicate with any of the city's elderly populated buildings on the possibility that either quarantine or evacuation is necessary. He has not discussed the possibility of the dead with local funeral homes. He has yet to communicate with non-profit organizations that provide services to the thousands of elderly people in the City.

He has not reached out to the local housing authority as well. There has only been one robocall to its residents and it was related to washing your hands. He has not addressed the issues of a large gathering of people except to say that the St. Patrick's Day parade was postponed,

which means contacting every restaurant and entertainment business in the city to discuss strategy. But without an Economic Development Director in place there isn't much attention placed on businesses.

I am not saying we should close anything at this moment. I am not saying that the City should build a wall around itself. But it would be ideal if the city had its plans communicated and on their pretty little website. The information shown about Lawrence is outdated and the rest is Governor Baker's suggestions.

Mayor Rivera knew that a trial court employee had been found positive with the Coronavirus and was in the Lawrence courts for training. He said nothing to no one, not even employees and when asked, he said it was not true. Actually, he just stated that no one in Essex County was found positive with the virus. The next day that number changed.

I just wonder if he or his staffs have even bothered to check on the poor parking attendant, near the city hall and the courthouse, who have been handing out parking stubs and receiving sums of money from this very same person, or anyone else who is coming in and out of these parking lots and stations, unprotected.

# Alerta de estafa: las estafas de Robocall se vuelven políticas

Entre los anuncios políticos y la cobertura de noticias, las elecciones presidenciales de 2020 son imposibles de ignorar. Pero los votantes no son los únicos que prestan atención. De acuerdo con informes recientes de BBB Scam Tracker, los estafadores están utilizando llamadas falsas de recaudación de fondos políticos para engañar a los estadounidenses para que "donen" a un candidato favorito.

Cómo funciona la estafa

Recibe una llamada automática y contesta el teléfono. Es una voz grabada, tal vez incluso una que suena como uno de los candidatos presidenciales. Según la grabación, los rivales han estado recaudando mucho dinero. Para ver a su candidato favorito elegido, debe donar... inmediatamente.

Si ofrece dar, será transferido a una persona en vivo y le pedirá la información de su tarjeta de crédito. Pero su dinero no irá a apoyar la causa política. En cambio, la persona que llama por teléfono falsificará su dinero y/o información personal que puede ser utilizada para el robo de identidad. A medida que se calienta la campaña electoral de 2020, esté atento a más versiones de esta estafa.

Cómo evitar las estafas de Robocall

- Filtrar sus llamadas telefónicas. Si recibe una llamada de un número que no reconoce, no responda. Incluso si el número le resulta familiar, tenga cuidado. Verifique el número en Whitepages.com (un negocio acreditado por BBB) para ver si se ha marcado con una alerta de fraude.
- No responda a llamadas automáticas no solicitadas. Si recibe una llamada automática no solicitada que parece



provenir de un negocio legítimo, tenga cuidado. Los estafadores pueden falsificar el identificador de llamadas, y las empresas solo pueden llamarlo por robocall con su permiso por escrito. Si alguien lo llama de la nada, lo más probable es que sea una estafa. La mejor práctica es colgar el teléfono sin interactuar con la llamada. No "presione 1 para ser eliminado de nuestra lista"; eso solo confirma al estafador que su número es bueno.

• Regístrese en el Registro de No Llamar. Este paso no evitará que los estafadores lo llamen, pero reducirá la cantidad de llamadas de marketing legítimas que reciba, lo que facilitará la identificación de las fraudulentas. Si vive en los Estados Unidos, llame al 888-382-1222 ó regístrate en línea en Donotcall.gov. Si vive en Canadá, visite la Lista Nacional de No Llamar.

## Scam Alert: Robocall Scams Get Political

Between the political ads and the news coverage, the 2020 presidential election is impossible to ignore. But voters aren't the only ones paying attention. According to recent BBB Scam Tracker reports, scammers are using phony political fundraising calls to trick Americans into "donating" to a favorite candidate.

How the Scam Works

You receive a robocall and answer the phone. It's a recorded voice – perhaps even one that sounds just like one of the presidential candidates. According to the recording, rivals have been raising a lot of money. In order to see your favorite candidate elected, you need to donate... immediately.

If you offer to give, you'll be transferred to a live person and asked for your credit card information. But your money won't go to support the political cause. Instead, the phony caller will make off with your money and/or personal information that can be used for identity theft. As the 2020 election campaign heats up, be on the lookout for more versions of this con.

How to Avoid Robocall Scams

- Screen your calls. If a call comes in from a number you don't recognize, don't answer. Even if the number looks familiar, be wary. Check the number on Whitepages.

## DECLARACIÓN: Neera Tanden de CAP sobre los últimos esfuerzos para combatir la crisis del Coronavirus

Washington, D.C. — El presidente declaró al coronavirus como una emergencia nacional ayer, invocando la Ley Stafford. Además, la Cámara de Representantes de los Estados Unidos aprobó la Ley de Respuesta al Coronavirus: Las Familias Primero. Esta legislación de emergencia mejoraría la salud y seguridad financiera de las familias en el país al suministrar exámenes gratuitos para identificar coronavirus; proporcionar licencias de emergencia remuneradas; ampliar el seguro de desempleo; aumentar el apoyo federal para los programas estatales de Medicaid, y apuntalar iniciativas de seguridad alimentaria, entre otras medidas. También brindaría asistencia necesaria a personas de bajos ingresos, niños y familias que ya enfrentaban desafíos económicos previo a esta crisis.

Neera Tanden, presidenta y directora ejecutiva del Center for American Progress, emitió esta declaración:

Esta es una crisis de salud pública que se está convirtiendo rápidamente en una crisis económica para las familias de todo el país. Nuestra respuesta a este desafío debe cumplir con la magnitud del problema y guiarse ante todo por la ciencia.

Después de semanas de intentar subestimar la amenaza del coronavirus, el presidente ya no puede ignorar la realidad científica de la crisis que enfrentamos. Declarar una emergencia nacional, aunque tan atrasada, es la decisión correcta. Esta acción necesaria de manera urgente, empoderará a la Agencia Federal para el Manejo de Emergencias (FEMA, por sus siglas en inglés); al Departamento de Salud y Servicios Humanos de los EE.UU., y

otras agencias federales para brindar apoyo adicional a los estados para responder a esta crisis, incluso aumentando la capacidad de la fuerza laboral de atención médica y los suministros, al ayudar con la logística.



### Jason Moon, Host of Bear Brook, Kicks off Library True Crime Series

In 1985 the bodies of a mother and her 7-year-old daughter were discovered in a barrel in New Hampshire's Bear Brook State Park. In 2000, the bodies of a second daughter and another girl were found nearby.

Not until 2017 was the likely suspect identified, and it was just last year that three of the victims were identified, through DNA evidence and forensic genealogy.

NHPR's podcast, Bear Brook, tells this heartbreaking story, and its host, Jason Moon, will share it with you at the Nashua Public Library on March 5.

Moon will talk about the longtime mysteries surrounding the case, how his

reporting came about, and the role science played in cracking key aspects of the crime. Subscribers to the podcast, longtime followers of this New Hampshire story, and all true crime fans are welcome.

The event, which begins at 7 p.m., is the first of three true crime programs at the library this spring. The second, "Do You Know Where Your DNA Is?" will be held on Sunday, March 22, at 2 p.m. The third is a talk by Victor Rosario, who spent 32 years behind bars, accused of arson and murder, before his case was overturned. That event will be held on Thursday, May 7, at 7 p.m. All these events are free and open to the public.


