## Nativo de Lawrence sirviendo en el USS Constitution



### Lawrence Native Selected to Serve Aboard Oldest Commissioned Warship Afloat: USS Constitution

Lawrence, Massachusetts native, Boatswain's Mate 2nd Class Jason Santamaria, earned his basic interpretive historian qualification aboard USS Constitution, Aug. 13.

Duty aboard USS Constitution is one of the Navy's special programs, and all prospective crewmembers must meet a high standard of sustained excellence and interview to be selected for the assignment.

The basic interpretive historian qualification means that a sailor has studied and trained on the history of USS Constitution and has learned about the ship's major historic battles, its unique design and the life of a sailor during the 19th century.

Crew members who achieve the basic interpretive historian are authorized to wear a unique command ball cap, with the word 'crewmember' embroidered on the back, in place of the Navy's standard eight-point cover or hat.

"There is so much rich history about the ship but I'm happy to have learned all I

have," said Santamaria

Santamaria has served in the Navy for five years, and his previous duty station was the nuclear-powered aircraft carrier USS Dwight D. Eisenhower (CVN 69).

Santamaria is a 2014 graduate of Lawrence High School.

USS Constitution is the world's oldest commissioned warship afloat, and played a crucial role in the Barbary Wars and the War of 1812, actively defending sea lanes from 1797 to 1855.

The active-duty sailors stationed aboard USS Constitution normally provide free tours and offer public visitation to more than 600,000 people each year as they support the ship's mission of promoting the Navy's history, maritime heritage, and raising awareness of the importance of a sustained naval presence.

USS Constitution was undefeated in battle and captured or destroyed 33 enemy vessels.

The ship earned the nickname of Old Ironsides during the war of 1812 after British cannonballs were seen bouncing off the ship's wooden hull.

El nativo de Lawrence, Massachusetts, el contramaestre de segunda clase Jason Santamaria, obtuvo su título básico de historiador interpretativo a bordo del USS Constitution, el 13 de agosto.

El deber a bordo del USS Constitution es uno de los programas especiales de la Marina, y todos los posibles miembros de la tripulación deben cumplir con un alto estándar de excelencia sostenida y una entrevista para ser seleccionados para la asignación.

La calificación básica de historiador interpretativo significa que un marinero ha estudiado y entrenado en la historia del USS Constitution y ha aprendido sobre las principales batallas históricas del barco, su diseño único y la vida de un marinero durante el siglo XIX.

Los miembros de la tripulación que logran el título de historiador interpretativo básico están autorizados a usar una gorra de béisbol de comando única, con la palabra "miembro de la tripulación" bordada en la parte posterior, en lugar de la gorra o sombrero estándar de ocho puntos de la Marina.

"Hay mucha historia rica sobre el barco, pero estoy feliz de haber aprendido

todo lo que tengo", dijo Santamaria.

Santamaria ha servido en la Marina durante cinco años, y su lugar de destino anterior era el portaaviones de propulsión nuclear USS Dwight D. Eisenhower (CVN 69).

Santamaria se graduó en 2014 de Lawrence High School.

El USS Constitution, es el buque de guerra comisionado más antiguo del mundo a flote, y jugó un papel crucial en las Guerras de Berbería y la Guerra de 1812, defendiendo activamente las rutas marítimas de 1797 a 1855.

Los marineros en servicio activo estacionados a bordo del USS Constitution normalmente ofrecen recorridos gratuitos y visitas públicas a más de 600,000 personas cada año, ya que apoyan la misión del barco de promover la historia de la Armada, el patrimonio marítimo y crear conciencia sobre la importancia de una presencia naval sostenida.


El USS Constitution quedó invicto en la batalla y capturó o destruyó 33 naves enemigas.

El barco se ganó el apodo de Old Ironsides durante la guerra de 1812 después de que se vieran balas de cañón británicas rebotando en el casco de madera del barco.

**NECESITAMOS TRABAJADORES ELECTORALES**

La Elecciones Estatales rápidamente se aproximan y la Ciudad de Lawrence necesita trabajadores electorales que trabajen el martes, 1 de septiembre 2020 y martes 3 de noviembre 2020.

Un mínimo compromiso desde la 6:30 a.m. hasta que las urnas oficialmente cierren [que usualmente es de 8:30 p.m. o 9:00 p.m.]. No obstante, las horas de trabajo pueden ser extendidas más allá del periodo del tiempo si es necesario. Un compromiso para trabajar el día completo es preferible pero turnos para trabajar un medio día de 6 horas puede ser considerado.

Si usted está registrado para votar en el Estado de Massachusetts usted es elegible para trabajar como un trabajador electoral en la Ciudad de Lawrence. Residentes de Lawrence y todos aquellos fluidos en el idioma de Español/Ingles serán tomados como primera preferencia.

Los trabajadores electorales reciben \$140 por un día completo –Secretarios/a reciben \$180 [día completo]- y Guardianes reciben \$220 [día completo]. La compensación por servicio de medio día puede estar disponible y se calculará en función de la tarifa de día completo. Cada trabajador que asista al el entrenamiento mandatorio recibe \$20.00 adicional [Trabajadores reciben el pago de \$20.00 para una sola sesión del entrenamiento y solo es pagado aquellos que son asignados a trabajar el día de la elección.]

**POLL WORKERS NEEDED**

The State Elections are rapidly approaching and the City of Lawrence needs the assistance of poll workers, poll clerks, and poll wardens to work on Tuesday, September 1, 2020 and Tuesday, November 3, 2020.

A minimum time commitment is from 6:30 a.m. until polls are officially closed [which is usually about 8:30 p.m. or 9:00 p.m.]. However, the hours to work may extend beyond that time period as needed. A full day commitment is preferred but half-day shifts of 6 hours may be arranged.

If you are registered to vote in the Commonwealth of Massachusetts you are eligible to work as a poll worker in the City of Lawrence. Lawrence residents and those fluent in Spanish/English language are preferred.

Poll workers receive \$140.00 for a full day – Clerks receive \$180 [full day] – Wardens receive \$220 [full day]. Half day compensation rates are calculated pro-rata on the full day rate. Each worker attending mandatory training sessions receive an additional \$20.00 for training attendance [Workers receive payment of \$20.00 for one training session only and is paid only to those workers placed into service.]

# Desde Mi Esquina

## El Senador Markey exagera

Algo nuevo durante los debates es el uso de "fact-checkers" (personas que están comprobando la veracidad de lo que el oponente a su candidato diga instantáneamente) y hace más interesante verlos porque sabemos inmediatamente cuándo los candidatos mienten.

En el reciente debate entre Joe Kennedy y Ed Markey en WCVB-TV, el senador declaró que ha escrito más de 500 proyectos de ley que se han convertido en leyes. En menos de 5 minutos después de pronunciar esa declaración, la campaña de Kennedy me envió este comunicado:

"Según Congress.gov, solo se han promulgado 15 leyes de su autoría. Según el recuento más generoso de GovTrack, solo 27 de los proyectos de ley del Senador Markey se han convertido en ley. Una discrepancia de más de 500 facturas no se puede justificar con metodologías diferentes."

"De los proyectos de ley que dice haber sido el autor, la gran mayoría fueron escritos por otros miembros del Congreso, que el Senador Markey simplemente copatrocinó. Aproximadamente la mitad de estos proyectos de ley son resoluciones o medidas ceremoniales para cambiar el nombre de edificios federales o distribuir monedas conmemorativas. Entre los proyectos de ley que afirma haber sido el autor, más de la mitad se presentaron semanas o meses antes de que el Senador Markey agregara su nombre como copatrocinador".

Quizás esa sea la razón por la que el Representante Estatal Marcos Devers hace lo mismo. Seamos realistas: si otros lo hacen a nivel federal, él cree que está excusado. Ha estado reciclando los mismos 4 proyectos de leyes durante los últimos 10 años para dar la impresión de que está haciendo algo, incluso cuando no tiene la intención de luchar por ellos.

Mientras tanto, es co-auspiciador en cientos de proyectos de ley patrocinados por otros representantes.

## Mi opinión sobre el voto por correos

Durante mi participación en el programa de radio A Fuego Cruzado, con Santiago Matías, Nazario Esquea y José Alfonso García, mencioné mis razones para oponerme al envío de la boleta por correo porque se enviarán a cualquier persona

inscrita para votar y esas boletas podrían ser mal utilizadas en la mano de cualquier persona que no sea el destinatario.

Como ejemplo, ofrezco el caso de nuestro propio Alcalde Dan Rivera, que vive en 2 Thomas Rd. Kevin Clement y su esposa le vendieron la casa hace tres años, pero siguen siendo votantes en esa dirección, aunque ahora viven fuera de Lawrence. Deberían haberse dado de baja de la lista de votantes pero, como no hicieron eso, la Ciudad debe esperar cuatro años y esa es la ley federal.

Algunos políticos utilizan la lista de inactivos para presentar de manera fraudulenta votos ausentes.

La respuesta del Estado al problema es poner la responsabilidad en las ciudades y pueblos y hacer que determinen quién se muda o no. ¿Qué se supone que deben hacer? Ir a las casas y ver quién vive en ellas? ¡Eso es una locura!

Ahora tenemos cuatro métodos de votación: Voto por correo, Voto anticipado, Voto en ausencia y Voto en persona. Es su elección si no se siente seguro al votar en persona, solicitar una boleta de voto en ausencia o póngase la máscara y vote en el Ayuntamiento (consulte las fechas y horarios en la página 5). Recientemente publiqué una broma en Facebook, "La gente va a Walmart y HomeDepot, ¡pongamos las urnas allí!"

En Lawrence, la gente sigue teniendo fiestas en el patio sin tener en cuenta las recomendaciones por la pandemia. Si la gente va a restaurantes manteniendo una distancia segura entre las mesas o al aire libre, ¿por qué no pueden votar en persona? Sigo diciendo que la integridad de la votación por correo depende de nosotros, no del correo.

Según el New York Post, "Un juez ha dictaminado que se celebrarán nuevas elecciones en noviembre para un escaño en disputa en el Concejo Municipal de Paterson, NJ pocas semanas después de que el aparente ganador de la carrera y un concejal en funciones fueran acusados de fraude electoral.

"Alex Méndez había ganado una elección especial el 12 de mayo para ocupar el puesto, pero pronto surgieron denuncias de fraude electoral. Luego se inició una investigación después de que el brazo de aplicación de la ley del Servicio Postal de los EE.UU. informara a la oficina del fiscal general del estado sobre cientos de boletas por correo ubicadas en un buzón en Paterson, junto con otras más encontradas en las cercanías de Haledon".

Voters who are registered and eligible to vote in the State Primary to be held on Tuesday, September 1, 2020 may cast and Early Voting ballot “in person” or “by mail”.

### How do I Vote Early? Voting in Person:

Early Voting in Lawrence is available to voters who may appear “in person” to vote at Lawrence City Hall, City Council Chambers, 200 Common Street, Lawrence, MA beginning Saturday, August 22, 2020 through and including Friday, August 28, 2020 during the following dates and times: Massachusetts laws do not allow for any ballot be given to the voter to be taken out of the City Council Chambers which will serve as a Polling Location for this purpose. All Early Voting ballots must be completed while in City Hall.

### Early Voting by Mail:

Registered voters may request an Early Voting ballot through the mail by filling out an application and mailing it or delivering it to the Lawrence Election Division, Room B-4, 200 Common Street, Lawrence, MA 01840. A copy of the Early Voting application can be obtained from the Lawrence Election Division Office located at this address or from the website of the Office of the Secretary of State for

the Commonwealth of Massachusetts.

Early Voting applications must be received by the Lawrence Election Division or the City Clerk’s Office no later than 5:00 on Wednesday, August 26, 2020. It is encouraged that voters file an application for an Early Voting ballot as early as possible in order to assure that the ballot can be mailed to the voter and returned to the Lawrence Election Division or City Clerk’s Office by the voter at City Hall in a timely manner. All Early Voting ballots must be received by the Lawrence Election Division before the close of polls on Tuesday, September 1, 2020 [the day of the State Primary Election]. All polls close in Lawrence on Election Day - Tuesday, September 1, 2020 at 8:00 p.m. Remember to return Early Voting Ballots to the Lawrence Election Division office in City Hall and NOT to any polling location.

Remember: Voters who cast an Early Voting ballot may no longer vote at the polls on Election Day.

The Massachusetts Registry of Motor Vehicles (RMV) is extending the timeframe for which eligible customers can renew their Massachusetts driver's license or Massachusetts ID card online at Mass.Gov/RMV in order to qualify for a free upgrade to a REAL ID credential in 2021.

The cost for renewing a driver's license

is \$50. The cost for renewing an ID card is \$25. These costs are the same for both a standard or REAL ID license or ID card.

Driver's licenses and ID cards that expired or were set to expire in July have been extended until November 2020.

# El Representante Estatal Frank A. Morán obtiene más de \$1 millón para el Distrito 17

Frente a una economía sufrida por COVID-19, el Representante Estatal Frank A. Morán, se unió al Presidente DeLeo y a sus colegas en la Cámara para aprobar un proyecto de ley para darle una oportunidad a la economía del estado al legalizar los juegos deportivos, facilitar el desarrollo de viviendas y proporcionar más de \$450 millones en fondos estatales para estimular el crecimiento.

“Este proyecto de ley de desarrollo económico integral brindará alivio financiero a la economía de nuestro estado, así como a las comunidades individuales dentro de nuestro estado”, dijo el Representante Estatal Frank A. Morán (D - Lawrence). “Me enorgulleció asegurar más de \$1 millón en fondos directos para Lawrence, Andover y Methuen que los equiparán con los recursos que reforzarán e invertirán dentro de nuestra comunidad de pequeñas empresas”.

El Representante Morán abogó por la asignación de fondos para las organizaciones locales en Lawrence, Andover y Methuen:

- \$100,000 para que la Ciudad de Lawrence rehabilite su cancha de handball
- \$200,000 para el Andover Senior Center
- \$125,000 para la programación juvenil del vecindario de Arlington en Methuen
- \$50,000 para capacitación laboral en el vecindario de Arlington en Methuen
- \$75,000 para la promoción de pequeñas empresas locales en la Ciudad de

Methuen

- \$500,000 para un puente peatonal en Lawrence Rail Trail

Además, el proyecto de ley combina iniciativas para mejorar el mercado de la vivienda para los compradores y, al mismo tiempo, brinda protección a los inquilinos. Autoriza el concepto de elección de vivienda, lo que reduce el requisito de votación para una variedad de cambios de zonificación relacionados con la vivienda y permisos especiales a nivel local, desde un umbral de dos tercios hasta una mayoría simple. La legislación también crea una opción local para el derecho del inquilino a comprar/primer derecho de negarse a comprar edificios que los propietarios ponen a la venta, aumenta el crédito fiscal para viviendas para personas de bajos ingresos de \$20 millones a \$40 millones, y requiere que el DHCD notifique a los inquilinos que tienen un derecho a la mediación con los propietarios antes del proceso de desalojo. El proyecto de ley establece el Crédito Tributario para Empleos Rurales para las empresas que realicen una contribución de capital a un fondo de crecimiento rural, que se establecerá dentro de la Oficina de Desarrollo Empresarial. Permite la creación de Distritos de Comercialización de Destinos Turísticos, que, luego de la aprobación local, pueden agregar un recargo adicional del 2% a los impuestos por ocupación de habitaciones para

financiar actividades de comercialización turística dentro de estos distritos. La legislación también crea una Comisión de Recuperación del Consejo Cultural para revisar y desarrollar recomendaciones para la recuperación, promoción y crecimiento continuo y vitalidad del sector cultural y creativo en el Commonwealth.

El proyecto de ley inicia un sistema para juegos deportivos legales en Massachusetts que permite a la Comisión de Juegos de Massachusetts independiente otorgar licencias en persona a los casinos e instalaciones de carreras existentes. Las aplicaciones móviles y los casinos también son elegibles para recibir licencias de juegos móviles. Además de las tarifas de licencia, el estado recibirá el 15% de todas las ganancias de las apuestas deportivas - \$50 millones anuales - (con un 1% adicional para los juegos jugados en Massachusetts que se destinará a un fondo para garantizar la integridad del juego). Se

distribuirá de la siguiente manera:

- 40% a un fondo de desarrollo de la fuerza laboral para jóvenes en riesgo en comunidades minoritarias o de bajos ingresos
- 30% a un Fondo para restaurantes en dificultades que ayudaría a más de 1,000 restaurantes a pagar el alquiler, la nómina y el PPE durante un período de dos años
- 10% para iniciativas de desarrollo juvenil (aumentado al 25% después de enero de 2023), incluidas becas y programas extracurriculares
- 10% a ayuda local (aumentado al 25% después de enero de 2023)
- 9% a la salud pública, incluida la adicción a los juegos
- 1% al fondo benéfico de un jugador para pagar fundaciones benéficas conectadas a jugadores locales.

## State Representative Frank A. Morán Secures More than \$1 Million in Funding for the 17th District

Faced with an economy buffeted by COVID-19 State Representative Frank A. Morán joined Speaker DeLeo and their colleagues in the House to pass a bill to give a shot in the arm to the state's economy by legalizing sports gaming, facilitating housing development and providing more than \$450 million in state funding to spur growth.

“This comprehensive economic development bill will provide financial relief to our state's economy, as well as the individual communities within our Commonwealth,” said State Representative Frank A. Morán (D - Lawrence). “I was proud to secure more than \$1 million in direct funding for Lawrence, Andover, and Methuen that will equip them with the resources that will bolster and invest within our small business community.”


Representative Morán advocated for the allocation of funds for local organizations in Lawrence, Andover, and Methuen:

- \$100,000 for the City of Lawrence to rehabilitate its handball court
- \$200,000 for the Andover Senior Center
- \$125,000 for Methuen Arlington Neighborhood youth programming
- \$50,000 for Methuen Arlington Neighborhood jobs training
- \$75,000 for the promotion of local, small businesses in the City of Methuen
- \$500,000 for a pedestrian footbridge on the Lawrence Rail Trail

landlords prior to the eviction process. The bill establishes the Rural Jobs Tax Credit for businesses that make a capital contribution to a rural growth fund, which will be established within the Office of Business Development. It allows for the creation of Tourism Destination Marketing Districts, which, following local approval, can add an additional 2% surcharge on room occupancy taxes to fund tourism marketing activities within these districts. The legislation also creates a Cultural Council Recovery Commission to review and develop recommendations for the recovery, promotion and continued growth and vitality of the cultural and creative sector in the commonwealth.

The bill initiates a system for legal sports gaming in Massachusetts enabling the independent Massachusetts Gaming Commission to grant in-person licenses to existing casinos and racing facilities. Mobile applications and casinos are also eligible to receive mobile gaming licenses. In addition to licensing fees, the state will receive 15% of all sports betting proceeds -- \$50 million annually -- (with an additional 1% for games played in Massachusetts going to a fund to ensure the integrity of the game.) The proceeds will be distributed in the following fashion:

- 40% to a workforce development fund for at-risk youth in low-income/minority communities
- 30% to a Distressed Restaurant Fund that would help over 1,000 restaurants pay for things like rent, payroll, and PPE for a period of two years
- 10% to Youth Development Initiatives (raised to 25% after January 2023), including scholarships and after-School programs
- 10% to Local Aid (raised to 25% after January 2023)
- 9% to Public Health, including Gaming Addiction
- 1% to a Player's Benevolent fund to pay for local player connected charity foundations.

# La vacuna contra la influenza ahora es necesaria para todos los estudiantes en Massachusetts

Los funcionarios estatales de salud pública anunciaron hoy que se requerirá la vacunación contra la influenza para todos los niños de 6 meses de edad o mayores que asistan al cuidado infantil, preescolar, jardín de infantes, y 12º grado de Massachusetts, y universidades. El requisito de la nueva vacuna es un paso importante para reducir las enfermedades relacionadas con la influenza y el impacto general de las enfermedades respiratorias durante la pandemia de COVID-19.

Se espera que los estudiantes hayan recibido una vacuna contra la influenza antes del 31 de diciembre de 2020 para la temporada de influenza 2020-2021, a menos que se proporcione una exención médica o religiosa. También están exentos los estudiantes K-12 que son educados en el hogar y los estudiantes de educación superior que están completamente fuera del campus y solo participan en el aprendizaje remoto. Este nuevo requisito de vacunación contra la influenza para ingresar a la escuela en enero se suma a los requisitos de vacunación existentes para todos los que asisten a guarderías, preescolares, jardín de infantes a 12º grado y colegios y universidades en Massachusetts. Los estudiantes de primaria y secundaria en distritos y escuelas que utilizan un modelo de

educación remota no están exentos.

“Cada año, miles de personas de todas las edades se ven afectadas por la influenza, lo que provoca muchas hospitalizaciones y muertes”, dijo el Dr. Larry Madoff, director médico de la Oficina de Enfermedades Infecciosas y Ciencias de Laboratorio del DPH. “Es más importante ahora que nunca vacunarse contra la influenza porque los síntomas de la influenza son muy similares a los del COVID-19 y prevenir la influenza salvará vidas y preservará los recursos de atención médica”.

Todos los niños de al menos 6 meses de edad que asisten a la guardería o al preescolar deben vacunarse de acuerdo con el Programa de vacunación recomendado por el ACIP.

Todos los estudiantes de K-12 deben recibir la vacuna contra la influenza estacional anualmente antes del 31 de diciembre. Los estudiantes nuevos que ingresen entre el 1 de enero y el 31 de marzo deben haber recibido una dosis de la vacuna para la temporada de influenza actual antes de ingresar.

Según la edad del niño y los antecedentes de vacunación contra la influenza, se puede recomendar una segunda dosis de la vacuna contra la influenza en la misma temporada. En estos casos, no se requiere la segunda dosis para ingresar a la escuela.



Para los estudiantes mayores, el requisito de la vacuna contra la influenza se aplica a todos los estudiantes de pregrado y posgrado de tiempo completo menores de 30 años y a todos los estudiantes de ciencias de la salud de tiempo completo y parcial. El requisito incluye a personas de fuera de los EE.UU. que asisten o visitan clases o programas educativos en Massachusetts como parte de un programa académico de visitas o intercambio. La única excepción es para los estudiantes universitarios que

asisten exclusivamente a clases en línea y nunca visitan el campus en persona. Los estudiantes universitarios que asistan a cualquier clase o actividad en el campus, aunque sea una vez, deben vacunarse antes del 31 de diciembre.

# Flu Vaccine Now Required for all Massachusetts School Students

## Together We Can Beat the Flu

6 Tips to Stay Healthy this Flu Season



State public health officials today announced that influenza immunization will be required for all children 6 months of age or older who are attending Massachusetts child care, pre-school, kindergarten, K-12, and colleges and universities. The new vaccine requirement is an important step to reduce flu-related illness and the overall impact of respiratory illness during the COVID-19 pandemic.

Students will be expected to have received a flu vaccine by December 31, 2020 for the 2020-2021 influenza season, unless either a medical or religious exemption is provided. Also exempted are K-12 students who are homeschooled and higher education students who are completely off-campus and engaged in remote learning only. This new flu

immunization requirement to enter school in January is in addition to existing vaccine requirements for all those attending child care, preschool, K-12, and colleges and universities in Massachusetts. Elementary and secondary students in districts and schools that are using a remote education model are not exempt.

"Every year, thousands of people of all ages are affected by influenza, leading to many hospitalizations and deaths," said Dr. Larry Madoff, Medical Director, DPH's Bureau of Infectious Disease and Laboratory Sciences. "It is more important now than ever to get a flu vaccine because flu symptoms are very similar to those of COVID-19 and preventing the flu will save lives and preserve healthcare resources."

All children at least 6 months old who

attend child care or preschool must be immunized in accordance with the ACIP Recommended Immunization Schedule.


All students in K-12 must receive the seasonal influenza vaccine annually by December 31. New students entering between January 1 and March 31 must have received a dose of vaccine for the current flu season before entry.

Depending on the child's age and flu vaccination history, a second dose of flu vaccine in the same season may be recommended. In these cases, the second dose is not required for school entry.

For older students, the flu vaccine requirement applies to all full-time undergraduate and graduate students under

30 years of age and all full- and part-time health science students. The requirement includes individuals from outside the U.S. attending or visiting classes or educational programs in Massachusetts as part of an academic visitation or exchange program. The only exception is for college and university students who exclusively attend classes online and never visit campus in person. College students who attend any classes or activities on campus, even once, must be vaccinated by December 31.

WASHINGTON – En un evento virtual, la Administración Nacional de Seguridad del Tráfico en las Carreteras (NHTSA) del Departamento de Transporte de EEUU lanzó su campaña de Labor Day de cumplimiento de alta visibilidad de la ley sobre el manejo borracho, recordando a las personas que viven en Estados Unidos que no manejen borrachos. Este año una campaña publicitaria nacional de \$10 millones respaldará el cumplimiento de alta visibilidad de la ley. Los automovilistas pueden esperar ver más agentes del orden público en las carreteras desde el 19 de agosto al 7 de septiembre.

“El manejo borracho es una de las principales causas de muertes en las carreteras de nuestra nación, y durante este fin de semana del Labor Day, por favor toma acción para evitar estas tragedias completamente prevenibles”, dijo la Secretaria de Transporte de EEUU, Elaine L. Chao.

Los últimos datos de NHTSA sobre el manejo bajo la influencia de alcohol muestran que, en 2018, 10,511 personas murieron en choques automovilísticos que involucraron a un conductor con una concentración de alcohol en la sangre (BAC) de .08 g/dL o más, el 29% de todas las muertes causadas por choques automovilísticos ese año. Aproximadamente dos tercios (7,051) de todas las muertes causadas por conductores borrachos ocurrieron en choques que involucraron a un conductor con un BAC de .15 g/dL o más – casi el doble del límite legal en la mayoría de los estados.

La campaña de este año se extenderá

hasta el fin de semana del Labor Day, una de las temporadas más mortales del año en las carreteras de Estados Unidos. Durante este período, miles de agencias del orden público estatales y locales participantes estarán monitoreando las carreteras para proteger al público de los conductores borrachos.

“El objetivo de nuestra campaña es crear conciencia nacional sobre los peligros de manejar borracho, y prevenir muertes y lesiones futuras causadas por choques”, dijo el Administrador Adjunto de NHTSA, James Owens. “NHTSA exhorta a todos a celebrar este Labor Day de forma socialmente distanciada y segura, y crear un plan que impide que tú, tus amigos o tu familia manejen bajo la influencia”.

Con el Administrador Adjunto de NHTSA, James Owens, al evento virtual asistieron la Secretaria Chao, la Presidenta Nacional de las Madres en Contra de Manejar Borracho (MADD), Helen Witty, representantes de la Patrulla de Carreteras de California y la Patrulla de Carreteras de Tennessee y Ed y Denise Hill.

El manejo bajo la influencia de cualquier sustancia—alcohol o drogas, ya sea legal o ilegal—es contra la ley en los 50 estados y el Distrito de Columbia. Incluso en los estados en los que las leyes sobre el uso de marihuana han cambiadas, todavía es ilegal manejar bajo la influencia de la droga. Los medicamentos con prescripción y de venta libre también pueden afectar negativamente nuestra capacidad de manejar de forma segura, y el manejo bajo su influencia es ilegal.



## US Department of Transportation reminds everyone: Drive Drunk and You Will Be Arrested

WASHINGTON - At a virtual event, the National Highway Traffic Safety Administration (NHTSA) of the U.S. Department of Transportation launched its high-visibility Labor Day enforcement campaign on the drunk driving law, reminding the people who live in the United States not to drive drunk. This year a \$10 million national ad campaign will support high visibility enforcement of the law. Motorists can expect to see more law enforcement officers on the roads from Aug. 19 to Sept. 7.

“Drunk driving is a leading cause of death on our nation’s highways, and this Labor Day weekend, please take action to prevent these completely preventable tragedies,” said US Secretary of Transportation Elaine L. Chao.

The latest NHTSA data on driving under the influence shows that, in 2018, 10,511 people were killed in motor vehicle crashes involving a driver with a blood alcohol concentration (BAC) of .08 g/dL or more, 29% of all deaths caused by motor vehicle crashes that year. About two-thirds (7,051) of all drunk driving fatalities occurred in crashes involving a driver with a BAC of .15 g/dL or higher - almost double the legal limit in most states.

This year’s campaign will run through Labor Day weekend, one of the deadliest seasons of the year on America’s roads. During this period, thousands

of participating state and local law enforcement agencies will be monitoring the roads to protect the public from drunk drivers.

“The goal of our campaign is to raise national awareness of the dangers of drunk driving, and to prevent future deaths and injuries caused by crashes,” said NHTSA Deputy Administrator James Owens. “NHTSA encourages everyone to celebrate this Labor Day in a socially distanced and safe way, and create a plan that prevents you, your friends, or your family from driving under the influence.”

With NHTSA Deputy Administrator James Owens, the virtual event was attended by Secretary Chao, National Mothers Against Drunk Driving (MADD) President, Helen Witty, representatives from the California Highway Patrol and the California Highway Patrol, Tennessee and Ed and Denise Hill.

Driving under the influence of any substance — alcohol or drugs, whether legal or illegal — is against the law in all 50 states and the District of Columbia. Even in states where the laws on the use of marijuana have changed, it is still illegal to drive under the influence of the drug. Prescription and over-the-counter medications can also negatively affect our ability to drive safely, and driving under their influence is illegal.

# Consejo de BBB: Consejos de seguridad en Internet para el regreso a clases

Es posible que varios distritos escolares estén retomando donde lo dejaron en marzo, cuando muchas escuelas en el país cerraron repentinamente debido a las preocupaciones sobre el coronavirus. Ahora, a medida que nos acercamos al comienzo del año escolar, los maestros, administradores y familias se están adaptando a un primer día de clases inusual, y muchas escuelas se enfocan en el aprendizaje en línea. Better Business Bureau (BBB) alienta a todos a mantenerse seguros mientras están en línea y evitar ser un blanco fácil para los estafadores en línea.

## Padres: tengan cuidado

Crear cuentas en sitios web sin permiso: los sitios de redes sociales están llenos de extraños con intenciones que pueden ser bastante diferentes a las suyas. Muchos sitios están diseñados para recopilar y vender detalles y comportamientos de usuarios no autorizados a anunciantes que buscan participar en marketing dirigido. Al crear una cuenta, algunos niños pueden crear falsamente una fecha de nacimiento para cumplir con el requisito de edad mínima. Sepa lo que su hijo está haciendo en línea y realice un seguimiento de los sitios de redes sociales y las cuentas a las que tiene acceso.

**Concursos y obsequios:** los concursos y obsequios suelen recopilar una gran cantidad de información personal en sus formularios de participación. Muchas son formas apenas disimuladas de recopilar información personal o financiera que podrían conducir al robo de identidad. Asegúrese de que su hijo no tenga acceso a información bancaria o de tarjetas de crédito y supervise el llenado de los formularios.

**Phishing:** los adultos no son los únicos que reciben spam y correo basura. Los niños a menudo reciben correo basura y, dado que no tienen mucha experiencia en línea, es más probable que sean susceptibles de hacer clic en enlaces y responder preguntas que probablemente no deberían. Si bien algunos correos electrónicos pueden ser legítimos, lo último que los padres quieren o necesitan es una factura de \$ 500 de un sitio web fraudulento donde se puede haber realizado una compra o, lo que es peor, proporcionar información personal que se puede rastrear hasta su hogar.

**Entienda las aplicaciones.** Abreviatura de "aplicaciones", las aplicaciones son

software descargado que funciona en varios dispositivos, como teléfonos inteligentes. Sin embargo, ciertas aplicaciones pueden recopilar y compartir información personal sobre su hijo o dirigirse a su hijo con anuncios. Incluso las aplicaciones gratuitas pueden incluir funciones de pago, y es posible que los niños no comprendan que algunas aplicaciones o funciones de juegos cuestan dinero, ya que se etiquetaron como gratuitas para descargar. Pueden hacer clic en estos llamados juegos gratuitos y terminar costándoles a los padres o tutores una factura considerable al final del mes.

**Sitios para compartir archivos:** muchos sitios web permiten a los niños descargar medios gratuitos. Lo que quizás no sepan es que estos sitios a menudo llevan el riesgo de descargar un virus, lo que permite a los ladrones de identidad acceder al dispositivo de juego, la computadora personal o incluso el teléfono celular que se está utilizando. Desde allí, el ladrón cibernético puede rastrear las transacciones financieras, la ubicación física o incluso acceder al wifi del hogar sin que nadie lo sepa.

## Maestros y administradores:

**Herramientas de videoconferencia:** al igual que las empresas, asegúrese de que el software en línea utilizado para impartir conferencias, el trabajo en el aula y otras interacciones en línea sea seguro. Los días de los bombardeos de Zoom, el phishing y otras formas de actividad delictiva cibernética no han terminado.

**Evalué y actualice los planes de ciberseguridad:** el cierre repentino de las actividades en persona dejó a muchos luchando por cambiar de rumbo en la creación y entrega de un plan de estudios. Ahora es el momento de que los educadores creen un plan para notificar a los estudiantes, profesores y personal en caso de que haya una violación de datos o un problema de seguridad una vez que las clases vuelvan a estar en sesión.

**Mantenga una máquina limpia y actualice los dispositivos que se conectan a Internet:** realizar copias de seguridad de los planes de lecciones fundamentales, la información personal y las asignaciones es la mejor defensa contra virus, malware y otras amenazas en línea. La única forma de hacer esto es mantenerse actualizado con el software más actual para protegerse contra ellos.

## BBB Tip: Back to School Internet Safety Tips

Several school districts may be picking up where they left off in March when many schools in the country suddenly shut down due to concerns over coronavirus. Now, as we approach the beginning of the school year, teachers, administrators and families are adapting to an unusual first day of school, and many schools have a focus on online learning. The Better Business Bureau (BBB) encourages everyone to stay safe while online and avoid being easy targets for online scammers.

### Parents: Be careful

**Creating accounts on websites without permission:** Social media sites are ripe with strangers with intentions that may be quite different than yours. Many sites are designed to collect and sell unauthorized user details and behaviors to advertisers looking to engage in targeted marketing. When creating an account, some kids may falsely create a birthdate to meet the minimum age requirement. Know what your child is doing online, and keep track of the social media sites and accounts to which they have access.

**Contests and giveaways:** Contests and giveaways often collect a hefty amount of personal information on their entry forms. Many are thinly disguised ways of collecting personal or financial information that could lead to identity theft. Make sure your child doesn't have access to banking or credit card information, and supervise the filling out of any forms.

**Phishing:** Adults are not the only ones who receive spam and junk mail. Kids often get junk mail, and since they don't have much online experience, are more likely to be susceptible to click on links and answer questions they probably shouldn't. While some emails may be legitimate, the last thing parents want, or need, is a \$500 bill from a fraudulent website where a purchase may have been made- or worse, giving up personal information that can be tracked back to your home.

**Understand apps.** Short for "applications," apps are downloaded software that operates on various devices, such as smart phones. However, certain apps might collect and share personal information about your child, or target your child with ads. Even free apps may include paid features, and children may not understand that some apps or game features cost money, since they were labeled as free to download. They may click on these so-called free games and end up costing parents or guardians a hefty bill at the end of the month.

**File sharing sites:** Many websites allow children to download free media. What they may not know is these sites often come with the risk of downloading a virus, allowing identity thieves to access the gaming device, personal computer or even cell phone that's being used. From there, the cyberthief can track financial transactions, physical location or even tap into the household wifi without anyone knowing it.

### Teachers and administrators:

**Videoconferencing tools:** Just like businesses, make certain the online software used to deliver lectures, classroom work and other online interactions is secure. The days of Zoom bombing, phishing and other forms of cyber criminal activity aren't over. Evaluate and update cybersecurity plans: The sudden shutdown of in person activities left many scrambling to change course in creating and delivering a curriculum. Now is the time for educators to create a plan to notify students, faculty and staff should there be a data breach or security problem once classes are back in session.

**Keep a clean machine and update devices that connect to the internet:** Backing up critical lesson plans, personal information and assignments is the best defense against viruses, malware and other online threats. The only way to do this is to stay up to date on the most current software to protect against them.

Students are prepared to provide classroom support for children and other teachers in the Assistant Teacher certificate program. Students are encouraged to apply if they are new to the field and want to gain knowledge and experience.

The online ECE summer classes – such as MCC's Health, Safety and Nutrition course – enhanced students' learning and experience in the early childhood education field.

Michelle McLaughlin has worked in education for over 18 years. Although she has a lot of experience, she learned a lot from the class.

"My professor highlighted each

topic so well and really had us dive into the importance of each," she said. "She was very hands-on and interactive with her students and was there to answer any question we may have had. Aside from simply learning from a textbook, our professor provided incredible articles, PowerPoints and links to help us further our knowledge."

When Constance Cooper's summer program was canceled due to the pandemic, she stayed relevant and productive in the field by working towards her Leader Teacher certification.

"I think the pace of the class was excellent and the assignments were planned out to engage us with each other, learn and observe things in our professional environment and to reflect on how things we learn would be applied in our day-to-day professional lives," she said. # MCC's Science Department Uses Virtual Labs in Online Courses

Many colleges are struggling to adjust to the new normal, but Middlesex Community College has been creative in developing curriculum and opportunities to keep students on track. As a leader of online learning for over 20 years, Middlesex will run about 95 percent of courses online for the Fall semester – this includes the use of virtual labs in many of MCC's Science classes.

When COVID-19 hit in the middle of the Spring semester, science classes – including anatomy and physiology, biology, microbiology, physics and chemistry – transitioned fully online. Faculty were creative in sharing worksheets, homework assignments, quizzes, videos and articles. They also found free resources online and from other colleges and universities.

Dr. Iveta Dinbergs, MCC's Chairperson and Professor of Science, has been teaching hybrid online and face-to-face courses since 2003 and believes Middlesex makes the effort to invest in quality virtual labs for courses.

"Middlesex has always been on the frontline of technology," she said. "We were one of the first to offer online courses. We have all the latest and greatest virtual lab technology and we have phenomenal training, support and professional development. We are state-of-the-art."

Dinbergs appreciates that MCC has always remained focused about staying ahead of the curve, teaching with cutting edge technology at an affordable price.

Olivia Kane, from Dedham, graduated from Boston University in the spring with a B.A. in health science. She needed to finish prerequisites in order to apply for nursing school and registered to take MCC's Anatomy and Physiology I course. She had a positive experience using virtual labs in the online class taught by Ali Ahrabi, MCC's Assistant Professor of Science.

"Being able to learn in the comfort of my own home – especially during these unprecedented times – was something that I was extremely grateful for," she said. "Now, more than ever, it is important to further your education. Education can change your perspective and provide you with the tools to go and change the world – and no one can take that away from you."

MCC uses the virtual simulation Labster for a number of disciplines. Students go through the experience as though they are in a real lab, beginning the process by entering the lab, putting on a lab coat, and following safety protocols, including throwing away used gloves in the appropriate way. They cannot skip steps.

"The Labster simulations allow students to experiment with concepts, perform a series of experiments that yield authentic results, and use simulated laboratory equipment that behaves in almost the same way as it would in a real face-to-face laboratory," Ahrabi said. "In a real lab, we often see some students who need more time to understand a lab concept better or need extra opportunity to repeat the lab exercise in order to learn better. In a simulated environment, the students can repeat the labs as many times as they wish to learn in complete details."

Having an opportunity to redo labs not only improved Kane's grades, but led to a deeper understanding of the material. Both her and Ahrabi agree that another positive was performing experiments online that



may be considered dangerous in real-life.

"The online labs allow students to engage in experiments and perform simulations that would have either been impossible or taken hours to complete in person," Kane said. "From creating explosions when studying molecular chemistry to viewing how specific conditions impact homeostasis of the human body, the virtual labs performed on my computer helped further my education than I could have ever imagined."

MCC's Science department also uses the virtual lab ADAM for anatomy and physiology to allow students a realistic look at the human body. Dinbergs describes the process as analyzing "slices" in the body that show the way muscles, bones and blood vessels all connect to move body parts.

Another virtual lab, Visible Body, offers students three-dimensional views of the body. Students interact with body parts – such as the lungs – and move them in a way that would mimic a dissection. This is important in science lessons because according to Dinbergs, "You have to envision molecules and how they rotate and spin – how they bind."

The labs are asynchronous, so students work on their own time. To hold them accountable and to check on the quality of work, Dinbergs will have students print out results or a picture of what they've been working on, such as a completed petri dish or data chart that has been filled out.

Some of the upper-level physics, chemistry and biotechnology labs are still being offered in-person while adhering to strict health and safety guidelines, wearing appropriate personal protective equipment (PPE), and following social distancing. While these courses need in-person lab experiences, Dinbergs believes virtual labs are here to stay.

"Students like the convenience and all the other aspects of it," she said. "The constant feedback that I am receiving from the Science faculty indicates to me that we are being quite successful at the switch from in-class to online teaching."

This fall, MCC is running more than 30 different science courses, with flexible formats including accelerated eight-week classes, hybrid and online options. MCC offers personalized financial aid counseling, payment plans and a supportive community to help keep students on track with their goals.

# Los pasajeros dejaron más de \$900K en los puntos de control de seguridad de la TSA

WASHINGTON - La Administración de Seguridad del Transporte recaudó \$926,030.44 en dinero no reclamado que los pasajeros dejaron en los puntos de control de seguridad del aeropuerto durante el año fiscal 2019, incluidos \$18,899.09 en moneda extranjera.

El dinero consistía en monedas sueltas y de papel que los pasajeros sacaron de sus bolsillos y dejaron en un contenedor durante el proceso de control de seguridad en los puntos de control de la TSA. La cantidad encontrada durante el año fiscal 19, que finalizó el 30 de septiembre de 2019, marcó una disminución en la cantidad de dinero no reclamado recaudado en el año fiscal 2018, cuando quedaron \$960,105.49.

Cuando los pasajeros se acercan al punto de control, se deben quitar todos los artículos de los bolsillos, incluidas las carteras y el cambio suelto. La TSA recomienda que los viajeros coloquen esos artículos directamente en sus bolsos de mano para que no dejen nada accidentalmente en un contenedor.

El objetivo de la TSA siempre es reunir a los viajeros con los artículos que dejaron en los puntos de control. Si alguien regresa al punto de control dentro de un período corto de tiempo para reclamar un artículo que dejó, se lo devuelven fácilmente. Si un pasajero deja un artículo, como una billetera, y no se da cuenta hasta después de abordar su vuelo, puede comunicarse con cualquiera de las oficinas de objetos perdidos de la TSA en los aeropuertos de todo el país para identificar el artículo perdido.



## Passengers left more than \$900K behind at TSA security checkpoints

WASHINGTON - The Transportation Security Administration collected \$926,030.44 in unclaimed money that passengers left behind at airport security checkpoints during Fiscal Year 2019, including \$18,899.09 in foreign currency.

The money consisted of loose change and paper currency that passengers removed from their pockets and left behind in a bin during the security screening process at TSA checkpoints. The amount found during FY19, which ended September 30, 2019, marked a decrease in the amount of unclaimed money collected in FY18 when \$960,105.49 was left behind.

When passengers approach the checkpoint, all items from pockets must be removed, including wallets and loose change. TSA recommends that travelers place those items directly into their carry-on bags so that they will not accidentally leave anything behind in a bin.

It is always TSA's goal to reunite travelers with items they have left behind at checkpoints. If someone returns to the

El plan del gobierno entrará en vigencia el 2 de octubre de 2020.

El cambio propuesto crea una prueba de riqueza para la naturalización, lo que hace que la ciudadanía sea completamente inaccesible para los inmigrantes de bajos ingresos. Esta flagrante discriminación llega justo a tiempo para las elecciones de 2020. Project Citizenship busca medidas cautelares y declaratorias que impidan la implementación de esta nueva regla.

## Project Citizenship Sues Department of Homeland Security and USCIS

On Monday, Project Citizenship, with the tremendous pro bono support of Ropes & Gray, filed a complaint in the U.S. District Court of Massachusetts against the U.S. Department of Homeland Security (DHS) and United States Citizenship and Immigration Services (USCIS). The lawsuit is an effort to stop USCIS's plan to 1) eliminate the possibility of a fee waiver to low income immigrants; and 2) increase the fee to file an application for citizenship from \$725 to \$1,170, an increase of 61%. The government's plan is set to go into effect on October 2, 2020.

The proposed change creates a wealth test for naturalization, making citizenship completely inaccessible to low income immigrants. This blatant discrimination comes just in time for the 2020 election. Project Citizenship is seeking declaratory and injunctive relief barring implementation of this new rule.

At Project Citizenship, we work

to ensure that all permanent residents understand and have access to the path to U.S. citizenship. We offer free, high quality legal services, and work to simplify the process and break down the many barriers to naturalization. This policy change will make citizenship unattainable for over 70% of our clients, who live in poverty.

While the lawsuit plays out in the courts, we urge all green card holders to call our office to schedule an appointment as soon as possible. Due to the pandemic, all clients will be served remotely, in an effort to make accessing our services both easy and safe.

## Millyard Museum hosts "Manchester's Urban Ponds"

Now through November 28, Millyard Museum in Manchester will host Manchester's Urban Ponds: Past, Present, and Future.

The exhibit, said Director of Operations Jeff Barraclough, investigates "the surprisingly unique history of many ponds in Manchester."

"There are images and memorabilia from Pine Island Park, ice harvesting tools recovered from Maxwell Pond and photos of the Hermit of Mosquito Pond," he said. "We also have recently discovered film footage of ice skating at Dorrs Pond."

The exhibit also highlights the work of the Manchester Urban Ponds Restoration Program, which has organized 116 cleanup events since 2000.

"1,066 volunteers have spent approximately 3,618 hours collecting 2,394 bags of trash," said Jen Drocik, acting coordinator of the Manchester Urban Ponds Restoration Program.

Over the past 20 years, she said the program has also worked on numerous on-the-ground restoration projects.

"These include Maxwell Pond dam removal, Black Brook restoration and water

quality improvements and stormwater mitigation efforts at Dorrs Pond, Crystal Lake and Nutts Pond," she added.

According to Barraclough, the exhibit underscores not only the mission of the museum, which is to tell the story of Manchester, but the intent behind many member institutions on The Trail.

"Many museums on The Trail help to tell the stories of where they are located," explained Barraclough, who is also president of The Trail. "For us, we explore Manchester, but Trail museums help tell the story of so many cities and regions."

Formed in 2014 as a way to share resources and better promote their respective collections, programs and events, The Trail is divided into the Seacoast, Merrimack Valley and Lakes Regions. Member institutions are located in Canterbury, Concord, Dover, Exeter, Laconia, Manchester, Moultonborough, Plymouth, Portsmouth, Tamworth and Wolfeboro.

to administer a lost wages program for its citizens who are unemployed due to COVID-19.

FEMA looks forward to working with the governors of additional states who agree to administer a lost wages program to bring financial relief to unemployed Americans.

### Hayes '20 Inks Deal with Tigers Tuebingen in Germany

NORTH ANDOVER, Mass. – Recent graduate Juvaris Hayes '20 of the Merrimack College men's basketball program signed his first professional contract this week, joining Tigers Tuebingen of the Basketball Bundesliga in Germany.

Hayes' deal comes on the heels of a fabulous year at the Division I level that capped off a superb career for the Paterson, N.J. native. Just last year he was named a Lou Henson All-American – the program's first All-American at the Division I level – as well as variety of other accolades including Northeast Conference (NEC) Defensive Player of the Year, NEC All-Conference First Team, USBWA All-District I Team, NABC All-District First Team, and winning the 2020 Lefty Driesell Award as the nation's top defensive player. Hayes never missed a game in his career, starting in all 126 of his appearances, and finished his career as one of the two winningest players in school history (81 wins).

Hayes' noteworthy season included leading all of Division I in both total steals (121) and steals per game (3.9). Hayes picked up his game in NEC action, averaging 4.5 steals per game – more than two thefts more than the next closest NEC competitor – and posted 81 steals overall, more than double the total of the next closest player. He also led the country in steal percentage (6.5) and posted nine separate games with at least five steals, including a career-high tying nine at



Central Connecticut.

The point guard established a new NCAA record (across divisions) in career steals with 457, breaking a 17-year mark. Hayes posted at least 120 steals in each of his last three seasons, finishing his senior year with the third most steals in a single year in NEC history. As a sophomore, Hayes set a Northeast-10 Conference (Division II) single-season record with 124 thefts, only to best that one year later as a junior with a career-high 125-steal campaign.

The Paterson, N.J. native ended the season as the NEC's leader in assists per game, dishing out 198 through 31 games for an average of 6.4 per contest. Offensively, he averaged 10.7 points per game, ending the year with double-digit scoring performances in six of his final seven contests. He concluded the regular season as the Warriors' team leader in assists (6.4), rebounds (4.7) and steals (3.9), serving as the catalyst of the team's offensive and defensive game plans. In his career, Hayes is the program's all-time assists and steals leader while ranking in the top-10 in both career points and career rebounds.

## Women's Basketball Introduces Freshman Class



NORTH ANDOVER, Mass. – Newly appointed head coach Kelly Morrone and the Merrimack College women's basketball program introduces its four-player freshman class, which will compete with the women's basketball program as first-year student-athletes this winter.

The Warriors' incoming class features a guard heavy group that includes one point guard and two shooting guards, as well as one forward. All four student-athletes arrive from different states. One player each are from Massachusetts, Connecticut, New York, and Pennsylvania.

"Our four freshmen Nadesha, Cassie, Teneisia, and Grace all bring something unique to our roster. From a skill standpoint, they collectively cover a lot of different areas of the game. That goes for their personalities too, as they have been a fun group to get to know. The returners and I have enjoyed mixing them into the fold," Morrone commented. "All four players have been very engaged throughout the summer preparing for their rookie debut. I'm excited to embrace their energy and their commitment to being a positive impact early on in their careers."

# From My Corner

## Senator Markey exaggerates

Something new during the debates is the use of "fact-checkers" and it makes watching them more interesting because you know immediately when the candidates are lying.

At the recent debate between Joe Kennedy and Ed Markey on WCVB-TV, the Senator stated that he has written more than 500 bills that have been signed into law. In less than 5 minutes after pronouncing that statement, the Kennedy campaign sent me this release:

"According to Congress.gov, only 15 laws he has authored have been signed into law. According to the more generous count by GovTrack, only 27 of Senator Markey's bills have been signed into law. A discrepancy of more than 500 bills cannot be justified by differing methodologies."

Of the bills he claims to have authored, the vast majority were authored by other members of Congress, which Senator Markey merely cosponsored. Roughly half of these bills are resolutions or ceremonial measures to rename federal buildings or distribute commemorative coins. Among the bills he claims to have authored, more than half were introduced weeks or months before Senator Markey added his name as a cosponsor."

Perhaps that's the reason for State Representative Marcos Devers to do the same. Let's face it: if others do it at the federal level, he believes he's excused. He has been recycling the same 4 bills for the past 10 years to appear that he's doing something, even when he has no intention to fight for them.

Meantime, he is a co-signer on hundreds of bills sponsored by other representatives.

## My take on mail voting

During my participation on the radio show A Fuego Cruzado, with Santiago Matías, Nazario Esquea and José Alfonso García, I mentioned my reasons for objecting to mailing voting because they will be sent to anyone registered to vote and those ballots could be misused in the hand of anyone except the addressee.

As an example, I offer the case of our own Mayor Dan Rivera who lives at 2 Thomas Rd. Kevin Clement and his wife sold the house to him three years ago but remain as voters at that address, even though they now live out of Lawrence. They should have removed themselves from the voting list but, since they did not do that,

the City must wait four years and that's federal law.

Some politicians play the inactive list to fraudulently file absentee ballots using the inactive list.

The State's answer to the problem is placing the responsibility on the Cities and Towns and have them determine who is moved or not. What are they supposed to do? Go to the houses and see who's at home? That's insane!

We have four methods of voting in place now – Vote by Mail, Early Voting, Absentee Voting, and In-Person voting. It's your choice if you don't feel safe voting in person, request an absentee ballot or get your mask on and vote at City Hall (take a look at the dates and hours on page 5.) I recently posted a joke on Facebook, "People go to Walmart and HomeDepot, let's put the polls there!"

In Lawrence people continue having backyard parties with no regard for pandemic recommendations. If people go to restaurants keeping a safe distance between tables or in open-air why can't they go vote in person? I still say that the integrity of mailing voting depends on us – not the mail.

According to the New York Post, "A judge has ruled that a new election will be held in November for a disputed Paterson City Council seat, just weeks after the race's apparent winner and a sitting councilman were charged with voter fraud.

"Alex Mendez had won a special election on May 12 to fill the seat, but claims of voter fraud were soon raised. An investigation was then launched after the U.S. Postal Service's law enforcement arm told the state attorney general's office about hundreds of mail-in ballots located in a mailbox in Paterson, along with more found in nearby Haledon."

A similar case in New York was the election of Democrat Rep. Carolyn Maloney running for the 12th Congressional District in the June 23 primary. The vote tabulation stretched out over half the summer because of a record number of people who cast ballots by mail because of the coronavirus pandemic. The winner was announced after six weeks of the primary election.

Maloney held onto a mere 658-vote lead after in-person voting concluded, with 65,000 mail-in votes uncounted. The final, certified margin of victory was 3,700 votes. A total of 13,000 mail-in votes were tossed out for various reasons, including missing signatures or incorrect postmarks.

Everyone eligible to vote should and must do it on September 1st and November 3rd.

# MCC Partners with VA to Shoot a Series of U.S. History Web Shorts

The many partnerships Middlesex Community College enjoys with local businesses and organizations benefit both the students the college serves and the industries Middlesex strengthens with its well-prepared and knowledgeable graduates. This spring semester, MCC's Communications department collaborated with the VA New England Healthcare System to create a series of short features on New England Veterans and U.S. military history.

Francois De Costerd is MCC's Media Production Coordinator. Starting in February 2020, De Costerd managed the MCC interns as they produced the VA's new weekly series of web shorts about U.S. military history narrated by Michael McNamara.

MCC interns researched and gathered content for the scripts that were provided by McNamara before putting together a rough edit using the visuals and narration over music. De Costerd then reviewed the work and completed the shorts with additional sources and motion graphics.

"It's a win-win collaboration where the VA gets great production services at a reduced fee and our Communications students get a first-rate professional and experiential learning experience," De Costerd said. "With an episode each week, the production pace was brisk. That initial research and assembly phase is real team work – projects are split up and assigned to each intern, content is shared online, and everyone contributes to the overall production."

In total, the department produced almost 20 episodes of the series, creating the visual content and the graphics. The MCC interns researched historical content, looked for motion graphics, designed logos and developed animations. The group also completed all of the closed captioning, which is a valuable skill for the industry according to De Costerd.

"All the MCC Media Production interns from Spring 2020 and Summer semesters have contributed to this work and were crucial in the success of this partnership," he said. "Our VA partners have been thrilled with the quality of the media content we have been producing."

Dr. Jennifer Bauer, MCC's Communications Department Chair and Professor, began the partnership with the VA in April 2019. Bauer wanted to develop an in-house production company where students could be mentored through hands-on learning experiences, while serving the community. She hired De Costerd who then took on the project with the VA.

"These partnerships are so essential to the students and the COM program because they provide a real-world environment and production experience that allows students to practice what they have learned in the classroom while building their resume and production reel," Bauer said. "To see this come to life so quickly is a testament to Francois' talent and production management skills. Francois is an integral part of the partnership because he provides the professional link between the VA and our student interns."

The partnership with MCC and the VA continues with new projects, including with the YouTube show SITREP. MCC also ran a photoshoot to help with the VA's graphic needs.

These experiences allow MCC students to develop important work and

practice valuable industry-related skills.

"Working on the VA project was a terrific experience that gave me a better view of the hands-on work for my major," said James Briere, an MCC Communications student. "I learned so much about the technical process and enjoyed being a part of a professional environment."

In addition to Briere, the MCC interns who worked on the VA project include Cameron Dawson, Johannes Crueger-Cain, Dalton DeLima, Nassir Mandrafino and Jonathan Zurawski.


