Iniciativa de desvío de desalojos: servicios legales gratuitos

A través del Proyecto de Ayuda Legal para Desalojos COVID-19 (CELHP), hay una expansión sustancial de la ayuda legal gratuita para inquilinos de bajos ingresos, así como propietarios-ocupantes de bajos ingresos de 2-3 propiedades familiares que navegan por el proceso de desalojo. Estos servicios se pueden usar antes de que comience el proceso de desalojo, así como una vez que se haya recibido un aviso, y se pueden usar en coordinación con los servicios de mediación comunitaria (www. resolutionma.org). Para los servicios legales, la elegibilidad por ingresos está limitada al 200% del nivel federal de pobreza.

legales Los servicios estarán disponibles en todas las regiones y se pueden encontrar en www.evictionlegalhelp. org. Los hogares también pueden llamar al 2-1-1 y obtener más información en el sitio web del Departamento de Vivienda y Desarrollo Comunitario, www.mass.gov/ CovidHousingHelp.

La ayuda legal está disponible en este momento para los inquilinos elegibles por ingresos que enfrentan un desalojo. Recomendamos encarecidamente a los inquilinos y propietarios que aprendan sobre la ayuda legal y los recursos de mediación comunitaria. Los inquilinos y propietarios elegibles deben buscar ayuda tan pronto como sea posible, antes de que ocurra una presentación judicial.

Eviction Diversion Initiative: Free Legal Services

Through the COVID-19 Eviction Legal Help Project (CELHP), there is a substantial expansion of free legal help for low-income tenants as well as low-income owner-occupants of 2-3 family properties navigating the eviction process. These services can be used before the eviction process begins, as well as once a notice has been received, and can be used in coordination with community mediation services (www.resolutionma.org). For the legal services income eligibility is capped at 200% of federal poverty level.

Legal services will be available in

every region and can be found at www. evictionlegalhelp.org. Households can also call 2-1-1 and learn more at the Department of Housing and Community Development's website, www.mass.gov/ CovidHousingHelp.

Legal help is available right now for income-eligible tenants facing eviction. We strongly encourage tenants and landlords to learn about legal help as well as community mediation resources. Eligible tenants and landlords should seek help as soon as possible, before a court filing occurs.

¡Eres analfabeto! ¡No puedes leer! Al menos eso es lo que acaba de decir la Concejala de la Ciudad de Lawrence, María De La Cruz, durante la reunión del Concejo Municipal del lunes. Ella dijo "Ustedes no saben leer" a los residentes de la Ciudad de Lawrence. Ella le está diciendo claramente que usted no es inteligente. No creo que haya entendido lo que acabo de escribir, así que lo escribiré una vez más: "No sabe

La Concejala María De La Cruz es una política vendida. No digo esto solamente por ella estar a favor de aprobar la petición de autonomía que niega a sus electores el derecho a votar por un nuevo alcalde en elecciones especiales. Las agencias federales advierten sobre esquemas de fraude emergentes relacionados con las vacunas de COVID-19

La Oficina Federal de Investigaciones (FBI), la Oficina del Inspector General del Departamento de Salud y Servicios Humanos (HHS-OIG) y los Centros de Servicios de Medicare y Medicaid (CMS) advierten al público sobre varios esquemas de fraude emergentes relacionados con las vacunas de COVID-19. .

El FBI, HHS-OIG y CMS han recibido quejas de estafadores que utilizan el interés del público en las vacunas de COVID-19 para obtener información de identificación personal (PII) y dinero a través de varios Continuamos trabajando diligentemente con los socios encargados de hacer cumplir la ley y el sector privado para identificar las amenazas cibernéticas y el fraude en todas sus formas.

El público debe conocer los siguientes indicadores potenciales de actividad fraudulenta:

- Anuncios u ofertas para acceso temprano a una vacuna mediante el pago de un depósito o tarifa.
- Solicitudes que le piden que pague de su bolsillo para obtener la vacuna o que ponga su nombre en una lista de espera para la vacuna de COVID-19.
- Ofertas para someterse a pruebas o procedimientos médicos adicionales al obtener una vacuna.
- Comercializadores que ofrecen vender y/o enviar dosis de una vacuna, a nivel nacional o internacional, a cambio del pago de un depósito o tarifa.
- llamadas Correos electrónicos, telefónicas o contacto personal no solicitado de alguien que dice ser de un consultorio médico, una compañía de seguros o un

centro de vacunación de COVID-19 solicitando información personal y/o médica para determinar la elegibilidad de los destinatarios para participar en ensayos clínicos de vacunas u obtener la vacuna.

- Declaraciones de aprobación de la FDA para una vacuna que no se puede verificar.
- Anuncios de vacunas a través de plataformas de redes sociales, correo electrónico, llamadas telefónicas, en línea o de fuentes no solicitadas/desconocidas.
- Personas que se comuniquen con usted en persona, por teléfono o por correo electrónico para informarle que el gobierno o los funcionarios del gobierno requieren que reciba una vacuna de COVID-19.

Consejos para evitar el fraude relacionado con la **COVID-19:**

- Consulte el sitio web del departamento de salud de su estado para obtener información actualizada sobre los canales de distribución de vacunas autorizados y solo obtener una vacuna a través de dichos canales.
- Consulte el sitio web de la FDA (fda. gov) para obtener información actualizada sobre las autorizaciones de uso de emergencia de vacunas.
- Consulte a su médico de atención primaria antes de recibir cualquier vacuna.
- No comparta su información personal o de salud con nadie más que profesionales médicos conocidos y de confianza.
- Verifique sus facturas médicas y la explicación de beneficios del seguro (EOB) en busca de reclamos sospechosos e informe de inmediato cualquier error a su

proveedor de seguro médico.

Siga la guía y las recomendaciones de los Centros para el Control y la Prevención de Enfermedades (CDC) de EE.UU. y otros profesionales médicos de confianza.

Técnicas generales de prevención del fraude en línea/cibernético:

- Verifique la ortografía de direcciones web, sitios web y direcciones de correo electrónico que parezcan confiables pero que puedan ser imitaciones de sitios web legítimos.
- Asegúrese de que los sistemas operativos y las aplicaciones estén actualizados a las versiones más actuales.
- Actualice el software anti-malware y antivirus y realice análisis de red regulares.
- No habilite macros en documentos descargados de un correo electrónico a menos que sea necesario y después de asegurarse de

que el archivo no sea malicioso.

- No se comunique ni abra correos electrónicos, archivos adjuntos o enlaces de personas desconocidas.
- Nunca proporcione información personal de ningún tipo por correo electrónico; Tenga en cuenta que muchos correos electrónicos solicitando su información personal pueden parecer legítimos.
- Si es posible, utilice una autenticación sólida de dos factores, mediante biometría, tokens de hardware o aplicaciones de autenticación.
- Deshabilite o elimine aplicaciones de software innecesarias.

Si cree que ha sido víctima de un fraude de COVID-19, denúncielo inmediatamente al FBI (ic3.gov, tips.fbi. gov o 1-800-CALL-FBI) o al HHS OIG (tips.hhs.gov o 1-800-HHS-TIPS).

Federal Agencies Warn of Emerging Fraud **Schemes Related to COVID-19 Vaccines**

The Federal Bureau of Investigation (FBI), Department of Health and Human Services Office of Inspector General (HHS-OIG), and Centers for Medicare & Medicaid Services (CMS) are warning the public about several emerging fraud schemes related to COVID-19 vaccines.

The FBI, HHS-OIG, and CMS have received complaints of scammers using the public's interest in COVID-19 vaccines to obtain personally identifiable information (PII) and money through various schemes. We continue to work diligently with law enforcement partners and the private sector to identify cyber threats and fraud in all forms.

The public should be aware of the following potential indicators of fraudulent activity:

- · Advertisements or offers for early access to a vaccine upon payment of a deposit or fee.
- Requests asking you to pay out of pocket to obtain the vaccine or to put your name on a COVID-19 vaccine waiting list.
- Offers to undergo additional medical testing or procedures when obtaining a vaccine.
- Marketers offering to sell and/or ship doses of a vaccine, domestically or internationally, in exchange for payment of a deposit or fee.
- Unsolicited emails, telephone calls, or personal contact from someone claiming to be from a medical office, insurance company, or COVID-19 vaccine center requesting personal and/or medical information to determine recipients' eligibility to participate in clinical vaccine trials or obtain the vaccine.
- Claims of FDA approval for a vaccine that cannot be verified.
- Advertisements for vaccines through social media platforms, email, telephone calls, online, or from unsolicited/unknown
- Individuals contacting you in person, by phone, or by email to tell you the government or government officials require you to receive a COVID-19 vaccine.

Tips to avoid COVID-19 vaccine-related fraud:


Consult your state's health department website for up-to-date information about authorized vaccine distribution channels and only obtaining a vaccine through such

- Check the FDA's website (fda.gov) for current information about vaccine emergency use authorizations.
- Consult your primary care physician before undergoing any vaccination.
- Don't share your personal or health information with anyone other than known and trusted medical professionals.
- Check your medical bills and insurance explanation of benefits (EOBs) for any suspicious claims and promptly reporting any errors to your health insurance provider.
- Follow guidance and recommendations from the U.S. Centers for Disease Control and Prevention (CDC) and other trusted medical professionals.

General online/cyber fraud prevention techniques:

- · Verify the spelling of web addresses, websites, and email addresses that look trustworthy but may be imitations of legitimate websites.
- Ensure operating systems applications are updated to the most current versions.
- Update anti-malware and anti-virus software and conduct regular network scans.
- Do not enable macros on documents downloaded from an email unless necessary and after ensuring the file is not malicious.
- Do not communicate with or open emails, attachments, or links from unknown individuals.
- Never provide personal information of any sort via email; be aware that many emails requesting your personal information may appear to be legitimate.
- Use strong two-factor authentication if possible, using biometrics, hardware tokens, or authentication apps.
- Disable or remove unneeded software

If you believe you have been the victim of a COVID-19 fraud, immediately report it to the FBI (ic3.gov, tips.fbi.gov, or 1-800-CALL-FBI) or HHS OIG (tips.hhs. gov or 1-800-HHS-TIPS).



- You are asked to pay to put your name on a vaccine waiting list or to get early access.
- Advertisements for vaccines through social media platforms, email, telephone calls, online, or from unsolicited/unknown sources.
- Marketers offering to sell or ship doses of the vaccine
- ✓ Protect Yourself. Do not give out your personal information to unknown sources.

The Commonwealth of Massachusetts

In the One Hundred and Ninety-First General Court (2019-2020)

An Act relative to the Office of the Mayor in the city of Lawrence.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Notwithstanding the provisions of paragraph (a) of subsection 11 of Section
 - 4 of Chapter 425 of the Acts of 1983, or any general or special law to the contrary, if a vacancy
 - in the office of the mayor occurs in the year two thousand and twenty-one, the president of the
- city council shall become acting mayor until the mayor elected in the regularly scheduled 2021
- municipal election is provided the oath of office immediately upon certification of that election
- Upon the qualification of the president of the city council as acting mayor, his office of councilor
- shall be appointed as provided for by the City of Lawrence City Charter, paragraph (a) or (b) of
- subsection 9 of Section 3.

- The president of the city council as acting mayor shall have all the powers of the mayor and shall serve for the balance of the then unexpired term of the mayor.
- The council vice president, as the successor of the council president shall not receive any
- 11 12 added financial benefit for the remainder of this term.
- 13 The mayoral candidate elected in the regularly scheduled 2021 municipal election will be 14 immediately seated, administered the oath of office, and assume all the powers of mayor
- 15 immediately upon the proper certification by the board of registrars, and serve for the balance of
- the then unexpired term of mayor. 16
- 17 The acting mayor, provided for by this petition, will resume their city council role for the
- remaining term of the current city council term. The appointed city councilor filling the
- president's seat as provided by the City of Lawrence City Charter, paragraph (a) /or (b) of 19
- subsection 9 of Section 3 shall immediately be relieved of their service once the oath of office is

Greater Lowell Community Foundation awards additional \$55K in COVID-19 response grants in latest round

LOWELL - A dozen local nonprofits, from organizations that provide essential supplies to individuals in need to those who serve the hungry, have been announced as the recipients of the Greater Lowell Community Foundation's most recent round of COVID-19 response grants. The Greater Lowell Community Foundation (GLCF) announced that it granted an additional \$55,000 in emergency grant funds from the GLCF COVID-19 Emergency Response Fund.

"It has been eye-opening to see how COVID-19 has compounded the profound inequities in Greater Lowell. Local nonprofits are stretched beyond capacity to provide services to vulnerable populations due to growing needs," said GLCF president & CEO Jay Linnehan. "There has never been a more critical time for our community to work together on solutions to address long-term challenges, and we are incredibly grateful to our donors who have continued to step up to offer support."

In total, the community foundation awarded \$55,125 to 12 organizations serving Greater Lowell. The GLCF COVID-19 Emergency Response Fund awards were the 11th round of grants disbursed by the community foundation this year. Since March, through grants from the GLCF COVID-19 Emergency Response Fund and the Massachusetts COVID Relief Fund, the foundation has supported more than 100 local nonprofit organizations with grants totaling over \$2.9 million.

This round of grants has aided organizations such as Lowell Alliance, an organization that helps Lowell families and neighborhoods thrive by connecting them with critical resources, including diapers. "Since the pandemic began in March, Lowell Alliance has distributed almost 50,000 diapers to families in need, triple the amount of diapers we usually give out," said Lowell Alliance Director Nancy Coan.

"While some of the diapers are donated, we purchase most of the diapers we distribute, and we've struggled this year to keep up with the increased demand. GLCF's grant for our diaper bank is critical in allowing us to continue to help meet the basic needs of vulnerable families in Lowell."

The funding has also helped the Massachusetts Military Support Foundation to help local veterans and military families through its Food4Vets program. "Massachusetts Military Support Foundation is pleased to continue its Food4Vets program, which serves our Veteran Families in the greater Lowell region and throughout Massachusetts during the COVID-19 Emergency. Partners, like the Greater Lowell Community Foundation, enable us to respond to the needs of our partners, families, and other nonprofits who continue to meet the needs of those who are food insecure during this horrible pandemic," said Don Cox, president of the Massachusetts Military Support Foundation.

"Over the last nine months, ECCF has worked with so many incredible nonprofit organizations that have effectively and efficiently navigated the continuing challenges faced by Essex County's cities

"Our local nonprofits have really been the boots on the ground since the pandemic began, and we are so thrilled to have these continue their critical work for residents in our region," added Carol Lavoie Schuster, ECCF's vice president for grants, nonprofit and donor services.

As the COVID-19 pandemic continues to intensify, ECCF remains committed to working closely with local nonprofits to monitor Essex County's ever-changing needs and seeking out ways to meet the inevitable challenges that will continue to arise for its residents.

"While we anxiously await the vaccine, we know the economic effects of COVID-19 will persist into the foreseeable future," said Francis. "But ECCF will also persist in our work to bring people together to rise up to the challenges we face together."

MCC's Corporate Ed. Trains Employees to Develop Leadership Skills

Middlesex Community College's Corporate Education and Training program partners with local businesses and organizations to help companies identify their workforce training needs. These partnerships use a collaborative process to develop programs that offer the most relevant and effective professional development opportunities for companies.

MCC's Corporate Ed. collaborated with Jeffrey Davis, MCC adjunct faculty member; Joanna Dowling from the Center for Manufacturing Technology (CMT); and Natasha Simmers, Human Resources Manager for Accumet Engineering, to build a 50-hour training program focused on leadership for Accumet employees.

"Joanna Dowling hired us to teach the leadership portion of a training for Accumet at CMT," said Lisa Tuzzolo, MCC's Director of Corporate Education and Training. "Although this is the first of its kind, Middlesex has been partnering with community businesses and organizations for over 30 years to deliver tailored and comprehensive training opportunities for employees. Not only do our trainings strengthen companies, but they also hone the talents and skills of people within the Commonwealth, leading to a more advanced, capable and wellrounded workforce."

Middlesex has partnered with CMT for several years. With a strong foundation of knowledge in advanced manufacturing, Dowling understands what makes a company successful in the industry. According to Dowling, CMT works with MCC because of Corporate Ed.'s "flexibility and dedication," and believes the pandemic presents an opportune time for companies to offer training to their employees.

"We were extremely happy with the professionalism and content delivery with Jeff Davis and the support team/ staff at Middlesex," Dowling said. "If employers are faced with downtime for their employees, it is a perfect time to invest in training to give their employees an opportunity to improve on critical skills that they might be lacking or in need of for that next promotion."

Before developing his program, Davis engaged in conversations with Simmers to find out why Accumet was looking for trainings. Through these conversations, he understood there was a desire to provide employees with ways to build their leadership skills, "preparing them for roles with expanded responsibility, visibility and influence." These types of conversations between the group were continuous throughout the duration of the trainings to ensure Accumet and their employees were learning the information they needed to be more effective leaders.

"We all agreed to re-visit the training program every few weeks and make adjustments in the content and the training activities, based on observations and feedback from the participants," Davis said. "These regular meetings were very helpful in the tailoring of the training, especially when a second cohort of participants was identified."



Topics included defining effective leadership, building leadership credibility, communicating in the workplace, having productive difficult conversations, and increasing accountability, among others. Davis describes his method of teaching the program as an "inside-out model."

"Leaders cannot credibly influence others to grow and change unless they are on their own professional development journey that is resulting in genuine change, from the 'inside-out," he said. "As leaders, we are less capable to offer others what they need – encouragement, acknowledgement, improvement feedback, confidence, courage, humility, curiosity - unless we first give those important qualities and characteristics to ourselves."

Simmers appreciates MCC's ability to tailor the program to meet Accumet's needs, as well as the leadership Davis has shown throughout the trainings. She also believes the program has improved employees' communication and selfawareness skills.

"The employees keep raving about the instructor Jeff and the class content, and say that their co-workers absolutely must take the class," Simmers said. "Jeff was great about establishing communication with me to create content catered specifically to employees in each cohort."

Start the New Year off Right: Promptly Dispose of Natural Christmas Trees

State Fire Marshal Peter J. Ostroskey said, "Start the new year off right: promptly dispose of your Christmas tree. A dried out Christmas tree will ignite quickly and spread a fire very fast."

Dried Out Trees Are Fuel for Fires Indoors and Out

Over the past few years, there have been several fires involving Christmas trees that had dried out. If trees are up early, they can dry out before Christmas. Ostroskey said, "Keep the tree watered, and away from all heat sources. After Christmas, dispose of your tree promptly. If a fire should start for any reason, a tree will help spread the fire extremely rapidly."

On January 3, 2020 at 4:30 p.m., the Westfield Fire Department responded to a Christmas tree fire in a single-family home. The fire began in the living room. No one was injured. The home did not have sprinklers and damages were estimated to be \$160,000.

On January 6, 2020 at 9:59 p.m., the Belmont Fire Department responded to a Christmas tree fire in a single-family home. The fire began in the living room where a nearby candle ignited an extremely dry tree. Smoke alarms operated and no one was injured. The home did not have sprinklers and damages were estimated at \$2,500.

Disposal of the Tree

up days or recycling programs, many of which start next week. To find out if your community has a Christmas tree recycling program, contact your local public works department or recycling committee. Some local goat farms accept bare tree and wreath donations as they are looking for greens things to eat.



USCIS Cancelará Dos Programas de Permisos de Permanencia Temporal por Categorías

El Programa de Permisos para Reunificación de Familias Haitianas y el Programa de Permisos para Veteranos Filipinos de la Segunda Guerra Mundial serán Cancelados

De acuerdo con el anuncio de la agencia de agosto de 2019, el Servicio de Ciudadanía e Inmigración de Estados Unidos anunció hoy una notificación en el Registro Federal donde solicita comentarios del público acerca de las revisiones del Formulario I-131, Solicitud de Documento de Viaje, a fin de eliminar secciones relacionadas con el Programa de Permisos para Reunificación de Familias Haitianas (HFRP) y el Programa de Permisos para Veteranos Filipinos de la Segunda Guerra Mundial (FWVP). La notificación será publicada formalmente el 28 de diciembre, y USCIS aceptará comentarios del público durante 60 días. Estos cambios cancelarán los programas HFRP y FWVP cuando los cambios a las instrucciones de los formularios sean

USCIS cancela estos dos programas de permisos por categorías para ser consistentes con la Orden Ejecutiva 13767, titulada Mejoras a la Seguridad en la Frontera y Control de Inmigración, y para garantizar mejor que el permiso ("parole") sea utilizado solo caso por caso, consistente con la sección 212(d)(5) de la Ley de Inmigración y Nacionalidad (INA), y sin criterios predeterminados.

El permiso de permanencia temporal es un proceso que permite que nacionales extranjeros entren o permanezcan temporalmente en Estados Unidos, incluidos aquellos que de otra manera son inadmisibles. El permiso de permanencia temporal por categoría (conocido en inglés como "categorical parole") se refiere a programas diseñados para considerar el permiso de permanencia temporal para grupos completos de extranjeros basados en unos criterios predeterminados. Bajo ambos programas de permisos por categorías, los familiares de extranjeros que tienen peticiones basadas en la familia aprobadas han sido autorizados a entrar a Estados Unidos y son elegibles para autorización de empleo mientras esperan que su tarjeta de residente permanente esté disponible.

"El permiso de permanencia temporal es para ser utilizado caso por caso, por motivos humanitarios urgentes o de beneficio público significativo. Con la cancelación de estos programas por categorías, cualquier nuevo solicitante será considerado al permiso de permanencia temporal de acuerdo con los criterios que aplican a cualquier otro extranjero que busca obtener un permiso de permanencia temporal", dijo el subdirector de Políticas de USCIS, Joseph Edlow. "USCIS está comprometido con ejercer esta autoridad limitada en una manera que preserve la integridad de nuestro sistema de inmigración".

USCIS procesará todos los casos pendientes bajo estos programas hasta que sean completados, así como todas las nuevas solicitudes que estén mataselladas en o antes de la fecha de efectividad de las instrucciones del nuevo formulario. USCIS publicará la fecha de vigencia de este cambio tan pronto como se finalicen los plazos, lo que podría ser tan temprano como febrero de 2021. Las personas que actualmente tienen permisos de permanencia temporal ("parolees") retendrán su actual periodo hasta que venza, a menos que se le cancele de alguna otra manera. USCIS emitirá notificaciones de casos individuales a las personas afectadas que tienen permisos de permanencia temporal, a fin de proporcionarles información acerca de la cancelación del programa y recordarles que deben proporcionar su dirección de correo actual, según requerido.

Ciertas personas con permisos de permanencia temporal bajo HFRP o FWVP que están en Estados Unidos pueden ser elegibles para ajustar su estatus a fin de convertirse en residentes permanentes legales. Aquellos que no hayan ajustado su estatus pueden solicitar que se les renueve el permiso de permanencia temporal (conocido en inglés como "re-parole") mediante la presentación del Formulario I-131 y el Formulario I-134. Renovar el permiso de permanencia temporal le permite a la persona que tiene dicho permiso a permanecer en Estados Unidos por un periodo adicional autorizado. USCIS considerará las peticiones de renovación de permiso de permanencia temporal caso por caso bajo los términos del programa HFRP

USCIS Ending Two Categorical Parole Programs

Haitian Family Reunification Parole and Filipino World War II Veterans Parole Programs to be Terminated

In keeping with the agency's August 2019 announcement, U.S. Citizenship and Immigration Services today announced a Federal Register notice requesting public comments on revisions to Form I-131, Application for Travel Document to remove sections relating to the Haitian Family Reunification Parole (HFRP) and the Filipino World War II Veterans (FWVP) Parole programs. The notice will formally publish on Dec. 28, and USCIS will accept public comments for 60 days. These changes will terminate the HFRP and FWVP programs when those form instruction changes are finalized.

USCIS is terminating these two categorical parole programs to be consistent with Executive Order (E.O.) 13767, Border Security and Immigration Enforcement Improvements and to better ensure that parole is used only on a case-bycase basis, consistent with section 212(d) (5) of the Immigration and Nationality Act (INA), and without using pre-set criteria.

Parole is a mechanism that allows aliens to temporarily enter or remain in the United States, including those who are otherwise inadmissible. Categorical parole refers to programs designed to consider parole for entire groups of aliens based on pre-set criteria. Under both categorical parole programs, aliens with approved family-based immigrant petitions have been authorized to enter the United States and are eligible to apply for employment authorization while waiting for their Green Card to become available.

"Parole is to be used on a case-bycase basis for urgent humanitarian reasons or significant public benefit. With the termination of these categorical programs,

any new applicants will be considered for parole consistent with the criteria that apply to any other alien seeking parole," said USCIS Deputy Director for Policy Joseph Edlow. "USCIS is committed to exercising this limited authority in a manner that preserves the integrity of our immigration system."

USCIS will process all pending cases under these programs to completion, and all new applications that are postmarked on or before the effective date of the new form instructions. USCIS will publish the effective date of this change as soon as timelines are finalized and could be as early as February 2021. Current parolees will maintain their current period of parole until it expires, unless it is otherwise terminated. USCIS will issue individual case notices to affected parolees to provide information about the termination of the programs and remind parolees to provide their updated mailing address, as required.

Certain HFRP or FWVP parolees who are in the United States may be eligible to adjust their status to become lawful permanent residents. Those who have not adjusted status may request re-parole by filing Form I-131 and Form I-134. Reparole allows a parolee to remain in the United States for an additional period of authorized parole. USCIS will consider requests for re-parole on a case-by-case basis under the HFRP and FWVP program terms. 



NECC Farmers Market Fills a Growing Need During Pandemic

When the pandemic hit in March, Northern Essex suspended its free mobile farmers market for faculty, staff, and students, which is offered in partnership with the Greater Boston Food Bank once a month during the academic year.

"We wanted to get it back up as quickly as possible because we knew insecurity would increase with COVID-19," said Janel D'Agata-Lynch, Northern Essex's and community resources coordinator.

engagement, service-learning Phil Perkins from the Maintenance Department unloaded produce for NECC's December mobile farmers market.

Over the summer, a plan was hatched to launch a socially-distanced farmers market in September. Individuals sign up in advance, receive a timed appointment, and drive on to campus and get their food without having to leave their vehicle.

D'Agata-Lynch estimates that an average of 50 to 60 cars visited each campus for each market and that from September through November about 250 distinct households and over 1,000 individuals were served.

One repeat—and very appreciative customer is Tiffany Bell of Haverhill, a practical nursing student and the mother of six children ages 5 to 23. "You have no idea how helpful this is," said Bell. "I feel blessed."

At the December market, Northern Essex volunteers, led by Courtney Morin, the college's Campus Compact AmeriCorps VISTA volunteer, who is overseeing the Haverhill market as well as food pantries on both campuses, unloaded carrots, cabbage, salad, mangos, onions, and sweet potato; packed a bag for each client; and loaded the produce into the cars.

Morin, who is also a Northern Essex Biology student, is passionate about food security. "It's very difficult to be successful in class if you're thinking about where your next meal is coming from."

According to statistics shared by the Greater Boston Food Bank, 47% of community college students and 39%

of 4-year university students were food insecure before the pandemic.

"It is reasonable to assume that those numbers are much worse now," said Christina Peretti, Greater Boston Food Bank's assistant director of programs and community capacity. "We supply our partners and their clients with nutritious food because there are negative health consequences to hunger. Fresh fruit and vegetables are often some of the most expensive items to purchase in the grocery store."

program, four in one cohort and five in another. Despite needing to follow strict health and safety protocols — including social distancing – due to the pandemic, Davis was able to build a community-feel within the program.

The training participants enjoyed working together to motivate each other throughout their learning, as well as engaging in deep conversations. Based on feedback from the participants, Davis believes the biggest takeaway was gaining more confidence in themselves.

"This has become the platform for taking more courageous leadership actions at work - talking to their coworker about a sensitive subject, after putting off that conversation for a long time," he said. "Advocating for their team with their manager. Asking questions with a curiosity and 'what can we learn' mindset, instead of troubleshooting an issue to find out who did something wrong."

Solinka Potter, a Sales Representative at Accumet, emphasizes how much confidence she gained from participating. When she was offered a place in the training, her first instinct was to say "why not?" After getting to the first session, she

"It will help me through my whole life," she said. "Before, I would keep my questions to myself and was quieter, hiding behind my computer. I'd be embarrassed thinking, 'am I going to say something stupid?' Now I feel that I have the confidence to speak up and help and encourage others too."
