



HHS anuncia compromiso de organizaciones para alentar a consumidores latinos a inscribirse en un seguro médico a través de CuidadoDeSalud.gov

El secretario del Departamento de Salud y Servicios Humanos (HHS), Xavier Becerra, anunció que organizaciones nacionales se comprometen a apoyar los esfuerzos de ayudar a la comunidad latina a inscribirse en CuidadoDeSalud.gov durante el Período de Inscripción Especial (SEP) actual establecido por el presidente Biden durante la emergencia de salud pública del COVID-19. Como parte de la Semana de Acción Latina, entre el 18 al 24 de abril las organizaciones y HHS compartirán información con los consumidores latinos y usarán las redes sociales para incentivarlos a inscribirse en planes de salud asequibles y de calidad a través de CuidadoDeSalud.gov.

"Ayudar a que las comunidades aprovechen los costos reducidos de cuidado de salud de calidad es una prioridad para este Departamento. Además de demostrar que estamos invirtiendo en este esfuerzo, estamos asociándonos con organizaciones claves en la comunidad latina que ayudarán con su experiencia y alcance a promover la inscripción y acceso a una cobertura de cuidado de salud asequible durante el Período de Inscripción Especial," expresó el secretario Becerra. "A todos aquellos latinos que han perdido la cobertura durante esta pandemia, les digo que la ayuda ha llegado. La cobertura de cuidado de salud es más asequible para todos y la asistencia está disponible si necesitan encontrar un plan de salud que se acomode a sus necesidades".

El acceso a cobertura y atención médica asequibles es particularmente importante para la comunidad latina en Estados Unidos, debido a que el 22% de los latinos que no son personas de tercera edad no tienen seguro, una tasa casi 2,5 veces mayor que la de los estadounidenses blancos. A partir de esta semana, HHS y diversas organizaciones, incluidas las que se enumeran a continuación, enviarán mensajes específicos a la comunidad, participarán en medios de comunicación y ampliarán el SEP a través de las redes sociales para crear conciencia sobre las opciones de cobertura disponibles a través de CuidadoDeSalud.gov. Los Centros de Servicios de Medicare y Medicaid (CMS) también lanzaron una campaña de divulgación y educación, que incluye publicidad digital y medios tradicionales, y educa a través de correo electrónico y mensajes de texto tanto en español como en inglés.

The Ethics of Anti-Racism is Topic of Next White Fund Lecture

Eddie S. Glaude Jr., chair of the African American Studies Department at Princeton University, will deliver a virtual White Fund Lecture presentation titled "The Ethics of Anti-Racism" on Wednesday, May 5 at 6:30 pm,

Free and open to the public, with pre-registration required, his presentation will deconstruct the idea of whiteness and the way in which it determines the distribution of advantage and disadvantage in this country. The White Fund Lecture Series is a partnership with Northern Essex Community College.

An author, political commentator, public intellectual, and passionate educator, Glaude calls on his audiences to engage in an ongoing critique of racism's manifestations, challenging people to think more carefully and systematically about racial issues.

Glaude's writings include "Democracy in Black: How Race Still Enslaves the American Soul," "In a Shade of Blue: Pragmatism and the Politics of Black America", and his most recent, the New York Times bestseller, "Begin Again: James Baldwin's America and Its Urgent Lessons for our Own", which takes a wide look at Black communities, the difficulties of race in the United States and the challenges we face as a democracy.

In his writing and speaking, Glaude is an American critic in the tradition of James Baldwin and Ralph Waldo Emerson, confronting history and bringing our nation's complexities, vulnerabilities and hope into full view.

Glaude is the James S. McDonnell distinguished university professor and chair of the Department of African American

Studies at Princeton. He frequently appears in the media, as a columnist for TIME Magazine and as an MSNBC contributor on programs like "Morning Joe" and "Deadline Whitehouse with Nicolle Wallace". He regularly appears on "Meet the Press" on Sundays. Glaude also hosts Princeton's AAS podcast, a conversation around the field of African American Studies and the Black experience in the 21st century.

por adelantado de créditos fiscales para las primas. 3 millones de adultos latinos sin seguro pueden ser elegibles para acceder a un plan por menos de \$50 por mes después de los pagos anticipados de los créditos fiscales para las primas. Más de 500,000 estadounidenses ya se han inscrito para la cobertura de salud durante las primeras seis semanas de disponibilidad de SEP en CuidadoDeSalud.gov.

Casi 15 millones de estadounidenses que actualmente carecen de seguro médico y muchos de los afiliados actuales pueden ser elegibles para recibir apoyo financiero adicional para obtener cobertura a través del Mercado como parte del American Rescue Plan.

Los consumidores que quisieran inscribirse en una cobertura y ver si califican para primas más asequibles pueden visitar HealthCare.gov o CuidadoDeSalud.gov para ver los planes y precios de 2021 y, si son elegibles, inscribirse en el plan que mejor se adapte a sus necesidades. Además, los consumidores pueden llamar al Centro de llamadas de Marketplace al 1-800-318-2596, que brinda asistencia en más de 150 idiomas. Los usuarios de TTY pueden llamar al 1-855-889-4325. El concejo aprobó la construcción de la escuela Oliver

El martes, 20 de abril de 2021, el Concejo Municipal tomó una votación para aprobar un documento presentado por la Superintendente de las Escuelas Públicas de Lawrence para la Aprobación de Financiamiento para el costo de la Escuela Oliver Partnership de \$132,300,000.

Muchos padres, maestros y estudiantes utilizaron la porción de participación pública para abogar por la reconstrucción de la escuela. Había tanta gente esperando para hablar y la media hora asignada para ese período estaba a punto de cerrarse cuando el Concejal del Distrito D, Jeovanny Rodríguez, propuso suspender la regla para permitirles expresarse. Me alegré de que lo hiciera porque Richard Russell no había usado sus dos minutos y medio y siempre vale la pena escucharlo.

Según el Director de Finanzas, el costo estimado del proyecto es de 132.3 millones de dólares. La Autoridad de Construcción Escolar de Massachusetts (MSBA) se compromete a invertir un máximo de 46% del costo (\$60 millones sin hacer cambios ni sobrecostos). La ciudad deberá recaudar alrededor de \$73 millones. La deuda estará más cerca de \$80 millones debido a sobrecostos, órdenes de cambio o fondos no reembolsables de la MSBA.

Lo que eso significa es que la Ciudad tendrá que pedir prestados los \$73-80 (o más) y colocar entre \$5 y \$5.5 millones de fondos adicionales en el presupuesto operativo del fondo general de la ciudad solo para pagar, aunque ese costo se reduciría cada año a partir de ahora hasta el 2028 por el pago de otras deudas.

Recordemos a los lectores que la Ciudad se ha puesto en una situación con los gastos de COVID y culpemos al alcalde actual por ese problema. Teniendo nueve (9) lugares diferentes, en Lawrence, donde la gente podía inscribirse y recibir las vacunas COVID, decidió dejarse convencer por el Director de Salud y Servicios Humanos para abrir otro sitio de vacunas (otra historia posiblemente para otro día). Solo ese sitio de vacunación (Arlington School) ha gastado más de \$5 millones hasta la fecha, probablemente en efectivo gratis. Por lo tanto, es posible que el fondo en efectivo no esté disponible para algunos gastos de construcción escolar en el corto plazo. También podemos culpar al Director de Presupuesto y Finanzas por no detener ese gasto. Por qué tener esa posición que lo único que hace es pedir fondos prestados. Si no va a poner fin a los estúpidos gastos

presupuestarios, no está haciendo su trabajo.

En segundo lugar, culpemos a los funcionarios electos porque este es un año de elecciones y aquellos que se postulan para un cargo no querían mostrar a sus electores que el Concejo Municipal aumentaría los impuestos en los próximos años. Después de todo, no quieren perder votos. Sin embargo, cuando el Concejal Abdoo está de acuerdo y lo explica en la aplicación de impuestos, dice que este plan no se pensó a fondo y que coloca a la ciudad en una posición para tener una deuda mayor de la que puede tener.

En tercer lugar, culpemos a los padres, empleados de la escuela y residentes por no siquiera asistir a las reuniones del concejo de la ciudad para defender el proyecto de restauración y mejora de Oliver. Las personas que no asisten a las reuniones del concejo de la ciudad para hablar a favor o en contra de ningún proyecto hacen de esta una muestra muy triste de derechos ciudadanos. Sin embargo, mire la larga fila de un obsequio que se distribuye en toda la comunidad y vea cuántas personas hacen esa larga fila. Así que supongo que obtienen lo que les dan por no preocuparse.

Cuando el Alcalde Rivera asumió el cargo, inmediatamente creó la ilusión de escasez de unidades de alquiler, luego les dio cart blanche a muchos inversionistas para que vinieran a la ciudad y construyeran o reconstruyeran estructuras para apartamentos, aumentando así enormemente la población sin un plan para escuelas adicionales o tamaños de clases. Hace ocho años, la ex superintendente interina, Mary Lou Bergeron, hizo esta declaración. Le preocupaba que la Ciudad se estuviera moviendo demasiado rápido sin abordar el tamaño de las clases de las escuelas y la falta de construcción de nuevas escuelas. ¡Esto fue hace ocho años!

También es hora de un comité escolar electo. Un comité escolar elegido y autorizado habría sido fundamental en este tema. Sin embargo, al ver que el alcalde interino Vásquez ni siquiera es parte de la Junta de la Alianza Escolar de Lawrence, es posible que no esté interesado en llevar su lucha a la causa, incluso después de decirle al concejo que la apoya. No lo culpamos si no está a bordo. DESE debería haber reemplazado a Rivera con Vásquez.

Esta no es la única escuela que está en la lista de mejoras capitales: Leahy School. No existe un plan sobre cómo abordar ese proyecto. Ese plan detallado debería comenzar a construirse ahora. Me refiero a que de alguna manera, en el camino, la Ciudad le pide a la MSBA una mejora capital para las dos escuelas mencionadas y de alguna manera no había ningún plan en

ese momento (durante la solicitud).

Un plan maestro de la ciudad debe incluir permitir el crecimiento de las escuelas religiosas y autónomas para ayudar en la peor parte del aumento de la población escolar. En la reunión del concejo del 6 de abril, cada concejal pidió un plan para el futuro. Sin embargo, deberían haber abogado por ese plan durante la administración de Rivera.

Pues ahí va el aumento de valor y necesidad de valor de la propiedad de la Concejala Estela Reyes.

Estoy de acuerdo que la Ciudad necesita nuevas escuelas. Simplemente no sé si es una buena idea seguir aferrándose a estos edificios de la vieja escuela cuando es mejor colocar a nuestros estudiantes en nuevas estructuras tecnológicas y más adecuadas.

La parte divertida de la reunión

El momento culminante de la velada fue cuando la Concejala del Distrito A, María De La Cruz, se quejó (nuevamente) de la Comisión Histórica por no involucrarse en el tema de la escuela Oliver. Insiste en que es un edificio histórico, lo cual no es cierto, pero al menos esta vez no mencionó la casa de Estela.

Puedo decir que no lee mi columna porque le expliqué algunas veces lo equivocada que está y sigue repitiendo las tonterías.

Lawrence Youth Advisor gana el premio estatal en el Virtual Kick Butts Day: Youth Day of Action

Recientemente, los jóvenes del Grupo de Trabajo para la Prevención del Abuso de Sustancias Juveniles de la Coalición Comunitaria de Lawrence/Methuen asistieron al Kick Butts Day: Youth Day of Action, un evento virtual organizado por The 84 Movement, un movimiento estatal de jóvenes que luchan contra las industrias del tabaco y el vapeo en Massachusetts.

Los 318 jóvenes y adultos que asistieron al Kick Butts Day de todo el Commonwealth trabajan para educar y movilizar a los jóvenes en sus comunidades sobre la focalización de la industria del tabaco y el vapeo. El Día de Kick Butts tuvo lugar en la Casa de Estado de Massachusetts en Boston antes de la pandemia; ahora El Movimiento 84 todavía ofrece una forma segura de celebrar el evento anual.

Durante una ceremonia de premiación, Evelyn Rodríguez, asesora adulta del Grupo de Trabajo para la Prevención del Abuso de Sustancias Juveniles, recibió el Premio Asesor Adulto 2021 y fue honrada por su dedicación a la prevención del tabaquismo en los jóvenes y la promoción de la voz de los jóvenes. Es una defensora apasionada de la prevención del tabaco y estuvo muy involucrada en la campaña 2020 No Menthol Know Why que educó a la comunidad sobre la orientación de la industria tabacalera de los productos mentolados a las comunidades de color.

Evelyn Rodríguez ha sido la asesora de adultos del Grupo de Trabajo para la Prevención del Abuso de Sustancias Juveniles desde 2016 cuando comenzó el capítulo en Lawrence High School. Ella involucró a cientos de jóvenes en su capítulo y ayudó a crear una sólida comunidad de



líderes juveniles en Lawrence. La actitud positiva, el entusiasmo por la prevención del tabaquismo y el éxito de Eve en elevar las voces de los jóvenes son inspiradores.

Durante otra parte del evento del Día de Kick Butts, los jóvenes se reunieron virtualmente con los Representantes Christina Minicucci y Frank Moran. Hablaron de la importancia de mantener informada a la comunidad sobre los peligros del tabaco, las tácticas utilizadas por la industria para hacer adictos a los clientes y la prevalencia del tabaco narguile (cachimbo) en la ciudad de Lawrence. Los representantes se enteraron de que los jóvenes quieren ver datos sobre el uso de narguiles en Lawrence y están haciendo un seguimiento con YSAPTF al respecto.

Lawrence Youth Advisor Wins Statewide Award at Virtual Kick Butts Day: Youth Day of Action

Recently, young people from the Youth Substance Abuse Prevention Task Force from the Lawrence/Methuen Community Coalition attended Kick Butts Day: Youth Day of Action, a virtual event hosted by The 84 Movement, a statewide movement of youth fighting against the tobacco and vaping industries in Massachusetts.

The 318 youth and adults who attended Kick Butts Day from around the Commonwealth work to educate and mobilize young people in their communities about tobacco and vaping industry targeting. Kick Butts Day took place at the Massachusetts State House in Boston before the pandemic; now The 84 Movement still offers a safe way to celebrate the annual event.

During an awards ceremony, Evelyn Rodriguez, adult advisor to the Youth Substance Abuse Prevention Task Force, received the 2021 Adult Advisor Award and was honored for her dedication to youth tobacco prevention and promoting the voice of young people. She is a passionate advocate for tobacco prevention and was heavily involved in the 2020 No Menthol Know Why Campaign that educated the community about the tobacco

industry's targeting of menthol products to communities of color.

Evelyn Rodriguez has been the adult advisor to the Youth Substance Abuse Prevention Task Force since 2016 when she began the chapter at Lawrence High School. She engaged hundreds of youth in her chapter and helped create a strong community of youth leaders in Lawrence. Eve's positive attitude, enthusiasm for tobacco prevention, and success at elevating youth voices are inspiring.

During another part of the Kick Butts Day event, the youth met virtually with Representatives Christina Minicucci and Frank Moran. They discussed the importance of keeping the community informed on the dangers of tobacco, the tactics used by the industry to addict customers, and the prevalence of hookah tobacco in the city of Lawrence. The representatives learned that the youth want to see data about hookah use in Lawrence and they are following up with the YSAPTF about that.



Starting Monday, April 19, everyone ages 16 and older in Massachusetts is eligible to receive the COVID-19 vaccine.

Your best bet to get the vaccine as soon as possible is to pre-register with the state at VaccineSignUp.mass.gov. You will be notified when it is your turn to schedule an appointment at one of 7 mass vaccination locations.

We have also arranged a number of places in Haverhill where you can get vaccinated. Details are below.

We are also continuing to hold almost daily vaccination clinics at the Haverhill Citizens Center, 10 Welcome St. For an appointment, go to www.haverhillrec.com or call 978-374-2390.

Get the Vaccine as Soon as you can

As you know, the CDC and the State have temporarily paused the use of the Johnson and Johnson vaccine while they study a few cases of women who got blood clots a few weeks after receiving it. The risk of a blood clot is extremely low.

If and when the CDC releases the hold on the J&J vaccine, there is no reason to panic and no reason not to get vaccinated.

The danger we must be cautious of is the COVID-19 virus that has paralyzed the world and killed more than 3 million people. **It is the virus, not the vaccine, that must concern us.**

"I am very proud of these five officers," Mayor Perry said. "They have all made a choice to enter this profession at a time where they will face intense challenges and have dedicated themselves to mold policing into the future. Each of them has the power to define what it means to be a police officer."

"I'm so impressed with Brady, John, Jeffrey, James and Felicia and their courage to become a police officer in these trying times," Acting Chief McCarthy said. "I have been impressed with their enthusiasm, dedication and commitment. Each will complete a full training program before rotating onto working themselves as street officers. I am looking forward to watching their development as they start their careers."

• Officer Jeffrey McAndrew is a lifelong Methuen resident. He graduated from Methuen High School in 2011 and graduated from The University of Massachusetts Lowell in 2015 with a Bachelor's degree in Criminal Justice with a concentration in policing. Officer McAndrew was inspired to become a Methuen Police officer after having the opportunity to participate in several ride-alongs when he was younger. He has been working as a Reserve Officer with the Department since 2018.

• Officer James Keating is a lifelong Methuen resident. He attended Central Catholic High School in Lawrence and Northern Essex Community College in Haverhill, where he studied Criminal Justice. Prior to joining the Methuen Police Department, Officer Keating spent 11 years working as a contractor with G4S Security Solutions at Seabrook Station Nuclear Power Plant in Seabrook, N.H. Officer Keating was hired as a Reserve Officer with the Police Department in 2017. He is

married and has three children.

- Officer Felicia Bistany is a Methuen resident and has served as a reserve officer with the Police Department since 2018, after graduating from the New England Law Enforcement Training Center. She is a third-generation police officer, following in the footsteps of her mother and grandfather. Before becoming a full-time officer, Officer Bistany attended classes at Northern Essex Community College and was employed by the Lawrence Public School Department for several years.
- Officer John Laurenza graduated from Curry College in Milton in May 2019 with a Bachelor's degree in Criminal Justice and Psychology. From 2019-2020, Officer Laurenza worked as a correctional officer for the Essex County Sheriff's Department and as a security officer at Lawrence General Hospital. He graduated from the Massachusetts Law Enforcement Training Alliance in August 2020 and began the NECC Methuen Police Academy that November. During the Academy, Officer Laurenza received the Top Gun award for his firearms skills and the Physical Training award for his performance in fitness testing and training.

- Born and raised in Methuen, Officer Brady Abraham has given back to the community since 2016 as an Intermittent Officer for the department. He previously worked as a security officer for Lowell General Hospital. Officer Abraham completed his Associate's degree in Criminal Justice from Northern Essex Community College in 2016.

All five officers will complete a two-week training rotation consisting of additional firearms, Taser, first-aid, officer rescue and lifesaving training.

Officers McAndrew, Keating and Abraham have completed a 17-week Field Training program and will be assigned to a shift by the end of April. Officers Bistany and Laurenza will begin the 17-week Field Training program assigned to a veteran Field Training Officer and will be scheduled to complete their training during the summer.

Antes de unirse al Departamento de Policía de Methuen, el oficial Keating pasó 11 años trabajando como contratista con G4S Security Solutions en la planta de energía nuclear de la estación Seabrook en Seabrook, el oficial de NH Keating fue contratado como oficial de reserva con el Departamento de Policía en 2017. Está casado y tiene tres hijos.

• La oficial Felicia Bistany es residente de Methuen y se ha desempeñado como oficial de reserva en el Departamento de Policía desde 2018, después de graduarse del Centro de Capacitación para el Cumplimiento de la Ley de Nueva Inglaterra. Es una policía de tercera generación que sigue los pasos de su madre y su abuelo. Antes de convertirse en oficial a tiempo completo, la oficial Bistany asistió a clases en el Northern Essex Community College y fue empleada del Departamento de Escuelas Públicas de Lawrence durante varios años.

• El oficial John Laurenza se graduó de Curry College en Milton en mayo de

2019 con una licenciatura en Justicia Penal y Psicología. De 2019 a 2020, la oficial Laurenza trabajó como oficial correccional para el Departamento del Sheriff del condado de Essex y como oficial de seguridad en el Lawrence General Hospital. Los cinco oficiales completarán una rotación de entrenamiento de dos semanas que consiste en armas de fuego adicionales, Taser, primeros auxilios, rescate de oficiales y entrenamiento para salvar vidas.

Los oficiales McAndrew, Keating y Abraham han completado un programa de entrenamiento de campo de 17 semanas y serán asignados a un turno a fines de abril. Los oficiales Bistany y Laurenza comenzarán el programa de entrenamiento de campo de 17 semanas asignado a un oficial de entrenamiento de campo veterano y se programará para completar su entrenamiento durante el verano.

SBA anuncia Fondos Oficiales Para la Revitalización de Restaurantes Solicitud y Guías

Alivio económico priorizado para comunidades desatendidas

WASHINGTON - La administradora de la SBA, Isabella Casillas Guzmán, anunció detalles clave sobre los requisitos de solicitud, elegibilidad y una guía de programas para el Fondo de Revitalización de Restaurantes (RFF). La industria de restaurantes ha estado entre los sectores más afectados durante la recesión económica causada por la pandemia de COVID-19. Para ayudar a recuperar empleos y revivir la industria, el Plan de Rescate Estadounidense, promulgado por el presidente Joe Biden, estableció el Fondo de Revitalización de Restaurantes de \$28.6 mil millones en la Administración de Pequeñas Empresas de EE.UU. (SBA). La SBA administrará los fondos a los pequeños restaurantes más afectados.

"Hoy, estamos comenzando el proceso para ayudar a los restaurantes y bares de todo el país devastados por la pandemia, y este es nuestro mensaje: la ayuda está aquí. Con el lanzamiento del Fondo de Revitalización de Restaurantes, estamos dando prioridad a la financiación de las pequeñas empresas más afectadas: lugares de reunión insustituibles en nuestros vecindarios y comunidades que necesitan un salvavidas ahora para recuperarse", dijo Isabella Casillas Guzmán, administradora de la SBA. "Y, gracias a las claras directivas del Congreso, estamos implementando este programa para asegurarnos de que estas empresas puedan cumplir con la nómina, comprar suministros y obtener lo que necesitan para realizar la transición al

mercado actual restringido por COVID".

La Administradora Guzmán enfatizó: "También estamos enfocados en asegurar que el proceso de solicitud del programa RRF sea simplificado y libre de obstáculos burocráticos y onerosos, al tiempo que mantenemos una supervisión sólida. Bajo mi liderazgo, la SBA apunta a ser tan emprendedora como los emprendedores a los que servimos, y eso significa conocer a todas las pequeñas empresas donde se encuentran y brindarles el apoyo que necesitan para recuperarse, reconstruirse y prosperar".

Bajo este anuncio, los detalles sobre los requisitos de solicitud, elegibilidad y una guía del programa están ahora disponibles en inglés en www.sba.gov/restaurants o en español en www.sba.gov/restaurantes.

Antes del lanzamiento de la aplicación y durante las próximas dos semanas, la SBA establecerá un período piloto de siete días para el portal de la aplicación RRF y llevará a cabo una amplia divulgación y capacitación. El período piloto se utilizará para abordar problemas técnicos antes del lanzamiento público. Los participantes en este piloto serán seleccionados al azar entre los prestatarios de APP existentes en grupos prioritarios para RRF y no recibirán fondos hasta que el portal de solicitud esté abierto al público.

Después del piloto, el portal de la aplicación se abrirá al público. La fecha de lanzamiento oficial de la aplicación se anunciará más adelante. Durante los primeros 21 días que el programa esté

abierto, la SBA dará prioridad a la revisión de solicitudes de pequeñas empresas propiedad de mujeres, veteranos e individuos en desventaja social y económica. Después del período de 21 días, se anima a todos los solicitantes elegibles a enviar solicitudes.

La base para este anuncio es el resultado de un esfuerzo integral para llegar a diversas partes interesadas con el fin de comprender las necesidades y las barreras que enfrentan los restaurantes para acceder a la ayuda de emergencia.

"Hoy se están sirviendo muy buenas noticias a los restaurantes y bares locales", dijo Erika Polmar, directora ejecutiva de Independent Restaurant Coalition. "Estas pautas fueron elaboradas por la SBA después de conversaciones con operadores independientes de restaurantes y bares en todo el país.

Agradecemos a la SBA por su arduo trabajo para hacer que este proceso sea lo más accesible posible en un corto período de tiempo. Está claro que la SBA y la Administración Biden se preocupan profundamente por garantizar que las empresas que más luchan puedan usar este programa de ayuda de manera rápida y efectiva, y esperamos continuar las conversaciones y la colaboración para garantizar que este fondo funcione según lo previsto para la comunidad de bares y restaurantes independientes."

Los líderes empresariales comunitarios de comunidades marginadas también recibieron la ayuda de RRF como un alivio económico muy necesario y están

trabajando con sus amplias bases de miembros para navegar el proceso de solicitud de subvenciones.

"Además de tener históricamente menos liquidez operativa e ingresos que casi cualquier otro grupo demográfico de pequeñas empresas, los restaurantes propiedad de negros recibieron significativamente menos fondos de estímulo durante la pandemia de COVID-19, lo que aumentó los desafíos y provocó cierres desproporcionados", dijo Ron Busby, Sr., presidente y director ejecutivo de US Black Chambers, Inc. "La USBC cree que esta iniciativa y colaboración con la SBA brindará los recursos y el alivio necesarios a estas empresas a menudo desatendidas para ayudar en la estabilización, la recuperación y, en última instancia, fortalecer nuestra economía".

Además de los grupos de restaurantes y los principales grupos de defensa de las comunidades comerciales desatendidas, la SBA ha involucrado a asociaciones comerciales nacionales y estatales, y otras partes interesadas de pequeñas empresas en las últimas semanas para comprender sus preocupaciones sobre los programas de ayuda.

"Las cervecerías artesanales pequeñas e independientes son lugares vibrantes de reunión comunitaria que se pueden encontrar en casi todos los distritos del

SBA Announces Official Restaurant Revitalization Fund Application and Guidelines

Economic relief prioritized for underserved communities

WASHINGTON – SBA Administrator Isabella Casillas Guzman announced key details on application requirements, eligibility, and a program guide for the Restaurant Revitalization Fund (RRF). The restaurant industry has been among the hardest-hit sectors during the economic downturn caused by the COVID-19 pandemic. To help bring jobs back and revive the industry, the American Rescue Plan, signed into law by President Joe Biden, established the \$28.6 billion Restaurant Revitalization Fund at the U.S. Small Business Administration (SBA). The SBA will administer the funds to the hardest-hit small restaurants.

"Today, we are starting the process to help restaurants and bars across the country devastated by the pandemic, and this is our message: Help is here. With the launch of the Restaurant Revitalization Fund, we're prioritizing funding to the hardest-hit small businesses – irreplaceable gathering places in our neighborhoods and communities that need a lifeline now to get back on their feet," said SBA Administrator Isabella Casillas Guzman. "And, thanks to clear directives from Congress, we're rolling out this program to make sure that these businesses can meet payroll, purchase supplies, and get what they need in place to transition to today's COVID-restricted marketplace."

Administrator Guzman emphasized, "We're also focused on ensuring that

the RRF program's application process is streamlined and free of burdensome, bureaucratic hurdles – while still maintaining robust oversight. Under my leadership, the SBA aims to be as entrepreneurial as the entrepreneurs we serve – and that means meeting every small business where they are, and giving them the support they need to recover, rebuild and thrive."

Under this announcement, details on application requirements, eligibility, and a program guide are now available in English at www.sba.gov/restaurants or in Spanish at www.sba.gov/restaurantes.

Ahead of the application launch and over the next two weeks, the SBA will establish a seven-day pilot period for the RRF application portal and conduct extensive outreach and training. The pilot period will be used to address technical issues ahead of the public launch. Participants in this pilot will be randomly selected from existing PPP borrowers in priority groups for RRF and will not receive funds until the application portal is open to the public.

Following the pilot, the application portal will be opened to the public. The official application launch date will be announced at a later date. For the first 21 days that the program is open, the SBA will prioritize reviewing applications from small businesses owned by women, veterans, and socially and economically disadvantaged individuals. Following the 21-day period, all eligible applicants are encouraged to submit applications.

The groundwork for this announcement is the result of a comprehensive effort to reach out to diverse stakeholders in order to understand the needs and barriers restaurants face in accessing emergency relief aid.

"Local restaurants and bars are being served very good news today," said Erika Polmar, Executive Director of the Independent Restaurant Coalition. "These guidelines were crafted by the SBA after conversations with independent restaurant and bar operators across the country. We are grateful to the SBA for their hard work to make this process as accessible as possible in a short period of time. It is clear the SBA and the Biden Administration care deeply about ensuring businesses struggling the most can quickly and effectively use this relief program, and we look forward to continued conversations and collaboration to ensure this fund works as intended for the independent restaurant and bar community."

Community business leaders from underserved communities also welcomed RRF assistance as much-needed economic relief and are working with their broad membership bases to navigate the grant application process.

"In addition to historically having less operating liquidity and revenue than almost any other small business demographic, Black-owned restaurants received significantly less stimulus funding during the COVID-19 pandemic, heightening challenges and leading to disproportionate closures," said

Ron Busby, Sr., president and CEO, U.S. Black Chambers, Inc. "The USBC believes this initiative and collaboration with the SBA will bring needed resources and relief to these often underserved businesses to aid in stabilization, recovery and ultimately, strengthen our economy."

In addition to restaurant groups and leading advocacy groups for underserved business communities, the SBA has engaged national and state trade associations, and other small business stakeholders in recent weeks to understand their concerns about relief programs.

"Small and independent craft breweries are vibrant community gathering places that can be found in nearly every congressional district in the U.S. and contribute to manufacturing, hospitality, retail, tourism, and agricultural industries," said Bob Pease, president and CEO, Brewers Association. "We are pleased to work with the SBA to promote the Restaurant Revitalization Fund landing page and its available resources, and assist the breweries hit hardest by COVID-19 secure much needed additional relief to help them survive the pandemic and prepare for the restart of the economy."

At all levels, the SBA will continue engaging with stakeholder communities to inform and design delivery of financial assistance programs. As the SBA builds and prepares to roll out the program, this dedicated SBA website is the best source for up-to-date information for eligible restaurants interested in the RRF.


Nuevo libro sobre cubanos en Massachusetts





From My Corner

Council approved construction of the Oliver School

On Tuesday, April 20, 2021, the City Council took to take a vote to approve a document submitted by the Lawrence Public Schools Superintendent for the Approval of Funding for the Oliver Partnership School cost of \$132,300,000.

There were many parents, teachers, and students using the public participation portion to advocate for the school's rebuilding. There were so many people waiting to speak and the half-hour allocated for that period was about to close when District D Councilor Jeovanny Rodríguez proposed suspending the rule to allow them to express themselves. I was glad he did because Richard Russell had not used his two-and-a-half minutes and he is always worth listening.

According to the Finance Director, the estimated cost of the project is \$132.3 million. The Massachusetts School Building Authority (MSBA) commits to investing a maximum of 46% of the cost (\$60 million without hinge orders or overruns). The city will need to pick up around \$73 million. The debt will be closer to \$80 million due to overrun, change orders or non-reimbursable funds from the MSBA.

What that means is that the City will have to borrow the \$73-80 (or more) and place between \$5 to \$5.5 million additional funding into the city's general fund operating budget just to pay back, although that cost would be reduced every year from now until 2028 due to the payoff of other debts.

Let us remind the readers that the City has been put into a situation with the COVID expenditures and blame the current mayor for that issue. Having nine (9) different places, in Lawrence, that people could sign up and get COVID vaccinations he decided to let himself be convinced by the Director of Health & Human Services to

open up another vaccine site (another story possibly for another day). That vaccination site (Arlington School) alone has spent more than \$5 million to date – probably from free cash. So, free cash may not be readily available for some school building expenditures anytime soon. We can also blame the Budget and Finance Director for not putting a stop to that expenditure. So much for having that position shoved down our throats just to borrow funds. If he is not going to put a stop to foolish budget expenditures, he is not doing his job.

Second, let's blame the elected officials because this is an election year and those running for office would not want to show their constituents that the City Council would be increasing taxes in the coming year(s). After all, they don't want to lose votes. However, when you have Councilor Abdoo agree with, and makes his point on the tax application, it says that this plan was not thoroughly thought and that places the City in a position to have a bigger debt than it can hold.

Third, let's blame parents, school employees, and residents for not even attending the city council meetings to advocate for the Oliver restoration and upgrade project. People not attending city council meetings to speak for or against any projects make this a very sad display of citizen rights. However, look at the long line of a freebie being given out throughout the community, and see how many people make that long line. So I guess they get what they get for not caring.

When Mayor Rivera took office, he immediately created an illusion of rental unit shortage, then he gave cart blanche to many investors to come into the city and build or redevelop structures for apartments, thus hugely increasing population without a plan for additional schools or class sizes. Eight years ago, former Acting Superintendent, Mary Lou Bergeron, made this statement. She was concerned that the City was moving too quickly without addressing the school class size and the lack of new school

construction. This was eight years ago!

It's also time for an elected school committee. An elected and authoritative school committee would have been instrumental in this issue. However, seeing that Acting Mayor Vasquez is not even part of the Lawrence School Alliance Board, he may not be interested in taking their fight to cause even after telling the council that he supports it. We don't blame him if he is not on board. DESE should have replaced Rivera with Vasquez.

This is not the only school that is on the list for capital improvements – Leahy School. There is no plan in place on how to tackle that project. That detailed plan should start to be built now. I mean somehow along the way the City asks the MSBA for capital improvement to both of the above schools and somehow no plan was in place then (during the request).

A city master plan should include allowing the growth for religious and charter schools to help in the brunt of the increase of the school population. At the April 6th council meeting each councilor was asking for a plan, going forward. However, they should have advocated for that plan during the Rivera administration.

Well, there goes Councilor Estela Reyes' property increase of value and necessity of value.

I agree the City needs new schools. I just don't know if it's a good idea to continue holding onto these old school buildings when it is best to put our students into new technological and better-suited structures.


New book about Cubans in Massachusetts
