CDC guidance is clear that fully vaccinated people are safe to travel and can resume travel.

These devices are used to provide a comfortable prone position for women undergoing radiation therapy for breast cancer, which can also ensure a more accurate dose of targeted radiation.

The Women Working Wonders Fund (WWWF), a permanently endowed fund of the Greater Lowell Community Foundation, requests proposals for this year's grant cycle that opens on May 13. The Women Working Wonders Fund announced earlier this year that funding has been increased to award five grants at \$10,000 each to program/ projects that impact the lives of women and girls while advancing your organization's

"As we enter into our 17th year, we have been fortunate to continue to grow our endowment and increased grant support to our community," said Susan West Levine, Women Working Wonders Fund board president. Doherty, un veterano de 26 años del Departamento de Policía de Haverhill que comenzó como oficial auxiliar en 1995, sucede al exdiputado Anthony Haugh, quien se retiró el 31 de enero de 2021.

Doherty, que vive en Haverhill, tomó juramento en su nuevo cargo en una ceremonia en el auditorio del Ayuntamiento el jueves, 13 de mayo por la mañana. Meaghan Pare también prestará juramento como Capitán permanente en la misma ceremonia.

Doherty, vicepresidente del Sindicato de Superiores de Policía de Haverhill desde el 2008, se ha desempeñado como supervisor o gerencial durante 16 de sus aproximadamente 26 años en la aplicación

Ha dirigido la División de Investigaciones de la Policía de Haverhill desde el 2018. Esa división incluye investigaciones generales, narcóticos y pandillas, fiscal de la corte, unidad de pruebas/propiedad, análisis de TI/delitos y asuntos de los medios de comunicación.

Antes de eso, Doherty fue oficial de patrulla de Haverhill de 1998 al 2004.

Doherty es también el principal oficial de información pública del Departamento

En su currículum, Doherty enfatizó sus habilidades en la construcción de asociaciones comunitarias, liderazgo y relaciones laborales "para enfocarse en un punto de vista comprometido con el servicio orientado a la comunidad".

"Mi formación académica, junto con mi diversa experiencia laboral, me permite aplicar teorías y principios sólidos de liderazgo/gestión a situaciones laborales diarias de una manera eficaz y eficiente", dijo Doherty en su currículum.

Doherty tiene una licenciatura y una maestría en ciencias en aplicación de la ley y administración de justicia penal del Western New England College.

# **Mayor Promotes Doherty to Haverhill Deputy Police Chief**

Mayor James J. Fiorentini has appointed veteran Haverhill Police Detective Captain Stephen J. Doherty Jr. to be the city's new Deputy Police Chief.

Doherty, a 26-year veteran of the Haverhill Police Department who began as an auxiliary officer in 1995, succeeds former Deputy Anthony Haugh, who retired on January 31, 2021.

Doherty, who lives in Haverhill, was sworn-in to his new position at a ceremony in the City Hall auditorium Thursday, May 13 in the morning. Meaghan Pare will also take the oath as a permanent Captain at the same ceremony.

Doherty, vice-president of the Haverhill Police Superiors Union since 2008, has served in a supervisory or management capacity for 16 of his approximately 26 years in law enforcement.

He has headed Haverhill's Police Investigative Division since 2018. That division includes general investigations, narcotics and gangs, court prosecutor, evidence/property unit, IT/crime analysis, and media affairs. Before that, Doherty was

a Haverhill patrol officer from 1998 to 2004.

Doherty is also the Haverhill Department's primary Public Information

In his resume, Doherty stressed his skills in community partnership building, leadership, and labor relations "to focus on a point of view that is committed to community-oriented service."

"My educational background, along with my diverse work experience, affords me the ability to apply sound leadership/ management theories and principles to daily work situations effectively and efficiently," Doherty said in his resume.

Doherty has a bachelor's and Masters of Science degrees in Law Enforcement and Criminal Justice Administration from Western New England College.

The Haverhill Police Department is an accredited police department that serves a population of more than 63,000 residents in a 36-mile, mixed urban and rural area. There are 110 sworn officers and 21 civilian employees in the Haverhill Police Department.

# El alcalde asciende a Doherty a Laplante exige cambios en

El presidente del Concejo Municipal, Marc Laplante, exige que la Ciudad de Lawrence acelere una revisión de seguridad en la intersección de South Lawrence conocida como "Five Corners". Un accidente automovilístico a primera hora de la mañana del 30 de abril de 2021 en la intersección de Winthrop Avenue y South Union Street, que incluía una alta velocidad, se cobró trágicamente la vida de Gabriela Hernández, una residente de Lawrence de 25 años.

"Lo que sucedió ese jueves por la mañana fue impactante", dijo Laplante, cuyo distrito (Distrito F) abarca la intersección de las 5 Esquinas. "Un estudio financiado por la ciudad ha comenzado a evaluar opciones para mejorar esta intersección", agregó. "Esta revisión debe ser una prioridad y debe colocarse en la parte superior de cualquier lista".

"No pueden continuar más pérdidas de vidas o lesiones", continuó el presidente del

El Departamento de Policía de Lawrence ha realizado varias operaciones de tráfico de 5 Corners para tomar medidas

enérgicas contra el exceso de velocidad y otras infracciones de tráfico. Desde el 1 de enero hasta el 15 de abril, la policía emitió 155 citaciones por infracciones de tránsito y en movimiento en esa intersección. En las dos primeras semanas de abril se emitieron 45 citaciones por exceso de velocidad.

"Está claro que la policía está haciendo esfuerzos para cambiar los comportamientos peligrosos al conducir en la zona, pero no es suficiente", dijo el concejal de la ciudad de ocho mandatos. "Los residentes están legítimamente preocupados por 5 Corners, pero se necesitará más que la presencia de la policía. Estoy ansioso por revisar e implementar las recomendaciones estructurales hechas por los ingenieros de tráfico y otros expertos".

La intersección de las 5 esquinas está ubicada en la intersección de South Union Street, Winthrop Avenue y Exeter Street.

Laplante patrocina este tema en la agenda del Ayuntamiento de Lawrence. Es el Concejal de la Ciudad del Distrito F y el Presidente del Concejo Municipal.

# **Laplante Demands Changes** at Deadly Intersection

City Council President Marc Laplante is demanding that the City of Lawrence accelerate a safety review at the South Lawrence intersection known as "Five Corners." An April 30, 2021 early morning car crash at the intersection of Winthrop Avenue and South Union Street, which included a high rate of speed, tragically took the life of 25 year old Lawrence resident, Gabriela Hernandez.

"What happened on that early Thursday morning was shocking," said Laplante, whose district (District F) encompasses the 5 Corners intersection. "A city-funded study has begun to evaluate options to improve this intersection," he added. "This review must be a priority and placed on top of any list."

"Further loss of life or injury cannot continue," continued the Council President.

The Lawrence Police Department has conducted several 5 Corners traffic operations to crack down on speeding and other traffic violations. From January 1 to April 15, Police issued 155 traffic and moving violation citations at that intersection. In the first two weeks of April, 45 citations were issued for speeding.

"It is clear that the police are making efforts to change dangerous driving behaviors in the area, but it is not enough," said the eight term city councilor. "Residents are rightfully concerned about 5 Corners, but it will take more than police presence. I am eager to review and implement the structural recommendations made by traffic engineers and other experts."

The 5 Corners intersection is located at the intersection of South Union Street, Winthrop Avenue, and Exeter Street.

Laplante is sponsoring this item on Lawrence City Council agenda. He is the District F City Councilor and City Council President.




### Nuevo libro sobre cubanos en Massachusetts

# La destitución de la Jueza Abbe L. Ross

# Entrevista con Pilar Maté

En las últimas semanas cientos de personas en Massachusetts han visto circular la foto de esta madre en numerosas redes sociales. Ella es Pilar Maté quien, de la noche a la mañana, se ha convertido en el centro de atención mediático por hacer lo que hasta ahora nadie se había atrevido: Causar una auténtica revolución en el Probate & Family Court de Essex a través de su continuo apoyo al Proyecto de Ley presentado por el Representante Lenny Mirra para la destitución de la Jueza Abbe Ross.

Ross inicialmente fue nominada en 2014 por el entonces Gobernador Deval Patrick y comenzó a ejercer en el Condado de Suffolk.

Pilar Maté, nacida y criada en España, reside en EEUU desde 1993, es ciudadana americana desde el año 2012 y durante nuestra entrevista nos decía "siempre he confiado en el sistema judicial americano, pero después de mi experiencia, siento auténtica vergüenza de la inmensa falta de ética y de la completa desorganización que el estado de Massachusetts ejerce en las cortes de familia".

Es sabido que en los últimos meses, numerosas quejas han surgido por parte de abogados que se han encontrado con continuos retrasos, impedimentos y comportamientos sospechosos al archivar documentación para sus clientes. "Es un problema sistémico, no hay una sola persona responsable de este circo, sino un conjunto de organismos y departamentos que se niegan a ejercer con transparencia y equidad. Si los juzgados funcionaran como un reloj y los jueces no cometieran atrocidades, habría menos necesidad de hacer uso de abogados, quienes son los primeros en presenciar las injusticias que acaecen en el juzgado de familia, así como el comportamiento abusivo de algunos jueces. Por miedo a ser desfavorecidos en futuros casos, prefieren agachar la cabeza y callar ante estas injusticias. La propia Comisión de Conducta Judicial decide mirar a otro lado cuando reciben continuas quejas de un juez; no les interesa reconocer que hay un problema porque al hacerlo estarían abiertamente admitiendo que el sistema no funciona, que no protege los derechos constitucionales y civiles de los ciudadanos. Es vergonzoso pero hay muchos intereses políticos y económicos de por medio".

Rumbo publicó la historia de Pilar el 15 de Marzo este año y más de 1,500 personas lo han visto hasta la fecha.

La bomba estalló con la publicación de un artículo sobre el proyecto de ley en Massachusetts Lawyers Weekly que tiene por lo menos siete mil abogados y jueces subscritos. En respuesta y en absoluto estado de pánico, días después ha salido a la luz una carta iniciada y promulgada por la abogada Amy Hubbard, íntima amiga de Abbe Ross, recaudando firmas de otros abogados en apoyo a la jueza. No sabemos si la jueza pidió a estos abogados que firmasen o si la iniciativa salió de su amiga Mrs. Hubbard.

En cualquier caso es una violación de los cánones éticos de conducta judicial el mostrar favoritismo e imparcialidad en un caso como este.

La pregunta que todos nos hacemos es ¿qué sucederá con todos los casos que estén en manos de Abbe Ross y el abogado representante de una de las partes haya firmado esa carta de apoyo?

"Creo que firmando esa carta de apoyo, han abierto la caja de Pandora para especular con que actos de favoritismo e imparcialidad, así como pactos por debajo de la mesa y corrupción, ocurren diariamente en nuestros juzgados de familia", explica Pilar. "Éticamente, todos los abogados que han firmado dicha carta, deberían de haberse mantenido al margen, pero hay muchos intereses económicos de por medio y desgraciadamente el BBO (Massachusetts Board of Bar Overseers) mira para otro lado y pretende no saber nada de lo que está ocurriendo".

Maté tuvo custodia de su hija mayor hasta la edad de 8 años. El 11 de Agosto del 2017 fue asaltada por el padre de su hija en un estacionamiento mientras la perseguía con su celular grabando y provocando un incidente que resultó en el arresto de Maté. Inmediatamente, el padre utilizó esto en Octubre del 2017 para conseguir una orden temporal de custodia absoluta con la jueza Randy Kaplan, poniendo a la madre en visitas supervisadas por 2 horas a la semana.

Kaplan quería tener la seguridad de que la niña estaba bien con el padre debido a múltiples acusaciones de la menor de que el padre la forzaba a producir videos para luego usarlos en el juzgado. Citó a las dos partes 9 semanas más tarde para evaluar cómo la pequeña estaba con el padre, pero lamentablemente el caso había pasado a manos de Abbe Ross, quien optó por lo fácil manteniendo todo igual, en vez de familiarizarse con el caso y leerse el archivo de 8 años con más de 300 páginas.

Meses más tarde, durante el juicio criminal de la madre, el padre hizo uso de la Quinta Enmienda, básicamente admitiendo que aquel día 11 de Agosto del 2017 estaba cometiendo un crimen. Todos los cargos criminales de Pilar Maté fueron eliminados. Sin embargo, ella ya había perdido a su hija en el juzgado de familia.

Abbe Ross otorgó 4 días de juicio en 2019 a ambas partes para decidir la custodia de la pequeña. Durante el juicio, varios testigos participaron en apoyo de la madre: Una Guardian Ad Litem, que había hecho 2 investigaciones, la pediatra de la menor, junto con su terapeuta y 3 supervisores de las visitas. Así mismo se presentaron las declaraciones de la niña a través de DCF y un informe psiquiátrico de la niña. Todos concluían que la niña no quería vivir con su padre y que estaba traumatizada por los cientos de videos que el padre la forzaba a fabricar para poder acusar a la madre.

Algo importante de mencionar es el hecho de que Harvard Vanguard Atrius Health, la institución médica a la que asistía la niña para ver a su pediatra, se vio en la obligación de suspender el cuidado de la pequeña en cuanto el padre obtuvo custodia ya que el personal médico de pediatría empezó a recibir amenazas constantes por parte de él. Tras un primer aviso formal a través de una carta dirigida al padre, y viendo que las amenazas, en lugar de desaparecer, se hicieron más agresivas, la niña perdió al pediatra que la había tratado desde la edad de 2 años.

La terapeuta que trató a la niña por un período de dos años también fue eliminada en cuanto el padre obtuvo custodia.

"Lo primero que hace alguien cuando quiere manipularte, es aislarte", me dijo. Eso es exactamente lo que el padre



hizo, eliminó el círculo completo de la pequeña donde tenía una voz y comenzó a borrar progresivamente la presencia de la madre en la vida de la niña, denegándole visitas supervisadas y no informándola de absolutamente nada de lo que ocurría en la vida de la niña durante todos estos años.

La sentencia del juicio salió en Mayo del 2019, acabando completamente con la figura de la madre en la vida de la niña y otorgando todos los derechos de custodia legal y física al padre. "Tenia dos opciones: rendirme, suicidarme, abandonar... O luchar con uñas y dientes por recuperar a mi hija y por obtener justicia. No lo dudé un minuto".

Fue en dicho momento cuando Pilar Maté comenzó una insaciable búsqueda de otras víctimas del mal hacer de Abbe Ross. "No sé ni como no perdí mi trabajo, porque he de confesar que me pasaba al menos 15 horas al día investigando y contactando con posibles víctimas de Abbe Ross. Fue un proceso muy largo y de mucho esfuerzo emocional", dijo enfáticamente.

Finalmente pudo reunir un grupo con múltiples similitudes en cuanto a cómo Abbe Ross había obviado por completo el testimonio de todos los testigos de una de las partes, de cómo había tergiversado y mentido en toda la sentencia, y de cómo había eliminado por completo a uno de los dos bandos. El grupo presentó cientos de quejas con la Comisión de Conducta Judicial, algunas de las cuales llevaron a una investigación.

Contactaron a sus representantes estatales: "Hicimos ruido, mucho ruido... Y finalmente, con el apoyo del Representante Lenny Mirra obtuvimos un Bill of Address -o Proyecto de Ley- para la destitución de Abbe Ross. A partir de entonces, tanto Rep. Mirra como el grupo, no han parado de recibir constantes emails y llamadas de más victimas. En parte es alentador, porque te das cuenta de que no estás sola, y que tendrás más personas testificando, pero por otro lado es triste el saber que tantas vidas han sido destrozadas, que tantos niños han sido apartados de sus padres o hermanos. Y no hay dinero en el mundo que pueda devolverte todos los momentos que has perdido junto a un hijo, jamás podré tener recompensa alguna que me devuelva lo que Ross nos quitó a mí y a mis hijas".

Actualmente, la oficina del Representante Estatal Lenny Mirra continúa recolectando cientos de cartas diariamente en apoyo al Proyecto de Ley y en unos meses un comité será asignado al Proyecto de Ley para dar a las víctimas la oportunidad de testificar.

# The removal of Judge Abbe L. Ross

# An interview with Pilar Maté

In recent weeks hundreds of people in Massachusetts have seen the photo of this mother circulate on numerous social networks. She is Pilar Maté who, overnight, has become the center of media attention for doing what until now no one had dared: Cause a real revolution at Essex's Probate & Family Court through her ongoing support for the Bill presented by Representative Lenny Mirra for the removal of Judge Abbe

Ross was initially nominated in 2014 by then-Governor Deval Patrick and began practicing in Suffolk County.

Pilar Maté, born and raised in Spain, resides in the United States since 1993, has been an American citizen since 2012 and during our interview, she told us "I have always trusted the American judicial system, but after my experience, I am truly ashamed of the immense lack of ethics and of the complete disorganization that the Commonwealth of Massachusetts exercises in the family courts".

It is known that in recent months, numerous complaints have arisen from lawyers who have encountered continuous delays, impediments, and suspicious behavior in filing documentation for their clients. "It is a systemic problem, there is not a single person responsible for this circus, but a set of agencies and departments that refuse to exercise transparency and fairness. If the courts ran like clockwork and the judges did not commit atrocities, there would be less need for lawyers, who are the first to witness the injustices that occur in family court, as well as the abusive behavior of some judges. For fear of being disadvantaged in future cases, they prefer to bow their heads and remain silent in the face of these injustices. The Commission on Judicial Conduct itself decides to look the other way when they receive continuous complaints about a judge; they are not interested in recognizing that there is a problem because by doing so they would be openly admitting that the system does not work, that it does not protect the constitutional and civil rights of citizens. It is shameful but there are many political and economic interests involved".

Rumbo published Pilar's story on March 15 of this year and more than 1,500 people have seen it to date.

The bomb exploded with the publication of an article about the bill in the Massachusetts Lawyers Weekly with at least seven thousand subscribed lawyers and judges. In response and no state of panic, days later a letter initiated and promulgated by attorney Amy Hubbard, a close friend of Abbe Ross, has come to light, collecting signatures from other attorneys in support of the judge. We do not know if the judge asked these lawyers to sign or if the initiative came from her friend Mrs. Hubbard.

In any case, it is a violation of the ethical canons of judicial conduct to show favoritism and impartiality in a case like

The question we all ask ourselves is what will happen to all the cases that are in the hands of Abbe Ross and the lawyer representing one of the parties who has signed that letter of support?

"I believe that by signing that letter of support, they have opened a Pandora's Box to speculate that acts of favoritism

and impartiality, as well as pacts under the table and corruption, occur daily in our family courts," explains Pilar. "Ethically, all the lawyers who have signed this letter should have remained on the sidelines, but there are many economic interests involved and unfortunately the BBO (Massachusetts Board of Bar Overseers) looks the other way and pretends not to know anything about what it's happening".

Maté had custody of her eldest daughter until the age of 8. On August 11, 2017, she was assaulted by the father of her daughter in a parking lot while he was chasing her with her cell phone recording and causing an incident that resulted in Maté's arrest. Immediately, he used this incident in October 2017 to secure a temporary full custody order with Judge Randy Kaplan, putting her mother on supervised visitation for 2 hours a week.

Kaplan wanted to make sure the girl was okay with the father due to multiple allegations by the minor that the father forced her to produce videos for later use in court. He called the two parties 9 weeks later to assess how the little girl was with the father, but unfortunately, the case had passed into the hands of Abbe Ross, who opted for the easy thing keeping everything the same, instead of familiarizing herself with the case and reading the 8-year archive with more than 300 pages.

Months later, during the criminal trial of her mother, the father made use of the Fifth Amendment, basically admitting that that day August 11, 2017, he was committing a crime. All of Pilar Maté's criminal charges were dropped. However, she had already lost her daughter in family court.

Abbe Ross granted 4 days of trial in 2019 to both parties to decide custody of the little girl. During the trial, several witnesses participated in support of the mother: a Guardian Ad Litem, who had done 2 investigations, the minor's pediatrician, together with her therapist, and 3 supervisors of the visits. Likewise, the girl's statements were presented through DCF and a psychiatric report on the girl. They all concluded that the girl did not want to live with her father and that she was traumatized by the hundreds of videos that her father forced her to make to accuse her

Something important to mention is the fact that Harvard Vanguard Atrius Health, the medical institution that the girl attended to see her pediatrician, was forced to suspend the child's care as soon as the father obtained custody since the pediatric medical staff began to receive constant threats from him. After a first formal notice through a letter addressed to her father and seeing that the threats, instead of disappearing, became more aggressive, the girl lost the pediatrician who had treated her since the age of 2 years.

The therapist who treated the girl for two years was also removed as soon as her father obtained custody.

"The first thing someone does when he wants to manipulate you is to isolate you," she told me. That is exactly what the father did, he eliminated the complete circle of the little girl where she had a voice and began to progressively erase the presence of the mother in the life of the girl, denying her supervised visits and not informing her of



absolutely anything of what was happening in the girl's life for all these years.

The judgment of the trial came out in May 2019, completely ending the figure of the mother in the girl's life and granting all the rights of legal and physical custody to her father. "I had two options: surrender, commit suicide, abandon... Or fight tooth and nail to get my daughter back and to obtain justice. I didn't hesitate for a minute".

It was at that moment that Pilar Maté began an insatiable search for other victims of Abbe Ross's wrongdoing. "I don't even know how I didn't lose my job, because I have to confess that I spent at least 15 hours a day investigating and contacting possible victims of Abbe Ross. It was a very long process and a lot of emotional effort," she said emphatically.

She was finally able to assemble a group with multiple similarities as to how Abbe Ross had completely ignored the testimony of all the witnesses for one of the parties, how he had misrepresented and lied throughout the sentence, and how he had hundreds of complaints with the Judicial to testify.

Conduct Commission, some of which led to an investigation.

They contacted their state representatives: "We made noise, a lot of noise ... And finally, with the support of Representative Lenny Mirra, we obtained a Bill of Address - or Bill - for the removal of Abbe Ross. Since then, both Rep. Mirra and the group have not stopped receiving constant emails and calls from more victims. In part, it is encouraging, because you realize that you are not alone and that you will have more people testifying, but on the other hand, it is sad to know that so many lives have been shattered, that so many children have been taken away from their parents or siblings. And no money in the world can give you back all the moments you have lost with a child, I will never be able to have any reward that gives me back what Ross took from me and my daughters".

Currently, the office of State Representative Lenny Mirra continues to collect hundreds of letters daily in support of the Bill, and in a few months, a committee eliminated one of both sides. The group filed will be assigned to the Bill to allow victims

### SUPREME JUDICIAL COURT RULES

Rules of Professional Conduct Supreme Judicial Court Rules Rules of Professional Conduct: Preamble: A lawyer's responsibilities

1. A lawyer is a representative of clients, an officer of the legal system, and a public citizen having special responsibility for the quality of justice.

5. As a public citizen, a lawyer should seek improvement of the law, the administration of justice, and the quality of service rendered by the legal profession. As a member of a learned profession, a lawyer should cultivate knowledge of the law beyond its use for clients, employ that knowledge in reform of the law, and work to strengthen legal education. A lawyer should be mindful of deficiencies in the administration of justice and of the fact that the poor, and sometimes persons who are not poor, cannot afford adequate legal assistance, and should therefore devote professional time and civic influence in their behalf. A lawyer should aid the legal profession in pursuing these objectives and should help the bar regulate itself in the public interest.

6. Many of a lawyer's professional

responsibilities are prescribed in the Rules of Professional Conduct, as well as in substantive and procedural law. However, a lawyer is also guided by personal conscience and the approbation of professional peers. A lawyer should strive to attain the highest level of skill, to improve the law and the legal profession, and to exemplify the legal profession's ideals of public service.

11. The legal profession's relative autonomy carries with it special responsibilities of self-government. The profession has a responsibility to assure that its regulations are conceived in the public interest and not in furtherance of parochial or selfinterested concerns of the bar. Every lawyer is responsible for observance of the Rules of Professional Conduct. A lawyer should also aid in securing their observance by other lawyers. Neglect of these responsibilities compromises the independence of the profession and the public interest which it serves.

12. Lawyers play a vital role in the preservation of society. The fulfillment of this role requires an understanding by lawyers of their relationship to our legal system. The Rules of Professional Conduct, when properly applied, serve to define that relationship.

# Mayor Announces Second Weekend Vaccine Clinic Targeting Minorities, Young People

Following up on its successful first weekend vaccine clinic targeting the Hispanic community and high school students 16 and older, Haverhill will host a second, similar clinic May 23 from 11-3 at the AmVets function hall at 576 Primrose St., Mayor James J. Fiorentini has announced.

Led by the Haverhill Latino Coalition and organized by Mayor Fiorentini, community leaders and volunteers made hundreds of phone calls and knocked on doors in the city's densely packed Mount Washington and Arce neighborhoods to promote the first May 2 weekend clinic and educate residents about the safety and importance of the vaccine in ending the COVID-19 pandemic. The city also marketed the event with social media posts and videos.

"Our efforts led to a very successful Sunday clinic, serving over 80 people," Manny Matias, President of the Haverhill Latino Coalition, said of the May 2 clinic. "The Haverhill Latino Coalition and the Mayor understand that you have to get down to that very grassroots level, understand what communities need, listen to those local members and meet them where they are."

The clinic, run by the Curative health care company and overseen by the state Department of Public Health, had planned to offer second shots of the Pfizer vaccine May 23 to Haverhill residents and workers who received their first shot May 2. But due to the success of the first clinic, the site will also be offering first shots on a walk-in basis on May 23.

"This effort was a total success in serving people of color who continue to lag behind in vaccination rates," said Mayor Fiorentini, noting 86 Haverhill residents and workers were vaccinated at the May 2 clinic.

Curative also hosts a Vaccine clinic every weekday at the AmVets location from 10-2 through a mix of vouchers available at the mayor's office and walk-in appointments. Because the site offers the Pfizer vaccine, which is for anyone 16 and older, the city has also been promoting the site as the place for young people to get vaccinated.

The upcoming May 23 clinic was arranged on the heels of Gov. Baker's recent announcement that the state vaccine strategy is beginning a new phase with increased reliance on public outreach and smaller, local vaccination sites rather than massive state sites.

"We have successfully responded to the recent dip in demand for the vaccine by reaching out to the community, especially the Latino community, and vaccinating 86 people on Sunday May 2," Mayor Fiorentini said. "Especially encouraging was the number of young people including 16- and 17-year-olds who came to the event to be vaccinated."



### **Elder Services awarded a contract** to increase access to the COVID-19 vaccine

Elder Services of the Merrimack Valley and North Shore was one of 25 communitybased organizations to receive funding as part of the Massachusetts Vaccine Equity Initiative to increase awareness and access to the COVID-19 vaccine in the 20 cities and towns hardest hit by the pandemic.

The contracts are part of the Baker-Polito Administration's investment of \$27.4 million in federal funds announced in March.

"With the arrival of the COVID-19 vaccines, we have hosted vaccination clinics and supported the clinics of our community partners to ensure as many people as possible are vaccinated," said Elder Services' CEO Joan Hatem-Roy. "This contract allows us to expand that work in the areas hardest hit by the pandemic."

Under the contract, Elder Services will target the communities of Haverhill, Lawrence, Lowell, and Methuen to increase trust in the vaccine's safety and efficacy, especially in communities of color; identify and reduce barriers for accessing the vaccine, and increase vaccine access through existing vaccination locations and mobile vaccination options.

"Our services will be delivered in concert with existing community vaccine distribution programs and through new initiatives by bilingual and bicultural staff and community health workers, who have experience serving priority populations," said Hatem-Roy. "This approach will allow for a more intensive oneon-one vaccination support."

The identified cities and towns met the Massachusetts COVID-19 Advisory Group recommendation to prioritize communities and then ranked by average daily COVID-19 case rates. From this list by case rate, the top cities, and towns with the highest percentage of people of color were identified.

# Frontline Worker is MCC's Representative for '29 Who Shine Student'



Micaela Rainha – a Middlesex Community College Nursing student and Lowell General Hospital Nurse Assistant – was named one of 2021's Mass. Department of Higher Education's 29 Who Shine.

Micaela Rainha has spent the past year working on the frontlines of the pandemic and preparing to graduate from Middlesex Community College's Nursing program. From both her time as a student at Middlesex and as a Nurse Assistant at Lowell General Hospital (LGH), Rainha has gained a strong foundation of experience and knowledge. She was also named one of the Mass. Department of Higher Education's 29 Who Shine for 2021.

The 29 Who Shine is an annual program

recognizing outstanding students who represent each of the state's 29 public colleges and universities -15 community colleges, nine state universities and five University of Massachusetts campuses. Rainha from Burlington - was nominated as MCC's student representative by her Nursing faculty.

About receiving the nomination for the 29 Who Shine recognition, Rainha said, "This means the absolute world to me. I am so honored and humbled. It really is such an achievement and validates everything I've been doing. The school has given so much to me."

Calling her entire experience "really wonderful," Rainha knows Middlesex was the right choice for her because of the small class sizes, accessible services and resources, individualized advising sessions, instant feedback from professors, and affordable tuition.

"I'm really engaged, I like to ask a lot of questions and go to every possible exam review, have meetings with my professors weekly - that's what helps me," she said. "Middlesex has that holistic approach to it and I just always felt that the culture at the school is really inclusive."

All of her clinical and work-related experiences have made an impact on Rainha. MCC's program allows students the use of the college's state-of-the-art simulation lab in addition to in-person clinicals at local hospitals and other sites. Rainha has been exposed to a variety of specialties – including pediatrics, maternity, critical care, cardiac and post-operative surgery, among others - that have helped her better figure out what she wants to do

The COVID-19 pandemic struck in the middle of Rainha's second semester at Middlesex. Although this presented many challenges, the pandemic also offered her the opportunity to engage in historic learning opportunities and clinical experiences. As part of the Nursing program, she has helped community members by performing COVID-19 swab tests on MCC's Bedford campus and administering vaccinations at LGH's site.

"It feels good to be able to be there and to know that the school trusts us to be a part of something so big," she said. "It is the best thing ever just being able to make a difference in someone's life. That is unmeasurable."

Rainha heard about the job posting for her Nurse Assistant role at LGH while completing her clinicals for MCC. She believes she was hired because of her qualifications and the opportunity she had to network with employees. In this position, she has gained a better sense of how things run at the hospital, as well as valuable skills and practices she can use throughout her career.

One of her favorite aspects of working at her clinicals is educating her patients on ways to get better and live a healthier life. Her faculty mentor - and MCC Director of Nurse Education - Carolyn Walsh has helped mold her teaching style and bedside manner to be patient and flexible, while

making personal connections to what is being taught.

Rainha has also had experience teaching and helping her classmates as a Supplemental Instructor and tutor of Pharmacology and general nursing classes. A member of MCC's honors society Phi Theta Kappa (PTK), Rainha also participates in the Student Nurse Club where she has teamed up with classmates to volunteer with the VA to run fundraisers for veterans.

"Building connections with my peers has taught me how to become a part of a team, and also how to give good criticism and feedback," she said. "We all come from different backgrounds and collaborate together. Forming those relationships – as well as with my professors – has been my number one thing."

For three of her four semesters at Middlesex, Rainha has been the Student Representative for the Nursing program. In this role, she attends faculty meetings to be a liaison between students and professors, and has honed her confidence, communication and leadership skills.

"All of my professors have been influential to me, especially in the Nursing program," she said. "Every single person deserves recognition for my education and I'm so happy to have them. When you see someone who is so knowledgeable, it's almost intimidating to make a mistake or ask for help. But even in clinicals, a lot of

# El Departamento de Educación lanza campaña sobre la oferta de Internet de banda ancha a precio reducido para millones de estudiantes K-12 y beneficiarios de la beca federal Pell

El Departamento de Educación de EE.UU. lanzó hoy una importante campaña dirigida a millones de estudiantes que ahora tienen derecho a recibir un descuento en su servicio mensual de Internet de banda ancha según un programa temporal administrado por la Comisión Federal de Comunicaciones (FCC). La campaña informará a millones de familias con niños que participan en el programa de desayuno escolar o almuerzo gratuito o a precio reducido, y a 6.5 millones de beneficiarios de la Beca Pell que ahora podrían tener derecho a un descuento de hasta \$50 por mes. Los hogares en tierras tribales pueden recibir un descuento de hasta \$75 por mes.

"La pandemia de COVID-19 ha magnificado los problemas de acceso a Internet y la asequibilidad tanto para los estudiantes K-12 como para los estudiantes universitarios, en particular los estudiantes de color, los estudiantes en comunidades rurales y tribales y los estudiantes de familias de bajos ingresos", dijo Miguel Cardona, secretario de Educación de EE. UU. "Sabemos que la calidad de acceso a Internet en el hogar tiene un impacto en el éxito de los estudiantes y que los estudiantes sin buen acceso a Internet y dispositivos confiables tuvieron mayores dificultades con la transición al aprendizaje remoto el año pasado. Esta campaña no solo mantendrá a más de nuestros estudiantes conectados y aprendiendo, sino que también ayudará a eliminar las desigualdades exacerbadas por COVID-19. Según nos recuperamos de la pandemia, tenemos la oportunidad de reconstruir nuestro sistema educativo mejor que antes, y proporcionar acceso confiable y asequible de Internet para los estudiantes afectados desproporcionalmente por la pandemia, asegurando que estén preparados para el éxito".

Los hogares con un niño que ha sido aprobado para recibir los beneficios del Programa Nacional de Almuerzos Escolares (NSLP) o el Programa de Desayuno Escolar (SBP), incluido un niño que asiste a una escuela que participa en la Disposición de Participación Comunitaria (CEP), del Departamento de Agricultura de EE.UU. (USDA) durante los años escolares 2019-2020 y 2020-2021 ahora tienen derecho al Programa Urgente de Beneficios de Banda Ancha (Programa EBB) de la FCC. Los beneficiarios de la Beca Pell, que generalmente son estudiantes universitarios con necesidades financieras excepcionales, también tienen derecho al Programa EBB de la FCC para que puedan obtener una educación postsecundaria si recibieron su beca durante el año de concesión 2020-2021.

Este programa temporal ofrece un descuento mensual de hasta \$50 por mes sobre el servicio de banda ancha y equipo de acceso (un módem, por ejemplo) y hasta \$75 por mes para hogares en tierras tribales. Dentro del programa, cada hogar también puede recibir un descuento de hasta \$100 para adquirir un dispositivo para conectarse al Internet (una computadora portátil, de escritorio o tableta) de un proveedor de banda ancha participante, siempre que el hogar contribuya entre \$10 y \$50 para la adquisición del aparato.

Las familias de estudiantes K-12 y beneficiarios de la Beca Pell con derecho pueden solicitar el descuento en línea, por correo o mediante un proveedor de servicios participante. También pueden encontrar proveedores de servicios de Internet participantes en su localidad ingresando su código postal en la herramienta Compañías cercanas a mí.

"Es más evidente que nunca que la banda ancha ya no es un lujo, sino una necesidad", dijo la presidenta interina de la FCC, Jessica Rosenworcel. "Casi inmediatamente, la pandemia de COVID-19 requirió que millones de familias y estudiantes utilizaran el aprendizaje remoto. Estos estudiantes, sus familias y maestros se esforzaron para facilitar el aprendizaje remoto. Pero esta crisis mostró como nunca antes que millones de estudiantes no podían participar plenamente en la educación a distancia porque no tenían conexión adecuada a Internet en su casa, y los estudiantes de color y las familias de bajos ingresos eran los más afectados. Y eso es simplemente inaceptable. Con orgullo me uno al secretario Cardona y al Departamento de Educación para dar a conocer este nuevo programa de la FCC que ayuda a las familias a conectarse y brindarles el apoyo necesario para que lo hagan".

# Department of Education Launches Outreach Campaign to Millions of K-12 Students and Federal Pell Grant Recipients Now Eligible for Monthly Discounts on **Broadband Internet Service**

The U.S. Department of Education today launched a major outreach campaign to millions of students who are now eligible for a monthly discount on broadband internet service under a temporary program administered by the Federal Communications Commission (FCC). The campaign will inform millions of families with children participating in the free or reduced-price lunch or school breakfast program, and 6.5 million Pell Grant recipients that they are now eligible for the discount of up to \$50 per month. Eligible households on qualifying Tribal lands can receive a discount of up to \$75 per month.

"The COVID-19 pandemic has magnified issues of internet access and affordability for both K-12 students and college students, particularly students of color, students in rural or tribal communities, and students from low-income families," said U.S. Secretary of Education Miguel Cardona. "We know that the quality of home internet access has an impact on student success, and that students without robust internet access and reliable devices struggled more with the transition to remote learning this past year. This campaign will not only keep more of America's students connected and learning, but will help address inequities exacerbated by COVID-19. As we

recover from the pandemic, we have an opportunity to rebuild our education system back better than it was before, and providing reliable, affordable internet access to more students disproportionately impacted by the pandemic is one way we can make sure all students are set up for success."

Households with a child who has received approval for benefits under the under the National School Lunch Program (NSLP) or the School Breakfast Program (SBP), including a child that attends a school participating in the U.S. Department of Agriculture's (USDA) Community Eligibility Provision (CEP), during the 2019-2020 and 2020-2021 school years are now eligible for the FCC's Emergency Broadband Benefit Program (EBB Program). Pell Grant recipients, who are usually undergraduates with exceptional financial need, also qualify for the FCC's EBB Program to help pursue postsecondary education if they received their grant during the 2020-2021 award

The temporary program provides a monthly discount of up to \$50 per month on broadband service and associated equipment (a modem, for example) for eligible households and up to \$75 per month for households on qualifying Tribal

lands. Each participating household may also receive a one-time discount of up to \$100 for one connected device—a laptop, desktop, or tablet computer—where available from a participating broadband provider, as long as the household contributes between \$10 and \$50 towards the cost of the device.

Eligible families of K-12 students and eligible Pell Grant recipients can apply for the discount online, via mail, or through a participating service provider. Eligible households can find participating internet service providers in their area by entering their zip code into the Companies Near Me

"It's more apparent than ever that broadband is no longer nice-to-have. It's need-to-have. For everyone, everywhere," said acting FCC Chairwoman Jessica Rosenworcel. "Seemingly overnight, the COVID-19 pandemic required millions of families and students to shift to remote learning. These students, their families, and their teachers worked hard to make remote learning a reality. But this crisis highlighted like never before that the virtual classroom was closed to millions of students without reliable internet access at home – with students of color and low-income families hit the hardest. And that's simply unacceptable. I'm proud to partner with Secretary Cardona and the Department of Education to help get the word out about the FCC's newest program to help families struggling with digital disconnection and provide them support."

The Education Department is reaching out directly to approximately 6.5 million Pell Grant recipients to inform them that they may be eligible for the discount. The Department is also reaching out to CEP schools and districts to inform them that they or their students may be eligible for the internet access program and share information on how to apply. Additionally, the Department is working with the FCC to develop materials to support schools, districts, and postsecondary schools in spreading the word about the program to eligible students and families. As trusted community members, schools, districts, and postsecondary schools are critical outreach partners. In addition to conducting EBB Program outreach to

eligible students and families, schools can take steps to help eligible students and families navigate the sign-up process, including:

- 1. Using the outreach toolkit materials to inform eligible students and families about the Emergency Broadband Benefit. The toolkit and other consumer materials can be found at fcc.gov/broadbandbenefit. Outreach resources for K-12 schools and districts can be found at https://tech.ed.gov/ broadband/ebb/.
- 2. Creating an outreach team or partnering with a trusted community-based organization to spread the word and help eligible students and families navigate the sign-up process.
- 3. Helping eligible students and families use the Companies Near Me tool to identify participating providers.
- 4. Organizing a provider fair so that students and families can compare and ask questions about the available internet service plans offered by participating local providers.

The purpose was to bring entertainment, news, information, education, etc. to everyone but they prefer keeping our community ignorant.

Comcast and Verizon subscribers pay in their monthly cable bills an amount covering the salaries and equipment to run the local community, government, and schools channels. LCAT does not handle the schools and their portion of what we pay goes separately to Lawrence Public Schools.

On Tuesday, they held an Open House which Rumbo publicized a lot in the hope of having our residents ask questions and apparently, none of the people who promised they would do so, made it that night.

One thing is obvious: Lawrencians love the victim role. Through the years we expected the government to do everything for us and get everything for nothing. It's proven that politicians don't defend our rights and we are not about to do anything about it, not even asking the board of directors why we are not allowed to use the studio. Worst of all, we keep voting them in.

Elections are coming and, for the first time, I may leave my ballot blank because I don't see anyone who is worthy of my vote. My conscience will be clear knowing that I was right. ### Cancel culture and Section 230

my professors know that you're learning and they create a safe space."

Before attending Middlesex, Rainha worked full-time as a bartender and waitress. She wanted to make sure she was financially, physically and psychologically ready to enter the field of Nursing before committing to her education. Once she made her decision and started MCC's program, she said "it felt right to jump in."

After she graduates from MCC, Rainha wants to start working as soon as she can as a Registered Nurse in Massachusetts. She also plans to start a bachelor's degree and go on to earn a master's in Nursing Education so she can one day become a professor to guide students like herself.

A quote by Florence Nightingale – a pioneer in the field of Nursing - reminds Rainha of her goals, as well as inspires her as she prepares to enter the field as a fulltime nurse amid the pandemic. Nightingale said, "I attribute my success to this: I never gave or took any excuse."


# **New book about Cubans in** Massachusetts



### **About the books**

Homegoing: Born in Ghana in the 1700s, Effia and Esi are half-sisters, unknown to one another. Effia marries an Englishman and lives a life of luxury in his Ghanaian castle. Esi, captured in a tribal war, is shipped to America and sold into slavery. "Homegoing" follows the lives of these two women and of eight generations of their descendants. From the Gold Coast

of Africa to Mississippi and Harlem, through the Civil War and the Great Migration, the novel illuminates the injustices of racism and slavery over the past 300 years.

Clayton Byrd Goes Underground: Clayton feels most alive when he's with his grandfather and the band of Bluesmen—he can't wait to join them, just as soon as he has a blues song of his own. But then the unthinkable happens. His grandfather dies, and Clayton's mother forbids Clayton from playing the blues. Clayton runs away from home in search of the Bluesmen, hoping he can join them on the road.

One Crazy Summer: Elevenyear-old Delphine is like a mother to her two younger sisters. She's had to be, ever since their mother, for a radical new life in California. But when the sisters arrive from Brooklyn to spend the summer with her, Cecile is nothing like they imagined. While the girls hope to go to Disneyland, their mother sends them to a day camp run by the Black Panthers. Unexpectedly they learn much about their family, their country and themselves during one truly crazy summer.

### About the authors

Yaa Gyasi: Yaa Gyasi's debut novel, "Homegoing," won the National Book Critics Circle's John Leonard Prize for best first book, the PEN/Hemingway Award for a first book of fiction and an American Book Award. In 2016, Yaa received the National Book Foundation's 5 Under 35 Award. When her second novel, "Transcendent Kingdom," was released in 2020 it became an instant bestseller.

Born in Ghana and raised in Huntsville, Alabama, Yaa earned a Bachelor of Arts in English from Stanford University and a Master of Fine Arts from the Iowa Writers' Workshop.

Rita Williams-Garcia: On her website, Rita Williams-Garcia says, "I always asked for a pencil and paper in kindergarten while my classmates colored pictures. By 12, I was sending short stories to magazines only to be politely rejected. My family had




