



The City of Lawrence has completed processing the 2021 annual census forms for Lawrence residents. Confirmation Notice postcards were mailed out this week to registered voters from whom the Election Division has yet to receive a completed census form.

If you receive a Confirmation Notice postcard, please complete the information requested and correct any information if necessary. Once completed, sign it and return it to the Election Division. Postage on the return postcard is pre-paid, so you can mail it without any additional postage. If you prefer, you may return the completed Confirmation Notice postcard to Election Division Office in person at the address below. Returning the Confirmation Notice postcard to the Election Division Office will update and confirm your status as an "active" registered voter.

If you have moved to another city/town, please complete, sign, and return the Confirmation Notice postcard, and your name will be removed from the voter's list in the City of Lawrence. In order to vote in the city or town that you live in, you must register to vote in your new city/town.

Registered voters for whom the Election Division has not received a 2021 census form or a Confirmation Notice will be designated as an "inactive voter". Voters designated as "INACTIVE VOTERS REMAIN ELIGIBLE TO VOTE" but should update their voting status as soon as possible.

Any voter can verify and update their voter registration by contacting the Election Division, who will assist you. If you need additional information or assistance, please contact the Lawrence Election Division by telephone at 978-620-3290

The Election Division Office is open every business day from 8:30 a.m. to 4:30 p.m. and is located in City Hall, Basement Floor, 200 Common Street, Lawrence, MA.



Se queman a más de 1,200 grados Fahrenheit y fomentan el uso de fósforos y encendedores por parte de los niños. No compre ni use fuegos artificiales o bengalas. Lleve a su familia a un espectáculo de fuegos artificiales supervisado para disfrutar de los días festivos.



Without a License, Fireworks are Illegal in Massachusetts

The use of fireworks by anyone who is not a licensed professional is against the law in Massachusetts. The Division of Fire Safety has information for the fireworks industry and for fire prevention officers enforcing fireworks laws and regulations. Fire departments make sure supervised fireworks displays are safe for both spectators and shooters.

Set a Good Example for Children

Children account for a significant number of fireworks injuries in Massachusetts every year. Children imitate adults. If you use fireworks, children who see you will not understand the dangers of fireworks. And children know where you keep fireworks.

Even sparklers are dangerous. They burn at more than 1,200 degrees Fahrenheit, and encourage the use of matches and lighters by children. Don't

¡Oh, qué farsa!

La reunión del Concejo Municipal de esta noche fue una sorpresa para muchos residentes cuando votaron para aprobar el presupuesto del año fiscal 22 sin discusiones, preguntas o nada, pero yo no soy tonta. Esperaba ese resultado cuando recibí esta foto de

un amigo. Yo sabía que tenía los votos para aprobar el presupuesto.

Aunque los concejales David Abdoo y Marc Laplante votaron a favor, los respeto más porque no mezclan sus responsabilidades con la política barata. Estos funcionarios electos festejaron con el alcalde interino y no tuvieron las agallas para hacer las preguntas que preocupan a muchos residentes.

Sé que Kendrys se reunió con algunos concejales (quizás todos) sobre por qué deberían aprobar el presupuesto. Uno de ellos me dijo que "fue muy amable durante la conversación, no arrogante como suele ser". ¡Bien, esa es una razón suficientemente buena para complacerlo!

La mayoría de nosotros ignoramos al Sr. Maali cuando habla durante la parte de Participación Pública de la reunión porque siempre es lo mismo con el superintendente escolar y la policía, pero Richard Russell fue desconectado y no pudo hacer su presentación. Según él, "Seguí marcando el número y la contraseña indicada y me rebotaban cada 5 minutos después diciéndome que la reunión no había comenzado".

Hubo más de 100 comentarios en Facebook durante la reunión y probablemente se fueron a casa, tomaron un vaso de leche y mañana será otro día. Pronto será olvidado. Y los políticos lo saben; ¡están apostando en ello!

Y está funcionando porque vemos esta prohibición con demasiada frecuencia. Eche un vistazo a la forma en que se administran las Escuelas Públicas de Lawrence. Pocos padres saben algo sobre el funcionamiento del sistema escolar y los que lo saben, no tienen idea de cómo poder expresar sus puntos de vista.

Lenin Lorenzo Roa escribió en su página de Facebook lo siguiente: "No debería ser tan difícil permitir la participación pública; traté de participar en una reunión de LAE BOARD y no se me permitió. Pagamos impuestos y estos presupuestos se producen con nuestro dinero; se nos debería permitir hablar sin ninguna resistencia en estos procedimientos".

LAE significa Lawrence Education Alliance, la junta nombrada por el estado que controla las escuelas, ignorando por completo al comité escolar. La ley estipula que aunque el estado tomó el control de las escuelas hace más de diez años, el comité escolar seguirá existiendo. Son funcionarios



no tienen voz en sus reuniones.

Otro logro de esta noche fue la votación para pedir prestado hasta \$58 millones para la nueva estación de policía. No hay disposiciones en este presupuesto para reemplazar algo de dinero en la cuenta de "efectivo libre" y no se menciona la deuda pendiente. Si lo desea, lea mi artículo El Presupuesto y la Deuda de \$69 millones en la edición de la semana pasada. Lawrence nunca saldrá de deudas y las cosas solo pueden empeorar.

"Deberíamos esperar por la oficina del Fiscal General de MA para ver si el Concejo Municipal de Lawrence violó alguna ley al cambiar 'REPENTINAMENTE' la audiencia del Presupuesto de la Ciudad de esta noche de una reunión abierta al público a una reunión ZOOm", declaró Russell.

¡Nada de politiquería aquí!

El Concejo Municipal tiene una regla para cualquier persona que hable durante la participación pública. Se supone que no deben mencionar a los políticos, particularmente durante la época de elecciones. Pero, como sabemos, las reglas están hechas para romperse. La semana pasada, la Directora de Desarrollo Comunitario utilizó sus dos minutos y medio para presentar las actividades de su departamento y los fondos disponibles para proyectos públicos.

Cuando terminó, varios miembros diferentes de esa oficina hicieron presentaciones similares utilizando los dos minutos y medio asignado a cada orador. No había ninguna explicación o razón para que estuvieran allí deleitándose por el maravilloso trabajo que están haciendo.

El Concejo permitió que este circo continuara porque ellos no pueden hacer preguntas o intervenir de ninguna manera. Pienso que el presidente debió decirle a la jefa del departamento que si tenía algo de importancia que traer, lo normal es que lo pusiera en la agenda.

Además, de esta forma, la encargada de los "homeless" no corría el riesgo de que le hicieran preguntas sobre su función en esta

El equipo de campo de Massachusetts DPH en Lawrence y Methuen difunde información vital sobre la vacuna de COVID-19

La Iniciativa de Equidad de Vacunas del Estado llega a poblaciones prioritarias en todo Massachusetts, con un enfoque en 20 ciudades y pueblos, incluido Lawrence, que han sido los más afectados por COVID-19.

de campo del Departamento de Salud Pública de Massachusetts (DPH) centró sus esfuerzos en Lawrence para difundir información sobre la vacuna COVID-19. Los encuestadores capacitados trabajaron con las empresas locales y viajaron de puerta en puerta para responder preguntas y entregar información para que los residentes se vacunen.

Estos esfuerzos son parte de la Iniciativa de Equidad de Vacunas más grande de DPH, que trabaja con poblaciones y comunidades que se ven afectadas de manera desproporcionada por COVID-19 para reducir las barreras a la vacunación, aumentar la conciencia sobre la seguridad y eficacia de las vacunas y, en última instancia, aumentar las vacunas. Dar prioridad al alcance de las vacunas en estas comunidades es clave para poner fin a la pandemia.

Los voluntarios capacitados del DPH continuaron las operaciones. El equipo, compuesto por residentes de Lawrence y Methuen, fue de puerta en puerta para repartir volantes, colgar aldabas y responder preguntas como "¿Cuándo puedo recibir la vacuna de COVID-19?" Mass. DPH Field Team in Lawrence and **Methuen Spreads Vital Information** about the COVID-19 Vaccine

The State's Vaccine Equity Initiative reaches priority populations across Massachusetts, with a focus on 20 cities and towns, including Lawrence, which have been most heavily impacted by COVID-19

Over the past few weeks, the Massachusetts Department of Public Health (DPH) field team focused efforts in Lawrence to spread information about the COVID-19 vaccine. Trained canvassers worked with local businesses as well as traveled doorto-door to answer questions and hand out information for residents to get vaccinated. These efforts are part of DPH's larger Vaccine Equity Initiative, which works with populations and communities that are disproportionately affected by COVID-19 to reduce barriers to vaccination, increase awareness of vaccine safety and efficacy, and ultimately increase vaccinations. Prioritizing vaccine outreach to these communities is key to ending the pandemic.

DPH's trained canvassers continued field operations on the ground. The team, comprised of Lawrence and Methuen residents, traveled door-to-door to hand out flyers, hang doorknob knockers, and answered questions such as "When can I get the COVID-19 vaccine?" "How will I know it's my turn to get vaccinated?" and "Is vaccination safe?"

This focused grassroots outreach strategy is the product of a collaboration between DPH and Archipelago Strategies Group (ASG) and Health Care for All (HCFA), and is just one component of DPH's larger Vaccine Equity Initiative.

The initiative prioritizes 20 cities across the state that were identified as having been disproportionately impacted by COVID-19. These priority populations were determined using case data and the COVID-19 Community Impact Survey,

which DPH conducted in the fall of 2020. To ensure the vaccine is accessible to our most disproportionately impacted populations, the Commonwealth prioritizes vaccine to each of the 20 municipalities every week, subject to program administration



NECC has Funding Available to Help New and Returning Students

Northern Essex Community College (Haverhill and Lawrence, MA) Journalism/Communications major Bryan Fernandez of Lawrence was on track to graduate with his associate degree this summer, but, because of student debt incurred during the pandemic, it didn't look like he would be able to achieve that goal.

Thanks to an infusion of over \$2.58 million from the Higher Education Emergency Relief Fund, which Northern Essex is directing toward student support, Fernandez is now on track to complete his degree—with high honors—by the end of August and transfer to UMass Lowell to continue his studies in the fall.

"It was a giant weight off my shoulders," says Fernandez, whose work as a professional photographer has slowed during COVID-19, "I felt like I was getting a break from the universe."

The funding Northern Essex has received will be used to help current students pay off college debt and cover educational expenses related to the disruption caused by COVID-19 and to assist both new and returning students with educational costs for the summer and fall semesters of 2021.

Applications for funding are being considered now, and students have until September 3 to apply.

"Many of our students have been hard hit by the pandemic," said Lane Glenn, Northern Essex President. "Our hope is that by dedicating these funds to them, we will alleviate some of the financial challenges and help them get back on track with their education."

The majority of the funding, \$1.63 million, is direct student aid, designated to help students with educational expenses, which include tuition and fees, books, course materials, Internet, food, living expenses, etc. This funding is available to students taking credit courses, including high school students in the Early College Program, as well as students taking noncredit courses through Pies de Latinos, the Center for Adult Basic Education, and Corporate and Community Education.


Northern Essex has also opted to use an additional \$957,000 of the institutional funds which it received through the Higher Education Emergency Relief Fund, to support students. Here's how that funding is being allocated:

Fall Laptop Bookstore Credit, \$250,000

New and returning students can apply for a bookstore credit to purchase a laptop that meets the requirements of their program.

Start Right Grant for New Students, \$300,000

Six hundred grants of \$500 each will be awarded to students who are new to the college and enrolled in six credits or more. These grants will help pay for fall tuition and fees.



Finish What You Started for Returning Students, \$407,788

These grants will help 522 returning students to pay off student debt from the fall 2020 and spring 2021 semesters and cover other educational expenses.

Jennifer Mezquita, vice president of student affairs, encourages students and prospective students to reach out. "The pandemic has presented many challenges for our students; the good news is that we have resources to help them with some of the financial obstacles they've faced."

Community College enrollments have dropped more dramatically than those in any other sector of higher education during the pandemic, according to stats recently released by the National Student Clearinghouse. Undergraduate enrollments across all sectors have decreased by 4.5%, compared to community colleges nationwide which were down 9.5% last fall and 11.3% this spring. Northern Essex is doing better than most, with a 5% decrease in the fall and a 7% decrease in the spring.

"Most of the students who did not arrive on campus this fall because of the pandemic were low-income, first generation, students of color—the students we need to serve now more than ever," said Glenn. "If fewer local residents are graduating from college, this will negatively impact our local economy."

For the past two semesters, 90% of classes at the college have been offered online with just 10% face to face. In the fall, at least 25% of classes will be face-to-face, with social distancing and extra safety measures.

South Broadway railroad grade crossing

, Route 28 South Lawrence, June 15: Great news for the long suffering motorists of Lawrence! Effective soon, you will begin to experience improvement to this long neglected railroad grade crossing. Today's site survey work began long necessary improvements.

Beginning soon, the rubber membranes that surround the railroad tracks will be removed, the potholes addressed and new asphalt seamlessly brought right up to the edge of the rail. This corrective action is a temporary "fix" until the grade crossing is completely replaced in the Spring '22. The necessary materials are in-hand, and the noncity money committed. Recently, the City of Lawrence received a state MassDOT grant, as well as contributions from a private business owner of the South Lawrence industrial park, that will improve the entire length of this rail spur. The rail spur (currently owned, operated and maintained by Pan Am Railways) that goes from the railroad mainline across Route 28 /South Broadway out to the South Lawrence industrial park.

Rail Improvements will include replacement of rail, wooden ties and ballast. These will result in safer tracks for the railroad, and economic development opportunities in our industrial park. This



progress will create more jobs facilitated by more rail cars accessing the park, rail cars that will be able access tens of thousands of square feet of currently empty commercialindustrial space. This is long-overdue improvement for motorists and neighbors alike. The current state of those tracks are unacceptable, after a glacier slow response by the railroad.

These hard-fought-for improvements will certainly bring safer conditions for the tens of thousands of motorists who cross those tracks each day, and improved conditions for the abutters whose homes directly abut the Pan Am owned and

operated railroad tracks. Next year, when the construction improvements are completed, the result will be jobs creation, and broader commercial revenue for the City of Lawrence. #Safety #Improvement #Jobs

Mayor Names Police Chief Interview Panels

Mayor James J. Fiorentini has appointed nine people to interview panels to assist in hiring a new police chief to succeed retiring longtime Haverhill chief Alan DeNaro.

The interview panels are divided into two groups: a panel with experience in policing and police hiring, and a panel of community members to provide community input. The interview panels will assist in drafting questions and will advise the city on the hire.

A schedule for interviews and a timeline for the hiring process will be announced

"We are dedicated to getting the best and most professional police chief, the person best suited for this city," Mayor Fiorentini said. "I have established two panels of people to assist in the interviews. The first is a panel of people familiar with police hiring. This will be headed by Alan Gould, a former police chief who has been extensively involved in hiring police chiefs in many cities for many years."

Also serving on the police experience panel is former Hampton police chief and Haverhill native William Wrenn. Chief Wrenn was on the original committee that assisted in hiring chief DeNaro 20 years ago.

The second panel consists of community members, including several members of the LatinX and African American communities. The mayor stressed that he will seek broad consensus for the next chief and that the next chief will be expected to expand community policing in Haverhill's neighborhoods.

Chief DeNaro, who is set to officially retire at the end of this month, notified the mayor in May that he was taking a permanent leave of absence for health reasons until his retirement.

On May 21, Mayor Fiorentini appointed former Deputy Chief Anthony Haugh to lead the Haverhill department on an acting basis until July 16 while the city continued its search for the new chief.

The city has hired New Hampshirebased Municipal Resources Inc. and its president Alan Gould to help recruit candidates and guide the city's search.

Here are the members of the Mayor's Police Chief Interview Committee.

Interview committee appointees with policing or police hiring experience:

- Chief William Wrenn, Haverhill native. Chief Wrenn was the long-time police chief in Hampton, N.H. and the former head of the New Hampshire Department of Corrections. Chief Wrenn was on the original interview panel that chose Chief DeNaro 18 years ago.
- Richard MacDonald, Haverhill Health and Inspectional Services Director and a former Duxbury, Mass. town manager for many years with experience hiring police chiefs.
- Alan Gould, president of MRI, retired interim police chief in Salem, N.H. He has served all ranks in Salem and is a retired police chief in Rye N.H. and a retired town manager in Rye. N.H. Chief Gould has extensive experience in recruiting and hiring police chiefs.

William Cox, Haverhill City Solicitor. Attorney Cox has vast knowledge concerning police laws and procedures.

Community input group:

- Kalister Green-Byrd, Haverhill resident who is active in the community. Ms. Green-Byrd has held many volunteer positions in the city over the decades.
- Lynda Brown, head of the Highlands Neighborhood Group and head of Haverhill Brightside, a community and neighborhood beautification group.
- Manuel Matias, Haverhill resident and representative of the Haverhill Latino Coalition.
- Irene Haley, CEO of the Greater Haverhill Chamber of Commerce, representing Haverhill's business community.
- Eliza Espinal, Haverhill resident and volunteer assistant in the Lawrence Deputy

Police Chief's office.

A representative of the School Department will be named shortly.

The city's job posting for the Haverhill Police Department's top job closed June 1 and set salary in the low \$200,000s, based on qualifications. Approximately 27 applications were received.

The search for DeNaro's replacement was open to internal applicants as well as applicants from Massachusetts and other

The candidate pool includes applicants from nine states, including 14 from Massachusetts. Additionally, there were three candidates each from Connecticut and Texas; two candidates from New York, and one each from Michigan, Washington, New Mexico, Pennsylvania, and Oregon.

Two candidates have a PhD; one has a Juris Doctorate and a Master's degree; two have a Juris Doctorate and Bachelor's degree; 16 have Master's degrees, and five candidates have Bachelor's degrees.



State Fire Marshal Offers Summer Fire Safety Tips

El Jefe de Bomberos Estatal ofrece consejos de seguridad contra incendios de verano

Cortacéspedes de gasolina y césped

El Jefe de Bomberos del Estado Ostroskey dijo: "¿Su hijo adolescente finalmente tiene la edad suficiente para cortar el césped? Entonces asegúrese de discutir la seguridad de la gasolina al mismo tiempo; hable sobre por qué es importante dejar que el motor se enfríe antes de repostar".

Los vapores de gasolina son altamente inflamables y repostar un motor caliente puede encenderlos. La gasolina derramada sobre la ropa puede desprender vapores hasta que esté completamente seca y cualquier fuente de calor la encienda. Los vapores de gasolina pueden viajar una gran distancia para encontrar una fuente de ignición, por lo que la gasolina no se puede almacenar dentro de la casa.

En los últimos cinco años (2016-2020), 338 incendios de cortadoras de césped causaron la muerte de un civil, tres heridos de civiles, cuatro heridos en el servicio de bomberos y una pérdida estimada en dólares de \$ 1.6 millones.

- Almacene la gasolina en el exterior solo en recipientes aprobados.
- Mantenga la gasolina alejada de todas las fuentes de calor, como materiales para fumar, luces piloto, fogatas y parrillas.
- Reposte una cortadora de césped enfriada. Nunca vuelva a llenar mientras esté caliente.
- Mantenga las manos y los pies alejados de la podadora mientras esté en funcionamiento.

Gasolina e incendios al aire libre

"Nunca use gasolina para encender una fogata ni la agregue a ningún fuego interior o exterior", dijo Ostroskey. "Hemos tenido tantas lesiones este año por personas que manejan mal la gasolina y otros líquidos inflamables". En los últimos cinco años (2016 - 2020), los hospitales de Massachusetts han informado [1] que han tratado a 137 personas con lesiones graves por quemaduras causadas por la gasolina.

Seguridad al fumar

Fumar fue la principal causa de muerte por incendios en Massachusetts el año pasado, y ha habido muchos incendios esta primavera debido a materiales para fumar desechados incorrectamente en porches y patios traseros. Estos incendios pueden arder sin ser detectados durante mucho tiempo y cuando se convierten en llamas, viajan rápido. Si comienzan en el exterior del edificio, estos incendios pueden tener un fuerte control antes de que las alarmas de humo interiores comiencen a advertir a alguien del peligro.

"Si permite fumar en su propiedad, proporcione recipientes adecuados para desechar los materiales de fumar: un cenicero profundo, una lata con arena o agua. No permita que las personas arrojen materiales para fumar al mantillo, hojas, césped, plantas en macetas u otros recipientes que puedan incendiarse. No dejes que los golpeen en la barandilla del porche o en las escaleras ", dijo Ostroskey.

Gasoline and Lawnmowers

State Fire Marshal Ostroskey said, "Is your teenager finally old enough to mow the lawn? Then be sure to discuss gasoline safety at the same time; talk about why it is important to let the engine cool before refueling."

Gasoline vapors are highly flammable and refueling a hot motor can ignite them. Gasoline spilled onto clothing can give off vapors until completely dry and be ignited by any heat source. Gasoline vapors can travel a long distance to find an ignition source, which is why gasoline cannot be stored inside the house.

In the past five years (2016-2020), 338 lawn mower fires caused one civilian death, three civilian injuries, four fire service injuries and an estimated dollar loss of \$1.6

- Store gasoline outside only in approved
- Keep gasoline away from all heat sources, such as smoking materials, pilot lights, campfires, and grills.
- Refuel a cooled lawn mower. Never refill while it is hot.
- Keep hands and feet away from a mower while it is running.

Gasoline and Outdoor Fires

"Never use gasoline to start a campfire or add it to any indoor or outdoor fire," said Ostroskey. "We have had so many injuries this year from people mishandling gasoline and other flammable liquids." In the past five years (2016 – 2020), Massachusetts hospitals have reported[1] treating 137 people with serious burn injuries from

Smoking Safety

Smoking was the leading cause of fire deaths in Massachusetts last year, and there have been many fires this spring from improperly discarded smoking materials on porches and in backyards. These fires can smolder undetected for a long time and when they erupt into flames, travel fast. If they start on the exterior of the building, these fires can get a strong hold before the interior smoke alarms start to warn anyone of the danger.

"If you allow smoking on your property, provide appropriate receptacles for discarding smoking materials: a deep ashtray, a can with sand or water. Don't let people toss smoking materials into the mulch, leaves, grass, potted plants or other containers that can catch fire. Don't let them stub them out on the porch railing or stairs," said Ostroskey.

Según los Centros para el Control y la Prevención de Enfermedades de EE.UU., El 44,4% de la población de EE. UU. Ha sido completamente vacunada, el 58% en Massachusetts. En el condado de Essex, el 54% de la población ha sido completamente vacunada, con algunas comunidades rezagadas, como Lawrence, donde el 37,9% de la población está vacunada.

"Creemos que cuantas más personas se vacunen, más seguros estaremos como comunidad", dijo Lane Glenn, presidente de Northern Essex. "Es por eso que estamos haciendo todo lo posible, incluido unirnos al desafío del presidente, para que las vacunas estén disponibles para nuestra facultad, personal y estudiantes, y las comunidades a las que servimos".

Las universidades participantes se comprometen a tres acciones: involucrar a todos los estudiantes, profesores y miembros del personal; organizar las comunidades del campus en torno a los esfuerzos de vacunación; y brindar acceso a las vacunas para todos.

Northern Essex ha hecho todo lo posible para que la vacuna sea accesible para la universidad y sus comunidades.

En abril, Greater Lawrence Family

Health Center (GLFHC) abrió una clínica de vacunas en el edificio Dimitry en el campus de Lawrence de la universidad. Esa clínica permanecerá abierta hasta el 30 de junio y se otorgarán citas prioritarias a los profesores, el personal y los estudiantes de Northern Essex.

Desde el 1 de marzo, estudiantes de enfermería y asistentes médicos han estado administrando vacunas como voluntarios en clínicas administradas por la ciudad de Lawrence, Pentucket Medical y GLFHC. El consultorio médico que ayuda a los estudiantes ha ayudado a registrar a los pacientes.

Además, la universidad ha llevado a cabo una campaña de comunicación para promover las vacunas. Rosanna Lara, administradora de casos de seguimiento por contrato de la universidad, está visitando las aulas y hablando con grupos de estudiantes en inglés y español para responder preguntas sobre la vacuna.

La universidad continúa manteniendo un sitio web COVID-19 con información y recursos, que se actualiza periódicamente.

Aimed at reducing carbon emissions and helping developers reach their building energy efficiency objectives, Eversource as a sponsor of Mass Save – has developed several new construction, energy efficiency offerings suited for a variety of building types and featuring a range of strategies and technologies. The energy company offers higher incentives and additional support to projects pursuing ZNE and those with low overall energy needs, including technical assistance and incentives through the first year of occupancy to ensure that the building is truly ZNE. Eversource's technical experts help project teams make design decisions that will enable them to reach their goals

for ultra-low energy use and provide incentive dollars that can buy down the cost of equipment and systems that will get them across the finish line. Purchasing green power or installing solar panels on site brings projects to full ZNE status by offsetting the already low energy needs with clean renewable power.

As an example of its ZNE work, the energy company worked with the City of Cambridge on highly efficient designs for the Martin Luther King Jr. School, and the King Open & Cambridge Street Upper Schools, and is also currently working with the city on the Tobin Montessori Vassal Lane School, which is set to finish construction in 2025. In addition, Eversource has worked with the city to interconnect and operate solar panels at five of the city's schools. Collectively, those solar panels have generated 1.67 Million kWh, one million kWh of which the district has used directly to power its school buildings while sending almost 700 kWh back to the grid. These efforts have resulted in a one-year cost savings of approximately \$238,000, with these five schools using more than 40% less rgy than an average regional school.

"As part of our commitment to achieving carbon neutrality, we're working to increase renewable energy production and decrease carbon emissions from our municipal and school buildings," said Cambridge Public Schools Net Zero Projects Manager Kris Weeks. NECC Joins President Biden's COVID-19 Challenge

Northern Essex Community College (Haverhill and Lawrence, MA) has joined the White House COVID-19 College Vaccine Challenge, along with colleges and universities across the country.

Announced by the White House and U.S. Department of Education earlier this month, the challenge is part of President Joe Biden's goal to get 70% of U.S. adults vaccinated with at least a first dose by July 4.

According to the U.S. Centers for Disease Control and Prevention, 44.4% of the U.S. population has been fully vaccinated, 58% in Massachusetts. In Essex County 54% of the population has been fully vaccinated, with some communities lagging behind, such as Lawrence, where 37.9% of the population is vaccinated.

"We believe that the more people who are vaccinated, the safer we will be as a community," said Lane Glenn, Northern Essex president. "That's why we are doing everything possible, including joining the President's challenge, to make the vaccines available to our faculty, staff, and students, and the communities we serve."

Participating colleges commit to three actions: engaging every student, faculty, and staff member; organizing campus communities around vaccine efforts; and delivering vaccine access for all.

Northern Essex has made every effort to make the vaccine accessible to the college and its communities.

In April, Greater Lawrence Family

Health Center (GLFHC) opened a vaccine clinic in the Dimitry Building on the college's Lawrence Campus. That clinic will stay open through June 30 and priority appointments are being given to Northern Essex faculty, staff, and students.

Since March 1, nursing and medical assistant students have been administering vaccines as volunteers in clinics run by the city of Lawrence, Pentucket Medical, and GLFHC. Medical office assisting students have helped with registering patients.

Also, the college has waged a communications campaign to promote vaccinations. Rosanna Lara, the college's contract tracer case manager, is visiting classrooms and speaking with student groups in both English and Spanish to answer questions about the vaccine.

The college continues to maintain a COVID-19 website with information and resources, which is updated regularly.

For the past two semesters, 90% of classes at the college have been offered online with just 10% face-to-face. In the fall, at least 25% of classes will be face-to-face, with social distancing and extra safety measures.

"The availability of vaccines promises a return to some kind of normal again soon," said Glenn. "It's likely that by the fall, most of the Northern Essex community will be vaccinated, providing us with the opportunity for a gradual, safe transition back to in-person learning."

Esperanza Academy graduation A year of triumph, joy, and success because of you

This past academic year we experienced pain, love, joy, loss, and triumph in ways we could have never imagined. As life normalizes and our community regains its footing, it is abundantly clear that Esperanza's mission to end generational poverty through culturally responsive education is more urgent than ever. Everyday I am grateful that we are able to achieve the dream set out for us by the school's founders in 2006, to support Lawrence families and to change lives, one incredible Esperanza girl at a time. It is because of the strength of our team and the commitment of our supporters that we are seeing these dreams realized.

We know that families with lowincome backgrounds have faced the brunt of inequities caused by the global pandemic, social unrest, and policies that disproportionately hurt the poor. Recent research continues to reveal the stark inequities for school districts with a majority of students of color. Compared to districts with a majority of white students, low-income schools were more likely to have cut instructional minutes and to have learned remotely all year. As of midyear, the majority of Black, Hispanic and Asian-American fourth graders were learning fully remotely, compared to only a quarter of white fourth graders. While I will not surmise that students of color have "fallen behind" or suffered from "learning loss" complex and misleading terms—the truth is that low-income students simply have not had the same educational opportunities as their wealthier counterparts.

Amid this reality, however, Esperanza Academy has offered a counter-narrative. This year, we have witnessed the power of an independent school education rooted in love and trust, and how far such a school can go - did go - to ensure that students learn during the pandemic and remain poised for both success and self-love in high school, college, and life.

Our students have had the resources they need to succeed - including an extended day and year program with a challenging academic curriculum, an innovative music therapy program to address social emotional well-being, and a restorative-justice program aimed at infusing our school with the kind of trust that builds a strong, productive learning environment. Our students also have a group of adults wholeheartedly committed to them for a full 12 years — adults who will be there for each and every student in even the most difficult times.

Witnessing firsthand the stories of triumph, joy, and success within the school, our board also clearly recognizes the impact of our program. As a result, we have formed

a Strategic Planning Committee to plot the growth of the school over the coming years. This committee includes past and present board members and industry leaders, all coming together to think about the future of Esperanza. While we are still fine-tuning ideas, it is clear to everyone that we are ready to serve more students, move into a bigger space better suited for our population and program and expand the Esperanza family. In the fall of 2021, we will present our strategic plan to our constituents.

I'm looking forward to our work this summer. But first I want to share my gratitude for all that we've achieved this year. For one, I'm grateful for our broader Lawrence community. Our partnership with Northern Essex Community College, for one, enabled us to finish the school year in person on the Northern Essex campus. I'm grateful to our school principal, Delia Duran Clarke, who, in her first year, did an extraordinary job of caring for the well-being and success of our kids. I'm grateful for a board that has been incredibly supportive and wise throughout these complicated months. I'm grateful for a team of teachers who never cease to inspire me; who teach and mentor our students every day with academic acuity and their full hearts. I'm grateful for our development team, which both understands our mission

and works every day to ensure we stay financially strong so we can continue to serve our children well. And I'm grateful for all of you — the friends and community members who gently hold the dreams of our students in your hands.

In particular, I'm deeply grateful for the leadership of Sarah Bankson Newton during her time as our board chair. Without question, she was our biggest champion and a true advocate for equitable change in our society through access to education. We wouldn't be where we are without Sarah's vision, commitment, and love for the Esperanza girls.

Finally, I want to thank everyone involved in the school — students, parents, faculty, staff, board members and community friends — for making this a successful year in the lives of our girls. Nothing was certain last fall. But our community rose with a remarkable fearlessness to every challenge. At the beginning of the year, I told the faculty, "I'm not sure what this year will entail, but at the end, I want us to say that we lead with love and courage." As we send off another cohort of graduates to their high school careers, I can't help but be proud of the work we've done together and look forward to the coming year as this remarkable team leads another group of brilliant girls towards their dreams.

Most of us tune out Mr. Maali when he's speaking during the Public Participation portion of the meeting because it's always the same about the school superintendent and the police, but Richard Russell kept being disconnected and could not do his presentation. According to him, "I kept dialing the listed number and passcode and would get bounced out every 5 minutes after telling me that the meeting hadn't started."

There were over 100 comments on Facebook while the meeting was ongoing and they probably went home, had a glass of milk, and tomorrow will be another day. Soon it will be forgotten. And politicians know it; they are banking on it!

And it's working because we are seeing this prohibition too often. Take a look at the way the Lawrence Public Schools are being run. Few parents know anything about the workings of the school system and those that do, have no idea how to air their views.

Lenin Lorenzo Roa wrote on his Facebook page the following: "It should not



be so hard to allow for public participation to happen; I tried to participate at an LAE BOARD meeting and was not allowed to. We pay taxes, and these budgets are produced with our money; we should be permitted to speak without any resistance at these proceedings."

LEA stands for Lawrence Education Alliance, the state-appointed board that controls the schools, completely ignoring the school committee. The law stipulates that even though the state took control of the schools over ten years ago, that the school committee shall continue to exist. They are elected officials representing families but have no voice at their meetings.

Another accomplishment tonight was the vote to borrow up to \$58 million for the new police station. There are no provisions in this budget to replace some money in the 'free cash' account and no mention of the outstanding debt. You may want to read my article The Budget and the \$69 Million Debt in last week's edition. Lawrence will never be out of debt and it can only get worse.

"We should wait for the MA Attorney General's office to see if the Lawrence City Council violated any laws by 'SUDDENLY' changing tonight's City Budget hearing from an open to the public meeting to a ZOOm meeting," stated Russell.

No politicking here!

The City Council has a rule for anyone speaking during public participation. They are not supposed to mention politicians, particularly during election time. But, as we know, rules are made to be broken.






GLCF announces new Steven **Joncas Community Connector Award at Annual Meeting**

George Ramirez, a former state positioned to help Lawrence continue its trajectory as a City on the Move. I look forward to getting started."


