Letter from Lawrence Teachers Union Admin

Emergency meeting called to address violence in Lawrence schools

Elected officials in Lawrence have called an emergency meeting for Monday evening to address violence in their schools and they want state Education Commissioner Jeff Riley to join them.

Mayor Kendrys Vasquez, who also chairs the Lawrence School Committee, called Thursday for the committee and the Lawrence City Council to sit jointly for the meeting, and asked that Riley, or his designee, and Lawrence Schools Superintendent Cynthia Paris, be in attendance.

"Members of the public are deeply concerned about the developments at Lawrence High School," Vasquez said in a statement. "I have done everything in my power to provide aid to the district within the constraints of receivership."

Vasquez added that "while the District and DESE have scarcely participated in the City's public forums, School Committee or Council meetings, when asked to appear," he hopes that "in this opportunity they will participate and at the very least acknowledge the concerns of community members."

The purpose of the meeting is to address "the altercations at Lawrence High School over the past few weeks and the District's response to the incidents," the mayor said, and to allow the public and elected city officials to ask questions of Paris and Riley "relative to the state of receivership in Lawrence and the overseer's relation to Lawrencians particularly during times of crisis as the ones our schools are living through today."

Monday's meeting begins at 7 p.m. at the Lawrence Public Library, 51 Lawrence Street, Lawrence.

Carta del Sindicato the Maestros de Lawrence

Se convocó una reunión de emergencia para abordar la violencia en las escuelas de Lawrence

Los funcionarios electos en Lawrence han convocado una reunión de emergencia para el lunes por la noche para abordar la violencia en sus escuelas y quieren que el Comisionado de Educación del estado, Jeff Riley, se una a ellos.

El alcalde Kendrys Vasquez, quien también preside el Comité Escolar de Lawrence, pidió el jueves que el comité y el Concejo Municipal de Lawrence se

sienten juntos para la reunión y pidió que Riley, o su designado, y la Superintendente de las Escuelas de Lawrence, Cynthia Paris, estuvieran presentes.

"Los miembros del público están profundamente preocupados por los desarrollos en Lawrence High School", dijo Vásquez en un comunicado. "He hecho todo lo que estaba en mi poder para brindar ayuda al distrito dentro de las limitaciones de la administración judicial".

Vásquez agregó que "si bien el Distrito y el DESE apenas han participado en los foros públicos de la Ciudad, en las reuniones del Comité Escolar o del Concejo cuando se les pidió comparecer", espera que "en esta oportunidad, participen y al menos reconozcan las preocupaciones de la comunidad miembros."

El propósito de la reunión es abordar "los altercados en Lawrence High School durante las últimas semanas y la respuesta del Distrito a los incidentes", dijo el alcalde, y permitir que el público y los funcionarios electos de la ciudad hagan preguntas a Paris y Riley "en relación con el estado de la quiebra en Lawrence y la relación del supervisor con los residentes de Lawrence, particularmente durante tiempos de crisis como los que nuestras escuelas están atravesando hoy".

La reunión del lunes comienza a las 7 p.m. en la Biblioteca Pública de Lawrence, 51 Lawrence Street, Lawrence.

El Comité Escolar de Lawrence solicita al Departamento de Primaria y Educación Secundaria para poner fin a la administración judicial en las Escuelas Públicas de Lawrence

El Comité Escolar de Lawrence vota para avanzar hacia el control local

Lawrence, MA - El lunes por la noche, el Comité Escolar de Lawrence y el Concejo Municipal se reunieron en una Sesión Conjunta de Emergencia para discutir los altercados en la Escuela Secundaria Lawrence y el estado actual de la Administración Judicial de las Escuelas Públicas de Lawrence. El distrito escolar más diverso del estado ha estado bajo el control del Departamento de Educación Primaria y Secundaria (DESE) durante más de diez años. DESE ha recibido críticas en las últimas semanas de los miembros de la comunidad a raíz de los altercados en curso en Lawrence High School y las frustraciones de las familias por que la voz de su comunidad fuera excluida de la conversación sobre la educación de sus propios estudiantes en Lawrence.

"Lawrence merece respeto, sin embargo, a la comunidad más diversa del Commonwealth se le ha negado la autonomía durante más de diez años y eso debe terminar", dijo el alcalde Vásquez en su declaración de apertura, y luego agradeció a todos los que están "luchando para liberar a nuestro distrito de las garras del supervisor".

Cientos de familias, maestros y estudiantes se reunieron en el auditorio de la Biblioteca Pública de Lawrence en Lawrence Street, así como virtualmente, para expresar sus preocupaciones y escuchar directamente a los administradores del Distrito sobre la situación. El alcalde, que convocó la reunión, invitó tanto al comisionado del DESE, Jeff Riley, como a la superintendente de distrito Cynthia Paris. Paris llegó para la reunión de las 7:00 pm; Riley, que no se presentó, envió una carta minutos antes de que comenzara la reunión excusando su ausencia que leyó el alcalde Vásquez. Madeline Rosa, madre de un estudiante de Lawrence High School dijo: "Lo siento por mi hija ... No ha ido a la escuela durante una semana porque teme por su seguridad... estamos lidiando con COVID, Delta - también estamos lidiando con el estrés". Rosa continuó: "Estos niños van a terminar con trastorno de estrés postraumático por todo lo que están presenciando, todos los

días en Lawrence High. Y alguien debe rendir cuentas por esto. Suficiente es suficiente."

También estuvieron ausentes los concejales de la ciudad de Lawrence Pavel Payano, Ana Levy, Estela Reyes y Dave Abdo. Aún así, el Ayuntamiento logró su quórum gracias a la presencia de los concejales Celina Reyes, Jeovanny Rodríguez, Jorge González, María De La Cruz y la presidenta del Concejo Laplante. Todos los miembros de la Escuela electa.

El comité estuvo presente: Jonathan Guzman, Rafaela Pichardo, Enrique Matos, Patricia Mariano, Joshua Alba, y el presidente del Comité Escolar de Lawrence, el alcalde Kendrys Vasquez.

Hacia el final de la reunión se propusieron dos mociones. La primera moción puesta sobre la mesa por el Ayuntamiento para pedir el fin de la Sindicatura fue aprobada por cuatro de los cinco Concejales presentes, pero finalmente fracasó dado que dos tercios del Concejo no estuvieron presentes por las ausencias de los Concejales Pavel Payano, Ana Levy, Estela Reyes y David Abdo. Una moción posterior presentada por el miembro del Comité Escolar Joshua Alba para solicitar al DESE que elimine al Síndico, fue aprobada por unanimidad por un voto de seis a cero, incluido el voto del presidente, el alcalde Vásquez.

Kimberly Barry, presidenta del Sindicato de Maestros de Lawrence declaró: "No podemos reparar Lawrence High sin reconocer el papel que ha desempeñado la Administración Estatal en nuestra ciudad durante la última década. Durante los últimos 10 años de la administración judicial, el Estado ha ignorado las voces de nuestros educadores, familias, estudiantes y grupos comunitarios". Barry continuó: "Avanzando con una llamada agenda de cambio que no ha funcionado y que realmente no ha evolucionado en 10 años. Como educadores, siempre se nos enseña a reflexionar sobre nuestro trabajo y hacer ajustes por el bien de nuestros estudiantes; el Estado no ha logrado eso".

Lawrence School Committee Petitions the Department of Elementary and Secondary Education to End Receivership in Lawrence Public Schools

Lawrence School Committee votes to move toward local control

Lawrence, MA – Monday evening, the Lawrence School Committee and City Council met in an Emergency Joint Session to discuss the altercations at the Lawrence High School and the current status of the Receivership of the Lawrence Public Schools. The state's most diverse school district has been under the control of the Department of Elementary and Secondary Education (DESE) for over ten years. DESE has drawn criticism in the last few weeks from community members in the wake of the on-going altercations at Lawrence High School and families' frustrations over having their community-voice shut out from the conversation about their own students' education in Lawrence.

"Lawrence deserves respect, yet the most diverse community in the Commonwealth has been denied autonomy for more than ten years and that must end," said Mayor Vasquez in his opening statement, then thanking everyone that is "fighting to free our district from the grasp of the overseer."

Hundreds of families, teachers, and students gathered in the auditorium at the Lawrence Public Library on Lawrence Street, as well as virtually, to express their concerns and hear directly from the District's administrators about the situation. The Mayor, who convened the meeting, invited both DESE Commissioner Jeff Riley and District Superintendent Cynthia Paris. Paris arrived for the 7:00pm meeting; Riley, a no-show, sent a letter minutes before the meeting began excusing his absence that Mayor Vasquez read.

Madeline Rosa, a parent of a student at the Lawrence High School stated, "I feel for my daughter ... She hasn't been in school for a week because she is afraid for her safety ... We're dealing with COVID, Delta – we're also dealing with stress." Rosa continued, "These kids are going to end up with PTSD from everything that they're witnessing, every single day at the Lawrence High. And someone needs to be held accountable for this. Enough is enough."

Also absent, Lawrence City Councilors Pavel Payano, Ana Levy, Estela Reyes, and Dave Abdo. Still, the City Council achieved its quorum thanks to the presence of Councilors Celina Reyes, Jeovanny Rodriguez, Jorge Gonzalez, Maria De La

Cruz, and Council President Laplante. All of the members of the elected School

Committee were present – Jonathan Guzman, Rafaela Pichardo, Enrique Matos, Patricia Mariano, Joshua Alba, and Chair of the Lawrence School Committee, Mayor Kendrys Vasquez.

Toward the end of the meeting, two motions were proposed. The first motion put on the table by the City Council to call for the end of Receivership was approved by four out of the five Councilors present, but ultimately failed given that two-thirds of the Council was not present due to the absences of Councilors Pavel Payano, Ana Levy, Estela Reyes, and David Abdo. A later motion introduced by School Committee Member Joshua Alba to petition DESE to remove the Receiver, passed unanimously by a vote of six to zero, including Chair, Mayor Vasquez's vote.

Kimberly Barry, President Lawrence Teachers Union stated, "We cannot mend Lawrence High without acknowledging the role that the State Receivership has played in our city for the last decade. Over the last 10 years of receivership, the State has ignored the voices of our educators, families, students, and community groups." Barry continued, "Plowing forward with a so-called turn-around agenda that hasn't worked and that hasn't really evolved in 10 years. As educators, we're always taught to reflect on our work and make adjustments for the good of our students – the State has failed to do that."

La identificación de votantes

Durante muchos años, la gente de todo el país ha estado pidiendo que se implemente una identificación de votante adecuada, lo que ha provocado un caos que condujo a procedimientos legales y mucha desinformación.

Las noticias informaron de un crucero que partía de Fort Lauderdale, Florida, y las personas mostraban su identificación antes de abordar. No escuché a nadie quejarse. Sabemos que para volar en un avión es necesario mostrarlo y cuando recojo mis medicamentos en la farmacia tengo que sacar mi licencia de conducir.

Lo mismo sucedió con los teatros de Broadway en New York cuando comenzaron a abrir y vi en la televisión la larga fila de personas esperando felices para ver a Bruce Springsteen con una identificación en mano.

Lo que realmente me inspiró a escribir sobre esto fue ir a la cooperativa de crédito de donde me jubilé y tener que mostrarla también.

El propósito de pedir identificación es asegurarnos de que nuestras elecciones sean honestas y limpias y luego de las últimas rondas electorales, debemos pensar en esto como imperativo para garantizar que el sistema resulte como lo que esperamos que sea.

Hemos escuchado las razones más absurdas de por qué no debería suceder, como que es difícil o imposible que las minorías adquieran una tarjeta de identificación debido a la distancia de sus hogares al Registro de Vehículos Motorizados, el costo, la falta de transporte o simplemente que esta práctica discrimina a las minorías.

Ahora está sucediendo en todo el estado; las personas están sintiendo tal frustración que hay más de 6,000 voluntarios recogiendo firmas para ponerlo en la boleta electoral el próximo noviembre del 2022. Con mucho gusto que me ofrecí para poner de mi parte y estoy buscando apoyo. Si alguien quiere cooperar conmigo, por favor llámeme.

Tenemos solamente 3 semanas para reunir las planillas, dárselas a la City Clerk para que las certifique y enviárselas a los coordinadores.

Esto será un requisito para todos los ciudadanos de cualquier raza o color, no

específicamente para nadie. Mi respuesta es simple: cualquier persona que conduzca un automóvil debe tener una licencia y eso es lo suficientemente para votar. Cualquiera que no conduzca puede obtener una identificación similar a la licencia de conducir a un costo de \$15.

El requisito de identificación para votar significa mostrar algo oficial que le diga al trabajador electoral que usted es la persona en la lista. Mientras le pidan a cada persona que lo demuestre, nadie puede reclamar discriminación sin embargo, he estado escuchando últimamente la palabra "racista".

Lawrence, donde hacemos las cosas al revés

El Concejo Municipal aprobó el pasado martes 19 de octubre, una nueva regla que dice lo siguiente:

Campaña electoral. Durante el período de tiempo designado para la votación ausente en persona y el Período de Votación Anticipada del Estado de Massachusetts, ningún cartel, tarjeta, folleto, fotografía o circular que tenga la intención de influir en la acción del votante, excepto los expresamente autorizados por GL c. 54, § 65, se colocarán, exhibirán, circularán o distribuirán en cualquier edificio donde se lleve a cabo la votación anticipada, incluso en las paredes del mismo, en las instalaciones en las que se lleva a cabo la votación anticipada, o dentro de los ciento cincuenta pies de la puerta de entrada del edificio.

Después de las elecciones preliminares, escuchamos muchas quejas sobre violaciones de esta regla con la excusa de que no era aplicable a los sitios de votación anticipada.

mujer adulta que se cree que es la madre de una de las personas involucradas fue arrestada por alteración del orden público.



Joint Statement from Interim Mayor Kendrys Vasquez and Chief Roy Vasque

Following the dismissal of the Lawrence High School campus an altercation broke out in nearby Sullivan Park. As part of the safety plan that has been put in place by the School District and the City, several members of the Lawrence Police Department were in the area at the time of the altercation. Four juveniles were arrested as a result of their

involvement in the incident. Additionally, an adult female who is believed to be the mother of one of the individuals involved was arrested for disorderly conduct.

The safety of the students of the Lawrence Public Schools continues to be of paramount importance to Mayor Vasquez and Chief Vasque, as such we will continue to proactively address this issue.

El informe indica un impacto desproporcionado de las estafas en las comunidades de color y destaca las respuestas de la agencia

Una nueva investigación publicada en un informe del personal de la Comisión Federal de Comercio (FTC, por su sigla en inglés) indica una serie de diferencias clave en la manera en que el fraude y otras estafas afectan a las comunidades de color, desde el tipo de estafas dirigidas específicamente contra estas comunidades hasta los métodos que usan para pagar cuando pierden dinero con una estafa.

El nuevo informe, titulado “Al servicio de las comunidades de color”, destaca las tareas de aplicación de la ley y de difusión y alcance comunitario llevadas a cabo por la FTC para abordar las cuestiones de protección del consumidor que enfrentan estas comunidades y también describe la investigación recientemente publicada.

Samuel Levine, Director del Buró de Protección del Consumidor de la FTC, dijo al respecto: “Nuestra misión es proteger a cada uno de los consumidores estadounidenses contra el fraude y otras estafas, y para hacerlo, es vital que comprendamos el efecto que tienen estos problemas en las comunidades de color. Aunque hemos tomado energéticas medidas para combatir los problemas que afectan a estos consumidores de manera desproporcionada, hay más trabajo por hacer, y estamos comprometidos a hacerlo”.

En uno de los estudios del informe se examinan las diferencias entre los reportes recibidos por la FTC de parte de consumidores que viven en comunidades con mayoría de residentes negros y latinos comparándolos con los reportes presentados por aquellas personas que viven en comunidades mayoritariamente blancas.

Este análisis indica que las personas que viven en comunidades con mayoría de residentes negros y latinos reportaron con mayor frecuencia haberles pagado a los estafadores con medios de pago que ofrecen pocas o ninguna protección contra el fraude, por ejemplo, con dinero en efectivo, criptomonedas, órdenes de pago y tarjetas de débito. La gente que vive en comunidades con mayoría de residentes blancos presentó la mayor proporción de reportes que indican haber pagado con tarjeta de crédito, que es un medio de pago que ofrece una mejor protección contra el fraude.

La investigación también halló diferencias notables en los tipos de fraude reportados ante la FTC por la gente que vive en comunidades con mayoría de

residentes negros y mayoría de residentes latinos, indicando para estos grupos una mayor proporción de fraudes relacionados con problemas con la compra de carros, bancos y prestadores, asuntos de crédito y cobranza de deudas en comparación con lo reportado por la gente de comunidades mayoritariamente blancas.

Otro estudio del informe analizó la información recabada a partir de una cantidad de casos de la FTC que indicó que, en los casos que involucraban solicitudes de préstamos de día de pago, programas de alivio de deudas para préstamos estudiantiles, y algunos casos de oportunidades de negocio, la mayor cantidad de consumidores residía en comunidades predominantemente negras.

Además de la nueva investigación, el informe también ofrece un resumen de los más de 25 casos entablados por la FTC en los últimos cinco años en los que se perpetró alguna conducta dirigida específicamente contra las comunidades de color o que afectó de manera desproporcionada a los miembros de estas comunidades. En el informe también se ofrece información sobre el continuo programa de difusión y alcance comunitario de la agencia para las comunidades de color, el cual incluye eventos, colaboraciones locales y nacionales y una serie de videos y publicaciones diseñadas para proveer información relevante y oportuna.

Este informe subsigue al informe ante el congreso de 2016, “Combatiendo el fraude en las comunidades afroamericanas y latinas: Plan estratégico integral de la FTC,” (en inglés).

El resultado de la votación de la Comisión para autorizar a su personal a publicar el nuevo informe fue 4-0-1, con el Comisionado Chopra registrado como no participando.

El alcalde Kendry Vasquez y CAFO Ianello toman represalias contra los bomberos

Un día, después de que los Bomberos de Lawrence del Local 146 respaldaran unánimemente a Brian DePeña, el Alcalde Interino Kendry Vasquez tomó represalias contra la fuerza informando (a través del corrupto CAFO Mark Ianello) al presidente del grupo

que la ciudad ya no reconocería el banco de licencias por enfermedad de los bomberos.

Probablemente se preguntará qué es exactamente un "banco de licencias por enfermedad". Bueno, durante más de 50 años, cada bombero dona uno o dos días al año a lo que se llama un "banco de licencias por enfermedad". Es una acumulación de días de enfermedad que la hermandad utiliza para ayudar a sus hermanos en caso de que necesiten tiempo libre debido a una lesión personal o enfermedad personal, evitando las dificultades financieras debido a la falta de saldo de la licencia por enfermedad.

Conozco esta práctica porque yo mismo he aprobado, conocido y escuchado quejas

sobre este tema varias veces mientras trabajaba para la Ciudad, como Director de Personal. Sé que los bomberos no juegan trucos ni mienten cuando se trata de ayudar a sus hermanos, realizar sus tareas responsables o poner en marcha procesos sin autorización.

Sin embargo, la excusa que utiliza el CAFO Mark Ianello para desmentir dicha práctica es decir que los días de baja laboral acumulados nunca fueron ingresados al Sistema de Información Municipal (MUNIS). MUNIS es un sistema financiero que utiliza la ciudad; tiene menús para recursos humanos y más.

Ahora, la ciudad no les está diciendo a los bomberos que los días donados no están registrados, porque están registrados en un libro. Una libreta impresa se guarda en la oficina administrativa del Jefe de Bomberos. Entonces, en tecnicismo, CAFO Ianello y el alcalde interino Vasquez le están diciendo al sindicato que solo porque el Jefe de Bomberos Moriarty (y su equipo administrativo) no agregaron esos días a MUNIS, los días no son reales. Excepto que, ahora, cada uno de esos bomberos que donaron a ese banco de

licencia por enfermedad no puede recuperar el reembolso de su licencia por enfermedad en sus acumulaciones.

Hubo autorización mucho antes de que Kendry Vasquez asumiera el cargo, y ciertamente hubo autorización antes de que CAFO Ianello asumiera el cargo. Uno solo tiene que llamar al ex alcalde Michael Sullivan para confirmar que este sistema estaba en vigor a principios de 2000.

La cantidad de trucos sucios, represalias y corrupción contra mucha gente buena, y buenos grupos trabajadores, es tan evidente,

que debemos votar en contra de este tipo de trucos solapados.

Los bomberos conocían las razones para respaldar a Brian y tiene que ver con no respaldar a alguien que quiere usar la fuerza para obtener apoyo utilizando sus juegos mentales.

Mayor Kendry Vasquez and CAFO Ianello Retaliate Against Firefighters

One day, after Local 146 Lawrence Firefighters unanimously endorse Brian DePeña, Interim Mayor Kendry Vasquez retaliated against the force by informing (through corrupt CAFO Mark Ianello) the group president

that the city would no longer acknowledge the firefighters' sick leave bank.

You would probably be asking yourself exactly what a sick leave bank is. Well, for over 50 years, each firefighter donates one or two days a year into what is called a "sick leave bank." It's an accumulation of sick days that the brotherhood utilizes to help their brethren in case of need time off due to personal injury or personal illness while avoiding financial difficulties due to having no balance of sick leave.

I know this practice because I, myself, have approved, known, heard complaints on this issue a few times while working for the City, as Personnel Director. I know that the firefighters don't play tricks or lie when it comes to assisting their brothers, working their responsible tasks, or placing processes in place without authorization.

However, the excuse that CAFO Mark Ianello is using to deny said practice is by saying that the accumulated sick leave days were never entered into the Municipal Information System (MUNIS). MUNIS is a financial system that the city utilizes; it has

menus for human resources, and more.

Now, the city is not telling the firefighters that the donated days are not recorded, because they are recorded on a book. A hard copy notebook is kept at the Fire Chief's administrative office. So, in technicality, CAFO Ianello and Interim Mayor Vasquez are telling the union that just because Fire Chief Moriarty (and his administrative team) did not add those days into MUNIS, that the days are not real. Except, now, each of those firefighters that donated into that sick leave bank can't get their sick leave reimbursed back into their accruals.

There was authorization long before Kendry Vasquez came into office, and there was certainly authorization before CAFO Ianello came into office. One only has to call on former Mayor Michael Sullivan to confirm that this system was in place back in early 2000.

The number of dirty tricks, retaliation, and corruption against many good people, and good hard-working groups, is so evident, that you must vote against this type of underhanded trickery.

The firefighters knew the reasons for endorsing Brian and it has to do with not endorsing someone who wants leverage for support by utilizing their mind games.

I am sure CAFO Mark Ianello is looking to have Kendry remain in office. If Kendry is not elected in November, CAFO Ianello is being walked out of City Hall, and it will be by the new Chief of Staff.

Preguntas y cálculos de la boleta electoral de Leahy School

(Read it in English on page 9)

Como todos sabemos a estas alturas, el Alcalde Interino Kendrys Vásquez ordenó que se colocara en la boleta electoral de noviembre una pregunta para aumentar los impuestos más allá del máximo de 2.5% para la construcción de la escuela Leahy. Ese máximo del 2.5% se calcula a partir de su presupuesto actual para 2022. Pero en noviembre (ahora si votan temprano como yo) le están haciendo la pregunta a los votantes de aumentar sus impuestos más allá de ese máximo de 2.5%.

Un voto "SI" significa que la ciudad aumentaría sus impuestos por encima del 2.5% (el funcionario municipal electo aún no ha informado a los votantes el número real (o el administrador en jefe de la ciudad ni el funcionario financiero Mark Ianello) y un voto "NO" no lo aumentará por encima del 2.5%.

La mayoría de los residentes de Lawrence saben que necesitamos más edificios escolares nuevos/renovados para los estudiantes de la ciudad. Eso es un hecho. Lo que molestó a muchos votantes de Lawrence es que saben que los funcionarios electos, la superintendente escolar y el CAFO Mark Ianello están efectuando juegos mentales con este aumento propuesto. No están siendo transparentes con sus residentes, y muchos creen que estas mismas personas están engañando a los votantes sobre la naturaleza real de la cantidad, los préstamos y usando tácticas de miedo para convencerlos de que vote "SI". Hasta aquí la transparencia en la administración del Alcalde Interino Vásquez.

Permitame explicar, el Concejo Municipal no pidió ninguna información al Alcalde Interino Vásquez y al CAFO Mark Ianello para la anulación propuesta, a pesar de que tanto Ianello como Vásquez (incluyendo el equipo de finanzas (del que yo era miembro) lo sabían a principios de junio que se necesitaba una anulación desde antes que el presupuesto fuera ante el concejo. Ni siquiera agregaron ningún aumento al presupuesto de este año porque pensaron que podrían ocultárselo a los votantes mientras asistían a estas elecciones. Si quiere una prueba de esto, todo lo que debe hacer es solicitar (como parte de los registros públicos) el Informe de calificación de bonos de la Ciudad de Lawrence, que está fechado el 3 de junio de 2021.

El Informe de calificación de bonos, establece específicamente que la administración les avisó a principios de marzo de 2021 que tendrán que pedir una anulación de los impuestos máximos en noviembre. El principal analista de crédito de este informe fue Danielle L Leonardis de Nueva York y Victor M Medeiros de Boston que trabajaban para S&P Global.

En el informe de calificación crediticia, S&P Global indicó a Lawrence como "flexibilidad presupuestaria muy débil", "Perfil de deuda y pasivo contingente muy fuerte", "Economía débil, con un valor de mercado per cápita de \$64,837" y "Desempeño presupuestario adecuado, con resultados operativos que esperamos se debilite en el corto plazo en relación con el año fiscal 2020". También indicaron que "si experimentaran más presiones fiscales", reducirían la calificación crediticia de la ciudad. Además, insistiendo en

que "si bien esperamos que Lawrence Massachusetts tenga al menos resultados operativos equilibrados, no esperamos que los resultados sean tan favorables como lo habían sido en 2020".

También sé con certeza que en junio del 2021, la ciudad había recibido o se esperaba que recibiera un total de \$7.1 millones en dinero de la Ley CARES, \$41.8 millones en dinero ARPA, \$10 millones adicionales del condado y un reembolso completo de FEMA para sus seis proyectos presentados (que incluyen un sitio de vacunación). Se esperaba que las escuelas recibieran \$31 millones adicionales en fondos de ESSR. Para continuar con sus prácticas presupuestarias conservadoras, solo \$2.0 millones de dinero ARPA se han incluido en el presupuesto fiscal 2022.

Y finalmente, los comentarios en este informe del 3 de junio de 2021 incluyeron "La ciudad planea emitir aproximadamente \$130 millones para dos proyectos escolares: la Escuela Oliver y la Escuela Leahy en el corto plazo. La ciudad no planea anular la deuda de la escuela Oliver a medida que el servicio de la deuda disminuya en el año fiscal 2028, pero probablemente requerirá el uso planificado de una parte del dinero en caja (free cash), mientras que Leahy School probablemente requiera una anulación, que podría ir a los votantes ya en el otoño de 2021".

¡Ellos lo supieron a principios de este año! Lo sabían en marzo de 2021, que es cuando se estaba llevando a cabo esta auditoría/calificación crediticia. ¡No hicieron nada! Sin transparencia, sin comunicación, sin nada para informar a los votantes que esto estaba en camino en noviembre. Y luego, enviar a la superintendente Paris a recibir la presión por colocar la pregunta en la boleta electoral fue la presión que le pusieron encima este grupo de personas corruptas y poco transparentes, y es la razón por la que me fui.

El 23 de septiembre de 2021, el presidente del Consejo Laplante solicitó (como parte de una reunión del concejo) información a CAFO Ianello sobre cómo se vería la estructura de los préstamos para la Escuela Leahy. El 3 de octubre de 2021, CAFO Ianello respondió al presidente del Concejo con algunos cálculos de "números difusos". Afirmó en su memorando lo siguiente.

"El Proyecto de Construcción de Escuelas Leahy tiene un costo estimado de \$103,7 millones, de los cuales se espera que la Autoridad de Construcción de Escuelas de Massachusetts financie un máximo del 59.08% de los costos del proyecto, o \$61.3 millones. La ciudad de Lawrence será responsable de los costos restantes del proyecto, que se estiman en \$42,4 millones, ó 40.92% de los costos totales del proyecto. Pedir prestados \$42.4 millones durante 20 años requerirá \$3 millones anuales, 25 años requerirán \$2.6 millones anuales y 30 años requerirán \$3 millones anuales".

\$2.6 millones, o \$3 millones, al año no suena tan mal para que una ciudad pague a los acreedores. ¿O lo hace? Recuerde, Lawrence es una ciudad de línea roja, al igual que otras comunidades pobres del Commonwealth, lo que significa que obtenemos préstamos a tasas de interés altas. Las tasas de interés no se incluyeron en la carta al presidente del Concejo. Solo las cantidades de dinero y una página adicional indican los aumentos estimados promedio

en los propietarios. Pero calculemos la cantidad de la letra como se muestra en la carta.

1. Tres millones de dólares, durante 20 años, totalizan \$60 millones. Esto significa que de un préstamo de \$42.4 millones, Lawrence pagará \$17.6 millones solo en intereses. Eso es un interés del 29.4% durante la vigencia del préstamo y del 69% en el pago del principal.

2. \$2.6 millones, durante 25 años, totalizan \$65 millones. Esto significa que de un préstamo de \$42.4 millones, Lawrence pagará \$22.6 millones solo en intereses. Eso es un 38.5% de interés durante la vigencia del préstamo y un 65% en pagos de capital.

3. \$3 millones, durante 30 años, totalizan \$90 millones. Esto significa que un préstamo de \$42.4 millones, Lawrence pagará \$47.6 millones solo en intereses. Eso es 47.1% de interés en la vida del préstamo y 53% en pagos de capital.

Mientras tanto, algunas comunidades como Newton, Winchester o Andover pueden ver tasas tan altas. Los acreedores no los tachan de rojo como ocurre con Lawrence. Es un círculo vicioso en el que estamos porque somos pobres. Es el equivalente a que las personas con mal crédito reciban ofertas de tarjetas de crédito, pero a una tasa de interés del 33% y multas por pago anticipado.

Además, CAFO Ianello afirma (en la tabla de evaluación de impuestos de \$2.3 millones) que el aumento promedio, para viviendas unifamiliares, será de \$101 más por año. Las casas de dos familias y las casas de tres familias verán aumentos de impuestos de \$137 y \$156, respectivamente. Pero esa no es una afirmación verdadera. Es posible que su vivienda unifamiliar no se evalúe como mi vivienda unifamiliar. Es posible que su casa, o la mía, se evalúen más alto y pagará más impuestos. De la misma manera que no existen tres viviendas unifamiliares se evalúan por igual.

Debería haberse elaborado un informe más detallado; después de todo, ya tienen toda esta información en su software financiero. Pueden estimar impuestos futuros o detallados ingresando el porcentaje o monto de la recaudación. CAFO Ianello puede proporcionar detalles de cada hogar, negocio en esta ciudad. Ahora eso sería transparencia real. Pero eso es demasiado trabajo para alguien que gana \$175,000 por año y no desperdicia un centavo en Lawrence (porque no vive en Lawrence).

Para empeorar las cosas, al final del año, el ayuntamiento establece una tasa de impuestos para el nuevo año (es obligatorio que la ciudad obtenga fondos del DOR para la segunda mitad de su presupuesto). El concejo puede elegir una tasa impositiva que aumente aún más sus impuestos, lo que convierte la declaración de CAFO Ianello en una declaración falsa. Oiga, este sistema está hecho para exprimir tanto dinero de sus propiedades como el estado pueda obtener, y crearán todas estas leyes y reglas para que no las entendamos. Sin embargo, si llega a comprenderlo, es demasiado tarde, sus impuestos y posiblemente una anulación (el override) ya se habrá realizado.

El departamento escolar publicó su propia versión del monto promedio de impuestos por hogar. Déjeme decirle que eran diferentes a lo que se le proporcionó al concejo. Pero lo que fue tan descarado en su volante fue que las personas buscadas

en el lado norte de la ciudad sienten que están recibiendo menos que en el lado sur de Lawrence al colocar declaraciones como; "Proporcionar equipos y laboratorios de ciencia y tecnología de vanguardia equitativos, así como espacios de arte y música que actualmente están disponibles para los estudiantes que asisten a las escuelas Wetherbee, Guilmette, Parthum y South Lawrence East".

Seguramente, esta información no debería mostrarse como los que tienen y los que no tienen. Los residentes de Lawrence no están en guerra entre sí. Pero la superintendente Paris está utilizando la política comparada. El método comparativo es uno de los cuatro enfoques metodológicos principales en las ciencias (los otros son el método estadístico, el método experimental y el método de estudio de casos).

El método comparativo es importante para las ciencias políticas porque las otras metodologías científicas principales son más difíciles de emplear. Es por eso que puedo entender (pero no estoy de acuerdo) que la Superintendente Paris empleará este método para influir en los votantes para que anulen los impuestos. Ella no tiene datos (o pruebas) que indiquen que los edificios educativos de Wetherbee, Guilmette, Parthum y South Lawrence East tienen un impacto positivo directo en el aprendizaje de los estudiantes de Lawrence. Verá que MCAS no se usa para calcular eso, MCAS solo se usa para calcular una prueba escrita realizada por los estudiantes.

Finalmente, lo que CAFO Ianello no ha indicado es que él mismo ha declarado en reuniones a principios del verano pasado que la Autoridad de Construcción Escolar de Massachusetts generalmente no pagará más del 21% del costo del edificio escolar.

Entonces tenía razón, pero ¿por qué cambió de posición? ¿Quizás un pequeño empujón del Alcalde Interino Vásquez? Existe una fórmula que se utiliza para calcular los gastos reembolsables estimados asociados con las escuelas por la MSBA. El MSBA toma una tasa base del 31% y agrega un factor socioeconómico como; factor de ingresos de la comunidad (proporcionado por el Departamento de Ingresos), tasa del factor de riqueza de la propiedad comunitaria (también proporcionada por el DOR) y tasa del factor de pobreza de la comunidad (proporcionada por DESE).

Nadie en esta administración ha mostrado ningún documento de que la MSBA haya prometido un reembolso de devolución del 59% del proyecto. Eso es porque no lo hay. He solicitado esto como un registro público y no tienen tales documentos.

Estos cálculos son estimaciones de CAFO Ianello y los funcionarios de finanzas escolares (posiblemente el comité de construcción escolar que está de incógnito y no se ha escuchado de él). La preocupación, así como las preocupaciones anteriores, es que la MSBA no pagará por partes del proyecto que se supone que no deben ser aprobadas por sus reglas. Reembolsable es la única discreción de la MSBA.

Leahy School Ballot Question and Calculations

As we all know by now, Interim Mayor Kendrys Vasquez order to be placed onto the November ballot a question to increase taxes beyond the maximum of 2.5% for the construction of the Leahy School. That's maximum of 2.5% is calculated out of your current 2022 budget. But in November (now if you vote early like me) the question to increase your taxes beyond that maximum of 2.5% is being asked of the voters.

A "YES" vote means that the city would increase your taxes above 2.5% (actual number still not told to the voters by your elected city official (or by City Chief Administrator & Financial Officer Mark Ianello) and a "NO" vote will not increase it above the 2.5%.

Most of the residents of Lawrence know that we need newer/updated school buildings for city students. That's a given. What upset many Lawrence voters is that they know the elected officials, the school superintendent, and CAFO Mark Ianello are playing mind games with this proposed increase. They are not being transparent with its residents, and many believe that these same people are deceiving voters of the actual nature of the amount, the loans, and using scare tactics to convince you to vote "Yes". So much for transparency in the Interim Mayor Vasquez administration. But hey, by the book right. Sure.

Let me explain, the City Council did not ask for any information, from Interim Mayor Vasquez and CAFO Mark Ianello for the proposed override, even though both Ianello and Vasquez (including the finance team (which I was a member) knew in early June that an override was needed before the budget went to council. They didn't even add any increases to this year's budget because they thought they could hide it from the voters while they were going into these elections. If you want proof of this, all you must do is request (as part of the public records) the City of Lawrence Bond Rating Report, which is dated June 3, 2021.

The Bond Rating Report, specifically states that the administrations told them in early March 2021, that they will have to go for an override of the maximum taxes in November. He primary credit analyst of this report was Danielle L Leonardis of New York and Victor M Medeiros of Boston working for S&P Global.

In the credit rating report, S&P Global indicated Lawrence as "very weak budgetary flexibility", "Very strong debt and contingent liability profile", "Weak economy, with a market value per capita of \$64,837" and "Adequate budgetary performance, with operating results that we expect could weaken in the near term relative to fiscal 2020". They also indicated that "were to experience further fiscal pressures" they would reduce the city's credit rating. Furthermore, insisting that "while we expect Lawrence Massachusetts to have at least balanced operating results, we do not expect results to be as favorable as they had been in 2020."

I also know for a fact that as of June 2021, the city had received or was expected to receive a total of \$7.1 million in CARES Act money, \$41.8 million in ARPA money, an additional \$10 million from the county and full reimbursement from FEMA for their six submitted projects (which include a

vaccination site). The schools were expected to receive an additional \$31 million in ESSR money. To continue their conservative budgeting practices, only \$2.0 million of ARPA money has been included in the fiscal 2022 budget.

And finally, comments in this June 3rd, 2021 report included "The city plans to issue roughly \$130 million for two school projects: the Oliver School and the Leahy School over the near term. The city does not plan to do an over-ride for the Oliver school as debt service declines in fiscal 2028 but will likely require the planned use of a portion of free cash, while the Leahy School will likely require an override, which could go to the voters as early as the Fall of 2021."

They knew early this year! They knew in March 2021, which is when this audit/credit rating was taking place. They did nothing! No transparency, no communication, no anything to inform the voters this was on its way in November. And then to send Superintendent Paris to take the heat for placing the question on the ballot was the cherry on top of this untransparent and corrupt group of individuals – hence why I left.

On September 23, 2021, Council President LaPlante requested (as part of a council meeting) information from CAFO Ianello regarding how the structure of the Leahy loans would look. On October 3, 2021, CAFO Ianello responded to Council President with some "fuzzy number" calculations. He stated in his memorandum the following.

"The Leahy School Building Project has an estimated cost of \$103.7 million, of which the Massachusetts School Building Authority is expected to fund a maximum of 59.08% of the project costs, or \$61.3 million. The City of Lawrence will be responsible for the remaining project costs which are estimated at \$42.4 million, or 40.92% of the total project costs. Borrowing \$42.4M for 20-years will require \$3M annually, 25-years will require \$2.6M annually, and 30-years will require \$3M annually."

\$2.6 million, or \$3 million, a year does not sound that bad for a city to pay back the creditors. Or does it? Remember, Lawrence is a redline city, as are other poor communities across the Commonwealth, which means we get loans at high-interest rates. The interest rates were not included in the letter to Council President. Only money amounts and an additional page indicate average estimated increases on property owners. But let's calculate the amount of the letter as shown in the letter.

1. Three million dollars, for 20 years, total \$60 million. This means that of a \$42.4 million loan, Lawrence will pay \$17.6 million in interest alone. That's 29.4% interest in the life of the loan, and 69% in principal payment.
2. \$2.6 million, for 25 years, totals \$65 million. This means that of a \$42.4 million loan, Lawrence will pay \$22.6 million in interest alone. That's 38.5% interest over the life of the loan and 65% in principal payments.
3. \$3 million, for 30 years, totals \$90 million. This means that of a \$42.4 million loan, Lawrence will pay \$47.6 million in interest alone!!! That is 47.1% interest in the life of the loan, and 53% in principal payments.

Meanwhile, some communities such as Newton, Winchester, or Andover do get

to see rates this high. They are not getting redlined by creditors like they do Lawrence. It's a vicious circle that we are in because we are poor. It's the equivalent of people with bad credit getting offers for credit cards, but at a 33% interest rate payback and early payoff penalties.

Additionally, CAFO Ianello states (in the \$2.3 million levy assessment chart) that the average increase, for single-family homes, will be \$101 more per year. Two-family homes and three-family homes will see tax increases of \$137 and \$156, respectively. But that is not a true statement. Your single-family home may not be assessed as to my single-family home. Your, or my house, may be assessed higher and will pay more taxes. In the same manner that there are no three family homes are assessed alike.

A more detailed report should have been produced – after all they already have all this information in their financial software. They can estimate future or detailed taxes by plugging in the levy percentage or amount. CAFO Ianello can provide detail of every home, business in this city. Now that would be real transparency. But that's too much work for someone who earns \$175,000 per year and doesn't waste one cent in Lawrence (because he does not live in Lawrence).

To make matters worse, at the end of the year the city council sets a tax rate for the New Year (it's mandatory for the City to get funds released from the DOR for the second half of its budget). The council may choose a tax rate that further increases your taxes, making the statement by CAFO Ianello a false statement. Hey, this system is made to squeeze as much money from your properties as the Commonwealth can get, and they will create all these laws and rules to get you not to understand. However, if you get to understand it, it's too late, your taxes, and possibly an override, will have already taken place.

The school department released its own version of the average amount of taxes per home. Let me tell you they were different than what was provided to the council. But what was so brazen in their flyer was that the wanted people in the north side of the city feel like they were receiving less than the south side of Lawrence by placing statements such as; "Provide equitable state of art Science and Technology equipment and labs as well as art and music spaces which are currently available to students attending the Wetherbee, Guilmette, Parthum and South Lawrence East Schools."

Surely, this information should not

be shown as the haves and have nots. Lawrence residents are not at war with one another. But Superintendent Paris is using Comparative Politics. The comparative method is one of four main methodological approaches in the sciences (the others being statistical method, experimental method, and case study method).

The comparative method is important to political science because the other main scientific methodologies are more difficult to employ. This is why I can understand (but not agree) that Superintendent Paris would employ this method to influence voters for the override in taxes. She has no data (or proof) to indicate that the Wetherbee, Guilmette, Parthum, and South Lawrence East educational buildings have a direct positive impact on the learning of Lawrence students. You see MCAS is not used to calculate that, MCAS is only used to calculate a written test taken by the students.

Finally, what CAFO Ianello has not indicated is that he, himself, has stated in early meetings this past summer that the Massachusetts School Building Authority usually won't pay more than 21% of the school building cost.

He was correct then but why did he change his position? Maybe a little nudge by Interim Mayor Vasquez? There is a formula that is used to calculate estimated reimbursable expenses associated with schools by the MSBA. The MSBA takes a base rate of 31% and adds a socioeconomic factor such as, community income factor (provided by Department of Revenue), Community Property Wealth Factor rate (also provided by DOR), and Community Poverty Factor rate (provided by DESE).

No one in this administration has shown any documents that the MSBA has promised a return reimbursement of 59% of the project. That's because there is not. I have requested this as a public record, and they don't have such documents.

These calculations are estimates by CAFO Ianello and school finance officials (possibly the school building committee which is incognito and hasn't been heard from). The concern, as well as the above concerns, is that the MSBA won't pay for pieces of the project that is not supposed to be approved by their rules. Reimbursable is the sole discretion of the MSBA.

For further information on reimbursement rate calculation visit MGL 70B section 10. While you are there read the June 2021 bill introduced by state senators to revamp or update said laws.

Endowed Scholarship is Created in Memory of NECC Professor Emerita

Haverhill and Lawrence, MA (October 19, 2021) Thanks to a lifetime of effort by Mary DiGiovanni, a longtime resident of Reading, MA, who passed away in October, people with disabilities in the Merrimack Valley and beyond continue to receive a higher standard of care.

A nurse with a master's in community mental health, DiGiovanni founded the Human Service Program at Northern Essex Community College and served as its coordinator for three decades, until her retirement in 2001.

The college now offers an associate degree in human services as well as certificates in alcohol/drug abuse counseling, children's behavioral health specialist, community support human services practitioner, direct support, and peer recovery specialist, and all can be traced directly to DiGiovanni, and her passion for advocating for individuals who can't advocate for themselves, said Dr. Paul Bevilacqua, who was her colleague and then, as vice president of academic affairs, her supervisor for many years.

"Where she found the time to do all the things she did, I have no idea," he said. "She was continuous motion. Students loved her because they knew she cared deeply."

Human service professionals work in a range of settings with seniors, adults, adolescents, and children with substance abuse issues, mental illness, or developmental and/or emotional disabilities.

"Mary was connected with everyone in the Merrimack Valley in the human service field," said Bevilacqua. "She had either taught them or partnered with them to place students in practicums or jobs."

DiGiovanni also provided leadership for human services at the national level, serving on the Council for Standards in Human Service Education from 1992 to 2002. In 2009, she researched and wrote a national study creating recognition for the human service profession and developing skills standards for those working in the field.

Well aware of her dedication to the human services profession, DiGiovanni's family has created an endowed scholarship in their mother's name, which will be given to a human service student each year.

In creating the scholarship, her son Mark DiGiovanni wrote "We are creating this scholarship in memory of our mother and her dedication to the human services profession. Her passion in life was teaching and advocating for people with disabilities. She found her calling while at NECC in educating students on caring for others. We hope this scholarship will help others to follow in her footsteps."

After retiring from the college, DiGiovanni continued her work, spearheading grants designed to improve the skills and educational levels of those working with people with disabilities.

She was named Professor Emerita of

Human Services soon after her retirement, and, in 2013, she received the Making a Difference Award in conjunction with the college's 50th anniversary.

Permanently endowed scholarships, with naming opportunities and criteria restrictions, can be created with a minimum commitment of \$25,000, according to Allison Dolan-Wilson, vice president of institutional advancement.

"This is a wonderful way to carry on Mary's legacy," said Dolan-Wilson. "Our students will benefit for many years to come."





As superintendent, it was a productive and rewarding experience for me personally and professionally. Our roles, Leo in governance and mine as the school district's chief education officer always had one clear and motivating goal...the academic and career success of each and every student.

One of the crowning achievements during my time working with Leo is the present 52 million dollar educational facility that is not only home to the Reggies but is regularly used by other schools, organizations and businesses in the Merrimack Valley. Thanks to the efforts of many selfless and enterprising individuals, led by Mr. Lamontagne, this campus is a benchmark of excellence and state of the art technology.

The GLTS Model inspired other vocational-technical schools in the Commonwealth to restructure their school buildings. Under Leo's leadership, the school was the first to use the "High Schools That Work Framework" to revitalize teaching, improve educational standards and evaluate results. Paul Ratha Yem for District 7 in Lowell City Council

By 1995, he left the bank to become the executive director of the Cambodian American League of Lowell (CALL) to promote micro enterprise training, micro loans to individuals starting a business, to provide first time home buyers training in English, Spanish and Khmer in conjunction with the Merrimack Valley Housing Partnership, and to develop affordable housing for those who are not ready to buy a house at 60 Middlesex St. next to

Washington Savings bank creating 24 affordable units and 4 commercial spaces on the ground level that include the Garnick's music center, Majestic Barber Shop, and Sim's Driving School.

"I left the organization in 2002 to start my own businesses that include a convenience store, a Laundromat in South Lowell and my own real estate office in the Acre. As a real estate broker, I was able to bring Tasty Dumpling restaurant to the Acre at 351 Market St; Gormley's Breakfast to 347 Market St. And I will continue to fight for our small businesses to receive grants and other assistance."

1. Affordable Housing for low income family in the District;
2. Community Safety that keep our families and children safe;
3. Revitalized the Acre to include clean streets, sidewalks, parks for our children to play sports and recreation;

Voter ID

For many years, people all over the country have been asking for proper voter identification to be implemented, causing chaos leading to legal proceedings, and plenty of misinformation.

The news also had reports of a cruise ship leaving from Fort Lauderdale, Florida, and people were showing their ID before boarding. I didn't hear anyone complaining. We know that to fly in a plane you need to show it and when I pick up my medicines at the drug store I have to pull my driver's license.

The same for the theatres on New York's Broadway began to open up and I watched on television the long line of people waiting to see Bruce Springsteen with ID on hand and happy about it.

What inspired me to write about this was going to the credit union from where I retired and having to show it as well.

The purpose of asking for identification is to make sure that our elections are honest and clean and after the latest rounds of elections, we should think of this as imperative to guarantee that the system is what we expect it to be.

We've heard the most absurd reasons as to why it should not happen such as it's difficult or impossible for minorities to acquire an ID card due to distance from their homes to the Registry of Motor Vehicles, the cost, lack of transportation, or just that this practice is discriminatory against minorities.

Now, it's happening all over the Commonwealth; people are becoming so frustrated that there are over 6,000 volunteers collecting signatures to add it to the ballot next November of 2022. I gladly volunteered to do my part and I'm going around asking for support. If anyone wants to cooperate with me, please give me a call.

We only have 3 weeks left to collect the signature sheets, have them certified by the city clerk, and send them to the coordinators.

This will be a requirement for all

citizens of any race or color, not specifically for anyone. My response is simple: any person who drives a car must have a driver's license and that's good enough to vote. Anyone who doesn't drive can get an ID similar to the driver's license for \$15.

The requirement of identification to vote means showing something official that tells the poll worker that you are the person on the list. As long as they ask every single person to show it, no one can claim discrimination yet, I've been hearing lately the word "racist."

Lawrence, where we do things backward

The City Council approved last Tuesday, October 19th, a new rule that reads as follows:

Electioneering. For the time period designated for in-person absentee voting and the Commonwealth of Massachusetts's Early Voting Period, no poster, card, handbill, placard, picture, or circular intended to influence the action of the voter, other than those expressly authorized by G. L. c. 54, § 65, shall be posted, exhibited, circulated or distributed in any building where early voting is to take place, including on the walls thereof, on the premises on which the early voting takes place, or within on hundred and fifty feet of the building entrance door.

After the Preliminary Election, we heard lots of complaints about violations of this rule with the excuse that it was not applicable to Early Voting sites.

Well, there's no argument that it will not be allowed. Let's see how they can control city employees going to the council chambers to "help" voters with their ballots (and you know who you are!)

The reason for saying that we do things backward is because the City Council couldn't wait the required 30 days because November 2 will be here soon so they waived the 30-days waiting period or



MassDOT Alerts Drivers to Bus-on-Shoulder Testing on Section of I-93

Intermittent field testing with empty MBTA, Massport, and MVRTA buses to occur on the shoulder of I-93 between I-95 and Somerville beginning Wednesday, October 20th

Testing is to continue for about three weeks

BOSTON – The Massachusetts Department of Transportation (MassDOT) is alerting drivers to the October 20, 2021, start of additional field testing for the viability of allowing buses to travel in the breakdown lane of I-93, between I-95 and Somerville.

This testing will last approximately three weeks, occurring on weekdays only, and will involve Massachusetts Bay Transportation

Authority (MBTA), Merrimack Valley Regional Transit Authority (MVRTA), and Massport's Logan Express buses. Motorists on I-93 may observe empty MBTA, MVRTA, and Logan Express buses traveling in the breakdown lane during the morning on I-93 southbound and in the afternoon on I-93 northbound. The bus on-shoulder travel area is 7 miles long in each direction and the

MBTA estimates the MBTA Route 354 bus currently gets in traffic congestion for 15 to 20 minutes on I-93. The Bus-on-shoulder route would allow buses to bypass this congestion. No motor vehicle travel is permitted in breakdown lanes with the exception of buses involved in the field testing.

MassDOT is advising drivers to be aware of buses traveling in the breakdown lane -- digital message boards and signage will also alert drivers to testing. The driver should continue to use the lane in case of an emergency or a roadway incident. Should bus operators involved in field testing encounter obstructions in the breakdown lane, they will safely maneuver to return to the mainline, pass the obstruction, and return to breakdown lane use.

Following several weeks of field testing, information will be evaluated to determine longer-term viability and potential next steps.

MassDOT and the MBTA have been increasingly taking steps to improve

the efficiency of traveling on buses. For example, this past June, MassDOT and the Cities of Medford and Somerville announced the implementation of a municipal dedicated bus lane pilot between the hours of 6 a.m. and 9 a.m. on Mystic Avenue. In summer 2020, the Cities of Medford and Somerville were awarded a grant from the Baker-Polito Administration's Shared Streets and Spaces Program to implement a "quick-build" morning peak hour inbound dedicated bus lane, as a trial, on Mystic Avenue.

Other steps taken by MassDOT and the MBTA include the installation of a dedicated bus lane on the Tobin Bridge for southbound buses and a partnership with the City of Boston and the MBTA to install dedicated bus lanes on major routes of travel including a section of Washington Street in Roslindale.

Dedicated bus lanes are effective in increasing the efficiency and reliability of public transportation, decreasing delays, and improving access to regional jobs and other essential services.

MassDOT alerta a los conductores sobre la prueba de autobús sobre el hombro en la sección de la I-93

Pruebas de campo intermitentes con autobuses MBTA, Massport y MVRTA vacíos que se realizarán en el arcén de la I-93 entre la I-95 y Somerville a partir del miércoles 20 de octubre

Las pruebas continuarán durante unas tres semanas.

BOSTON - El Departamento de Transporte de Massachusetts (MassDOT) está alertando a los conductores sobre el inicio de pruebas de campo adicionales del 20 de octubre de 2021 para determinar la viabilidad de permitir que los autobuses viajen en el carril de avería de la I-93, entre la I-95 y Somerville.

Esta prueba durará aproximadamente tres semanas, ocurrirá solo los días de semana e involucrará a la Autoridad de Transporte de la Bahía de Massachusetts (MBTA), la Autoridad de Tránsito Regional de Merrimack Valley (MVRTA) y los autobuses Logan Express de Massport. Los conductores de la I-93 pueden observar los autobuses MBTA, MVRTA y Logan Express vacíos que viajan en el carril de avería durante la mañana en la I-93 en dirección sur y por la tarde en la I-93 en dirección norte. El área de recorrido del autobús en el arcén tiene 7 millas de largo en cada dirección y la MBTA estima que el autobús de la ruta 354 de MBTA se encuentra actualmente en congestión de tráfico durante 15 a 20 minutos en la I-93. La ruta del autobús en el arcén permitiría a los autobuses evitar esta congestión. No se permite el desplazamiento de vehículos motorizados en carriles averiados con la excepción de los autobuses que participan en las pruebas de campo.

MassDOT recomienda a los conductores que estén atentos a los autobuses que viajan en el carril de avería; los tableros de mensajes digitales y la señalización también alertarán a los conductores sobre las pruebas. El conductor debe continuar usando el carril en caso de una emergencia o un incidente en la carretera. Si los operadores de autobuses involucrados en las pruebas de

campo encuentran obstrucciones en el carril de avería, maniobrarán de manera segura para regresar a la línea principal, pasar la obstrucción y volver al uso del carril de avería.

Después de varias semanas de pruebas de campo, se evaluará la información para determinar la viabilidad a más largo plazo y los posibles próximos pasos.

MassDOT y MBTA han tomado cada vez más medidas para mejorar la eficiencia de viajar en autobuses. Por ejemplo, en junio pasado, MassDOT y las ciudades de Medford y Somerville anunciaron la implementación de un piloto de carril exclusivo para autobuses municipal entre las 6 a.m. y las 9 a.m. en Mystic Avenue. En el verano de 2020, las ciudades de Medford y Somerville recibieron una subvención del Programa de Calles y Espacios Compartidos de la Administración de Baker-Polito para implementar un carril exclusivo para autobuses de entrada en las horas pico de la mañana de "construcción rápida", a modo de prueba, en Mystic Avenue.

Otras medidas tomadas por MassDOT y MBTA incluyen la instalación de un carril exclusivo para autobuses en el puente Tobin para los autobuses en dirección sur y una asociación con la ciudad de Boston y la MBTA para instalar carriles exclusivos para autobuses en las principales rutas de viaje, incluida una sección de Washington Street, en Roslindale.

Los carriles exclusivos para autobuses son efectivos para aumentar la eficiencia y confiabilidad del transporte público, disminuir las demoras y mejorar el acceso a trabajos regionales y otros servicios esenciales.

In addition to these three National Presidents, three members have served as National Directors of the Order. The Division yearly hosts numerous social events and activities and has scholarship opportunities on the high school and college level, including a college scholarship for study in Ireland.
