



MCAD Joins the City of Lawrence in Celebrating Disability Awareness Month

The Massachusetts Commission Against Discrimination (MCAD or "Commission") attended the annual Disability Employment Awareness Month program on Wednesday, hosted at the Lawrence Senior Center, to celebrate the 33rd Anniversary of the American with Disabilities Act (ADA). The event featured 30 organizations driven to provide resources and protections for persons with disabilities in the community. The MCAD was pleased to share information about its mission to eradicate discrimination in the Commonwealth through conversations with local residents, elected officials, and other present organization staff members.

"Educating community members about their civil rights is of major importance to the agency," Michael Memmolo, Interim Executive Director for the MCAD shared. "For nearly two decades the top complainants filed at the MCAD are those based on disability discrimination. In many instances, these complaints arise from a lack of interactive dialogue when responding to a request for a reasonable accommodation—a critical process to complying with the law to ensure workplaces, housing, and public accommodations are accessible for all."

First established in 1946, the MCAD is the independent state agency tasked to uphold the anti-discrimination laws in Massachusetts in employment, housing, public accommodations, credit and lending, and higher education admissions.

"I want to thank the Commission for participating and I am already looking

forward to next year's Disability Month celebration!" said Richard Rodriguez, ADA Coordinator for the City of Lawrence who led Wednesday's event alongside the Mayor's Office. "Lawrence is known as an immigrant city, where the largest racial/ethnic groups are Hispanic at 82.3%. This population, and others in the city, may also face disability discrimination due to lack of information. As such, the information the MCAD and others presented in this event to community members is significant so they can learn about their rights and where to go in accessing essential resources."

"We are grateful to have participated in this powerful event and to have interacted with many members of the Lawrence Community. Thank you to Mayor Brian DePeña and Lawrence ADA Coordinator, Richard Rodriguez, for allowing the MCAD to attend this celebration!" said Mr. Memmolo.

Hace historia como oficial electo más joven de Lawrence



El alcalde Brian A. DePeña y la Ciudad de Lawrence anuncian Crecimiento económico sin Precedentes y Presupuestos Históricos

Por segundo año consecutivo, el alcalde Brian A. DePeña y los concejales de la ciudad optaron por no aumentar los impuestos a la propiedad según la limitación permitida de la proposición 2.5, asegurando así las tasas impositivas divididas más bajas desde 2007 y el tercero más bajo en más de dos décadas. La tasa impositiva residencial propuesta para el año fiscal 2024 es de \$9,28; esto es una disminución de \$.088 y la tasa del impuesto comercial/industrial/propiedad personal es de \$19.43; una disminución de \$1,71.

El contribuyente unifamiliar promedio en Lawrence paga \$3,766 en impuestos a la propiedad y potencialmente puede notar una disminución anual en la factura del impuesto a la propiedad de \$47 dólares. En comparación con la factura de impuestos promedio para las viviendas unifamiliares en todo el estado el año pasado, que fue de \$6,719; esta es una diferencia en la factura de impuestos de \$2,953.

Los valores tasados de propiedad del año fiscal 2024 (FY2024) para fines de impuestos locales fueron aprobados por el DOR a su valor total y justo en efectivo. Se realizaron ajustes a las tasaciones para reflejar los cambios en el mercado inmobiliario y los cambios en la base

imponible debido a nuevas construcciones, modificaciones, demoliciones, etc.

En el año fiscal 2024, la valoración total imponible en Lawrence alcanzó un máximo histórico de \$ 7,6 mil millones de dólares; esto es un aumento de \$764,416,940 dólares o un aumento del 11.1% superando los totales récord del año anterior. El valor tasado promedio de una vivienda unifamiliar superó la alta valoración histórica del año pasado alcanzando los \$405,000.

Otra gran noticia es que el 25 de octubre de 2023, el Departamento de Ingresos de Massachusetts certificó que la cantidad de fondos disponibles, o "Free Cash", al 1 de julio de 2023, para la ciudad de Lawrence es de \$43,280,417. Se trata del mayor free cash certificado en la historia de la ciudad.

El resultado del cálculo, al 1 de julio, de los fondos restantes no restringidos de una comunidad provenientes de las operaciones del año fiscal anterior con base en el balance general al 30 de junio. Por lo general, incluye ingresos reales que exceden las estimaciones de ingresos y montos no gastados en depósitos departamentales, partidas presupuestarias para el año que acaba de terminar, más el free cash no gastado del año anterior.

Además, el Departamento de Agua y Alcantarillado de Lawrence recibió sus ganancias retenidas certificadas del Departamento de Ingresos de Massachusetts por un monto de \$3.1 millones de dólares. Esta es una mejora significativa con respecto al último año fiscal y es una gran noticia para la ciudad. Estamos entusiasmados con el progreso y

el futuro del departamento.

El alcalde Brian A. DePeña, agradece a todos los jefes de departamento y empleados de la ciudad por su arduo trabajo y su administración en la buena distribución de los fondos de la ciudad, lo que permitió esta certificación del free cash, algo sin precedentes en la historia de la Ciudad de Lawrence.

Mayor Brian A. DePeña and the City of Lawrence announce record-breaking economic growth and historic budgets

For the second year in a row, Mayor Brian A. DePeña and City Councilors chose not to increase property taxes by the allowable Proposition 2.5 limitation, therefore, assuring the lowest split tax rates since 2007 and the third lowest in over two decades. The proposed FY2024 Residential Tax Rate is \$9.28; this is a decrease of \$.088 and the Commercial/Industrial/Personal Property tax rate is \$19.43; a decrease of \$1.71.

The average single-family taxpayer in Lawrence pays \$3,766 in property taxes and may potentially notice an annual property tax bill decrease of \$47 dollars. In comparison to the statewide average single-family tax bill last year which was \$6,719; this is a tax bill difference of \$2,953.

The Fiscal Year 2024 (FY2024) property assessed values for local tax purposes were approved by the DOR at its full and fair cash value. Adjustments to assessments were made to reflect changes in the real estate market and changes to the tax base due to new construction, alterations, demolitions, etc. In FY24, the total taxable valuation in Lawrence reached an all-time historic high of \$7.6B dollars; this is an increase of \$764,416,940 dollars or an 11.1% increase surpassing the previous year's record high totals. The average single-family assessed value shattered last year's historic high valuation

reaching \$405,000 dollars.

Another great news is that on October 25, 2023, the Massachusetts Department of Revenue certified that the amount of available funds, or "free cash", as of July 1, 2023, for the City of Lawrence is \$43,280,417. This is the largest free cash certified in the city's history.

Free cash results from the calculation, as of July 1, of a community's remaining unrestricted funds from operations of the previous fiscal year based on the balance sheet as of June 30. It typically includes actual receipts in excess of revenue estimates and unspent amounts in departmental budget line items for the year just ending, plus unexpended free cash from the previous year.

Also, the Lawrence Water and Sewer Department received its certified retained earnings from the Massachusetts Department of Revenue in the amount of \$3.1 million dollars.

This is a significant improvement over the last fiscal year and is great news for the city. We are excited about the progress and the future of the department.

Mayor Brian A. DePeña would like to thank all city department heads and employees for their hard work and for their stewardship in managing city funds allowing for this record-free cash certification.

Emmaus Celebrates Record Breaking Donations from the 35th Cycle for Shelter!

Sponsorships and Cyclist Fundraising Reaches New Level!

HAVERHILL | Over 300 cyclists, volunteers, supporters and staff celebrated Emmaus' 35th Cycle for Shelter on Sunday, September 17. The cyclists enjoyed the beautiful scenery along the Merrimack Valley backcountry roads and the New Hampshire Seacoast, and finished their rides with an extensive cookout at Northern Essex Community College. Emmaus, the largest non-profit community housing development in Essex County offers emergency shelter, permanent affordable housing and supportive services to individuals and families, and relies upon this annual event to raise money for its shelters.

"What a spectacular day! The threat of inclement weather loomed over us with the severe storm forecasted for Saturday. We were blessed with a glorious early fall day, full sunshine, a light breeze, and temperature in the 60's. We couldn't have ordered better weather," commented Gretchen Arntz, Emmaus' Chief Development Officer.

This year, cyclists participated in one of four routes: 100, 62, 35 or 15 miles and pledged to raise a minimum of \$250 for Emmaus. On average, each cyclist raised approximately \$875 through their fundraising efforts-- a 31% increase over last year's average and an Emmaus record! To date, Emmaus raised \$193,000 from the cyclists' supporters and local business sponsors.

This beloved event brings together volunteers and supporters from local businesses, faith organizations, and community groups to help Emmaus raise money for its operations. Over 40 volunteers hand out water and snacks at each of the seven rest stops along the routes. Another seven escort the riders in case they need assistance. The remaining 60 volunteers help with registration, monitor the weather and safety of the riders through radio control, set up and serve at the cookout, and clean up at the end of the event. Cycle for Shelter would not be possible without this army of volunteers.

As Gretchen notes, "Our volunteers are simply amazing: it's no exaggeration to say that Cycle for Shelter wouldn't exist without them! In fact, as a certified Service Enterprise through the Points of Light Foundation, volunteers are the backbone of all we do at Emmaus and we wish to express our deepest gratitude to them."

Emmaus also thanks the generous event sponsors including our Presenting

Sponsors, Honda North and Merrimack Valley Credit Union, our Volunteer Sponsor, Haverhill Bank, our Premier Bike Shop Partner, Riverside Cycle, and our Venue Sponsor, Northern Essex Community College.

Many other local businesses supported this event as well as local restaurants LongHorn Steakhouse, Starbucks, the Chicken Connection and Biggart's Ice Cream, who not only donated ice cream for the rest stop on the 15-mile family ride, but also slush to the post-ride cookout. A new addition to the cookout included a beer tent featuring brews from BareWolf Brewing in Amesbury which was very popular with the thirsty cyclists.

Another highlight of the event included a short performance by Suriel, a rising rap artist who lived in the Emmaus Family Shelter with his mother and sister when he was twelve-years-old. Suriel spoke about the positive impact living in the shelter had on his life and how it helped him to develop the drive and persistence that have contributed to his success. He said that performing at Cycle for Shelter with his mom and sister in attendance was a "full circle moment" for him.

Cycle for Shelter serves two purposes—it raises crucial funds which support Emmaus' emergency shelters and it unites the local communities in a shared purpose and a fun event. Contributions to Emmaus help women, men and children battling homelessness rebuild their lives. Since 1985, Emmaus has helped more than 40,000 children and adults out of homelessness and toward self-sufficiency. Over the past year, Emmaus has helped 1,012 people, including 400 children through its shelters and housing programs. On any given night, 300 adults and children will call Emmaus "home."

In addition to its emergency shelters for families and individuals, Emmaus owns and operates 99 units of permanent affordable housing, serves approximately 80,000 meals annually, provides supplemental food on a regular basis to those residing in Emmaus housing, and helps people find jobs and connect to a wide range of supportive and educational services.

Auditor DiZoglio Releases Audit of the Sex Offender Registry Board

State Auditor Diana DiZoglio's office released an audit of the Sex Offender Registry Board (SORB), which reviewed the period of July 1, 2019, through June 30, 2021. The current audit followed up on deficiencies identified in a 2017 audit completed under the previous administration.

In our report, Auditor DiZoglio notes that SORB has not yet implemented prior recommendations to ensure that they have current addresses for sex offenders in violation. Although SORB entered into interdepartmental service agreements with the Department of Transitional Assistance and the Department of Revenue to conduct address verification data matching, they did not perform these verifications to ensure accurate data matched. In addition, SORB has not entered into any other interdepartmental service agreements with executive branch agencies to verify sex offenders' addresses.

"By law, SORB is required to keep sex offender registry information up-to-date and accurate. It is important that SORB work with our state and local public safety departments to properly educate the public about registered sex offenders living, working, or attending school in the



Commonwealth," said Auditor DiZoglio. "Our audits exist to help make government work better. When our audit findings and recommendations are ignored, as was the case here, it's not only a waste of taxpayer dollars but can be a threat to public safety. It is imperative that these matters be addressed immediately."

La auditora DiZoglio publica la auditoría de la Junta de Registro de Delincuentes Sexuales

La oficina de la auditora estatal Diana DiZoglio publicó una auditoría de la Junta de Registro de Delincuentes Sexuales (SORB), que revisó el período del 1 de julio de 2019 al 30 de junio de 2021. La auditoría actual dio seguimiento a las deficiencias identificadas en una auditoría de 2017 completada bajo la anterior administración.

En nuestro informe, la Auditora DiZoglio señala que SORB aún no ha implementado recomendaciones previas para garantizar que tengan direcciones actuales para los delincuentes sexuales que cometieron violaciones. Aunque SORB celebró acuerdos de servicios interdepartamentales con el Departamento de Asistencia Transicional y el Departamento de Ingresos para realizar la comparación de datos de verificación de direcciones, no realizaron estas verificaciones para garantizar una coincidencia de datos precisa. Además, SORB no ha celebrado ningún otro

acuerdo de servicio interdepartamental con agencias del poder ejecutivo para verificar las direcciones de los delincuentes sexuales.

"Por ley, SORB debe mantener la información del registro de delincuentes sexuales actualizada y precisa. Es importante que SORB trabaje con nuestros departamentos de seguridad pública estatales y locales para educar adecuadamente al público sobre los delincuentes sexuales registrados que viven, trabajan o asisten a la escuela en el Commonwealth", dijo la Auditora DiZoglio. "Nuestras auditorías existen para ayudar a que el gobierno funcione mejor. Cuando se ignoran los hallazgos y recomendaciones de nuestras auditorías, como fue el caso aquí, no solo es un desperdicio del dinero de los contribuyentes, sino que también puede ser una amenaza para la seguridad pública. Es imperativo que estos asuntos se aborden de inmediato".





The ceremony featured speeches from local and state leaders, community members, and members of Isabel Melendez’s family, who shared personal experiences and the impact she has had on her family and the city. Attendees had the opportunity to engage with the community, celebrate Isabel Melendez’s achievements, and experience the park’s features.

As we honor Immigrant Park in Isabel Melendez’s name let it be a symbol of community, a testament to the strength, and the enduring spirit of immigrants who have made this city their home and have played a pivotal role in building it up. This park stands as a reminder that diversity is our strength, and unity is our beacon.” Sen. Pavel Payano (D — Lawrence)

“It was an absolute pleasure to join so many familiar faces in Lawrence this morning to celebrate the rededication of the Immigrant Place Park in honor of Isabel Melendez,” said State Representative Frank A. Moran (D – Lawrence). “Lawrence is incredibly fortunate to have someone like Isabel working within our community and I consider it a privilege to call her my friend and mentor.

As an acting Police Chief and a proud Puerto Rican, I have looked up to Isabel Melendez as a role model and a beacon of hope. Her courage and dedication to justice have been a light throughout my career. I am honored to serve in a position where I can continue her legacy of serving and protecting the Lawrence community, said Chief William Castro.

On behalf of the Melendez and Guzman families, I would like to express my appreciation to all who were involved in the process of Dedicating Immigrant Place Park to my mom, Isabel Melendez. It is a Park that she herself will be able to enjoy. She is and will always be my hero. She has always been there to serve our community. She has taught me to be a voice for others. She has taught me to give back to the community. She has taught me that by doing so the self-satisfaction will be immense. May God bless her, and

allow her to serve many years to come, said Maritza Melendez.

Isabel Melendez was the first female and Latino candidate to make it to the general election. Lost by 600 votes even though her grassroots campaign only raised \$25,000. Started Voters in Action, a non-partisan group to educate and register qualified voters in Lawrence. Registered over 4,000 new voters between 2004 and 2014.

She has worked with local leaders to assist local residents relocate in area of what became Heritage Commons on Camella Teoli Way. Retired from Greater Lawrence Community Action Council after 39 years of service. Nowadays, she attends the General Donovan School every day, eager to serve our community and its residents.

With a very special lunch at the “Center” located on 155 Haverhill St. friends and families were very excited to celebrate with Isabel her 87 years of life and 65 years as a resident in Lawrence.


