After every election period in Lawrence, we hear complaints about the Elections Department workers, issues at the polling places, and, of course, cheating. The biggest problem is that no one presses charges, and the next time around, it happens all over again.

Lawrencians remember having seen surveillance videos of a well-known person stealing ballots from a mailbox a few years back and no one pursued it. But, this year, things are different. Not only have videos

been posted on social media for all to see but the person has been identified.

On this page, you can see a letter from Vladimir Acevedo, candidate for District A City Council who lost the election and is requesting an investigation since the person shown on the video is making the rounds in his district.

In total, more than 7 complaints have been sent to the Secretary of State's office and some have been requesting for the election to be canceled completely.

### Candidato exige investigación

Mi nombre es Vladimir Acevedo. Me postulé para Concejal por el Distrito A en las últimas elecciones municipales en Lawrence, Massachusetts. La elección tuvo lugar el 7 de noviembre de 2023.

Han pasado muchas cosas desde las elecciones y creo que durante dichos comicios se produjeron muchas irregularidades. Muchos electores se han puesto en contacto conmigo y han expresado sus preocupaciones con respecto a las boletas por correo que nunca fueron recibidas, problemas con las máquinas de votación, la votación anticipada, etc., y el personal en los centros de votación.

Como candidato, solicito que se lleve a cabo una investigación sobre la elección y el manejo de las papeletas. Me gustaría recibir el protocolo escrito para el manejo de las boletas cuando lleguen del estado al ayuntamiento. ¿Dónde se almacenan? ¿Quién tiene acceso? ¿Cómo se mantienen seguras las boletas por correo? ¿Cómo se transportan estos a las urnas? ¿Quién abre estos sobres? ¿Cómo realiza el departamento electoral un seguimiento de las boletas que se envían por correo?

¿Se han reportado al estado todas las irregularidades recientes reportadas a la Secretaría?

Es posible que esté al tanto de la circulación del video en las noticias y las redes sociales. El acto en el video afecta directamente los resultados de las elecciones.

¿Qué se hará al respecto?

¿Qué medidas tomará el departamento electoral ahora que tienen esta información? ¿Se ha informado de este incidente al Secretario de Estado? Hay tantas preguntas en el aire y nadie en la ciudad ha abordado este asunto.

También me han informado algunos electores que no pudieron votar en persona porque, en la lista, aparecían como si ya hubieran votado. Algunos recibieron votos provisionales; a otros se les negaron las papeletas provisionales.

Creo que durante estas elecciones se violaron los derechos constitucionales de los continuantes y candidatos.

Nosotros, como ciudad, debemos investigar y garantizar que la democracia sea lo primero. Espero su respuesta a la brevedad.

### Candidate demands investigation

November 14, 2023

My name is Vladimir Acevedo. I ran for City Councilor for District A in the last municipal elections in Lawrence, Massachusetts. The election took place on November 7th, 2023.

Many things have transpired since the election, and I believe many irregularities took place during said elections. Many constituents have contacted me and have expressed their concerns regarding mail ballots that were never received, as well as problems with the voting machines, early voting, etc., and staff at the voting polls.

As a candidate, I am requesting that an investigation be conducted regarding the election and handling of the ballots. I would like to receive the written protocol for the handling of the ballots when they arrive from the state to city hall. Where are they stored? Who has access? How are mail-in ballots kept safe? How are these transported to the polls? Who opens these envelopes? How does the election department keep track of the ballots going out in the mail?

Have all the recent irregularities reported to the Clerk's office been reported to the state?

You may be aware of the video circulation on the news, and social media. The act on the video directly affects the results of the election.

What will be done regarding this?

What steps will the election department take now that they have this information? Has this incident been reported to the Secretary of State? So many questions are up in the air and no one from the city has addressed this matter.

I have also been informed by constituents that they were unable to vote in person because, on the list, they appeared as if they had already voted. Some received provisional ballots; others were denied the provisional ballots.

I believe continuants' and candidates' constitutional rights were violated during these elections.

We as a city must investigate and ensure that democracy stands first. I await your response promptly.

# Desde Mi Esquina

## Más sobre las elecciones

La semana pasada mencioné la poca educación que tiene la gente a la hora de seleccionar a nuestros representantes. Hay mucho trabajo por hacer en lo que respecta a la educación cívica y a enseñar a la gente a juzgar a los candidatos.

En una comunidad donde la mayoría de la gente nunca ve una reunión del concejo municipal (o sus comités), no tenemos noticieros de radio que expliquen sus acciones y decisiones. Como resultado, todo tiende a distorsionarse dependiendo de quién habla de ello y de cómo le afecta personalmente.

Existe la impresión común de que su trabajo consiste en aprobar señales de PARE o para letreros de estacionamiento para discapacitados y rara vez tienen que lidiar con sindicatos, construcciones y cuestiones laborales. La realidad es que los concejales crean las reglas en la ciudad, tal como lo hacen nuestros representantes y senadores para el estado.

También deben enfrentar emergencias y necesidades importantes y luchar para lograr que se hagan esas cosas. Al final, ellos controlan los fondos y protegen nuestra base impositiva. Esa es la parte del trabajo que requiere la mayor parte de su tiempo en búsqueda e investigación, lo que da como resultado que sólo las partes interesadas hagan todo el trabajo. Cuando van ante el resto de los miembros, les explican, les educan y votan sobre el tema.

Poreso es tan injusto que determinadas personas utilicen las redes sociales para denigrar las acciones de cualquiera de ellos. Muy a menudo confunden sus actividades con las de organizaciones vecinales o su trabajo con el ayuntamiento. María De La Cruz era muy activa en su Distrito A con la asociación de vecinos pero eso no tenía nada que ver con sus responsabilidades concejales.

La semana pasada escribí sobre Celina Reyes siendo falsa al escribir en sus tarjetas políticas sobre su trabajo con proveedores de guarderías para lograr que más niños ingresen a los programas y mejores salarios para los trabajadores. Bueno, ella misma es proveedora y era parte de su trabajo cuando fue empleada por Lawrence CommunityWorks.

Celina no tenía absolutamente nada que escribir en su propaganda política. Su cerebro estaba en otro lugar durante las reuniones porque no tenía nada que aportar. Sin embargo, ella fue la segunda en obtener votos.

Si voy a usar a Celina como ejemplo, tengo que seguir a Ana Levy, quien quedó en tercer lugar como concejal general.

Conocí a Ana a mediados de los noventa cuando ella estaba muy involucrada con los grupos juveniles y con el Departamento de Justicia escribiendo artículos sobre su trabajo para los periódicos de Boston. Sus esfuerzos por educar a esta comunidad y hacerla avanzar impartiendo conocimientos me atrajeron de inmediato porque no hay mucha gente dispuesta a dar tanto de sí misma.

Incluso sin ocupar un cargo público, llevó al Departamento de Justicia a



observar las elecciones en Lawrence, algo que nadie más había intentado. Con el paso del tiempo se involucró en la política poniendo el mismo esfuerzo en todo lo que aborda.

Por eso me enfurece escuchar las críticas de que Ana siempre está buscando sesiones fotográficas y está en todas partes. A diferencia de otros concejales que trabajan a tiempo completo, ella está jubilada y puede permitirse el tiempo para asistir a eventos y estar en contacto con la gente más que los demás.

Solo eche un vistazo a algunos de sus logros recientes:

- Luchó por comprar nuevas máquinas de votación porque las viejas estaban obsoletas y se estropeaban constantemente;
- Patrocinó la ordenanza sobre vehículos comerciales y estacionamiento nocturno comercial;
- Estacionamiento para vehículos motorizados de recreo- Registrados y no registrados;
- Aumentó los salarios pagados a los trabajadores electorales en un 20% y un 30% para los inspectores, secretarios y guardianes;
- Más recientemente, Ana emprendió el reemplazo de todo el equipo de televisión del Ayuntamiento; de cámaras, micrófonos, equipos de grabación de video, etc. que estaban obsoletos, y no pudimos ver las reuniones del consejo debido a la mala administración de Lawrence Community Access Television (LCAT). Y ha sido la única concejala que ha luchado y representado los intereses de los lawrencianos en eso;
- Además, la Concejala Levy se comunicó con la Auditora Estatal Diana DiZoglio para solicitar una auditoría de LCAT que fue aprobada por el concejo y el alcalde;
- El verano pasado, solicitó al concejo el nombre oficial del Parque Nunzio DiMarca y fue aprobado por unanimidad.

Estas son sólo algunas de las cosas que me vienen a la mente en este momento. Decir que sólo está buscando "sesiones fotográficas" es sólo una muestra de la ignorancia del hablante.

Quizás se preguntan por qué no dije nada antes de las elecciones. Me habrían

# New FREE MeVa Service to the VA Bedford Healthcare System

Haverhill, MA — Local veterans seeking care at the VA Bedford Healthcare System will soon have access to a free door to door ride service with the launch of the new MeVa Transit VA Bedford mediMeVa. Last Thursday, the MeVa Transit Advisory Board unanimously approved the new mediMeVa service to the VA Bedford Healthcare System in Bedford, MA. Bob Snow, MeVa Advisory Board representative from Rowley was an early champion of the new service, stating that, "Being a Marine Veteran, Rowley's representative to the MeVa advisory board, and a member of the Paratransit committee, I was excited that MeVa's operations team was able to turn this idea into service so quickly. I was proud to join my fellow board members in voting to start the VA Bedford mediMeVa in January to help our region's Veterans who have given so much in service to our Country."

The idea of service to VA Bedford came through conversations between MeVa and Vision Committee members of the Merrimack Valley Veterans Collaborative. Each month, the Merrimack Valley Veterans Collaborative brings together Veterans Service Officers (VSOs) and other community organizations who serve veterans. Through community outreach and conversations with the Veterans Collaborative, it was clear there was a transportation service gap for Veterans and their families across the region who needed to access care at the VA Bedford Healthcare System. As the public transit providers for the region, MeVa Transit was perfectly positioned to close this gap with their mediMeVa van service. MeVa joined the Collaborative's September meeting with an idea of a service plan going forward. Christina Penna, Community Outreach Program Manager at AgeSpan who oversees the Veterans Collaborative said, "This new service is great news! We are grateful to MeVa Transit for providing more transportation options for our deserving veterans."

To ensure the best quality service, MeVa worked closely with the VA Bedford Health Care System to determine how best to implement this new service, which will take riders outside of MeVa's service district to reach Bedford. Patrick Kirby, Public Affairs Officer of the VA Bedford Health Care System is grateful to MeVa for responding to the needs of veterans by making this new service possible. "Reliable access to care is imperative, and MeVa has helped reduce barriers through this free offering. This not only improves access to medical appointments, but also enables Veterans to take advantage of the VA's many community-building offerings. From our free produce market, recreational therapy classes and healthy cooking classes, these programs help strengthen the bonds between Veterans and provide holistic support beyond healthcare. By making it easier for Veterans to visit our Bedford campus through this new transportation route, MeVa is helping advance our mission to care for Veterans' whole health."

Starting on January 2, 2024, the VA Bedford mediMeVa will operate

Wednesdays and Fridays by reservation. "As public transit professionals, MeVa was able to quickly design a program that would immediately address the need presented by the local veteran services community. We have created a program that is easy to use, without forcing our Veterans and their families to fill out excessive paperwork to access this service. Veterans and their families just have to call our offices to get set up in our reservation system," said Amy Jenkins, Director of miniMeVa services at MeVa Transit.

Rides to the VA Bedford Healthcare System will be available on Wednesdays and Fridays with one trip to Bedford in the morning and one return in the afternoon. This is a door to door shared ride service. Veterans will be picked up at their homes or other origination point within MeVa's service area and ride with others to Bedford. The hours of the service are flexible and will vary depending on the appointment times of the riders. All Veterans and their families, regardless of age or ability, who reside in one of the 16 cities and towns in MeVa's service area, are eligible to use this service. Sign up is easy by simply calling the miniMeVa office at 978-469-6878 option #3. Reservations must be made at least one week (7 days) in advance, and may be made no more than 14 days in advance. When making reservations, riders should be prepared to provide the reservationists with the date of travel, the pick-up location, and the time of the appointment. Like all of MeVa's transportation services, the VA Bedford mediMeVa is completely free.

This new service will close critical transportation gaps for Veterans living in the Merrimack Valley. Kirby added that "We are grateful that MeVa has made this possible and look forward to welcoming Veterans who utilize this convenient new service."

The mediMeVa service is provided by MeVa Transit, the regional transit provider serving the 16 communities along the Merrimack River from Andover to the seacoast. MeVa Transit runs fixed service buses with service hubs in Lawrence, Haverhill, Amesbury, and Newburyport and their miniMeVa and mediMeVa van services. In March of 2022, the MeVa advisory board voted to go fare-free systemwide in a move to encourage ridership and alleviate some of the financial burden shouldered by residents in the wake of the COVID-19 pandemic. In addition to free-fares, MeVa rebranded all their vans and buses, doubled service on Lawrence-based routes, extended service into Groveland, and optimized routing to improve efficiency. Through October 2023, ridership on MeVa's fixed route bus network as more than tripled since going fare free, and now exceeds pre-pandemic ridership levels by 37.9 percentage points. On the paratransit side, ridership has almost doubled since going fare free and now exceeds pre-pandemic levels by 4.6 percentage points.

# Una investigación y un litigio del Departamento de Trabajo recuperan \$11.4 millones en salarios atrasados y daños para más de 1,000 empleados de una cadena de restaurantes de la Costa Este

Plaza Azteca negó a sus trabajadores el salario mínimo y el pago de horas extras; pagará \$625,000 en por infracciones

WASHINGTON – El Departamento de Trabajo de EE UU ha recuperado \$11.4 millones en concepto de salarios atrasados y daños y perjuicios para más de 1,000 empleados de una cadena de restaurantes de la Costa Este después de una serie de investigaciones y de litigio que el Departamento llevó a cabo.

La recuperación de salarios está relacionada a un fallo por consentimiento que se registró en el Tribunal de Distrito de los EE UU para el Distrito Este de Virginia, en Norfolk, resuelve el litigio iniciado por la Oficina del Procurador (Office of the Solicitor) del Departamento en relación con las prácticas salariales en más de 40 establecimientos del restaurante mexicano Plaza Azteca, propiedad de Rubén León en siete estados. Después de una investigación de la División de Horas y Salarios del Departamento, personal del Departamento registró una denuncia alegando que León y sus restaurantes infringían las disposiciones sobre horas extras y salario mínimo de la Ley de Normas Justas de Trabajo (FLSA por sus siglas en inglés).

Los empleadores se pusieron de acuerdo con el fallo de consentimiento después de meses de litigio y justo antes de que empezara un juicio con jurado que estaba agendado. En la denuncia judicial, se incluían establecimientos de Plaza Azteca en Connecticut, Maryland,

Massachusetts, Nueva Jersey, Carolina del Norte, Pensilvania y Virginia.

“Nuestros investigadores descubrieron que Plaza Azteca conocía sus obligaciones legales de pagar a los trabajadores el salario mínimo y las horas extras y de mantener registros precisos de las nóminas y, sin embargo, incumplió deliberadamente la ley federal”, declaró la Administradora de la División de Horas y Salarios, Jessica Looman. “Los empleadores no pagaron los salarios completos a más de 1,000 empleados. La medida del tribunal en este caso es un paso importante para lograr un cambio significativo en la vida de estos trabajadores mediante la recuperación de los salarios que tanto les costó ganar.”

En concreto, el Departamento alegó que muchos restaurantes mexicanos Plaza Azteca pagaban a los empleados de servicio unas cantidades predeterminadas. De este modo, los empleadores no pagaban a algunos empleados que trabajaban hasta 40 horas semanales el salario mínimo requerido y tampoco pagaban a otros el 50% adicional sobre el salario por las horas trabajadas sobre las 40 en una semana laboral. Los empleadores tampoco mantuvieron registros precisos de las horas de trabajo y los salarios de los empleados, tal como se exige por ley.

Debido al carácter reincidente y deliberado de las infracciones, la sentencia por consentimiento también recuperó \$625,000 en sanciones de los empleadores.

“Este resultado envía un mensaje muy claro para otros empleadores del sector gastronómico sobre las costosas consecuencias que pueden producirse cuando privan a los empleados de sus salarios íntegros y legítimos”, declaró la Procuradora de Trabajo, Seema Nanda. “Como hicimos en este caso, el Departamento de Trabajo de los EE UU aplicará estratégicamente nuestros recursos de investigación y litigio para remediar las infracciones sistemáticas de la ley en todo el territorio nacional a través de cada establecimiento”.

Además de los salarios atrasados y las sanciones, la sentencia por consentimiento prohíbe a los empleadores infringir la Ley de Normas Justas de Trabajo (Fair Labor Standards Act, FLSA) en el futuro y les obliga a contratar a un consultor independiente calificado para asegurarse de que las nóminas y las prácticas de mantenimiento de registros de los empleadores cumplan con la FLSA.

Los salarios atrasados y los daños y

perjuicios se deben a ciertos empleados actuales y empleados de los restaurantes Plaza Azteca, independientemente de su condición migratoria. Dado que algunos de los trabajadores afectados por este caso pueden haberse trasladado, la División de Horas y Salarios recomienda a los empleados o actuales afectados que se pongan en contacto con la División llamando al 215-861-5180 si tienen alguna pregunta.

Las investigaciones fueron realizadas por las oficinas de distrito de la División de Horas y Salarios de Boston, Pittsburgh y Wilkes-Barre (Pensilvania) y Richmond (Virginia). Las oficinas regionales del Procurador de Boston y Filadelfia litigaron el caso.

On Thursday, Oct. 26, Credit Union Times published an exclusive profile of Merrimack Valley Credit Union's (MVCU) President & CEO John J. Howard. Additionally, Howard was recently named CEO of the Year during the Cooperative Credit Union Association's annual APEX conference on Oct. 12.

In the Credit Union Times profile, Howard described the big-picture impact he hopes to make at both MVCU and beyond in the credit union community.

"I believe the reason people 'love' their financial institution is because they

feel the organization will be there for them when some unexpected or stressful financial situation arises," Howard said. "My greatest aspiration is to work with our team to build a credit union that is truly and wholly supportive of our members. When they come to us for help, we have a machine built that can help them find a solution. I envision our credit union team walking arm in arm with members to help them clear any financial obstacles that are in their way!"



# Agradeciendo a los vivos y a los muertos este mes

Noviembre es para mí, como podría serlo para algunos de vosotros, un mes lleno de fechas importantes, tanto a nivel personal como general. Mi padre murió en noviembre de 1995; tres de mis nietos nacieron a finales de noviembre de varios años y fue en noviembre de hace muchos años que mi esposa y yo nos casamos.

En cuanto a la categoría de nivel general, "El Día de Muertos" en México y "Acción de Gracias" en este país son evidencia suficiente que probaría mi punto de vista y terminaría mi artículo aquí, pero, por supuesto, saben que no dejo a mis lectores tan fácilmente.

A finales del siglo XIX y principios del XX, había una mujer llamada Julia Rizo que vivía una vida intrascendente en un pueblo cubano cerca de La Habana llamado Alquizar. Tenía cinco hijos pequeños y un día perdió a su esposo, algunos informando que había sufrido un ataque al corazón, otros que simplemente la había abandonado.

Julia, que no era una persona educada, decidió trabajar para ganarse la vida en una empresa de fabricación de cigarros como despalilladora para mantener a su familia. Las despalilladoras retiraban a mano el tallo natural de las hojas de tabaco para hacerlas más fáciles y agradables como cigarros. No hubo ni hay trabajo más sencillo y humilde en la industria tabacalera cubana que el de despalilladora.

Julia se volvió a casar con el tiempo, tuvo dos hijos más y trabajó durante seis años en la misma fábrica de cigarros hasta que murió en su puesto de trabajo de un ataque cardíaco fatal causado por el esfuerzo.

Los siete hijos de Julia crecieron y se convirtieron en adultos útiles pero

humildes que también se casaron y tuvieron hijos propios, y a medida que lo hacían, el apellido de Julia retrocedió lenta pero seguramente en las identidades de sus descendientes, como lo hacen la mayoría de los apellidos. Su ADN se extendió y sobrevivió, pero no su apellido.

En el cementerio de Alquizar, a menos que el difunto o sus familias hayan comprado una parcela funeraria, los cuerpos de los pobres son exhumados dos años después de su fallecimiento y colocados en una tumba abierta grande y profunda donde sus huesos y los de cientos o tal vez miles de personas no identificables descansan hasta el infinito. Julia se unió a ese grupo anónimo. Se podía identificar y extraer el apellido Rizo a partir de los nombres legales de algunos de sus descendientes, pero era imposible desenterrar sus restos de la fosa común.

Este noviembre, ya sea en el "Día de Muertos" o en el "Día de Acción de Gracias", estoy recordando el nombre de Julia Rizo porque era una abuela que nunca conocí. Sé que todavía llevo algo de su ADN y su apellido muy abajo en la lista, y estoy seguro de que ella no tendría ningún problema con mi vida.

El día que subí al podio en mi primera clase como docente universitario y más tarde cuando publiqué mis cincuenta y seis libros en Amazon, ya le estaba dando a ella las gracias por la humilde vida que tenía antes que la mía. Mis manos se sintieron calientes. Tengo la sensación de que fue causado por el efecto heredado de los tallos del tabaco. Tenía que serlo. No podría haberlo hecho sin él.

Y esa es mi nota de agradecimiento en este mes de recuerdo.

# Thanking the Living and the Dead this month

November is for me, as it could be for some of you, a month full of important dates, both at the personal and general level. My father died in November of 1995; three of my grandchildren were born in late November of various years and it was in November many years ago that my wife and I tied the marriage knot.

As for the general level category, "The Day of the Dead" in Mexico and "Thanksgiving" in this country are sufficient evidence that would prove my point of view and end my article here, but, of course, you know I don't let my readers off so easily.

In the late nineteen and early twentieth centuries, there was a woman called Julia Rizo who lived an inconsequential life in a similarly unimportant Cuban town near Havana named Alquizar. She had five young children and one day she lost her husband, some reporting that he had suffered a heart attack, others that he had simply abandoned her.

Julia, not an educated person, decided to work for a living in a cigar manufacturing company as a destemmer to support her family. Destemmers remove by hand the natural stem of the tobacco leaves in order to make them more easily and enjoyable as cigars. There was not or is any simpler and more humble job in the Cuban tobacco industry than the one of a destemmer.

Julia remarried eventually, had two more children, and worked for six years in the same cigar factory until she died at her workstation from a fatal heart attack caused by exertion.

Julia's seven children grew up and

became useful but humble adults who also married and had children of their own, and as they did, Julia's surname receded slowly but surely in her descendants' identities as most surnames do. Her DNA spread and survived, but not her last name.

In Alquizar's cemetery, unless the deceased or their families had purchased a burial plot, the bodies of the poor are exhumed two years after their passing and placed in a large and deep open grave where their bones and the ones of hundreds or perhaps thousands of unidentifiable others rest for infinity. Julia joined that anonymous group. You could identify and dig the Rizo last name from some of her descendants' legal names, but it was impossible to dig her remains from her common grave.

This November, whether on the "Day of the Dead", or "Thanksgiving Day", I am remembering Julia Rizo's name because she was a grandmother I never met. I know I still carry some of her DNA and her last name far down the list, and I am sure she wouldn't have any problem with my life.

The day I climbed the podium in my first class as a university faculty member and later published fifty-six books at Amazon, I was already giving her my thanks for her humble life before me. My hands felt warm. I get the feeling that it was caused by the inherited effect of tobacco stems. It had to be. I couldn't have done it without it.

And that is my thank you note this month of remembrance.

So Long.

ever have to choose between paying for rent and utilities or putting food on their table."



# IRS:Cuidado con organizaciones benéficas falsas; verifique antes de donar

WASHINGTON - Con las trágicas crisis y los desastres naturales que ocurren alrededor del globo, el Servicio de Impuestos Internos advirtió hoy a los contribuyentes que tengan cuidado con criminales que solicitan donaciones y se hacen pasar falsamente por organizaciones benéficas legítimas. Cuando las organizaciones benéficas falsas estafan a donantes desprevenidos, las donaciones no van a quienes necesitan la ayuda y aquellos que contribuyeron a estas organizaciones benéficas falsas no pueden deducir sus donaciones en su declaración de impuestos.

"Todos queremos ayudar a las víctimas inocentes y a sus familias," declaró el comisionado del IRS Danny Werfel. "Sabiendo que estamos tratando de ayudar a los que sufren, los delincuentes salen de la nada para aprovecharse de los más vulnerables - las personas que simplemente quieren ayudar. Especialmente en estos tiempos difíciles, no se sienta presionado a donar inmediatamente a una organización benéfica de la que nunca ha oído hablar. Investigue primero la organización benéfica y confirme que es auténtica."

Quienes deseen donar deben usar la herramienta Búsqueda de Organizaciones Exentas de Impuestos (en inglés) o TEOS por sus siglas en inglés, en IRS.gov para encontrar o verificar organizaciones benéficas legítimas y calificadas.

## Con TEOS, las personas pueden

- Verificar la legitimidad de una organización benéfica.
- Comprobar su elegibilidad para recibir contribuciones caritativas deducibles de impuestos.
- Buscar información acerca del estado de la exención tributaria de una organización y sus declaraciones de impuestos.

Además, el IRS insta a cualquier persona que se cruce con una organización benéfica falsa o sospechosa a consultar los recursos del FBI sobre fraudes de organizaciones benéficas y desastres (en inglés).

## Organizaciones benéficas falsas

Los criminales suelen crear organizaciones benéficas falsas para aprovecharse de la generosidad del público durante crisis internacionales o desastres

naturales. Típicamente, buscan dinero e información personal, que puede usarse para explotar aún más a las víctimas mediante el robo de identidad.

Los promotores de organizaciones benéficas falsas pueden usar correos electrónicos, sitios web falsos o alterar o "falsificar" su identificador de llamadas para que parezca que es una organización benéfica real la que llama para solicitar donativos. Los delincuentes suelen dirigirse a personas mayores y a grupos con un dominio limitado del inglés.


A continuación, algunos consejos para protegerse de las estafas relacionadas con organizaciones benéficas falsas:

- Verifique primero. Los estafadores suelen usar nombres que suenan a organizaciones benéficas conocidas para confundir a la gente. Los donantes deben pedir al recaudador de fondos el nombre exacto de la organización, el sitio web y la dirección postal para poder confirmar la información de manera independiente. Use el sistema TEOS para verificar si una organización es una organización benéfica legítima exenta de impuestos.
- No ceda a las presiones. Los estafadores suelen presionar a la gente para que realice un pago inmediato. Por el contrario, las organizaciones benéficas legítimas están encantadas de recibir una donación en cualquier momento. Los donantes no deben sentirse presionados.

- No dé más de lo necesario. Los estafadores están a la caza tanto de dinero como de información personal. Los contribuyentes deben tratar la información personal como si fuera dinero en efectivo y no dársela a cualquiera.

• Desconfíe de cómo se solicita una donación. No colabore nunca con organizaciones benéficas que soliciten donativos pidiéndoles números de una tarjeta regalo o por transferencia de dinero. Es una estafa. Lo más seguro es pagar con tarjeta de crédito o cheque, y sólo después de verificar que la organización benéfica es real.

Los contribuyentes que donan dinero o bienes a una organización benéfica pueden reclamar una deducción (en inglés) si detallan las deducciones, pero estas donaciones sólo cuentan si van a una organización reconocida por el IRS.

# From My Corner

## More about the elections

Last week, I made mention of how poorly educated people are when it comes to selecting our representatives. There is a lot of work to be done when it comes to civics education and teaching people how to judge candidates.

In a community where most people never watch a city council meeting (or their committees), we don't have radio newscasts explaining their actions and decisions. As a result, everything tends to be distorted depending on who is talking about it and how they are personally affected by it.

There's a common impression that their job is approving handicap parking or STOP signs and they seldom have to deal with unions, building constructions, and employment issues. The reality is that councilors create the rules in the city, just like our representatives and senators do for the state.

They also must face emergencies and big-ticket needs and fight to get those things done. In the end, they hold the purse and protect our tax base. That's the part of the job that requires most of their time in searching and investigating, resulting in only the interested parties doing all the work. When they go before the rest of the membership, they explain it and educate them and they vote on the issue.

That's why it's so unfair when certain people use social media to denigrate the actions of any of them. Very often, they confuse their activities with neighborhood organizations or work with that of the city council. María De La Cruz was very active in her District A with the neighborhood association but that had nothing to do with her council responsibilities.

I wrote last week about Celina Reyes being phony writing on her political cards about her work with daycare providers getting more children into programs and better salaries to the workers. Well, she is a provider herself and it was part of her job when she was employed by Lawrence CommunityWorks.

Celina had absolutely nothing to write on her political propaganda. Her brain was someplace else during the meetings because she had nothing to contribute. Yet, she was the second vote-getter.

If I'm going to use Celina as an example, I have to follow with Ana Levy who came third as Councilor at-Large.

I met Ana in the mid-nineties when



she was very involved with the youth groups and with the Justice Department writing articles about her work for Boston newspapers. Her efforts to educate this community and make them advance by imparting knowledge attracted me immediately because there are not too many people willing to give so much of themselves.

Even without holding public office, she brought the Department of Justice to watch the elections in Lawrence, something no one else had tried. As time went by, she became involved in politics putting the same effort on everything she tackles.

That's why it infuriates me to hear the criticisms that Ana is always looking for photo-ops and she is everywhere. Contrary to other councilors who have a full-time job, she is retired and can afford the time to attend events and be in touch with people more than the others.

Just take a look at some of her recent accomplishments:

- She fought to buy new voting machines because the old ones were obsolete, breaking down constantly;
- Sponsored the ordinance regarding commercial vehicles and commercial overnight parking;
- Parking for recreational motorized vehicles- Registered and unregistered;
- Increased the salaries paid to Election workers by 20% and 30% for Inspectors, Clerks, and Wardens;
- Most recently, Ana undertook the replacement of all the television equipment at City Hall; from cameras,

microphones, videotaping equipment, etc. that were obsolete, and we were unable to watch the council meetings due to the mismanagement of Lawrence Community Access Television (LCAT). And she has been the only councilor to fight and represent the interests of Lawrencians when it comes to that;

- Furthermore, Councilor Levy contacted State Auditor Diana DiZoglio to request an audit of LCAT which was approved by the council and the mayor;
- Last summer, she petitioned the council for the official naming of the Nunzio DiMarca Park and it was unanimously approved.

Those are just a few things that come to mind right now. Saying that she is only looking for "photo-ops" is just a display of the ignorance of the speaker.

You might ask why I didn't say anything before the elections. I would have been dragged through the mud. Other members of the council work hard for our benefit and to highlight the good name of our city but they don't need my goodwill because they are not maligned in the same way.

One last note, before you go on an ignorant rant, do your homework.

Mayor DePeña announced that as part of the recovery efforts from the pandemic, on Thursday, November 16th, he will be providing full Thanksgiving Dinners to the first 100 Lawrence residents.



## Sanchez named Region 21 Player of the Year, four Knights named volleyball All-Region

Haverhill, MA (November 2, 2023) – In advance of the NJCAA Volleyball National Championship tournament beginning next week in Cedar Rapids, IA four members of the Northern Essex Community College women's volleyball team have been named to the All-Region teams.

Highlighted by Vielka Sanchez's (Lawrence) selection as the Region 21 Player of the Year, she was joined on the All-Region First Team by Abigail Heredia (Lawrence) and Maria Reyes (Lawrence). Chantel Melgen (Lawrence) was named to the second team.

Sanchez who currently ranks second in the nation with 1.87 service aces per set has also dished out 318 assists of the Knights region high 630 on the season using a two setter rotation. Sanchez served up a season high 17 aces in a September 16th match against Quinsigamond and recorded 10 or more aces on five different occasions on the season.

Heredia currently ranks second in the

nation in hitting percentage at .421 and has 236 kills which led all of Region 21 and was second in the region with 3.42 kills per set.

Reyes earned the Knights third spot on the first team for her two way play at the net. Her strong play has accounted for 1.55 digs per set and .67 service aces per set.

Melgen, the Knights defensive leader, has picked up 181 digs on the season which was good for fourth in the region. She had only 20 receiving errors in 297 attempts good for a 93% receiving percentage.

Following their first Region 21 championship since 2018, the Knights will make the programs first ever trip to the NJCAA National Championships next week. The action starts on Thursday November 9th where the 14th seeded Knights will take on the #3 seeded Century College (MN) Wood Ducks in the tournaments opening match at 10:00amET from the Alliant Energy Powerhouse Area in Cedar Rapids, IA.
