La legislación anti-inmigrante solo beneficia a la industria de las prisiones privadas

Sulma Arias es directora ejecutiva de People's Action, una red de grupos de base que trabajan para la justicia económica y social, con más de un millón de miembros en 30 estados.

H.R. 29, conocida como el proyecto de ley Laken Riley, es un ataque a las protecciones legales que socava nuestros derechos para enriquecer a los empresarios e inversores.

Estás leyendo las palabras de una inmigrante quien vino a este país sin documentos.

Cuando hui de El Salvador hace cuatro décadas, tenía 12 años y estaba sola. Buscaba refugio de la guerra civil en mi país natal, donde los escuadrones de la muerte respaldados por Estados Unidos habían convertido los asesinatos y las violaciones en nuestra realidad cotidiana.

Me reuní con mis hermanas, mi única familia sobreviviente, en Wichita, Kansas. Una vez aquí, ayudé a abrir iglesias, puse en marcha empresas y crié a mis tres hijas. Hubo momentos en que no estaba segura de que llegaríamos a fin de mes, pero estaba agradecida por la sensación de paz y seguridad que logramos crear aquí.

Por eso me preocupa tanto que el nuevo Congreso, liderado por los republicanos, haya decidido iniciar su labor con un proyecto de ley, el H.R. 29, que infunde miedo en los corazones de las familias inmigrantes de todo el país. Este proyecto de ley privará a los jueces de su discreción y exigirá que los inmigrantes fueran detenidos y sujetos a deportación si son acusados (ni siquiera condenados) de delitos menores.

El H.R. 29 es un ataque masivo a nuestro debido proceso legal. No garantizará la seguridad de nadie, sino que aterroriza a todos los inmigrantes de este país, que, según los estudios, tienen muchas menos probabilidades de cometer delitos de cualquier tipo que los estadounidenses que nacen aquí.

Entonces, ¿quién se beneficiará con la ley H.R. 29? Empresas como CoreCivic y GEO Group, que hicieron un gran negocio durante la última administración Trump administrando prisiones privadas para el Servicio de Inmigración y Control de Aduanas (ICE).

CoreCivic y GEO mantuvieron a inmigrantes y solicitantes de asilo en condiciones inhumanas, malsanas y tóxicas, y expusieron a mujeres y niños a asaltos sexuales. Con esta nueva ley, los ejecutivos cínicos de estas empresas quieren desviar más dinero del tesoro público, para que los inversores ricos obtengan más beneficios por abusar y demonizar a las personas que buscan refugio de la violencia o la pobreza.

Cuando Trump ganó, las acciones de estas empresas se dispararon. ¿Por qué? Porque los inversores esperan ganar una fortuna deteniendo a inmigrantes. Más del 90 por ciento de los inmigrantes detenidos por el ICE terminan en instalaciones con fines de lucro.

GEO Group, que donó el máximo legal en contribuciones a la campaña de Trump, dijo a sus inversores que podrían ganar casi 400 millones de dólares al año si respaldan “las necesidades futuras del ICE y del gobierno federal” en un segundo mandato de Trump. El precio de sus acciones casi se duplicó en noviembre.

Independientemente de que los detenidos sean culpables o no, CoreCivic y GEO reciben sus ganancias. Para eso está la ley H.R. 29: para fomentar la codicia corporativa, no para proteger a las personas.

Todos tenemos interés en impedir que las empresas penitenciarias como CoreCivic y GEO adquieran más poder, independientemente de nuestro idioma, raza, género o comunidad. Además de encarcelar a inmigrantes, estas empresas privadas también buscan nuevas formas de encarcelar a los ciudadanos para poder ganar aún más dinero.

Si es que permitimos que nos quiten derechos fundamentales de esta forma, disminuimos nuestra humanidad, tanto como los derechos y libertades de todos.

Los que están detrás de la ley H.R. 29 quieren que tengamos miedo unos de otros para que no nos unamos. Quieren poder entrar a la fuerza en nuestros hogares, escuelas e iglesias para llevarse a nuestros vecinos y seres queridos. Quieren que los trabajadores tengan demasiado miedo como para hacer frente a los abusos de sus jefes. Todo para que sus donantes en la industria de las prisiones privadas puedan ganar más dinero.

Los demócratas tendrán que encontrar su camino en este nuevo Congreso. No es la manera correcta de hacerlo alinearse con los nativistas que reciben millones en contribuciones de campaña de la industria de prisiones privadas.

Exigimos algo mejor para nuestro país. Queremos un liderazgo auténtico con una visión afirmativa del futuro con dignidad con todas las personas, incluidos los inmigrantes.

La ley H.R. 29 ataca a comunidades enteras por el idioma que hablamos y el color de nuestra piel. En cambio, nuestros líderes electos, independientemente del partido, deben trabajar para abordar las necesidades de las personas mediante la construcción de una economía que funcione para todos nosotros, no solo para unos pocos ricos.



El Informe de Bennett

Esta noche, 22 de enero, habrá una reunión para discutir la investigación sobre el jefe interino de policía William Castro, convocada a una Reunión Pública Especial del Concejo Municipal de Lawrence, que es todo menos pública.

Fue convocada por el presidente del Concejo Jeovanny Rodríguez y la vicepresidenta Stephany Infante para la "Revisión y Discusión del Informe Bennett de octubre de 2024 e Investigaciones Relacionadas". No habrá una sección de Participación Pública ni comunicaciones del alcalde.

La reunión será a puerta cerrada cuando regresen, y solo los medios de comunicación de su elección escucharán su versión.

Desde que se hizo público el "Informe Bennett", despertó muchas críticas en las redes sociales, el 99% negativas hacia el alcalde y el jefe Castro. Aun así, estoy dispuesta a apostar que el 90% de ellos, incluidos los miembros del Concejo Municipal, no lo han leído. Lo digo porque estoy en proceso de leerlo. La mayoría de la gente sabe leer, pero no tiene comprensión lectora. Este informe no es fácil de entender, tiene 83 páginas y está lleno de terminología legal que no estamos acostumbrados a leer. Ha sido difícil para mí y aún no lo he terminado. Pero he comprendido que la mayoría de las personas no saben leer. Sí, leen palabras y si alguien les pregunta qué aprendieron, solo pueden responder que Castro debería quedar fuera.

Para poder entender algunas de las afirmaciones, tuve que consultar el folleto policial del Departamento de Policía de Lawrence, en particular lo que dice sobre la "política de persecución".

En primer lugar, el informe está incompleto porque el objetivo principal era investigar a todos los involucrados en la persecución y las acciones del jefe Castro, y no fue entrevistado. Cuando Bennett envió un correo electrónico al abogado de Castro para programar una entrevista, el abogado de Castro tuvo un conflicto y pidió reprogramarla. Sin proporcionar otro día para realizar la entrevista, Bennett terminó su informe y lo envió al abogado de la ciudad, al teniente Rossi y al POST.

Espero que la ciudad demande a Comprehensive Investigations and Consulting (CIC) por un trabajo incompleto y reembolse los \$50,000 que recibió la

empresa. Lo que pone en duda cómo no se le permitió al alcalde la oportunidad de examinar el informe antes de que se enviara incompleto.

En otra nota, el alcalde DePeña no pidió recomendaciones. Solo quería los resultados de su investigación, al igual que se han hecho todas las demás investigaciones. Las recomendaciones se harán a nivel local.

Justo en la página 4, hay una cita de un correo electrónico de Octavien Spanner: "Detener la investigación", no terminar. Luego, en la página 7, hay una contradicción de lo anterior. Dice "cesar la investigación" cuando el correo electrónico no lo decía. Es justo decir que el informe de Bennett tiene más preguntas que respuestas.

El sargento Michael Simard le dijo al CIC que no está permitido que un oficial de policía conduzca por una acera para seguir a un automóvil. El investigador le pidió a Simard una copia de la Política de Persecución, pero nunca la recibió. La política no dice eso.

Según el informe, Simard dijo que la política del Departamento de Policía de Lawrence exige alertar al despacho y al OIC si se lleva a cabo una persecución, pero la política no dice eso.

También con aviso, el alcalde solicitó que se le enviara el informe una vez que estuviera terminado. En cambio, este informe inacabado, plagado de imprecisiones y sugerencias no solicitadas, se envió a varias personas, incluido el teniente Paul Rossi, la Comisión POST y el jefe del sindicato de policía, que son el sargento Michael Simard y el detective Paul MacMillan.

Seguiré leyendo para descubrir más discrepancias e informaré lo antes posible. Una recomendación que me gustaría hacer al público es que no se dejen llevar por los fanáticos o las personas que tienen un interés particular en este tema. Analicen lo que leen y saquen sus propias conclusiones porque seguir la opinión de personas mal inspiradas o simplemente ignorantes es muy peligroso.

Trump quiere eliminar la "ciudadanía por derecho de nacimiento"

Recientemente, escribí sobre los planes para eliminar la ciudadanía estadounidense a las personas nacidas en este país de padres que no están aquí como residentes permanentes o ciudadanos.

Durante décadas, un niño nacido en los Estados Unidos, incluso si la madre estaba aquí como turista, su recién nacido era considerado ciudadano o ciudadano por derecho de nacimiento. Cumpliendo su promesa, el lunes, después de su toma de posesión, el presidente Trump firmó una orden ejecutiva que inicia la larga lucha para analizar la 14^a Enmienda que protege a esos ciudadanos.

Al día siguiente, 18 estados planeaban emprender acciones legales contra ese mandato, incluido Massachusetts. La fiscal general de Massachusetts, Andrea Campbell, se presentó ante el Tribunal de Distrito de los Estados Unidos para el Distrito de Massachusetts pidiendo al tribunal que invalide la orden y bloquee cualquier acción para implementarla.

En una declaración, Campbell argumentó que la orden de Trump negaría la ciudadanía y todos los privilegios asociados a más de 150.000 niños nacidos cada año en los Estados Unidos. Además,

los estados argumentan que la orden les exigiría modificar el funcionamiento y la administración de los programas de beneficios. "El presidente Trump no tiene la autoridad para quitar derechos constitucionales, y lucharemos contra su intento de anular nuestra Constitución y castigar a los bebés inocentes nacidos en Massachusetts", dijo Campbell.

La ciudadanía por derecho de nacimiento significa que cualquier persona nacida en los EE. UU. es ciudadana, independientemente del estatus migratorio de sus padres. Por ejemplo, las personas que están en los Estados Unidos con una visa de turista o de otro tipo o que se encuentran en el país ilegalmente pueden convertirse en padres de un ciudadano si su hijo nace aquí.

La semana que viene, compartiré una historia de cómo comenzó y se convirtió en la norma. Trump y sus aliados cuestionan la interpretación de la 14.^a Enmienda y dicen que deben existir normas más estrictas para convertirse en ciudadano.

ReStore de Habitat for Humanity:

Apoya la vivienda asequible en el Condado de Essex (¡y es muy divertido para los buscadores de tesoros!)

El ReStore de Habitat for Humanity en Lawrence es una triple victoria para la comunidad: los muebles se pueden reciclar y evitar que terminen en los vertederos, los consumidores tienen un recurso para artículos usados de calidad y financia el importante trabajo de construir viviendas asequibles en el condado de Essex.

Comprar en un ReStore de Habitat no es como una experiencia de compra en cualquier otro lugar. Mitad tienda de mejoras para el hogar, mitad tienda de artículos para el hogar, mitad tienda de reventa, cada ReStore tiene una amplia selección que cambia a menudo. La parte divertida es que a veces es como una búsqueda del tesoro: nunca se sabe lo que encontrará. "A muchas personas les gusta ir a la búsqueda del tesoro", dijo Jim Kapelson, director del ReStore.

"Tenemos la suerte de estar rodeados por una comunidad muy generosa. Brindamos servicio en todo el condado de Essex, en las 34 ciudades y pueblos. Ofrecemos la recogida de muebles y materiales de construcción, si es necesario. "Tenemos un camión que sale cinco días a la semana y recoge de tres a cinco donaciones de donantes cada día", dijo. ReStore también está abierto para donaciones durante el horario comercial. Son particulares en lo que aceptan. "Hacemos nuestra pequeña parte para hacer todo lo posible para aceptar cosas que sabemos que la gente disfrutará y que se pueden usar y comprar a un precio muy asequible. Es una sensación agradable que las cosas no se tiren a la basura. Estamos ayudando a aliviar parte de los desechos que son tan frecuentes en nuestra sociedad. Aceptamos artículos relacionados con los hogares. Podemos aceptar electrodomésticos, ventanas, puertas, hardware, herramientas, muebles (sofás, sillas, mesas de comedor). No aceptamos materiales de cama, colchones o somieres, muebles para niños (sillas altas, por ejemplo). Debemos preocuparnos por la seguridad. No aceptamos asientos de automóvil ni pintura ni productos químicos de ningún tipo", dijo.

"Para mí, nuestra misión es integrarnos realmente en la comunidad, ser un recurso y, a su vez, brindar servicios y productos a quienes los necesitan. "Ofrecemos artículos de buena calidad que se pueden comprar a un precio excelente y apoyamos la vivienda asequible", dijo Jim. "Somos la tienda que construye viviendas asequibles. Las ganancias de nuestra tienda ayudan a financiar la construcción de viviendas en nuestra área de servicio del condado de Essex. Habitat for Humanity's ReStore: Supporting Affordable Housing in Essex County (and great fun for treasure hunters!)

The Habitat for Humanity ReStore in Lawrence is a triple win for the community: furniture can be recycled and kept out of landfills, consumers have a resource for quality pre-owned goods, and it funds the important work in building affordable housing in Essex County.

Shopping at a Habitat ReStore isn't like a shopping experience anywhere else. Part home improvement store, part home goods store, part resale store, each ReStore has a wide selection that changes often. The fun part is it's sometimes like a treasure hunt: you never know what you will find. "A lot of people like to go on the treasure hunt," said Jim Kapelson, Director of the ReStore.

"We are fortunate to be surrounded by a very giving community. We service all of Essex County, all 34 cities and towns. We offer pick-up of furniture and building materials, if needed. We have a box truck that is out five days a week picking up three to five donations from donors every day," he said. The ReStore is also open for donations during business hours. They are particular in what they accept. "We do our small part to do our level best to accept things that we know people will enjoy and can be used that can be purchased at a very affordable price. It's a feel good that things aren't just getting thrown away. We are helping to alleviate some of the waste that is so prevalent in our society. We take items related to homes. We can take appliances, windows, doors, hardware, tools, furniture (couches, chairs, dining tables). We do not take bedding materials, mattresses or box springs, children's furniture (highchairs, for example). We must be concerned with safety. We don't take car seats or paint or chemicals of any sort," he said.

"For me, our mission is to really integrate ourselves into the community, to be a resource, and in turn provide services and products to those who need them. We provide good quality items that can be purchased for a great value and support affordable housing," Jim said. "We're the store that builds affordable homes. Proceeds from our store help fund building houses in our Essex County service area. Our main function is to take donations related to homes, including building materials, furniture, appliances and housewares, etc., and sell them to support our home building and home repair efforts. We turn over inventory very quickly. If you see something

you like, buy it! Don't hesitate. It probably won't be there when you return."

In addition to selling pre-owned items, the store sells new paint including wall paint and house paint. There is also a full line of new waterproof laminate flooring. "We also offer a cabinet deconstruction program for those remodeling. We will come to your home or business and carefully remove cabinets and transport them to our store for resale," Jim said.

The store is supported by a staff team of eight people and approximately three dozen volunteers who help with receiving inventory, pricing merchandise, answering shoppers' questions on the sales floor, and helping to keep the facility clean. They also partner with American Training and Opportunity Works, local non-profits whose missions are to empower people with diverse abilities to gain experience in the workplace.

When asked what he is most proud of at the ReStore, Jim said, "I'm most proud of our staff team here. They are here because they believe in what we are doing. They have helped me and helped our organization do better. I'm really pleased and happy with our staff.

Whether you are a do-it-yourselfer, homeowner, renter, landlord, contractor, interior designer, environmentalist or treasure hunter, make Habitat for Humanity ReStore in Lawrence your first stop when shopping for your next home improvement, renovation or DIY project. Governor Healey Signs Laws Lowering Health Care Costs and Strengthening Oversight

New laws cap prescription drug copays at \$25, improve access to primary care and close regulatory gaps exploited by Steward Health Care

BOSTON – Governor Maura Healey today signed into law S.3012 An Act relative to pharmaceutical access, costs, and transparency and H.5159 An Act enhancing the market review process. The laws seek to lower health care costs, cap prescription drug costs at \$25, improve access to primary care and increase oversight of the health care industry to protect patients and providers.

"We know that one of the biggest strains on Massachusetts family's budgets is the high health care costs. These new laws will lower out-of-pocket costs by capping copays at \$25 for lifesaving prescription medications and increasing transparency in the industry," said Governor Maura Healey. "They also close loopholes in our regulatory processes so that for-profit providers like Steward Health Care are subject to the same transparency rules as non-profit providers. As Attorney General, I spent years in court trying to hold Steward to this standard, and I'm glad that our laws will no longer be exploited in this way. I'm grateful for the strong leadership of Speaker Ron Mariano, Senate President Karen Spilka, and the Legislature for advancing these bills that will strengthen our health care system, lower costs, and protect patients and providers."

"Massachusetts is proud to be a global leader in health care and life sciences innovation. Together, these laws further increase our ability to deliver world-class medical care that patients can afford and empower government to hold the health care industry accountable to the people," said Lieutenant Governor Kim Driscoll. "We appreciate the partnership of the Legislature, as well as all of the health care leaders, providers and patients who made their voices heard throughout this process."

"The bills signed by Governor Healey today represent the Legislature's enduring commitment to protecting patients, bringing down cost growth, and to fostering greater stability and accountability within the health care system," said House Speaker Ronald J. Mariano (D-Quincy). "Before Steward Health Care ultimately collapsed, executives spent years hiding their financial information from state regulators, putting patients and our health care system at risk. That's why ensuring that our institutions are equipped to monitor the health care landscape, and to guard against trends and transactions that drive up costs without improving patient outcomes, is so important. I would like to thank Chairman Lawn and our partners in the Senate for getting these bills across the finish line and marking the end of an incredibly productive legislative session."

"Because of our actions today, thousands of residents will pay less at the pharmacy counter, and communities across the state will be more protected from the high costs of private equity mismanagement," said Senate President Karen E. Spilka (D-Ashland). "With the Governor's signature on these two bills, we are doubling down on our global leadership in health care and making sure that in Massachusetts, patients are put before profits. I am grateful for Governor Healey's signature, the tireless and unwavering work of Senator Friedman, my colleagues in the Senate, and our partners in the House for getting these bills across the finish line."

An Act relative to pharmaceutical

access, costs and transparency includes comprehensive reforms to lower the cost of prescription drugs and improve oversight of the pharmaceutical industry. Notably, it requires insurers to eliminate cost-sharing requirements for one generic drug and to cap co-payments on one brand-name drug at \$25 per 30-day supply for diabetes, asthma, and certain heart conditions. It also ensures that consumers are not charged a co-pay if it would be cheaper for them to purchase a drug without using their insurance, and it requires insurers to provide continuity of coverage for new members' existing prescriptions when they switch to a new plan.

An Act enhancing the market review process seeks to close loopholes in the health care market regulatory process. It expands the scope of data collection and public review of health care and health care transactions by the Health Policy Commission (HPC) and the Center for Health Analysis and Information (CHIA), with the goal of increasing visibility and accountability for transactions involving private owners of health care resources. This will help to close gaps in oversight that were exploited for years by Steward Health Care and Ralph de la Torre. For example, it prohibits DPH from issuing hospital licenses to hospitals or systems where the main acute care campus is on Real Estate Investment Trust (REIT)-owned property. It also seeks to increase transparency around health care entities and their ownership, including more rigorous data sharing requirements and expanding participation in regulatory process to nontraditional healthcare entities.

The bill also includes a provision establishing a primary care task force, co-chaired by Health and Human Services Secretary Kate Walsh and the Executive Director of the HPC. The task force will study primary care access, delivery and payment, and develop recommendations to stabilize and strengthen the primary care system, increase recruitment, and increase financial investment and patient access.

"These laws are an important step toward transparency and accountability for our health care system, and making medications more affordable," said Health and Human Services Secretary Kate Walsh. "We know primary care access is a critical component of health equity, so I'm especially looking forward to the commitment of strengthening our primary care system to help more people in Massachusetts live healthy lives."

"As someone who represents communities within the Merrimack Valley that were impacted by Steward's closure, I am grateful that this historic legislation was passed by the Legislature. These two critical pieces of legislation will positively impact every resident in Massachusetts by making life-saving and essential prescription drugs more affordable for all residents, while also working to ensure that another Steward Health Care situation is never allowed to happen again in Massachusetts," said Second Assistant Majority Leader Frank A. Moran (D-Lawrence). "I would like to thank Governor Healey, Lieutenant Governor Driscoll, Speaker Mariano, Senate President Spilka, House Chair Lawn, and Senate Chair Friedman for their steadfast leadership in making this legislation a priority this session."



Knights avenge lone conference loss with 99-61 rout of Bristol

Haverhill, MA (January 21, 2025) – The #8 nationally ranked Northern Essex men's basketball team picked up their 15th straight win of the season and their 42nd straight home as they improved to 17-2 overall and 12-1 in conference play with 99-61 rout of Bristol and in the process avenged their lone conference loss on the season.

The Knights slowly opened the advantage in the game's first half before taking a 20 point lead into the locker room at halftime at 49-29, before outscoring the Bayhawks by a 50-32 total in the second half.

Alejandro Delgado (Haverhill) scored a game high 23 points to go along with 10

rebounds for a double-double effort.

Javien Kirmil (Lowell) and Alex Johnson (Worcester) joined Delgado in double figures as they recorded 11 and 10 respectively.

Ryan Pacy (Salem, MA) had all around strong effort as he picked up five assists, to go along with four steals and six points.

The Knights will return to the court on Saturday when they play host to Community College of Rhode Island at 2:00pm in the second half of a men's and women's double header.

Men's Basketball, Baseball both ranked 8th nationally

Haverhill, MA (January 22, 2025) – With the basketball season heading toward the home stretch in the weeks ahead and baseball preparing for the spring season to kick off in March, both programs currently sit at eighth in their respective NJCAA national polls.

For the men's basketball team, they are ranked for the fourth consecutive poll and have climbed each of the past three weeks. The number eight ranking is their second straight week inside the top 10.

The Knights are currently winners of 15 straight games and have won 42 straight games on their home court, a streak dating back to the conclusion of the 2021-22 season.

The Knights have a pair of scorers averaging in double figures in Alejandro Delgado (Haverhill) and Javien Kirmil (Lowell) scoring 14.8 and 10.6 points a game respectively.

As a team, the Knights are scoring 86.2 points per game which ranks 12th nationally. Defensively, NECC is holding the opponent to 68 points per game which currently ranks eighth best in the nation.

Switching over to the baseball diamond, NECC will be seeking a fourth consecutive trip to the NJCAA World Series in May as they earned a number eight preseason national ranking.

Set to open a 41-game schedule in March, including a 10-game trip to Florida, the Knights return a core nucleus from 2024 including five everyday positional players and three pitchers who pitched 18 innings or more a season ago.

Armano Paulino (Lawrence) returns after batting .352 last season and Michael Giessler (Peabody) expects to be at the top of rotation after throwing 41 innings on the hill last season.

A host of incoming freshman and transfers will look to make an immediate impact on the roster and add depth over the course of the season. Division I transfer Anthony Marino (Lynn) from the University of South Alabama is rejoining his high school teammate Giessler and the duo expect to lead the pitching staff in 2025.

Head Coach Jeff Mejia will enter the season with 297 career wins, all at Northern Essex.

Si no se diese esta búsqueda de equilibrio, tal vez la sociabilidad sería imposible, y los seres humanos se exterminarían unos a otros.

La paz resulta de la administración de los conflictos usando medios no conflictivos. En la construcción de la paz, los intereses colectivos deben sobreponerse a los individuales, la multiculturalidad ha de prevalecer sobre el etnocentrismo, la perspectiva global orientará la local.

Tenemos que ser realistas y sinceros. Hay violencia en el mundo porque yo llevo violencia dentro de mí en forma de rabia,

The challenge of violence

Frequent violence forces us to think. Why is it so recurrent? To see some light, we must start without self-deception from this fundamental ambiguity: on the one hand, reality is full of conflict, but in another sense, it is a fabric of order and peace. Neither of these two aspects succeeds in eradicating the other. They are mixed and maintained in a complex and dynamic equilibrium.

The art consists in maintaining this tension, seeking that convergence of energies that allows the emergence of peace, the fruit of minimally fair and inclusive institutions, and of healthy social arrangements guarded by a State that ensures the balance of tensions, legitimately using coercion when necessary. If this search for balance did not occur, sociability would be impossible, and human beings would exterminate each other.

Peace results from the management of conflicts using non-conflictive means. In peacebuilding, collective interests must prevail over individual interests, multiculturalism must prevail over ethnocentrism, and the global perspective will guide the local one. We have to be realistic and sincere. There is violence in the world because I carry violence within me in the form of rage, envy, and hatred, which I must always contain.

The explanation of aggression has challenged the most acute thinkers. Sigmund Freud starts by observing two basic drives: one that affirms and exalts life (Eros) and another that tends towards death (Thanatos) and its psychological derivatives, such as hatred and exclusion.

For Freud, aggression arises when the death instinct is activated by some threat that

comes from outside. Someone can threaten another and want to take his life. Then, the threatened person anticipates and attacks and eventually eliminates the person who threatens him.

Another contemporary thinker, René Girard, claims that aggression comes from the permanent rivalry that exists between human beings (which he calls "mimetic desire"). This rivalry creates permanent tensions and elaborates sinister complicities. Society makes him a scapegoat by concentrating all evil and all threats on someone. Everyone unites against him to get rid of him. This union establishes a momentary peace between all the contenders. Once the peace is destroyed, we must invent a new scapegoat (terrorists, drug dealers, etc.), and once again, everyone unites against him, and the lost peace is remade.

Anthropologists have also helped us to understand aggression. They assure us that we are simultaneously sapiens and demons, not because of degeneration but because of the evolutionary constitution. We are carriers of intelligence and inner energies oriented toward generosity, collaboration, and benevolence. And at the same time, we are carriers of madness, of excess, of death drives. We are tragic beings because we emerge as a coexistence of opposites.

Given this contradiction, how can we build peace? Peace will only triumph because people and communities are willing to cultivate cooperation, solidarity, and love as a life project. The culture of peace depends on the predominance of these positives and on the vigilance that people and institutions maintain over the other dimension, always present, of rivalry, selfishness, and exclusion.

Las Metáforas no Invitadas

Repetidamente, la vida nos ofrece ejemplos no solicitados de su fragilidad. Son momentos que no solo nos sorprenden, sino que nos confunden y desconciertan. Ya se trate de incidentes climáticos o de nuestras propias interacciones agresivas entre grupos, los resultados son los mismos: nada es como antes y no solo terminamos con la destrucción, sino también con una dura lección que nos enseñará cuán indefensos estamos realmente ante tales calamidades.

Los recientes incendios forestales destructivos en California son una excelente metáfora que podemos usar para evaluar nuestra existencia incluso si no estamos allí. Los árboles y arbustos que habían estado creciendo sin obstáculos durante siglos desaparecieron de la noche a la mañana. Casas de diferentes diseños arquitectónicos que albergaban tanto a ricos como a pobres se convirtieron en cenizas y sus ocupantes tuvieron que salir apresuradamente para evitar la muerte y luego no encontraron nada de valor cuando intentaron regresar. El concepto de "tabula rasa" puede aplicarse aquí.

Pero la metáfora cubre un amplio espectro más allá de California. Hubo millones de seres humanos en ciertos países, incluido el nuestro, antes y ahora, que hemos dejado atrás hogares, familias, cultura y posesiones para emigrar con nada más que un sueño y una bolsa al hombro, una ilusión de que las cosas mejorarán de

alguna manera. Huelga decir que se pagó un alto precio por la destrucción voluntaria de lo que había detrás y por la falta de reconocimiento positivo de las acciones que se tomaron.

No había fuego alimentado por los vientos detrás de nosotros cuando teníamos que movernos, pero el simbolismo era el mismo. En la historia de las civilizaciones, moverse de donde estamos es un comportamiento humano constante. Podrían haber sido las hordas que se desplazaban hacia el oeste desde África hacia las tierras europeas, los europeos que navegaban hacia América, los pueblos indígenas que cruzaban las tierras árticas hacia el este y el sur hasta nuestro continente. Quienes quiera que fueran, actuaron como víctimas de un incendio que consumió su pasado y los obligó a comenzar una nueva forma de vida.

Lo que nos lleva de nuevo al ejemplo de esta metáfora californiana. Los residentes de la Costa Oeste tienen que reconocer su tragedia y volver a encender sus motores. Ellos, y nosotros con simpatía, miraremos la lección enseñada por la destrucción de tantas vidas y seguiremos adelante de la misma manera que los millones de personas que lo hicieron anteriormente. Sobrevivieron; sus culturas finalmente también lo hicieron, y todos esperaron pacientemente cualquier nueva metáfora que la vida quisiera proporcionarles.

Y ese es mi punto de vista hoy. Agur.



5 COSAS QUE DEBE SABER CUANDO SU HIJO TIENE UNA INCAPACIDAD Y CUMPLE 18 AÑOS

Cuando su hijo cumple 18 años, se convierte legalmente en un adulto. Este es un momento importante para considerar su futuro financiero, especialmente si necesitan atención adicional hasta la edad adulta. Aquí hay 5 cosas que pueden ayudarle a prepararse para esta meta:

1. Tomar decisiones sobre la salud y el bienestar

Cuando su hijo se convierte legalmente en un adulto, usted ya no podrá tomar ciertas decisiones por él acerca de su salud y bienestar. Sin embargo, usted puede seguir participando a través del programa representante beneficiario. Infórmese en la página de internet www.ssa.gov/payee/index.htm (sólo en inglés). Tenga en cuenta que el Seguro Social no reconoce el poder notarial.

2. Cambios en la elegibilidad para Seguridad de Ingreso Suplementario (SSI)

Seguridad de Ingreso Suplementario (SSI, siglas en inglés) proporciona pagos mensuales a adultos y niños con incapacidades al igual que a personas de 65 años o más, que tienen escasos recursos o no tienen recursos financieros.

Si su hijo recibe SSI, cuando cumpla 18 años, revisaremos su elegibilidad para continuar recibiendo pagos de SSI según las reglas por incapacidad para adultos. Para informarse mejor, revise la publicación Lo que necesita saber del programa Seguridad de Ingreso Suplementario (SSI) cuando cumple 18 años en www.ssa.gov/pubs/ES-05-10915.pdf. Asegúrese de revisar esto con su niño. También le recomendamos que consulte la página Recursos del Seguro Social para jóvenes en www.segurosocial.gov/jovenes.

3. Transiciones educativas

Si su niño asiste a una escuela, tiene algunas opciones para continuar su educación, como por ejemplo:

- Un diploma: puede continuar su educación en programas universitarios o instituto politécnico con un Programa personalizado de educación (IEP, siglas en inglés). Más información sobre el IEP está disponible en www.ssa.gov/pubs/ES-64-118.pdf.

- Una certificación: Es posible que tengan la oportunidad de continuar en un programa de transición en su escuela preparatoria, incluso después de completar su último año. A la mayoría se les permite permanecer hasta que cumplan 22 años.

- Empleo: Los servicios locales de rehabilitación vocacional pueden ayudar con las opciones de empleo durante las reuniones del IEP previas a la graduación.

4. Apoyo para arreglos de vivienda

Una vez que su hijo cumpla 18 años,



podrá elegir o calificar para diferentes arreglos de vivienda dependiendo de los servicios que ya reciba. Si su hijo recibe servicios de terapia en la escuela, ¿cómo los recibirá una vez que se vaya? Podrían recibirlas a través de una exención de Medicaid o de un seguro privado.

El calificar para los servicios de relevo también puede verse diferente. Los servicios de relevo permiten que los cuidadores de las familias tengan tiempo para alejarse de sus obligaciones. Es esencial que comprenda todos los beneficios y opciones disponibles para su hijo después de completar la escuela preparatoria antes de decidir sobre los arreglos y servicios de vivienda.

5. Protección financiera

- Fideicomiso para necesidades especiales: actualice los documentos de planificación patrimonial antes de que su hijo cumpla 18 años. De lo contrario, la herencia puede cancelar los beneficios gubernamentales de su hijo.
- Cuenta ABLE (siglas en inglés): Puede depositar fondos en esta cuenta hasta un cierto límite cada año; sin embargo, existen límites en cuanto a lo que cubre su financiación. Más información sobre las cuentas ABLE está disponible en www.ssa.gov/payee/able_accounts.htm (sólo en inglés).

5 THINGS TO KNOW WHEN YOUR CHILD WITH DISABILITIES TURNS 18

When your child turns 18 years old, they legally become an adult. This is an important time to consider their financial future – especially if they need additional care into adulthood. Here are 5 things that may help you prepare for this milestone:

1. Health and Welfare Decision-making

When your child legally becomes an adult, you can no longer make certain decisions for them about their health and welfare. However, you can stay involved through our Representative Payee program. Social Security will determine who best serves as a representative payee for your child's benefits. To learn more about the Representative Payee program, read our webpage at www.ssa.gov/payee/index.htm. Please note Social Security does not recognize power of attorney.


2. Changes in Supplemental Security Income (SSI) Eligibility

SSI provides monthly payments to adults and children with disabilities, as well as people 65 and older, who have little or no income and resources. If your child receives SSI, when they turn 18 we will review their eligibility for continued SSI payments based on the disability rules for adults. For more information, please review the publication, What You Need To Know About Your Supplemental Security Income (SSI) When You Turn 18 at www.ssa.gov/pubs/EN-05-11005.pdf. Please be sure to review this with your child. We also encourage you to check out Social Security's Youth Toolkit webpage at www.ssa.gov/youth.

3. Education Transitions

If your child attends school, they have a few options to continue their education, such as pursuing:

- A diploma: They may pursue further education in college or trade programs with an Individualized Education Program (IEP). More information on the IEP is available at www.ssa.gov/pubs/EN-64-118.pdf.
- A certificate: They may have the opportunity to continue in a transitional program in their high school even after they complete their senior year. Most are permitted to remain until they turn 22.

- Employment: Local Vocational Rehabilitation Services can assist with employment options during pre-graduation IEP meetings.

4. Support for Living Arrangements

Once your child turns 18, they may choose or qualify for different living arrangements depending on the services they already receive. If your child receives therapy services at school, how will they receive them once they leave? They could receive them through a Medicaid waiver or private insurance.

Qualification for respite services may also look different. Respite services allow family caregivers time to step away from their duties. It is essential you understand all the benefits and options available to your child after they complete high school and before deciding on living arrangements and services.

5. Financial Protections

- Special Needs Trust: Update estate planning documents before your child turns 18. Otherwise, inheritance may terminate your child's governmental benefits.

- ABLE Account: You can deposit funds into this account up to a certain limit each year. However, there are limits on what its funding covers. More information on ABLE accounts is available at www.ssa.gov/payee/able_accounts.htm.

The Bennett Report

There will be a meeting tonight, January 22, to discuss the investigation on Acting Police Chief William Castro called a Special Public Meeting of the Lawrence City Council, which is anything but public.

It was called by Council President Jeovanny Rodriguez and Vice President Stephany Infante for "Review and Discussion of the October 2024 Bennett Report and Related Investigations. There will be no Public Participation section and no communications from the mayor.

The meeting will be closed when they return, and only the media of their choice will hear their version.

Since the "Bennett Report" was made public, it aroused many criticisms on social media, 99% negative towards the mayor and Chief Castro. Still, I am willing to bet that 90% of them, including members of the City Council, have not read it. I say that because I am in the process of reading it. Most people know how to read but have no reading comprehension.

This report is not easy to understand, it's 83 pages long and full of legal terminologies that we are not used to reading. It's been difficult for me, and I'm not finished with it. But I have comprehended that most people don't know how to read. Yes, they read words, and if anyone asks them what they learned, they can only answer that Castro should be left out.

To be able to grasp some of the statements, I needed to consult the Lawrence Police Department police booklet, particularly what it says about "pursuit policy."

First, the report is unfinished because the primary purpose was to investigate all of those involved in the pursuit and Chief Castro's actions, and he was not interviewed. When Bennett emailed Castro's attorney to set up an interview, Castro's attorney had a conflict and asked to reschedule. Without providing another day to conduct the interview, Bennett finished his report and forwarded it to the city attorney, Lt. Rossi and POST.

I hope the city sues Comprehensive Investigations and Consulting (CIC) for an incomplete job and refunds the \$50,000 the company received. Which brings into question how the mayor was not allowed the opportunity to examine the report before it was sent out incomplete.

On another note, Mayor DePeña did not ask for recommendations. He just wanted the results of his investigation, just like all other investigations have been done. The recommendations will be made at the local level.

Right on page 4, there's a quote from an email from Octavien Spanner: "To halt the investigation," not terminate. Then, on page 7, there's a contradiction of the above. It says to "cease the investigation" when the email didn't say that. It is fair to say that Bennett's report has more questions than answers.

Sgt. Michael Simard told the CIC that it is not permissible for a police officer to drive on a sidewalk to follow a car. The investigator asked Simard for a copy of the Pursuit Policy but never got it. The policy doesn't say that.

According to the report, Simard said that Lawrence Police Department policy requires to alert dispatch and the OIC if engaging in pursuit, but the policy doesn't say that.

Also on notice, the mayor requested the report to be sent to him upon completion. Instead, this unfinished report, plagued with inaccuracies and unrequested suggestions, was sent to several people, including Lt. Paul Rossi, the POST Commission and the head of the police union, which are Sgt. Michael Simard and Detective Paul MacMillan.

I will continue reading to discover more discrepancies and will be reporting as soon as possible. One recommendation I would like to make to the public is not to go along with the fanatics or people who have a particular interest in this issue. Analyze what you read and come to your own conclusion because following the opinion of ill inspired or just plain ignorant people is very dangerous.

Trump wants to remove "birthright citizenship"

Recently, I wrote about plans to remove United States citizenship from persons born in this country of parents who are not here as permanent residents or citizens.

For decades, a child born in the United States, even if the mother was here as a tourist, her newborn was considered a citizen or what they call birthright citizenship. Fulfilling his promise, on Monday, after his inauguration, President Trump signed an executive order initiating the long struggle to analyze the 14th Amendment protecting those citizens.

The next day, 18 states are planning to take legal action against that mandate and Massachusetts is one of them. Massachusetts Attorney General Andrea Campbell, went before the U.S. District Court for the District of Massachusetts. They are asking the court

to invalidate the order and block any actions taken to implement it.

In a statement, Campbell argued that Trump's order would withhold citizenship and all of the associated privileges from more than 150,000 children born every year in the United States. Additionally, the states argue the order would require them to modify the operation and administration of benefits programs.

"President Trump does not have the authority to take away constitutional rights, and we will fight against his effort to overturn our Constitution and punish innocent babies born in Massachusetts,"

Birthright citizenship means anyone born in the U.S. is a citizen, regardless of their parents' immigration status. People, for instance, in the United States on a tourist or other visa or in the country illegally can become the parents of a citizen if their child is born here.

Next week, I'll bring a story of how it began and how the 14th Amendment has been overlooked. Trump and allies dispute the reading of the amendment and say there need to be tougher standards on becoming a citizen.
