Commissioner builds consensus and elevates the voices of educators, students, and families most impacted. Puesto de Gestión de Emergencias

No todas las ciudades y pueblos de Massachusetts cuentan con un departamento dedicado a la Gestión de Emergencias, así que cuando la ciudad empezó a debatir el puesto, despertó mucho interés porque añadiría el gasto de un nuevo departamento (incluso si estuviera compuesto por una sola persona).

Acabábamos de pasar por las explosiones de gas y la pandemia de COVID-19, que revolucionaron la ciudad, y comencé a investigar. Para mi sorpresa, el jefe de bomberos era el responsable de la Gestión de Emergencias durante la dura prueba.

Al mismo tiempo, la ciudad empezó a considerar la posibilidad de contratar al agente de policía Abel Cano para encargarse de esas funciones. Posteriormente, publicamos una lista de ciudades con un responsable dedicado a ese puesto. En la mayoría de los lugares, la policía o los bomberos se encargan de las emergencias, y muy pocas comunidades asignan a una persona específica.

En Lawrence, el jefe de bomberos Brian Moriarty ejerció la Gestión de Emergencias durante muchos años y nunca cobró por ese trabajo. Cabe recordar que se

opuso abiertamente a este cambio ante el ayuntamiento. Abel Cano es un hombre y oficial decente, amigo de esta comunidad y una persona respetada, pero nunca ocupó ningún cargo en el departamento.

Octavien Spanner propuso el puesto de director de gestión de emergencias. La ciudad ya tenía el puesto establecido, pero estaba vacante porque nunca contrataron a nadie.

El alcalde sabía que Abel no tenía la certificación para el puesto, pero fue seleccionado personalmente para satisfacer a su amiga (esposa de Cano), la representante Estela Reyes. Tan pronto como Brian DePeña fue elegido alcalde de esta ciudad, ella insistió en que debía ascender a Cano a sargento, pero estaba muy abajo en la lista y no pudo ser.

Abel se matriculó en los cursos necesarios y trabajó para obtener su certificación, pagándola hasta que la obtuvo.

Este puesto paga \$110,000, que es aproximadamente el doble de lo que gana un oficial de policía, y está fuera del sindicato.

¿Qué tal si lo publican?

Ventas de la policía y la ciudad

Recuerdan cuando el departamento

de policía abrió el garaje para que el público pudiera explorar la mercancía robada recuperada durante las redadas? Había bicicletas para niños, computadoras, portátiles, muchas joyas, etc. Los residentes podían comprar esas cosas por muy poco dinero.

Eso fue hace muchos años, probablemente cerca de treinta, y nunca había oído hablar de otro.

También fui una vez al patio de la ciudad donde tenían escritorios, sillas de oficina, computadoras, impresoras, etc. A las computadoras les habían quitado la placa base, pero fue un gasto menor, y compré una impresora láser por \$10.

Cuando la ciudad renueva equipos o muebles al final de cada año escolar, camiones llenos salen de los edificios y nadie sabe dónde terminan. Esos artículos nos pertenecen a nosotros, los contribuyentes, y el público debería tener la oportunidad de comprarlos, pero ¿adónde van?

En el presupuesto, no anunciado

Tener puestos aprobados pero no cubiertos es una práctica común en esta ciudad. Ya vieron un ejemplo arriba, y hay

más. La ciudad contrató recientemente a Víctor E. Ortega, Director de Servicios para Veteranos, tras seis meses sin personal. Hay más de 2000 veteranos en Lawrence, jóvenes soldados que han regresado de conflictos mundiales, y hay mucho trabajo por hacer. Mientras tanto, ese departamento tiene dos puestos de asistente que aún no se han cubierto, pero que se ajustan al presupuesto.

¿Por qué lo hacen? ¿Acaso para tener dinero no utilizado en su presupuesto que pueda transferirse a otra área antes de que finalice el año fiscal?

Ojalá el Sr. Ortega comparezca ante el concejo y les pregunte por qué.

¿Será algo que dije?

La semana pasada escribí sobre la abogada Caryl García, directora interina de personal, y su intención de permanecer en el puesto, según he oido. Pero, ahora que el abogado Kevin Foley renunció, la necesitan en la oficina de abogados y debería regresar.

El plan era darle una prórroga de 90 días en la próxima reunión del Comité de Personal del 29 de abril, pero la prórroga se canceló. No hay noticias de si volverá a su puesto anterior.

El alcalde Brian A. DePeña, la delegación estatal de Lawrence y los concejales de la ciudad rindieron homenaje al jefe de bomberos Brian F. Moriarty por sus 38 años de dedicado servicio y sacrificio a la ciudad de Lawrence. Team Haverhill, Creative Haverhill, and SJ Art Consulting Announce Art in the Park Project in Collaboration with Haverhill High School

Team Haverhill, Creative Haverhill, and SJ Art Consulting are thrilled to announce the next work of art to be installed as part of Riverside Art in the Park, an ongoing collaborative effort by Team Haverhill, Creative Haverhill, and SJ Art Consulting. Working with regional artist Maia Mattson, Haverhill High School students will implement an Eco Labyrinth, featuring naturally dyed tapestries celebrating the colors of the natural world and the creativity of Haverhill High School Fine Arts students. Students have begun working on the project, with completion expected by the end of the school year.

Waxed and framed large scale, naturally dyed tapestries will be displayed through double sided plexiglass. Integrated site signage and bench seating will invite visitors to sit and reflect, while enjoying the artwork and the natural planting. The 500-foot Eco Labyrinth will feature mulched pathways guiding visitors through the labyrinth. More than 300 feet of native, perennial flowers, grasses, and ornamental shrubbery will border the mulched pathways.

"We couldn't be more excited about



the progress being made on this project, the inspiring direction artist Maia Mattson is taking, and the meaningful way she's engaging the talented students of the Haverhill High School Art Department. We hope the community will enjoy watching this vibrant new piece of public art come to life at Riverside Park alongside

the district. These drills will be conducted annually to keep skills sharp, and they are complemented by ongoing tabletop exercises throughout the year.

The Methuen High School training was designed and delivered by instructors who are certified by the ALERRT Center at Texas State University, in collaboration with local law enforcement trainers.

"Today's drill was a critical step in ensuring Methuen is prepared for the unthinkable," said Chief McNamara. "By uniting Police, Fire, and Schools in a realistic, high-pressure scenario, we strengthened our ability to neutralize threats, save lives, and protect our community. This training builds confidence in our coordinated response to any crisis."

"Our firefighters, who also serve as EMS providers staffing our ambulances, worked seamlessly with Police to execute Rescue Task Forces, rapidly evacuating casualties from the warm zone," said Chief Sheehy. "This drill proved our ability to integrate medical response with tactical operations, ensuring we can save lives under the most challenging conditions."

"Our number one priority is student and staff safety," said Superintendent Kwong. "MPS is so fortunate to have a positive, collaborative relationship with both the MPD and MFD to be able to plan and execute this level of training that impacts our community. We were all able to focus on response times of our students and staff and learn more about the coordinated emergency response in these situations. The exercise today was hugely successful, and I am grateful to the entire team that worked with us over the past several weeks to coordinate and execute it."

"As Mayor, I directed Chiefs McNamara and Sheehy, along with Superintendent Kwong, to conduct this drill to demonstrate Methuen's proactive approach to school safety. Their leadership and the dedication of their teams have set a standard for excellence in preparedness," said Mayor Beauregard. "We will continue to prioritize training, collaboration, and resources to keep our schools and community secure."

METHUEN — Police Chief Scott McNamara, Fire Chief Tim Sheehy, and Superintendent Brandi Kwong are pleased to share that the Methuen Police and Fire Departments and Methuen Public Schools, acting under the direction of Mayor D.J. Beauregard, participated in and successfully completed ALERRT active shooter training.

ALERRT (Advanced Law Enforcement Rapid Response Training) teaches first responders and civilians how to respond effectively to active shooter situations, providing practical skills and strategies to rapidly identify, isolate, and neutralize active shooters.

The training was conducted on Wednesday, April 16, at Methuen High School, with approximately 62 individuals involved in the training. Methuen High School student volunteers assisted by serving as role-players to enhance the realism of the training. All Methuen High School students and staff went into lockdown during the drill and took the drill seriously.

The drill extended far beyond a standard lockdown. It involved a fully choreographed scenario with high school student role-players and simulated casualties.

The drill tested the ability of first responders to neutralize a threat and form Rescue Task Forces, combining Police and Fire/EMS personnel, to evacuate wounded individuals from a warm zone. A warm zone is an area in an active shooter incident where the immediate threat has been neutralized or contained, but some risk remains, requiring coordinated efforts to safely extract victims. Methuen Firefighters play a critical role in such extractions, and training together with police and school officials builds the skills and readiness of all involved. This integrated response highlights Methuen's readiness to manage complex emergencies with precision and unity.

The training drill was the first conducted at such a scale at Methuen High School. Earlier this year, Methuen Police, Methuen Fire and Methuen Public Schools also teamed up to conduct smaller-scale lockdown drills at each school in

El bien y el mal que todos llevamos dentro


Bondad y maldad conviven en todas las personas y su expresión depende de circuitos cerebrales.

"El bien y el mal luchan constantemente y el terreno de esa lucha es el corazón humano", decía el escritor ruso Fiódor Dostoyevski para referenciar el pulso permanente que estos dos conceptos tienen en el interior de cada persona; pero, al tenor de la ciencia, el cerebro sería el mejor cuadrilátero para ese enfrentamiento.

De hecho, son muchas las investigaciones orientadas a identificar dónde están los domicilios de ese ángel que invita amigablemente a actuar de manera bondadosa y el de su contraparte, el demonio, que empuja a tomar decisiones contra las normas y que demuestran que los dos coexisten en el cerebro y que la manifestación de cada uno depende de muchos factores.

Pero esta búsqueda ha ido más allá, tanto que un equipo de científicos en la Universidad de Oxford (Inglaterra) liderado por Franz-Xaver Neubert, dijo haber hallado en una parte del lóbulo frontal el sitio del cerebro que controla "realmente" la toma de decisiones y que no dudaron en homologar con eso que la gente llama "la voz de la conciencia".

"Esta región es la fuente de la voz interior que nos azuza a inclinarnos por un acto que nosotros mismos consideramos malo o bueno", dijo Neubert y enfatizó que los macacos carecen de esta área lo que los torna incapaces de discernir el bien y el mal, más allá de sus instintos.

Aunque encontrarle una residencia a la conciencia parece novedoso, lo cierto es que esto refuerza otros estudios que ubicaron el autocontrol en los mismos territorios. Uno de ellos, publicado en Nature Neuroscience, hace más de una década, demostró que las personas que tenían lesiones en la corteza prefrontal "nunca mostraban sentimientos de culpa o remordimiento por sus actos", lo que dejó inferir que una avería anatómica podía modificar sustancialmente la escala de valores que cimentan la "conciencia".

Pero además de estos análisis, otras investigaciones han mostrado -a partir de imágenes- que la activación de la corteza prefrontal y la amígdala cerebral se correlacionan con el contenido moral de las acciones humanas. Condición que le permite a expertos en psiquiatría y leyes (que asesoran tribunales de justicia), como Stephen J. Morse de la Universidad de Pensilvania, asegurar que existen zonas del cerebro que permiten a las personas "guiarse por la razón" y que al fallar las lanzan hacia el bando de los malos.

Otros van más allá y ponen el actuar del ángel o del demonio en el mismo ADN. Es el caso de los niños que nacen con deficiencias en el gen que regula la monoamino oxidada (MAO) -conocido como el gen del guerrero- que tienen hasta nueve veces más probabilidades de tener comportamientos antisociales al crecer al ser comparados con los que no presentan la anormalidad. Claro, hay quienes dicen que la expresión de estos genes no es absoluta y depende del medio ambiente y otros factores, pero no hay que negar que dicha probabilidad existe.

El bien-DIOS que frena al mal-diablo Ahora, no siempre el diablillo se sale con las suyas, porque se ha visto que a pesar de haber empujado alguna acción, esta puede ser frenada por unos circuitos que habilitan la libertad de "no actuar". Marcel Brass, del Instituto Max Planck y Patrick Haggard del University College de Londres, encontraron en la línea media del cerebro, justo sobre los ojos, una zona

que puede detener una acción que estaba a punto de realizarse. Sería, guardada la proporción, como el centro de la reflexión que permitiría, además, contener impulsos y ponerse en el lugar del otro, algo fundamental para la convivencia.

Lo curioso es que esa misma zona, de acuerdo con Alexander Soutschek y Christian Ruff, de la Universidad de Dusseldorf (Alemania), es la que garantiza la empatía y el control de la gente cuando está sola.

De igual forma, hay quienes dicen que la impulsividad y la agresividad de algunas personas pueden ser frenadas por una especie de "bien-DIOS" en forma de neurotransmisor conocido como GABA (ácido gama amino butírico) que impide que la ansiedad, los nervios y el sentimiento de urgencia determinen comportamientos negativos diablo. Por supuesto que esta sustancia actúa con mayor énfasis en la corteza prefrontal.

A veces el mal-diablo triunfa. Afortunadamente, la mayoría de personas cuentan con herramientas biológicas que se oponen a los actos deshonestos. Se sabe, que las malas acciones generan emociones que hacen sentir mal a quienes las cometen; pero unos investigadores del University College de Londres acaban de comprobar que esas percepciones negativas -que no dejan obrar mal- se van debilitando con el

tiempo y con las repetición de las malas acciones, por lo que muchos terminan saltándose las normas y ejecutando actos indebidos sin que estos les parezcan anormales.

El estudio, publicado esta en la revista Nature, demostró que la amígdala cerebral es el centro que procesa esas emociones que son antagónicas con la deshonestidad, sin embargo, este regulador se desensibiliza a punta de "pequeños e inocentes" actos de maldad, al punto que algunos pueden llegar a cometer acciones peligrosas convencidos de que están actuando bien.

Tal vez, eso explica porque para muchas personas, decir mentiras piadosas, quedarse con el cambio, destapar un paquete de dulces y tomar unos en un supermercado o, incluso, maltratar a otras personas, son actos inofensivos y hasta divertidos, cuando lo que ocurre es que su diablo interior está fuera de control.

No obstante, la neurobiología parece tener todas las respuestas para explicar la cohabitación del bien-Dios y el mal-demonio en el cerebro humano, corrientes más fuertes defienden el comportamiento humano como la interacción entre las neuronas, la psique y el medio ambiente, con lo que se reafirma eso de que cada individuo es diferente así las pruebas neurológicas insistan en que todo son estados funcionales de la mente.

Enhanced State ID Program Promotes Successful Reentry for Formerly Incarcerated Individuals, Issuing Over 1,250 IDs Since Launch

Expanded Program and Mobile Unit Increases Reentry Support and Removes Barriers to Housing, Employment and Essential Services

The Healey-Driscoll Administration announces the successful expansion of the Enhanced State ID Program, which has provided more than 1,250 state-issued identification cards to individuals returning to their communities after incarceration. Now in its second year, the program was created to remove barriers to reentry by ensuring individuals have a government-issued photo identification upon release, facilitating their ability to access essential services, secure housing and find employment.

First announced in March 2023, the program streamlines the process of providing government-issued photo ID to individuals upon release from the Massachusetts Department of Correction (DOC). In 2024, the program expanded further to include a new mobile unit administered by the Massachusetts Registry of Motor Vehicles (RMV), increasing efficiency and accessibility by bringing ID services directly to DOC facilities. The mobile RMV workstation visits DOC facilities statewide, capturing photos and signatures, verifying documents, and issuing IDs. This program comes at no cost to the recipients.

The program's impact continues to grow. In 2023, it provided 572 eligible individuals with state IDs, a 55 percent increase from 2022. In 2024, that number rose to 669, with 233 of those IDs issued through the new mobile unit.

"This program makes all of our communities safer by helping individuals returning to their communities after incarceration access housing, jobs and essential services, thus lowering the risk of them re-entering the criminal justice system," said Governor Maura Healey. "We're proud to expand this program and commend our hardworking teams across multiple agencies for their efforts to make it such a success."

"Our administration is committed to creating pathways to successful reentry and supporting initiatives that improve outcomes by reducing the challenges often faced by those preparing to return to the community after incarceration," said Lieutenant Governor Kim Driscoll. "Possessing a state ID is an essential step toward gainful employment, housing and other essential support services."

In 2023, under the leadership of the Executive Office of Public Safety and Security (EOPSS), the DOC and the RMV signed a Memorandum of Understanding to streamline the process of obtaining a government-issued photo identification card for individuals within six months of release. This enhanced system allows the DOC to electronically transmit applications, supporting documents, standardized photos and signatures to the RMV through a secure file transfer system. Once processed, the RMV sends the completed ID to the DOC officials, ensuring individuals receive their identification upon release, removing a critical barrier to reentry.

A valid state ID is essential for opening a bank account, securing employment and finding stable housing. Without one, returning individuals face difficult barriers to accessing life's most basic necessities," said Public Safety and Security Secretary Terrence Reidy. "I commend the dedication of the DOC and RMV for their continued efforts to expand this program and grow reentry support for those preparing for life after incarceration."

As part of the State ID application process, individuals must submit proof of identity documents, most commonly a birth certificate. In cases where an acceptable document is unavailable – often because of incomplete information – the MOU allows the DOC to produce an alternative attestation of identity document for eligible individuals. These measures ensure equitable access to the process for all returning residents.

"Supporting returning citizens by providing free driver's licenses or ID cards—when they meet the requirements—is a vital step in removing barriers and affirming their dignity," said Transportation Secretary and CEO Monica Tibbets-Nutt. "This program reflects our values and our commitment to second chances. I'm grateful to the RMV workforce and the Department of Correction for their partnership in making this possible. We're proud to play a role in helping returning citizens rebuild their lives and contribute to their communities."

"Ensuring individuals receive a state-issued identification card upon release is one pillar in the DOC's multifaceted approach to removing barriers and preparing those transitioning back into communities for success," said DOC Commissioner Shawn Jenkins. "I commend our partners

at the Massachusetts Registry of Motor Vehicles for strengthening and expanding this program with the mobile unit. This identification is vital for individuals to apply for jobs, open bank accounts, and secure stable housing."

"We are pleased to see that the Enhanced State ID Program is making a difference for individuals who are taking steps to reintegrate into society," said Registrar of Motor Vehicles Colleen Ogilvie. "Thanks to this partnership with the DOC, we can bring our services to their sites helping individuals who qualify to obtain a Massachusetts identification card prior to release, so they can more easily seek employment and other services."

"I'm pleased to see the significant progress that we have made with the collaboration of the DOC, Social Security Administration, Vital Records and the RMV. We are now able to provide a packet that includes an ID, Social Security card and birth certificate for many returning citizens," said Representative Russell Holmes. "Removing the impediment of obtaining these documents enables returning citizens to more quickly become productive and prosocial citizens."

The Healey-Driscoll Administration's FY26 House 1 Budget proposes approximately \$10 million in funding to support reentry initiatives across DOC and EOPSS, including \$7 million for Pre- and Post-Release Services grant programs.

This proposed investment reflects the administration's commitment to providing incarcerated individuals access to need-specific programming and industry-specific training that prepares returning individuals for successful community reintegration.

Massachusetts is recognized as a national leader in recidivism reduction. According to the most recent DOC report, the overall recidivism rate for this cohort decreased to 26 percent, down from 29 percent in the previous year, underscoring the DOC's continued commitment to rehabilitation and reintegration efforts.

About the Massachusetts Department of Correction

The Massachusetts Department of Correction (DOC) manages the custody, care, and rehabilitation of approximately 6,000 individuals across 13 state facilities. The DOC emphasizes evidence-based programming, trauma-informed care, and educational and vocational training to reduce recidivism and is committed to fostering accountability, personal growth, and successful reentry. Through partnerships with community organizations and stakeholders, the DOC delivers innovative services tailored to the diverse needs of incarcerated individuals while advancing equity, inclusion, and long-term public safety.



Mejorar la salud renal con terapias basadas en evidencia disminuye la probabilidad de ataque cardíaco, ataque o derrame cerebral o insuficiencia cardíaca en personas con síndrome cardiovascular-renal-metabólico (cardiovascular-kidney-metabolic, CKM)

Janani Rangaswami, FAHA, voluntaria de la American Heart Association y Profesora de Medicina en la Facultad de Medicina y Ciencias de la Salud de George Washington University en Washington, D.C. A continuación, explica que existe una conexión entre el “dominio cardiorrenal” (la comunicación entre el corazón y los riñones) y el “dominio cardiometabólico”, que crea una interacción de afecciones coexistentes conocida como síndrome cardiovascular-renal-metabólico (CKM).

Aproximadamente 1 de cada 3 adultos estadounidenses tiene al menos tres componentes del síndrome CKM. El amplio impacto de estas condiciones es la razón por la que la Asociación desarrolló su Iniciativa de Salud Cardiovascular-Renal-Metabólica (sitio web en inglés), apoyada por los patrocinadores fundadores Novo Nordisk y Boehringer Ingelheim, y su patrocinador más reciente DaVita. Rangaswami es miembro del grupo asesor científico de la iniciativa.

La colaboración es clave entre los profesionales de la salud que tratan a personas con enfermedades cardiovasculares (ECV) y enfermedades renales. “Es importante pensar en estas afecciones de manera colectiva porque así es como las experimentan los pacientes”, dijo Mariell Jessup, M.D., FAHA, Directora Científica y Médica de la

American Heart Association. “Un enfoque holístico de la atención ayuda a brindar un mejor tratamiento y a reducir la sensación de agobio que experimentan los pacientes al lidiar con múltiples enfermedades crónicas”.

“Las personas que viven con enfermedad renal a menudo lidian con múltiples otras afecciones crónicas simultáneamente, lo que hace que la atención colaborativa sea esencial”, afirmó la Dra. Amy Schuerman-Gen, Directora Médica de DaVita Integrated Kidney Care. “Nos enorgullece enormemente apoyar a la American Heart Association en esta iniciativa para mejorar la vida de los pacientes mediante una atención interdisciplinaria y más eficiente”.

La enfermedad renal y la enfermedad cardíaca a menudo se desarrollan juntas. Incluso el daño renal temprano aumenta el riesgo de sufrir enfermedades cardiovasculares, como enfermedades cardíacas, insuficiencia cardíaca y derrames cerebrales. Los estudios muestran que 3 de cada 5 personas con enfermedad renal en etapa temprana también tienen enfermedad cardiovascular.

Para detectar la enfermedad renal se utilizan dos pruebas. La relación albúmina/creatinina en orina (urine albumin to creatinine ratio, UACR) utiliza una muestra de orina para buscar una proteína llamada albúmina en la orina, que puede indicar daño renal temprano. Un nivel de UACR de 30 o más puede ser un signo de enfermedad renal y está relacionado con un alto riesgo de ECV. La segunda prueba común para medir la salud renal es un análisis de sangre llamado tasa de filtración glomerular estimada o eGFR. Un nivel de eGFR saludable es de 90 o más. Los niveles más bajos pueden significar una pérdida de la función renal.

“Las enfermedades cardiovasculares, renales y metabólicas interconectadas representan un importante desafío para la salud mundial”, afirmó Sandy Sommer, Vicepresidente Corporativo Sénior y Director del Área Terapéutica Cardiovascular, Renal y Metabólica de Boehringer Ingelheim. “Dada la fuerte conexión entre el corazón y los riñones, promover un diagnóstico y tratamiento tempranos de la enfermedad renal puede ayudar a proteger el corazón y reducir el riesgo cardiovascular de los pacientes que atendemos. Boehringer Ingelheim se enorgullece de apoyar la Iniciativa de Salud CKM para generar conciencia y promover la detección y la atención integral de los pacientes”.

La salud metabólica (sitio web en inglés) es una pieza fundamental del rompecabezas del CKM porque el peso, la presión arterial, los lípidos y la glucosa en sangre juegan un papel importante en la salud del corazón y los riñones. El exceso de peso corporal, especialmente alrededor de la cintura, está relacionado con niveles más bajos de salud renal. Por cada 10 libras de aumento de peso a lo largo del tiempo, puede haber un aumento de hasta un 30 % en el riesgo de disminución de la función renal. Cuando se controlan estos elementos, la salud cardiovascular puede mejorar y los

riesgos de sufrir enfermedades renales y otros problemas de salud importantes son menores.

Controlar periódicamente la presión arterial, el colesterol, la grasa corporal, el nivel de azúcar en sangre y la salud renal puede ayudar a detectar signos del síndrome de CKM de forma temprana. Esto es especialmente importante porque el riesgo de muerte por ECV excede el riesgo de muerte por CKD, especialmente si alguien tiene diabetes tipo 2, dijo Rangaswami.

El síndrome de CKM tiene cuatro etapas (sitio web en inglés), las más avanzadas implican una enfermedad más grave. Las primeras etapas del síndrome de CKM son reversibles, pero es fundamental que las personas conozcan sus factores de riesgo.

- La etapa 1 incluye a personas con exceso de peso (medido por la circunferencia de la cintura o el índice de masa corporal) con o sin resistencia a la insulina, lo que significa que el cuerpo está comenzando a tener problemas para procesar la insulina. Cerca del 90 % de los adultos estadounidenses cumplen los criterios para esta etapa del síndrome de CKM.

- La etapa 2 incluye a personas que tienen sobrepeso y otros factores de riesgo metabólico con o sin enfermedad renal crónica. Los factores de riesgo metabólico incluyen colesterol anormal (triglicéridos altos, lipoproteínas de alta densidad bajas), presión arterial alta, niveles altos de glucosa (azúcar) en sangre o diabetes tipo 2.

- La etapa 3 incluye a personas cuyos análisis de sangre y exploraciones por imágenes muestran que los riñones, los vasos sanguíneos y el corazón presentan signos de enfermedad incluso sin síntomas.

- La etapa 4 describe a aquellos a quienes se les ha diagnosticado una enfermedad cardíaca y también pueden tener insuficiencia renal. Las personas en esta etapa experimentan síntomas como dolor en el pecho, dolor en las piernas, hinchazón o cicatrización lenta de las heridas. Estos ocurren debido a una función cardíaca reducida, un flujo sanguíneo reducido a las piernas, una función renal baja y diabetes.

“Comprender la conexión entre la salud renal y la salud cardíaca es fundamental para mejorar los resultados de las personas que viven con el síndrome de CKM”, afirmó Anna Windle, Ph.D., Vicepresidenta Sénior de Desarrollo Clínico, Asuntos Médicos y Regulatorios de Novo Nordisk. “A través de nuestro

apoyo a la iniciativa de la American Heart Association, nos comprometemos a generar conciencia sobre la importancia de la salud renal y a apoyar a los profesionales de la salud en la adopción de prácticas basadas en evidencia que integren la atención renal y cardiovascular. Esta iniciativa tiene como objetivo identificar los riesgos de forma temprana, mejorar la atención interdisciplinaria y, en última instancia, mejorar la calidad de vida de los pacientes y sus resultados generales de salud”.

La iniciativa también pretende aumentar el uso de terapia basada en evidencia para personas con síndrome CKM, lo que disminuye la probabilidad de tener malos resultados cardiovasculares. Muchos adultos en los EE. UU. podrían beneficiarse del creciente número de opciones terapéuticas basadas en evidencia para controlar el riesgo de CKM y afecciones como el control del azúcar en sangre, la reducción de peso, la mejora de la salud renal y la reducción del riesgo de ataque cardíaco y derrame cerebral.

Emergency Management job

Not all the cities and towns in Massachusetts have a department dedicated to Emergency Management, so when the city started discussing the position, it sparked a lot of interest because it would add the expense of a new department (even if it was composed of one person).

We had just gone through the gas explosions and the COVID pandemic, which turned the city upside down, and I began to look into it. To my surprise, the fire chief was the person in charge of Emergency Management during the ordeal.

At the same time, the city started discussing the possibility of hiring Police Officer Abel Cano to handle those duties. Then, we published a list of cities with a dedicated manager in that post. In most places, the police or fire department handles emergencies, and very few communities assign a specific person outside of those departments.

In Lawrence, Fire Chief Brian Moriarty did the job of Emergency Management for many years and never got paid for that work. You should remember that he was very vocal before the city council in opposition to this change.

Abel Cano is a decent man and officer,

a friend of this community, and a respected person, but he never held any rank in the department.

Octavien Spanner proposed the emergency management director's position. The city already had the position established, but it had been vacant because they never hired anyone.

The mayor knew Abel didn't have the certification for the job, but he was hand-picked to satisfy his friend (Cano's wife), Representative Estela Reyes. As soon as Brian DePeña was elected mayor of this city, she insisted that he should promote Cano to sergeant, but he was far down the list and could not be done.

Abel enrolled in the necessary courses and worked on obtaining his certification, paying for it until he got certified.

This position pays \$110,000 which is approximately double of what a police officer makes and it's out of the union.

How about posting it?

Police and city sales

Do you remember when the police department opened the garage for the public to browse among the stolen merchandise recovered during raids. There were children's bikes, computers, laptops, lots of jewelry, etc. Residents could buy those things for very little money.

That was many years ago, probably close to thirty years ago, and I had never heard of another one.

I also went to the city yard once where they had desks, office chairs, computers, printers, etc. The computers had the motherboard removed, but that was a minor expense, and I bought a laser printer for \$10.

When the city upgrades equipment or furniture at the end of every school year, truckloads leave the buildings, and no one knows where they end up. Those items belong to us, the taxpayers and the public should have a chance to buy them, but where do they go?

In the budget, not advertised

Having approved but not filled positions is common practice in this city. You saw an example above, and there's more.

The city recently hired Victor E. Ortega, Director of Veterans' Services, after six months with no one there. There are more than 2,000 veterans in Lawrence, young soldiers who have returned from world conflicts, and there is much work to do. Meanwhile, that department has two

assistant positions that have never been filled yet but are within the budget.

Why do they do that? Is it to have unused money in their budget that can be transferred to another area before the end of the fiscal year?

Hopefully, Mr. Ortega will go before the council and ask them why.
